The ornamental design for a display screen with animated user interface, as shown and described.

**DESCRIPTION**

FIG. 12 is the twelfth image thereof;

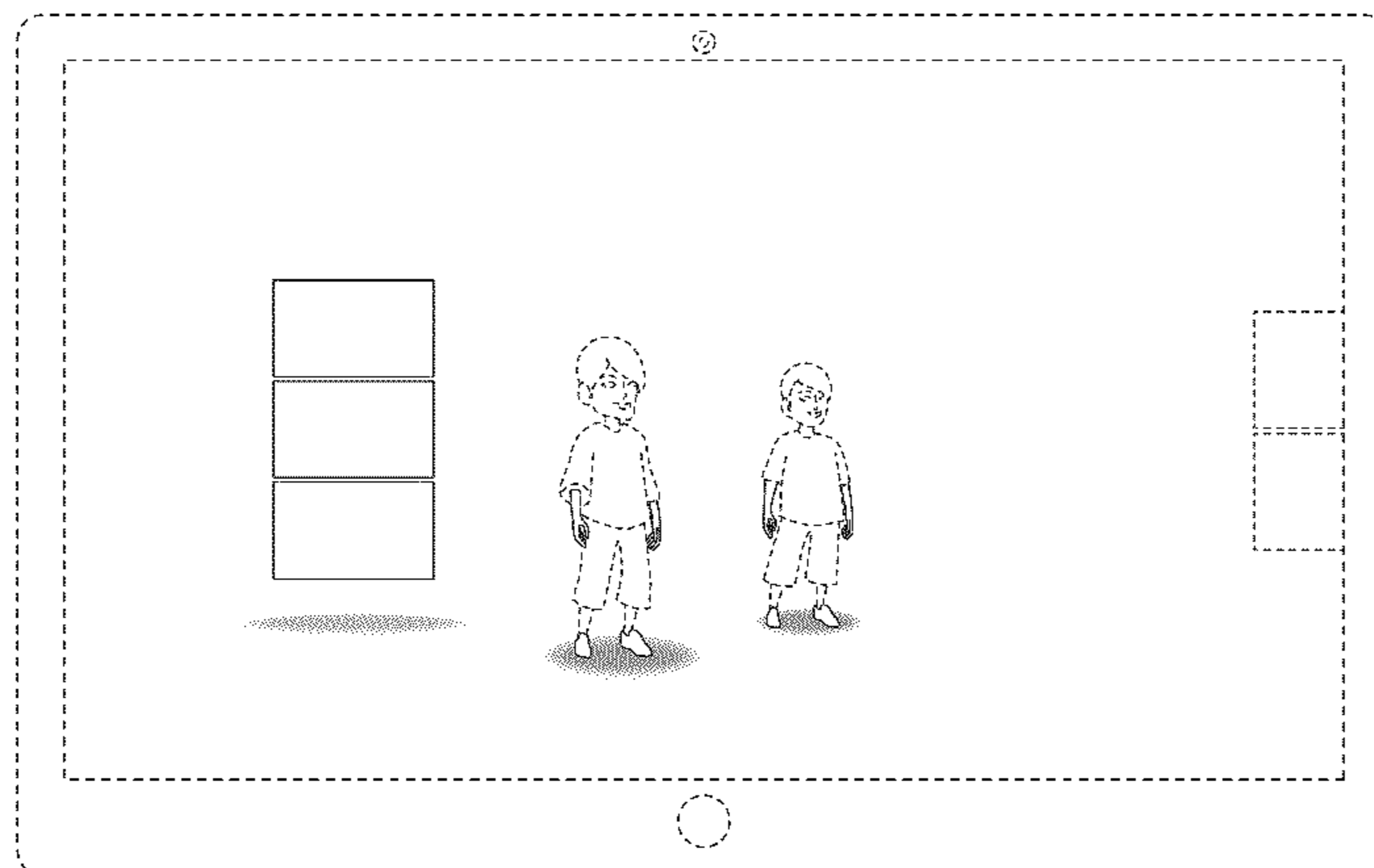
FIG. 13 is the thirteenth image thereof.

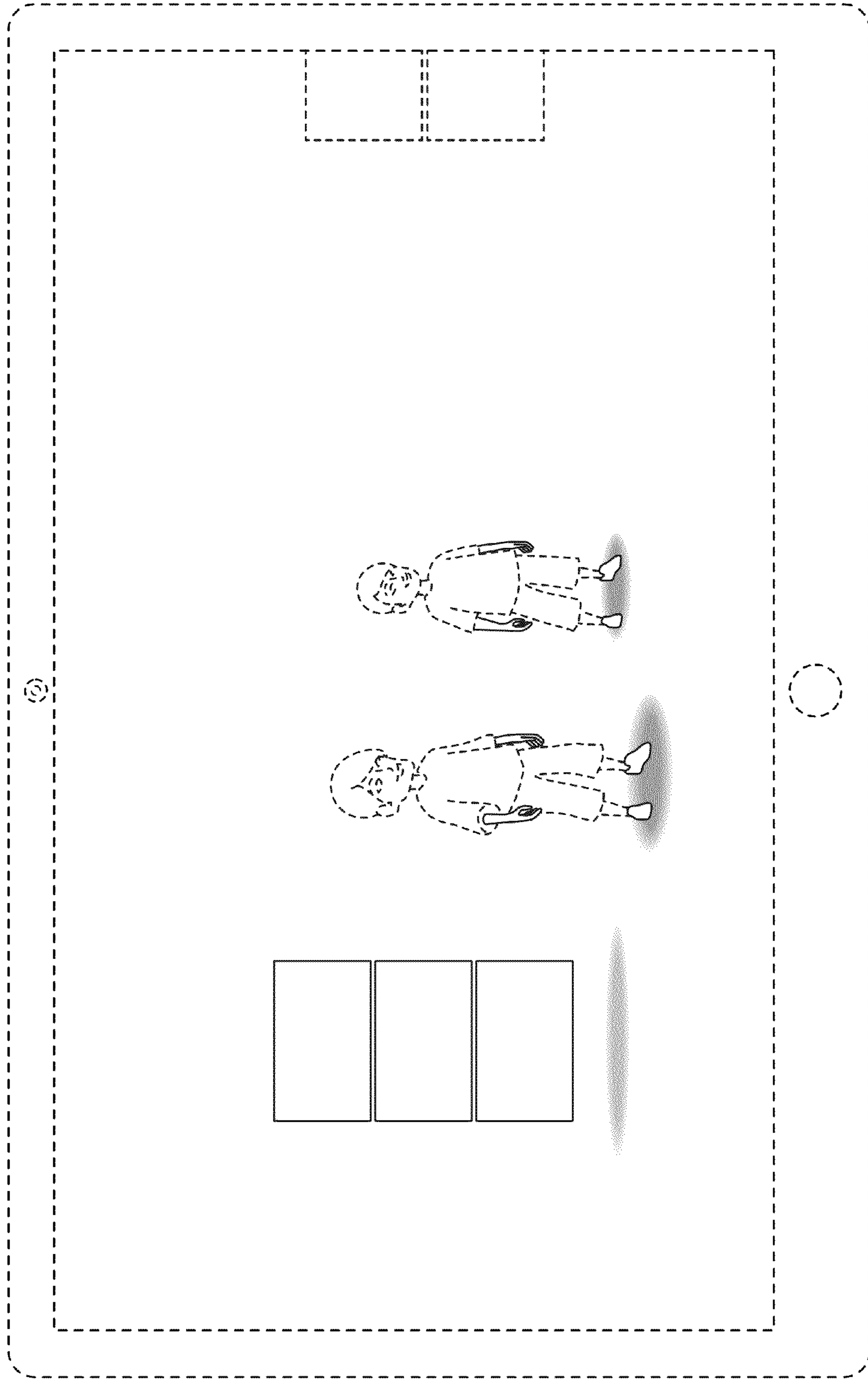

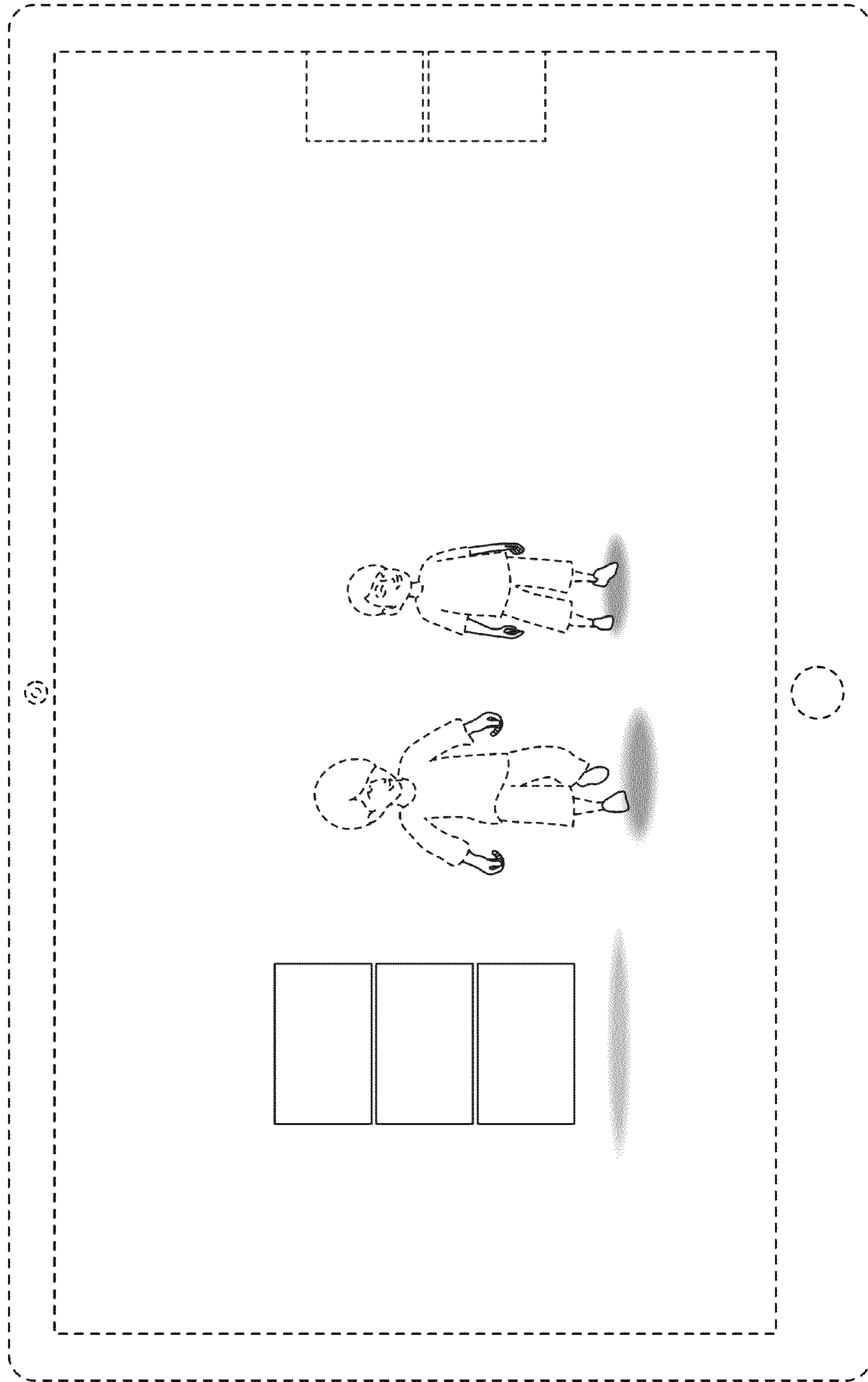

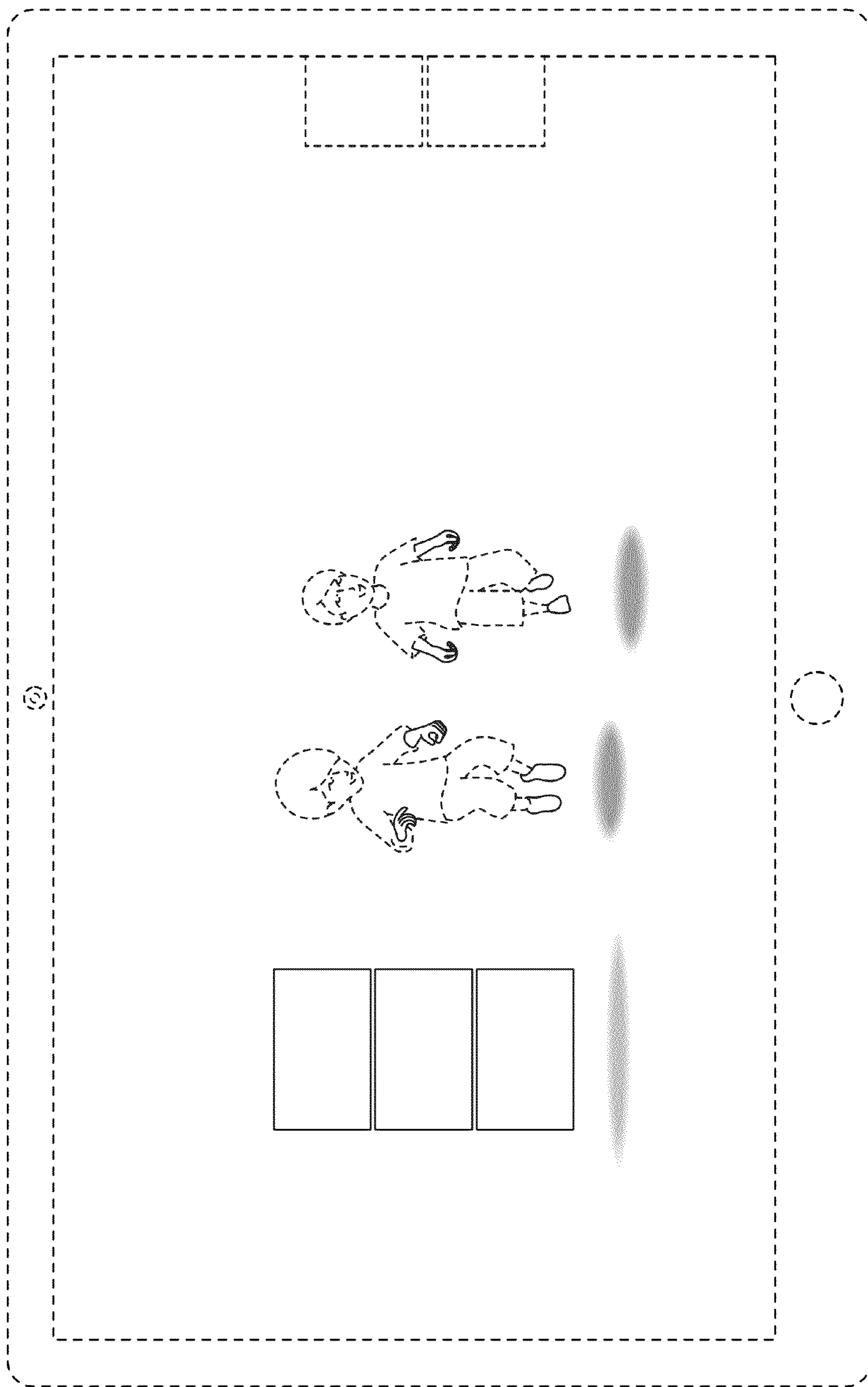

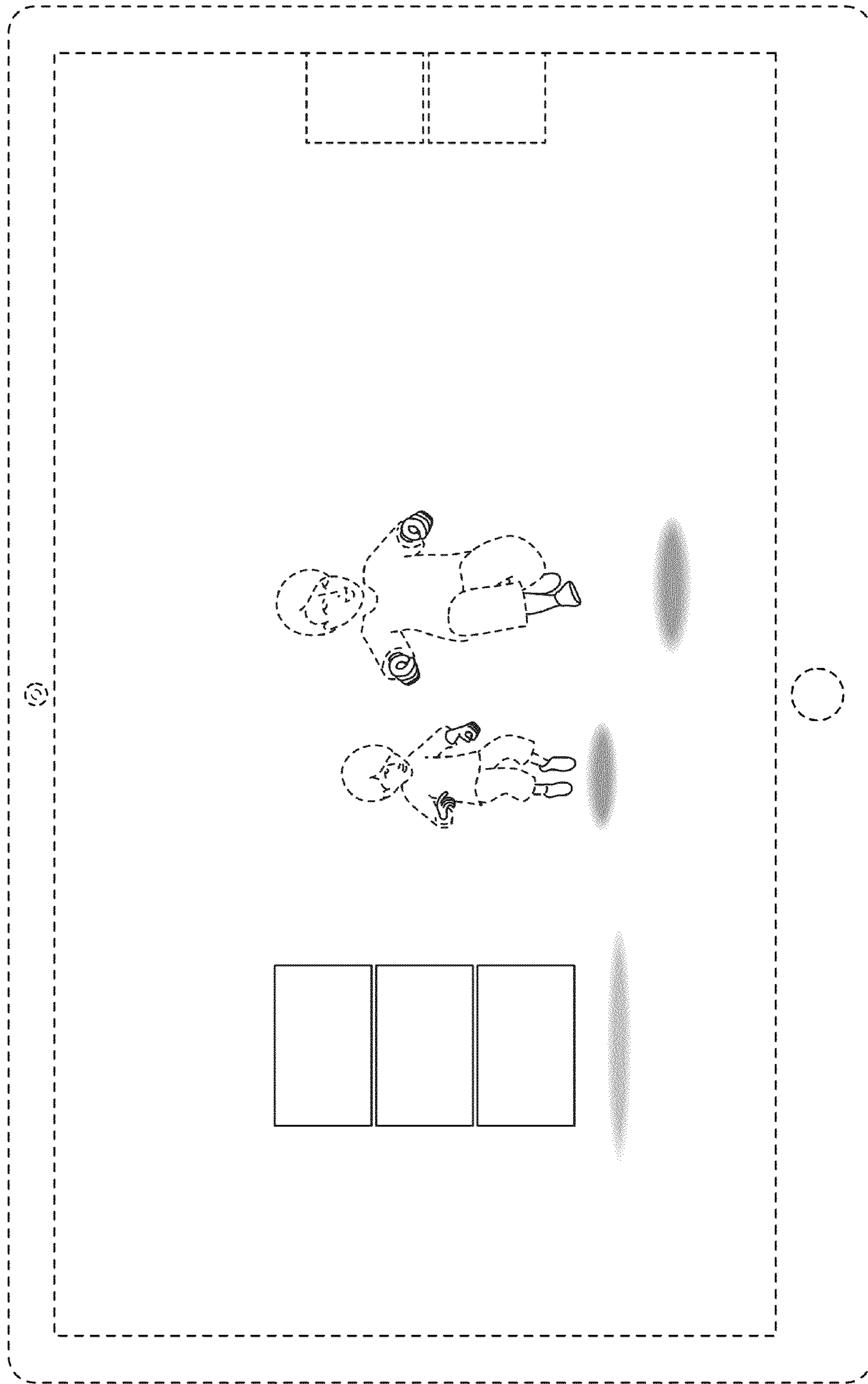

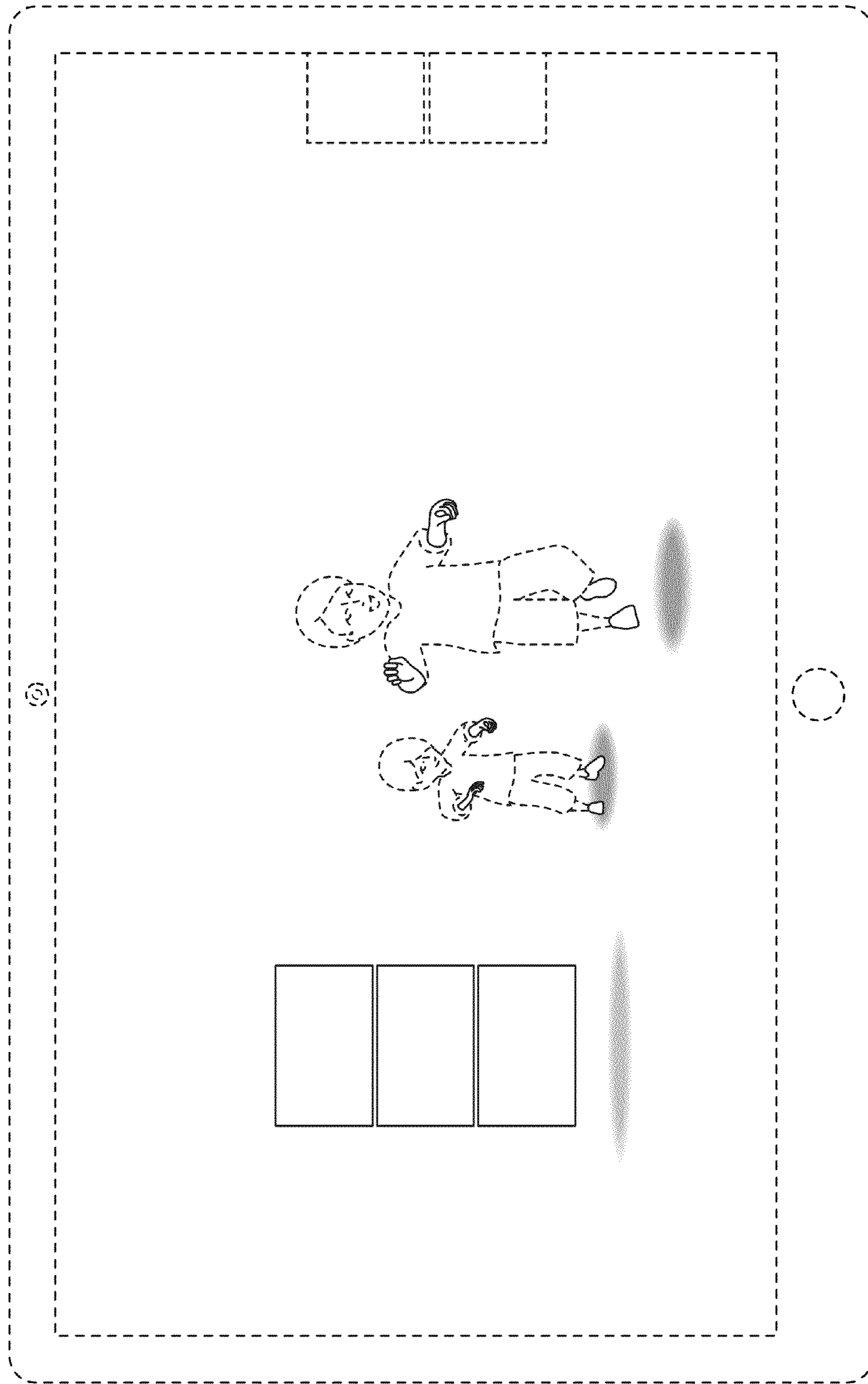

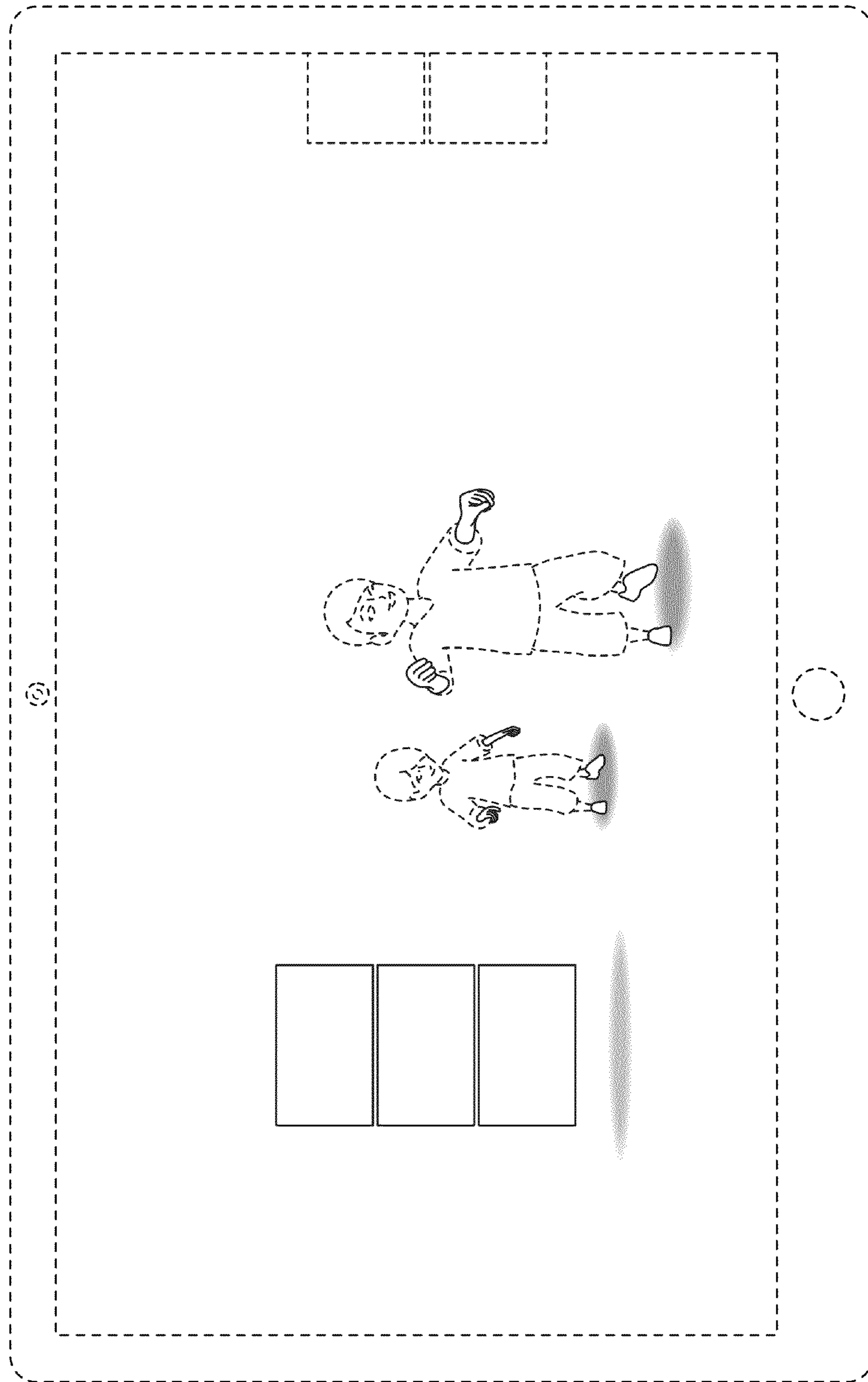

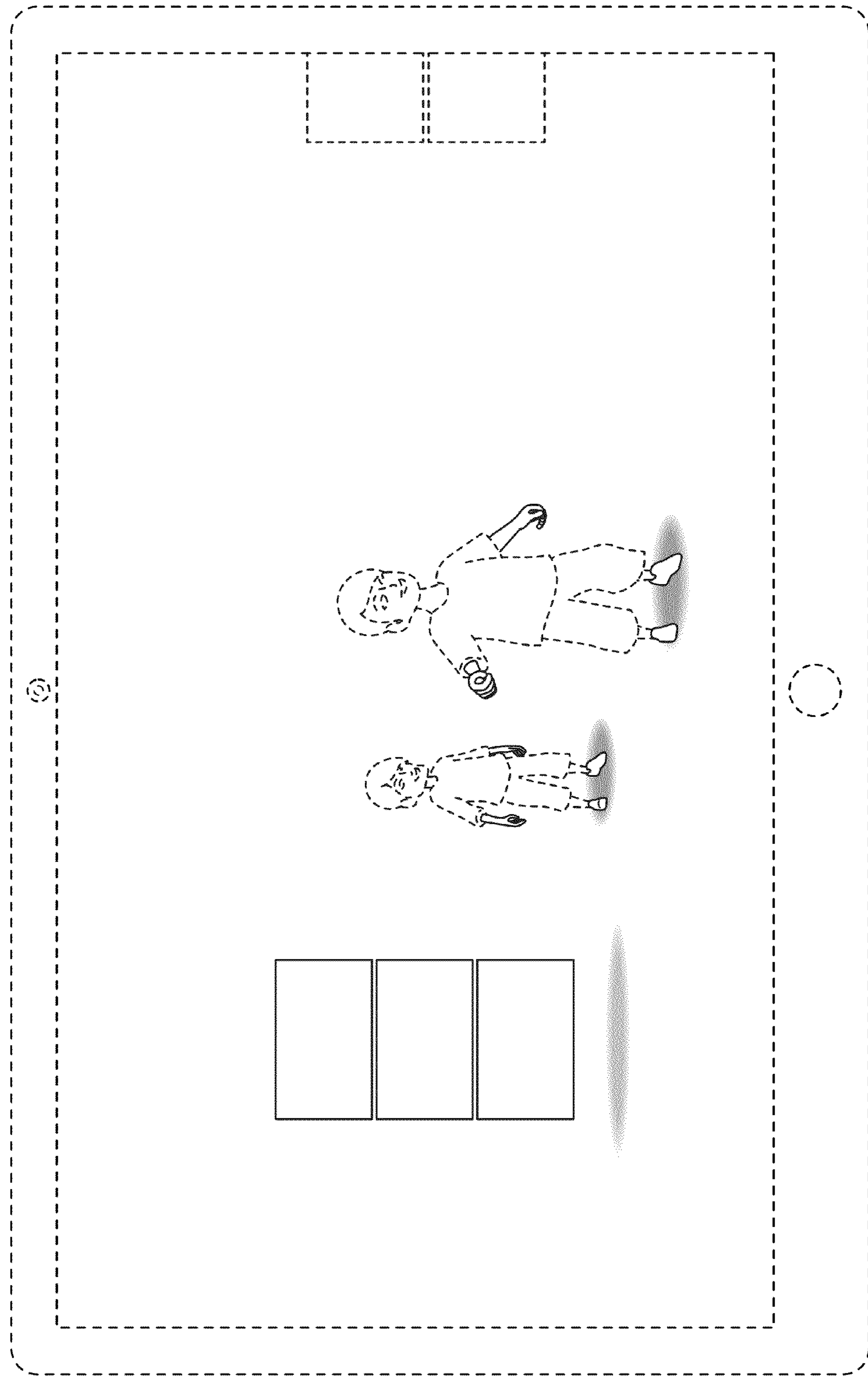

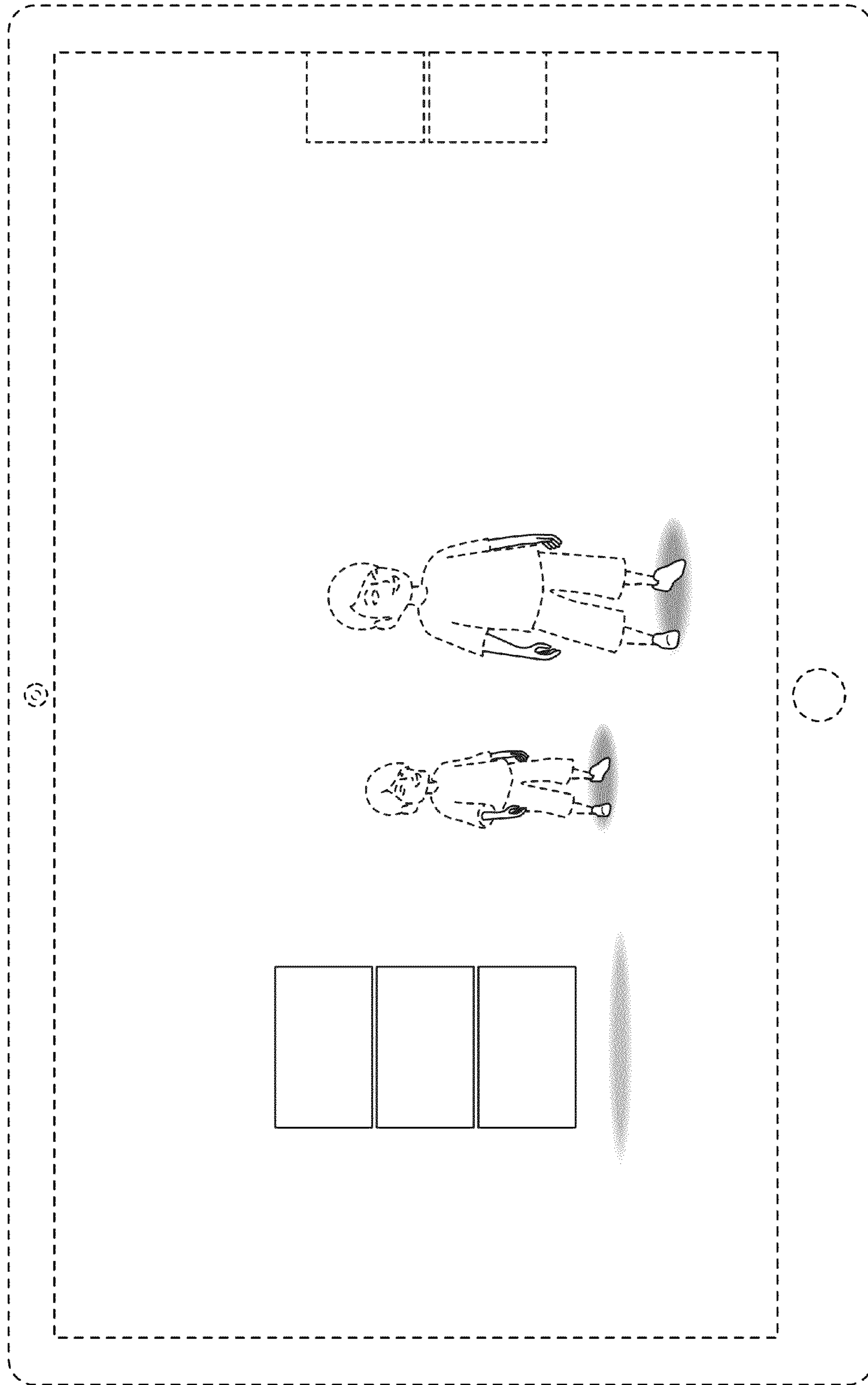

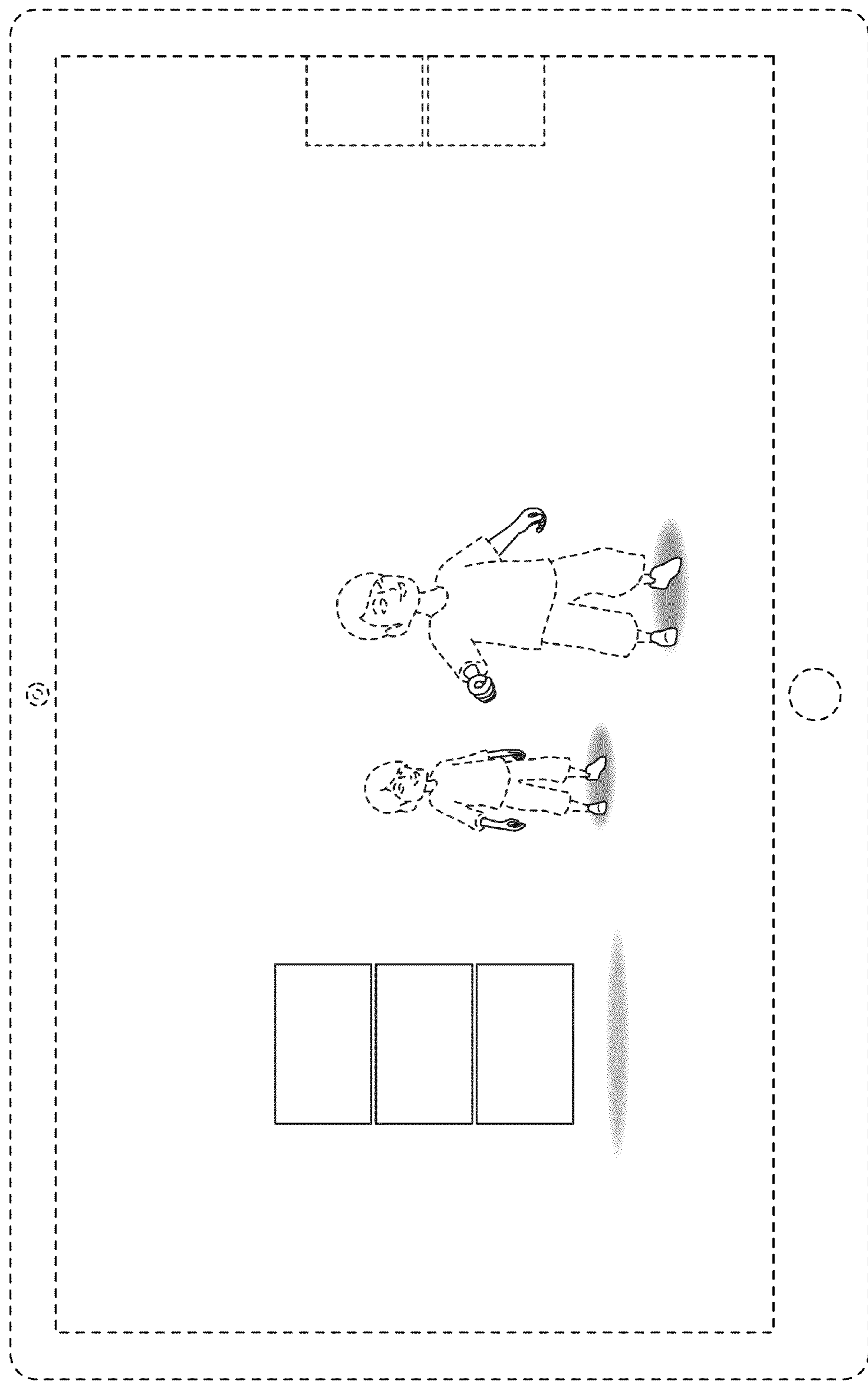

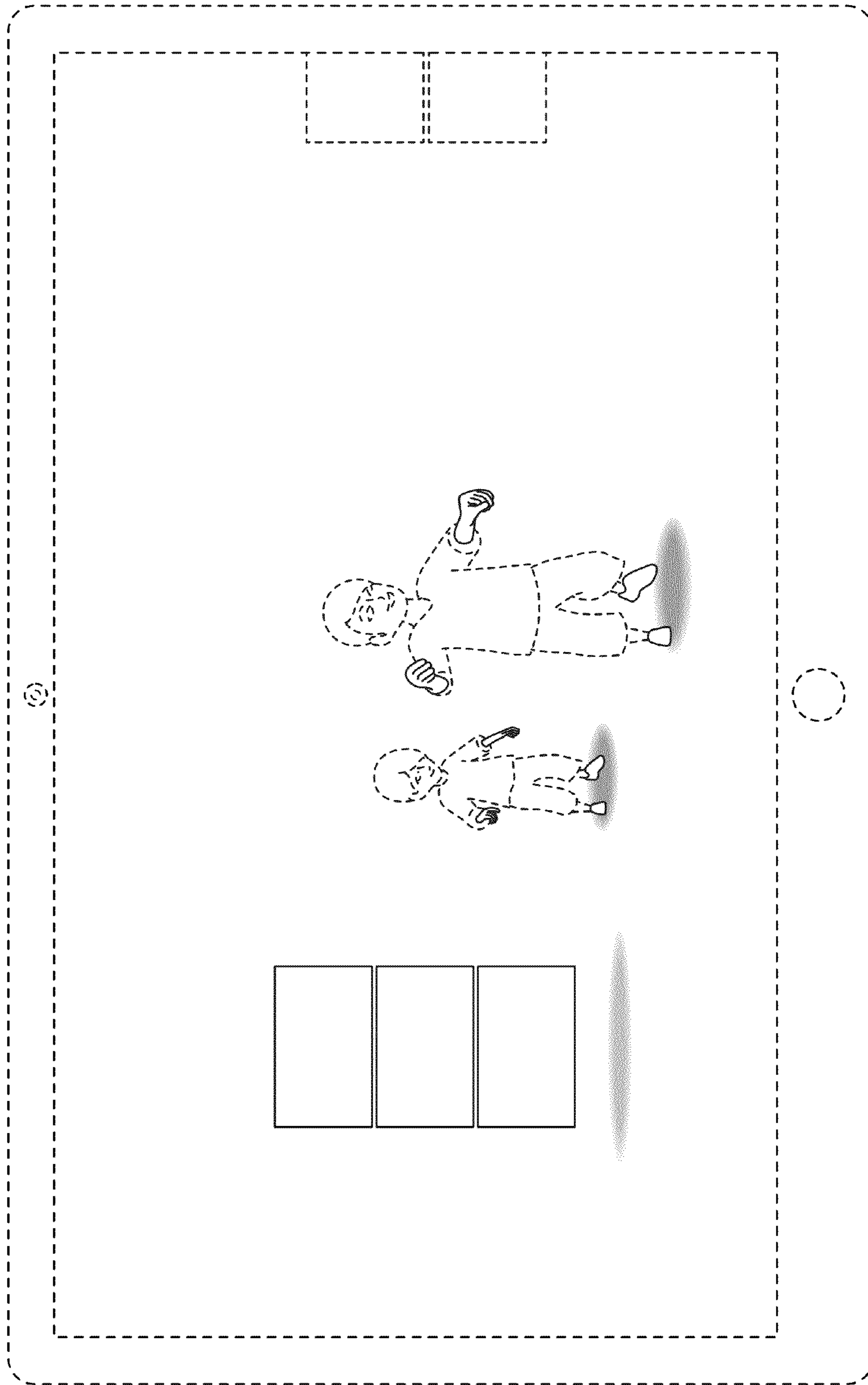

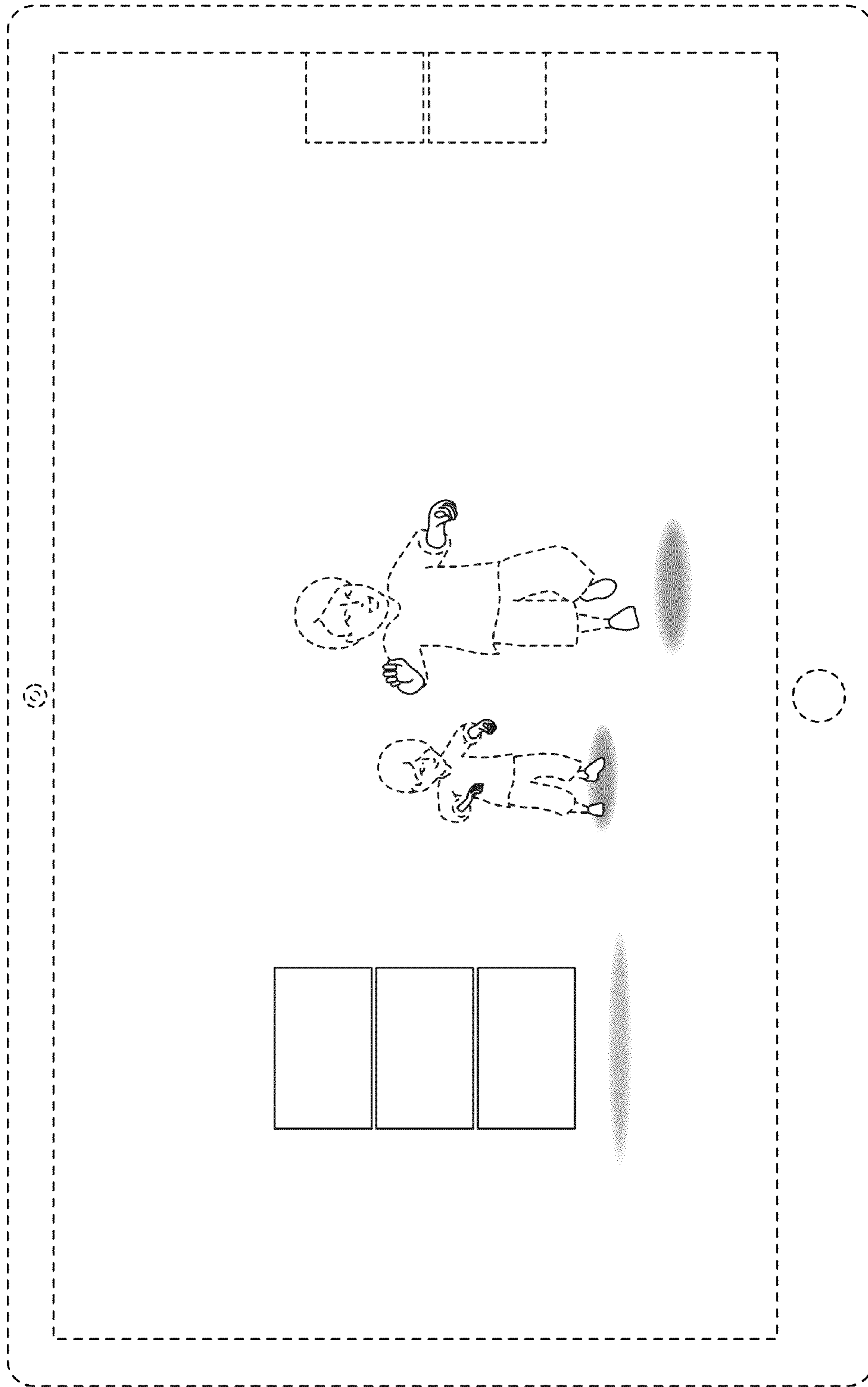

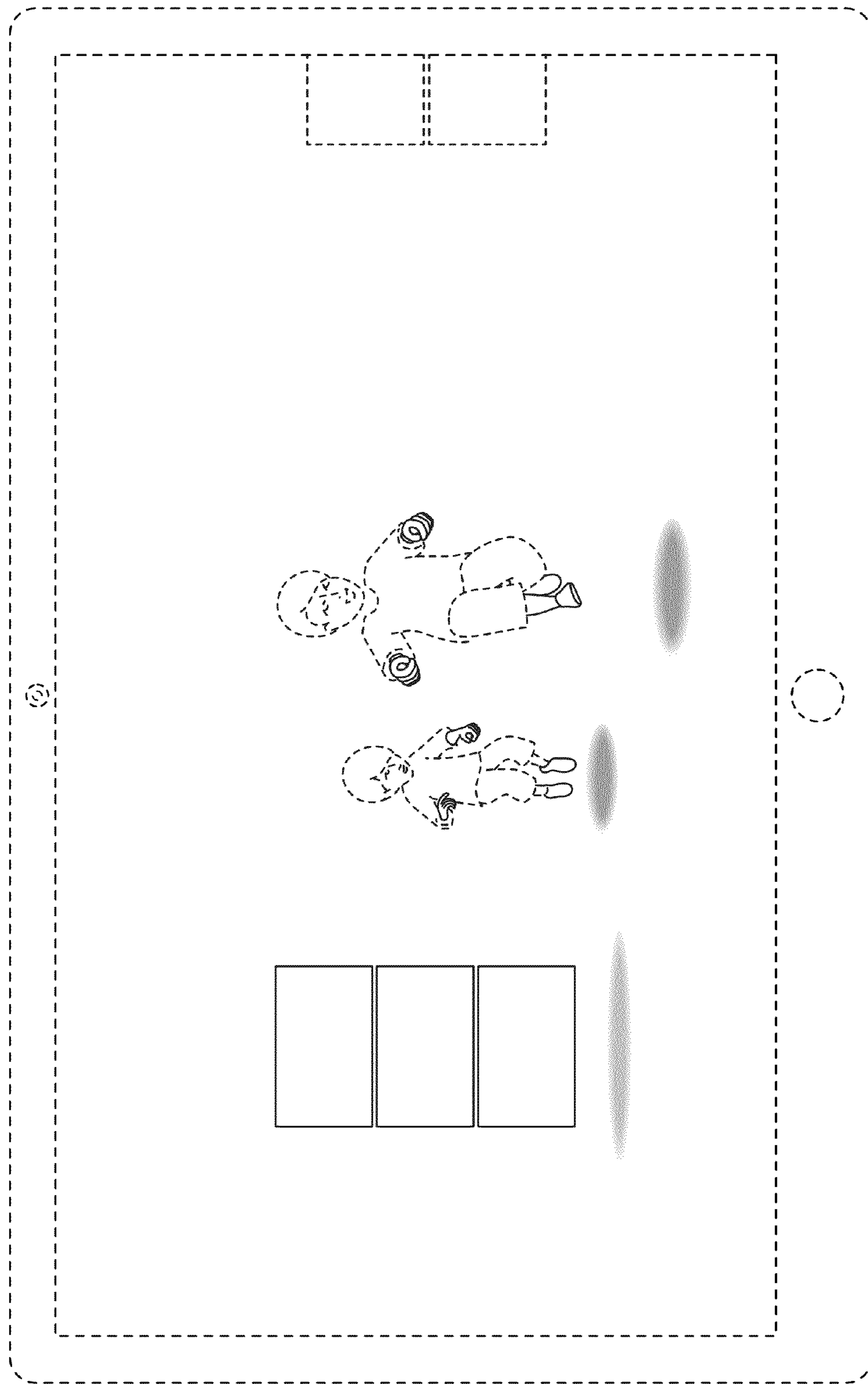

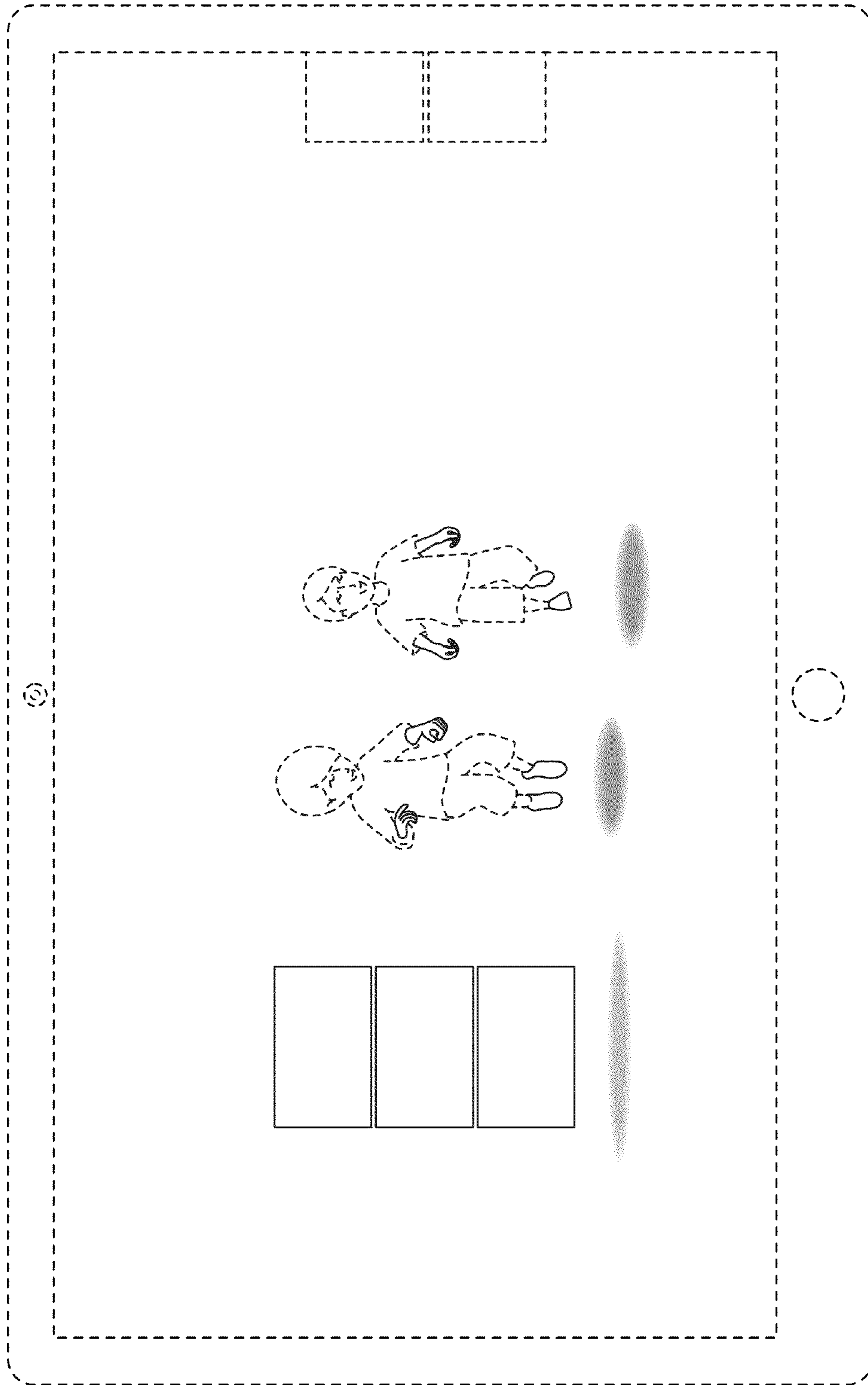

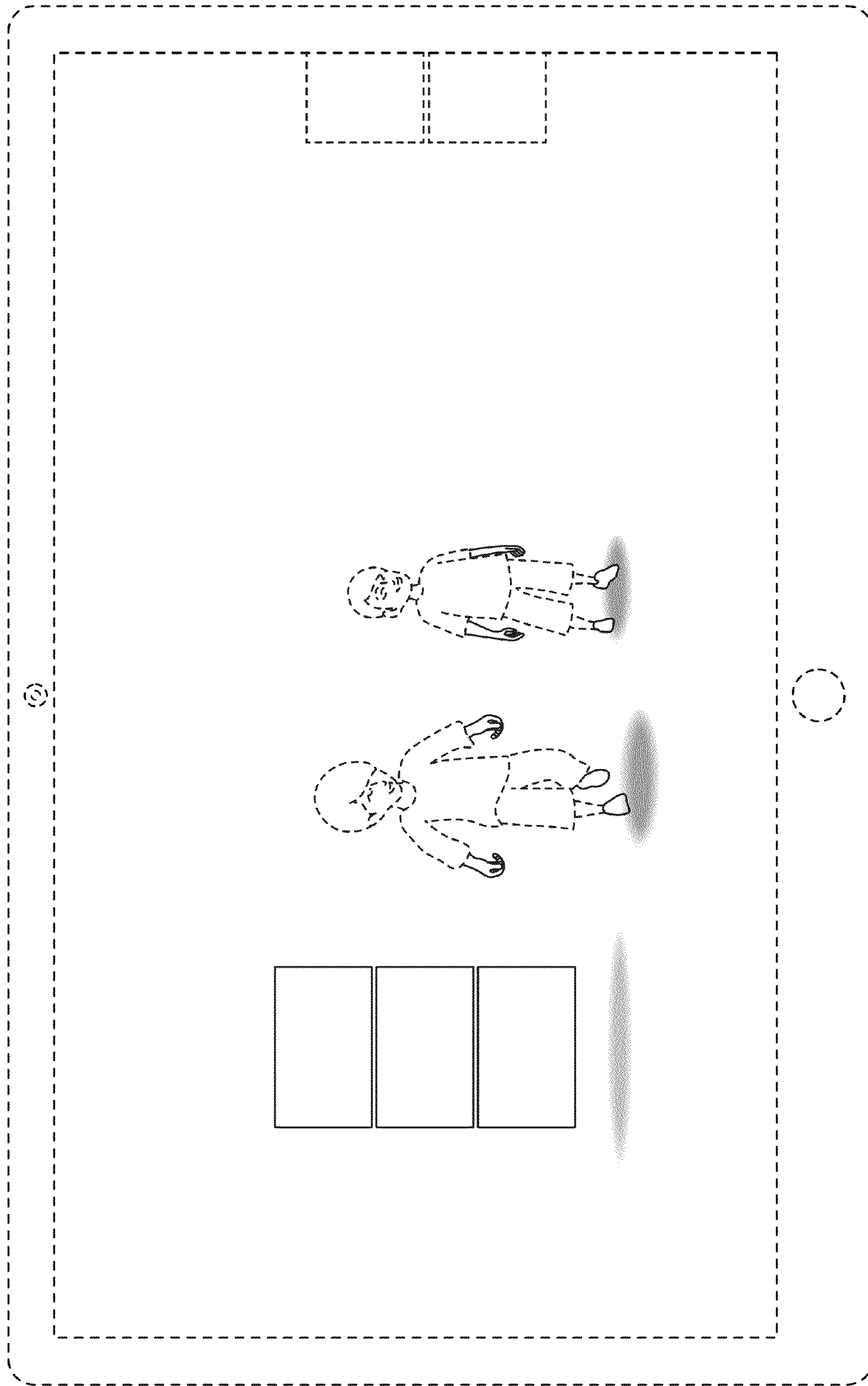

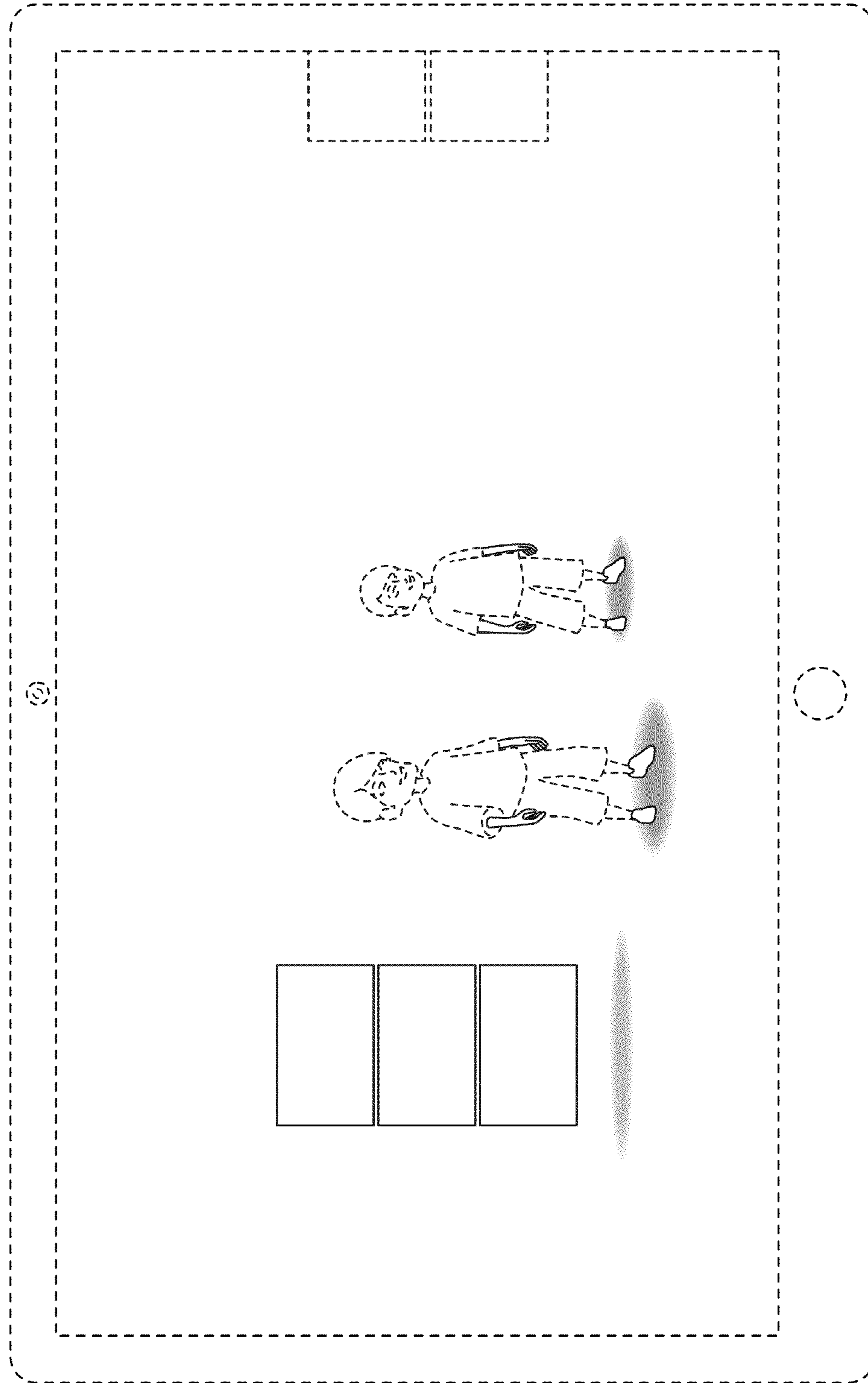
