(57) **CLAIM**

The ornamental design for a display screen with animated user interface, as shown and described.

DESCRIPTION

FIG. 7 is the seventh image thereof;

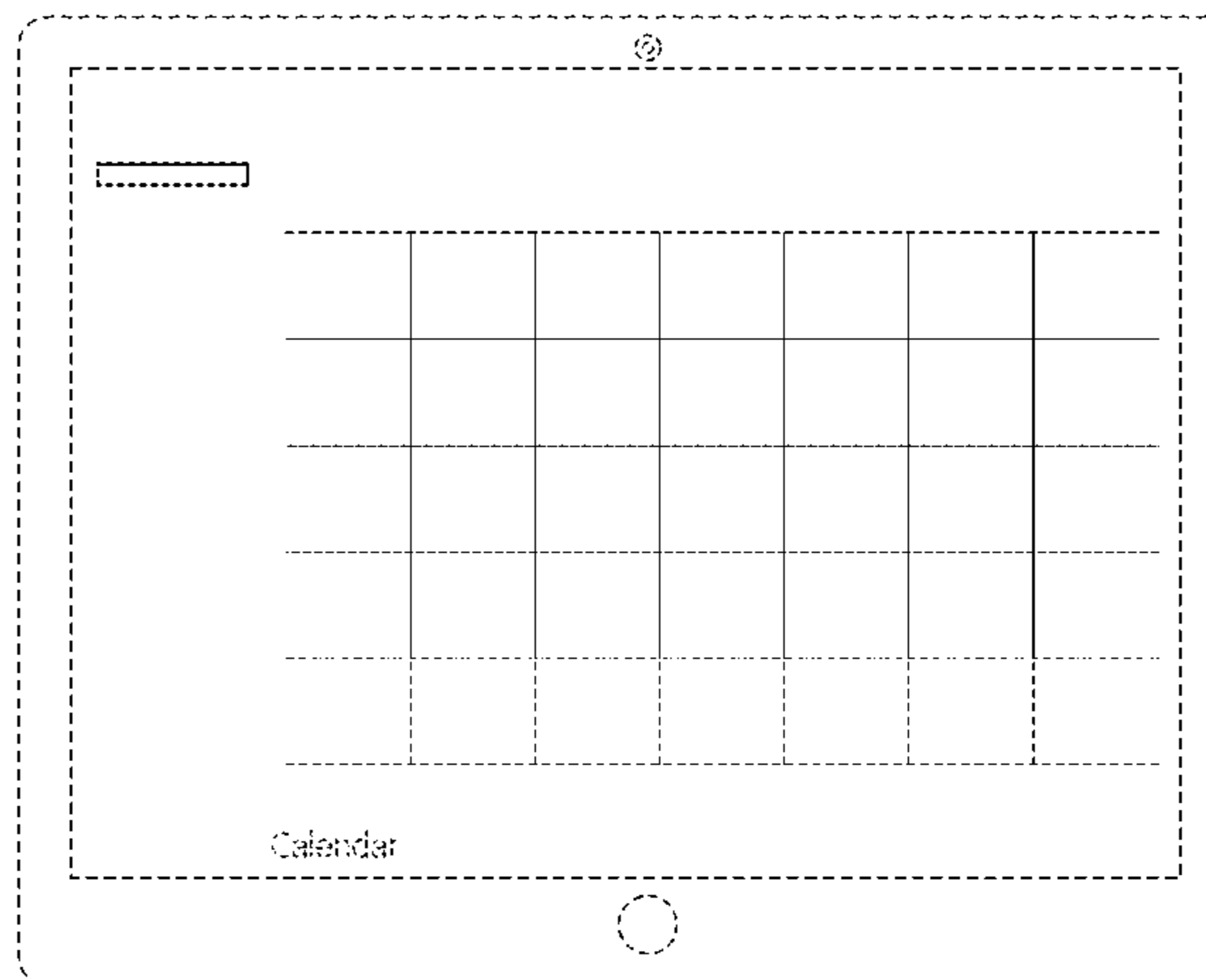
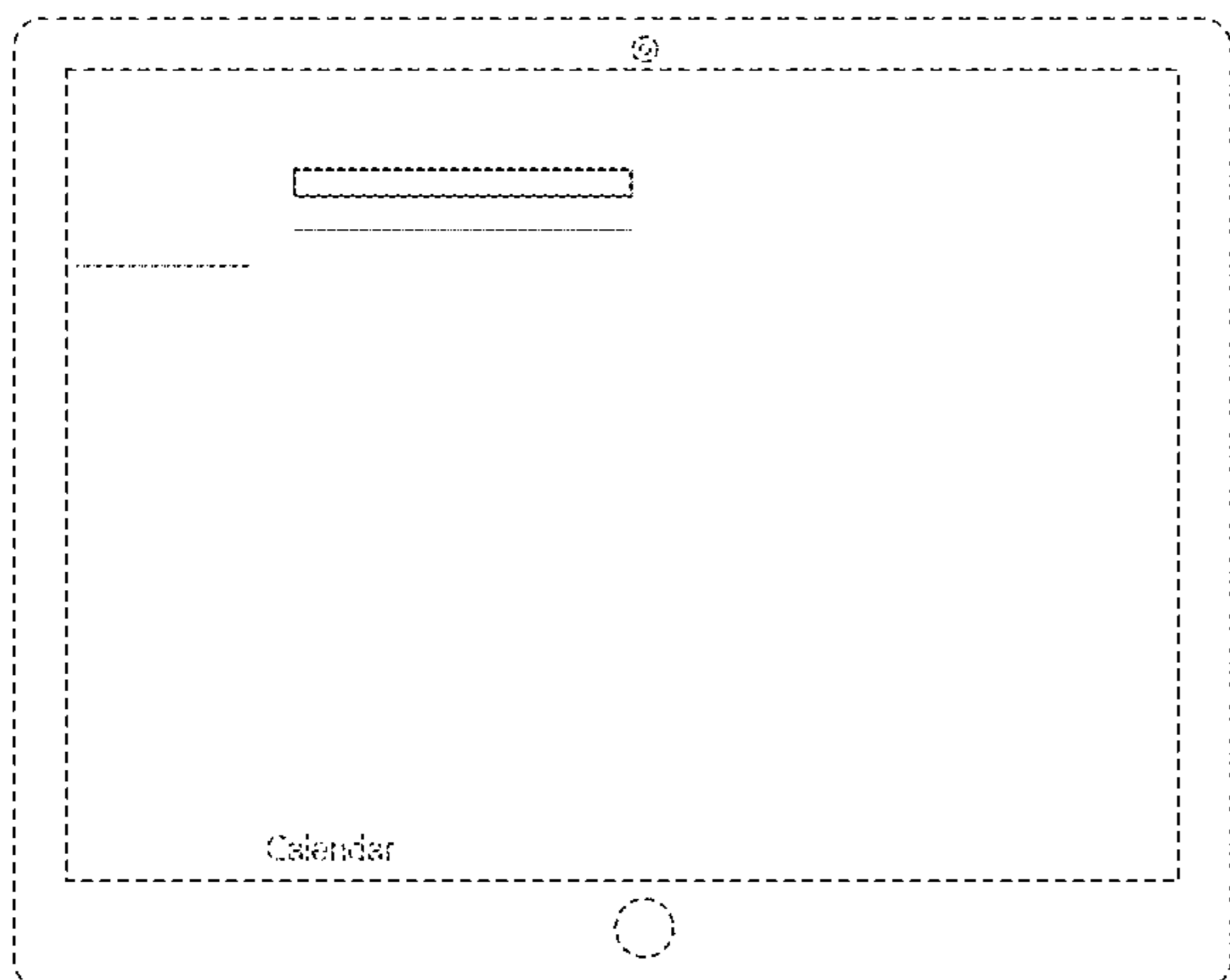
FIG. 8 is the eighth image thereof;

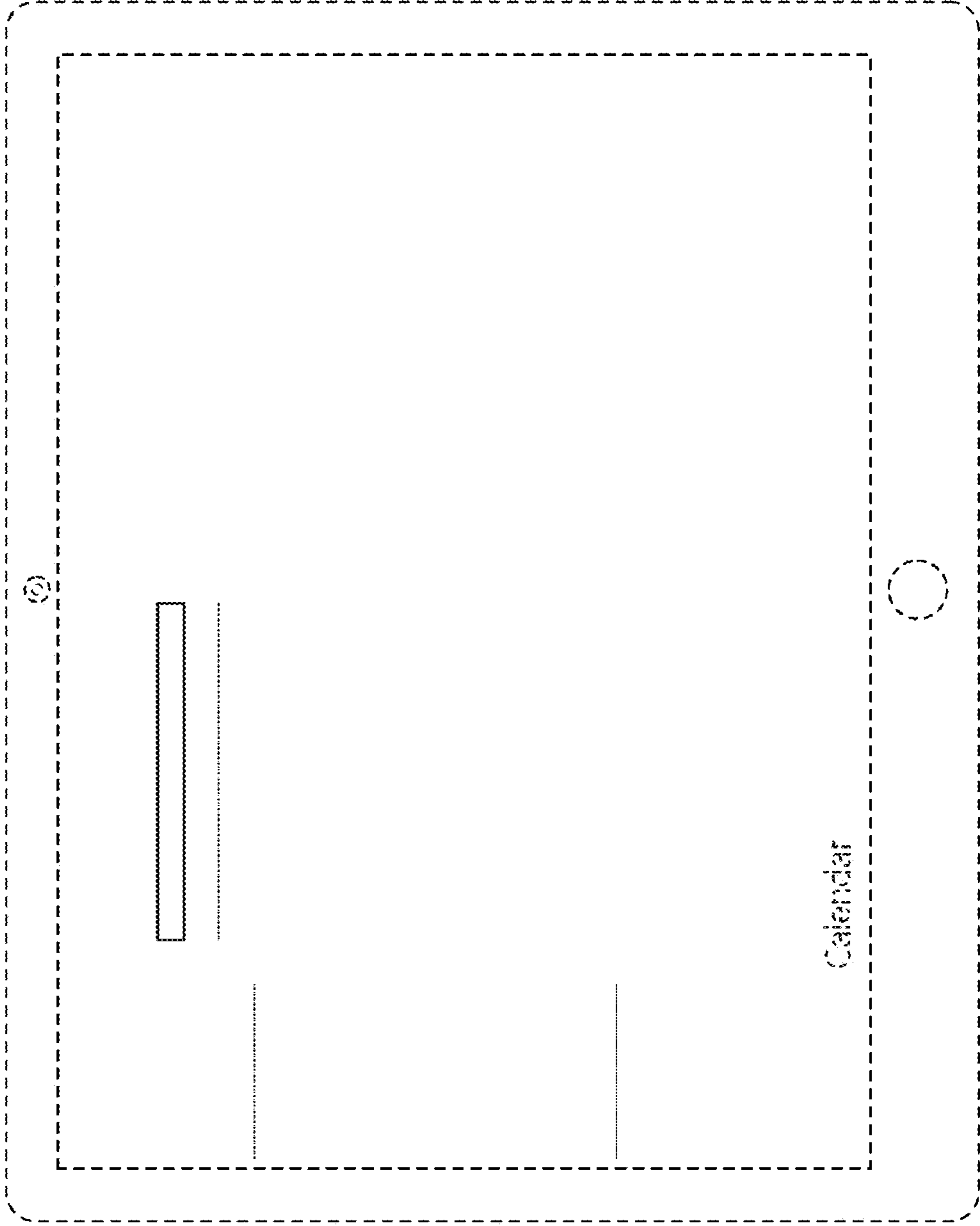

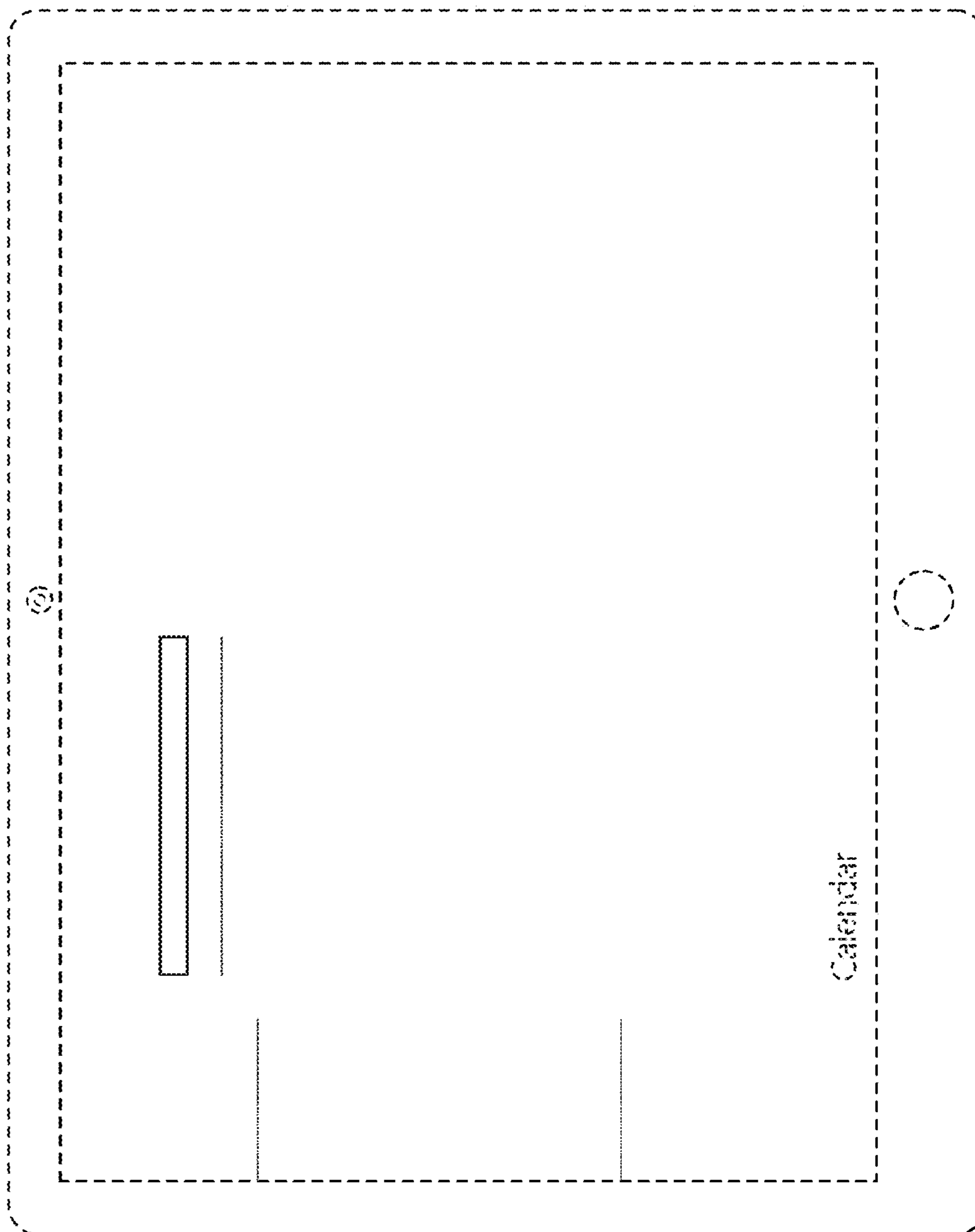

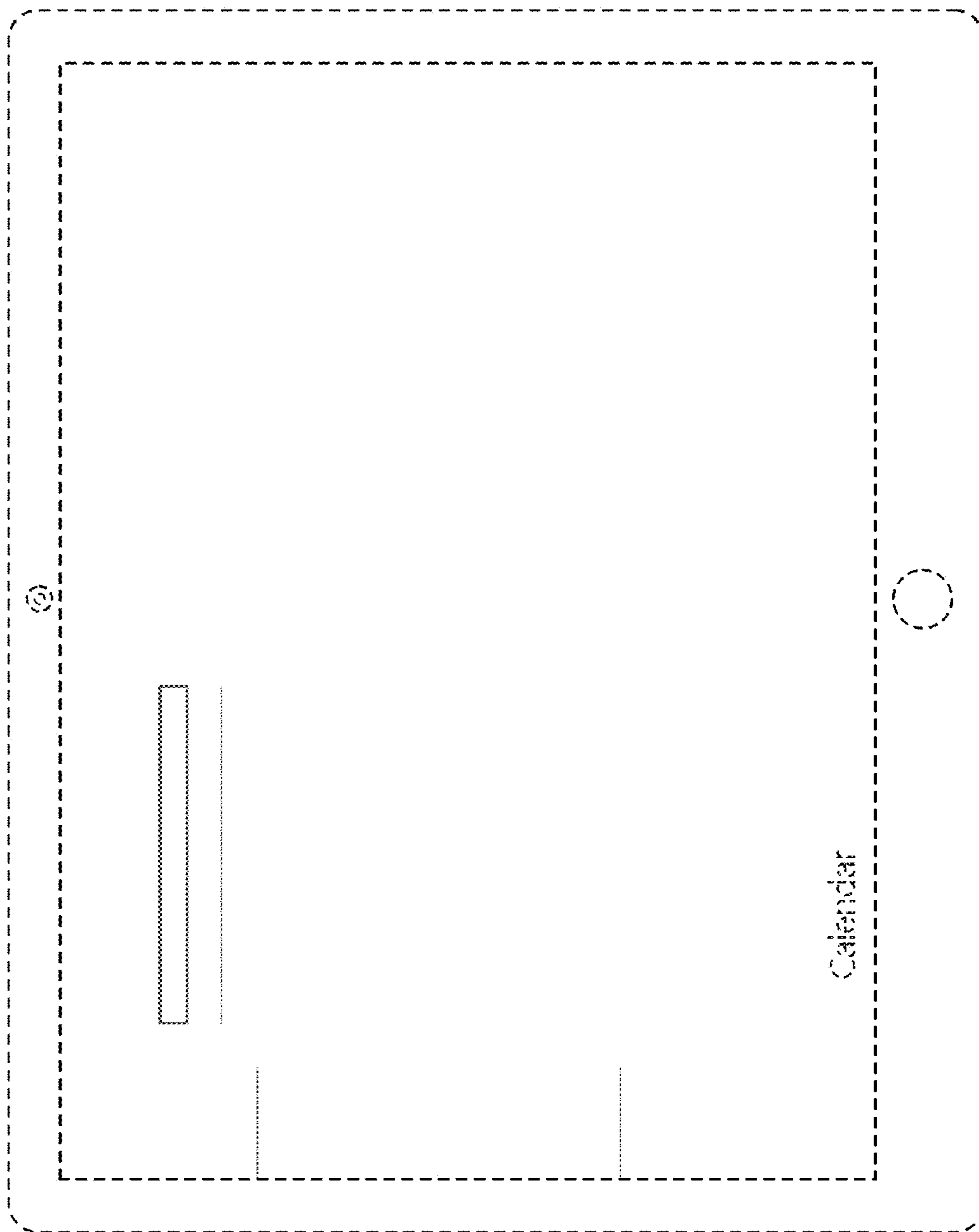

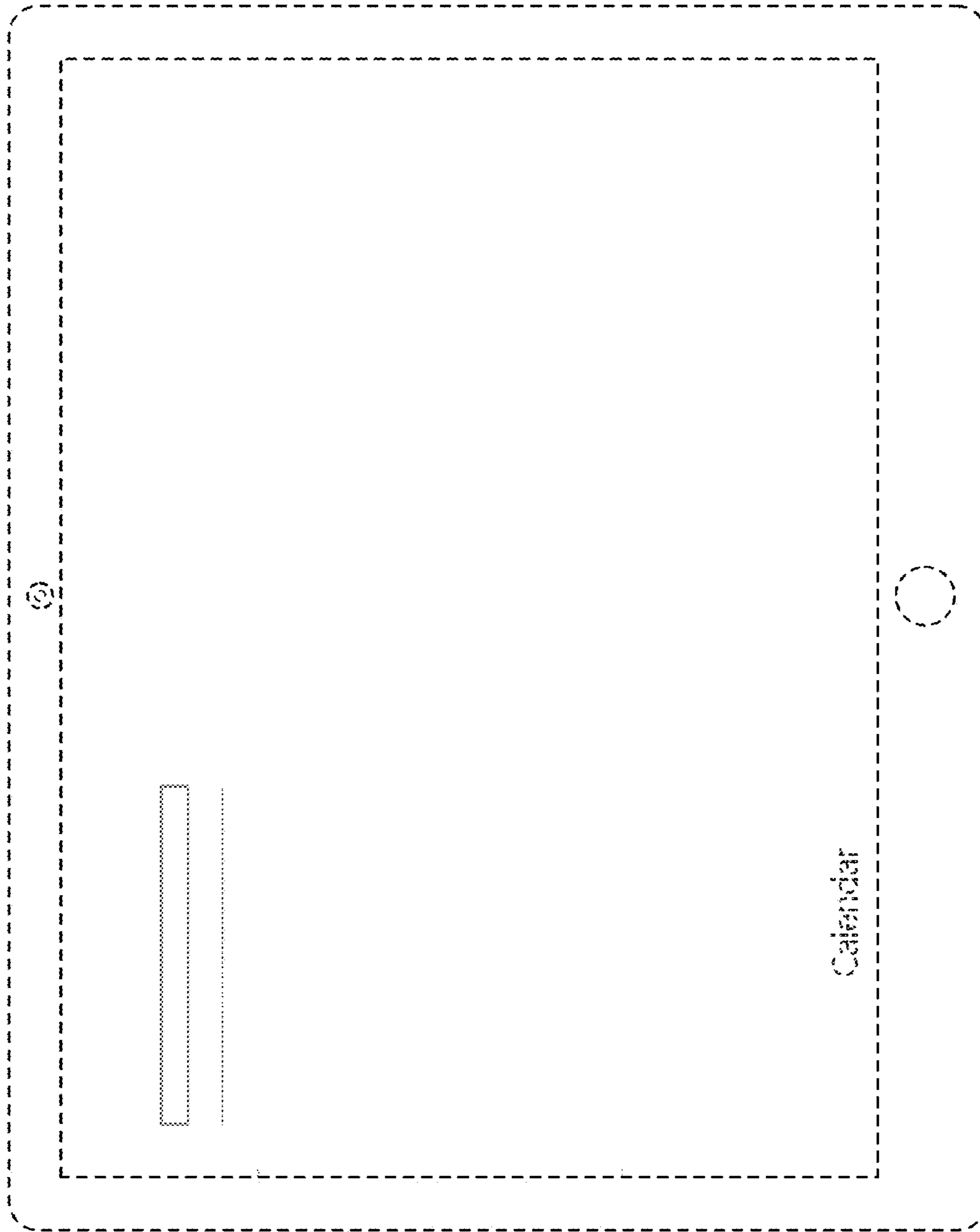
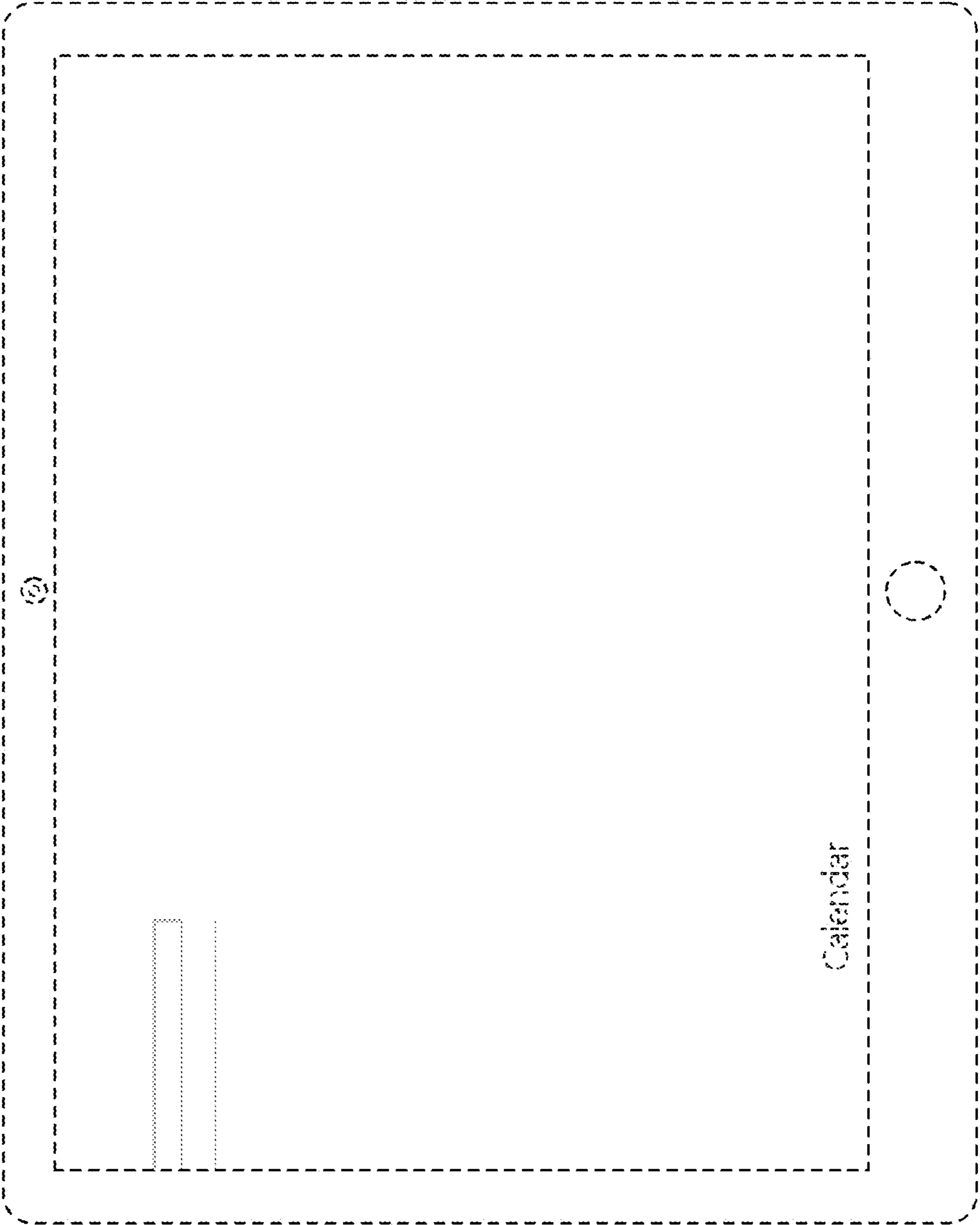
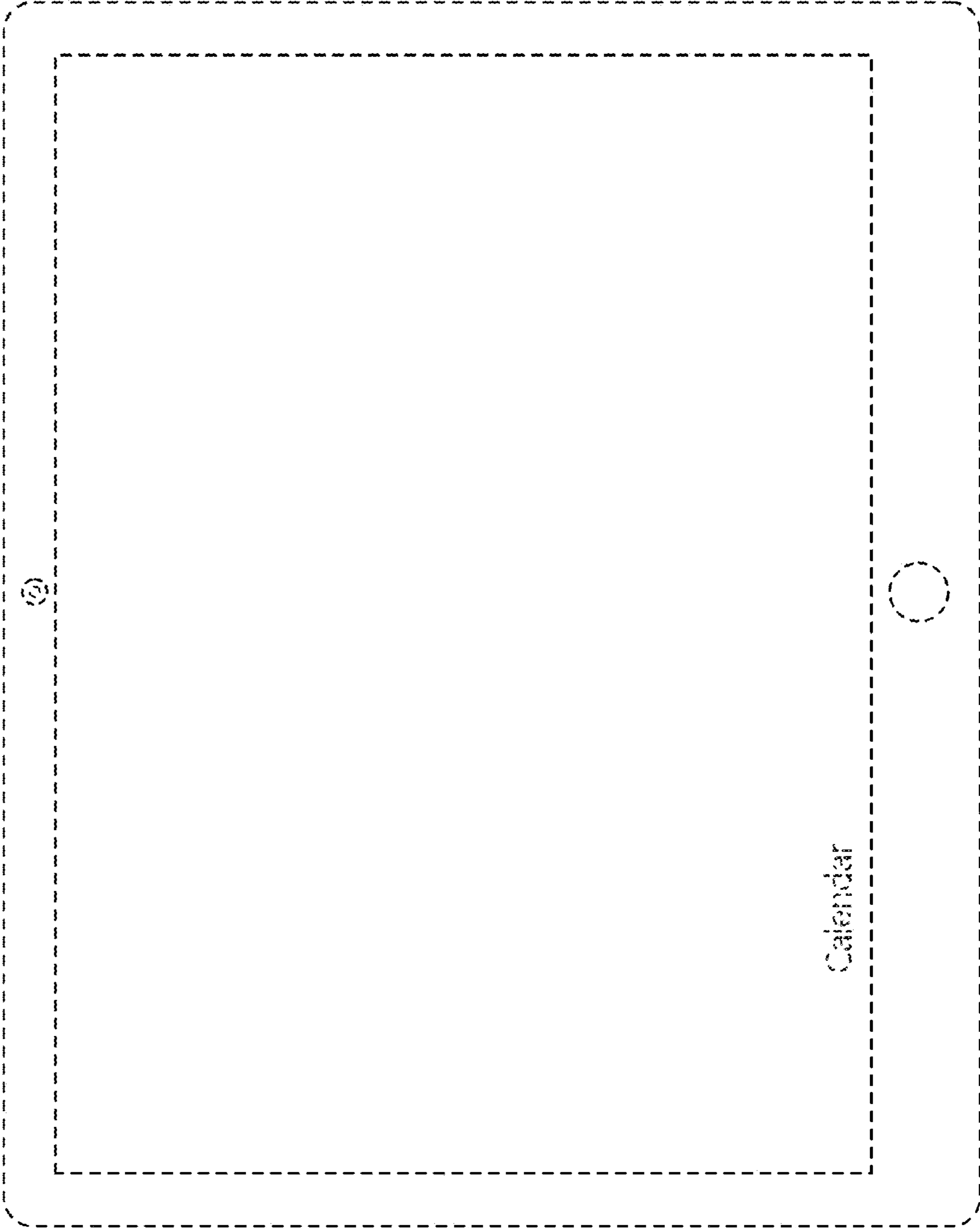


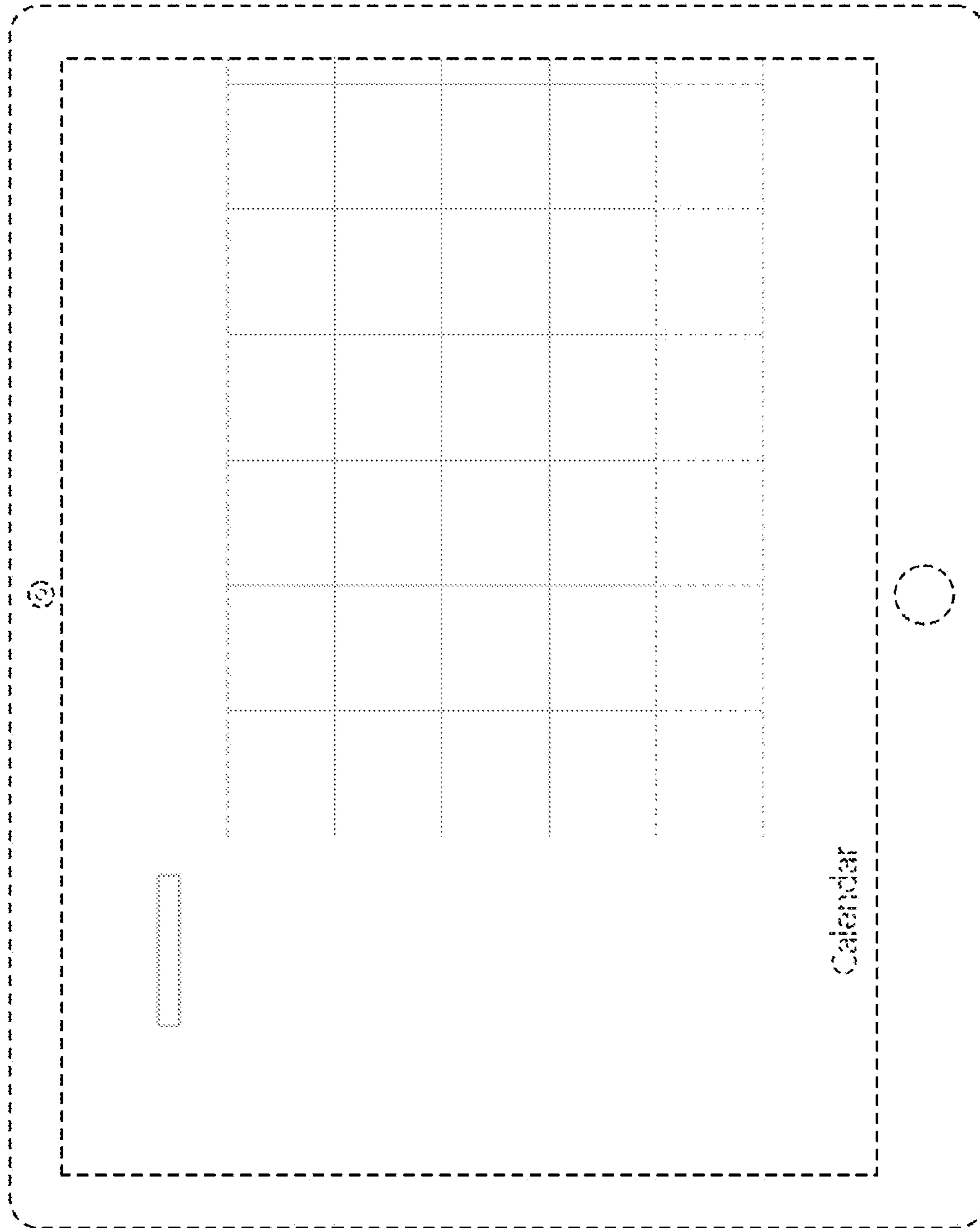

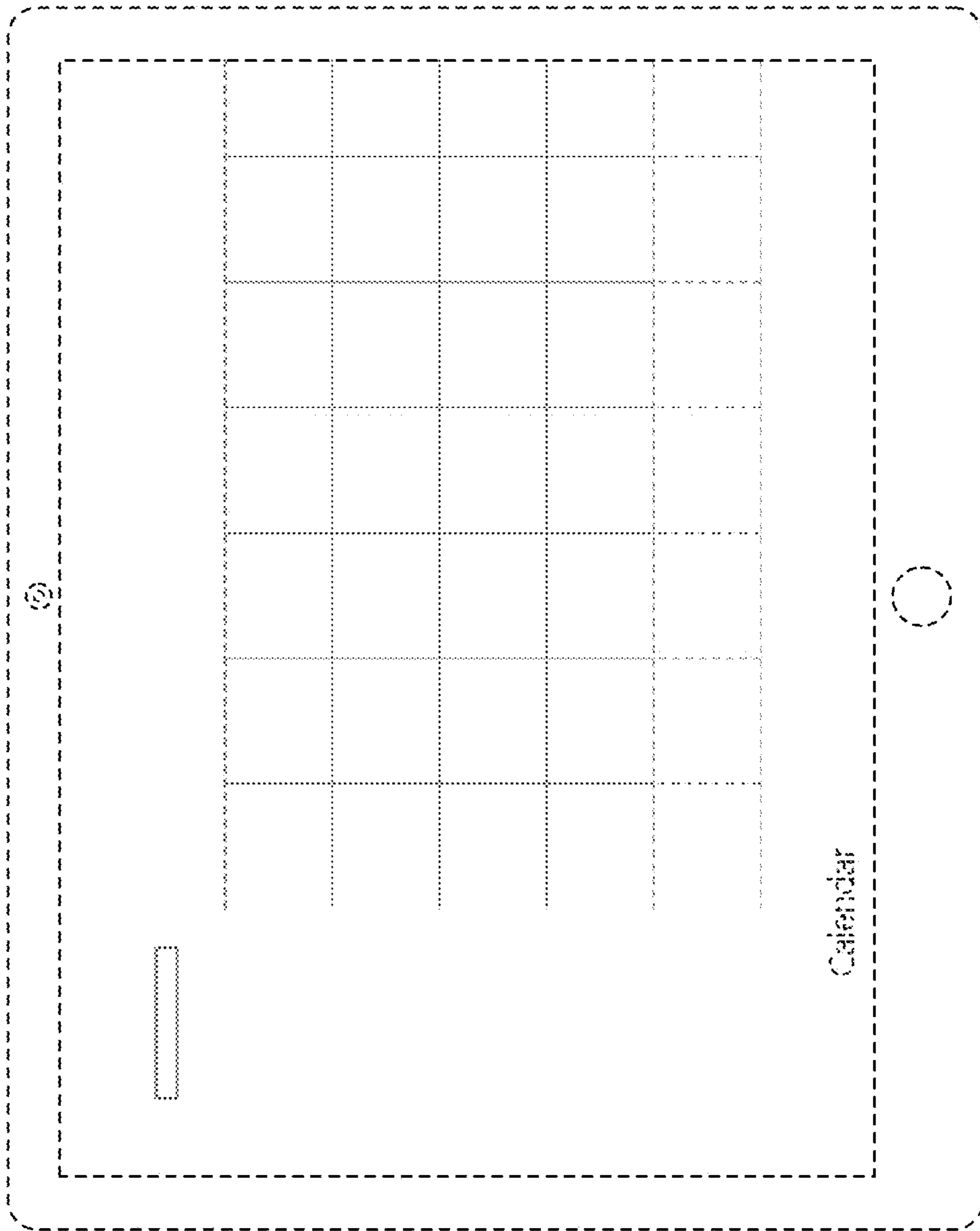
