The ornamental design for a display screen with icon set, as shown and described.

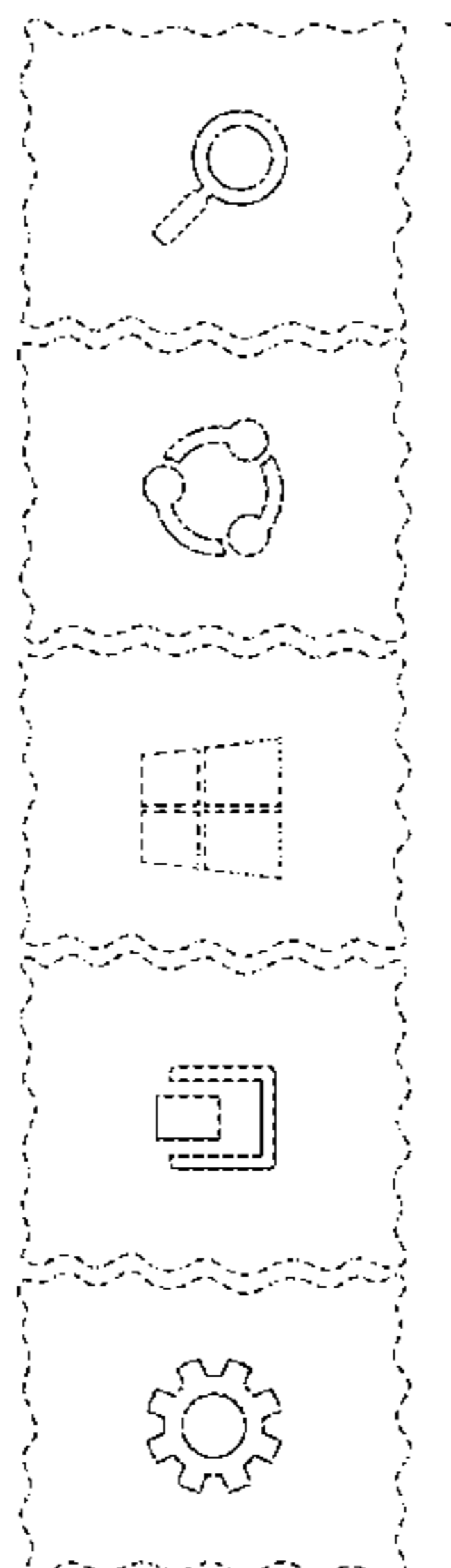
**DESCRIPTION**

FIG. 1 is a front view of a display screen with icon set showing the new design; and,

FIG. 2 is a front view of a display screen with icon set showing an alternative embodiment of the design of FIG. 1.

The broken line showing of the icon and the remainder of the display screen is for environmental purposes only and forms no part of the claimed design. The icon set in FIGS. 1 and 2 are arranged relatively on the drawing sheet for the convenience of display and their relative positioning forms no part of the claimed design.

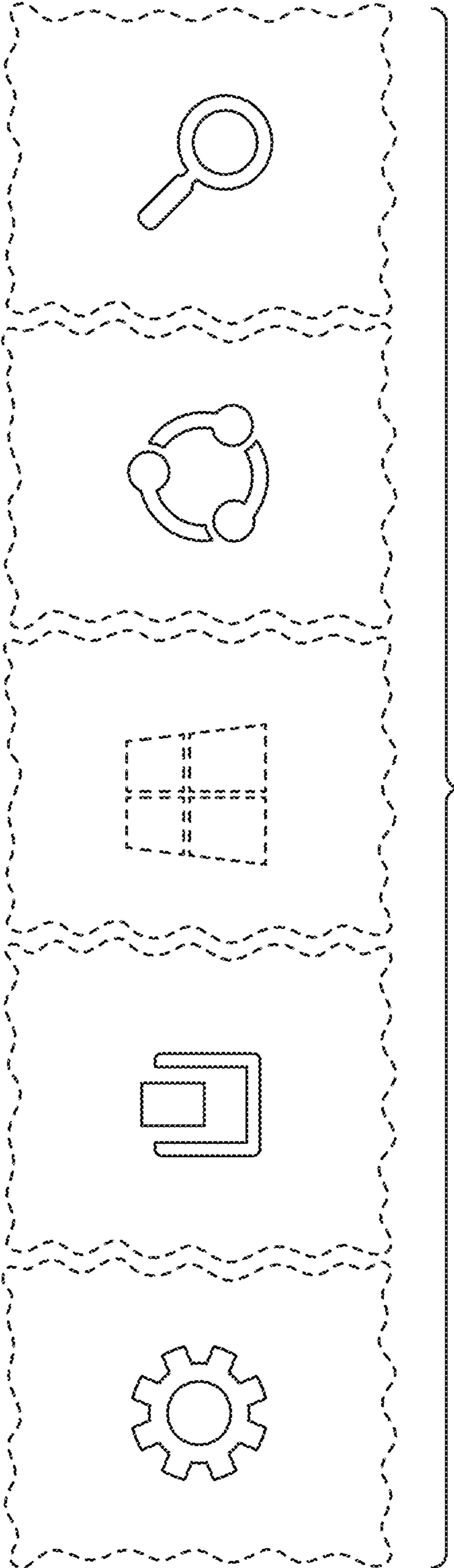

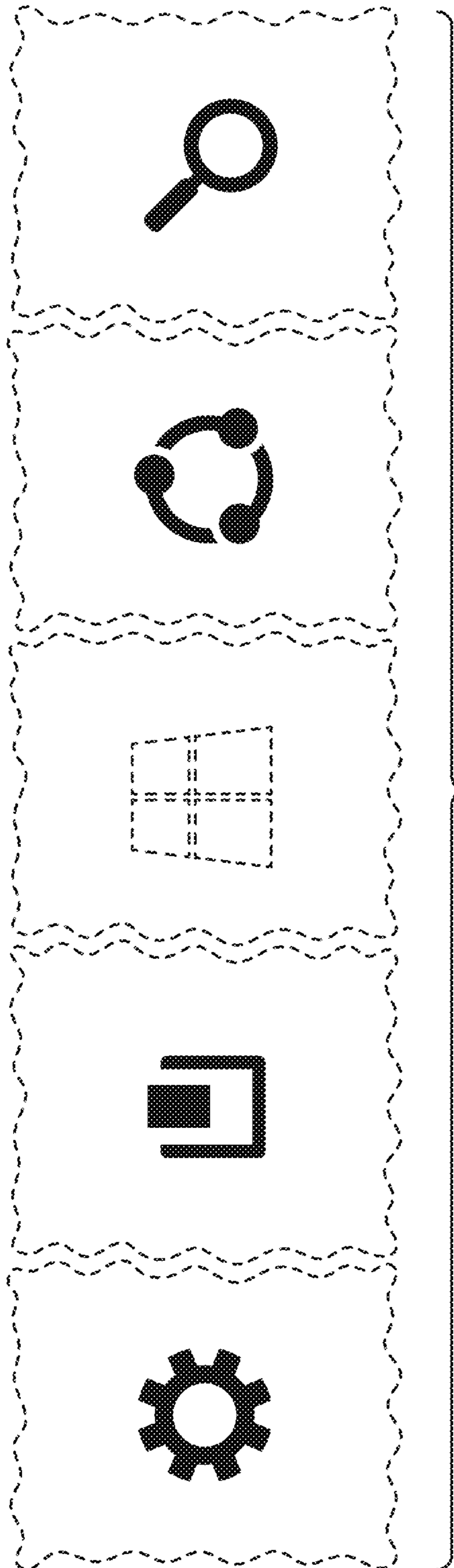
