FIG. 1 is a perspective view of a turf cutting reel showing our new design;

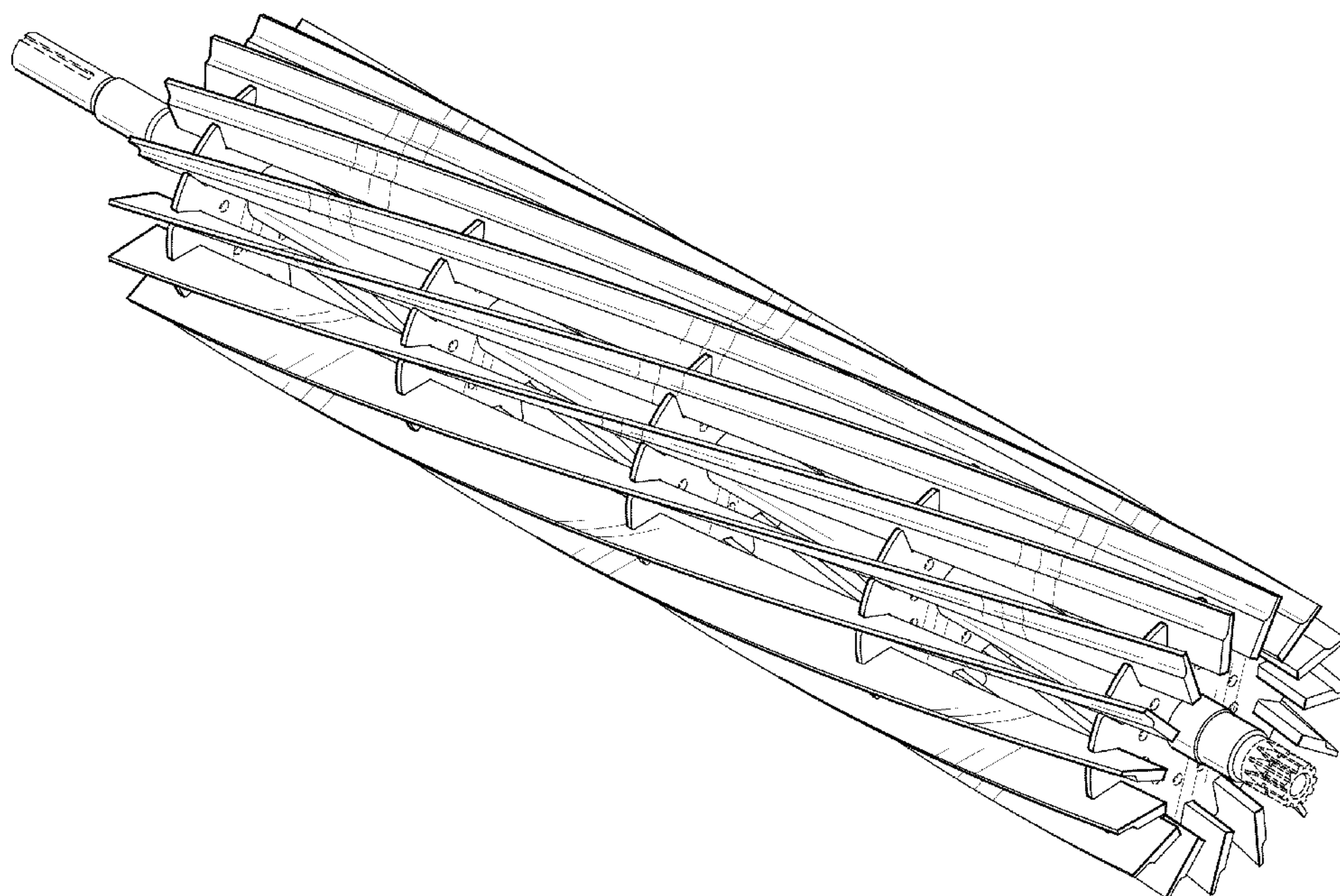
FIG. 2 is a front view thereof;

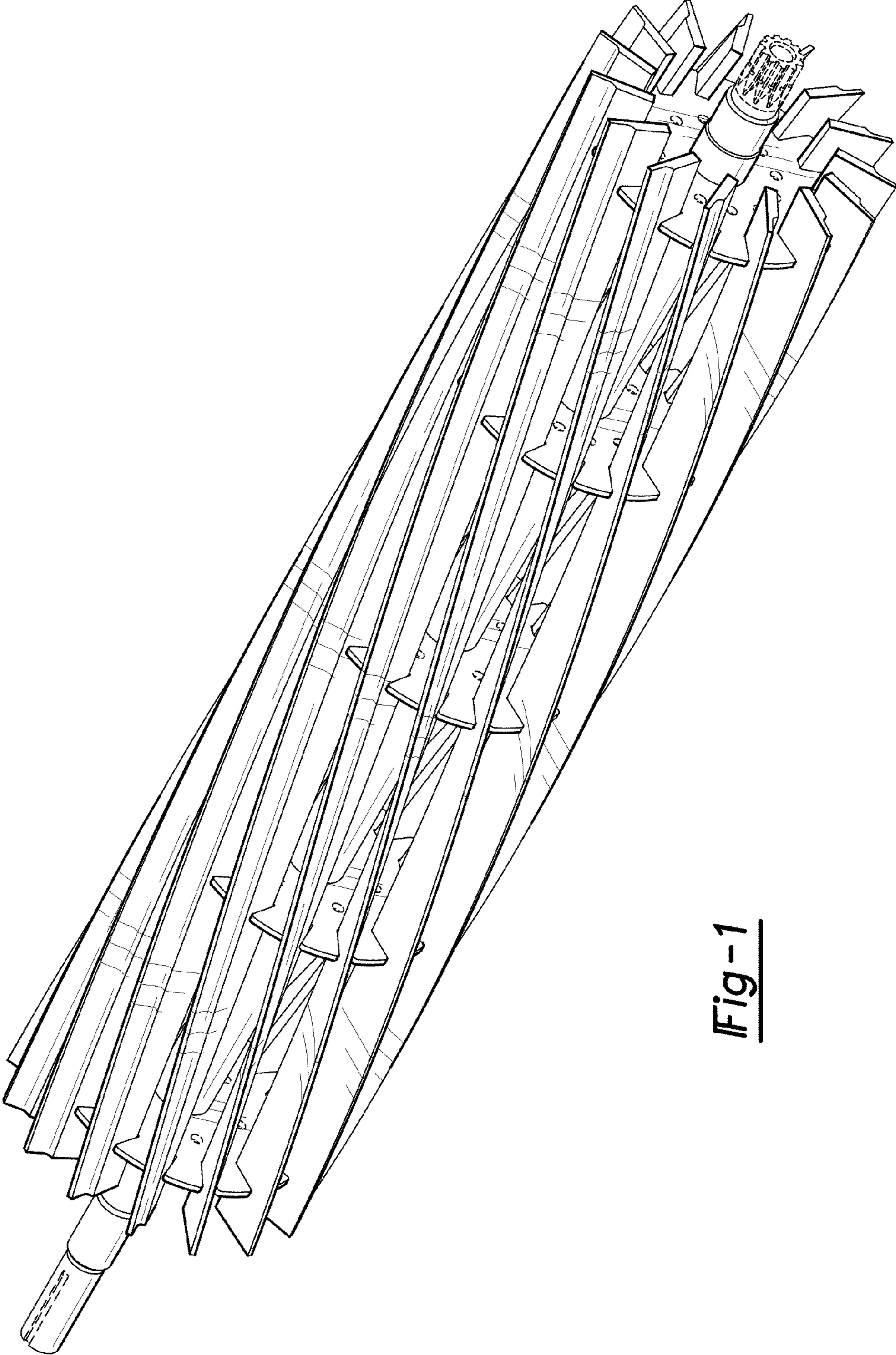

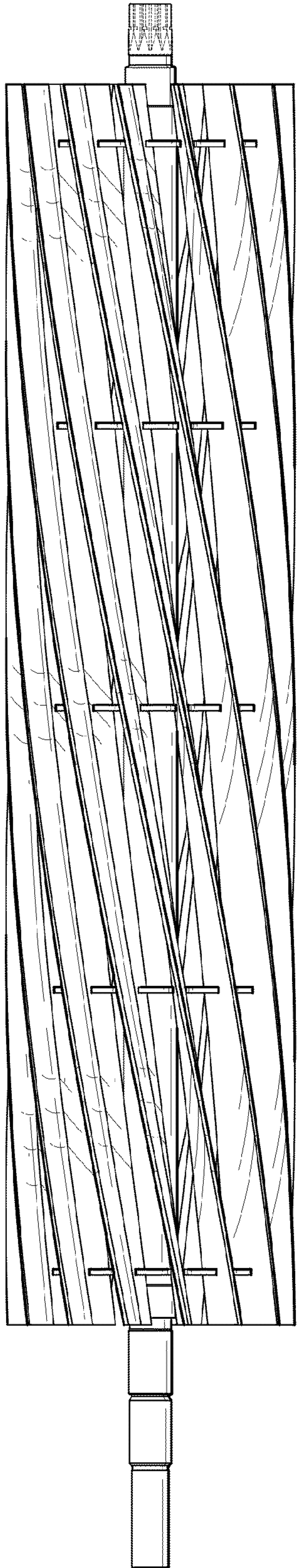

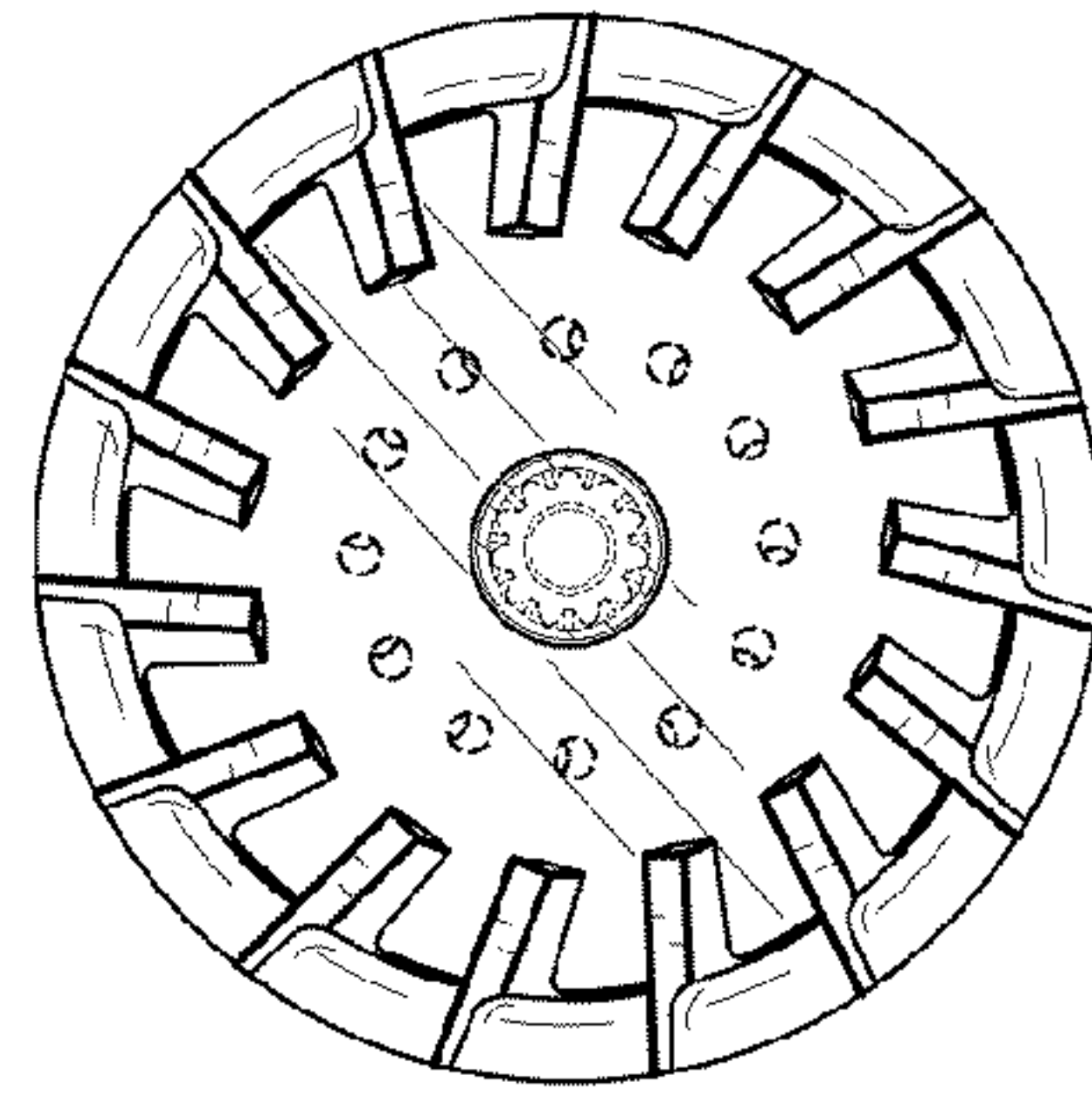

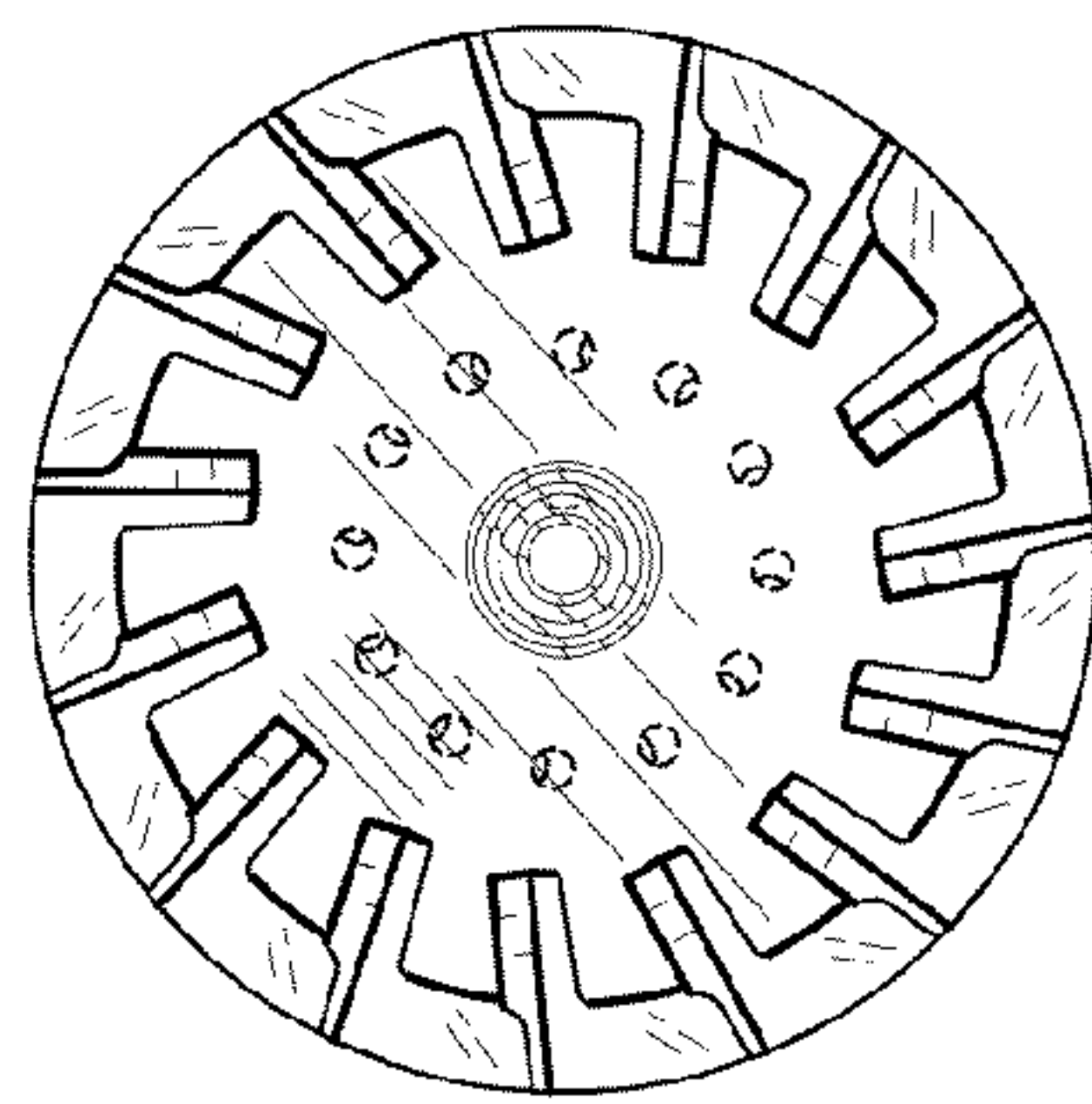
