(57) **CLAIM**

We claim the ornamental design for a collapsible three dimensional vector demonstration and measurement device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a collapsible three dimensional vector demonstration and measurement device in an open configuration showing my new design.

FIG. 2 is a front view of the device as depicted in FIG. 1.

FIG. 3 is a right side view of the device as depicted in FIG. 1.

FIG. 4 is a rear elevation view of the device as depicted in FIG. 1.

FIG. 5 is a left side elevation view of the device as depicted in FIG. 1.

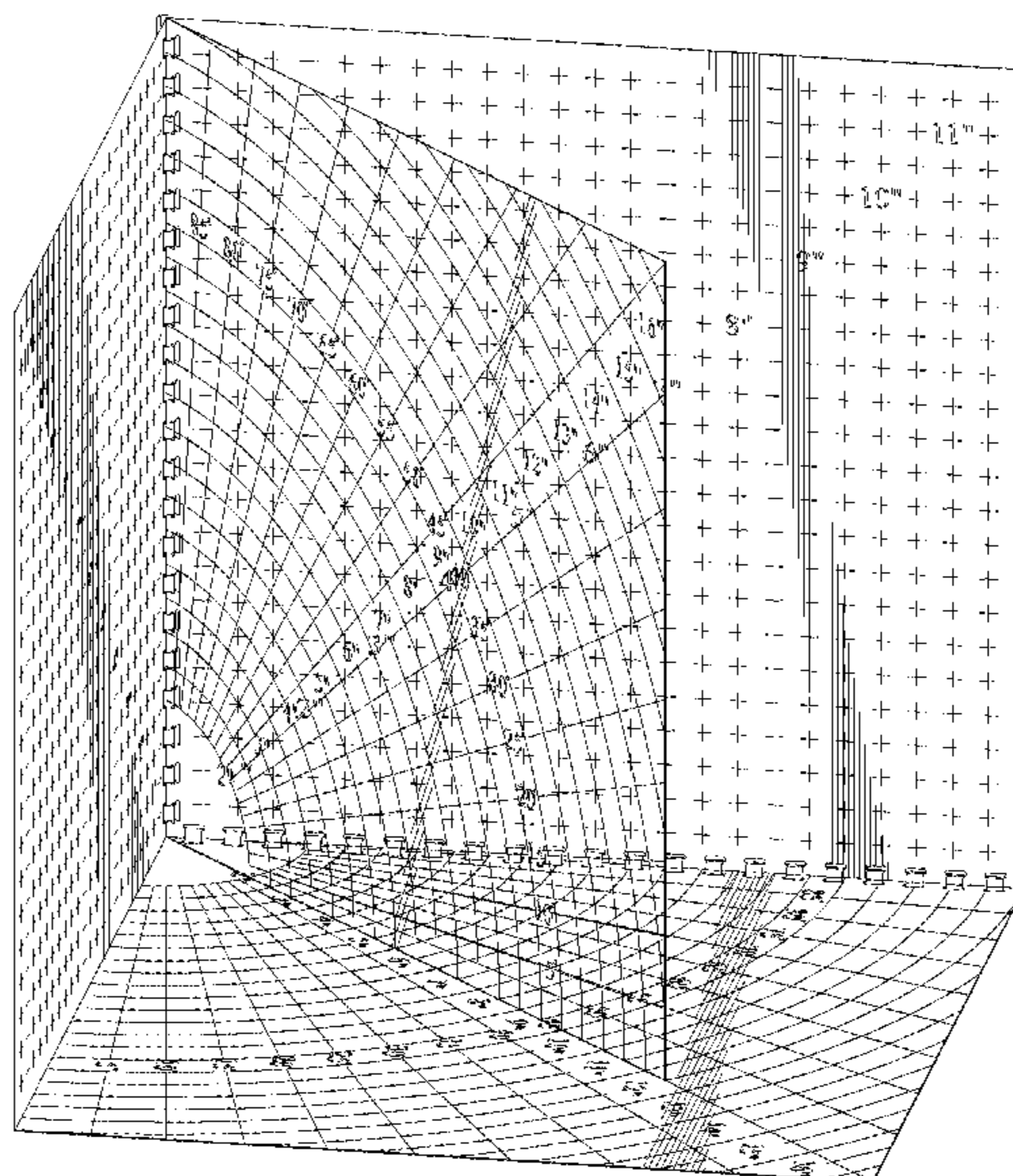
FIG. 6 is a top plan view of the device as depicted in FIG. 1.

FIG. 7 is a bottom plan view of the device as depicted in FIG. 1; and,

FIG. 8 is a perspective view of the device in a collapsed configuration.

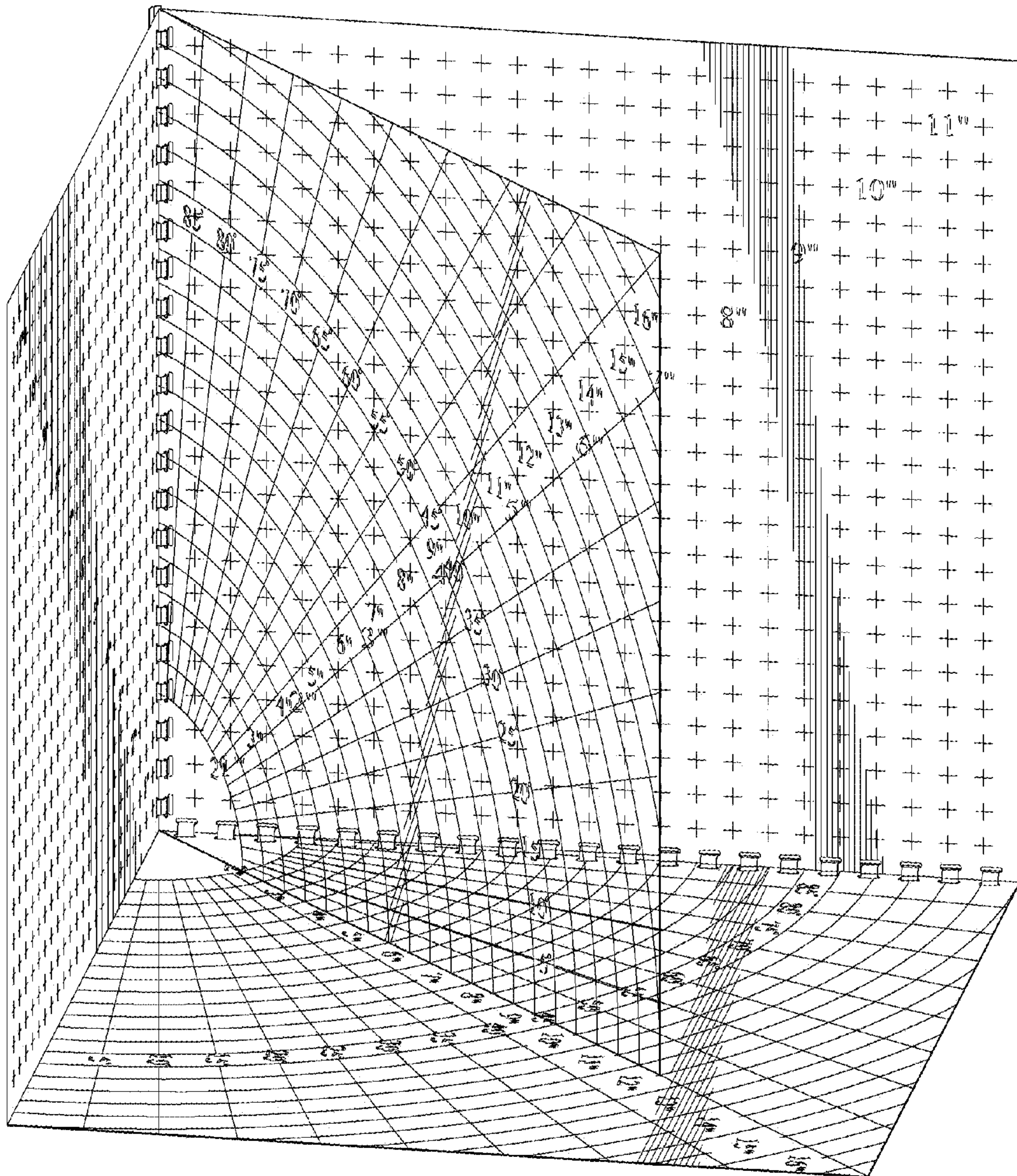

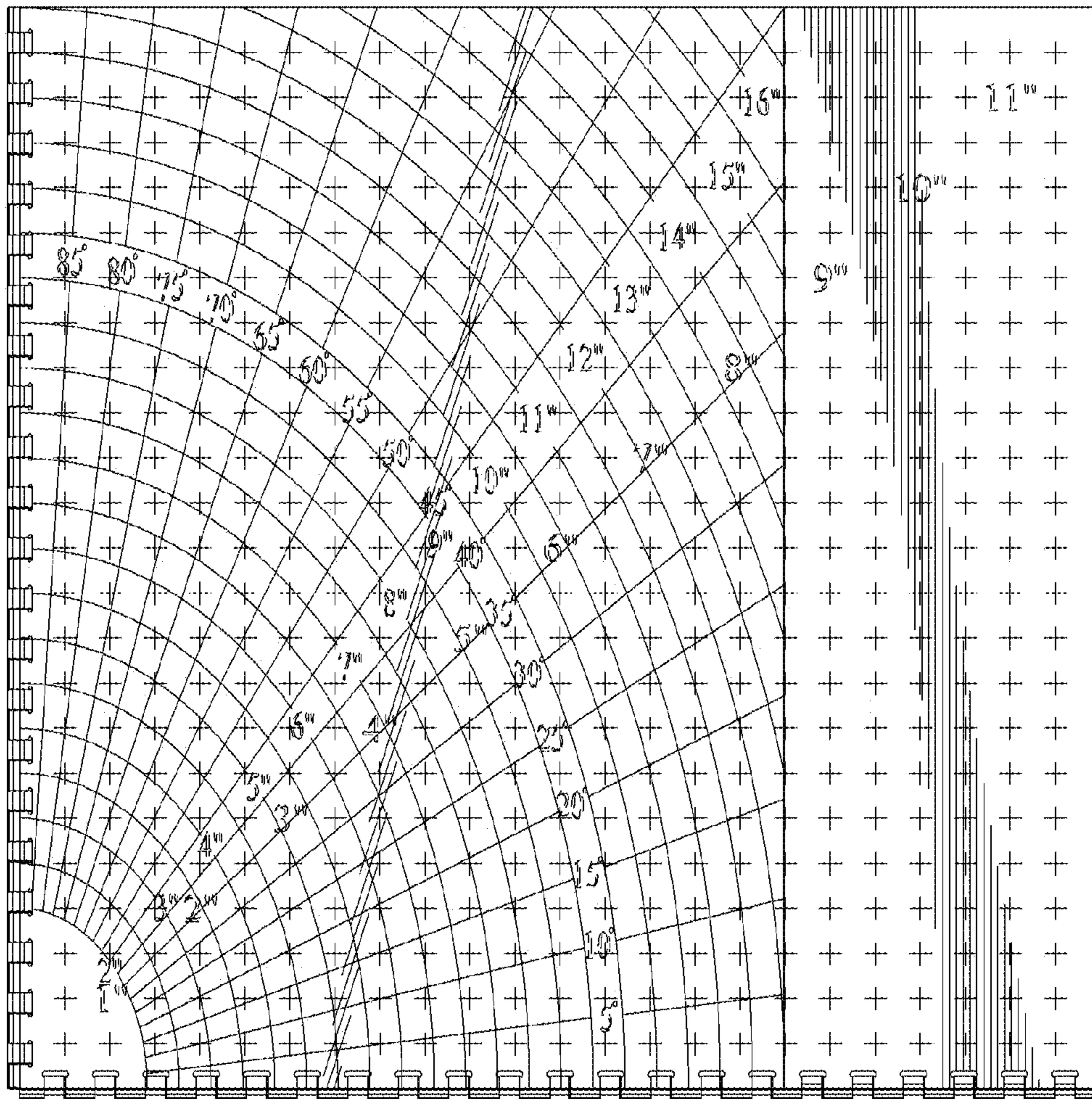

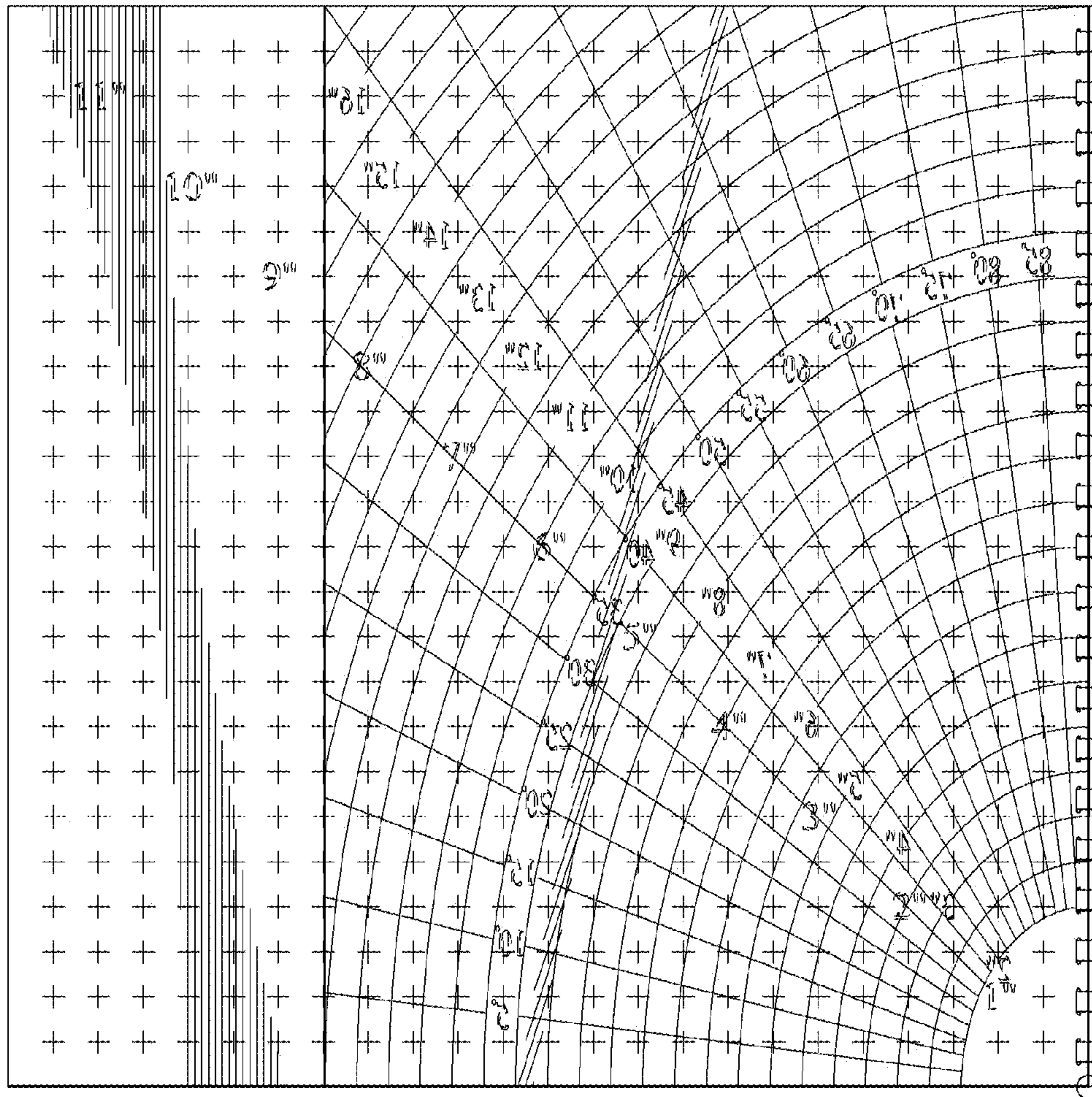

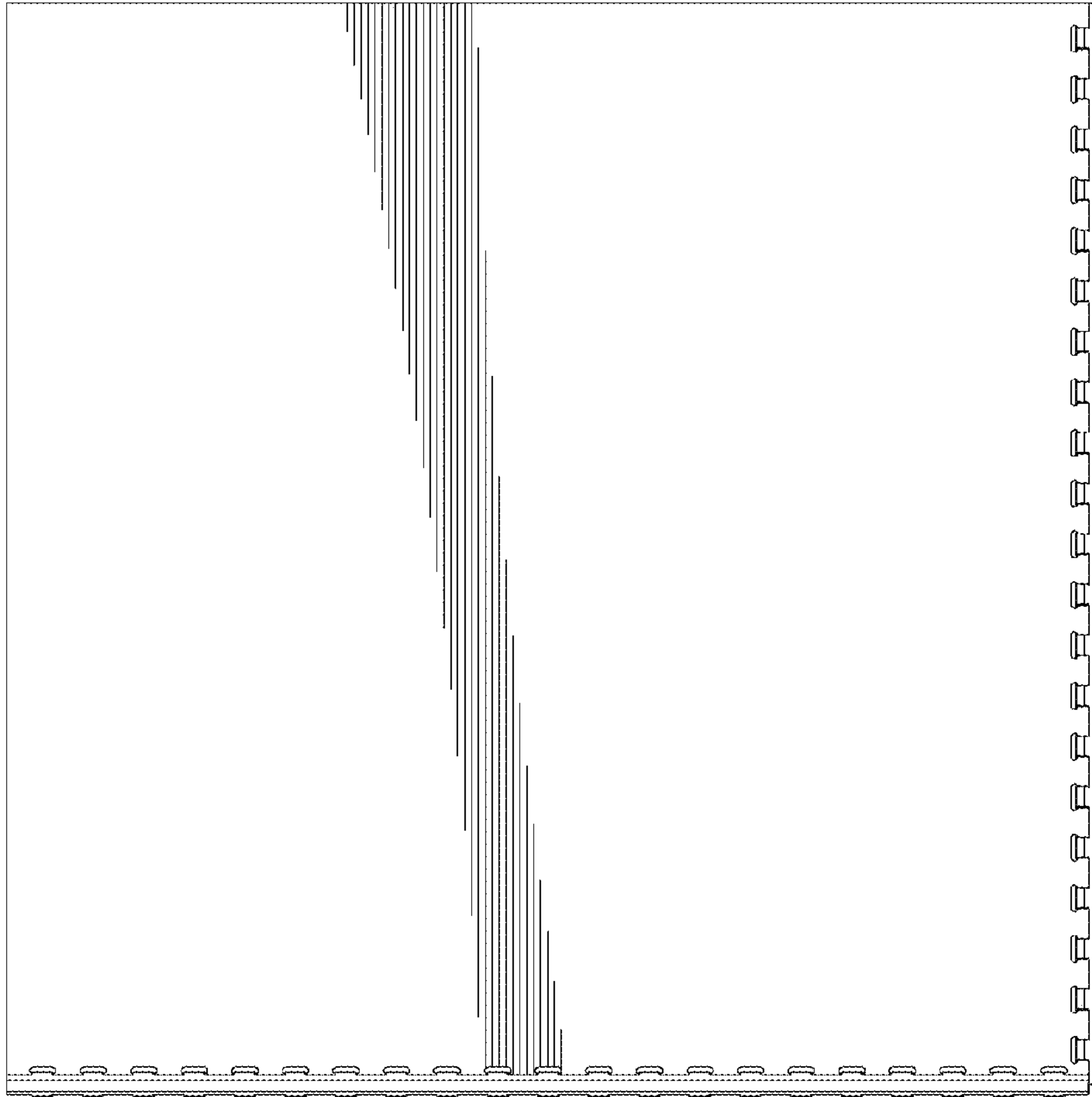

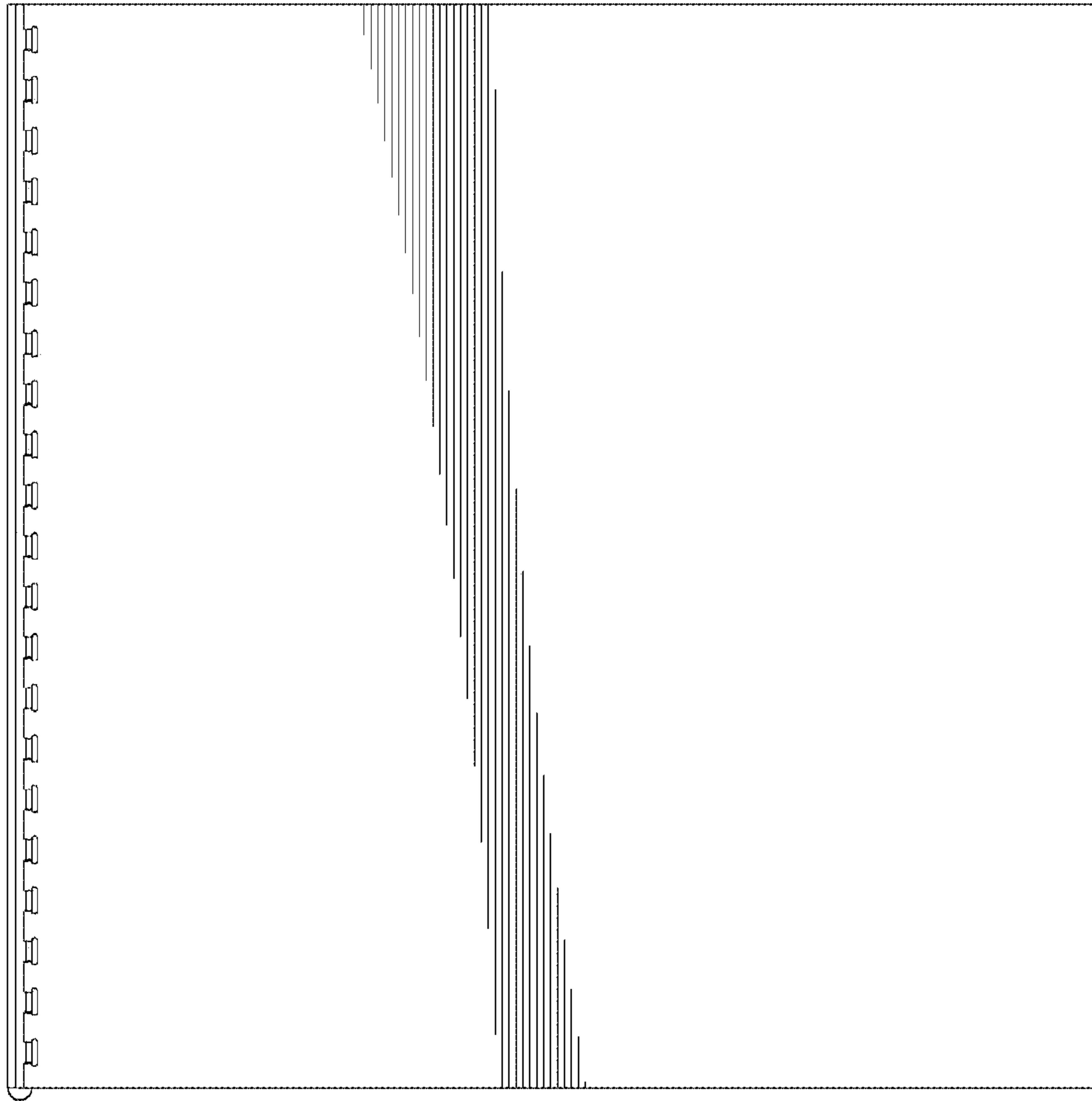

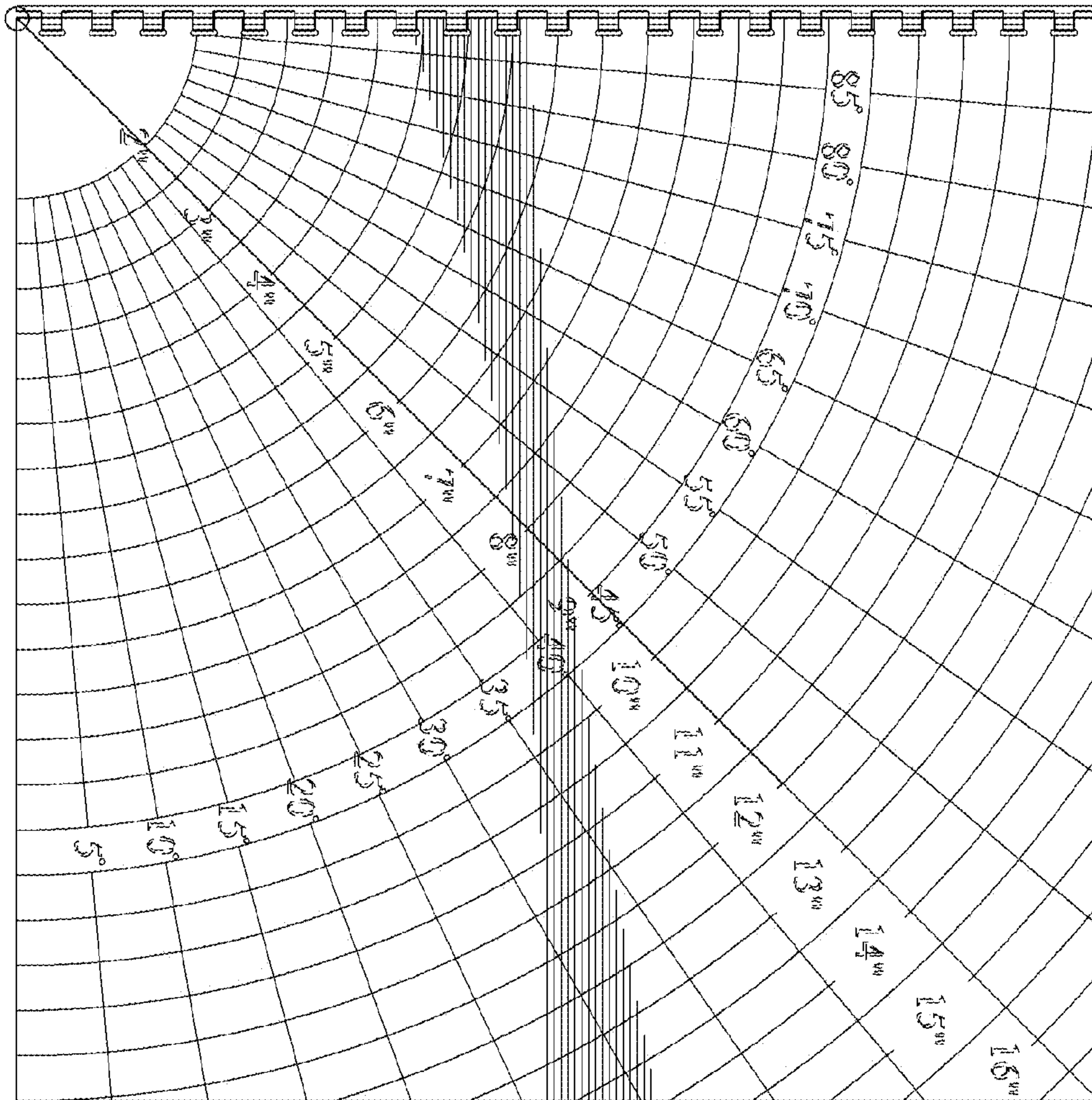

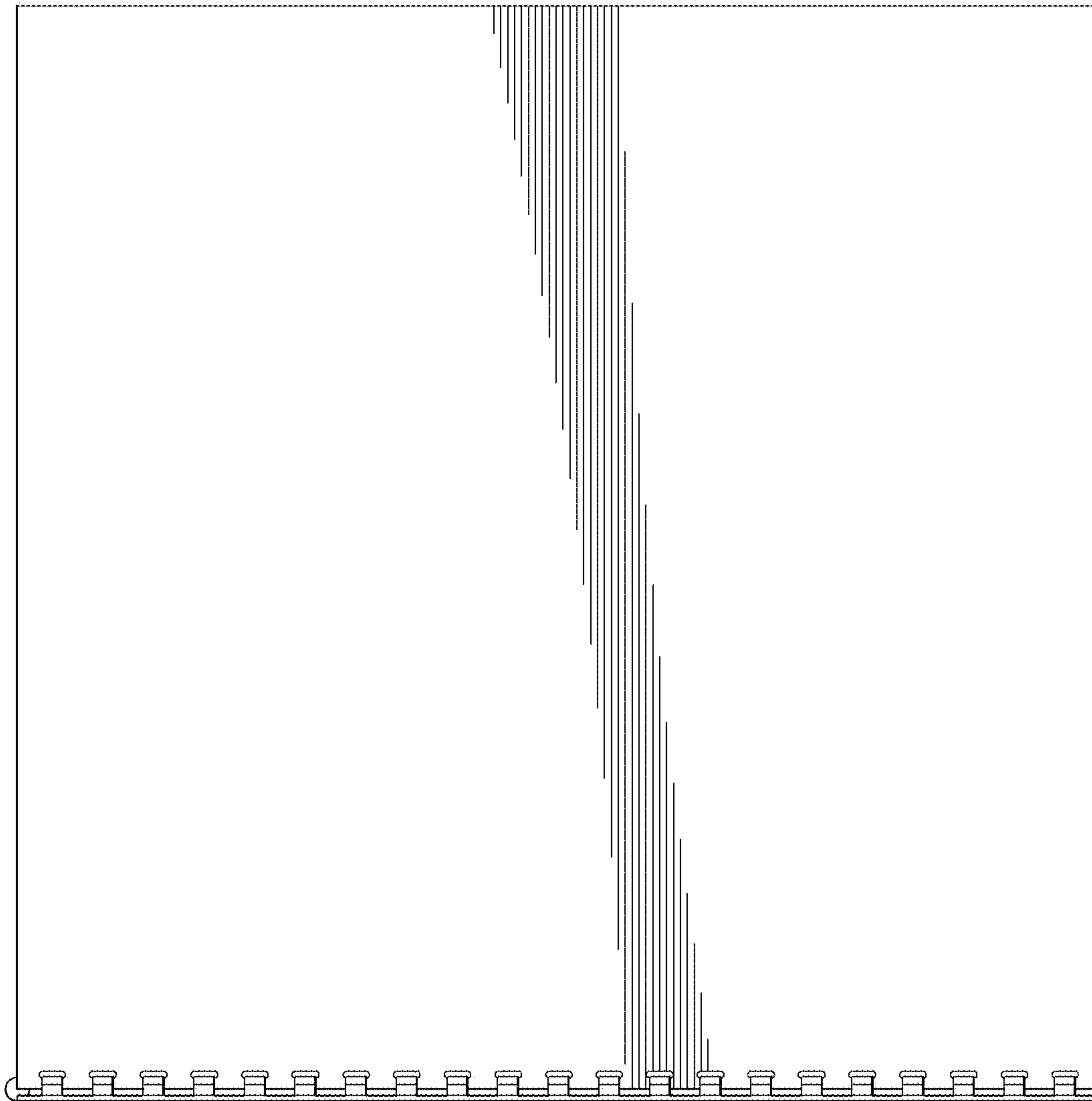

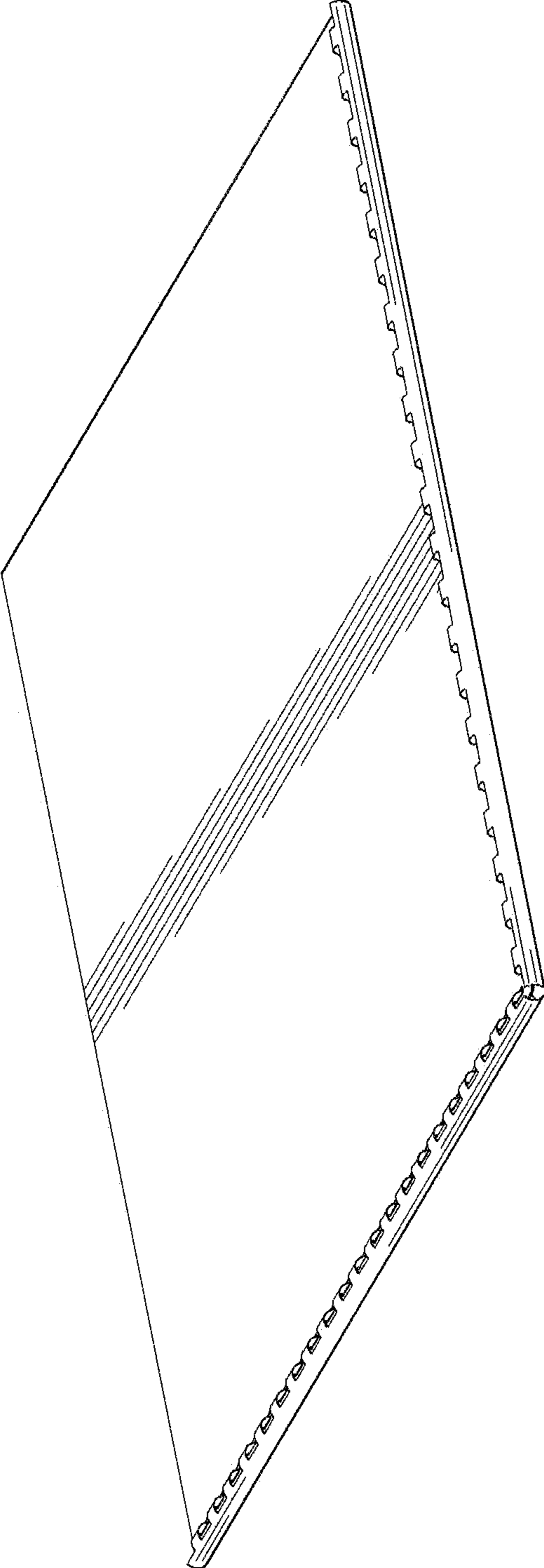
