(57) **CLAIM**

I claim the ornamental design for an exercise harness, as shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of an exercise harness showing my new design, shown in a stretched condition of use;

FIG. 2 is a front and side perspective view thereof, shown in a condition of rest;

FIG. 3 is a front elevational view of FIG. 2, the rear elevational view being a mirror image thereof;

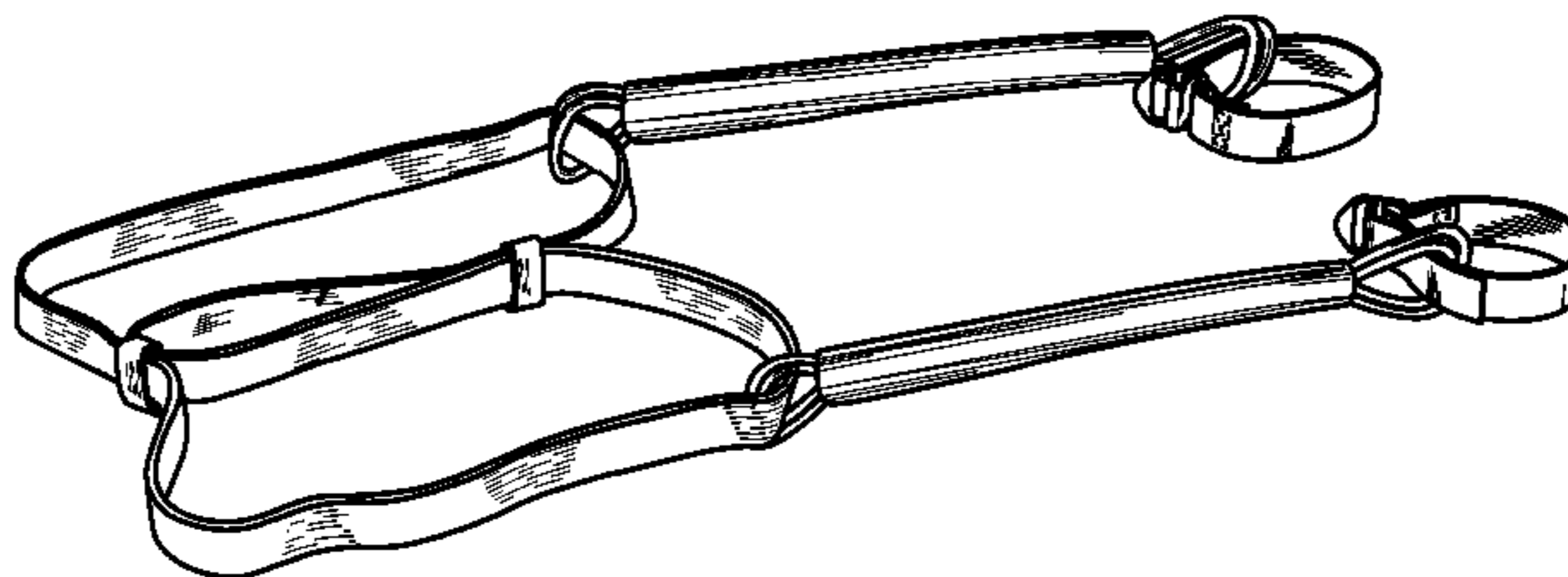
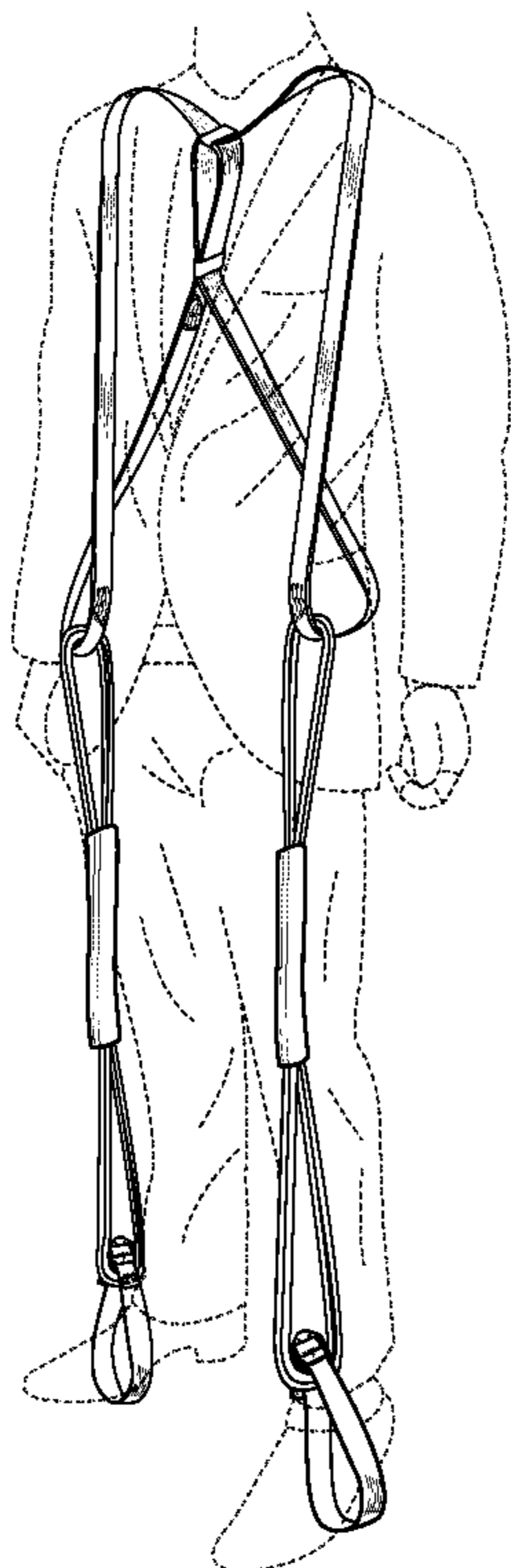
FIG. 4 is a top plan view of FIG. 2;

FIG. 5 is a bottom plan view of FIG. 2; and,

FIG. 6 is a left-side elevational view of FIG. 2, the right-side elevational view being a mirror image thereof.

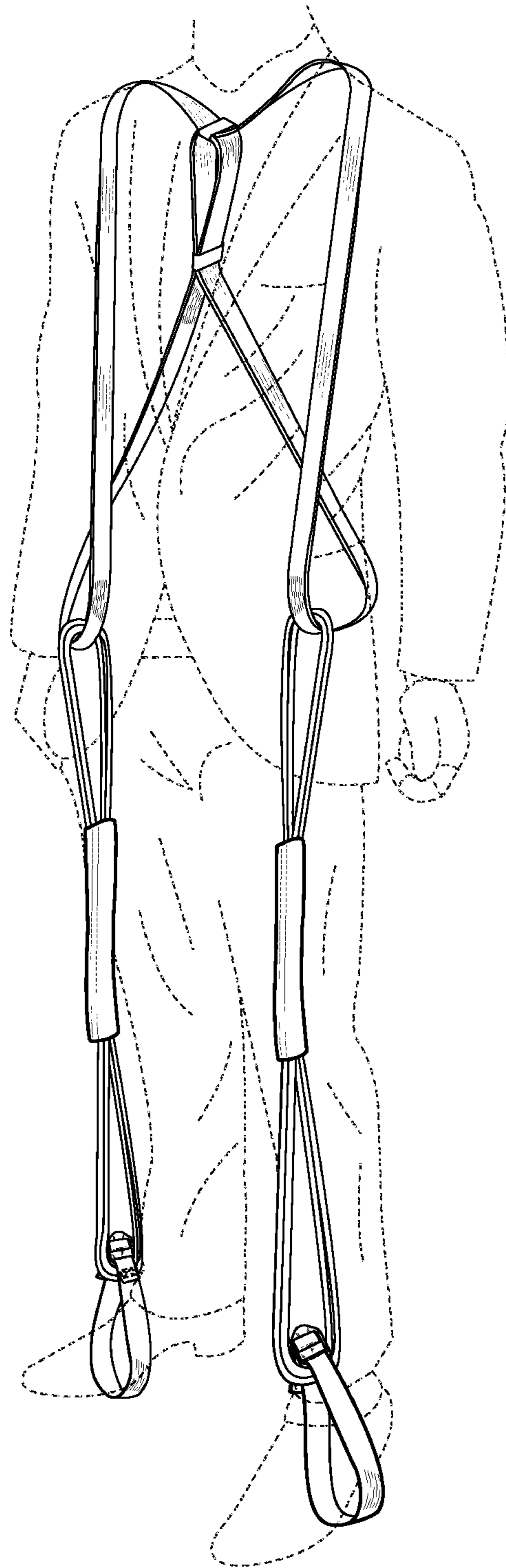

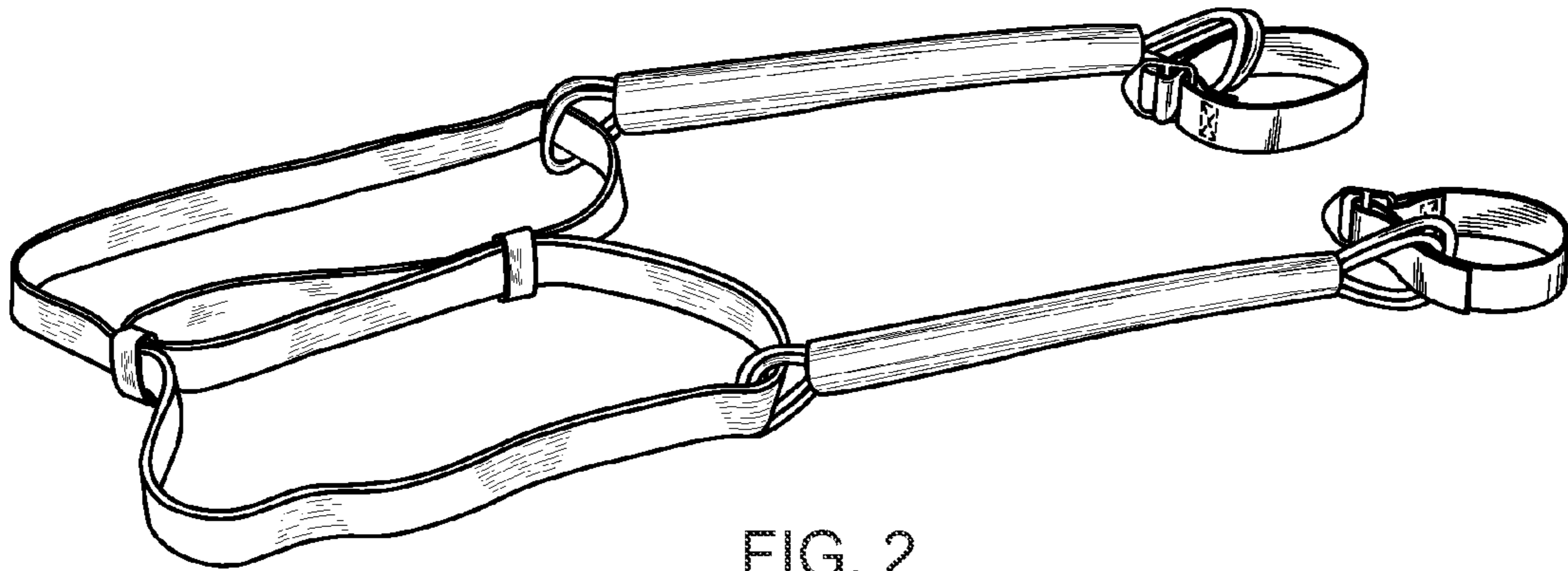

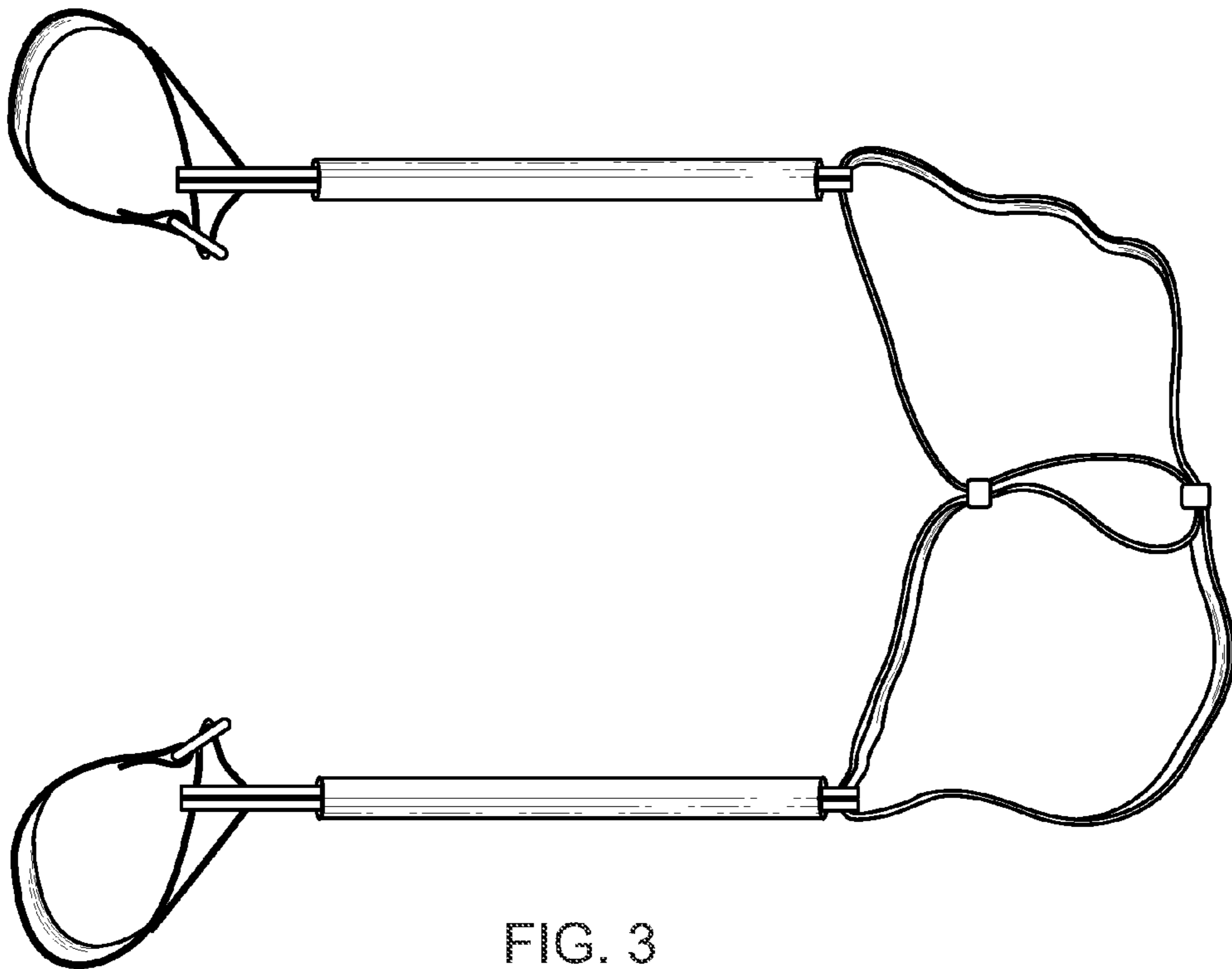

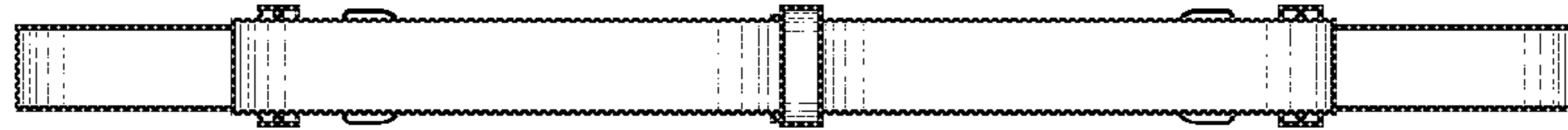

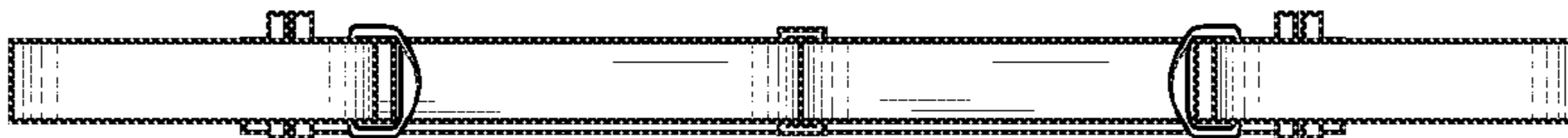

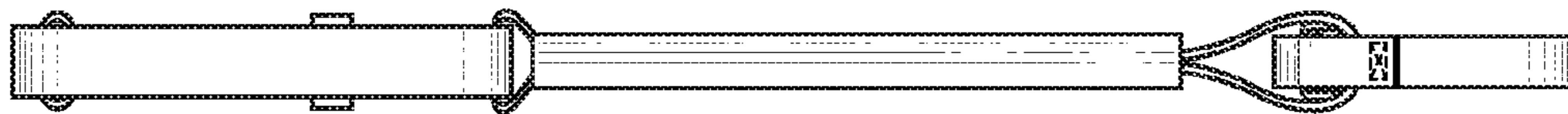
