(57) **CLAIM**

The ornamental design for a leash connector, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a leash connector showing  
my new design as used for connecting a leash to an object,  
such as a surf craft.

FIG. 2 is a second perspective view thereof.

FIG. 3 is a front elevational view thereof. A rear elevational  
view of the design is a mirror image of the front elevational  
view.

FIG. 4 is a top plan view thereof. A bottom plan view of the  
design is identical to the top plan view.

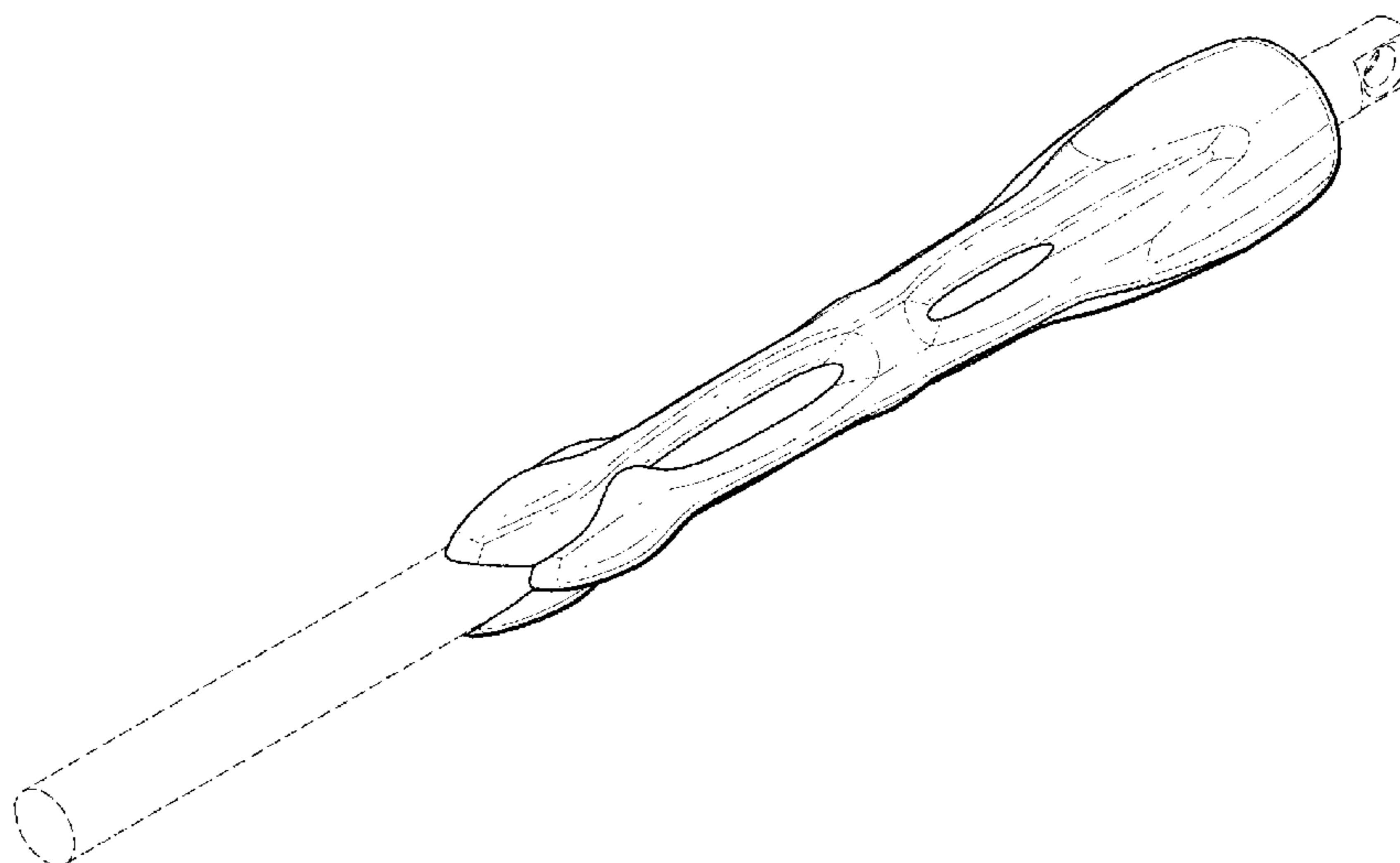
FIG. 5 is a right side elevational view thereof.

FIG. 6 is a left side elevational view thereof; and,

FIG. 7 is a third perspective view thereof, shown from the  
same angle as the second perspective view, but showing the  
left side without any connecting device inserted therein.

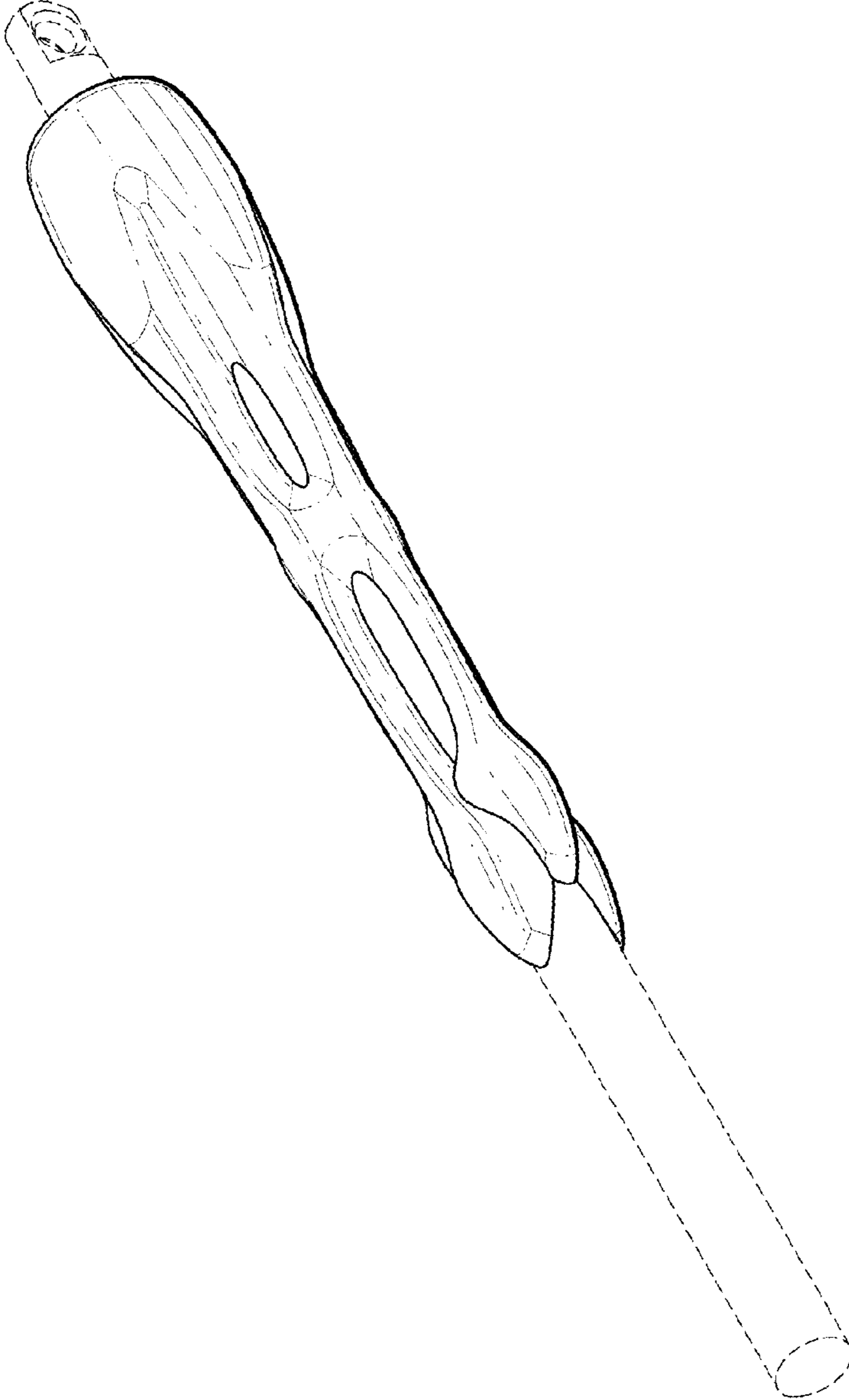

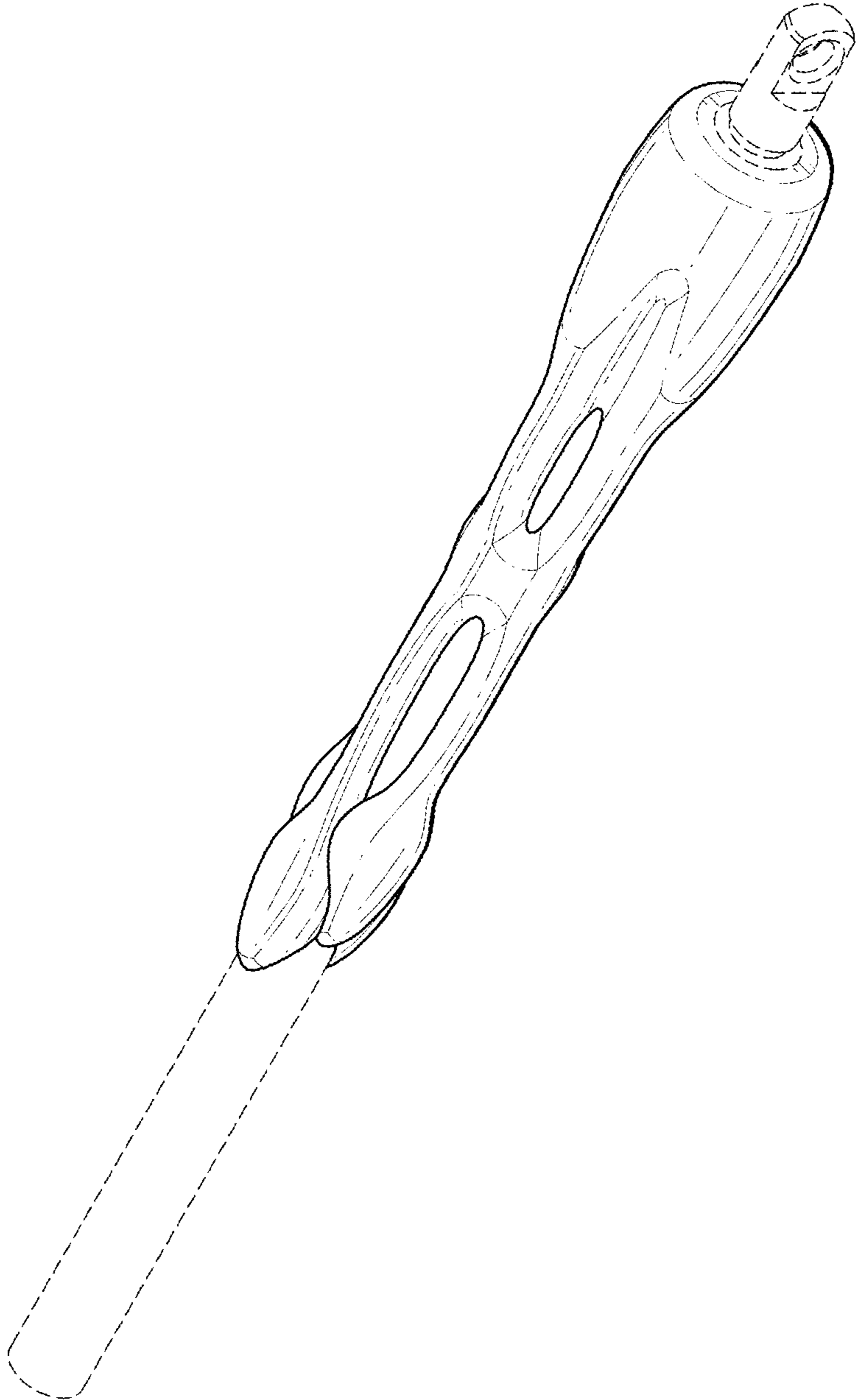

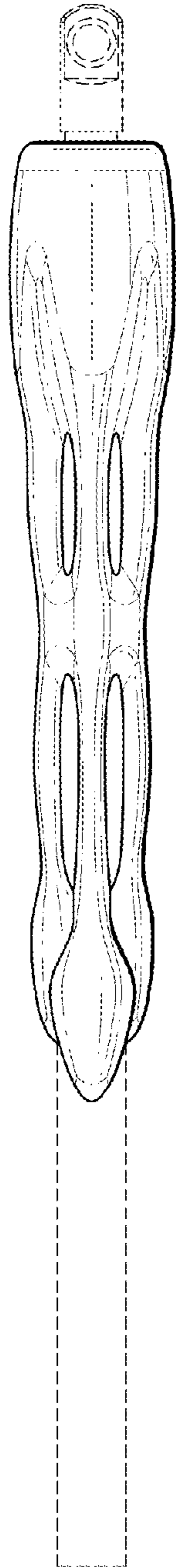

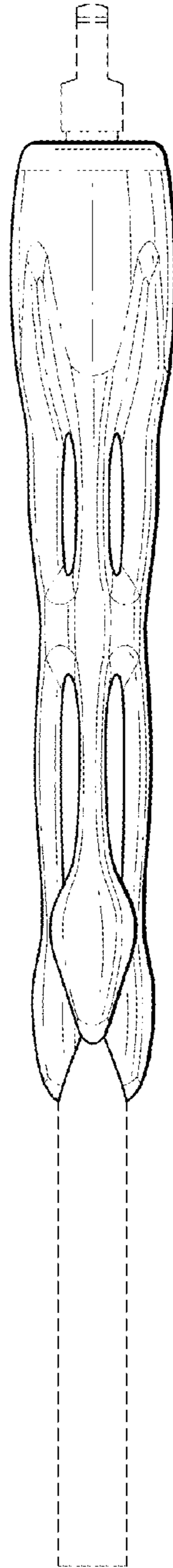

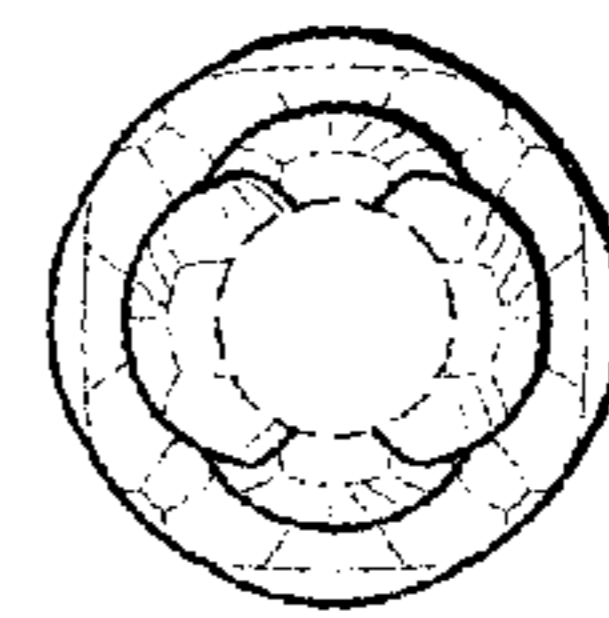

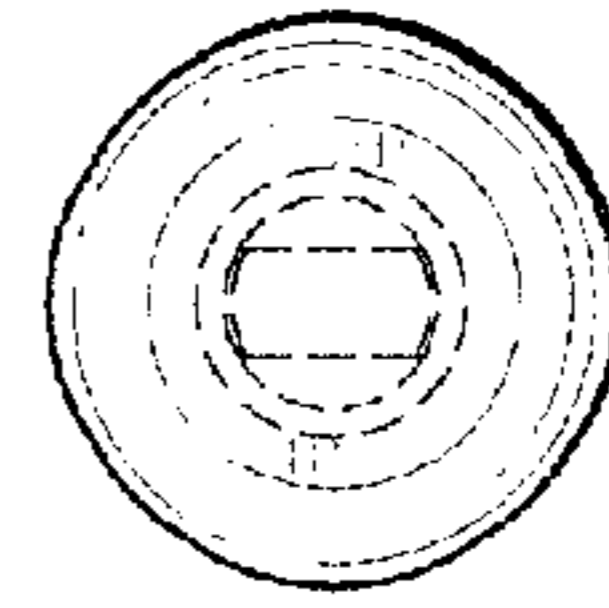
