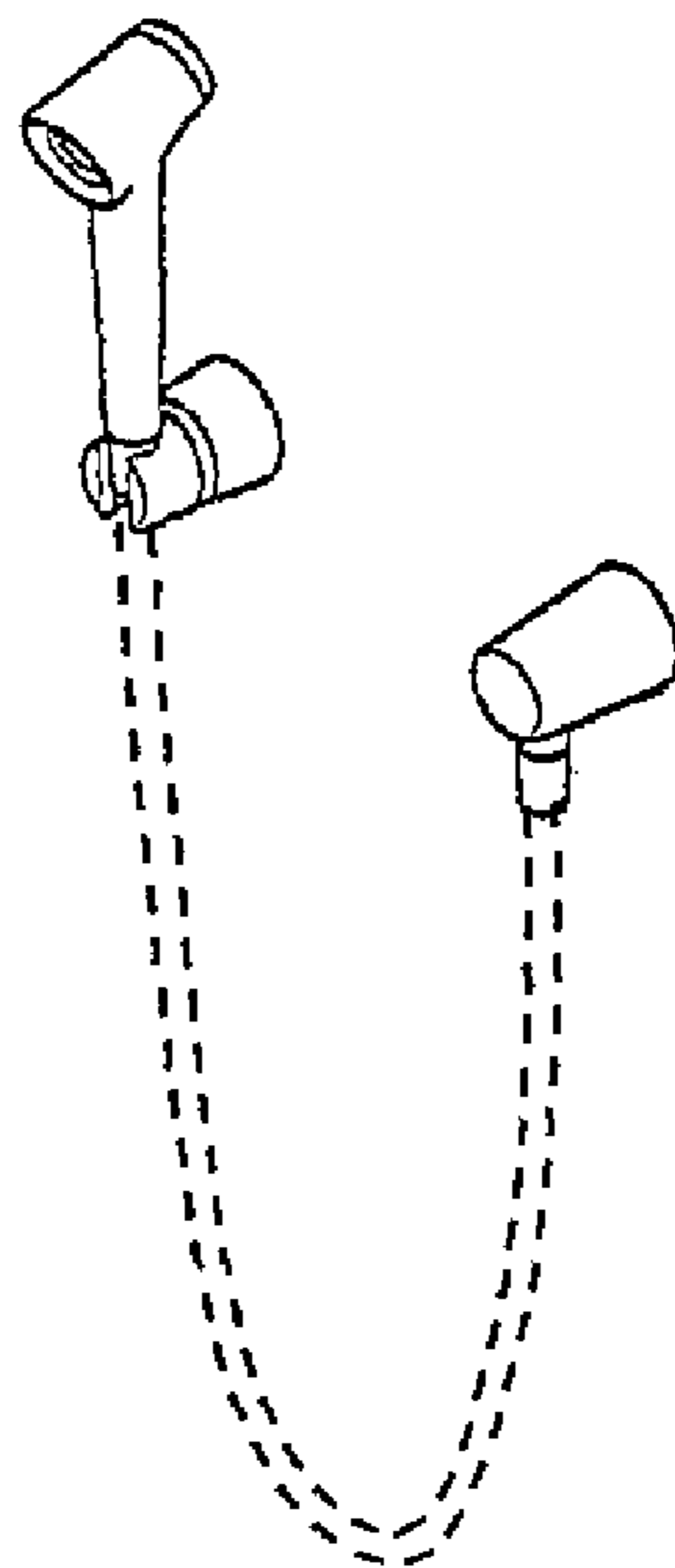
(57) **CLAIM**

I claim the ornamental design for a hand shower, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a hand shower showing my new design;
FIG. 2 is a bottom perspective view of the hand shower of FIG. 1;
FIG. 3 is a front view of the hand shower of FIG. 1;
FIG. 4 is a rear view of the hand shower of FIG. 1;
FIG. 5 is a left side view of the hand shower of FIG. 1;
FIG. 6 is a right side view of the hand shower of FIG. 1;
FIG. 7 is a top view of the hand shower of FIG. 1; and,

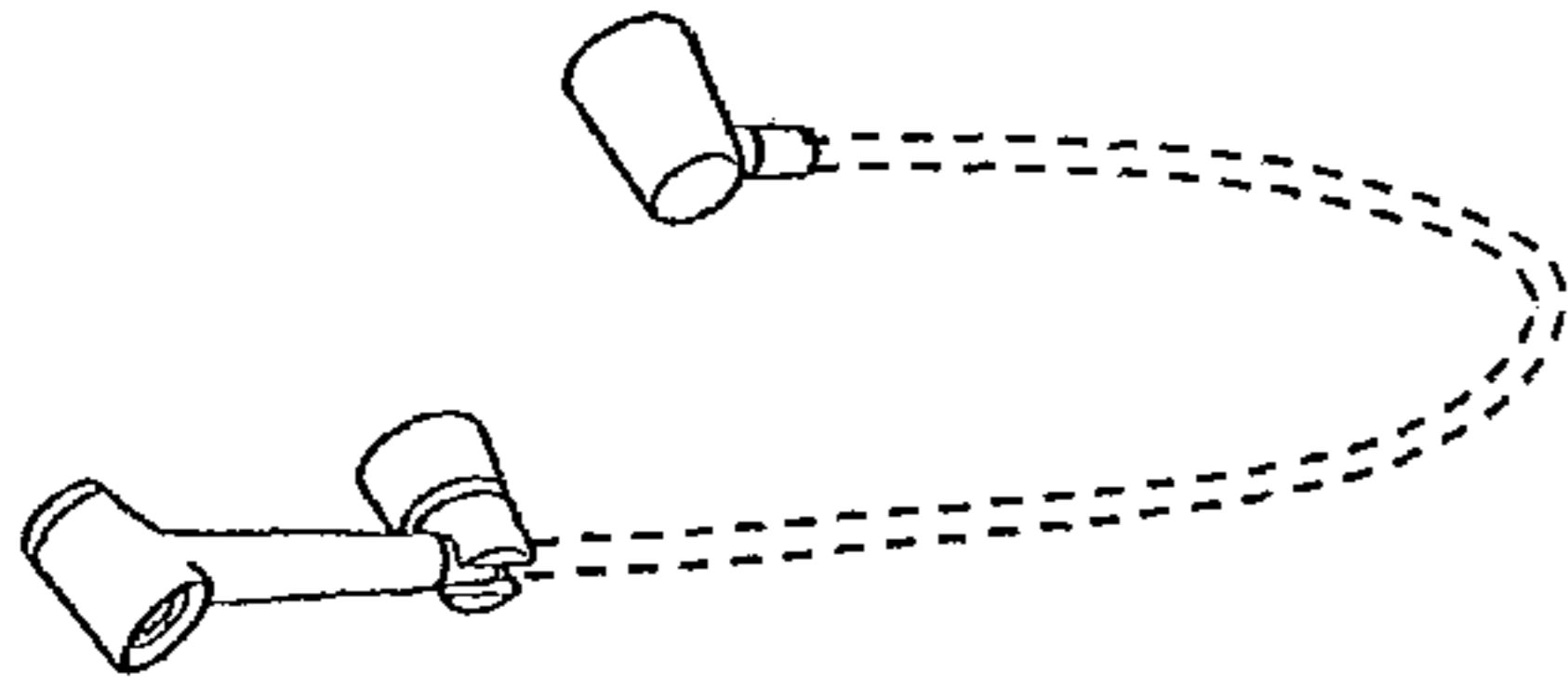

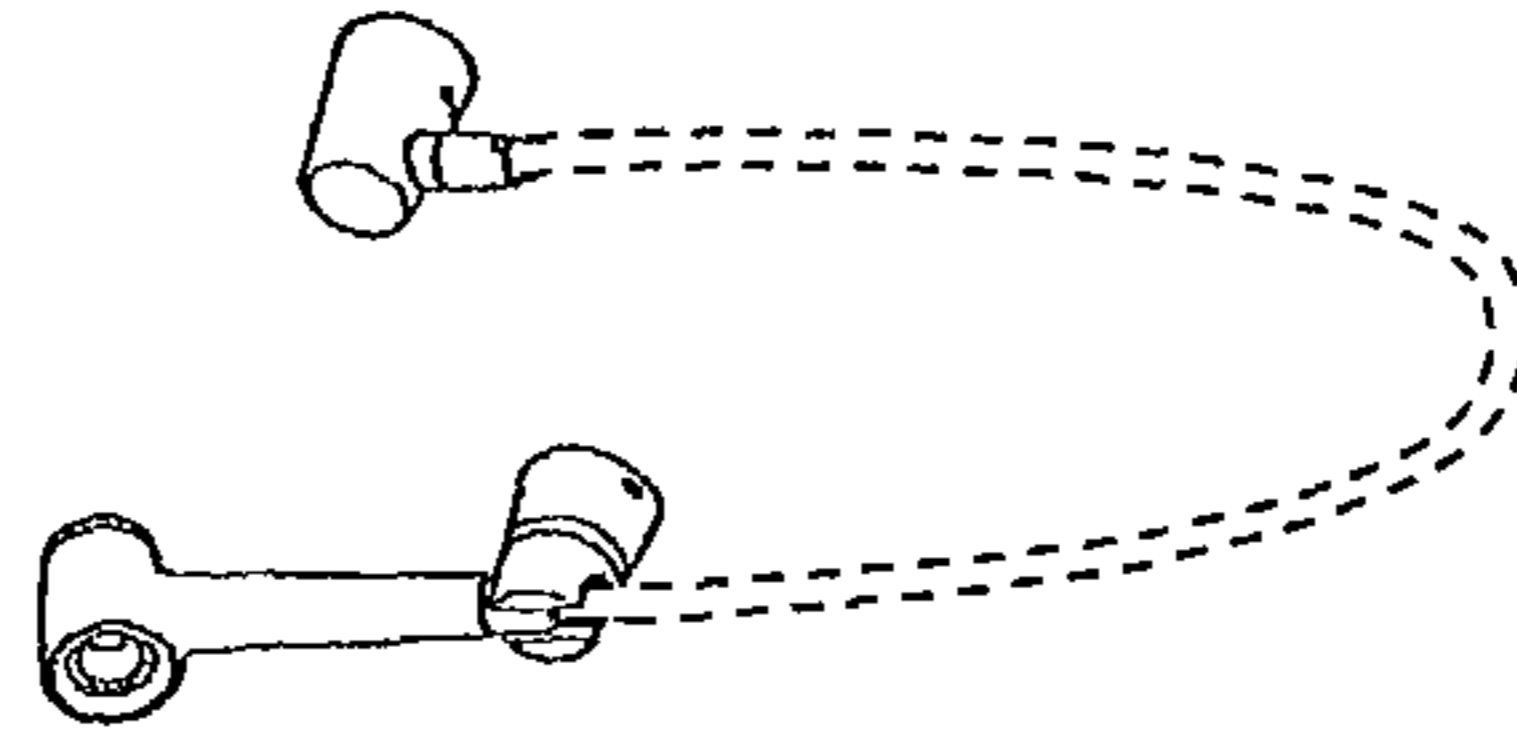

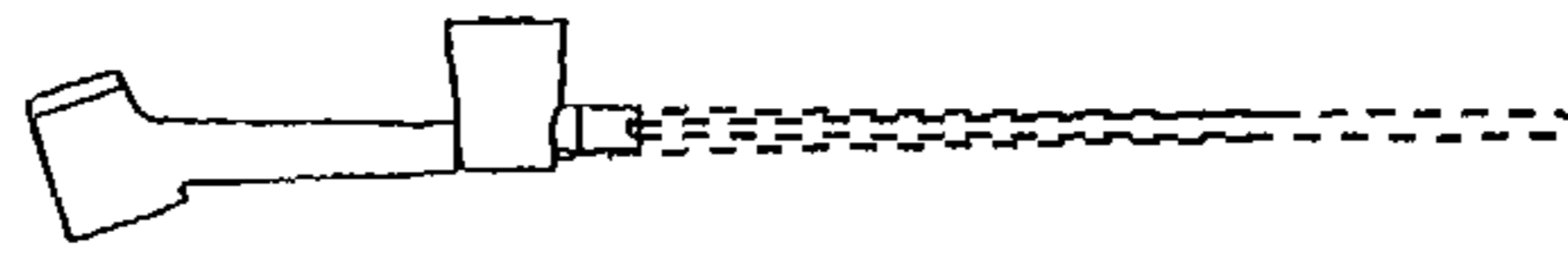

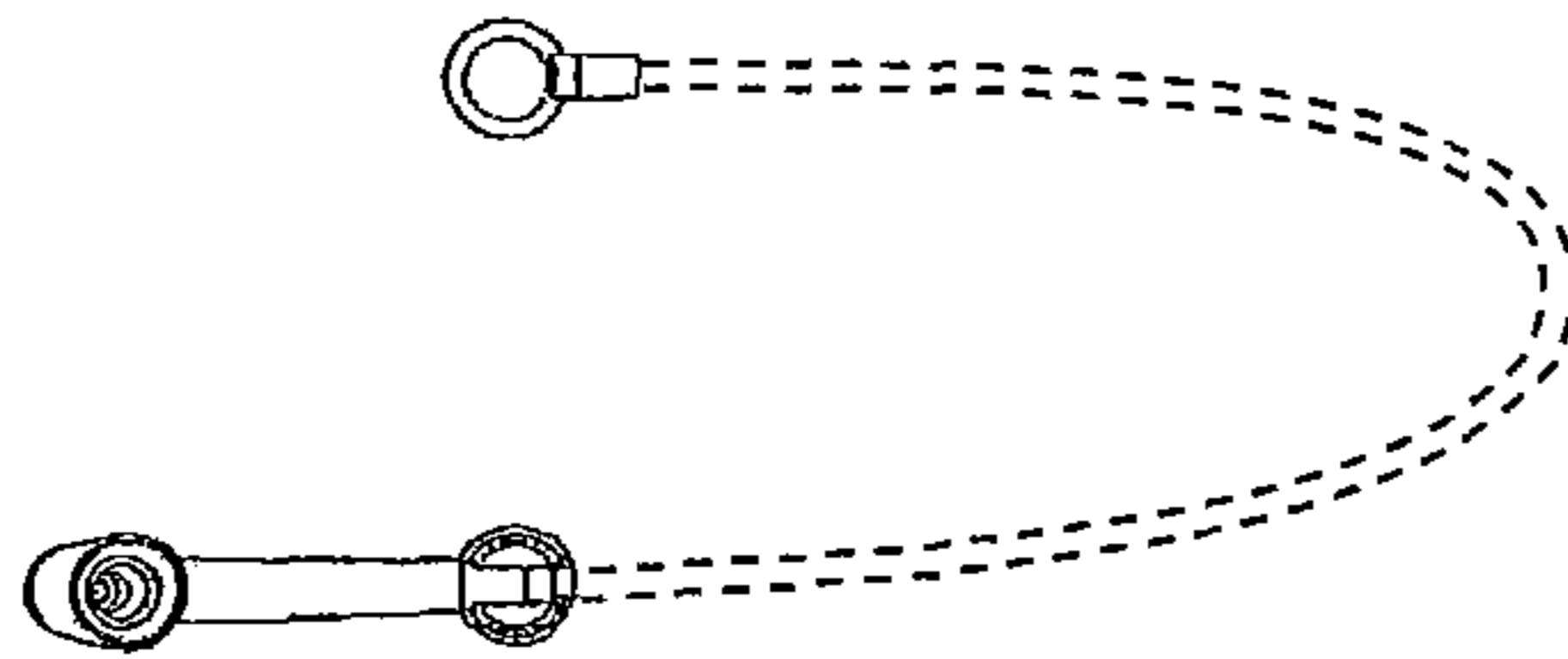

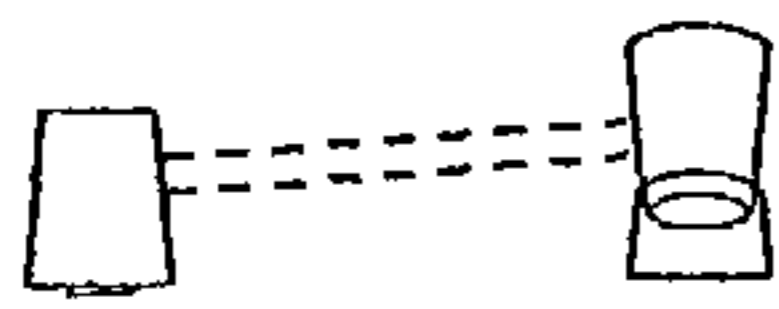

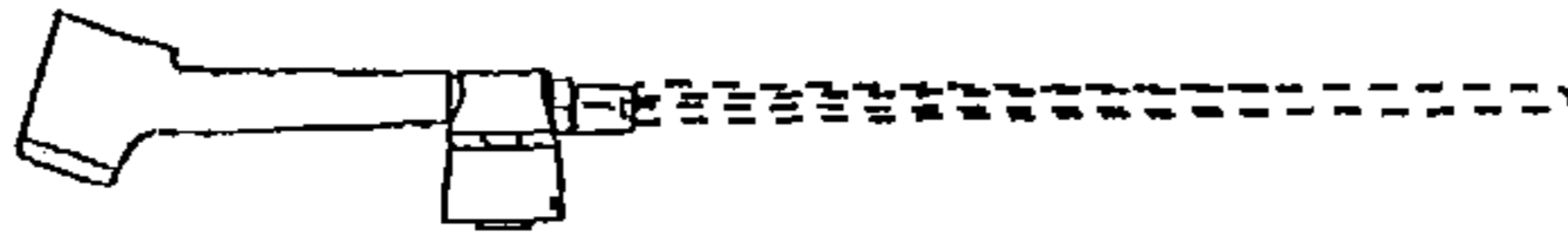

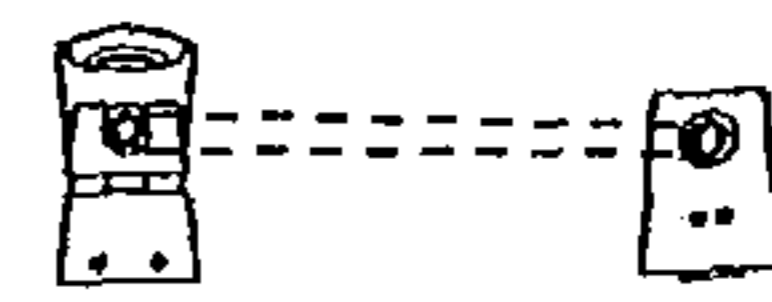

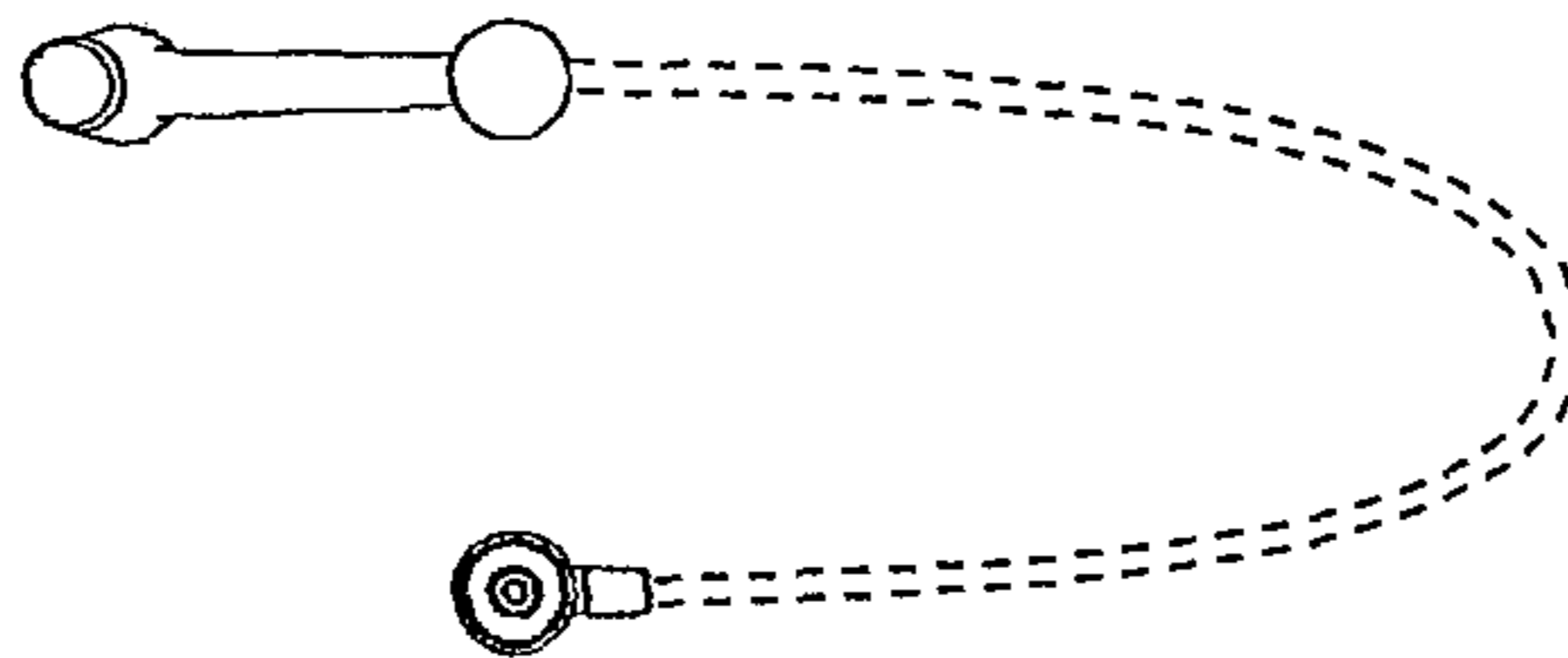
