**DESCRIPTION**

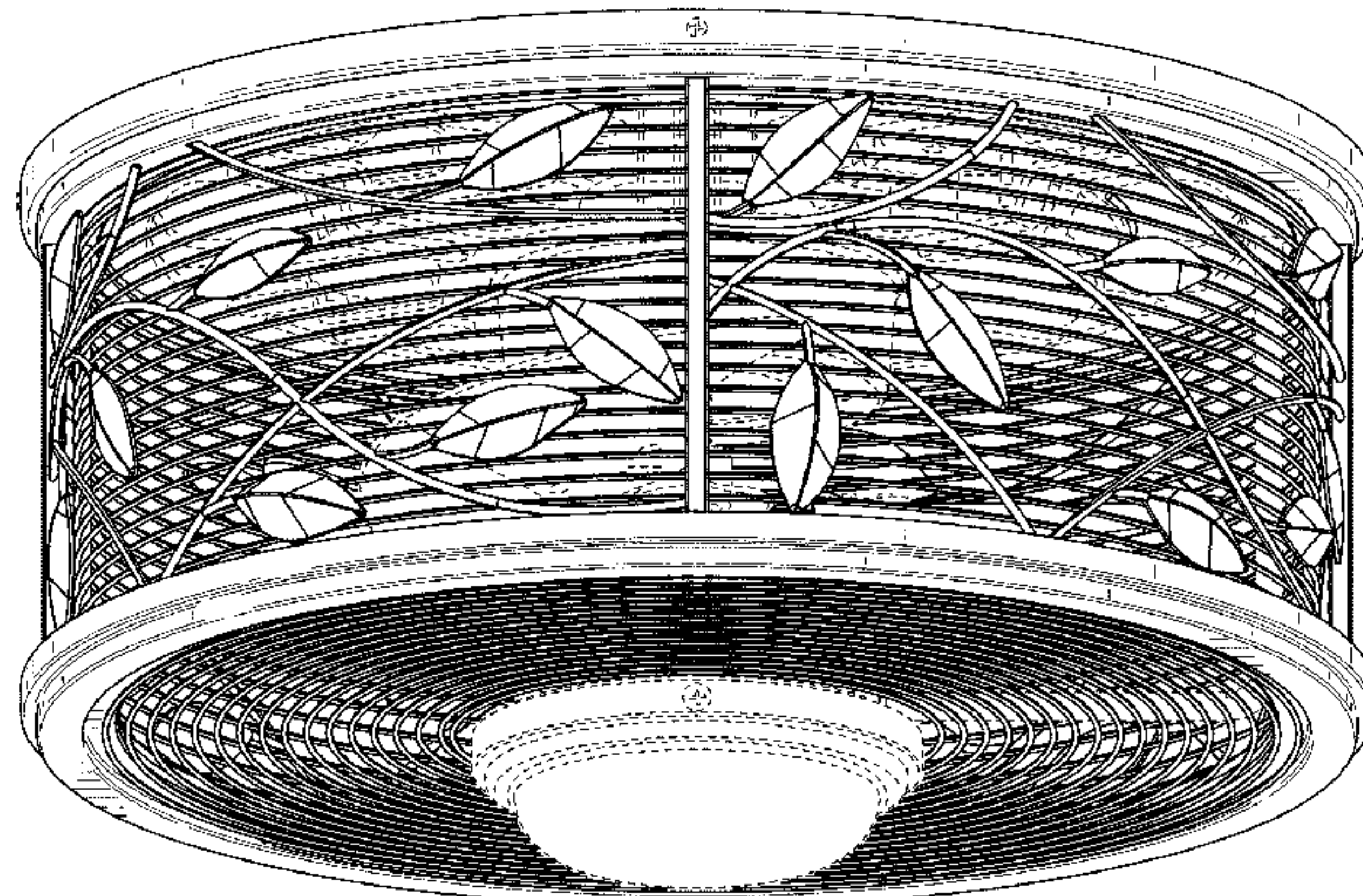
FIG. 1 is a perspective view of a fan assembly showing our new design;

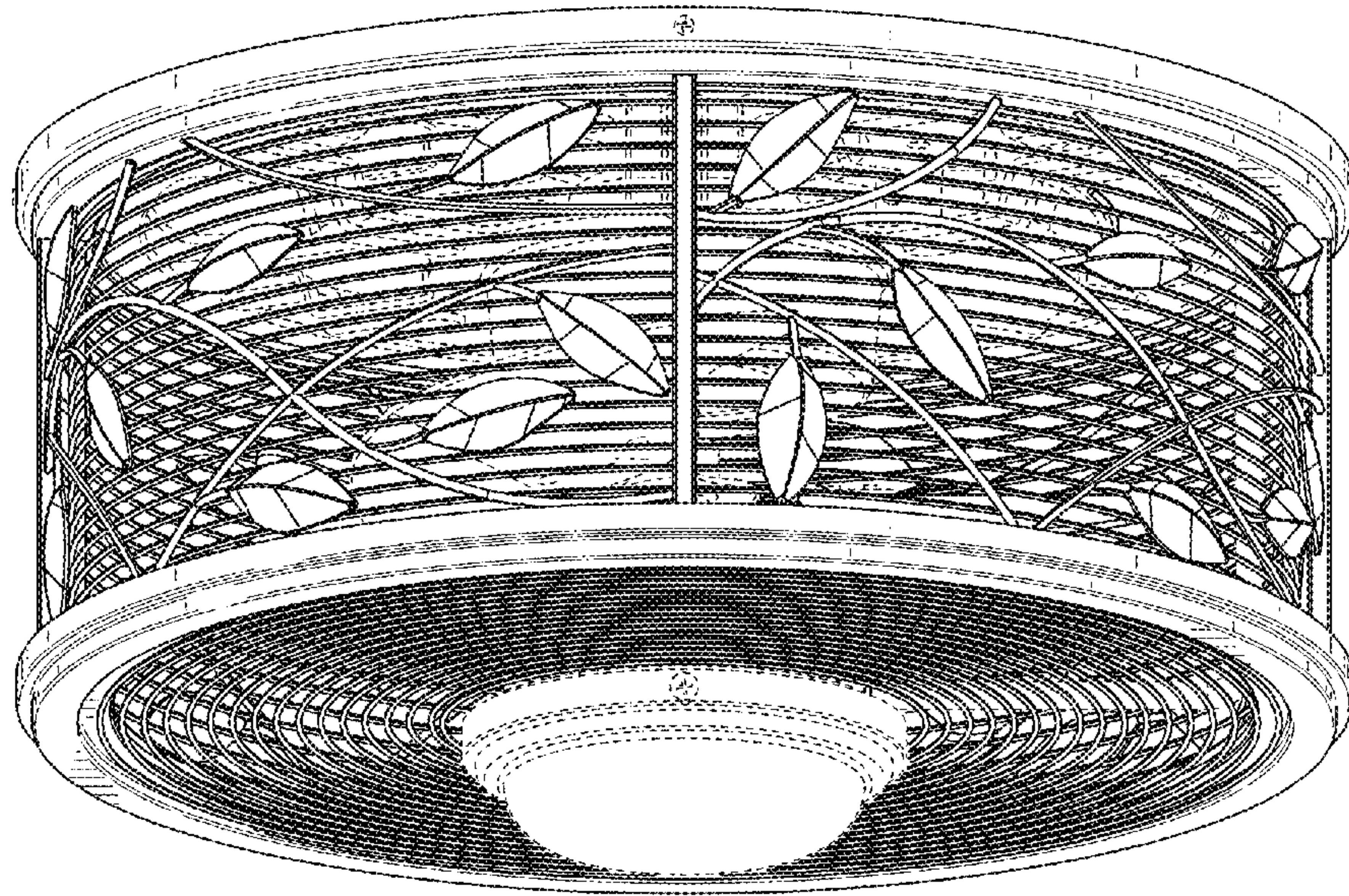

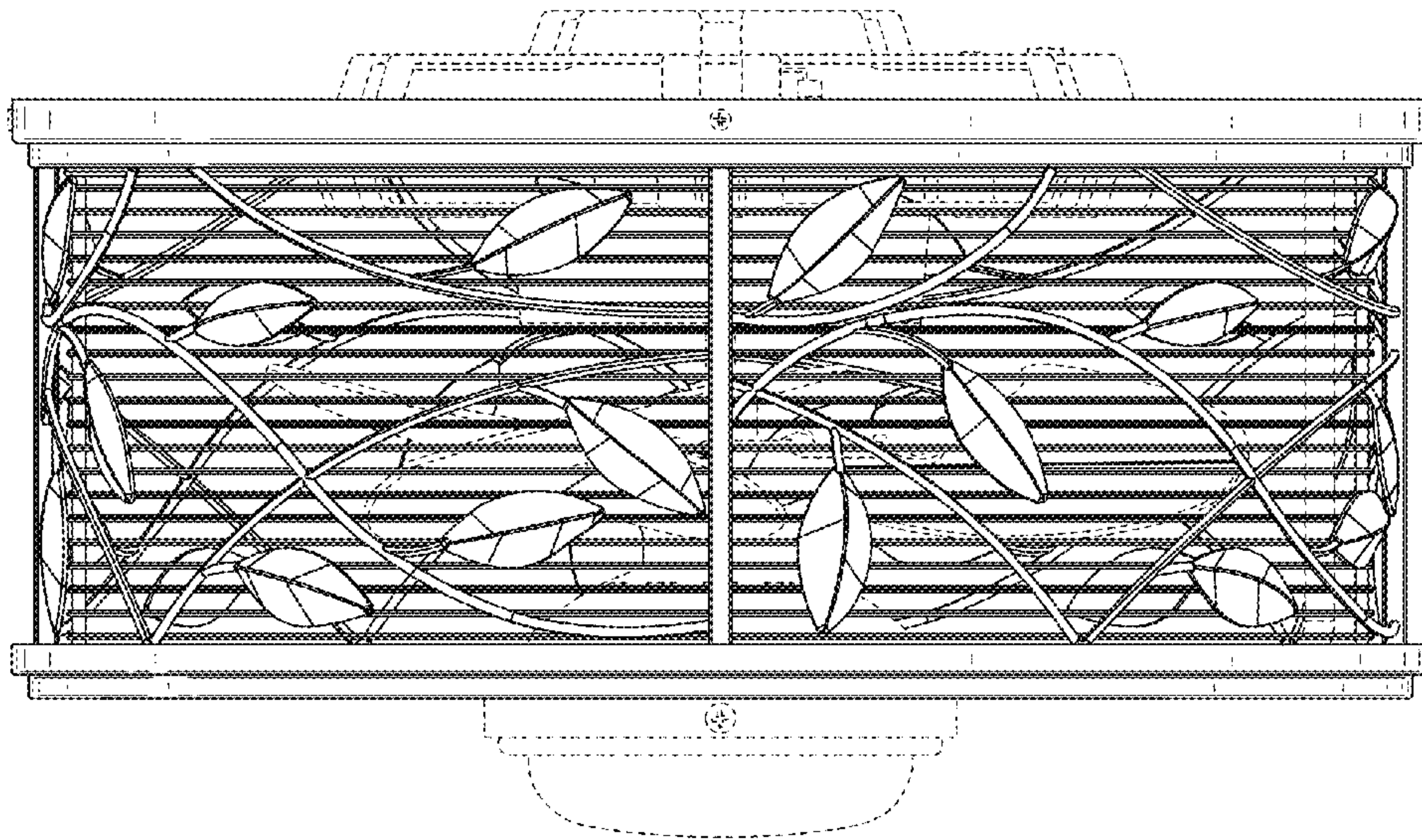

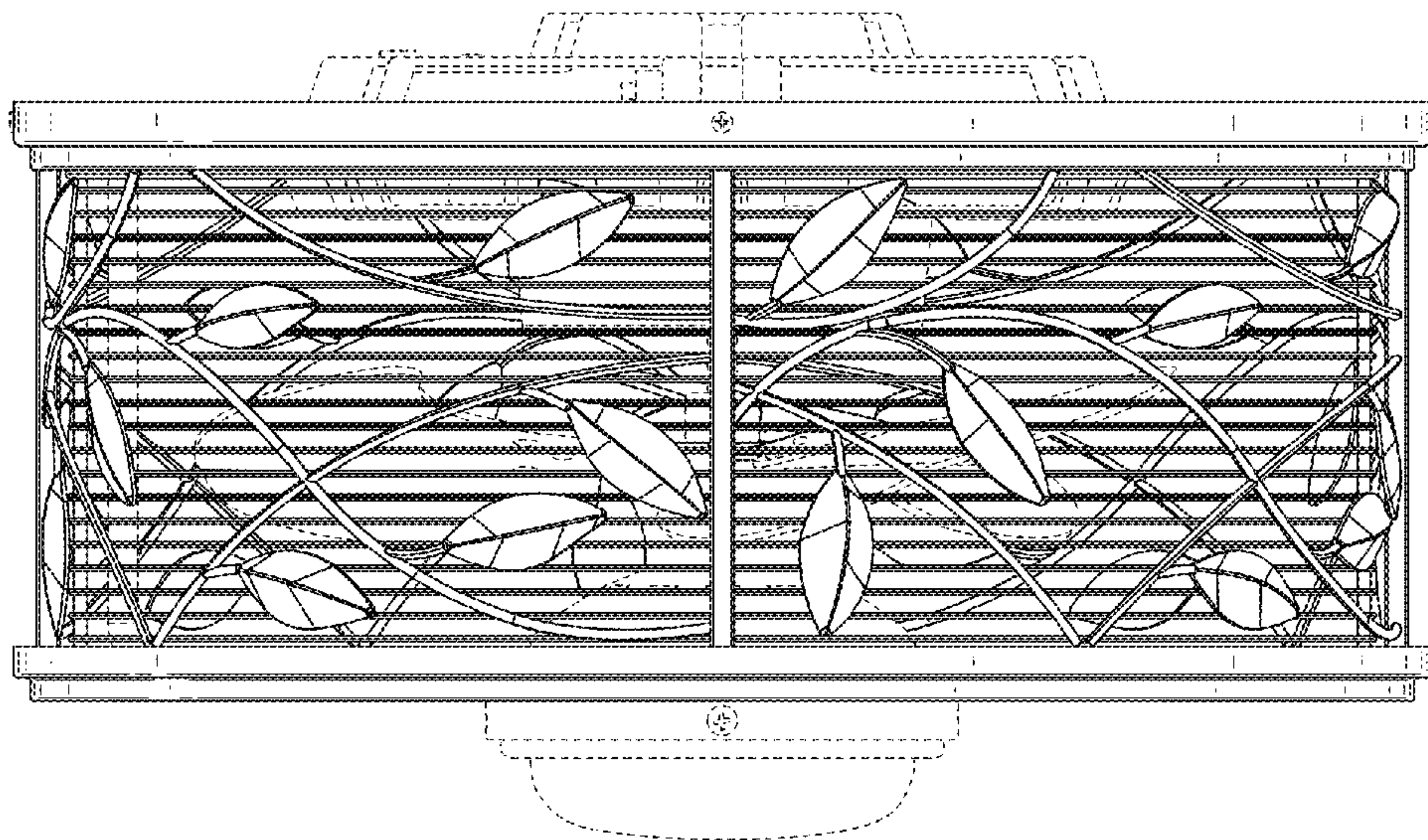

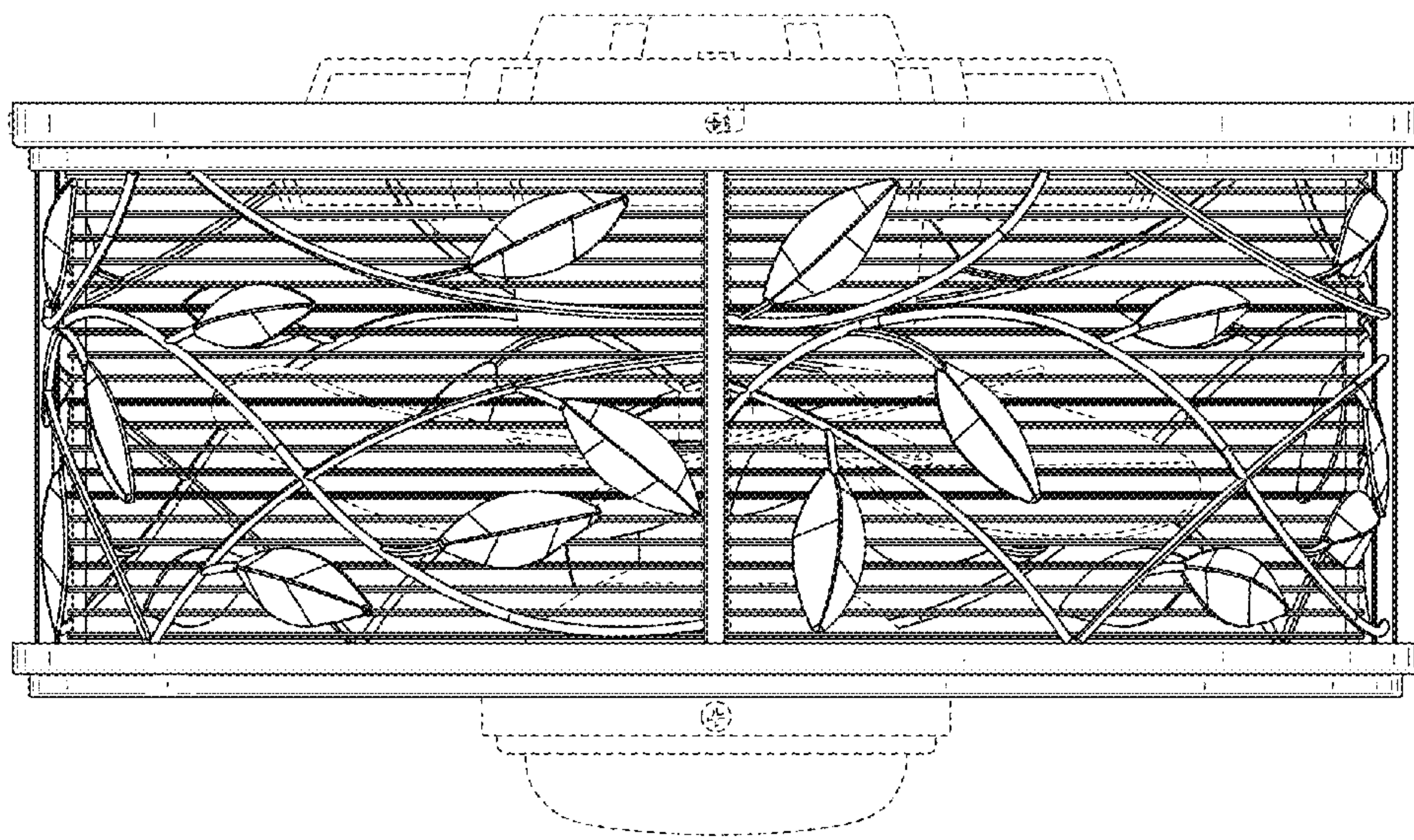

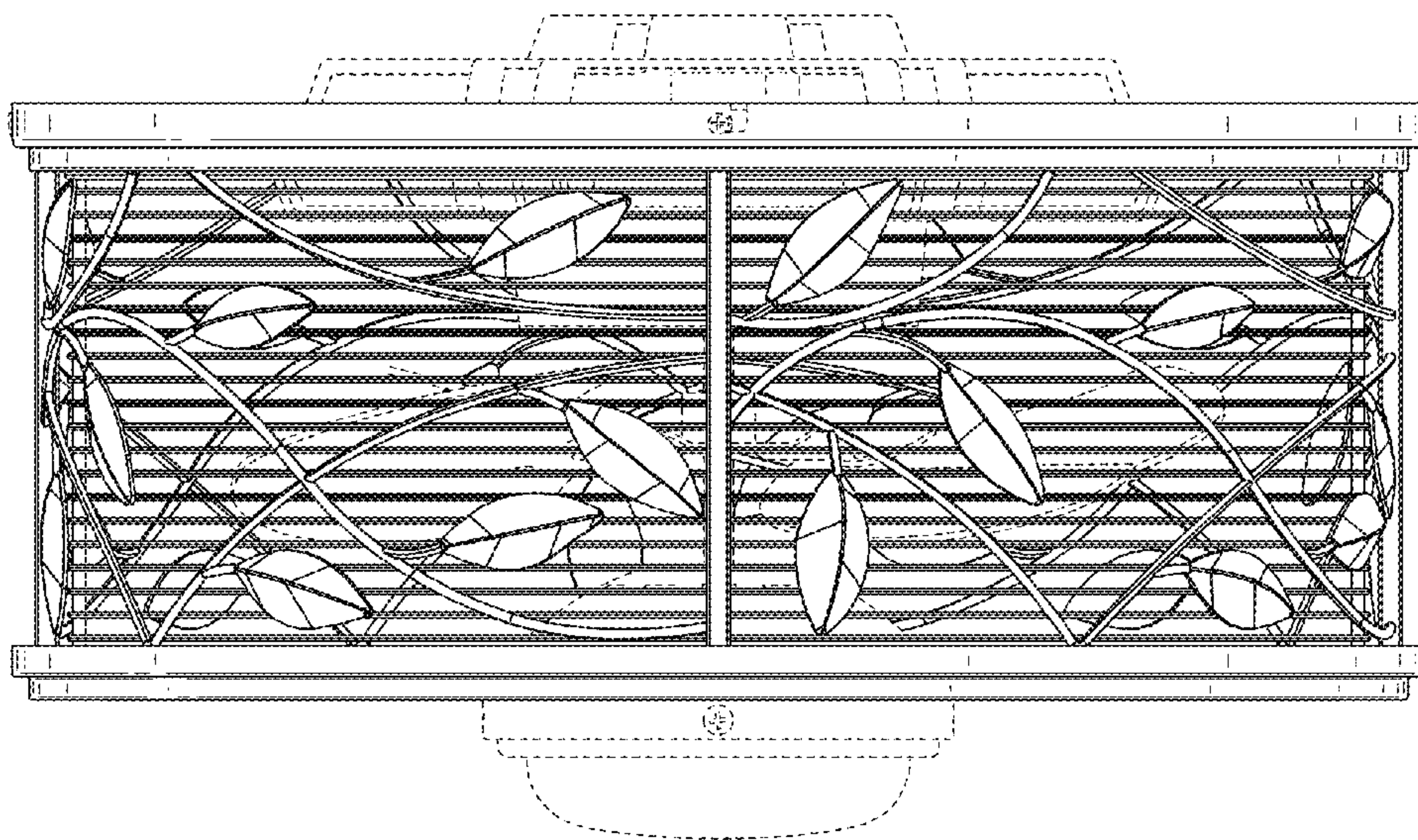

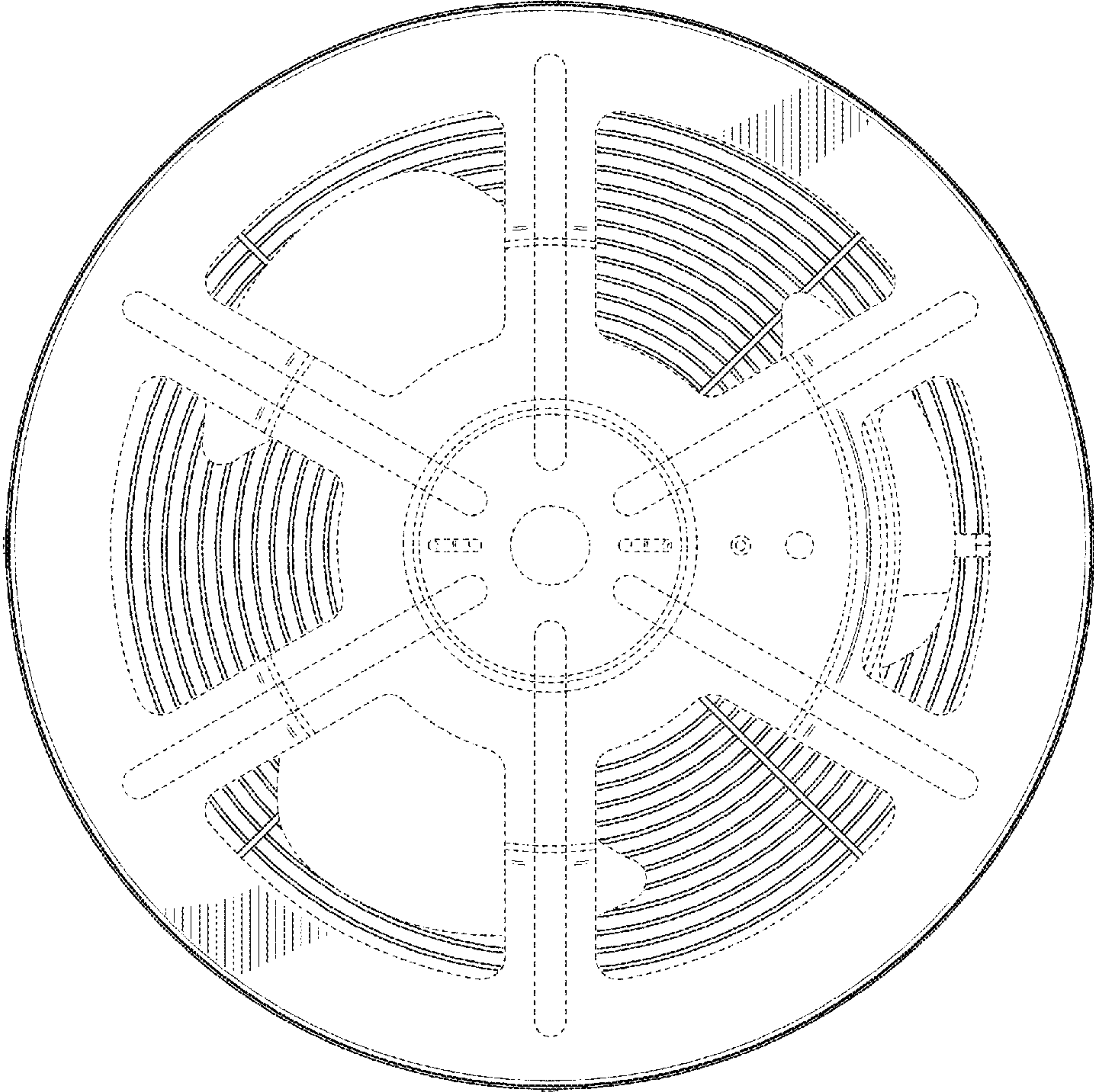

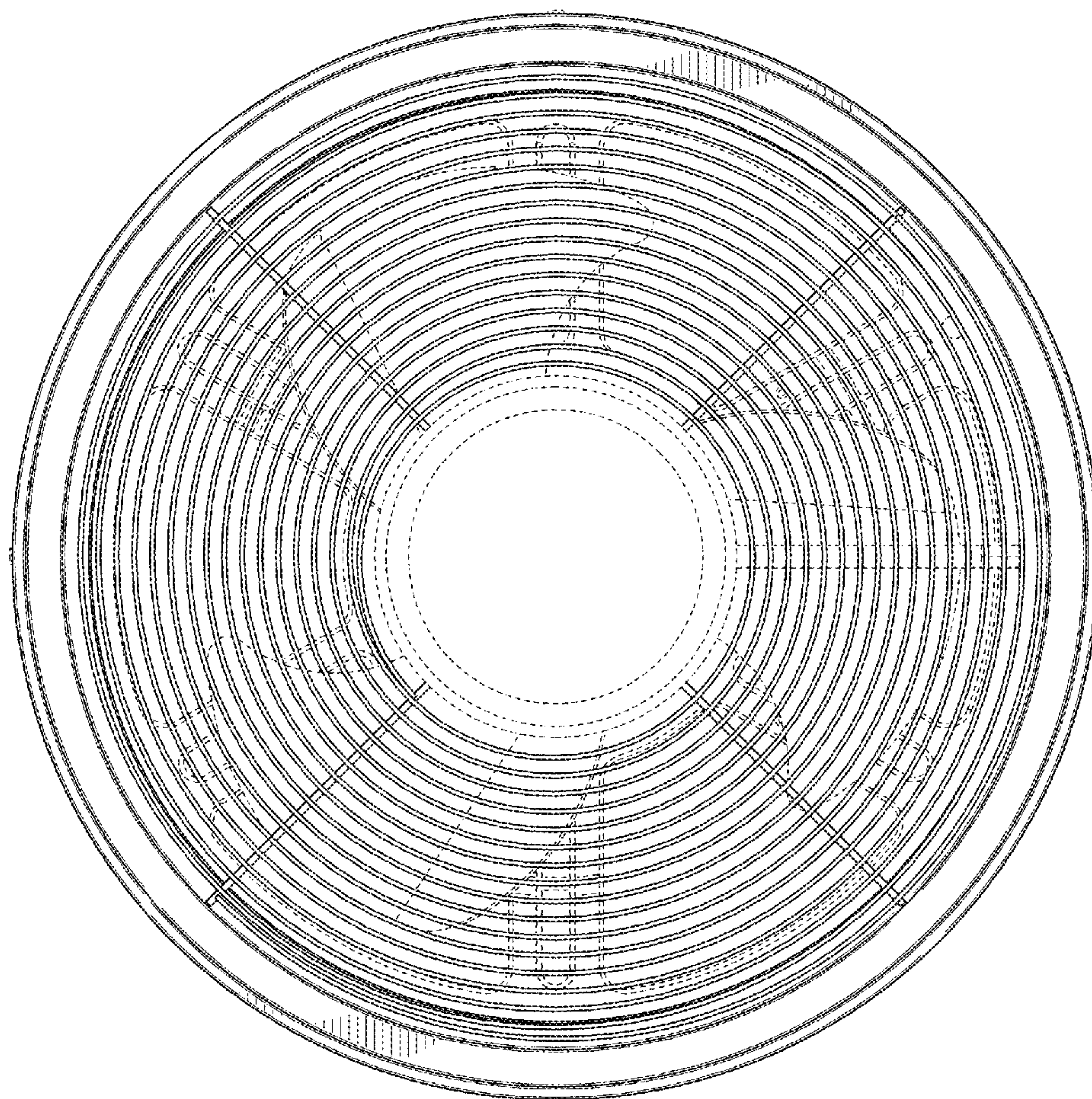
