FIG. 1 is a front elevation view of a travel massager, showing my new design, the rear elevation view being a mirror image thereof;

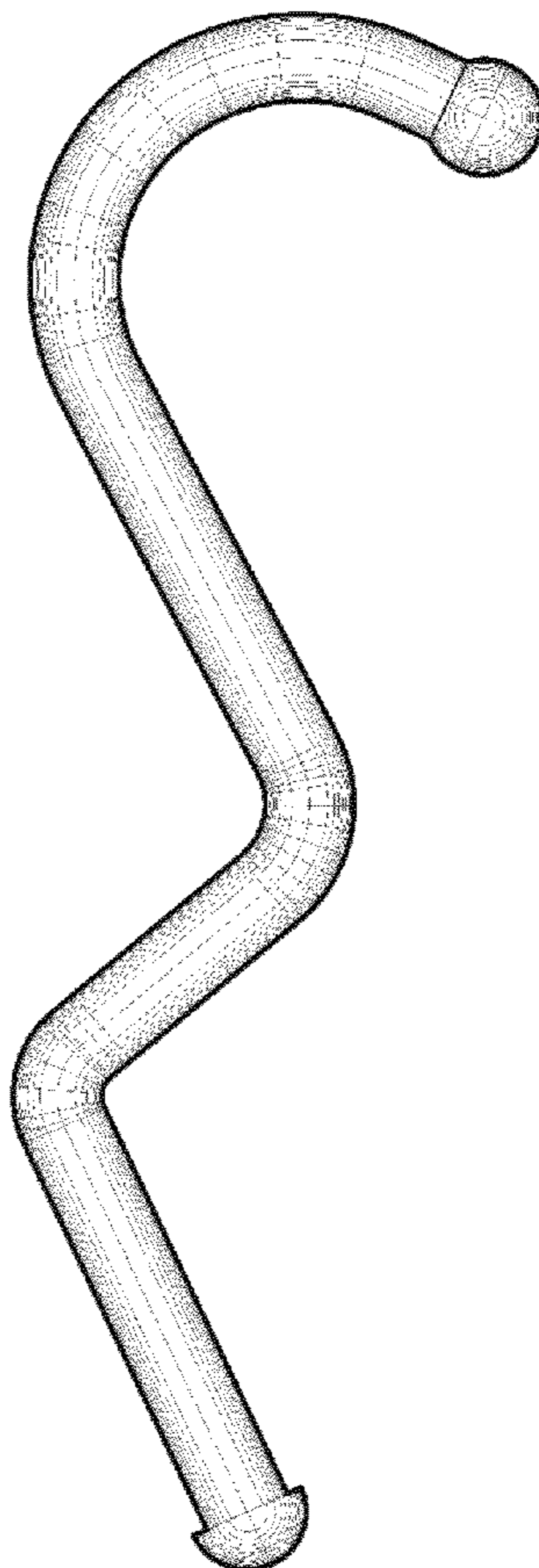
FIG. 2 is a left side elevation view thereof;

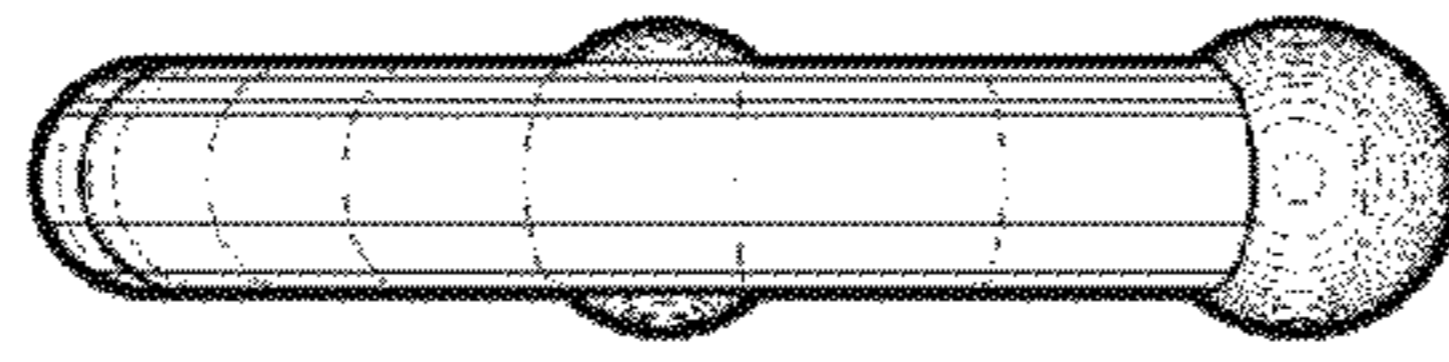

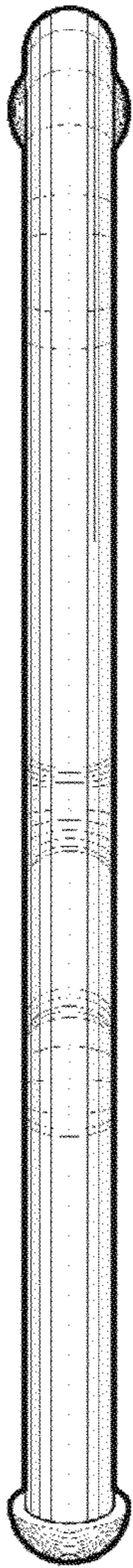

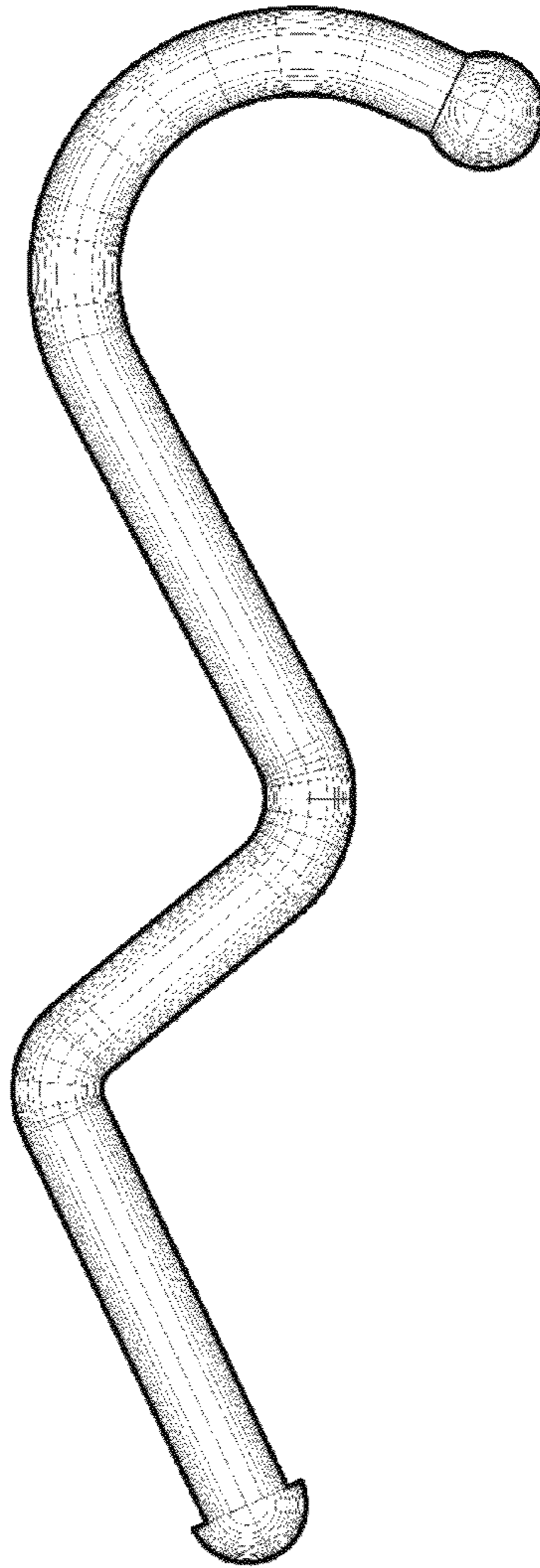

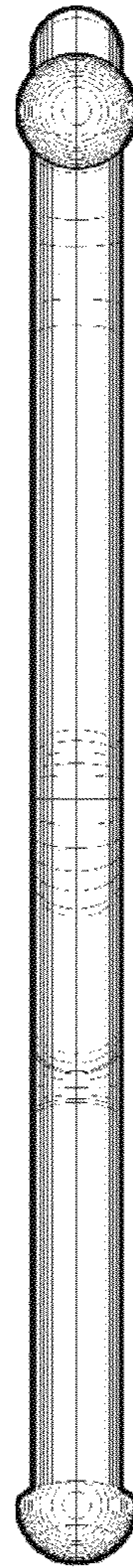
