(57) **CLAIM**

The ornamental design for a light cover, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a light cover showing our new design.

FIG. 2 is a bottom perspective view of the light cover as shown in FIG. 1 showing our new design.

FIG. 3 is a side elevation view of the light cover as shown in FIG. 1 showing our new design.

FIG. 4 is a center cross-section view of the light cover as shown in FIG. 1 showing our new design.

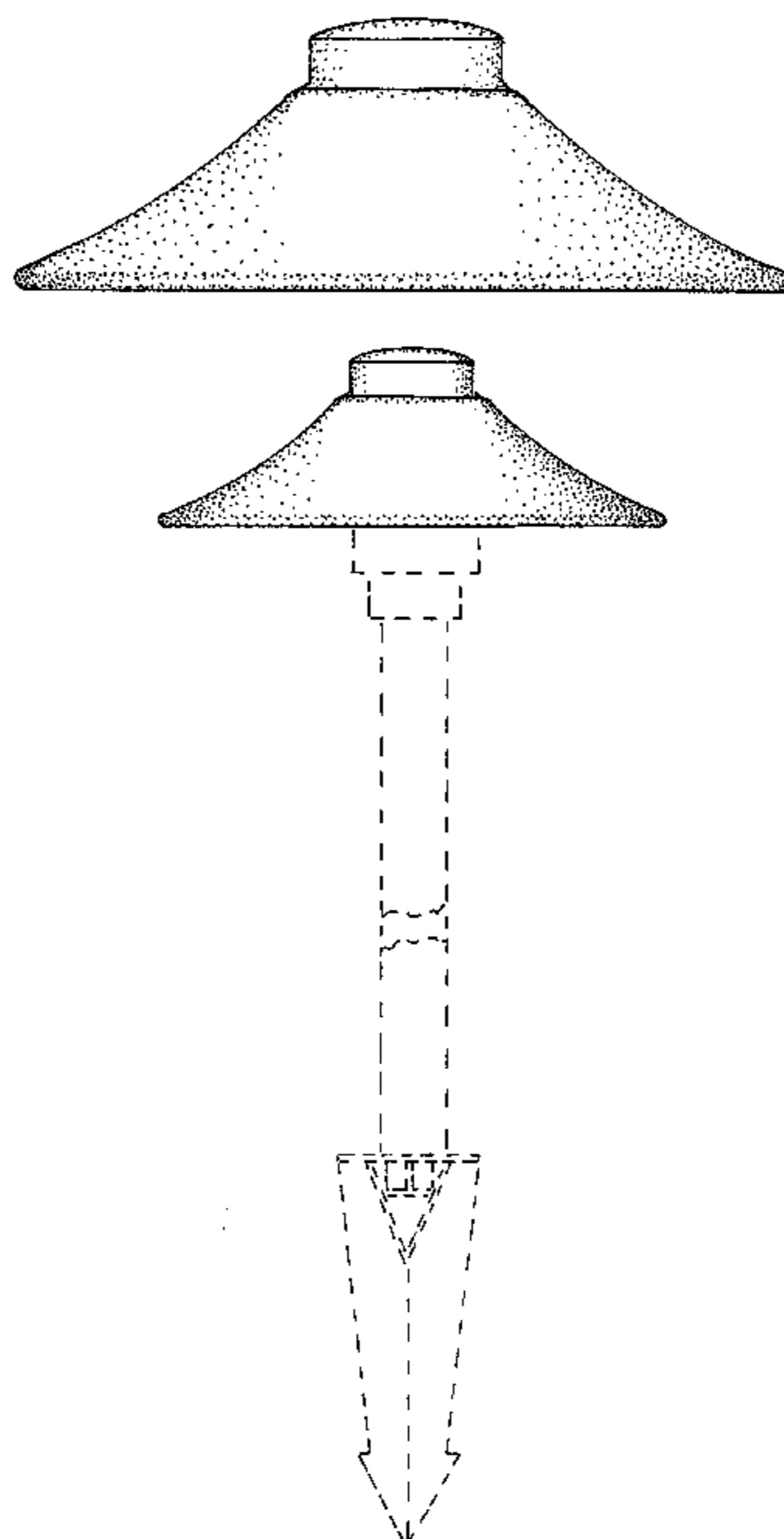
FIG. 5 is a top plan view of the light cover as shown in FIG. 1 showing our new design.

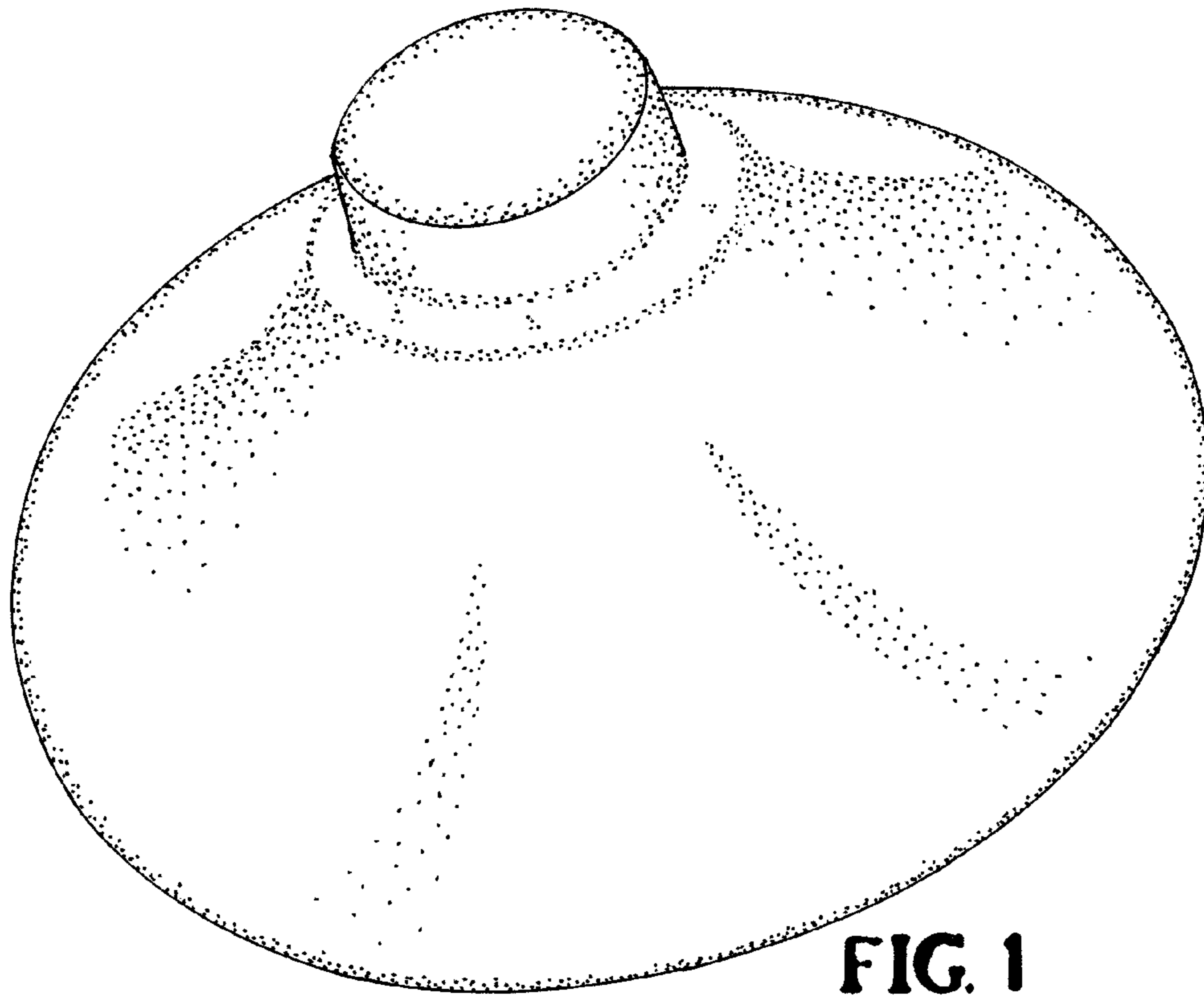

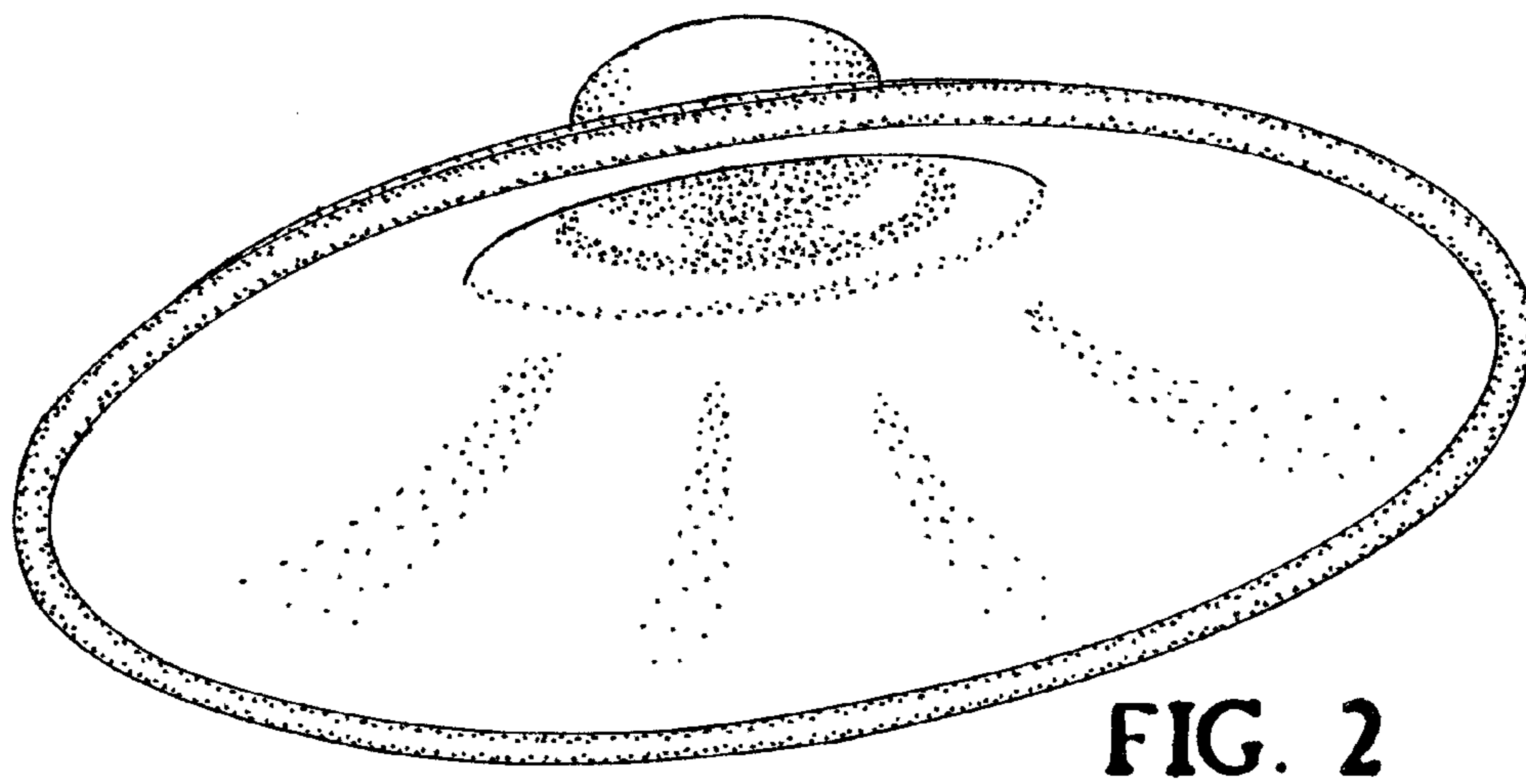

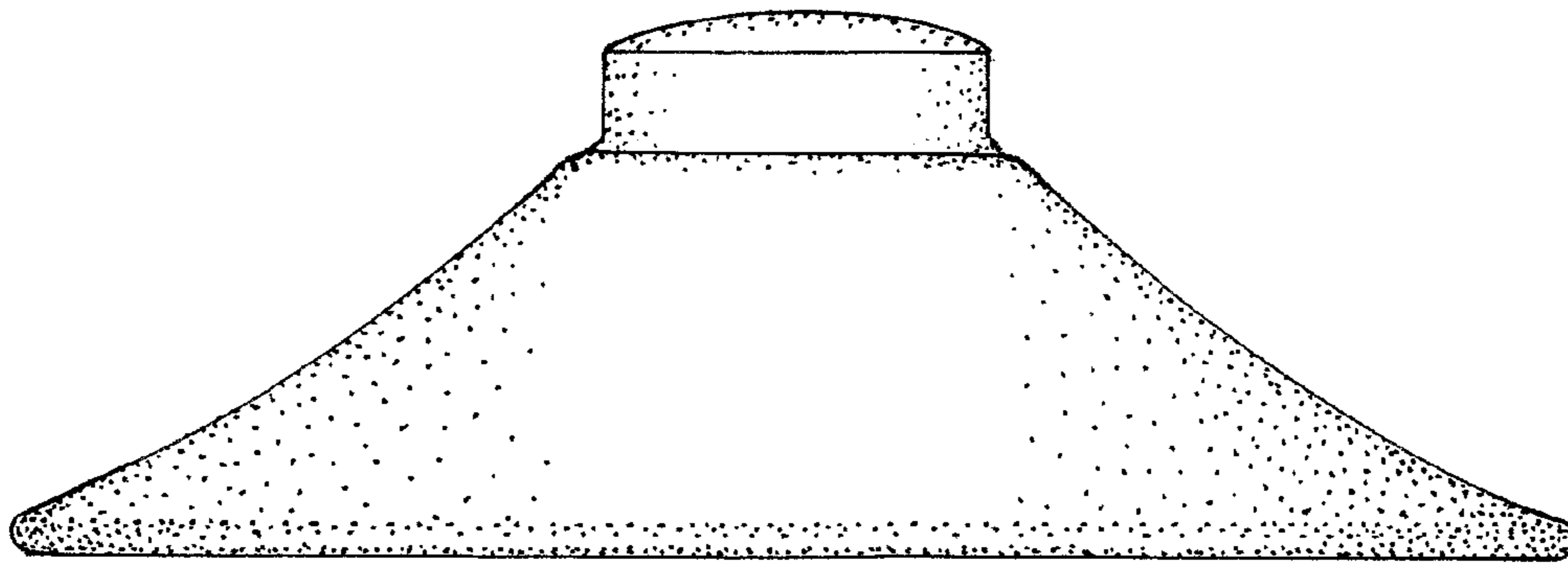

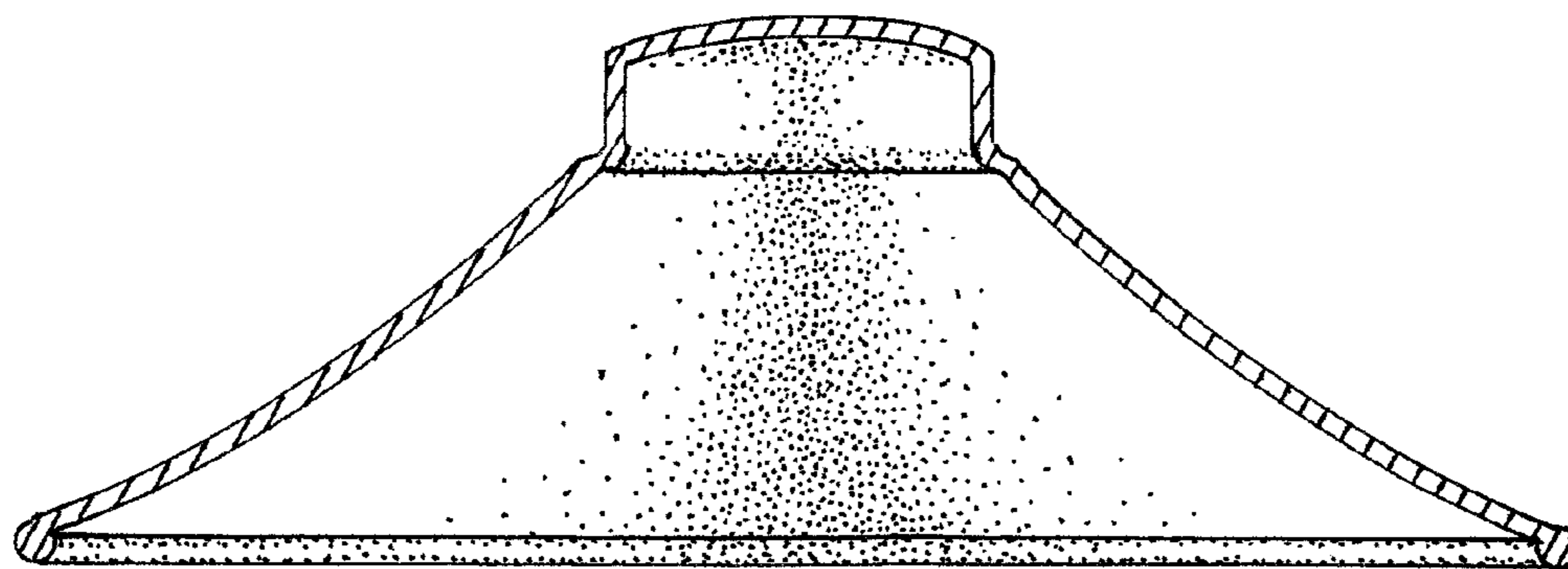

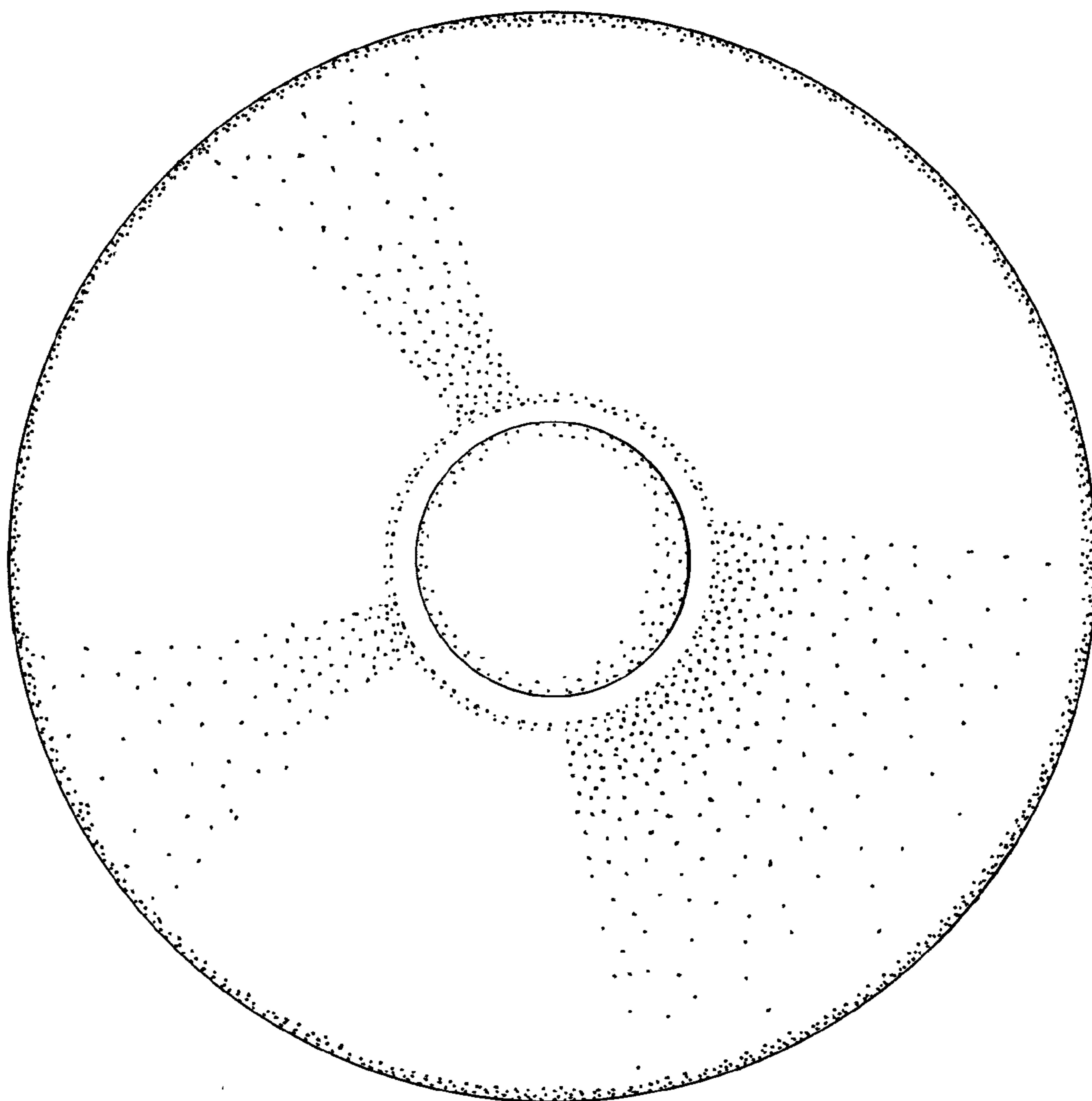

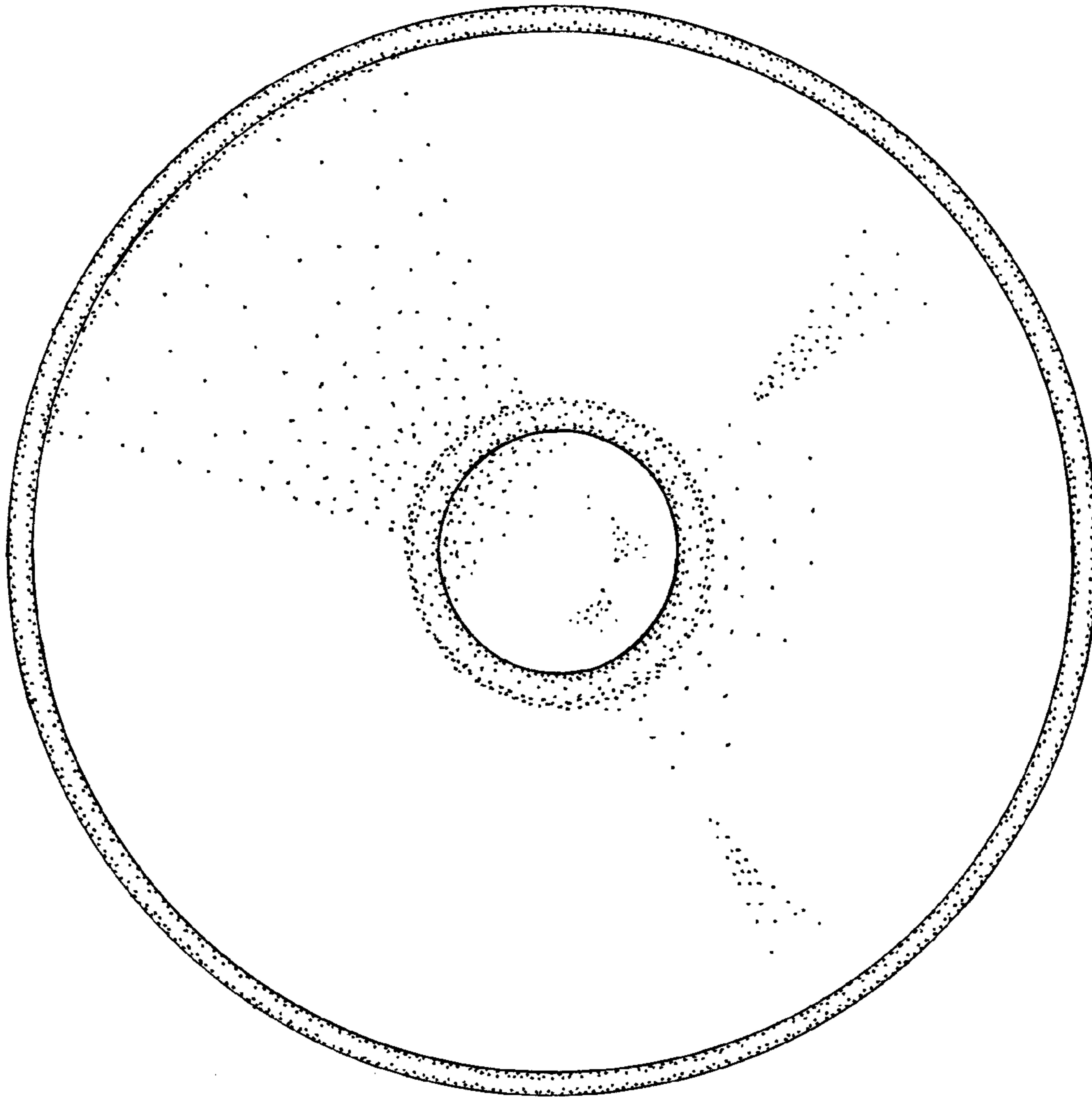

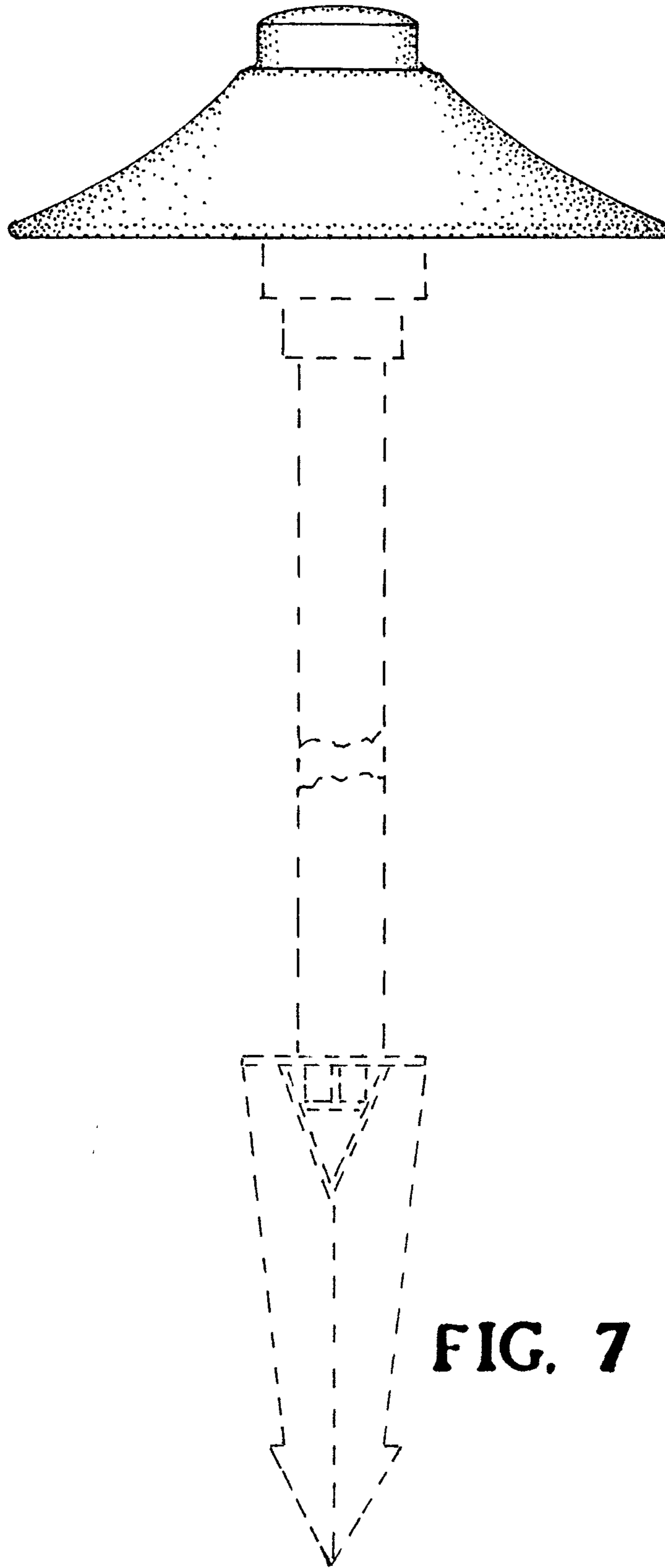
