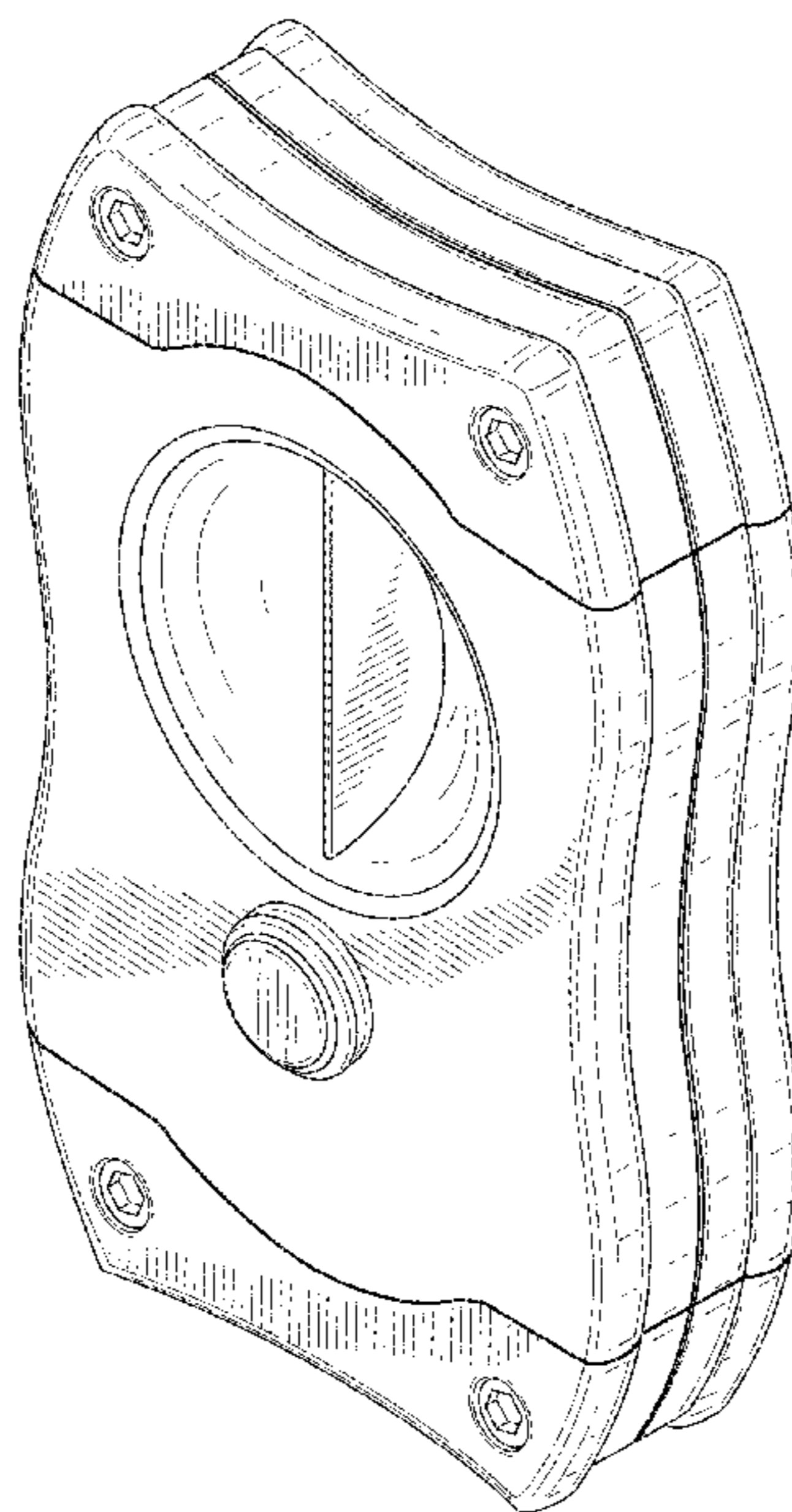
(57) **CLAIM**

The ornamental design for a cigar cutter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cigar cutter showing my new design;  
 FIG. 2 is a rear perspective view of the cigar cutter shown in FIG. 1 and shows my new design;  
 FIG. 3 is a front view of the cigar cutter shown in FIGS. 1 and 2, and shows my new design;  
 FIG. 4 is a rear view of the cigar cutter shown in FIGS. 1 and 2, and shows my new design;  
 FIG. 5 is a left side view of the cigar cutter shown in FIGS. 1 and 2 and shows my new design;  
 FIG. 6 is a side right view of the cigar cutter shown in FIGS. 1 and 2 and shows my new design;  
 FIG. 7 is a top view of the cigar cutter shown in FIGS. 1 and 2 and show my new design; and,  
 FIG. 8 is a bottom view of the cigar cutter shown in FIGS. 1 and 2 and shows my new design.  
 The device is a mechanism for cutting the tip of a cigar (or other rolled tobacco product) to expose a clean tip of the same for lighting a match thereto.

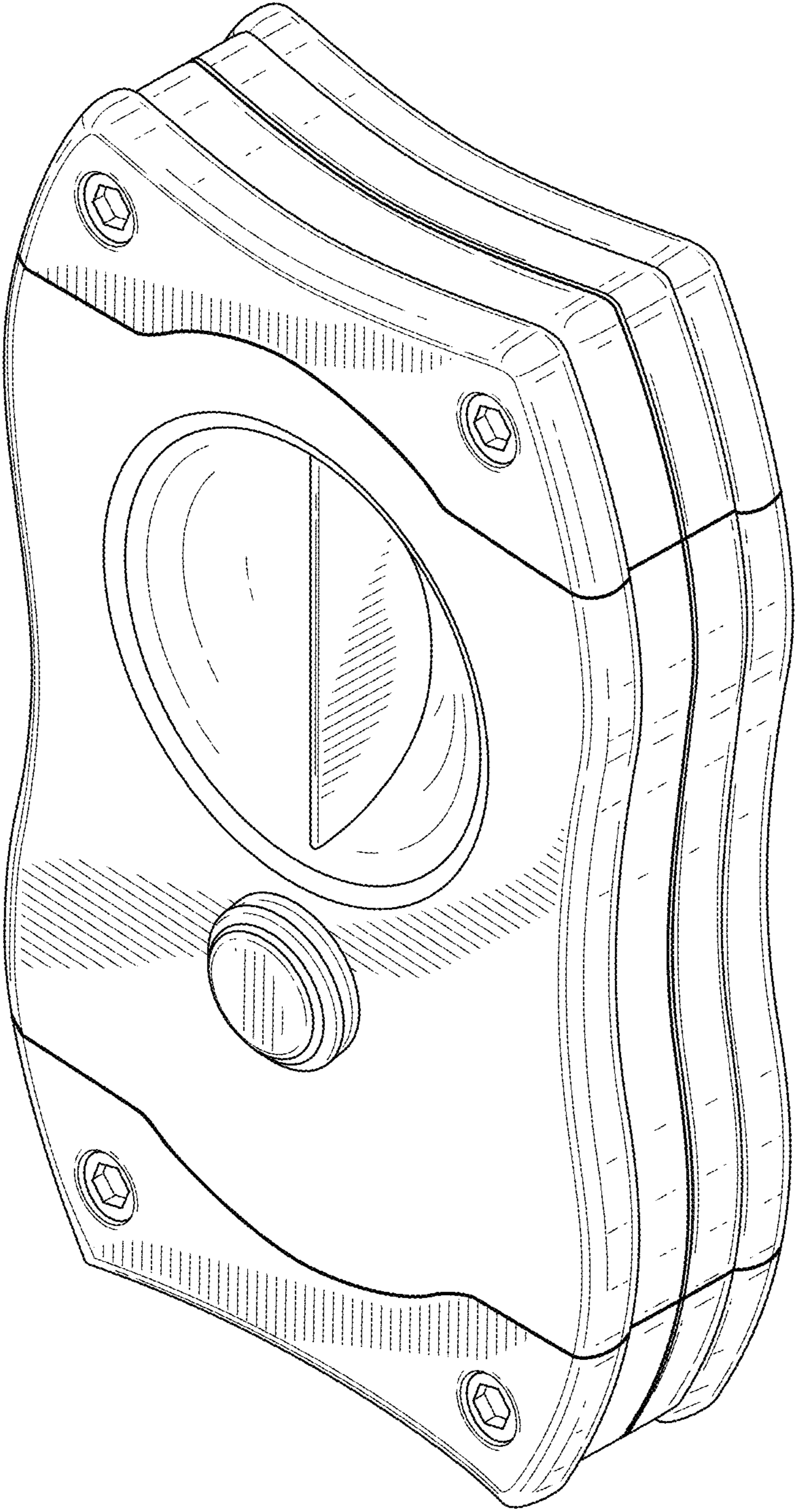

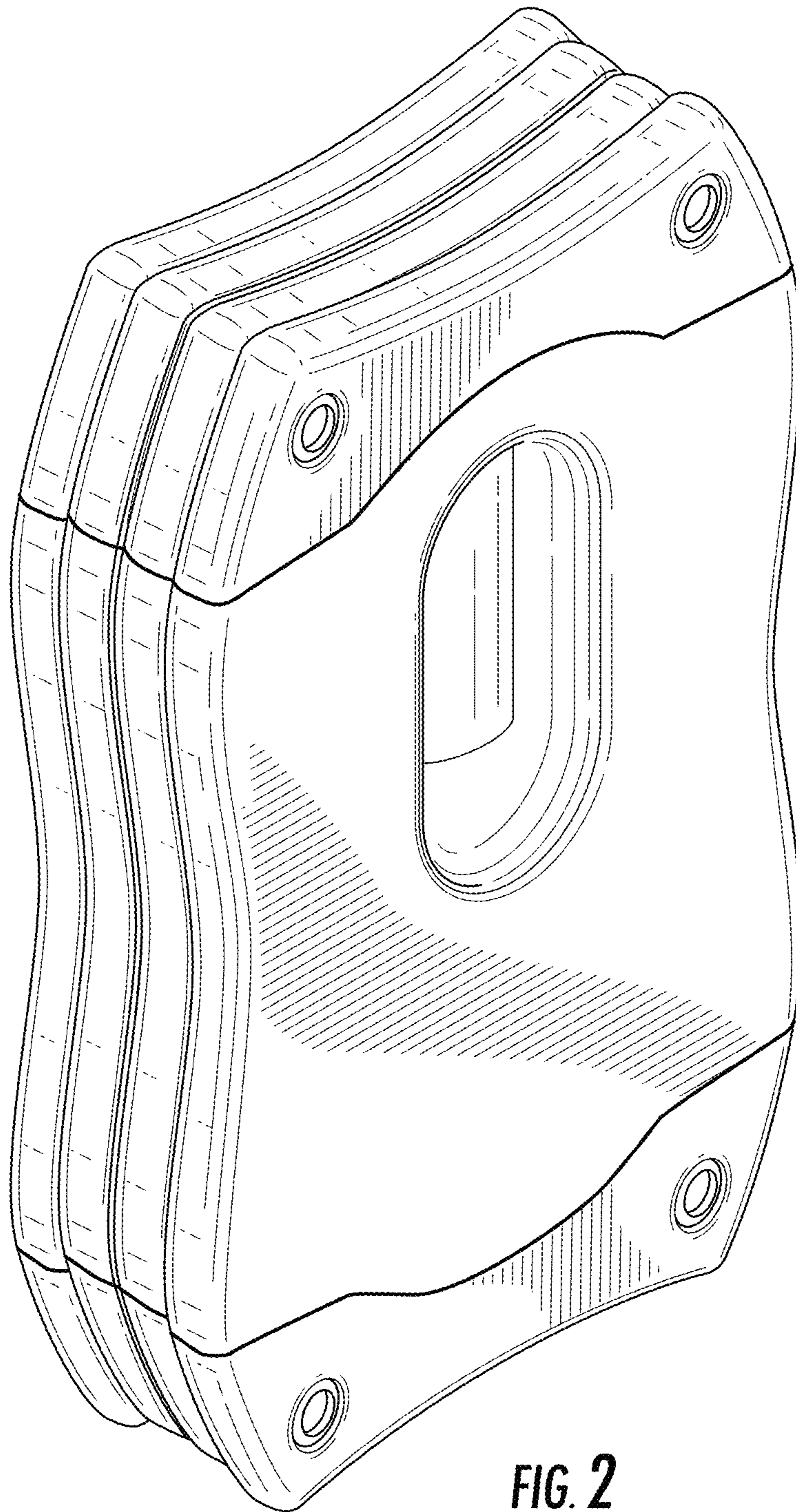

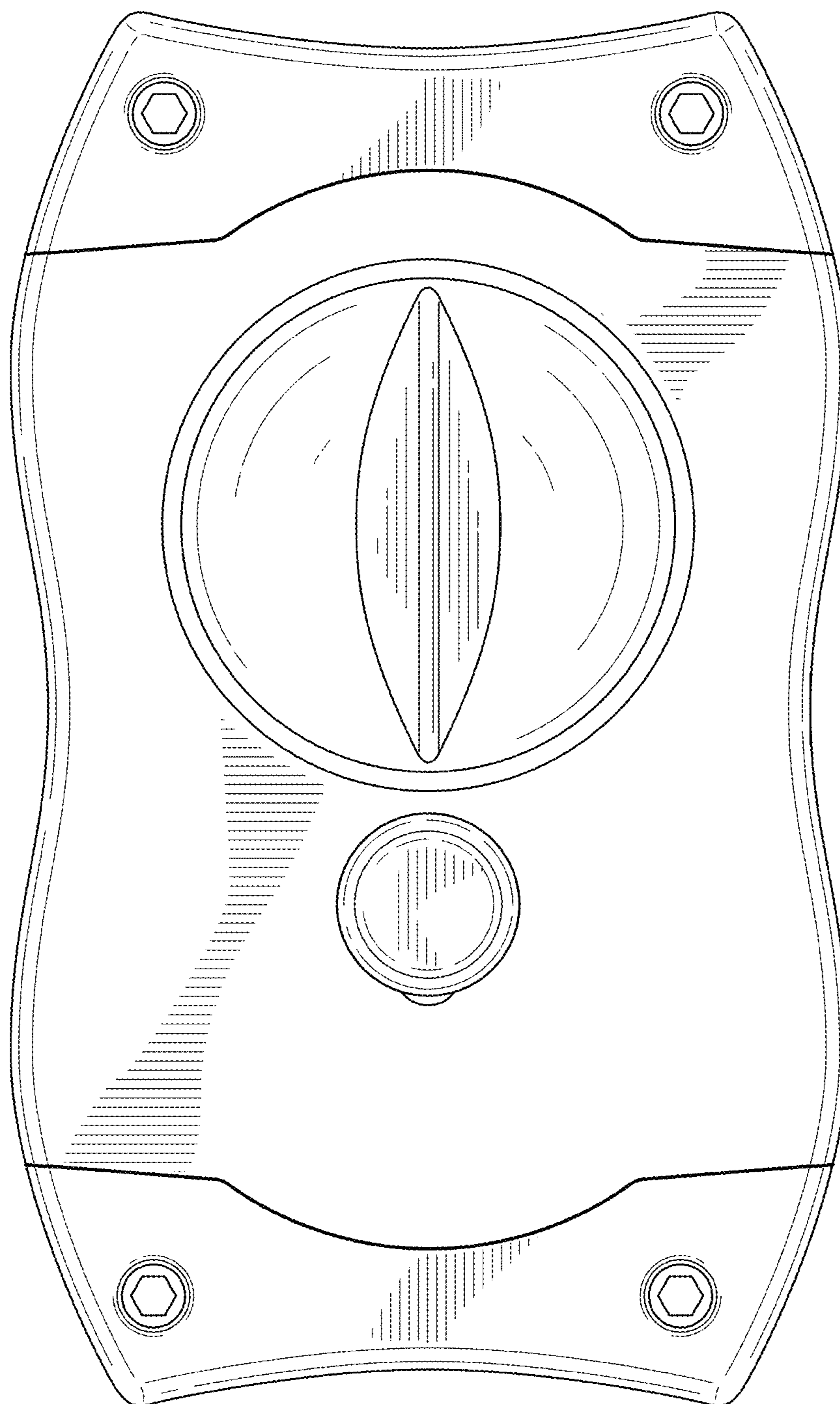

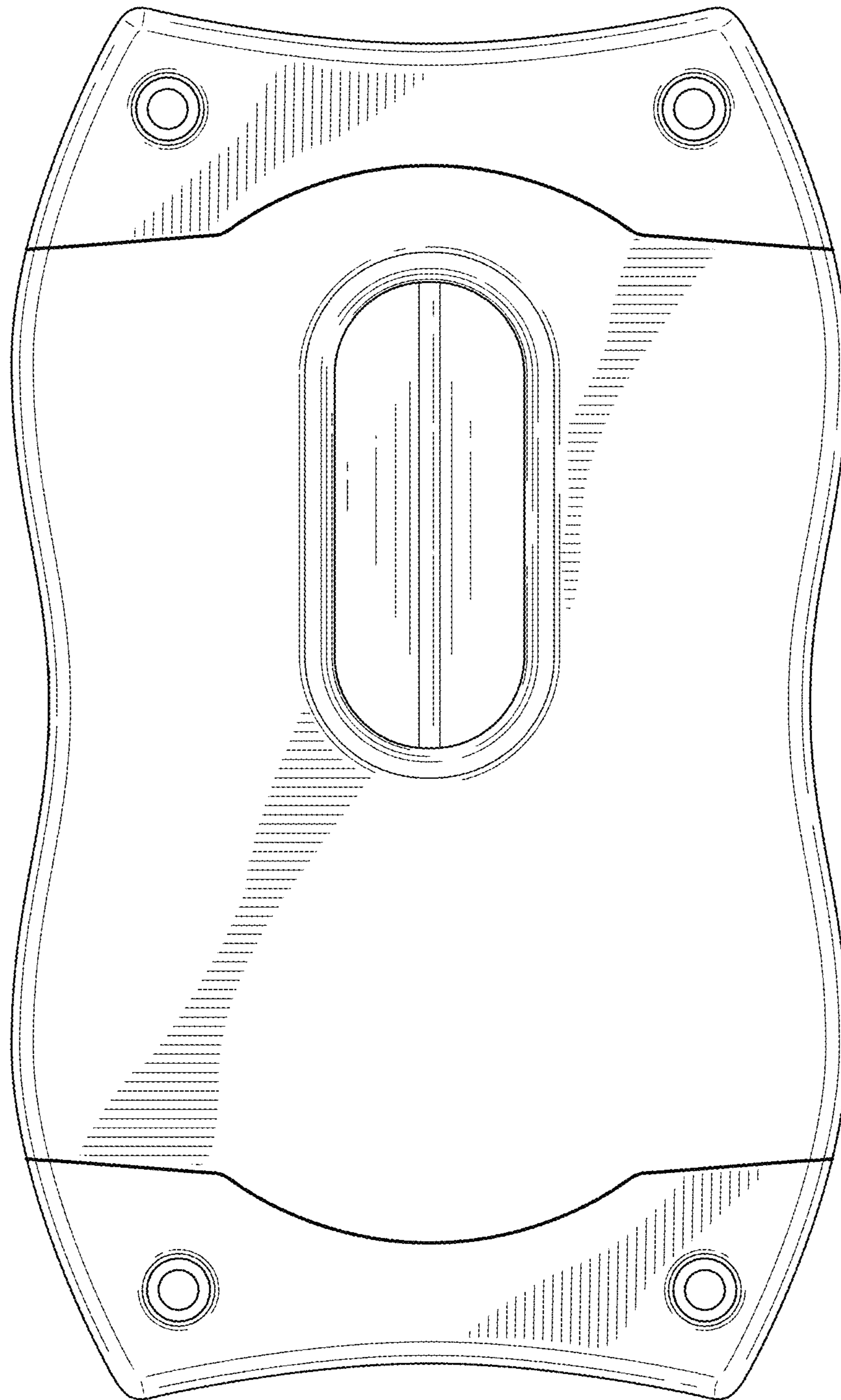
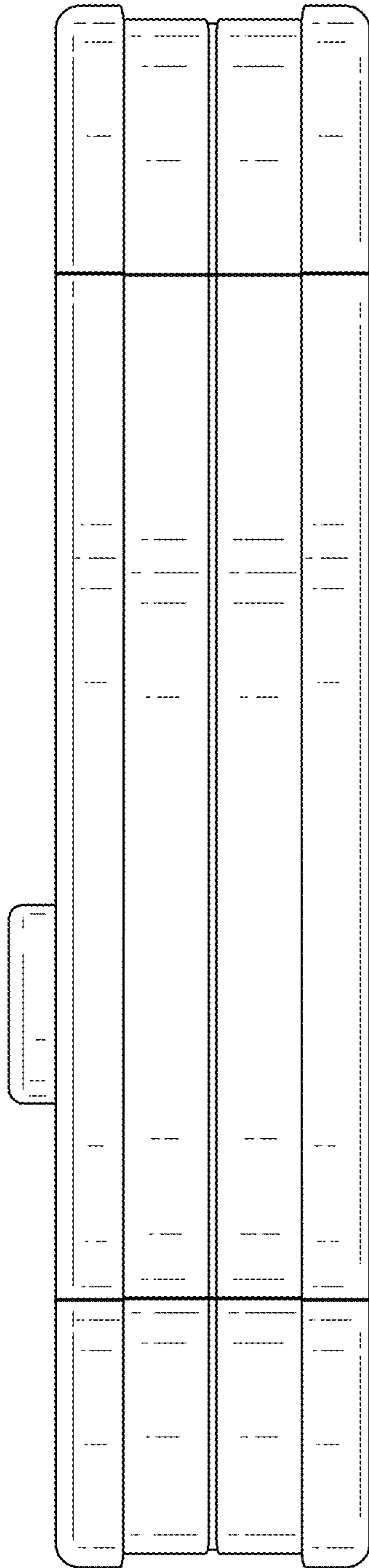
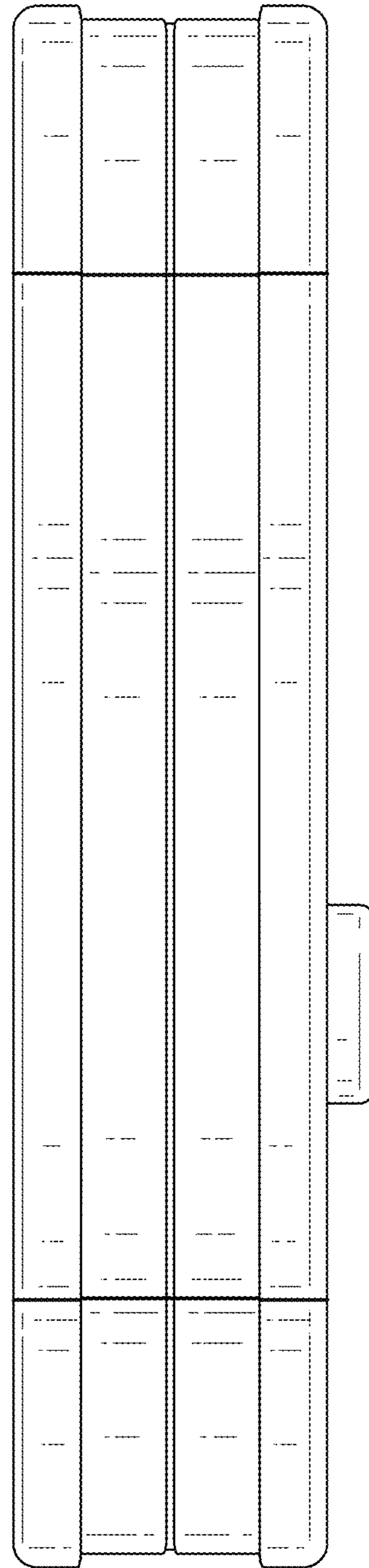


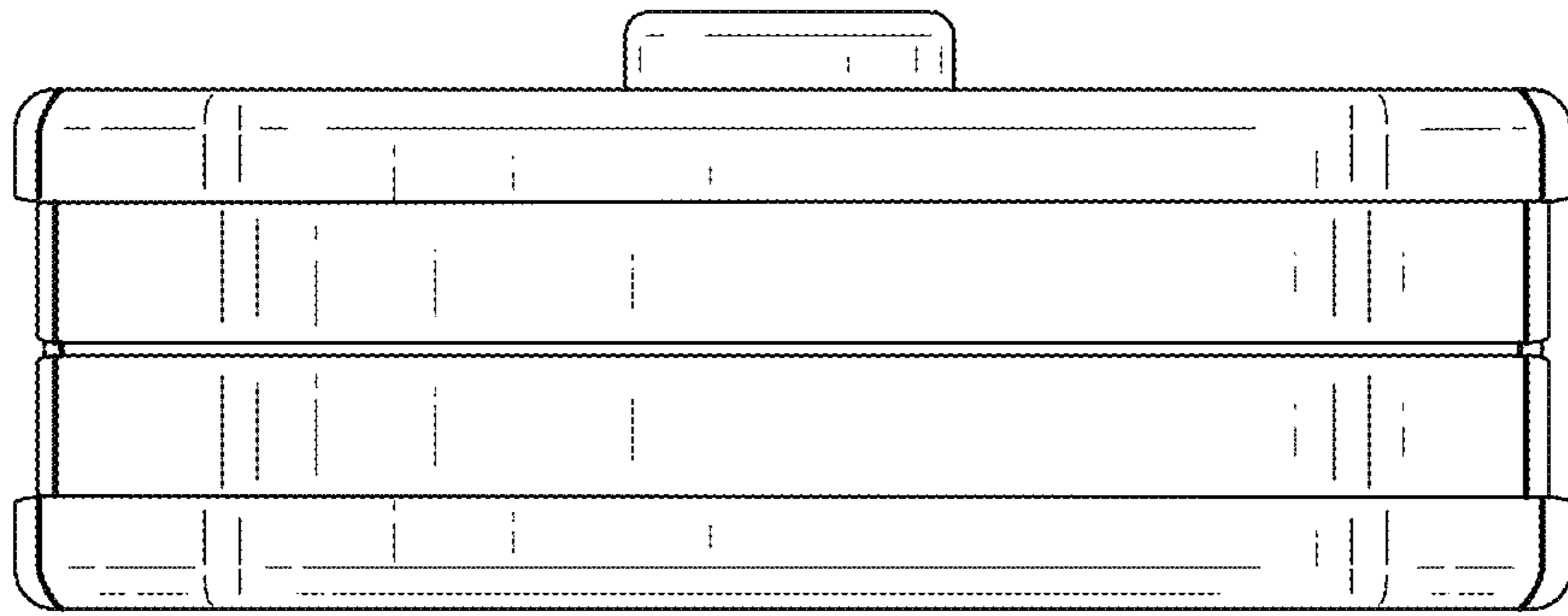

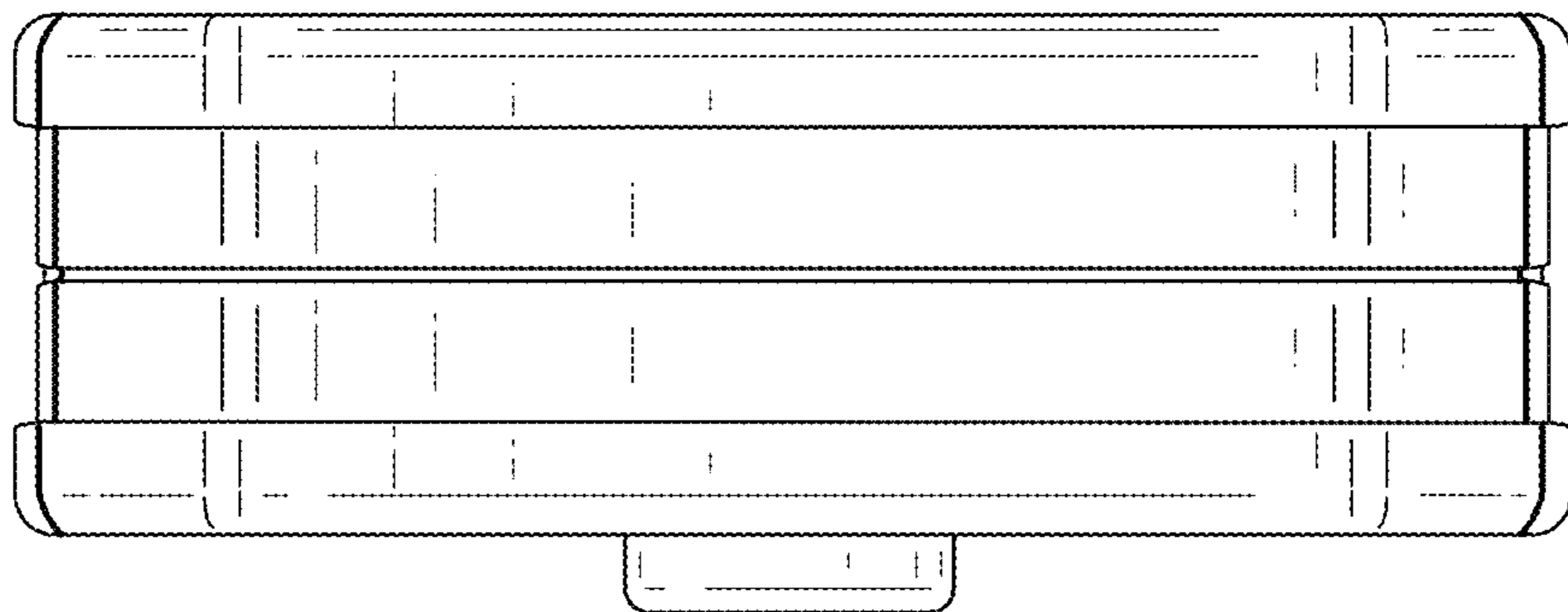
