**DESCRIPTION**

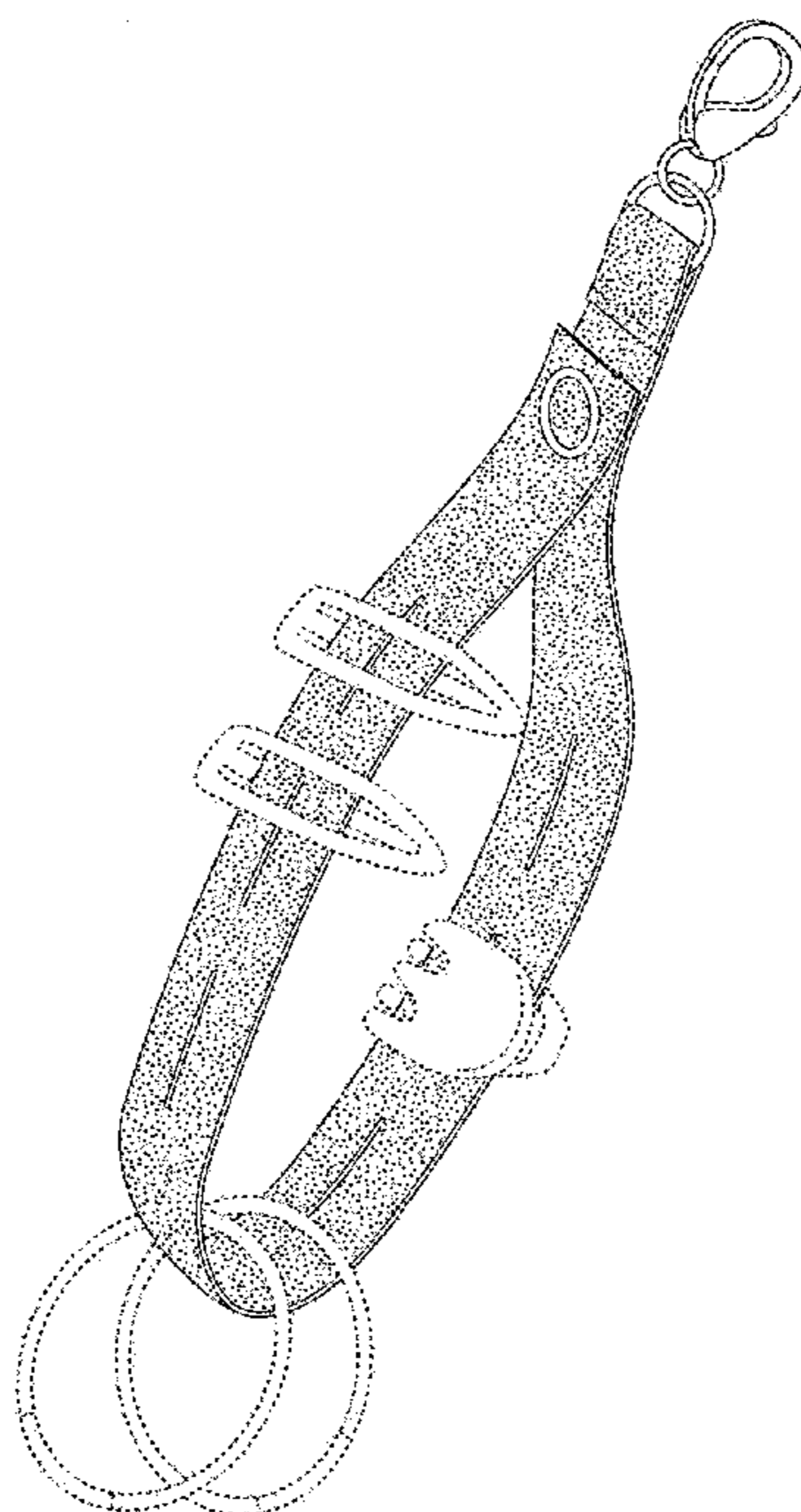
FIG. 1 is of a front isometric view of the hairband holder of the present invention,

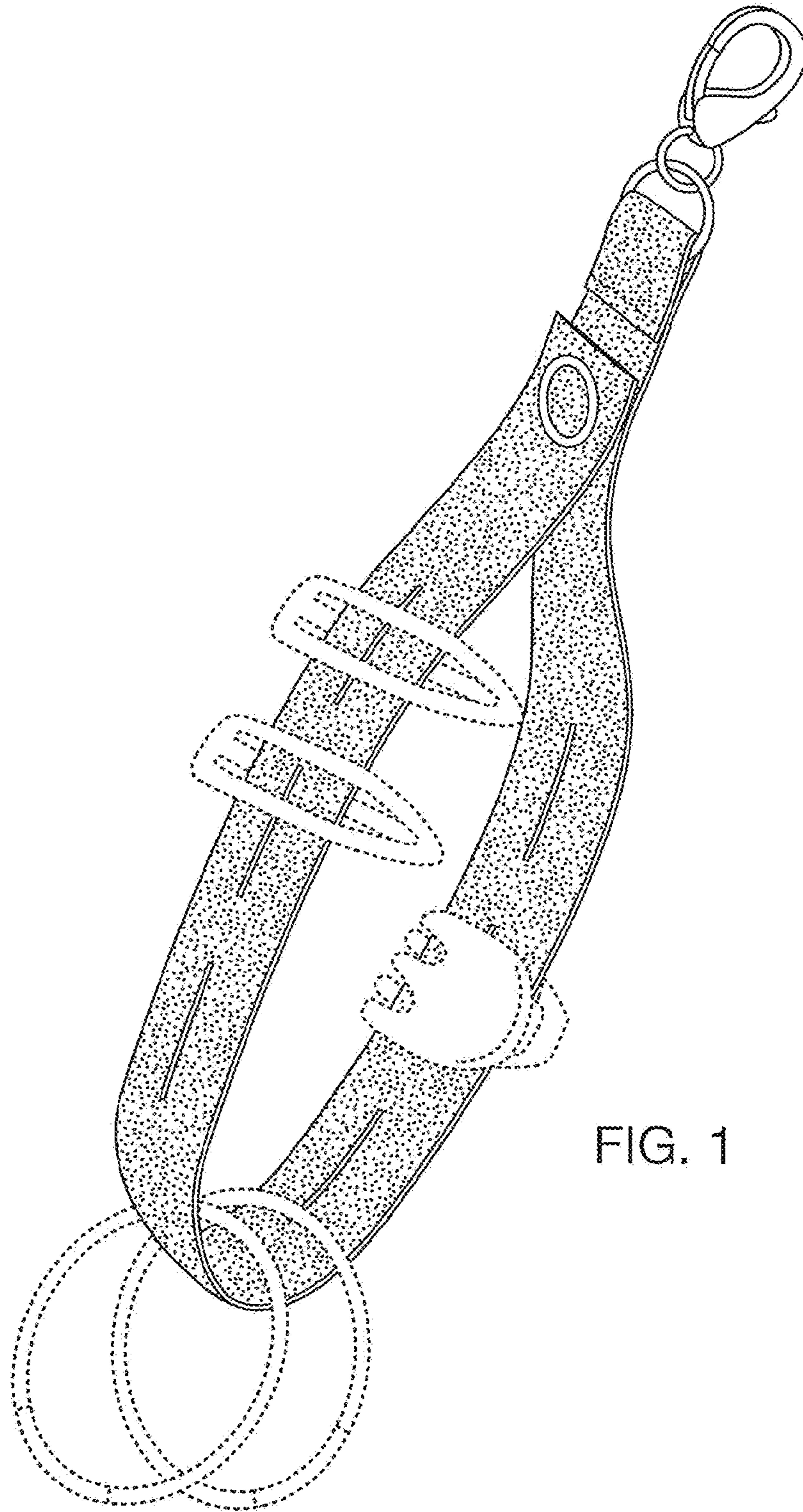

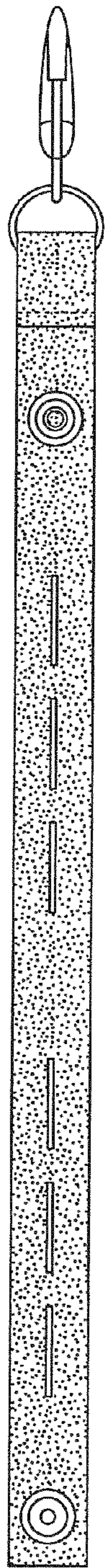

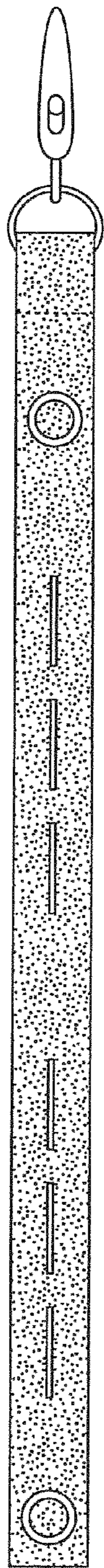

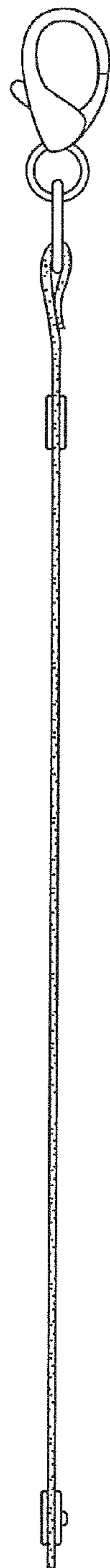

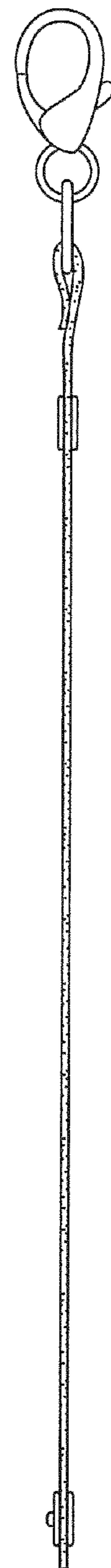

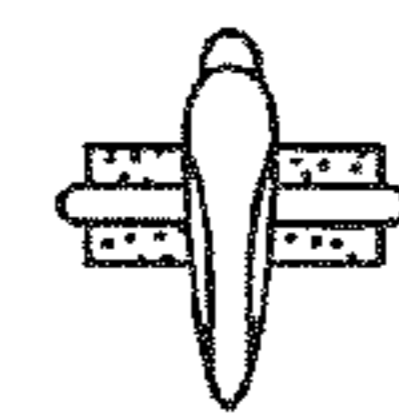

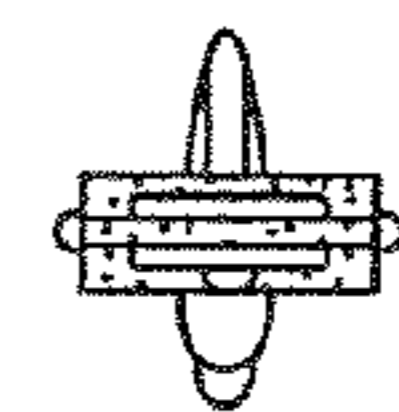
