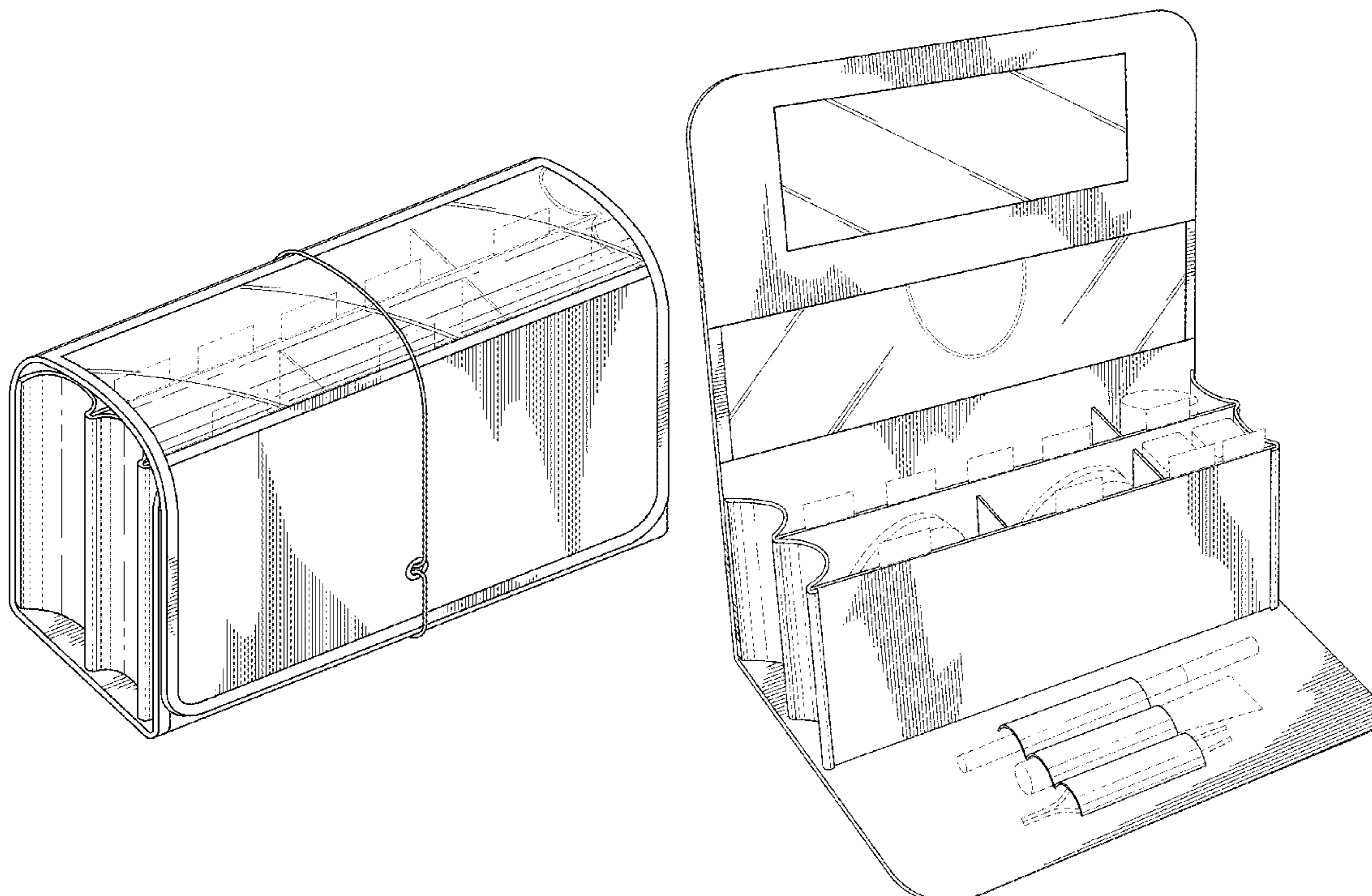
(57) **CLAIM**

The ornamental design for a portable cosmetic organizer, as shown and described herein.

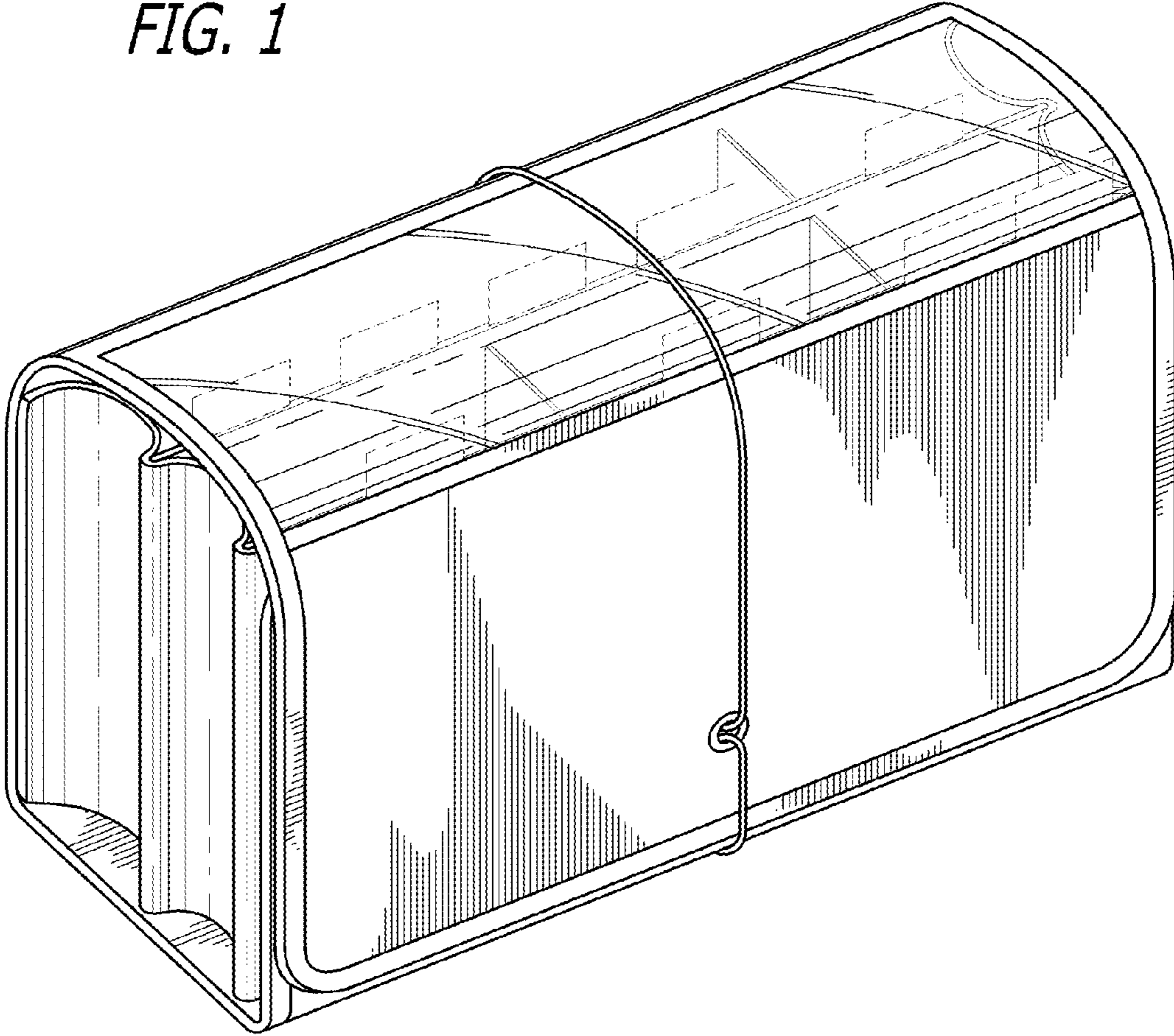
**DESCRIPTION**

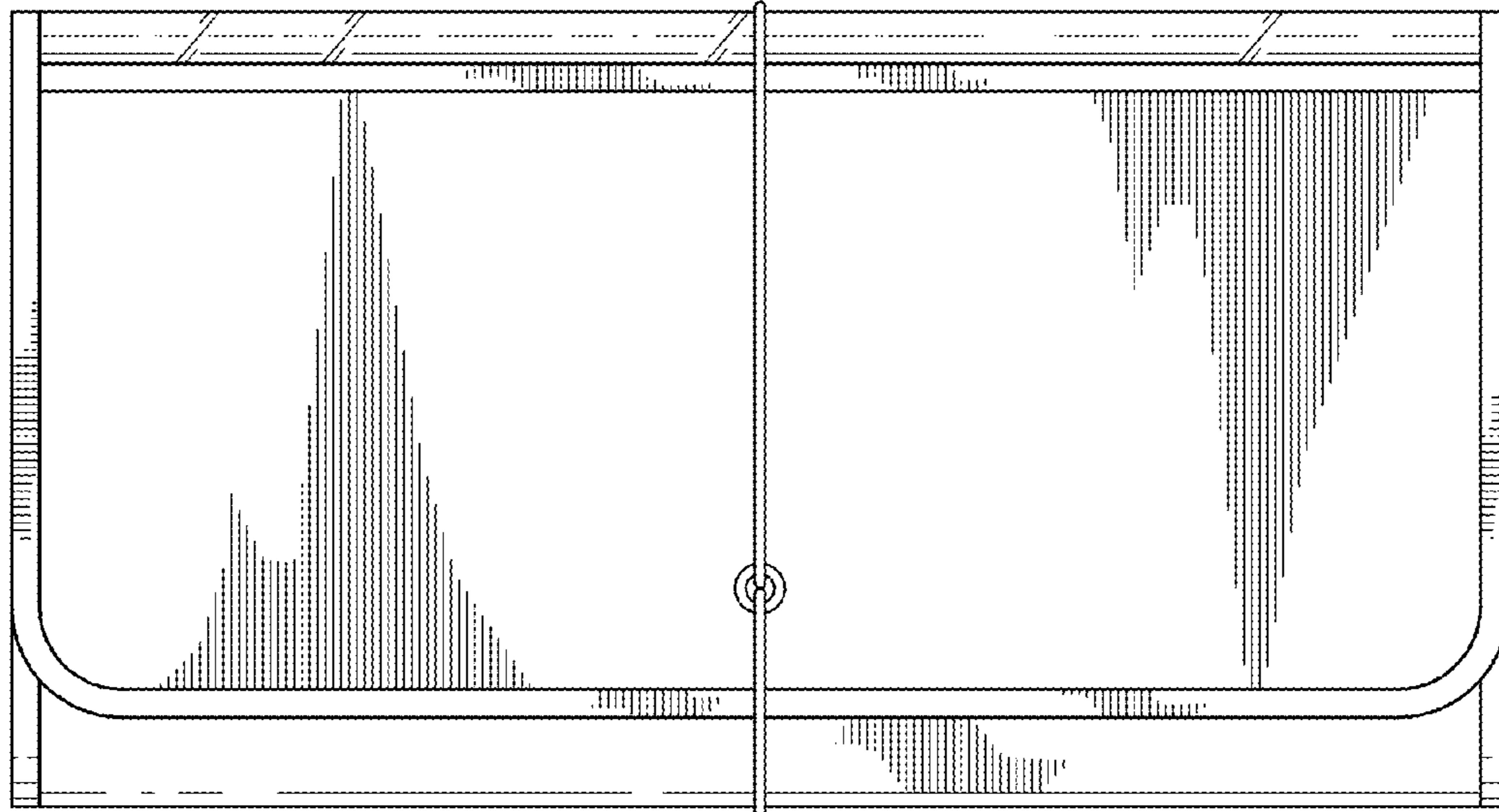

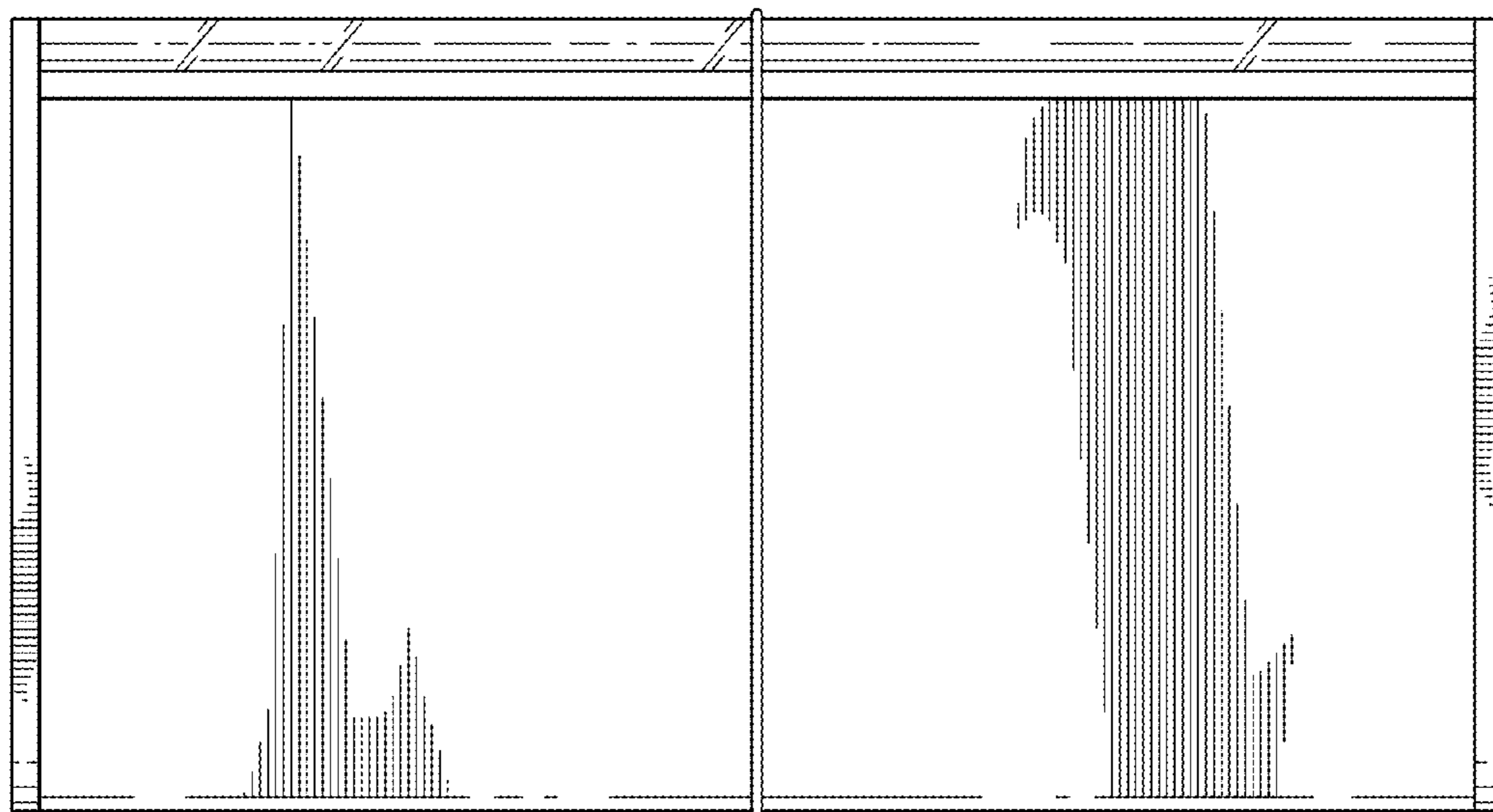
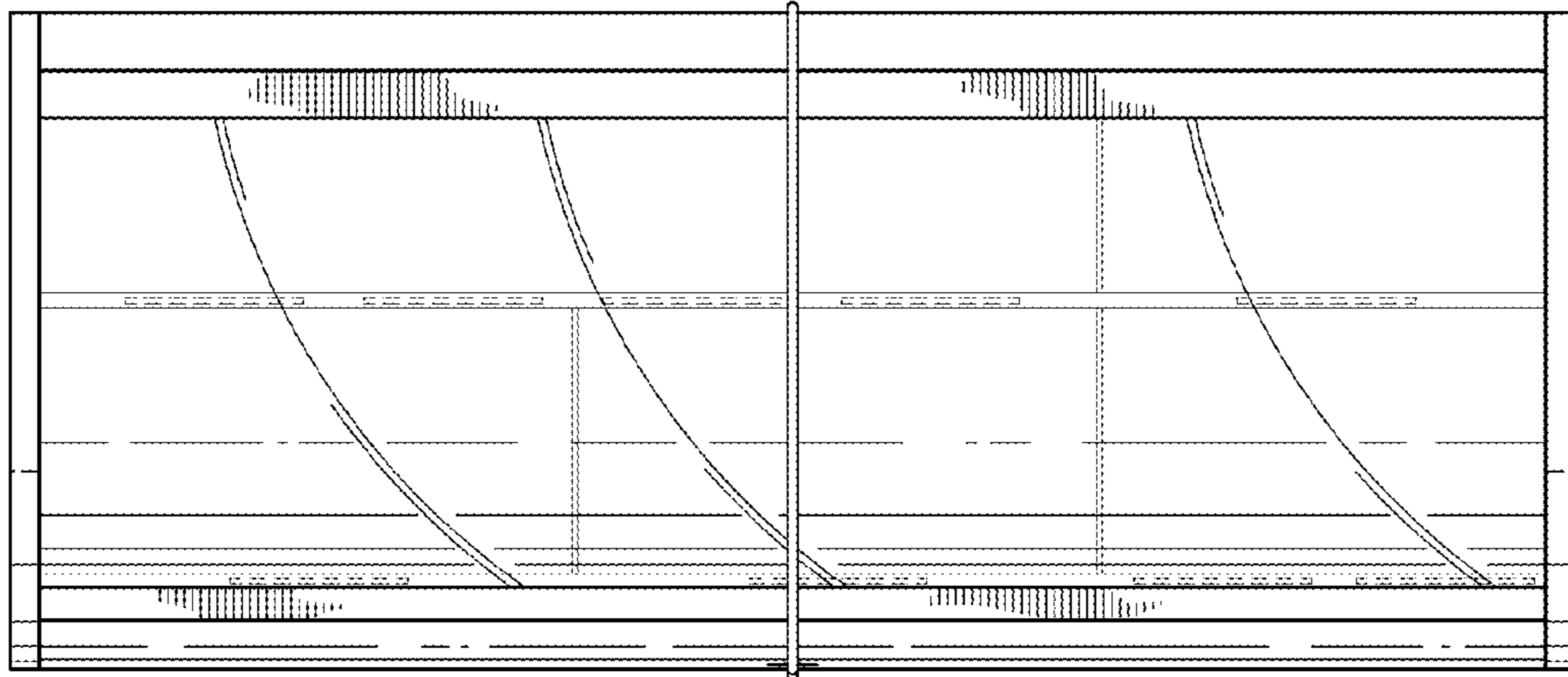
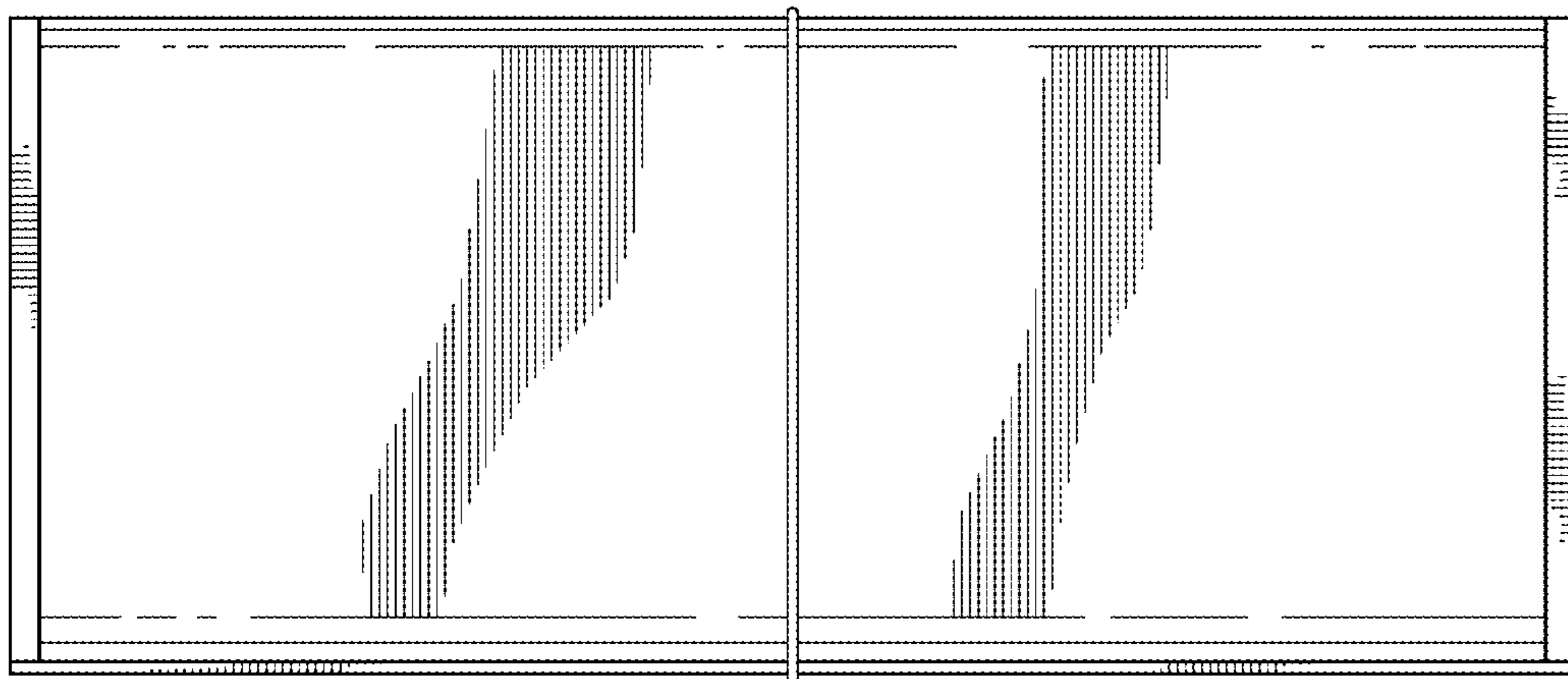


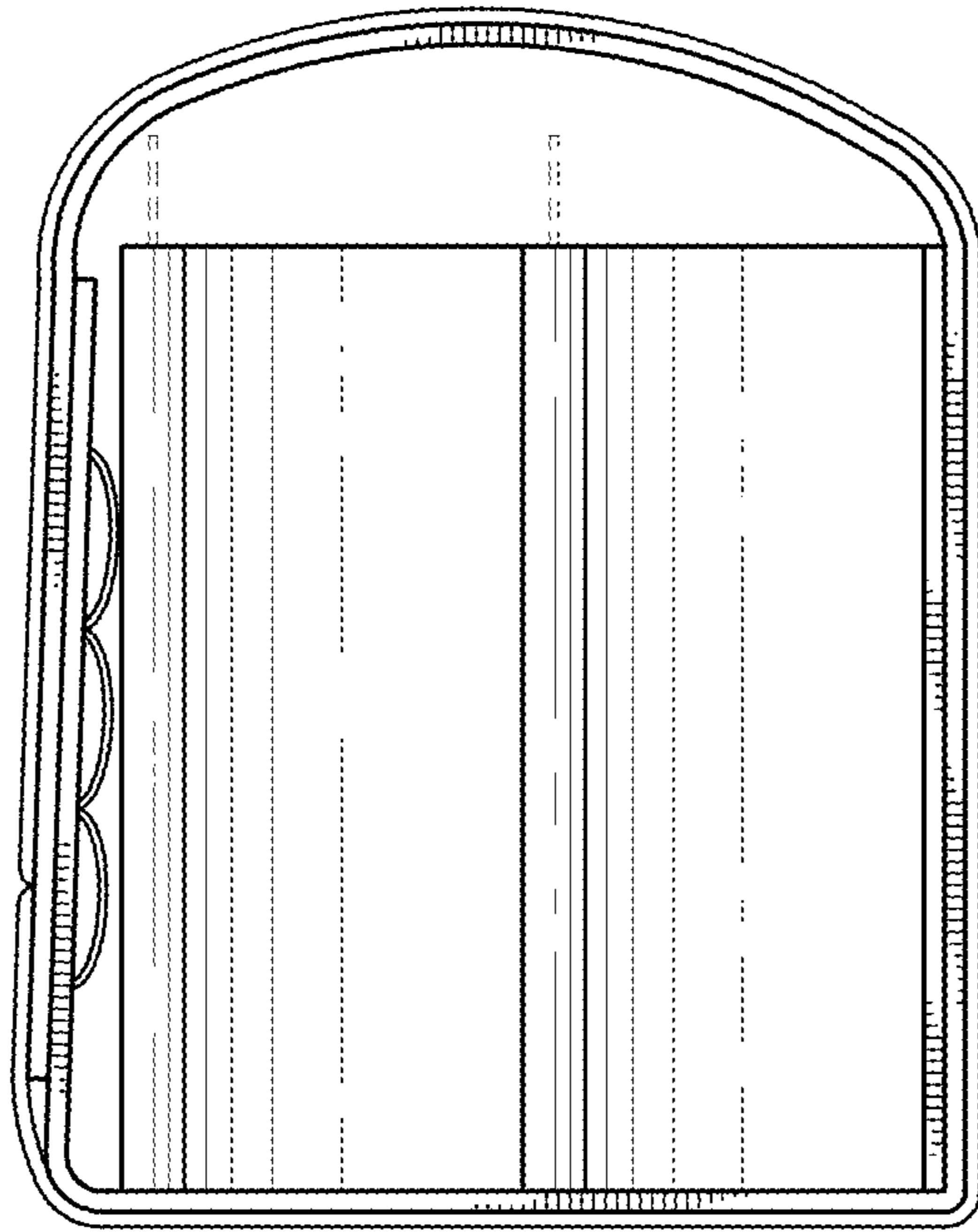

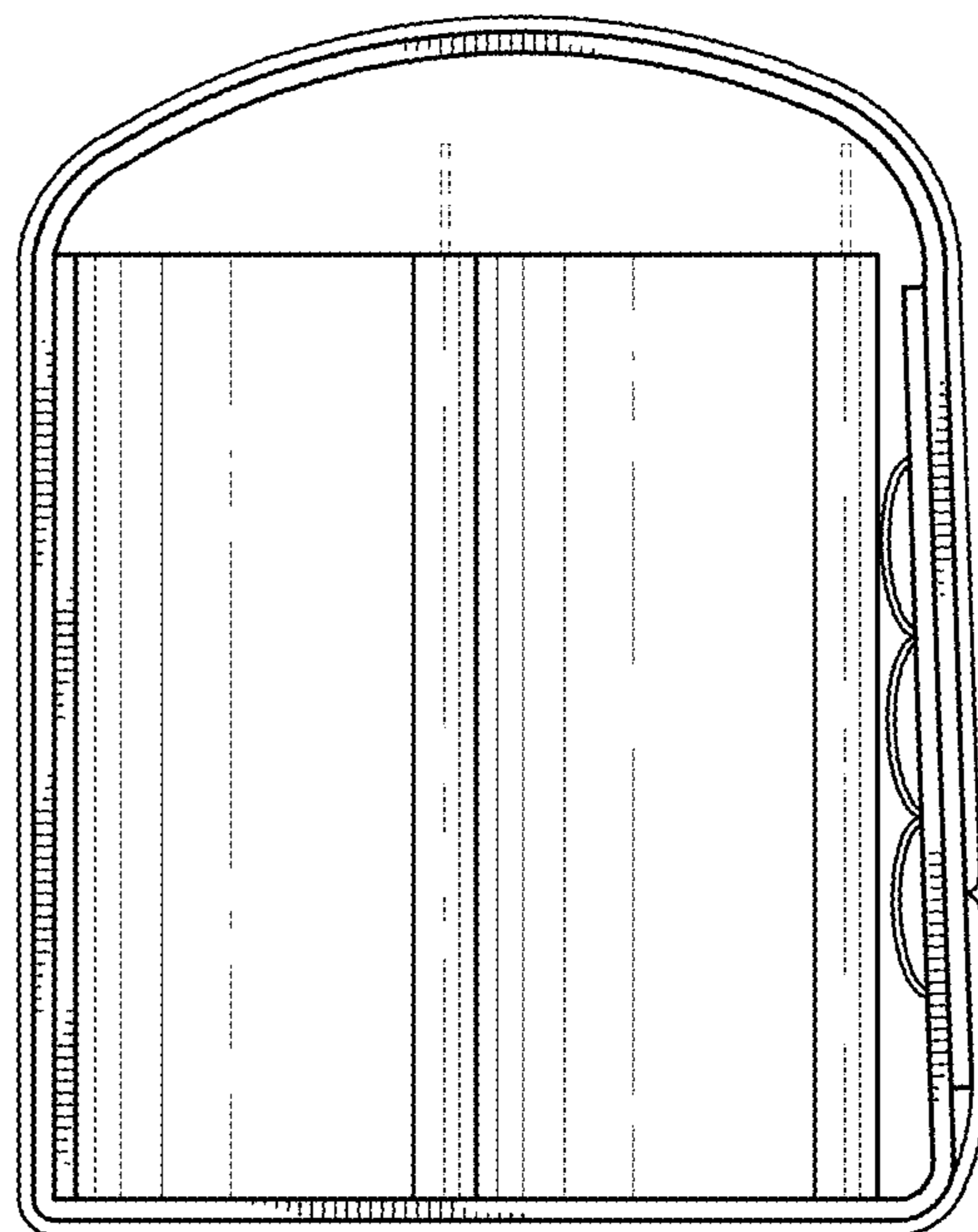

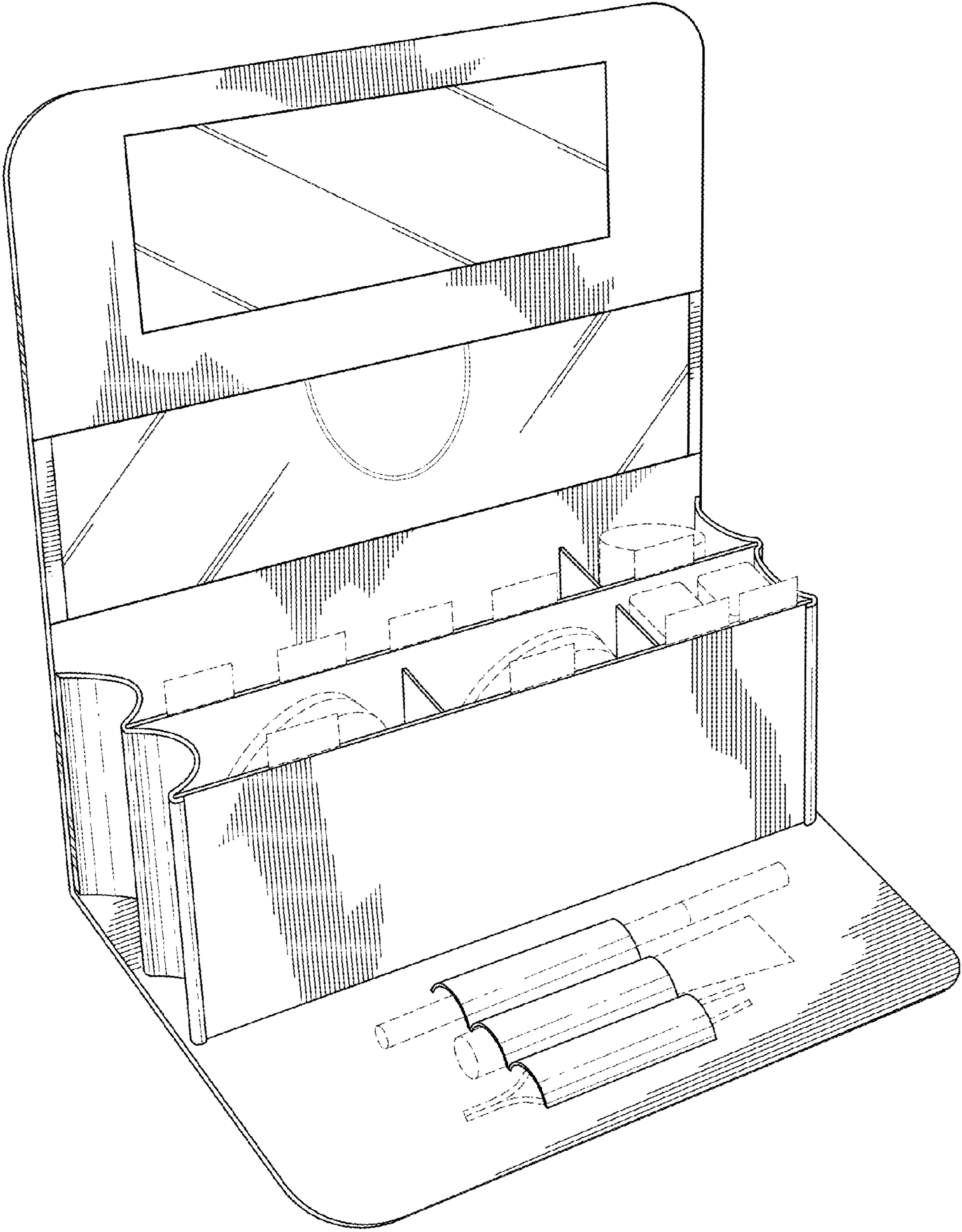
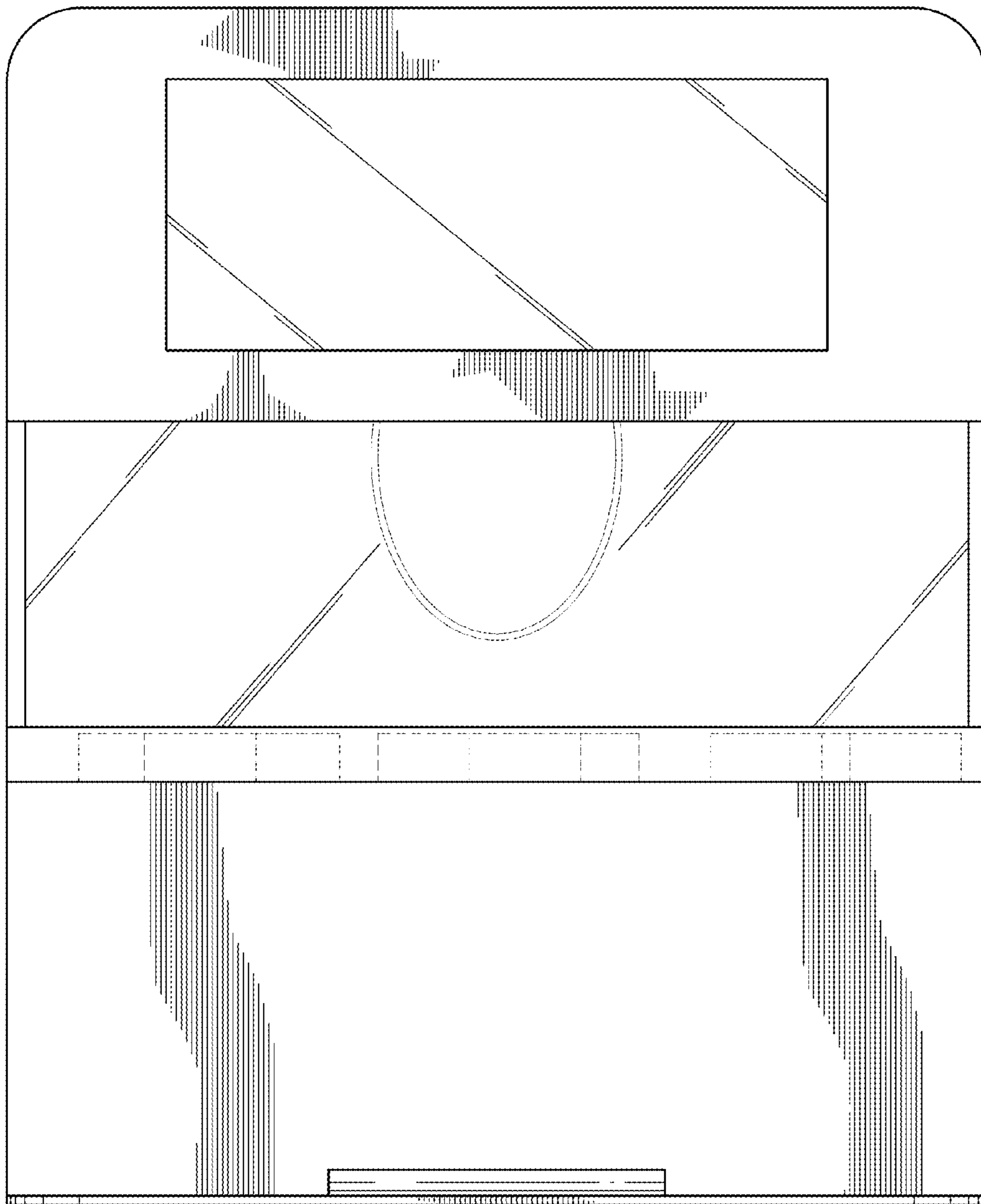
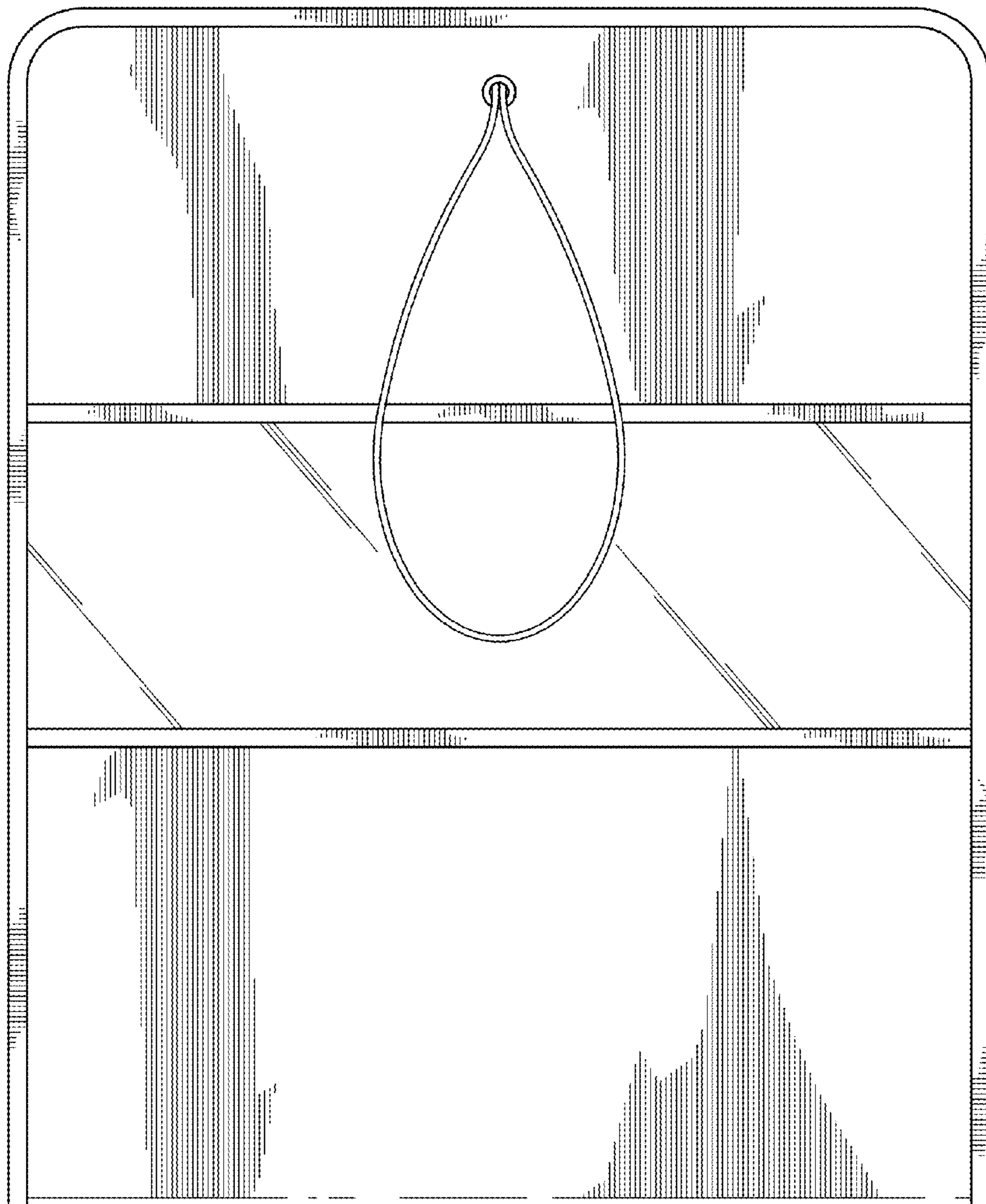

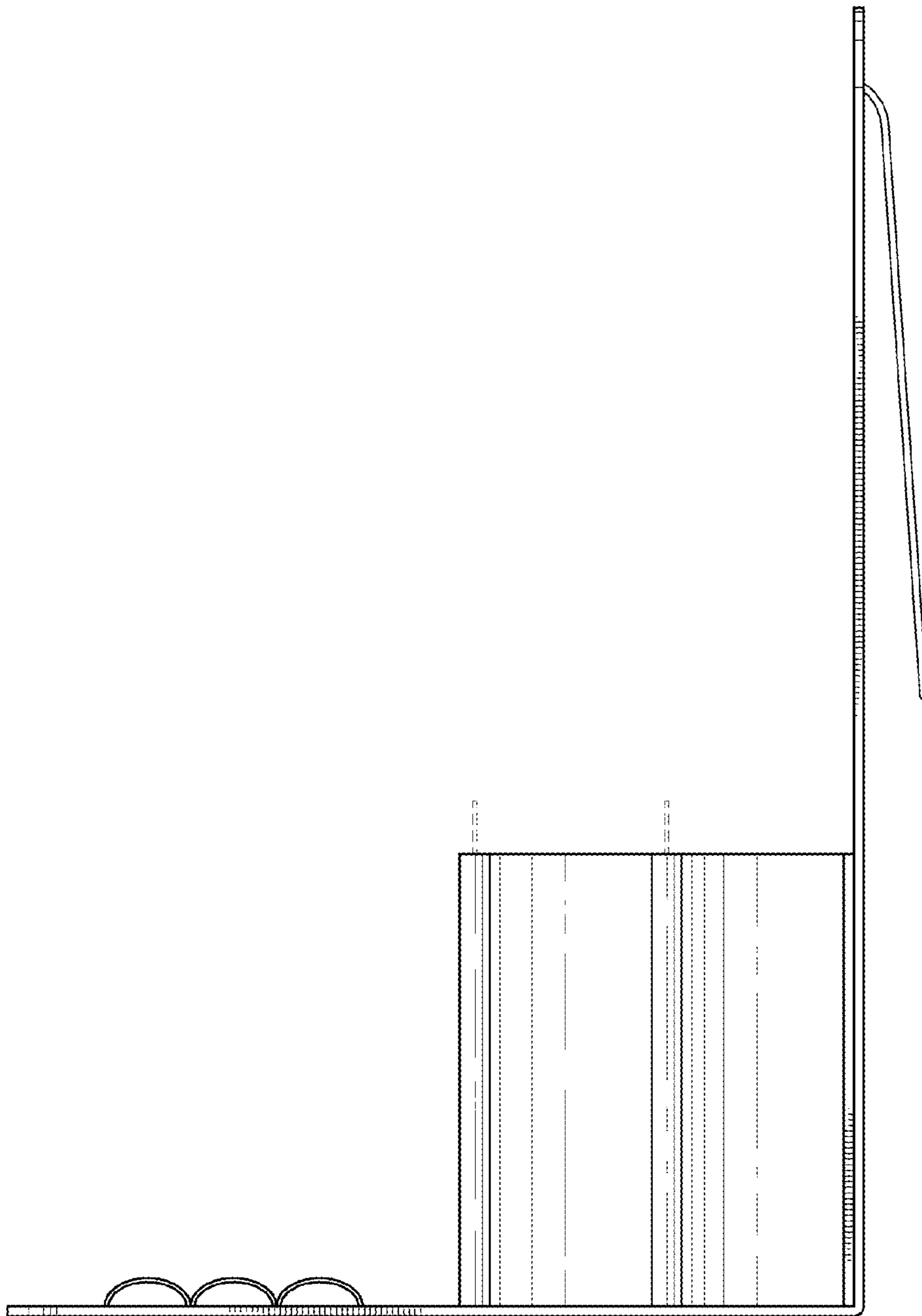

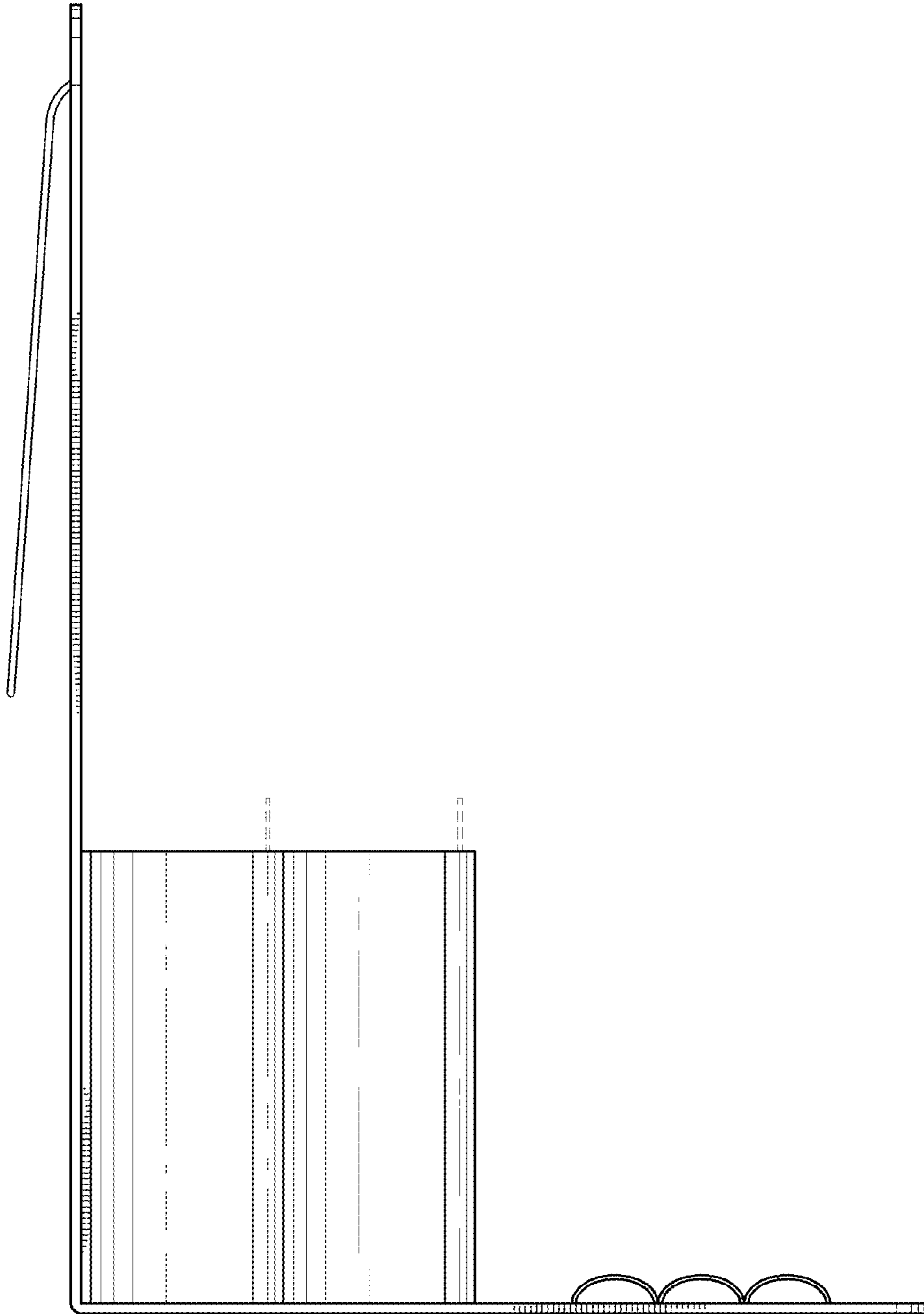
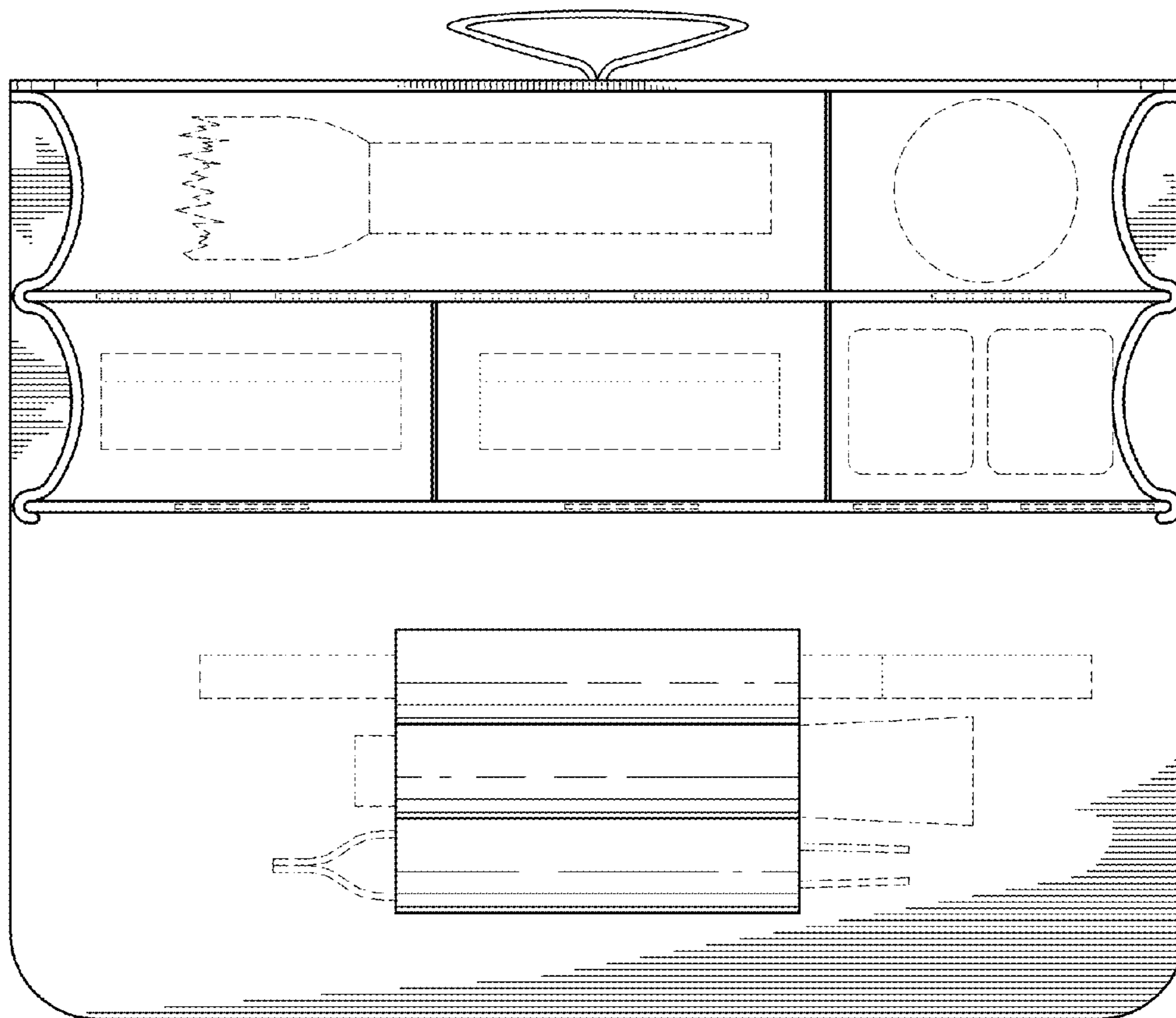
