DESCRIPTION

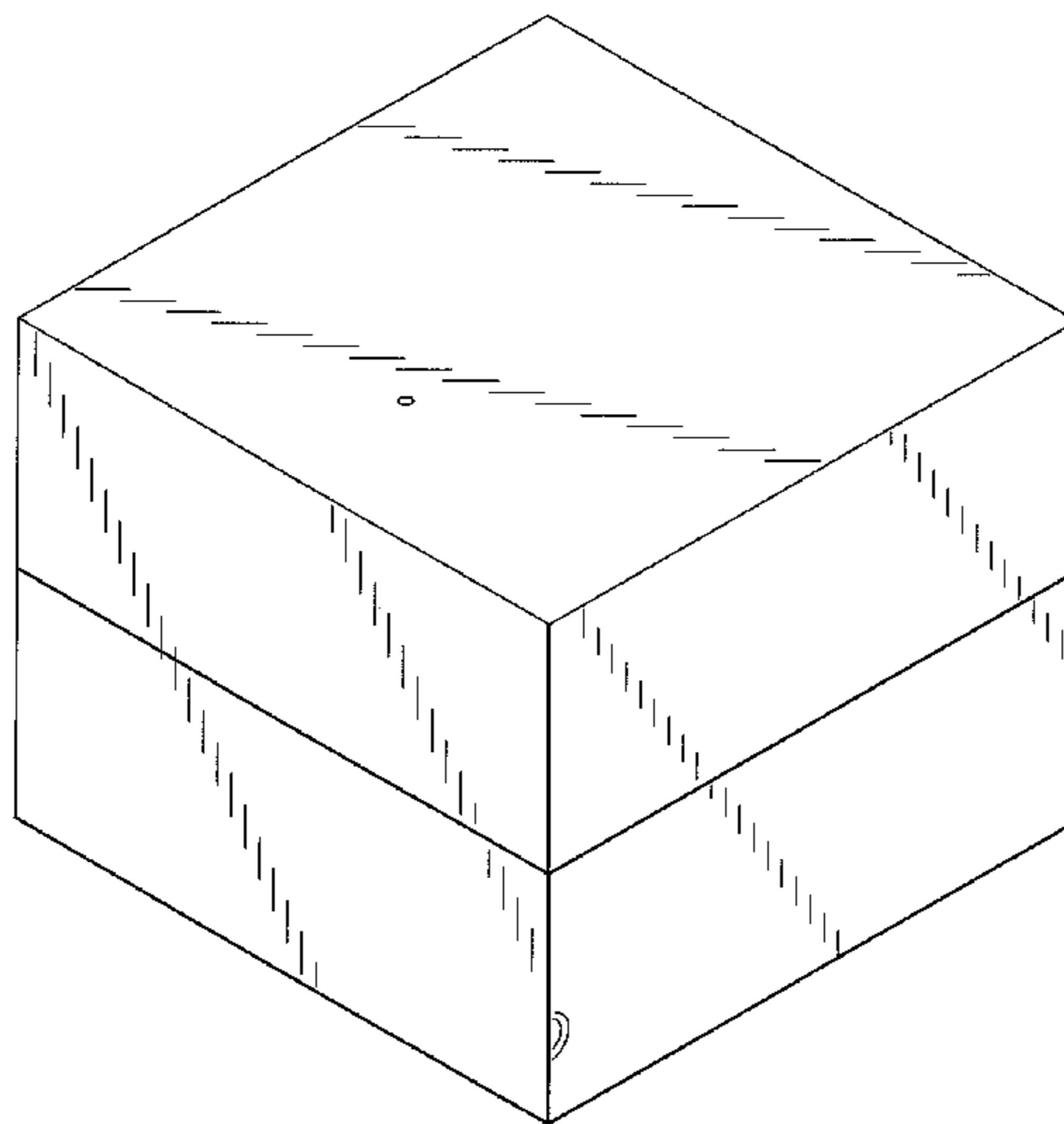
FIG. 1 is a perspective view of a media storage apparatus showing my new design;

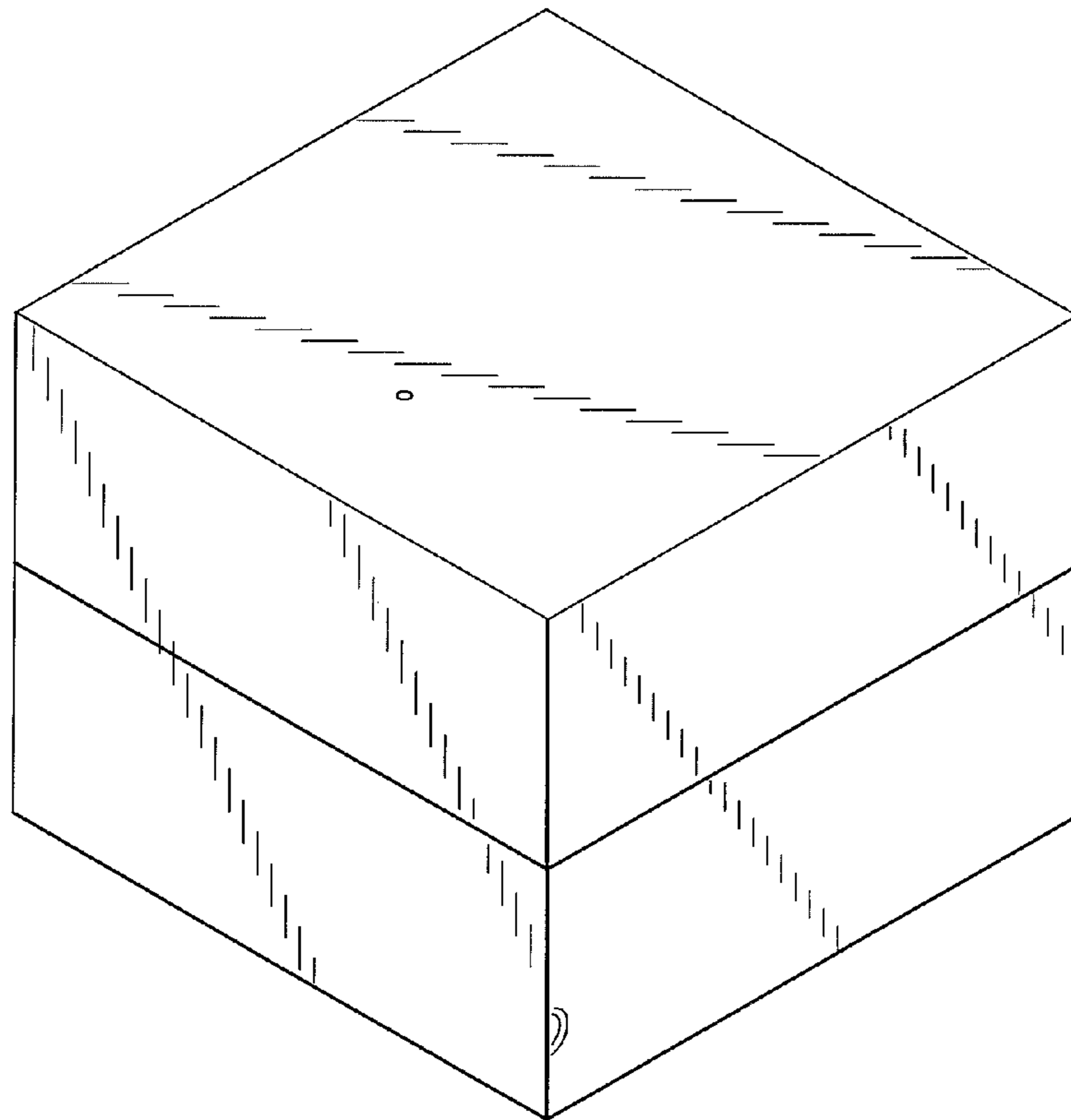

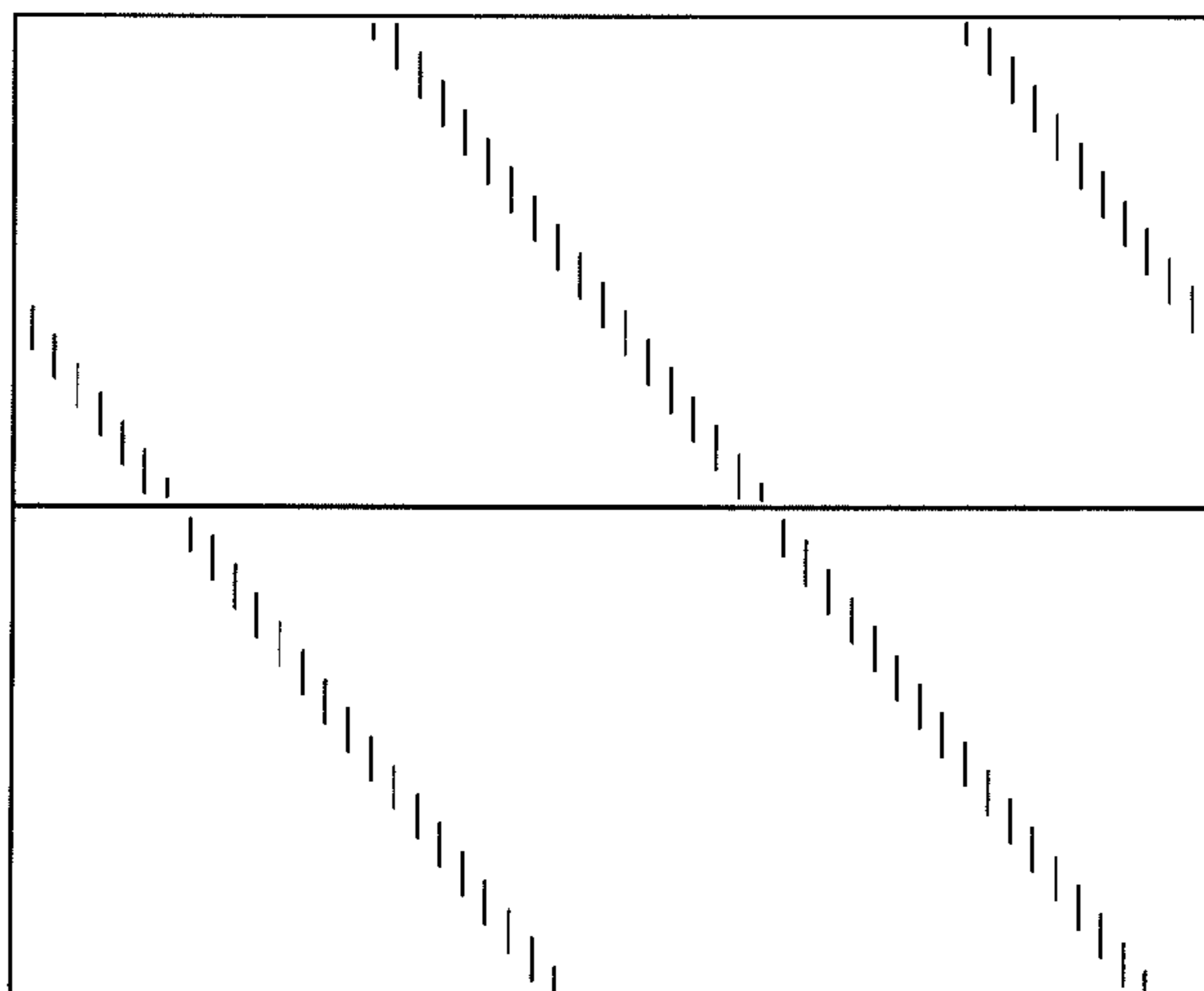

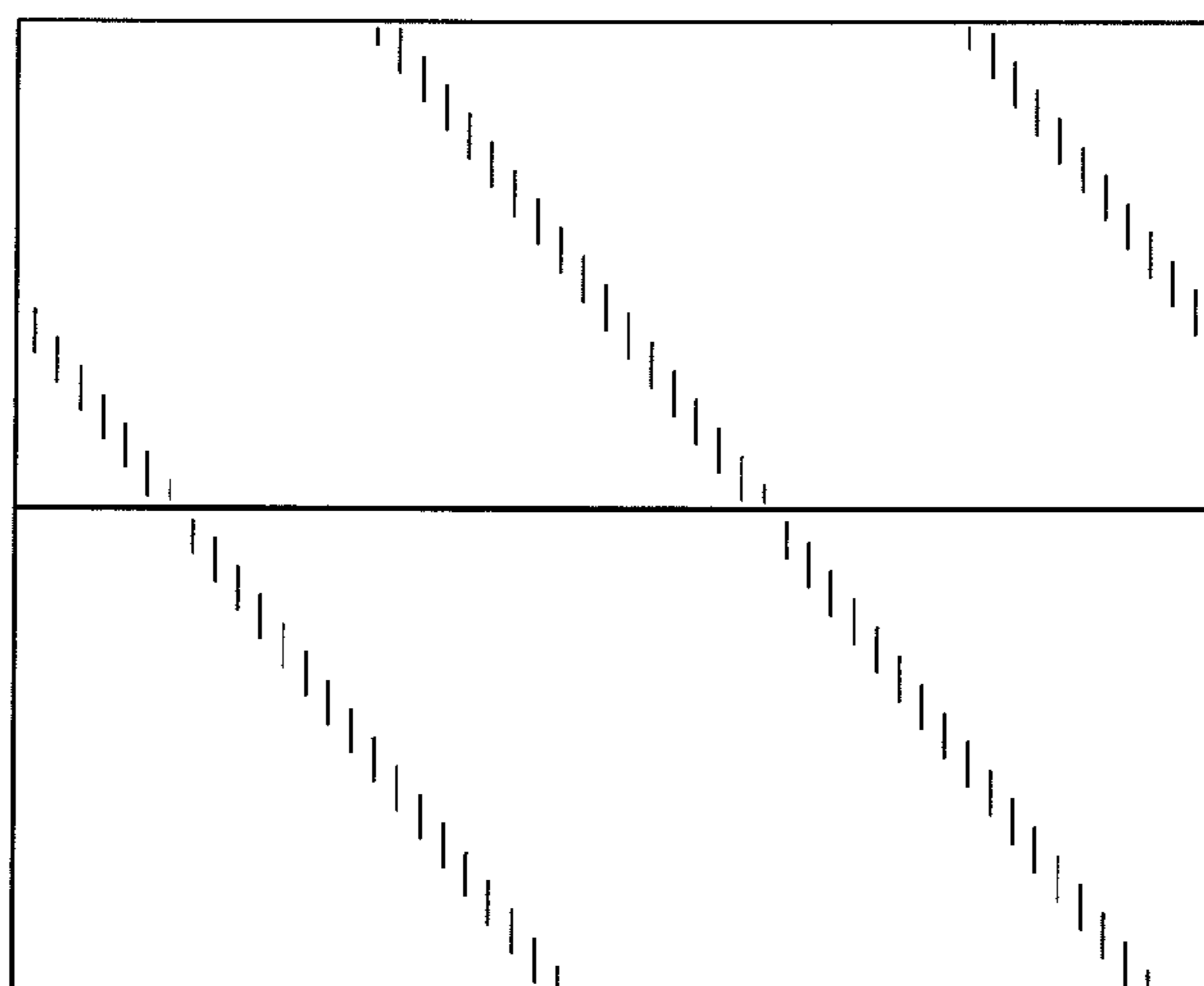

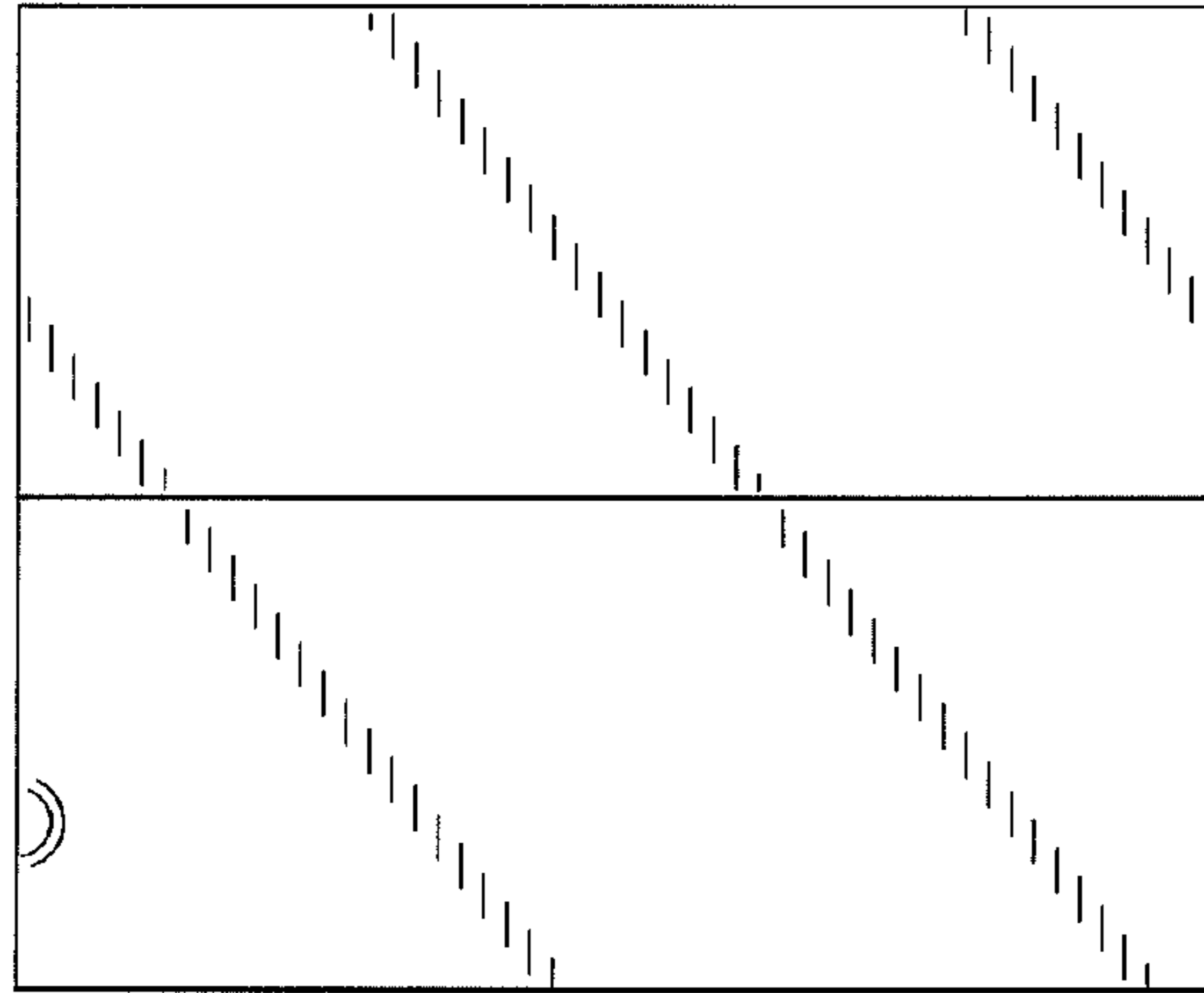

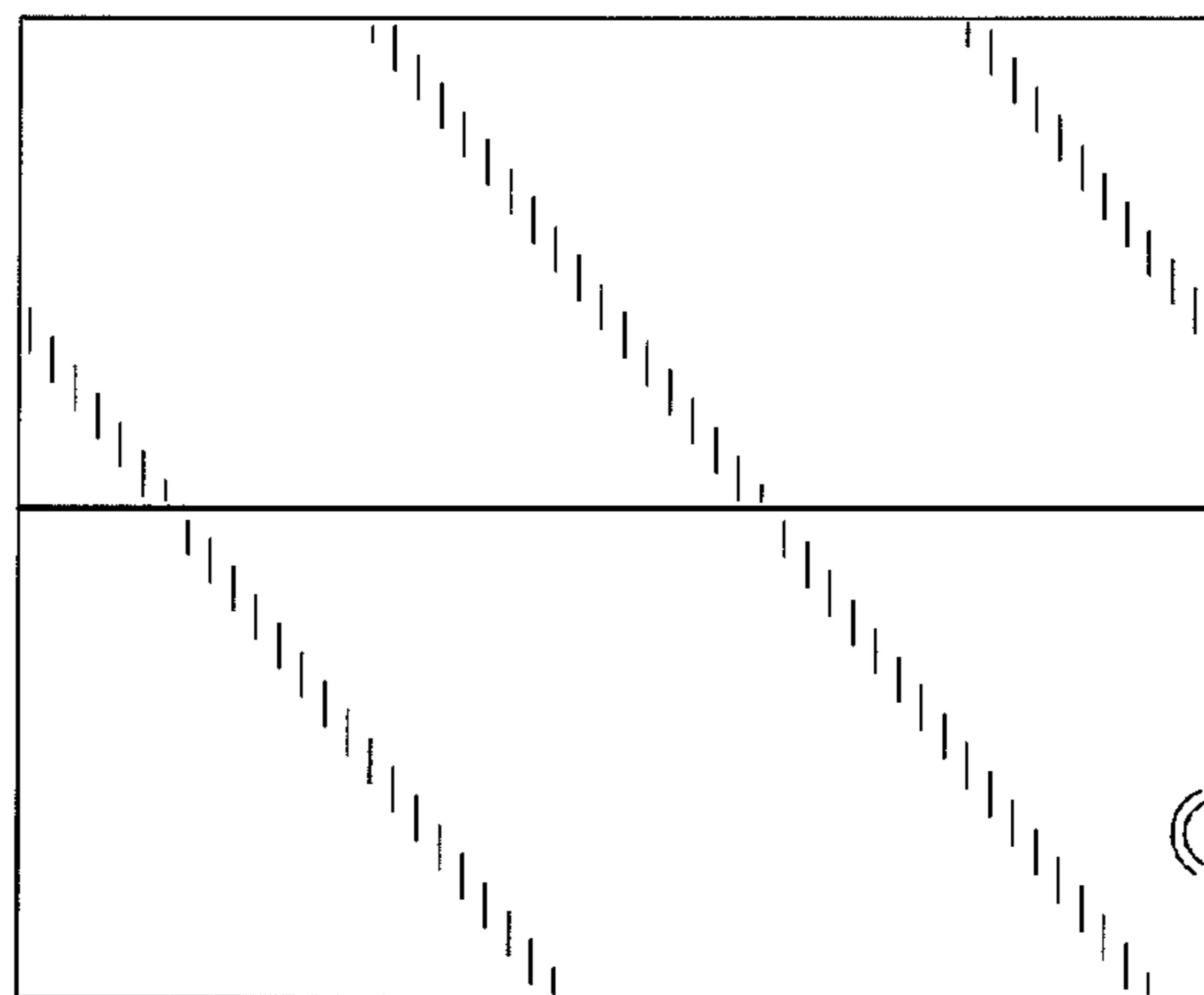

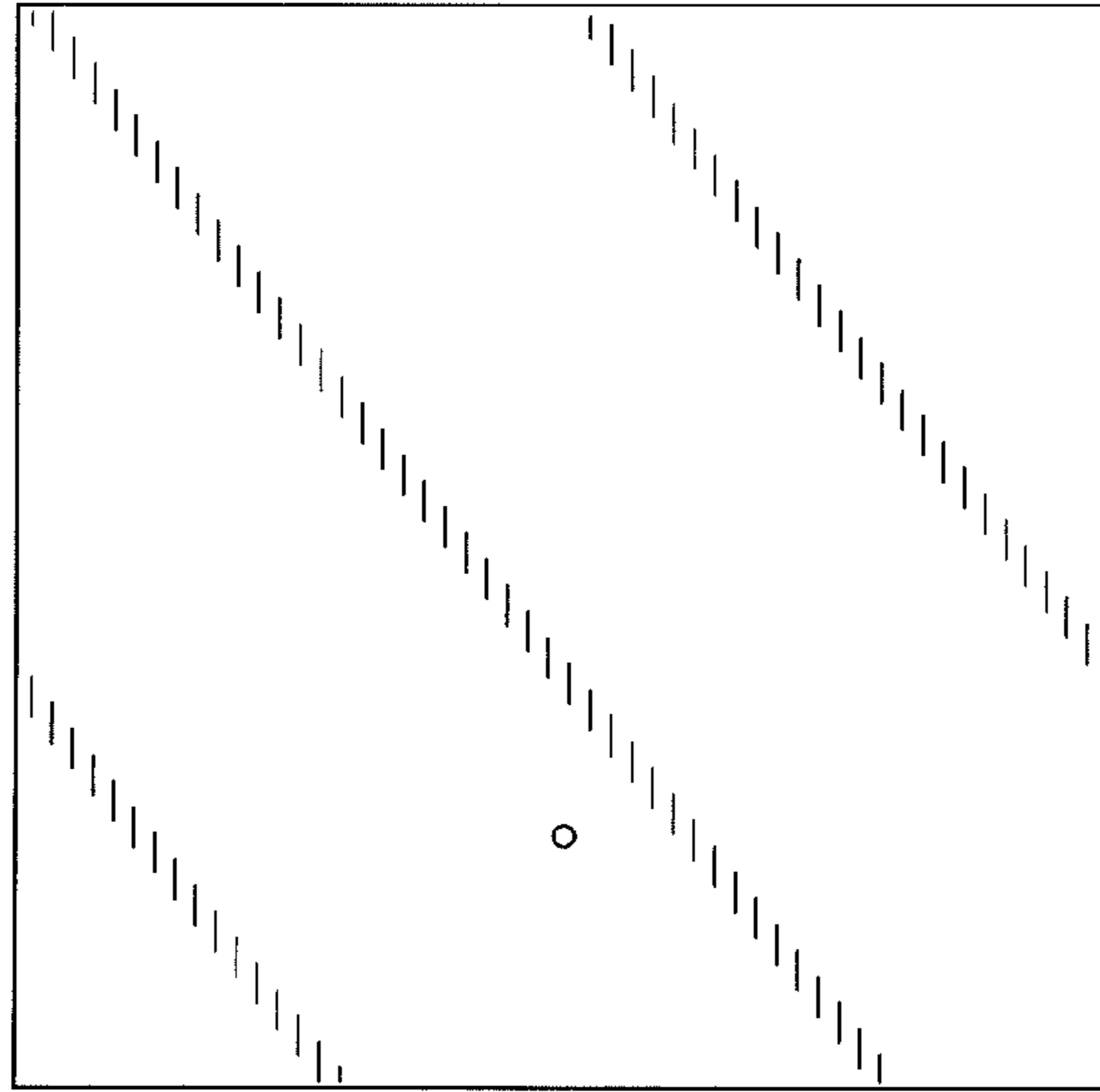

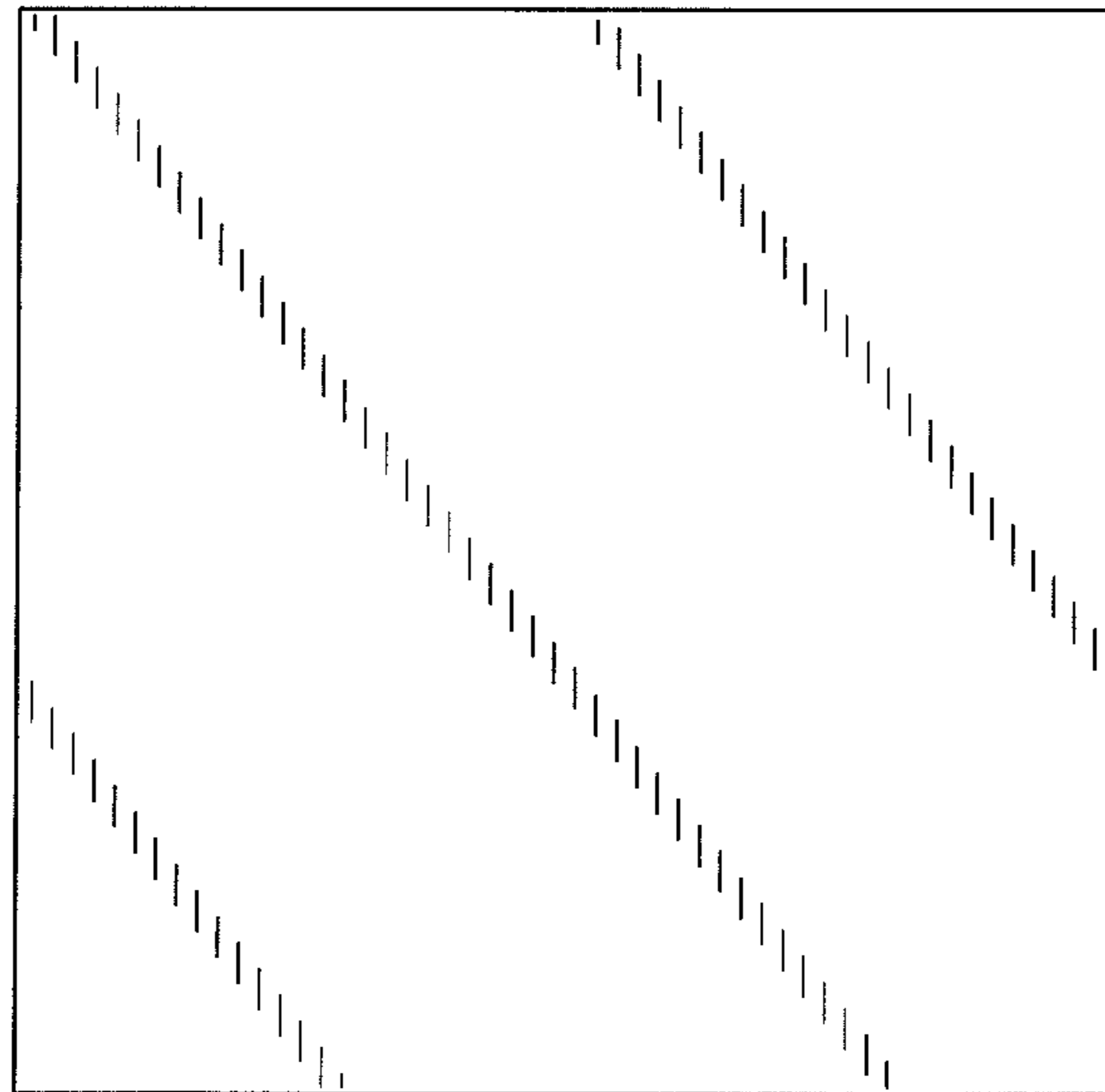

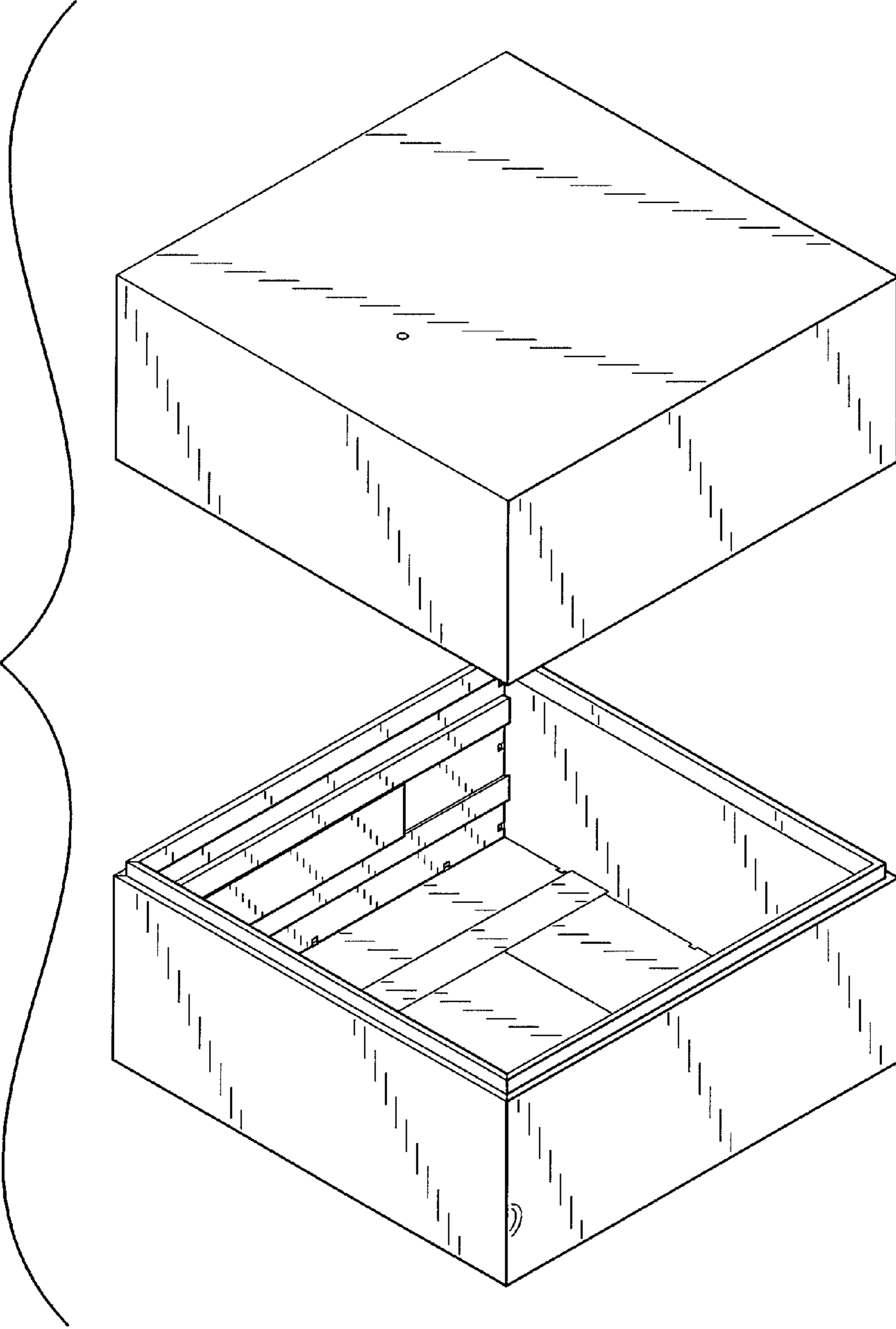

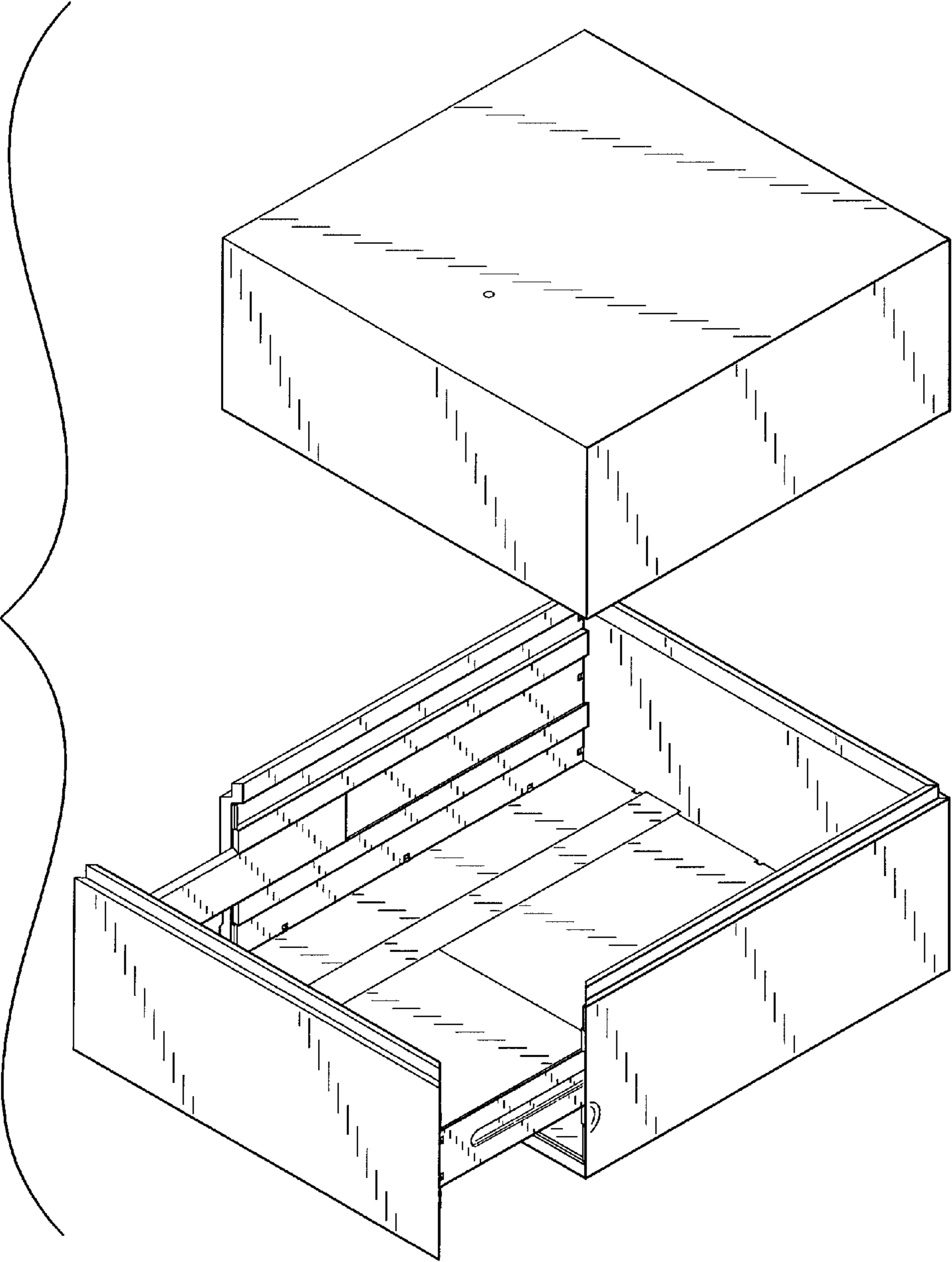
