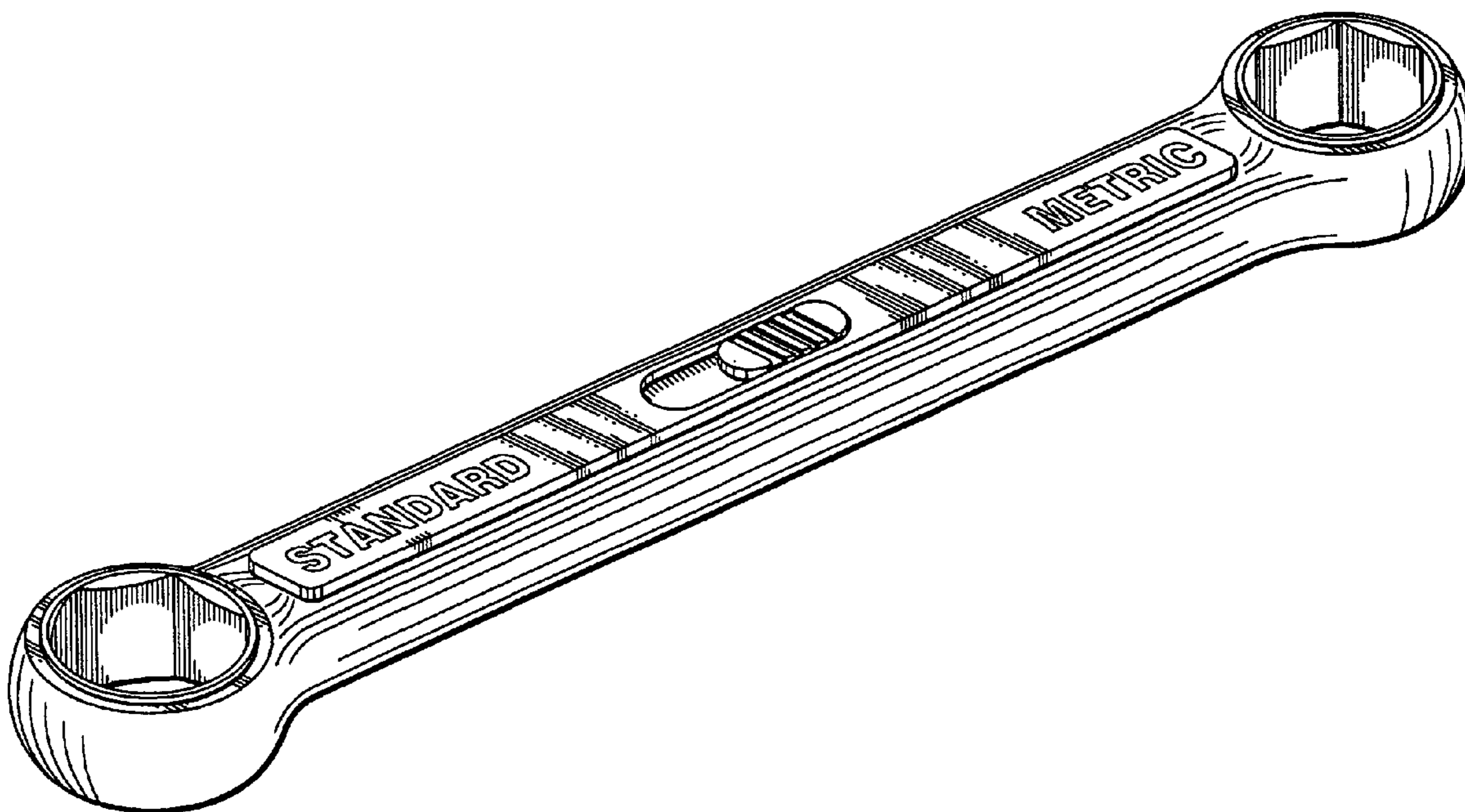
(57) **CLAIM**

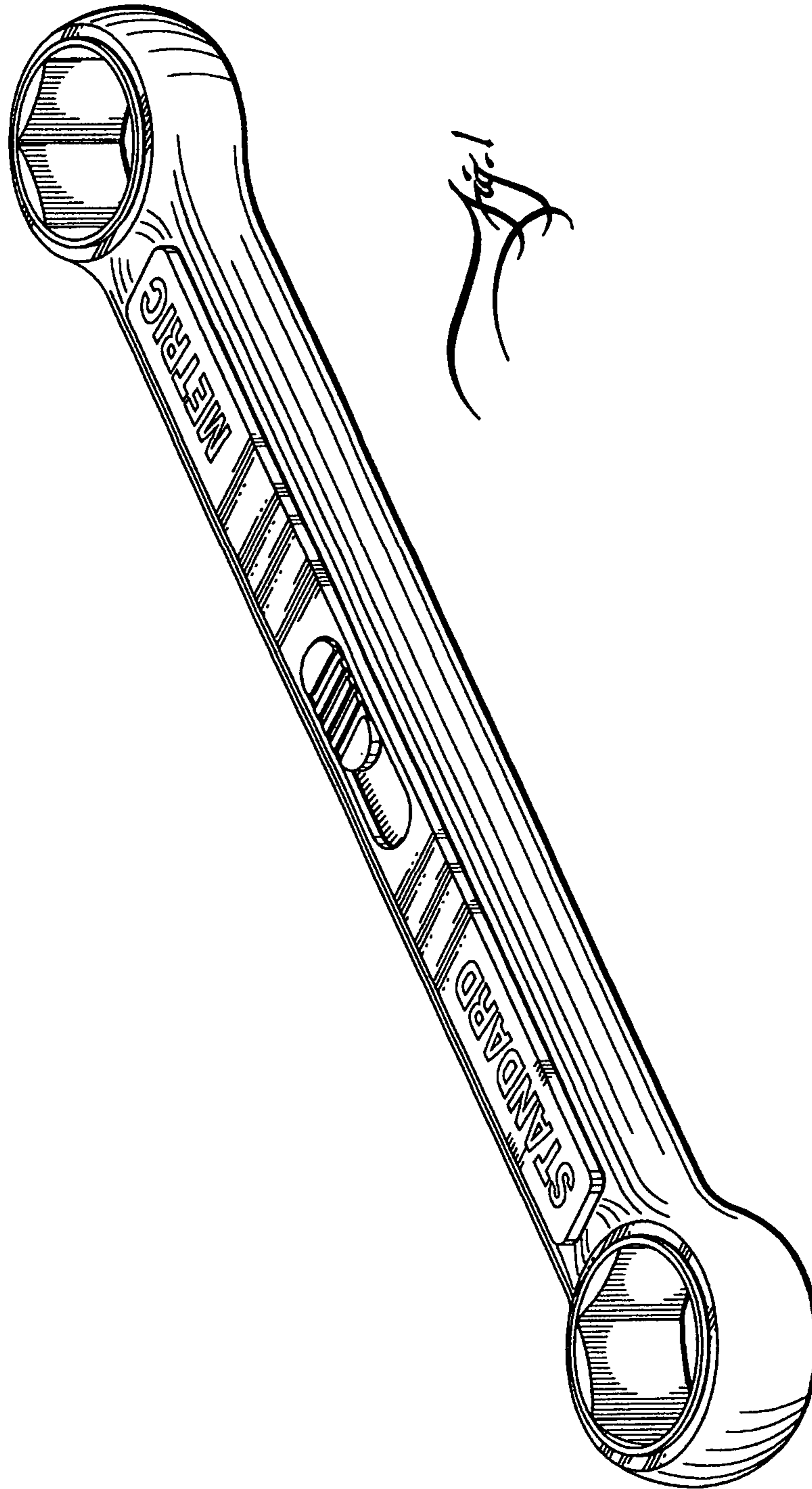
The ornamental design for a wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wrench of my new design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a bottom plan view thereof.
FIG. 4 is an elevational view of the front thereof. A elevational view of the back is a mirror image thereof.
FIG. 5 is an elevational view of the left end of the wrench shown in FIG. 1; and,
FIG. 6 is an elevational view of the right end of the wrench shown in FIG. 1.

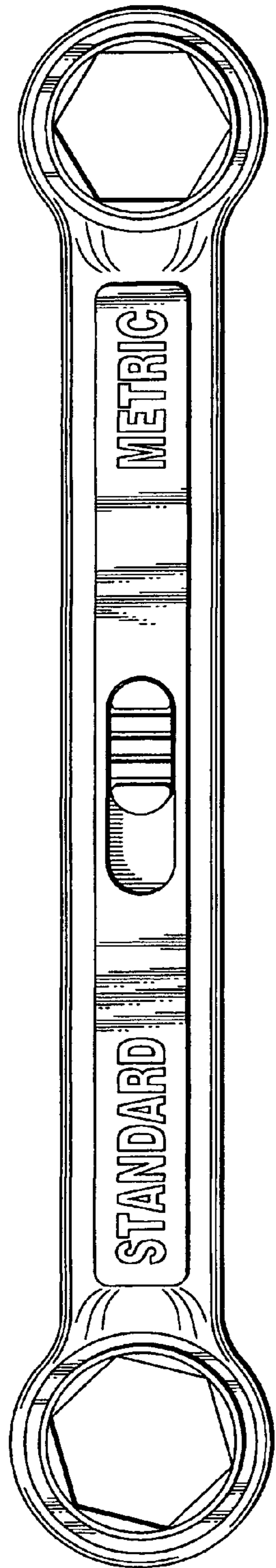

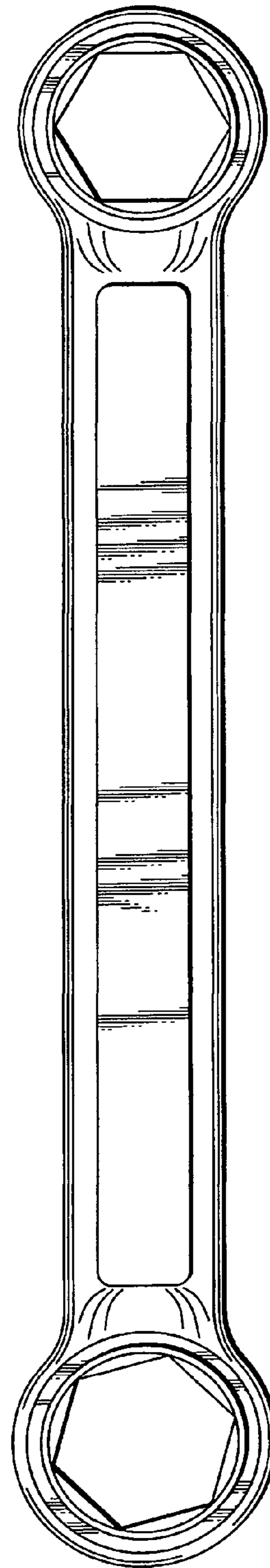

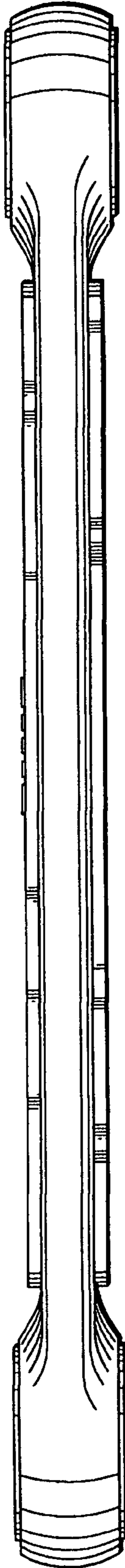

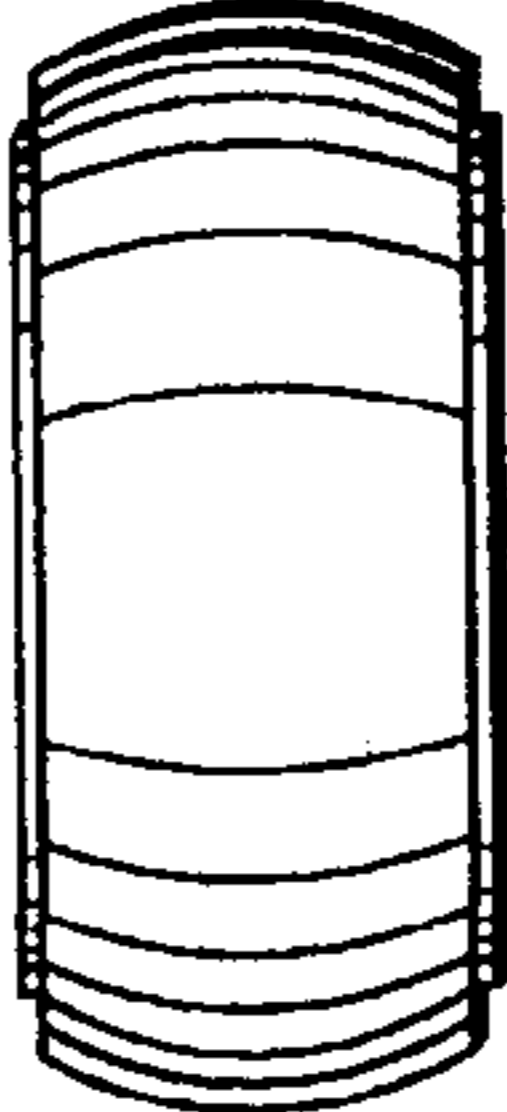

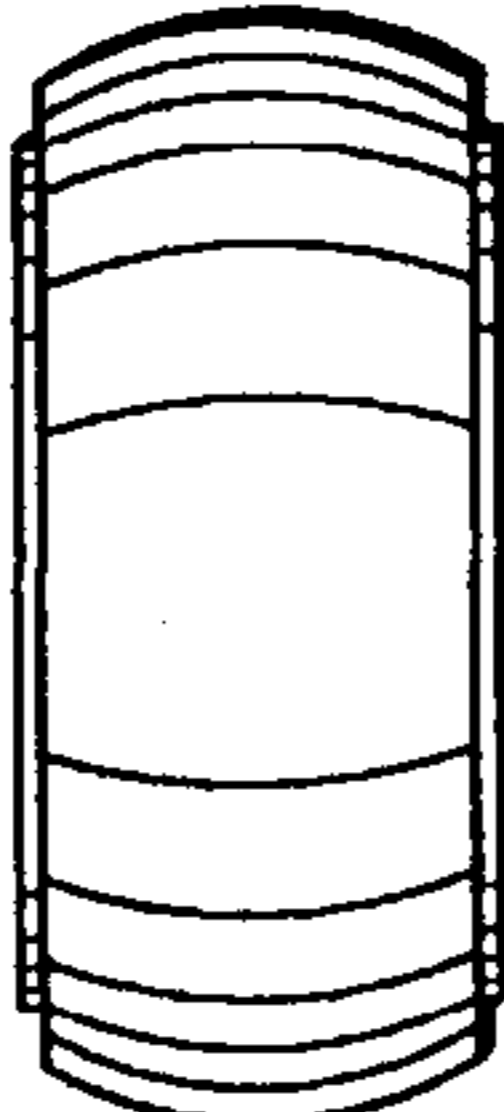
