FIG. 7 is a bottom plan view thereof;

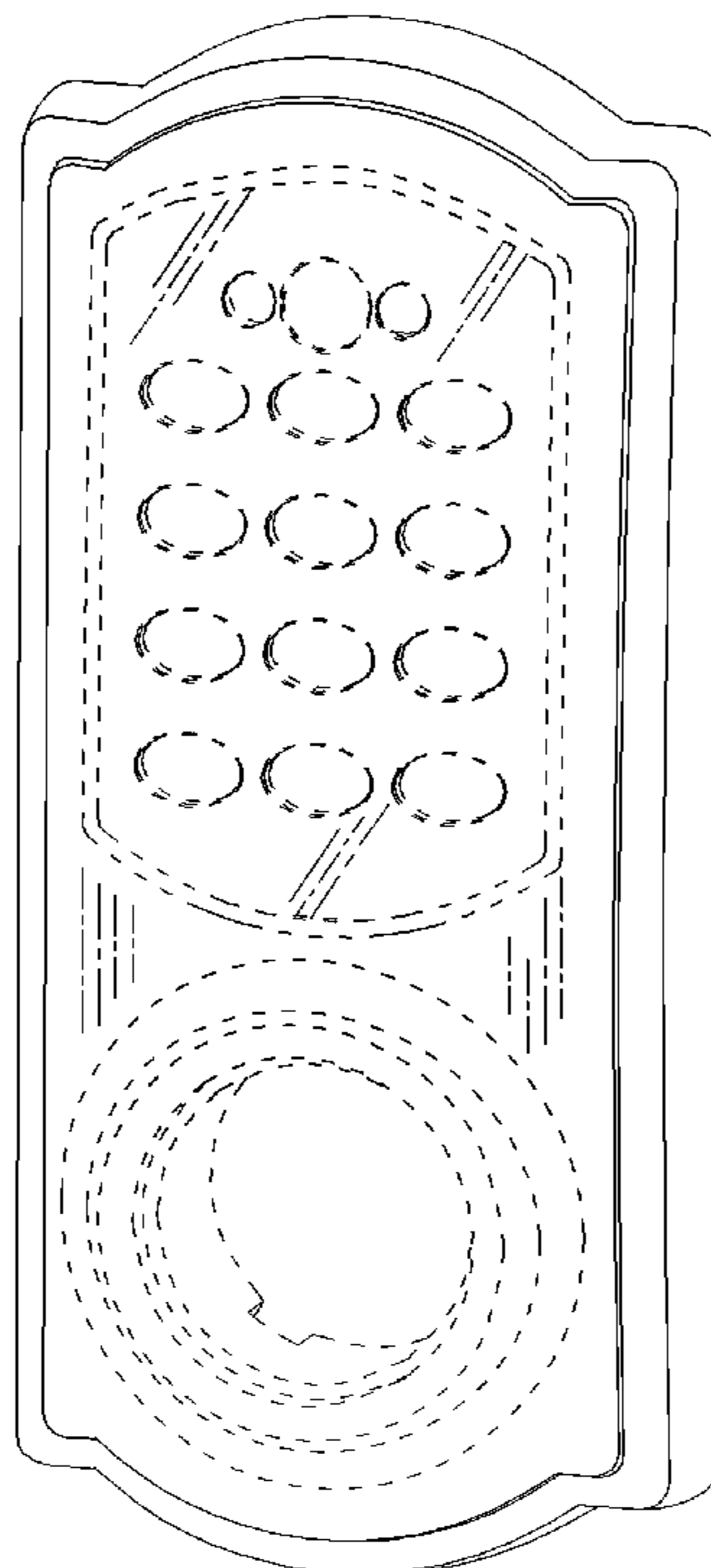
FIG. 8 is a perspective view thereof, shown in environmental use;

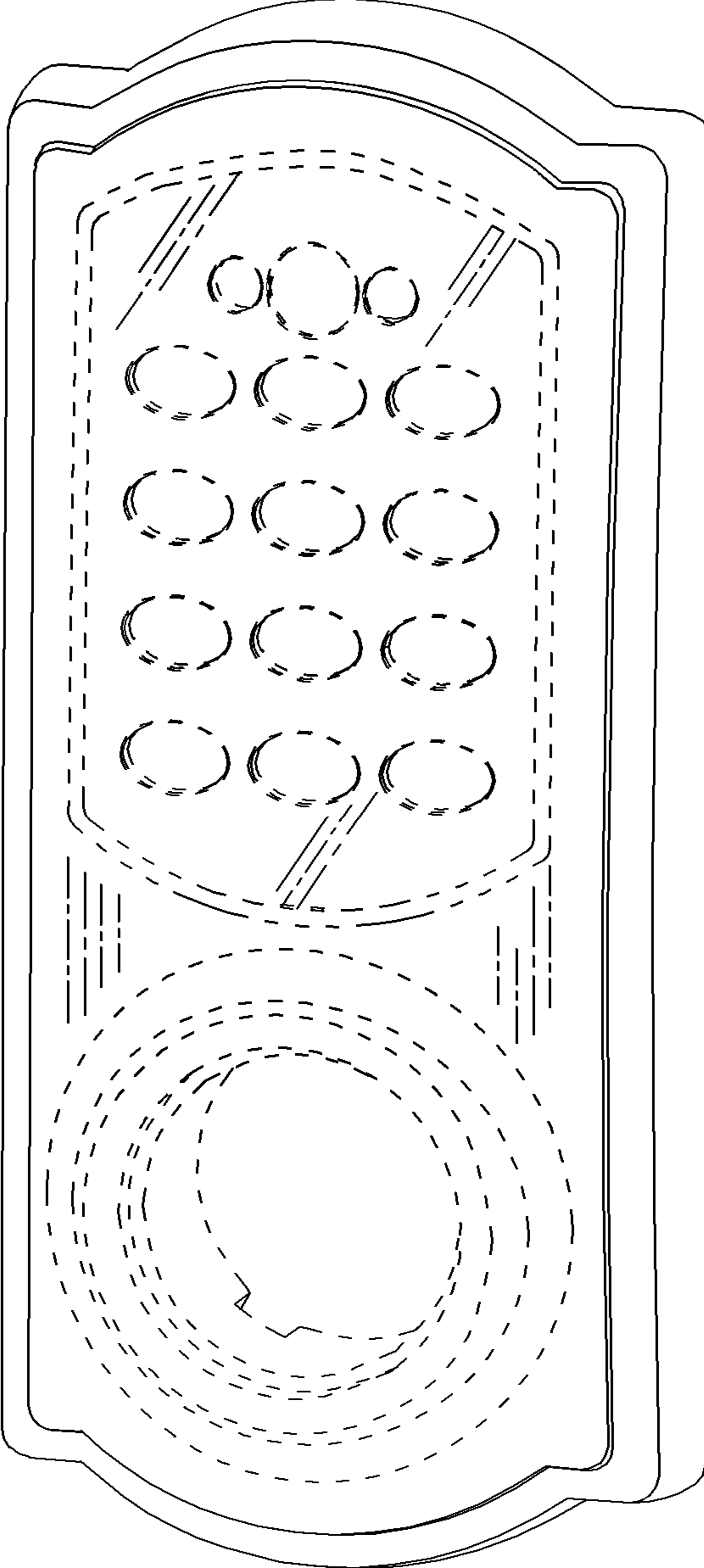

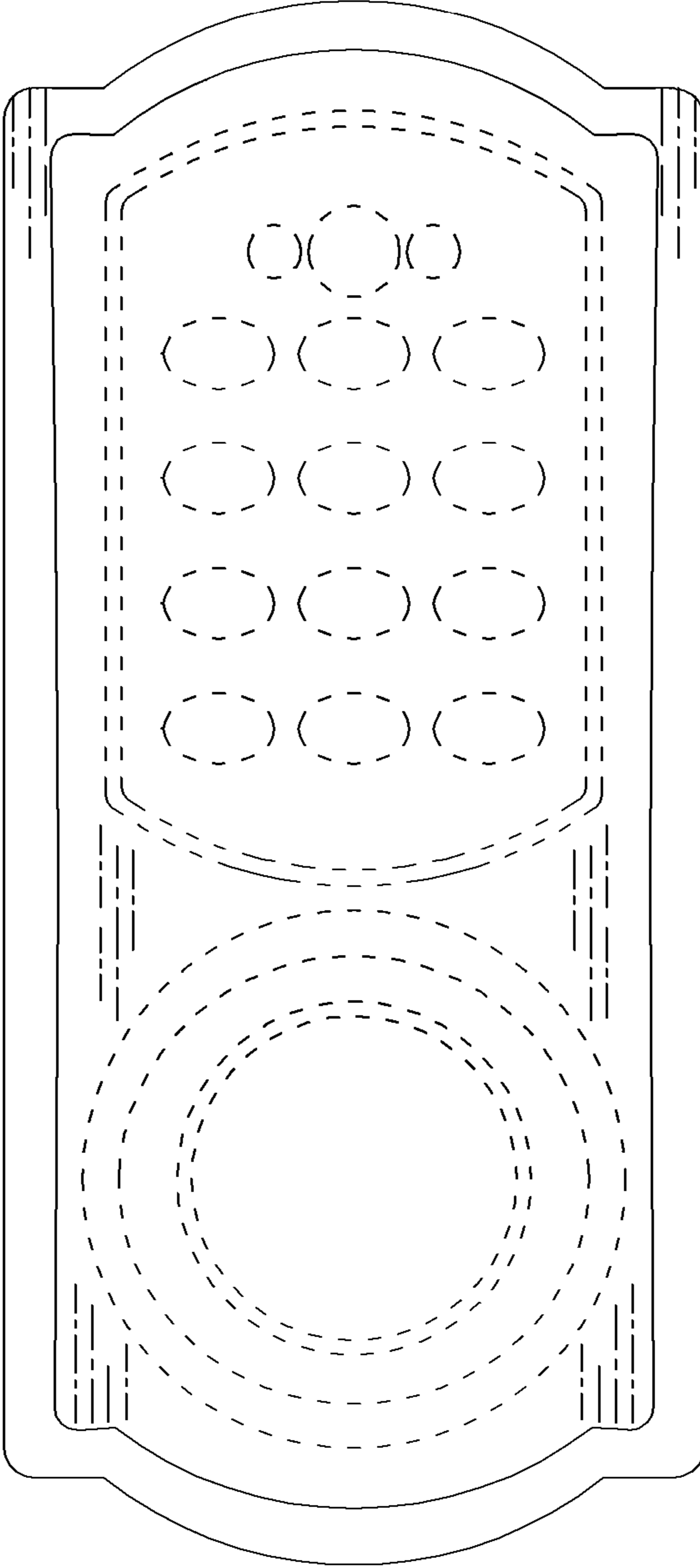

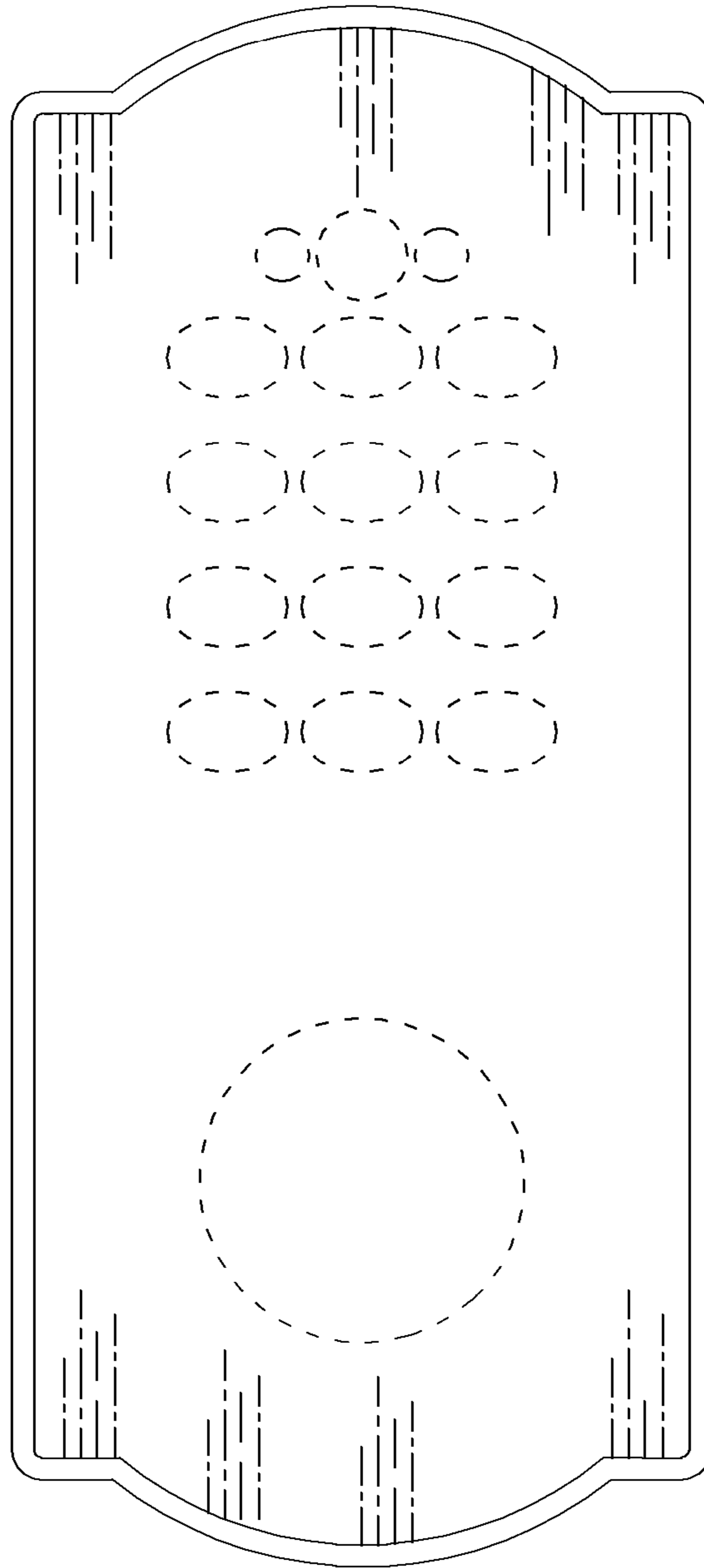

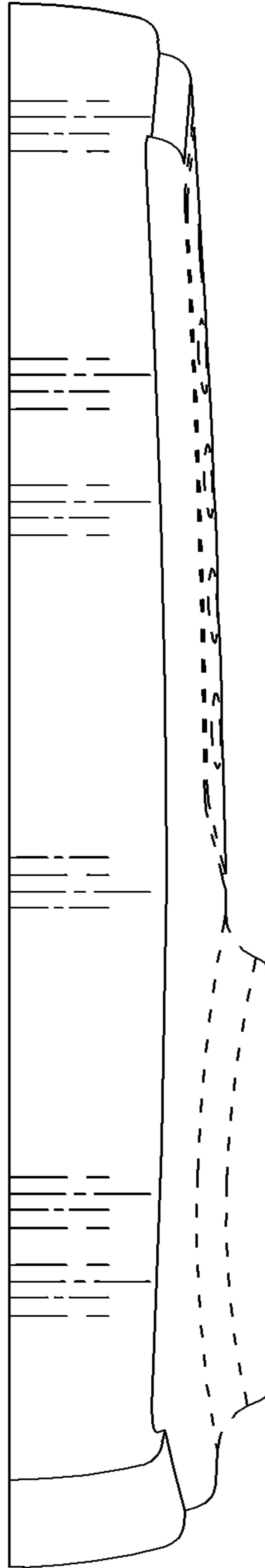

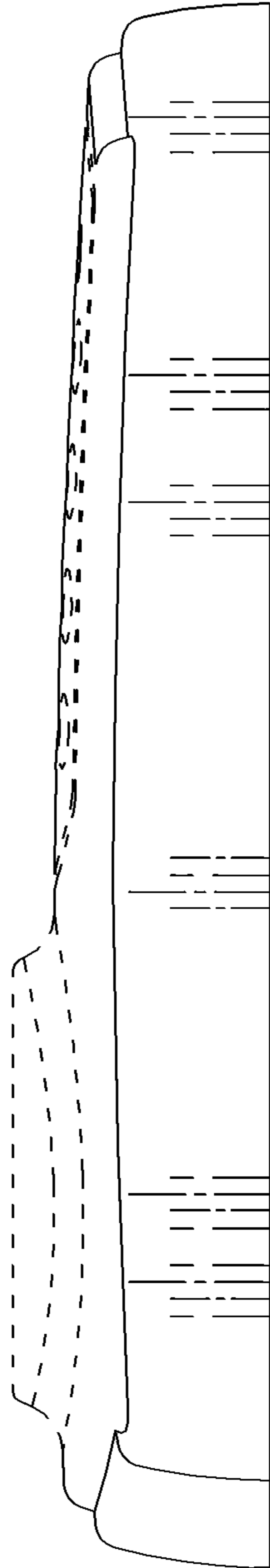

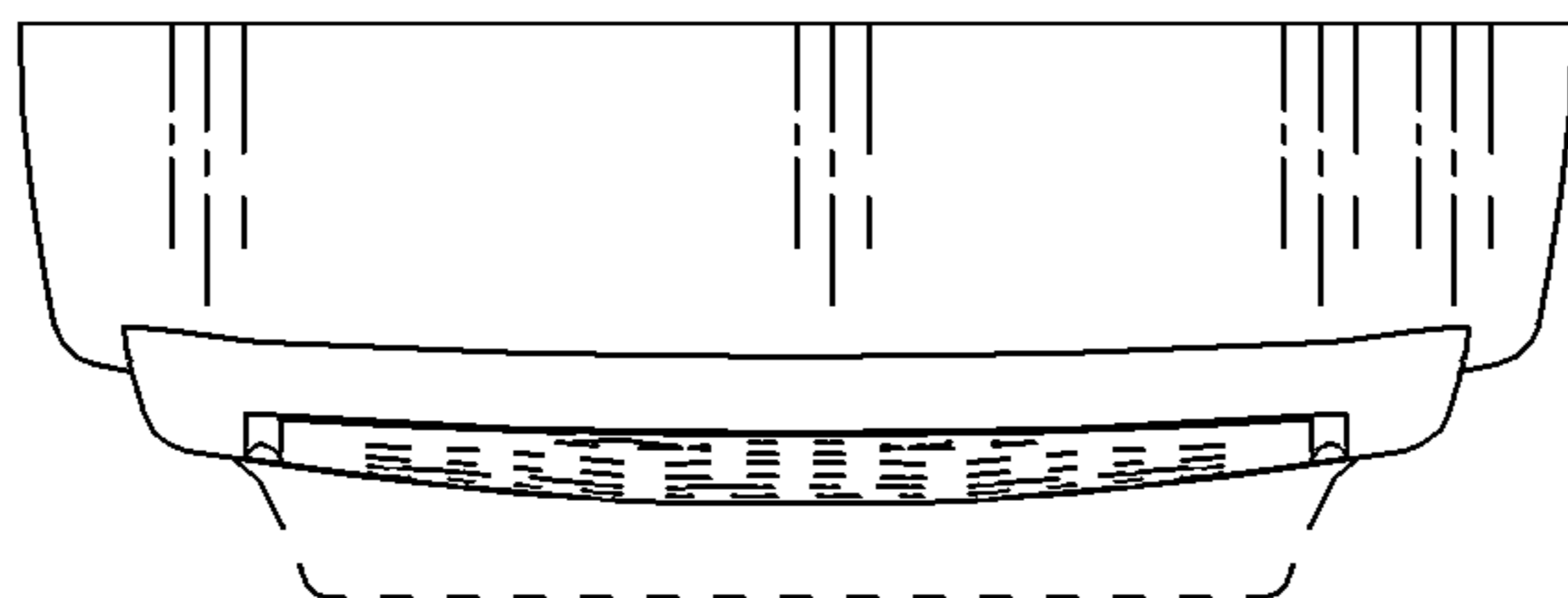

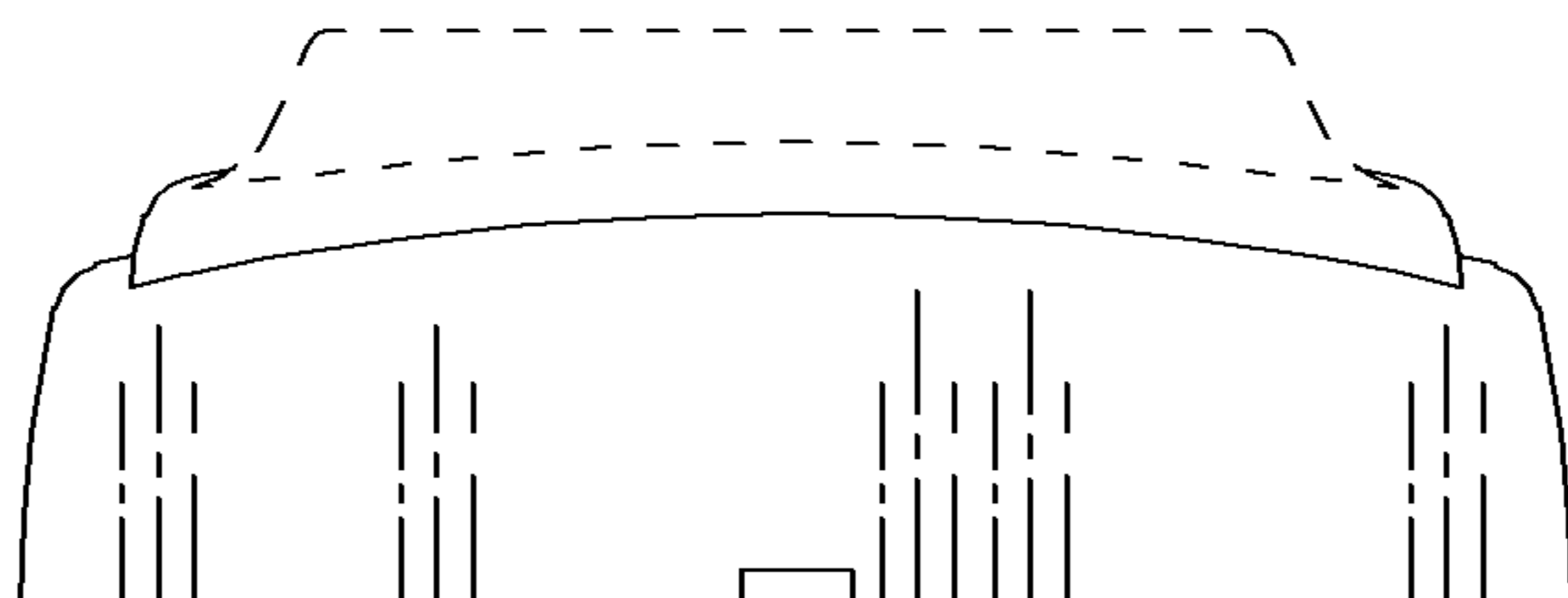

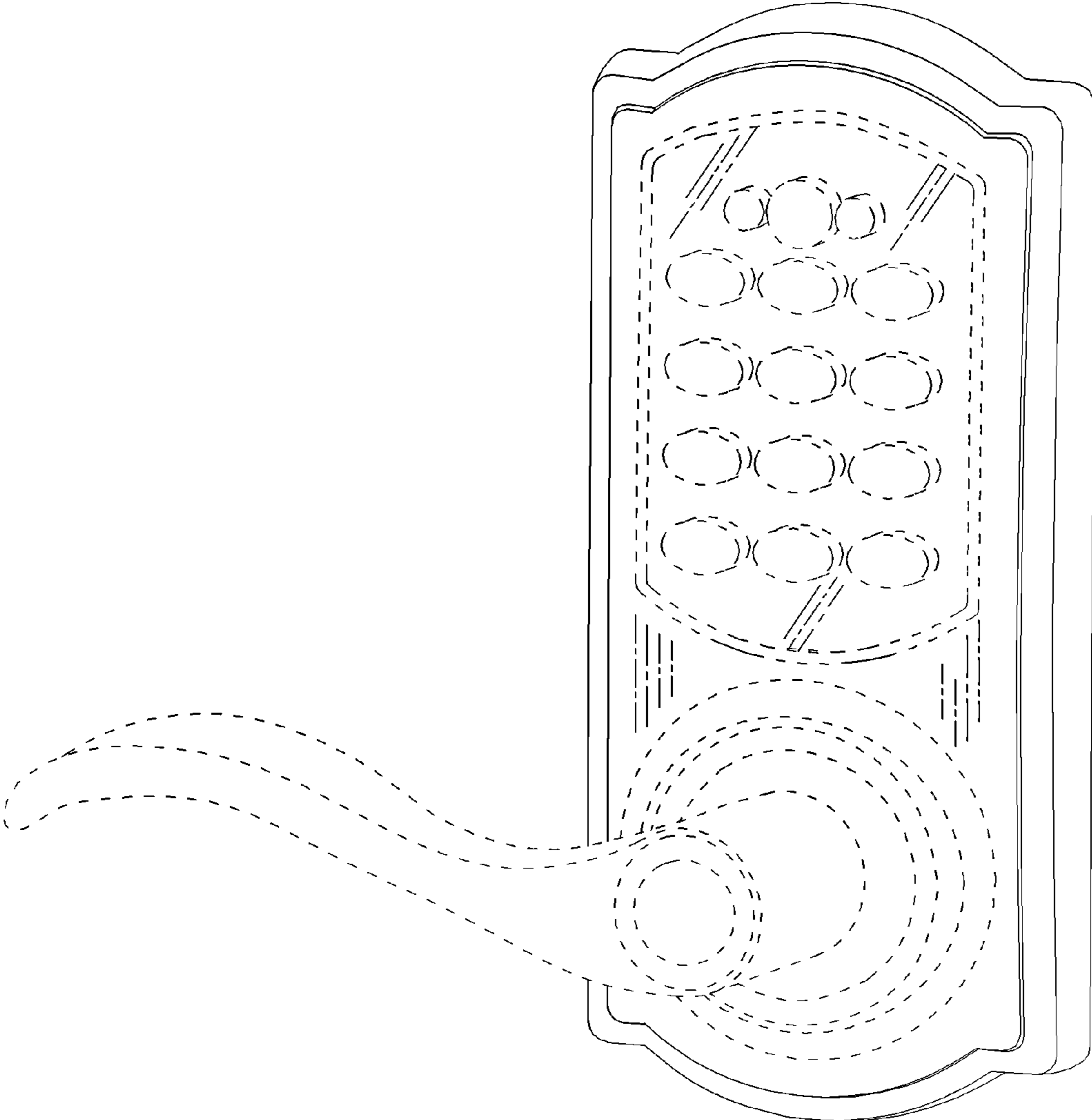

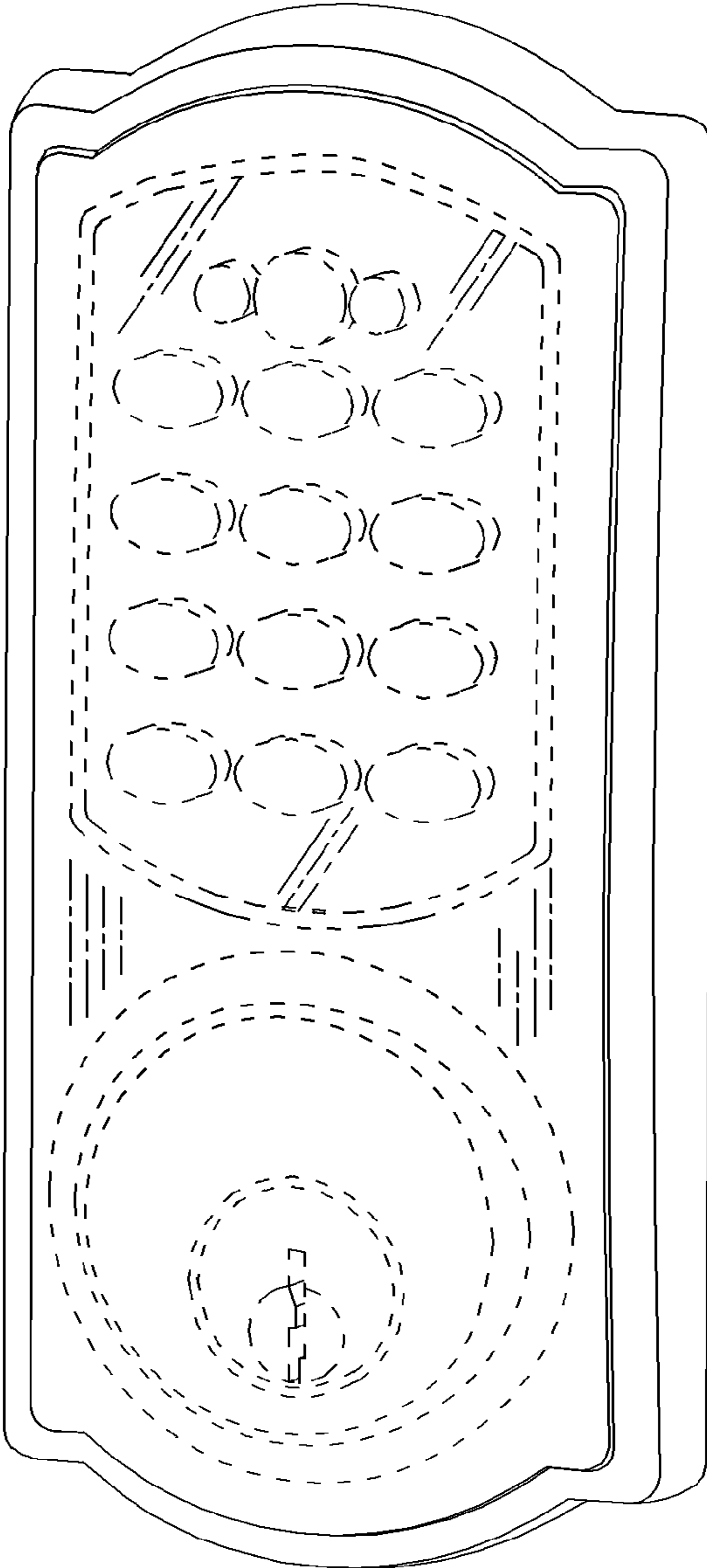

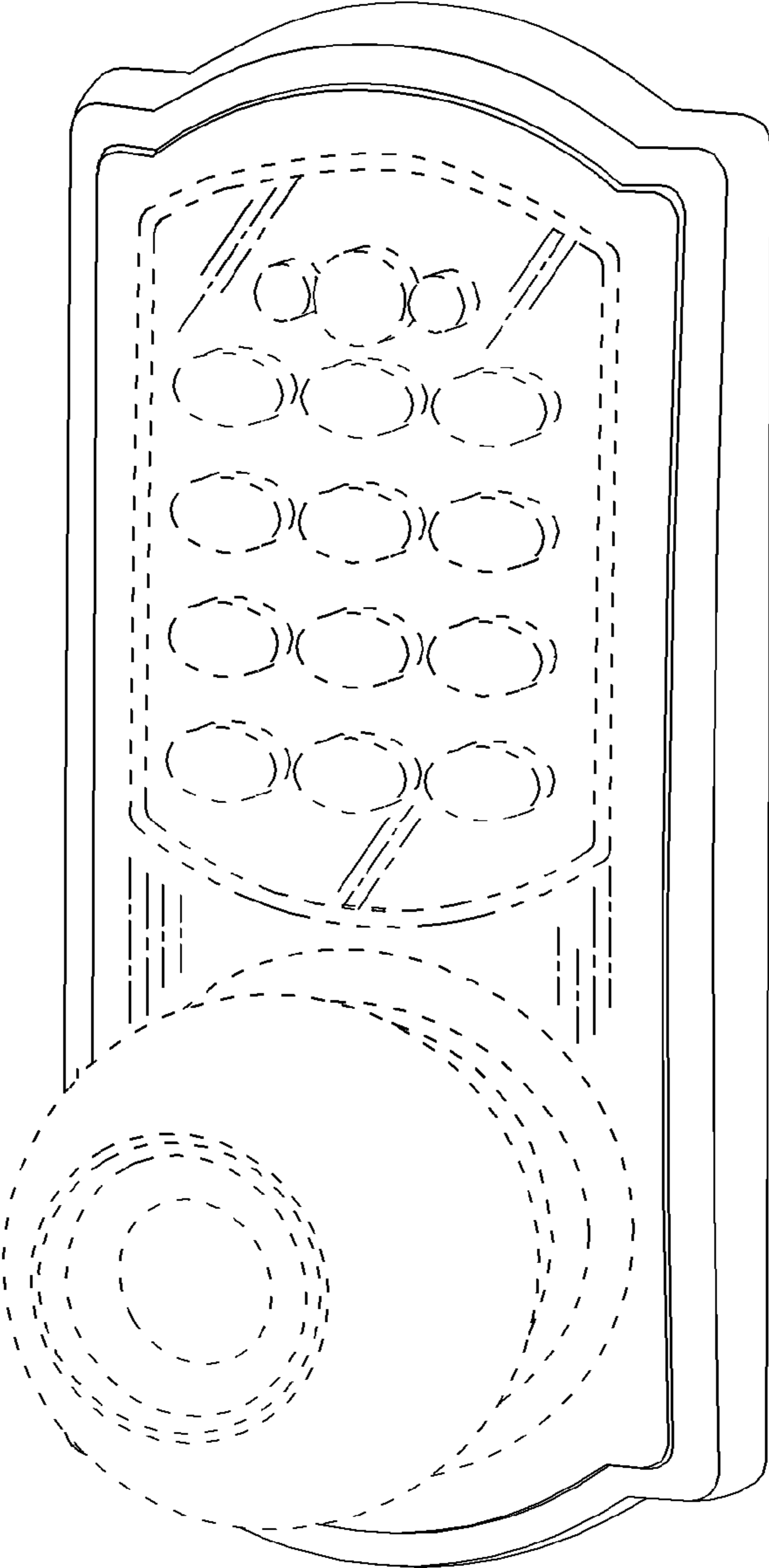
