The ornamental design for package with window, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the package with window. A material such as plastic that may provide a transparent or translucent appearance may be positioned in the window as shown in FIG. 1.

FIG. 2 is a left side view of the package with window of FIG. 1.

FIG. 3 is a right side view of the package with window of FIG. 1.

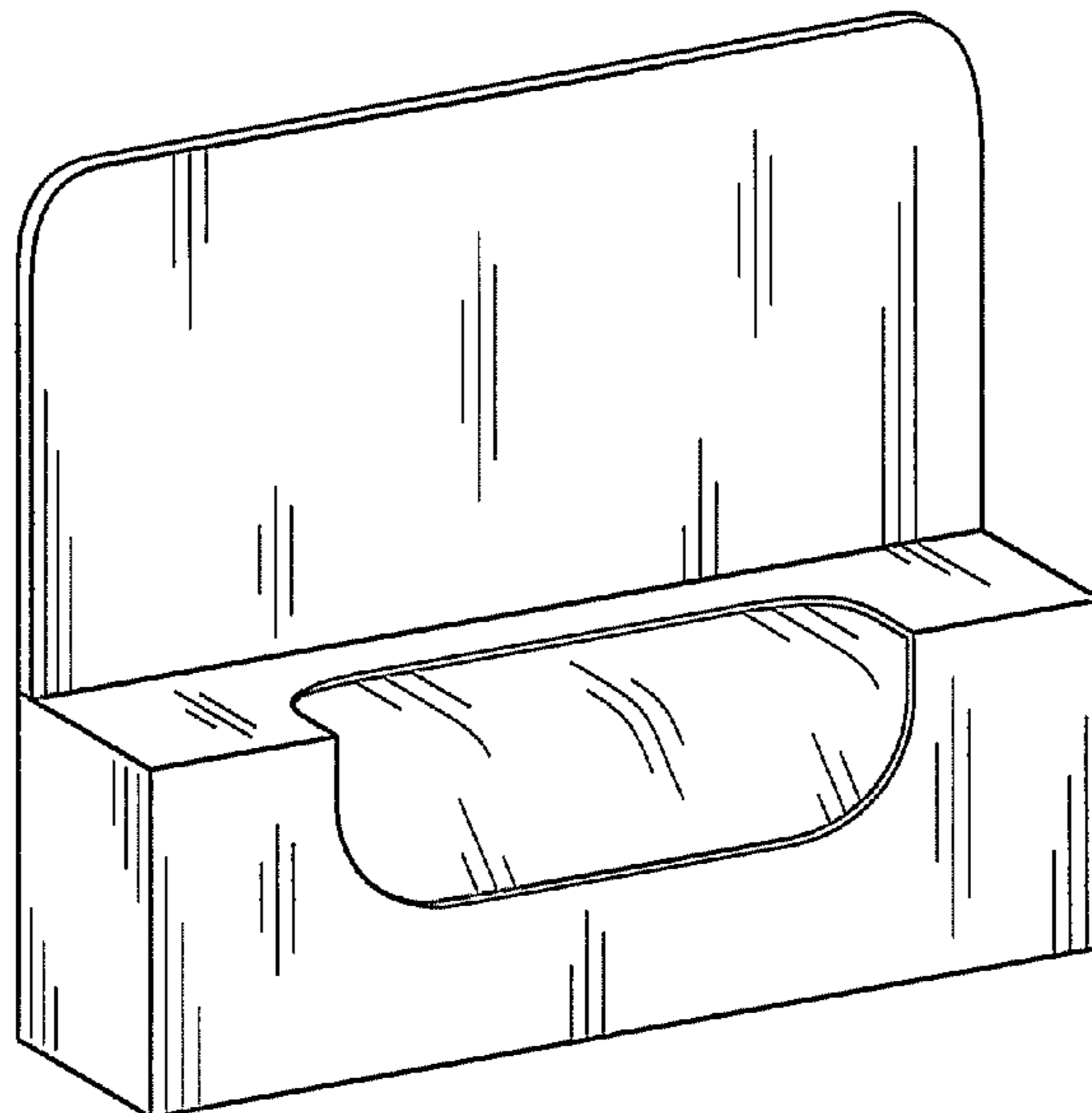
FIG. 4 is a front view of the package with window of FIG. 1.

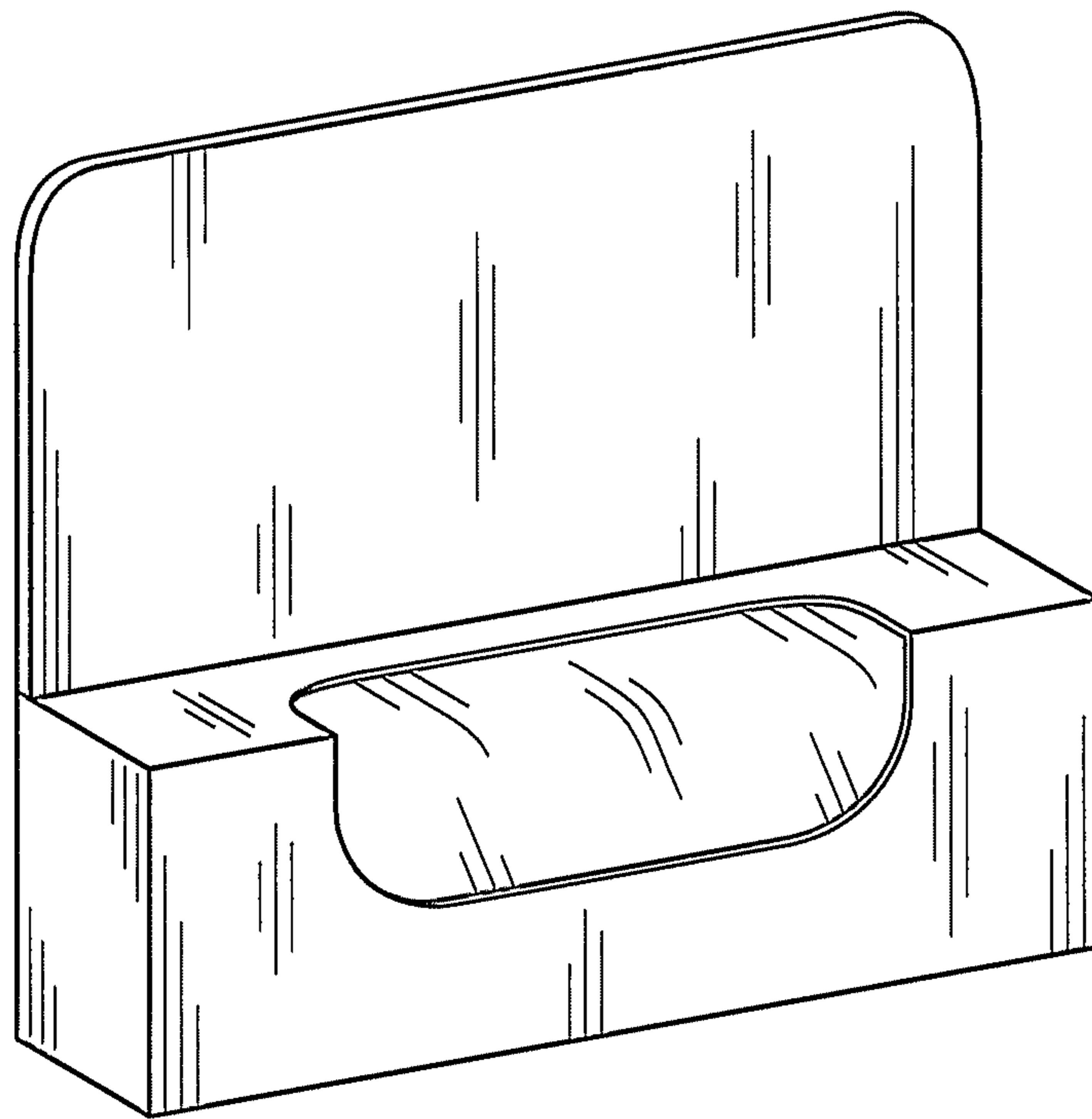

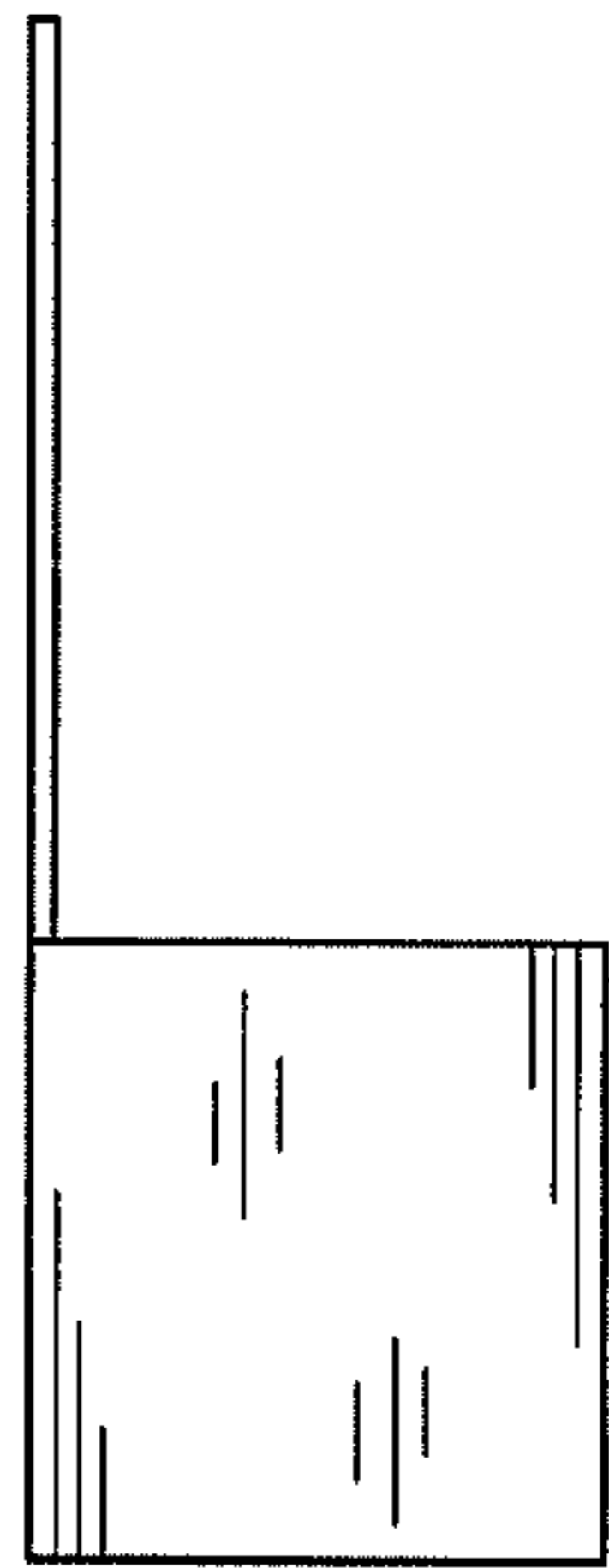

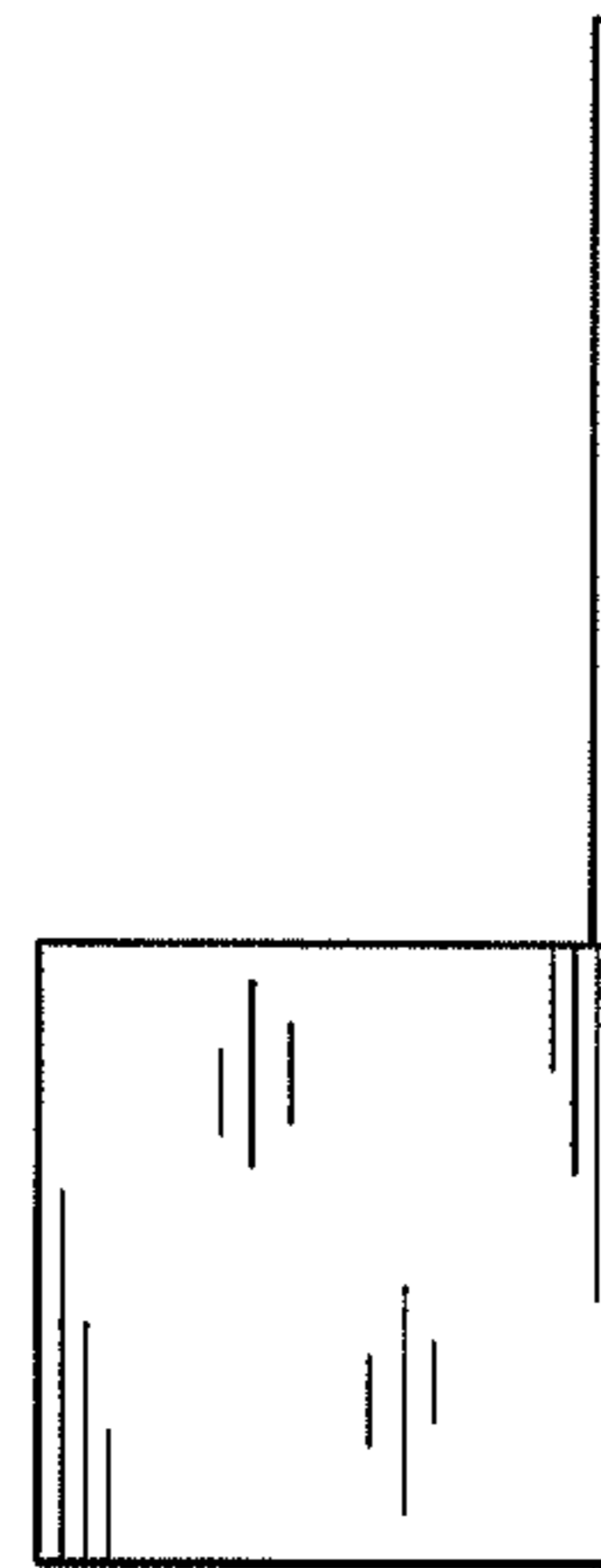

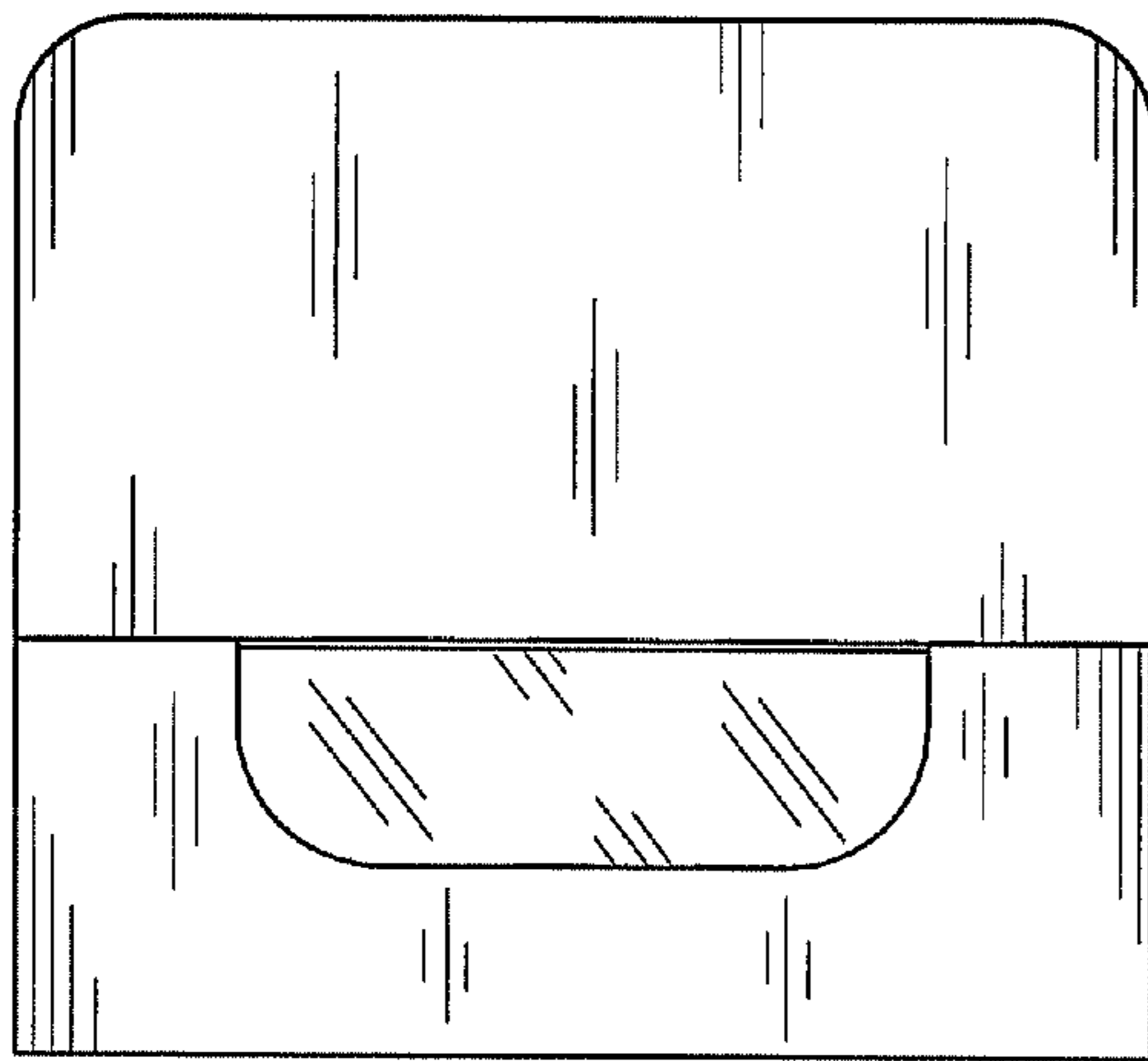

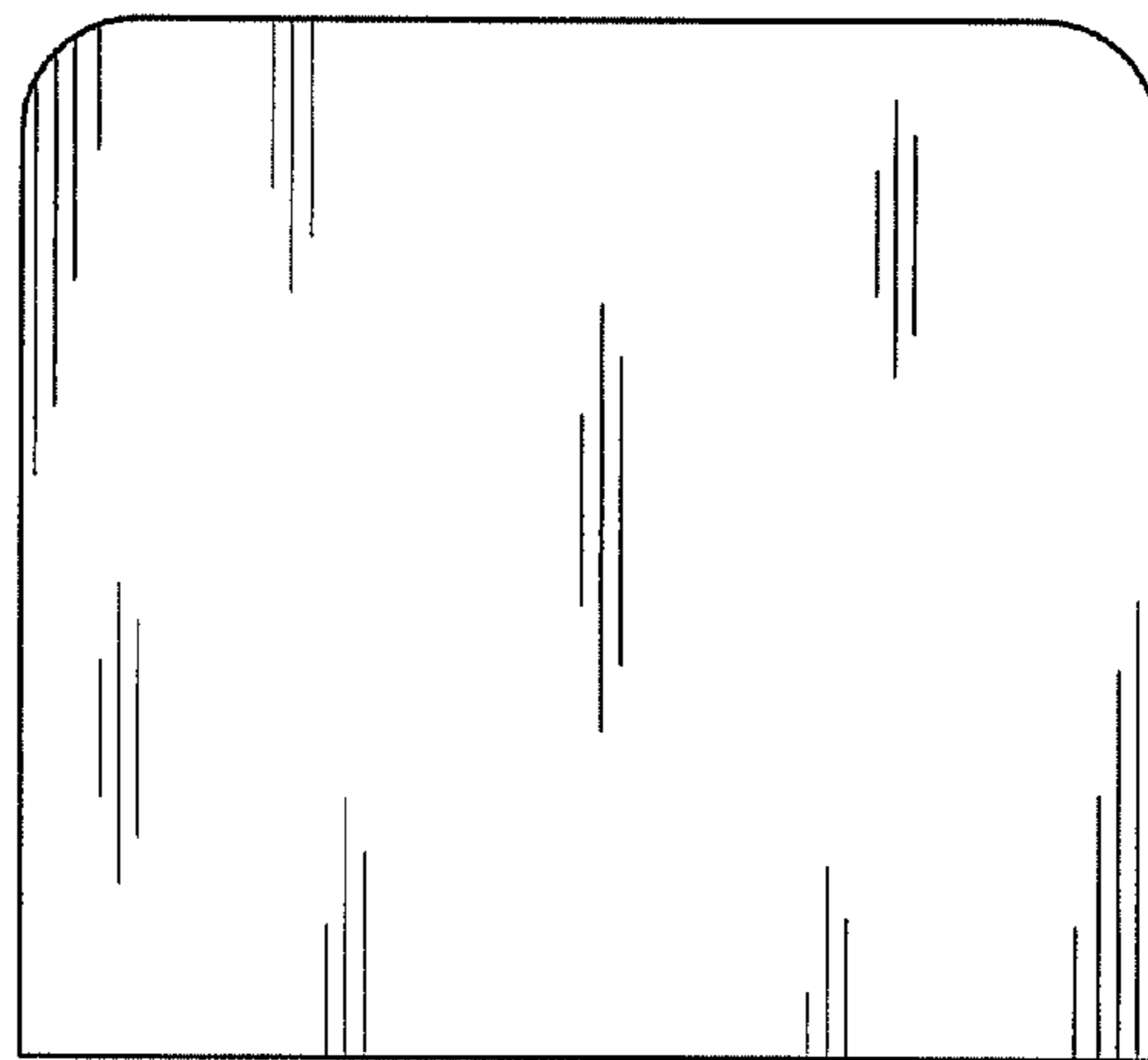

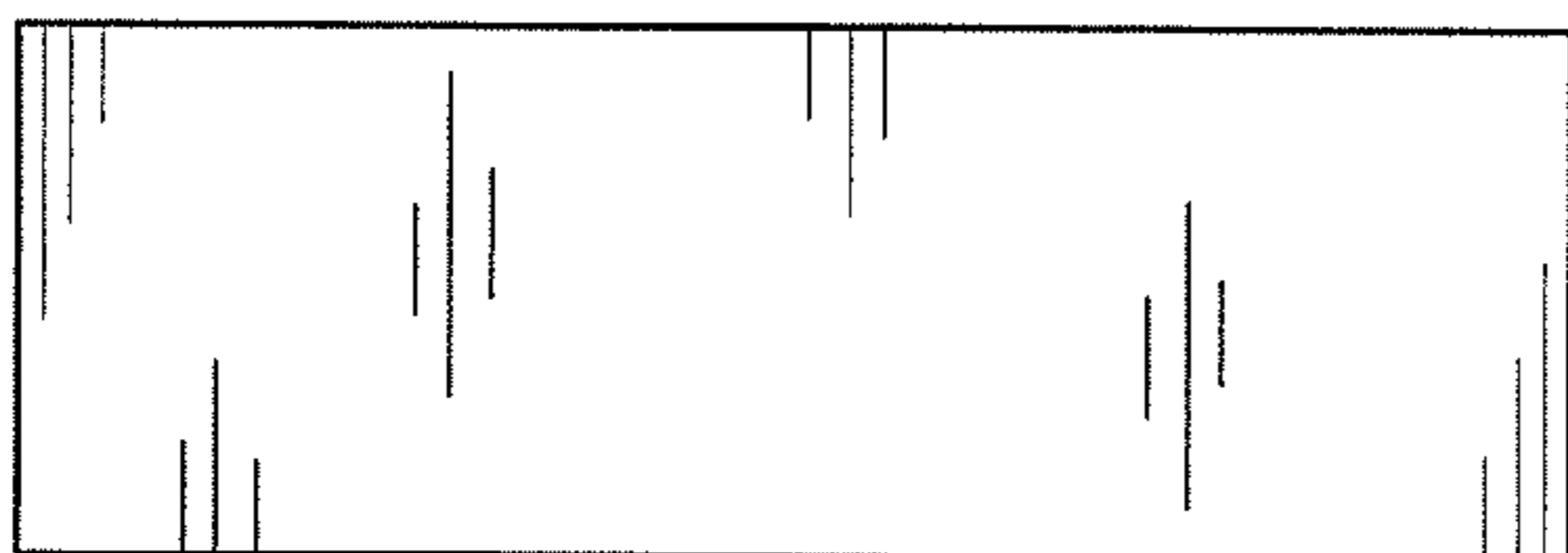

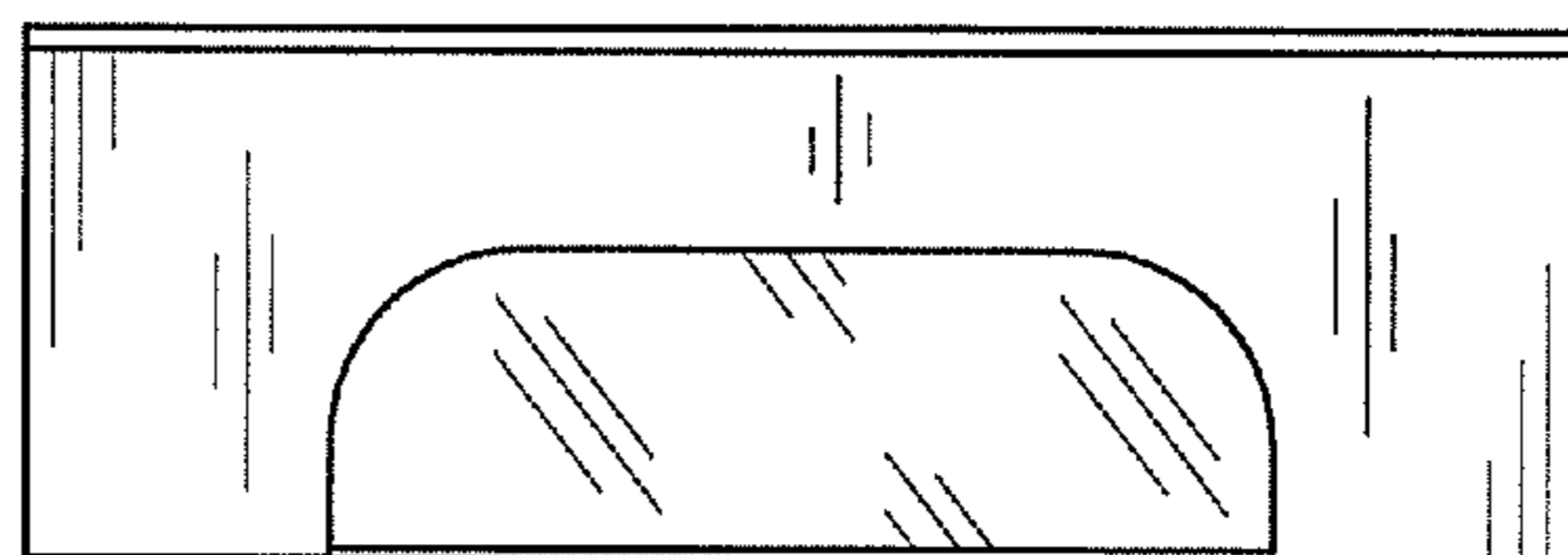
