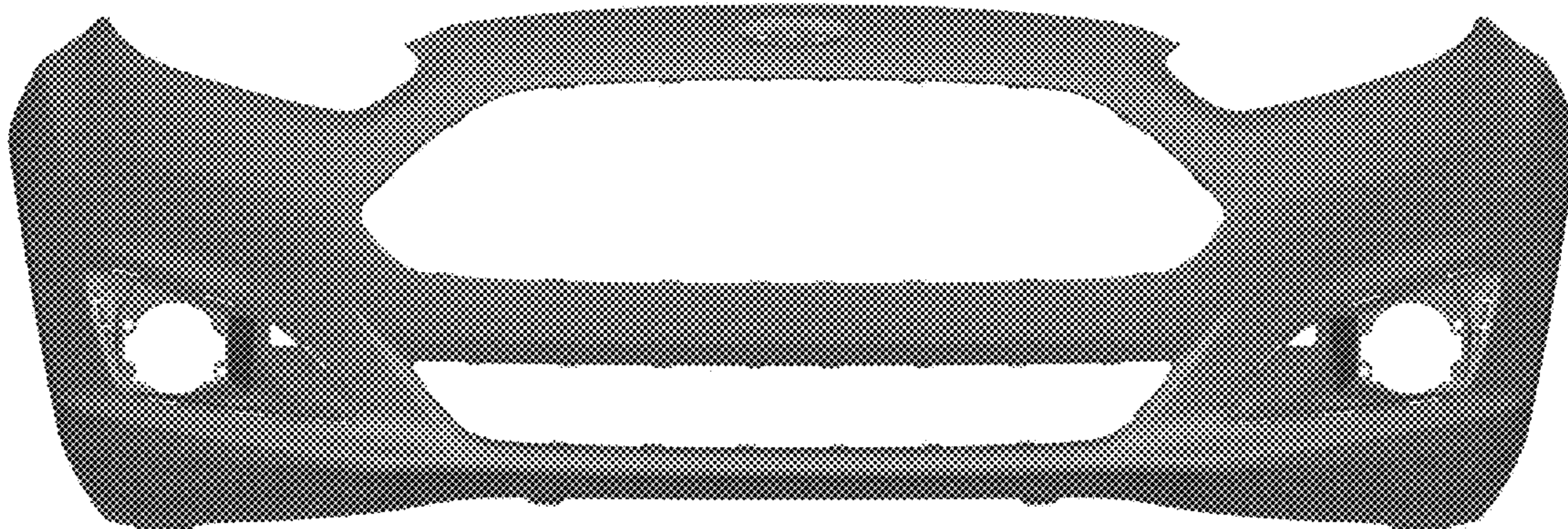
(57) **CLAIM**

The ornamental design for a vehicle front bumper cover, shown and described.

DESCRIPTION

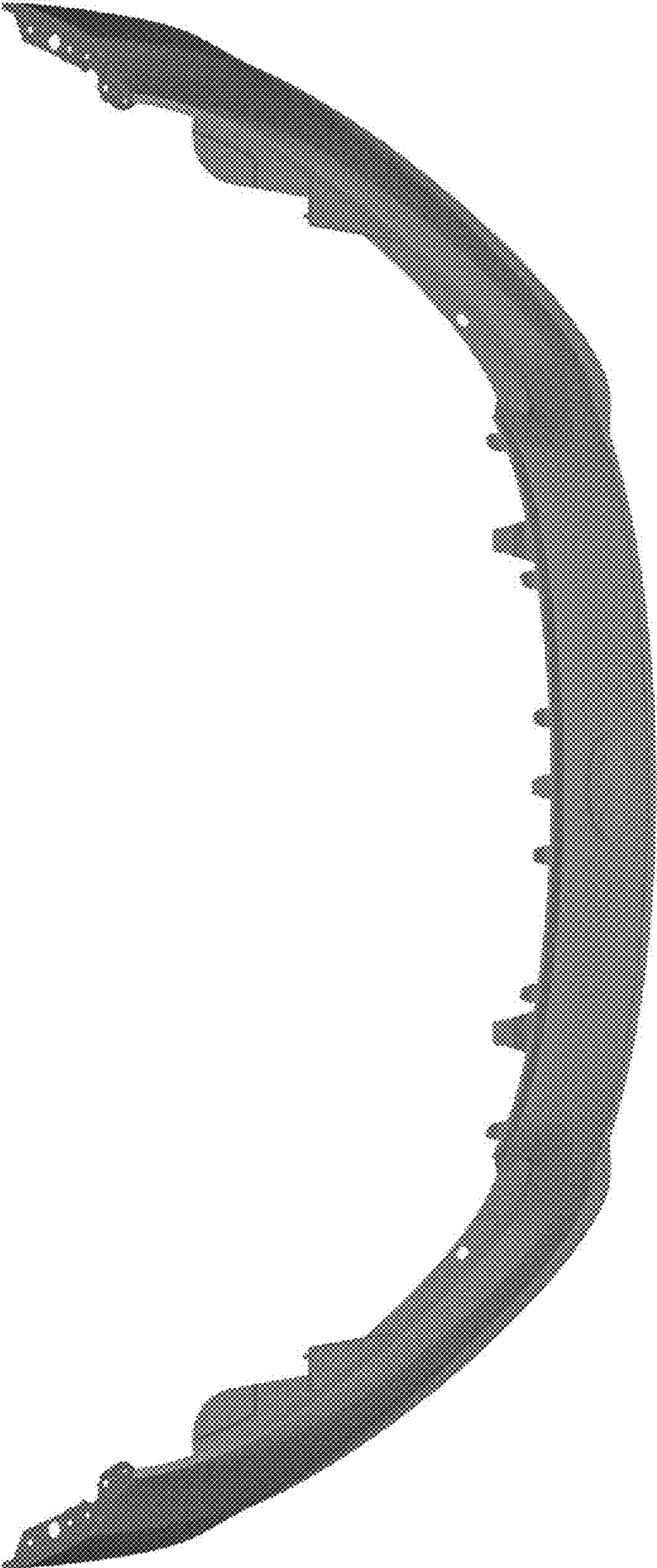
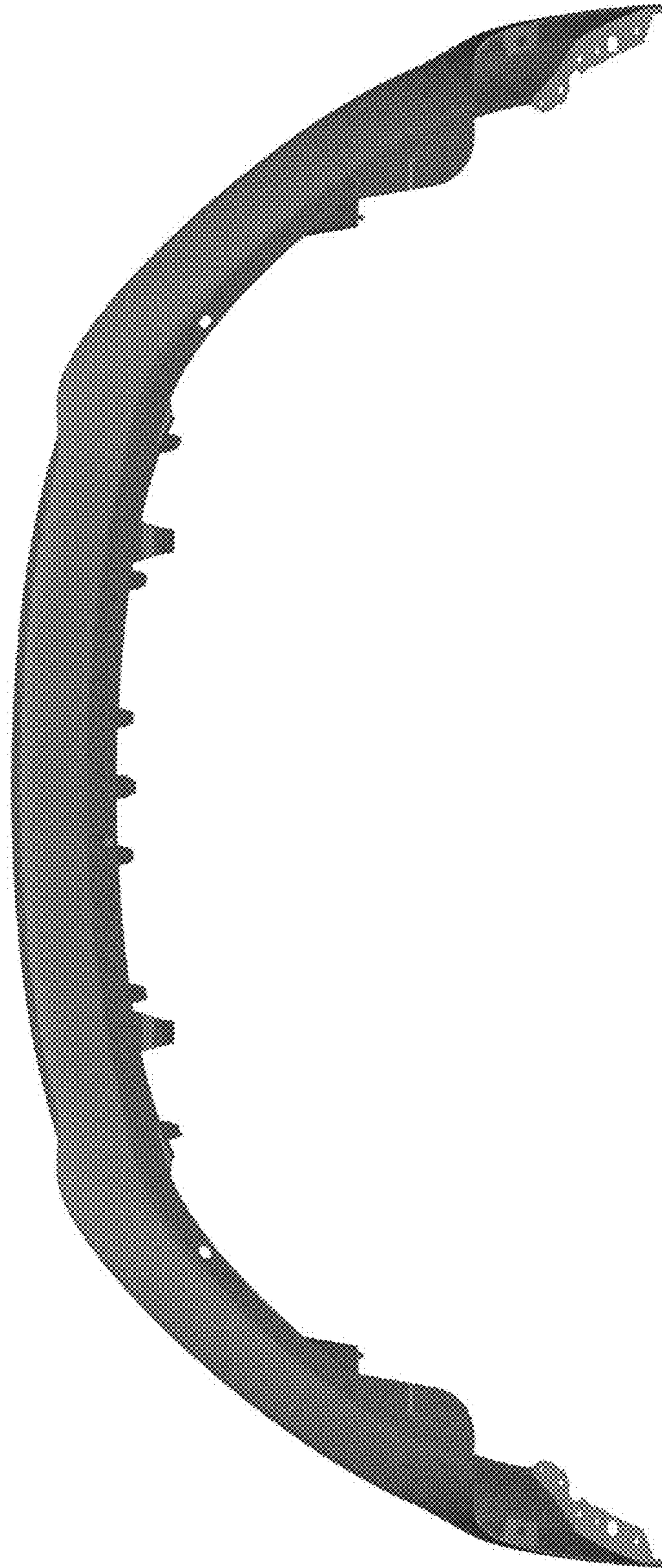

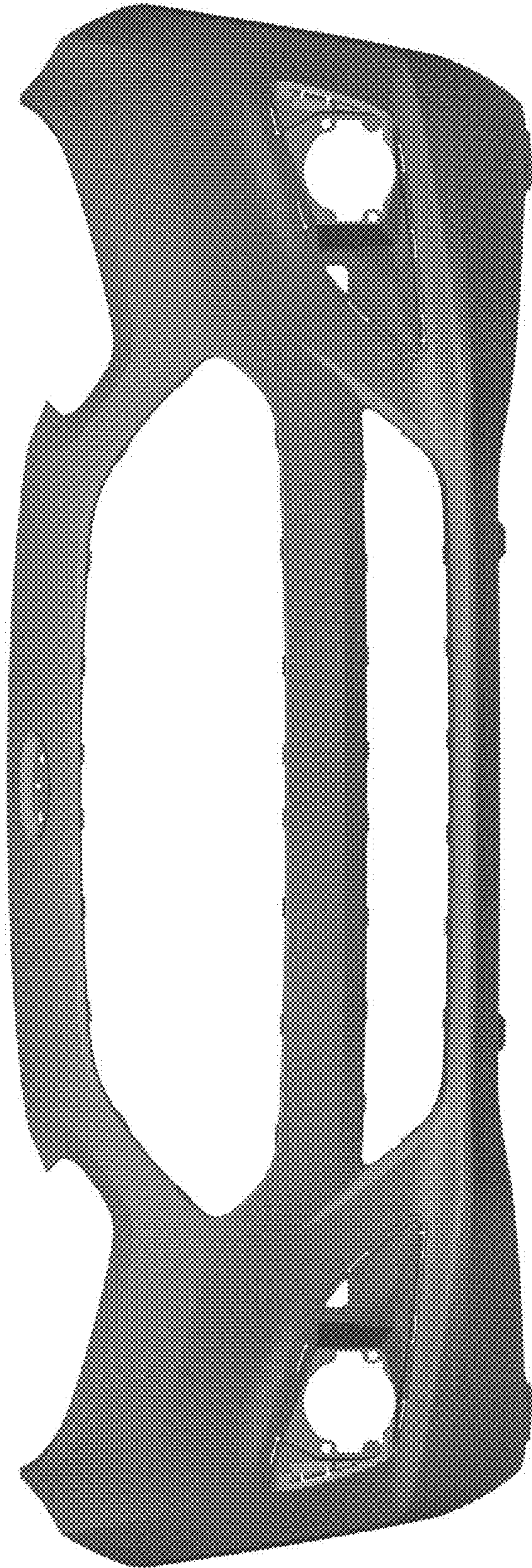

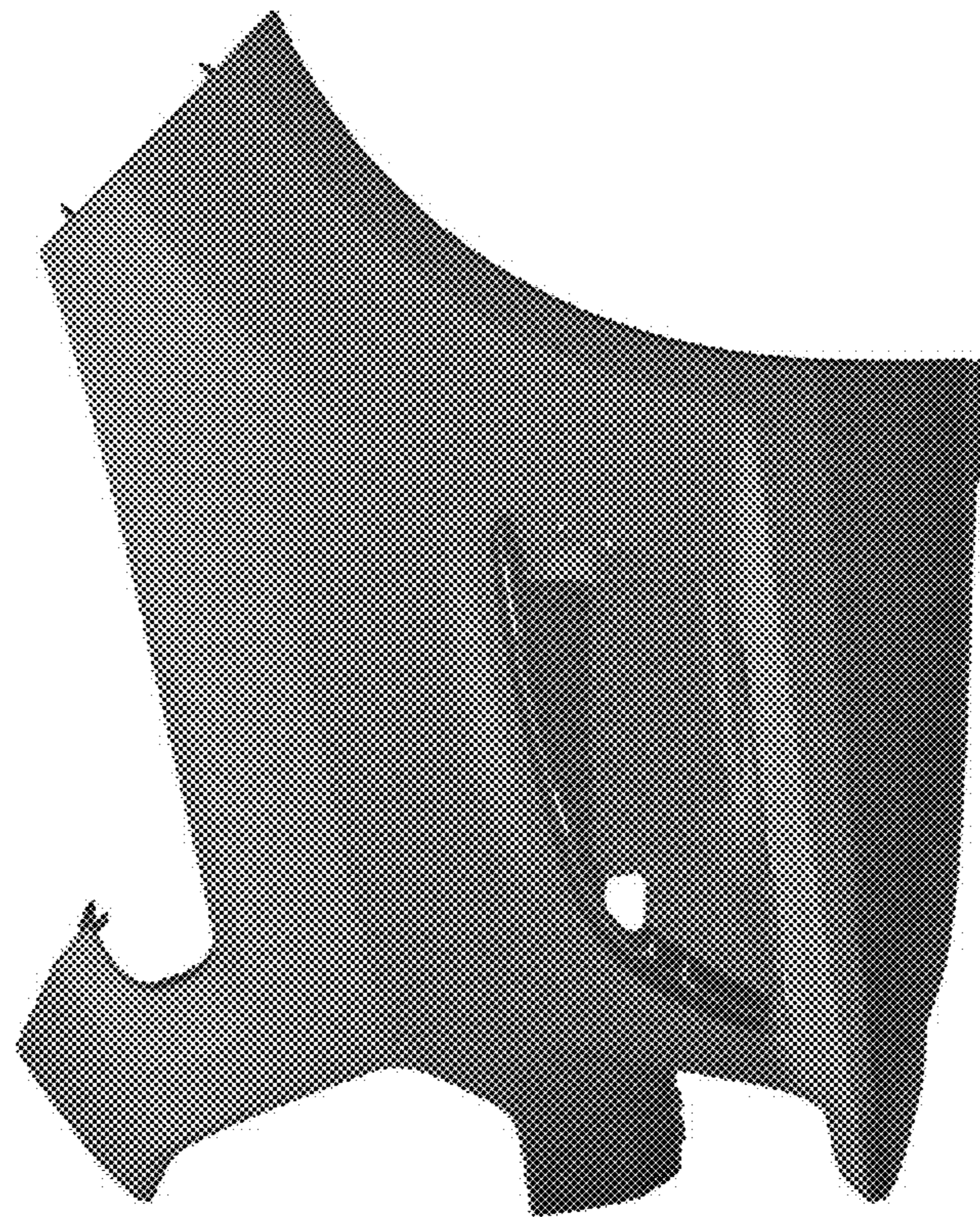

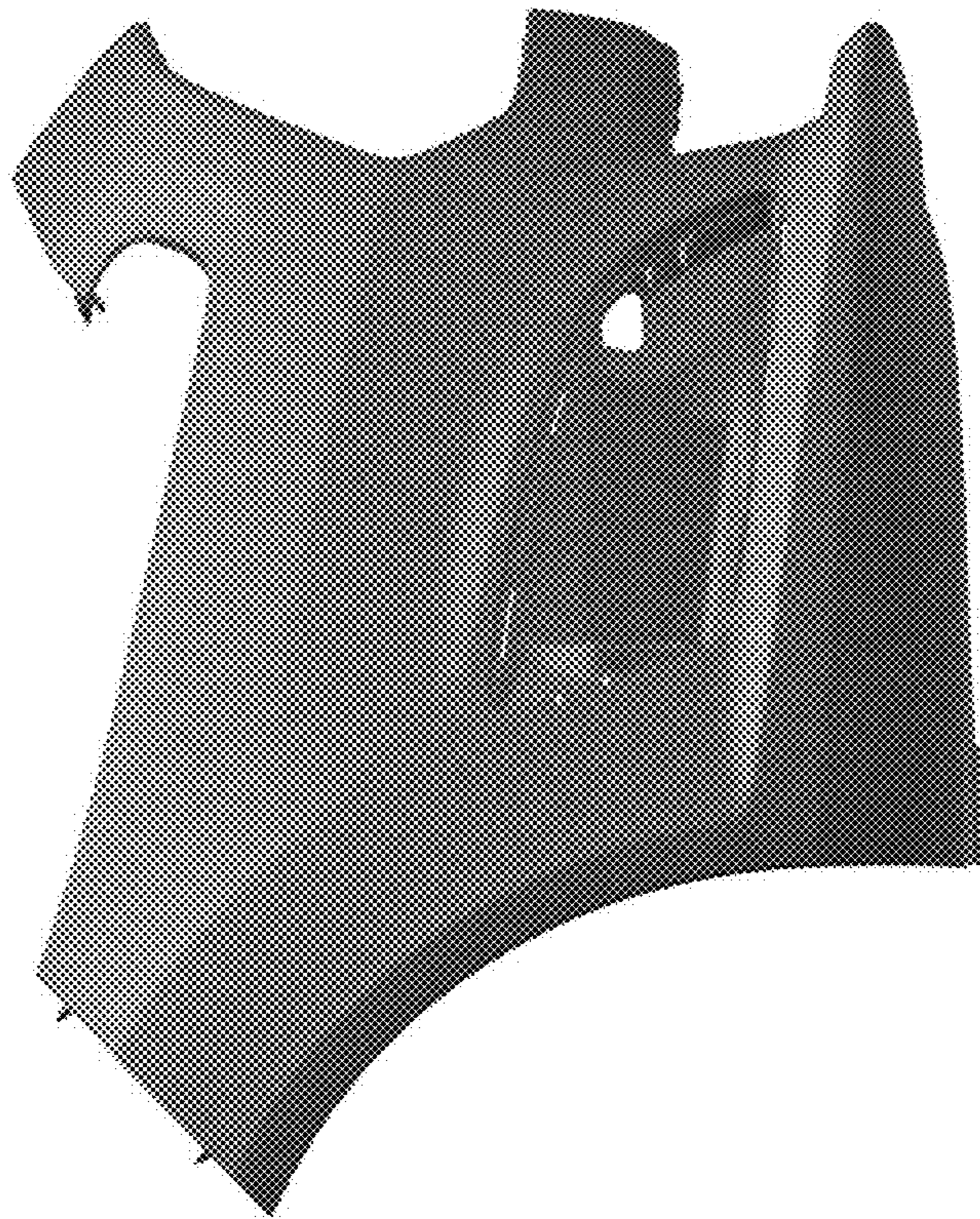
