(57) **CLAIM**

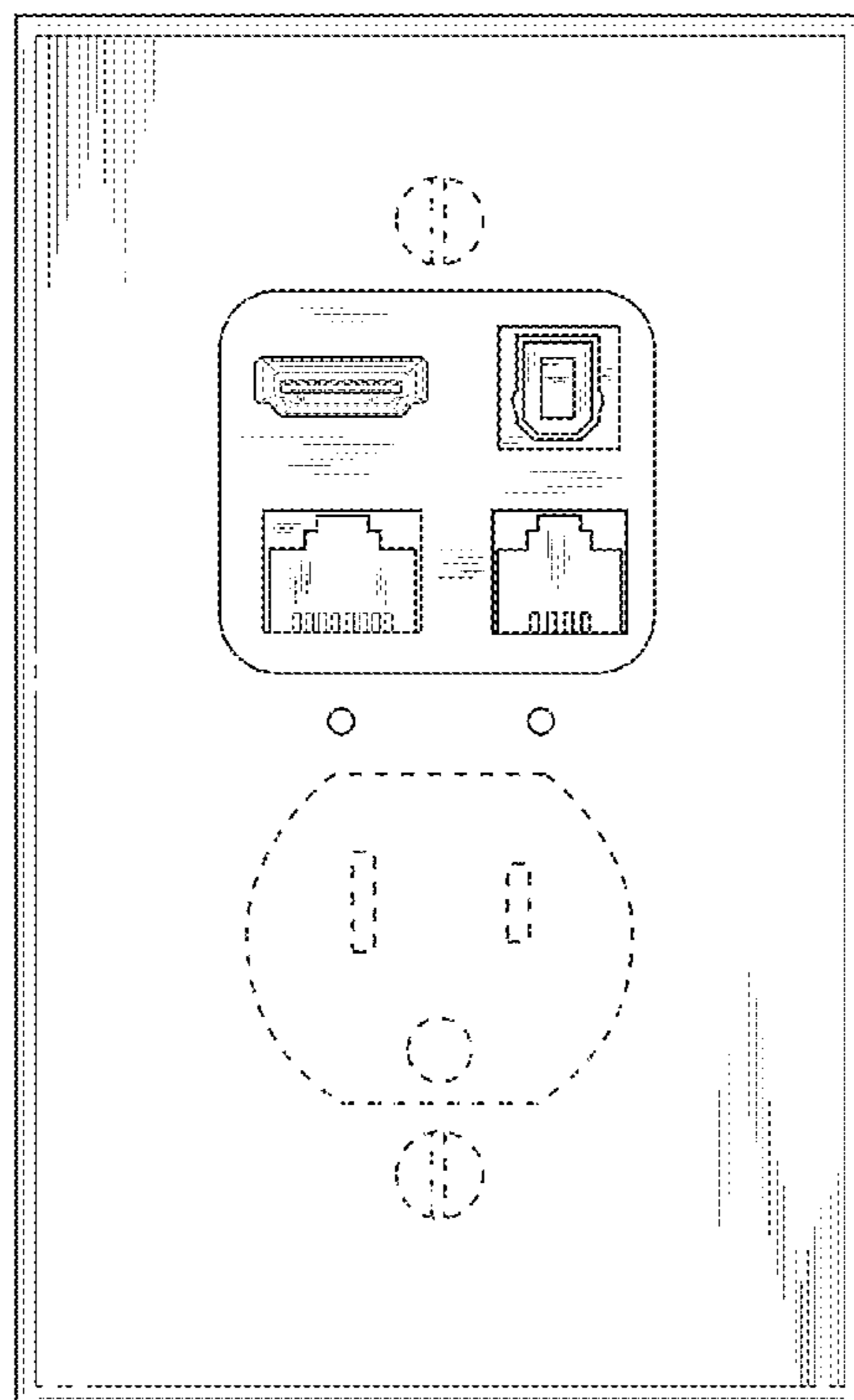
The ornamental design for a wall plate television adapter with video and audio outputs, telephone and ethernet ports, and power outlet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a wall plate television adapter with video and audio outputs, telephone and ethernet ports, and power outlet, showing our new design; and, FIG. 2 is a perspective view thereof.

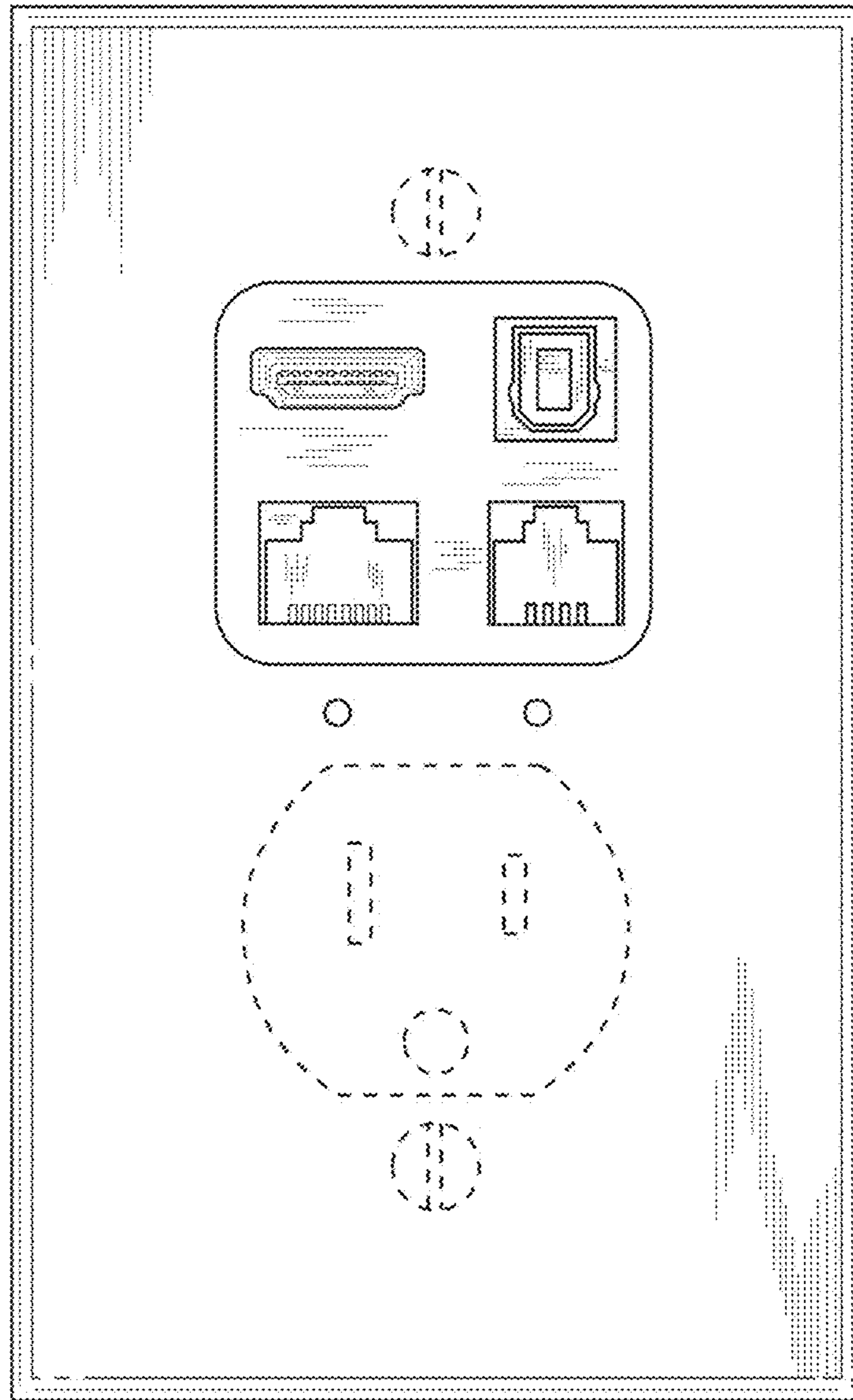

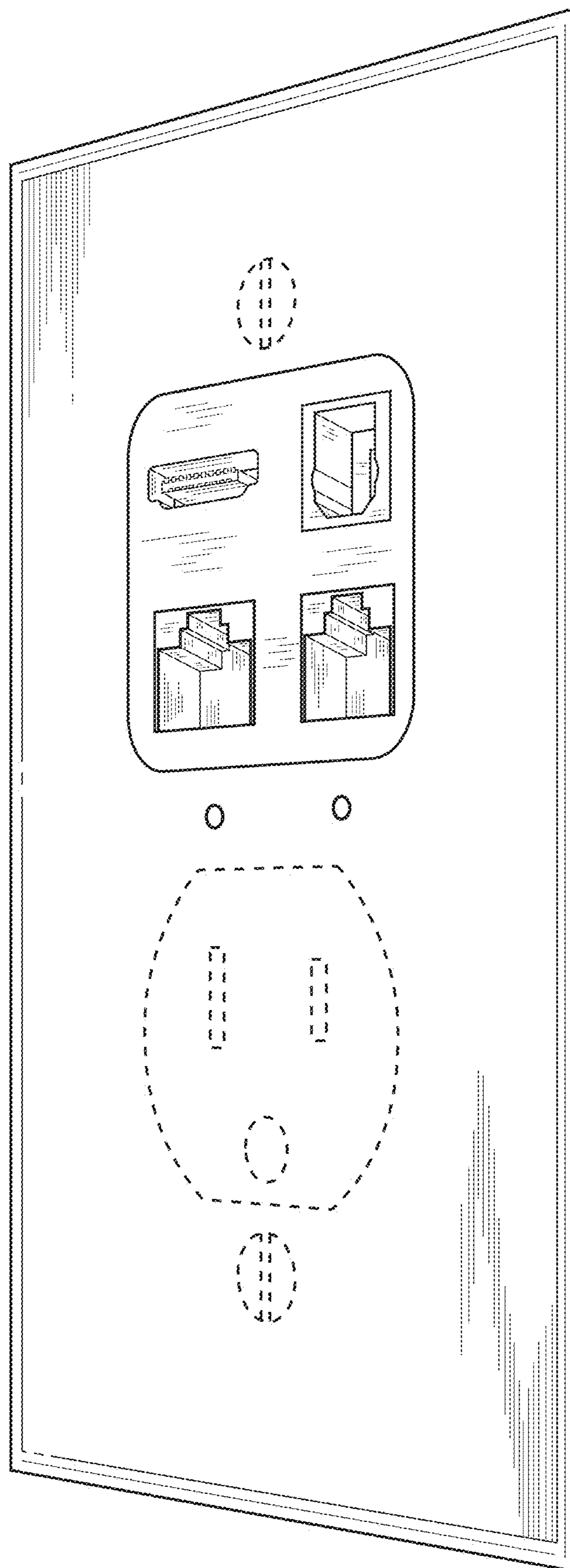
