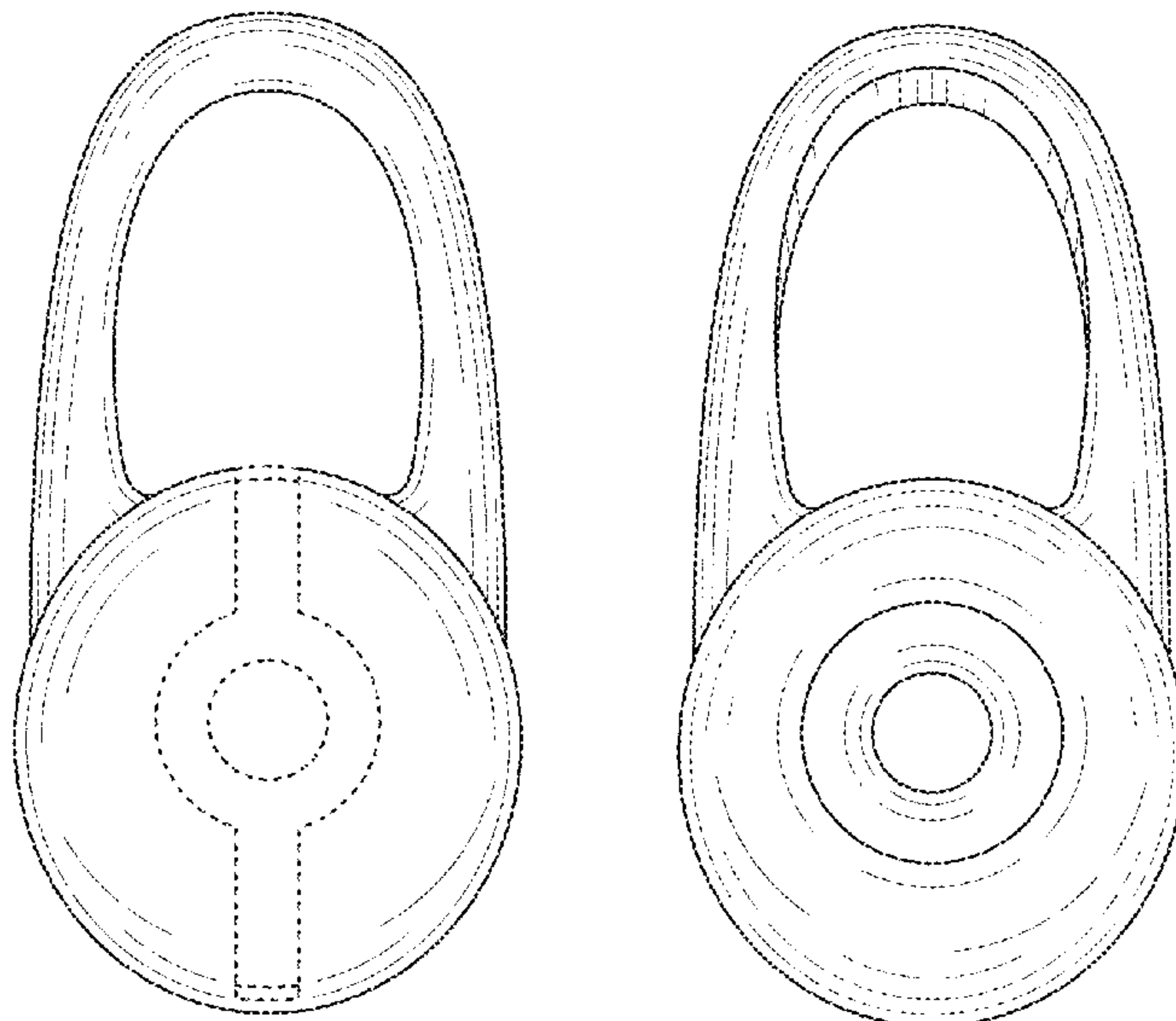
(57) **CLAIM**

The ornamental design for an ear tip for a communications headset, as shown and described.

DESCRIPTION

FIG. 1 is back-bottom-left perspective view of an ear tip for a communications headset showing our new design; FIG. 2 is a front-top-left perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof. The broken lines form no part of the claimed design.

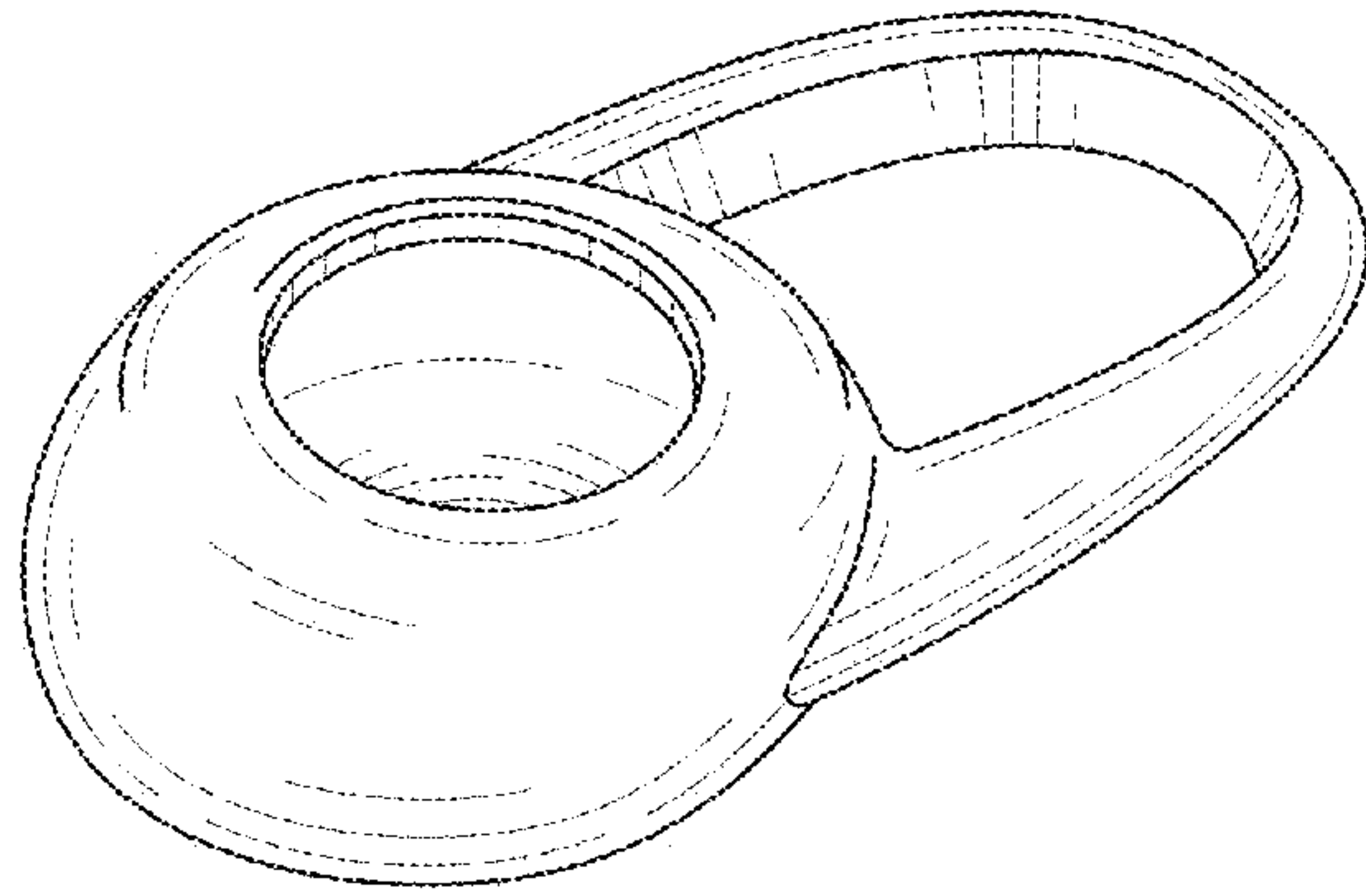

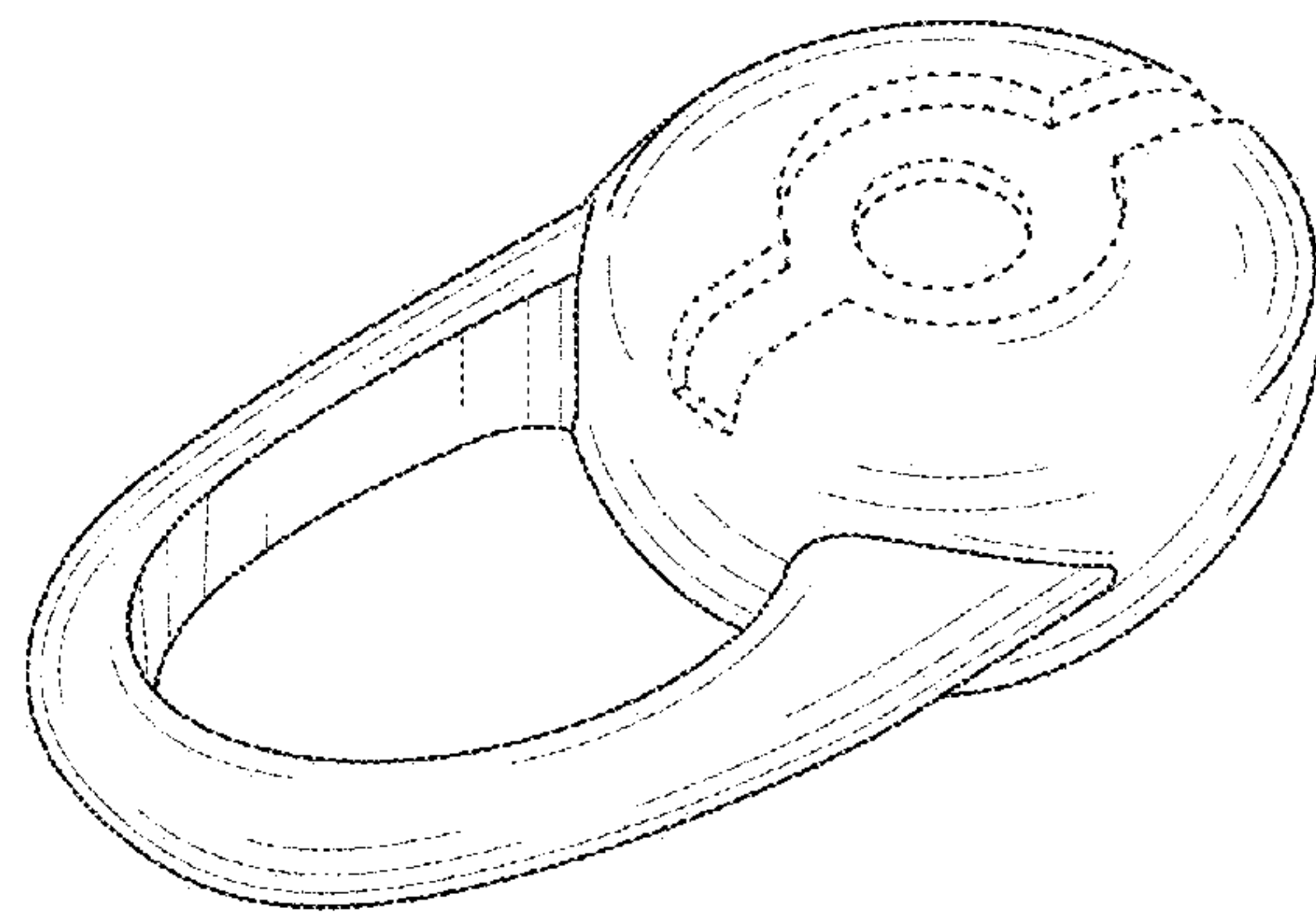

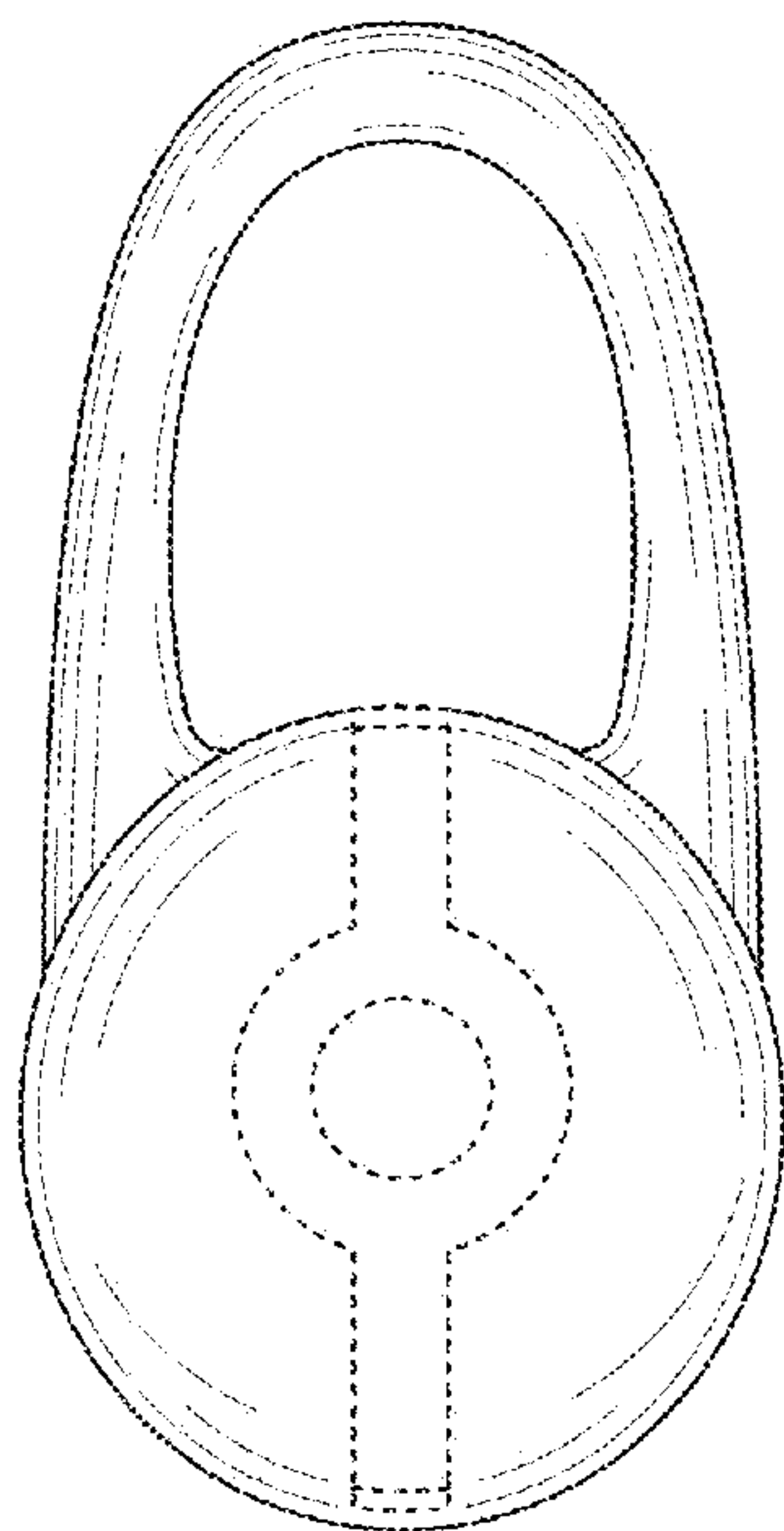

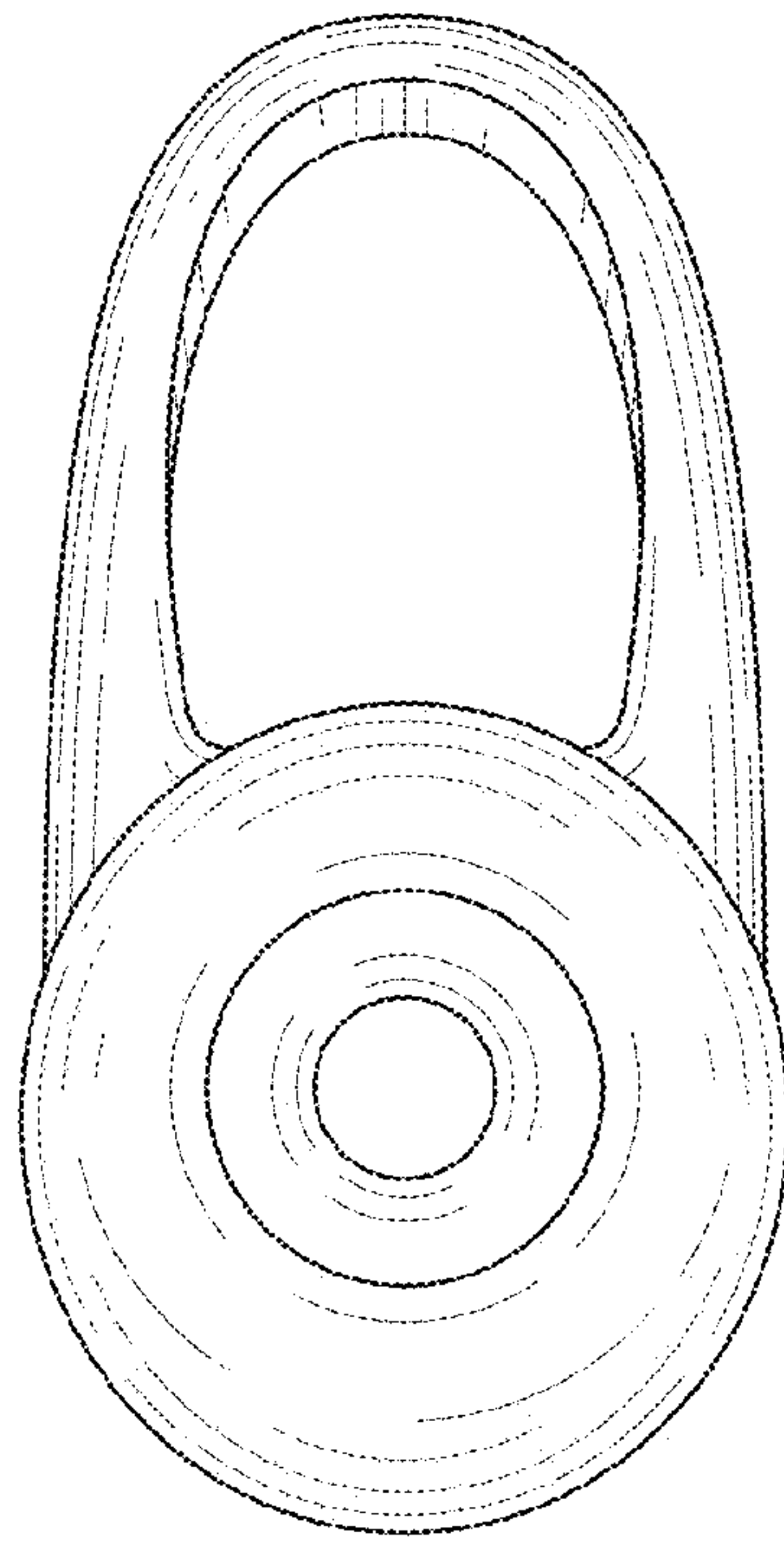

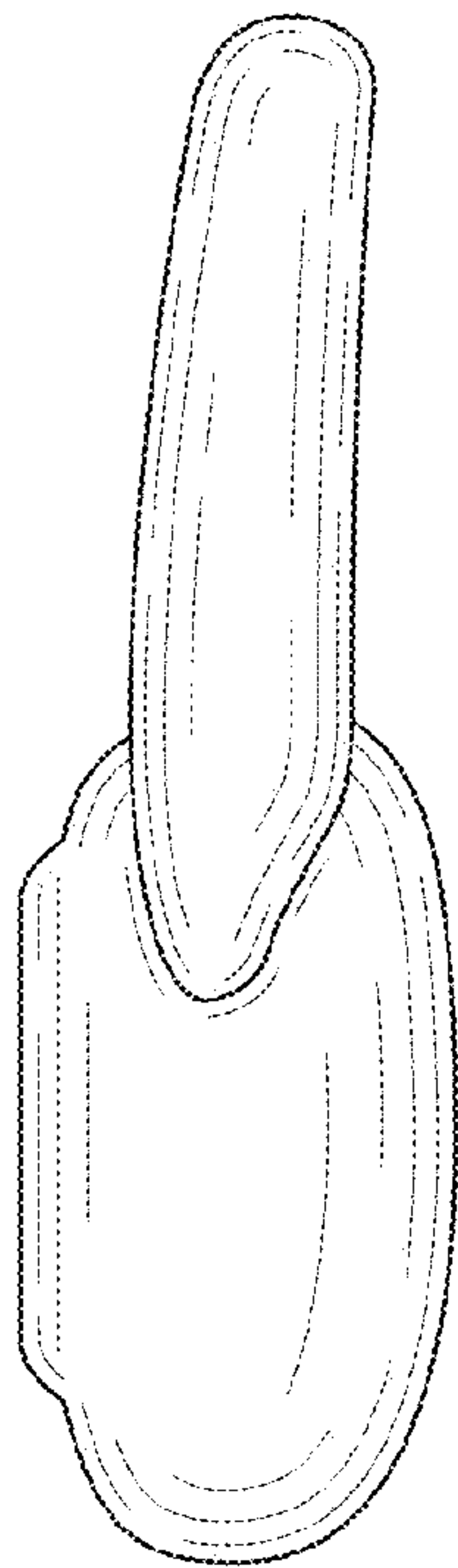

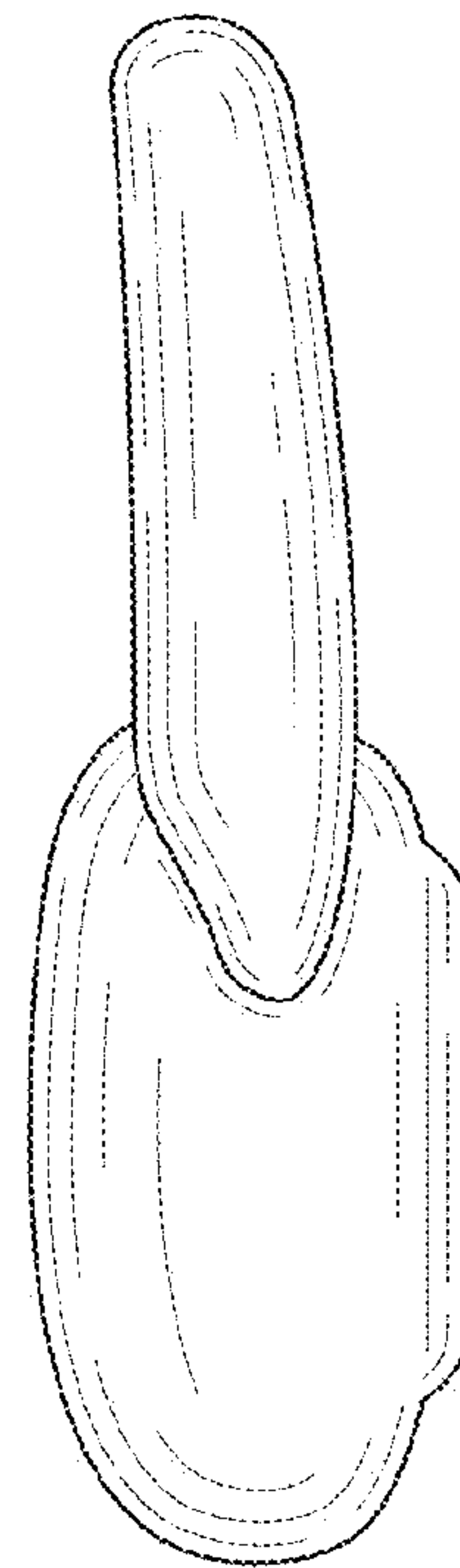

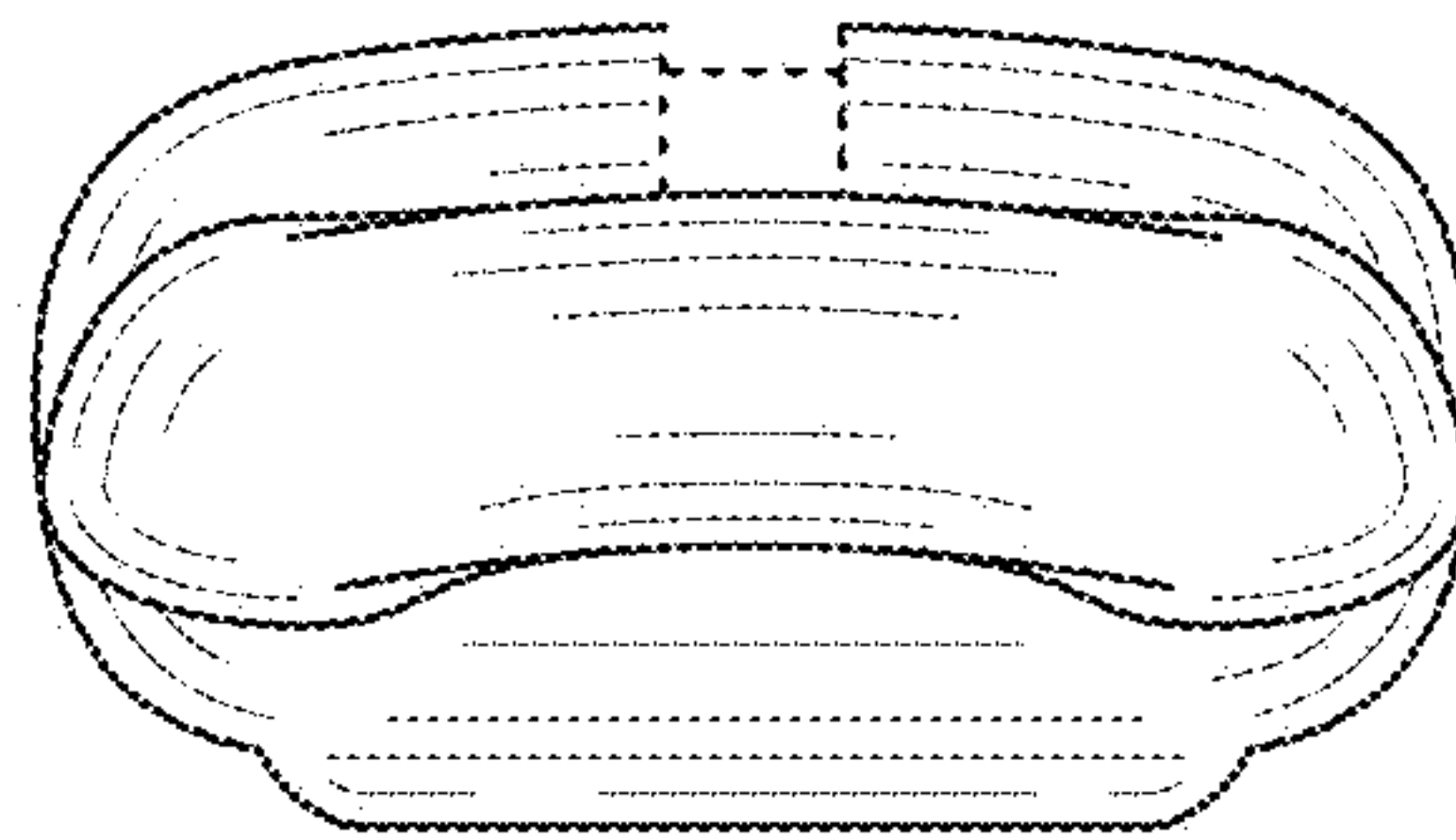

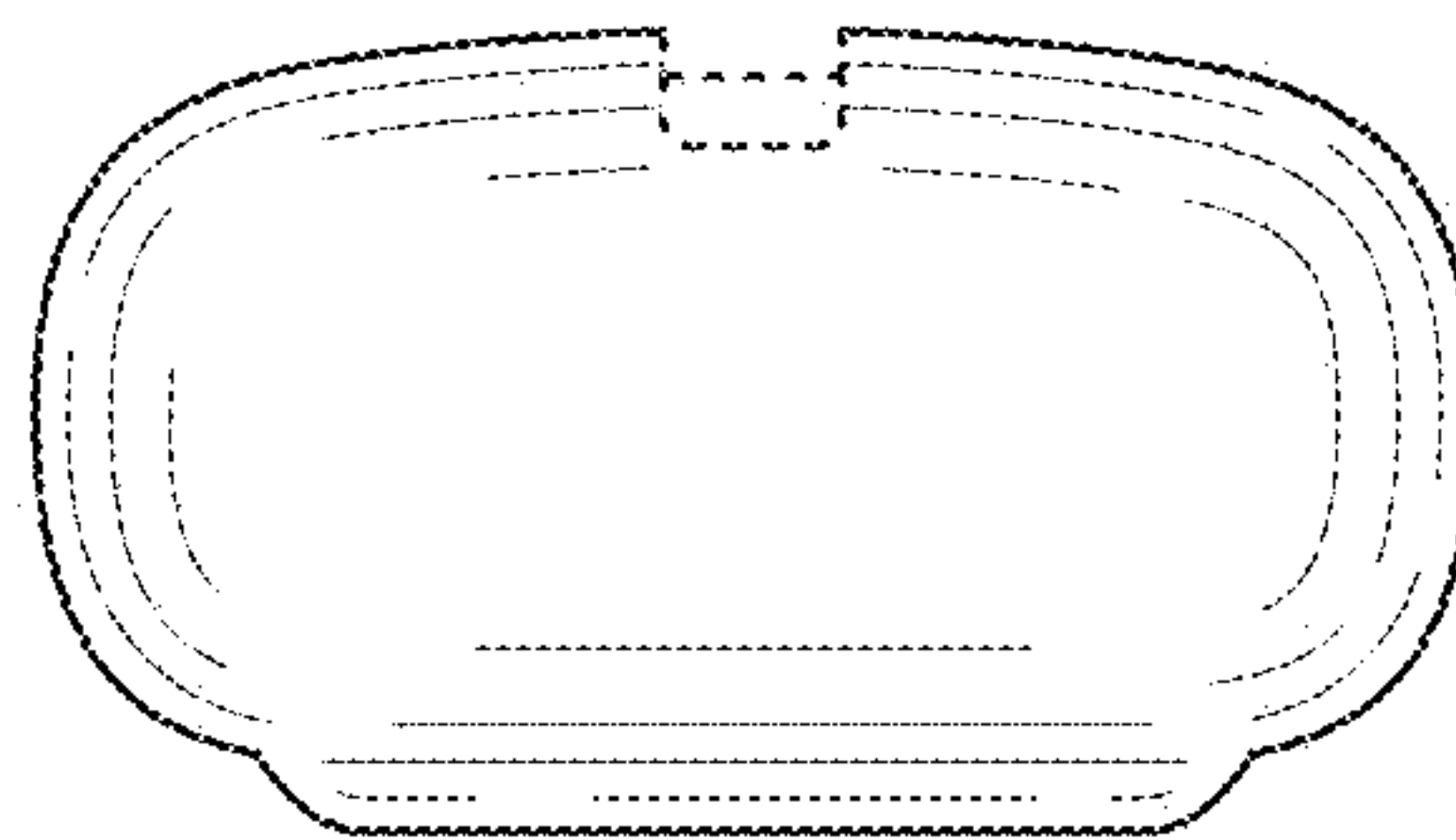
