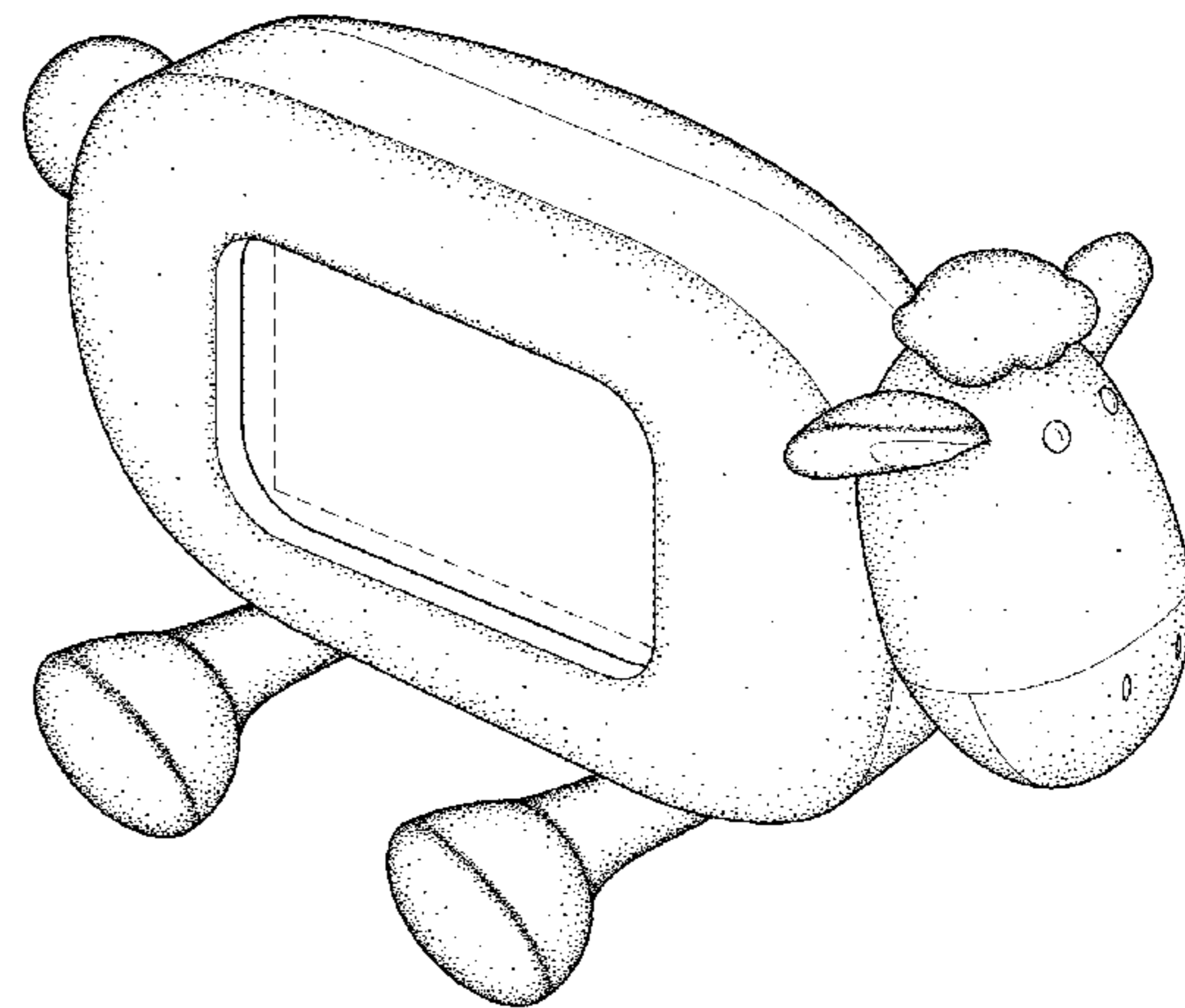
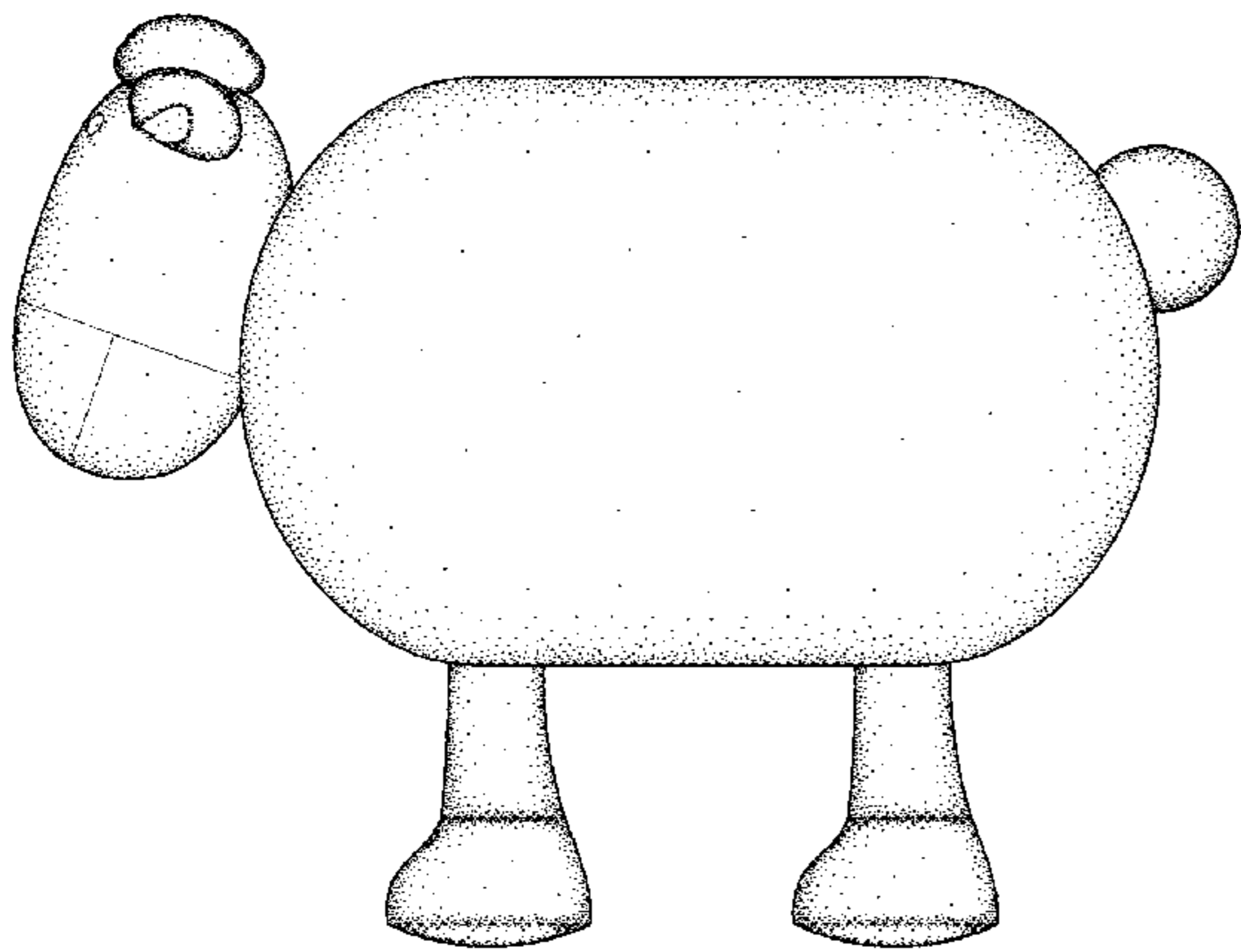
The ornamental design for protective cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a protective cover showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is another perspective view thereof in a use state with a display device shown in broken lines inserted within the protective cover.

The broken lines showing a device in FIG. 8 are for illustrative purposes and form no part of the claimed design.

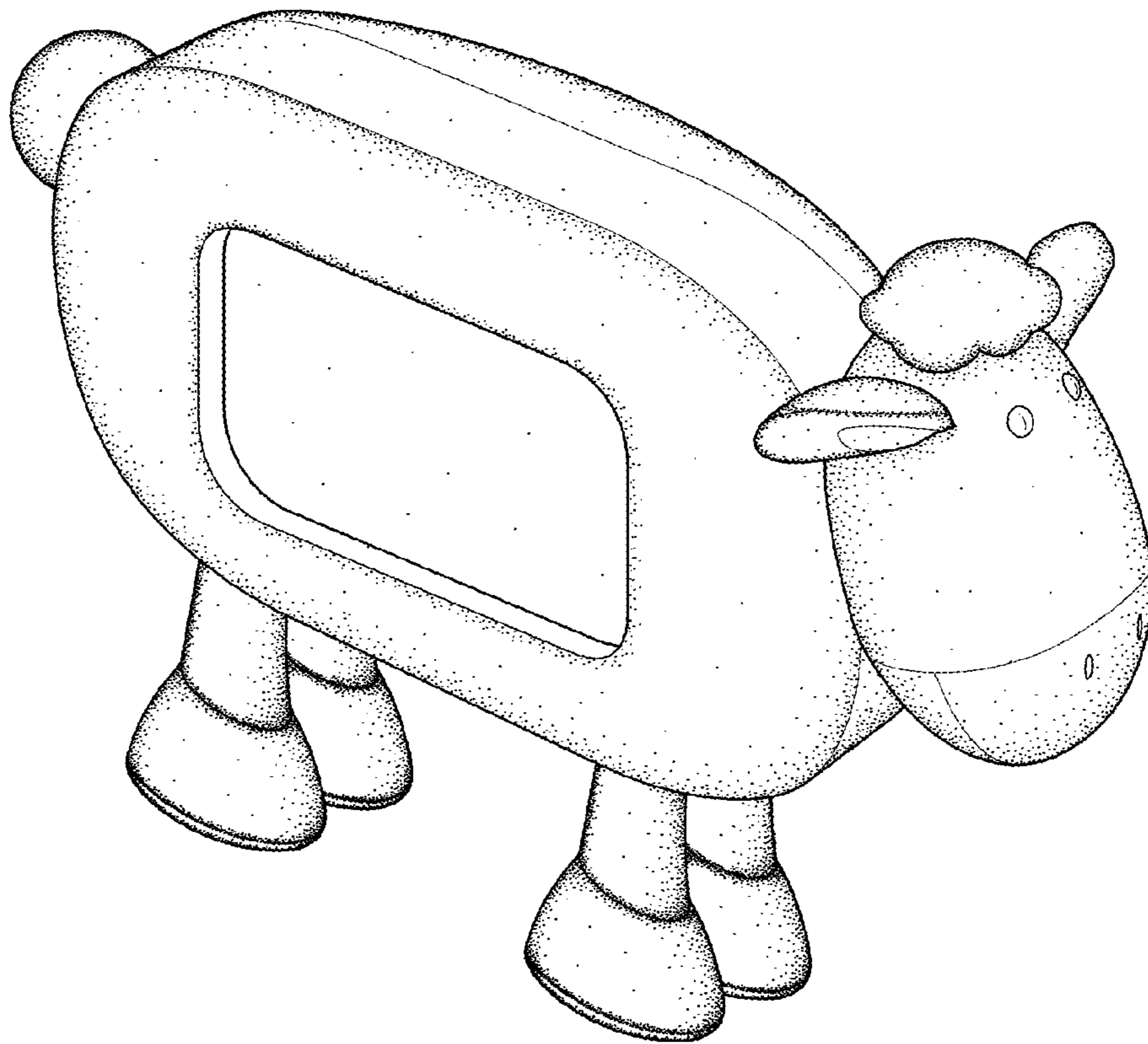

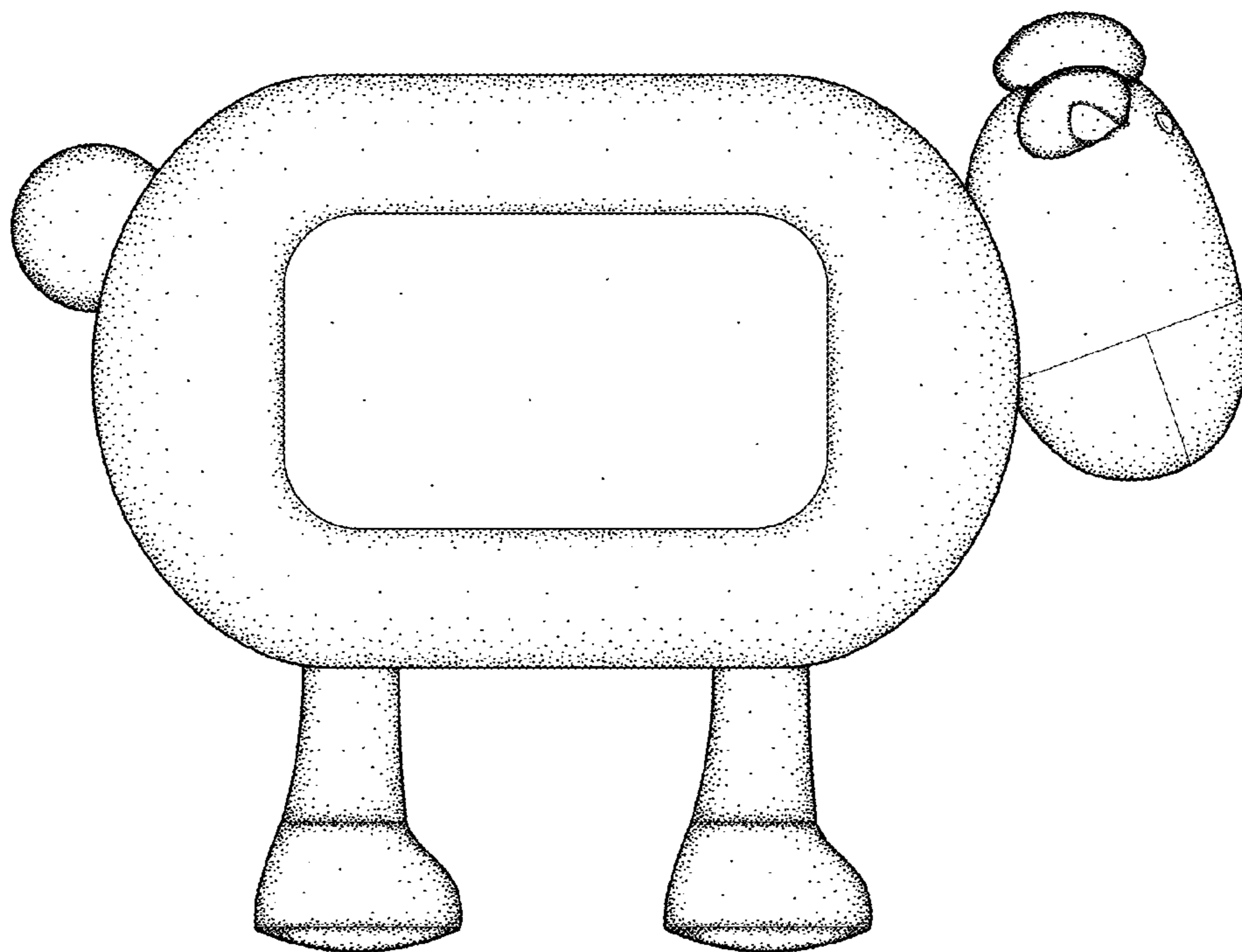

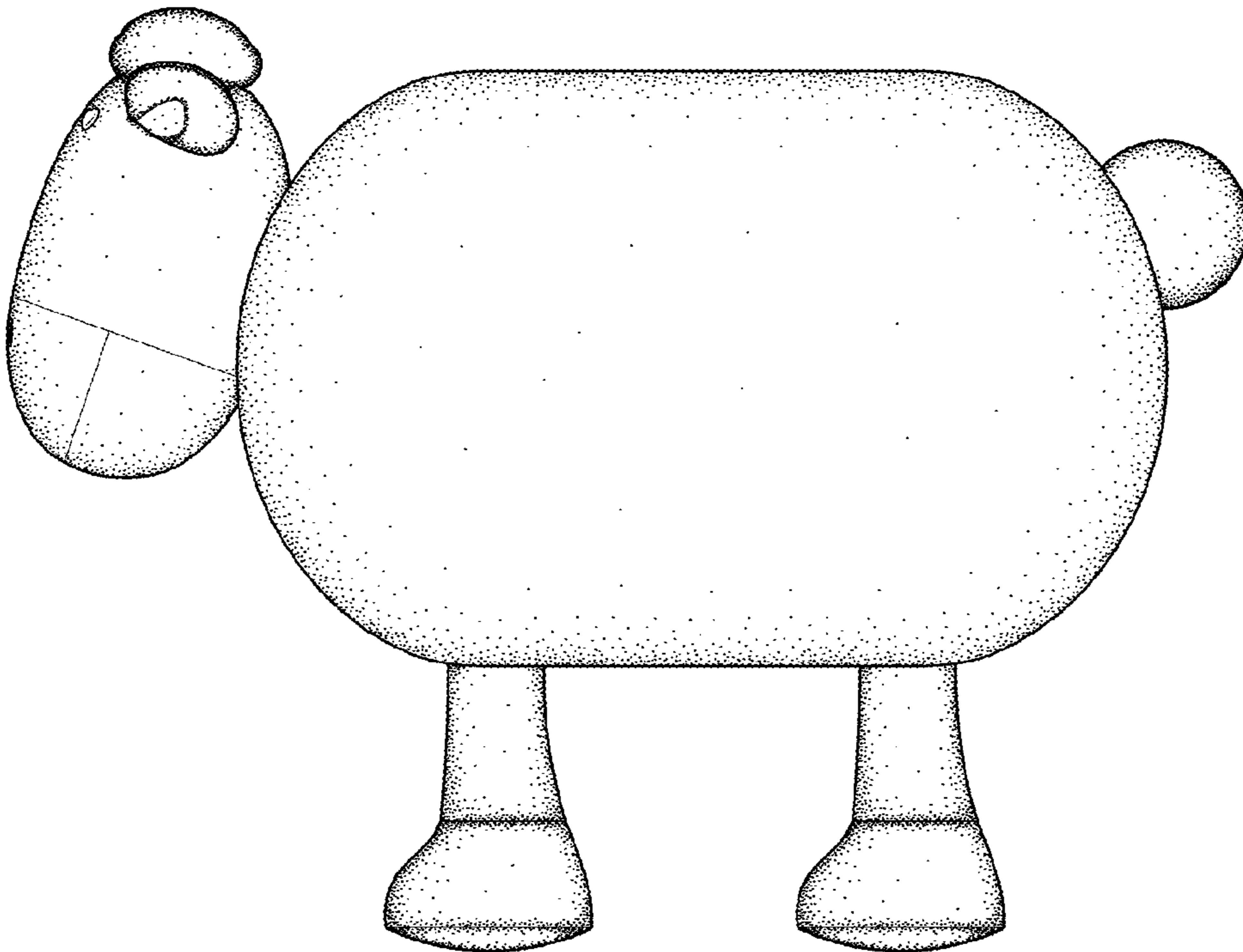

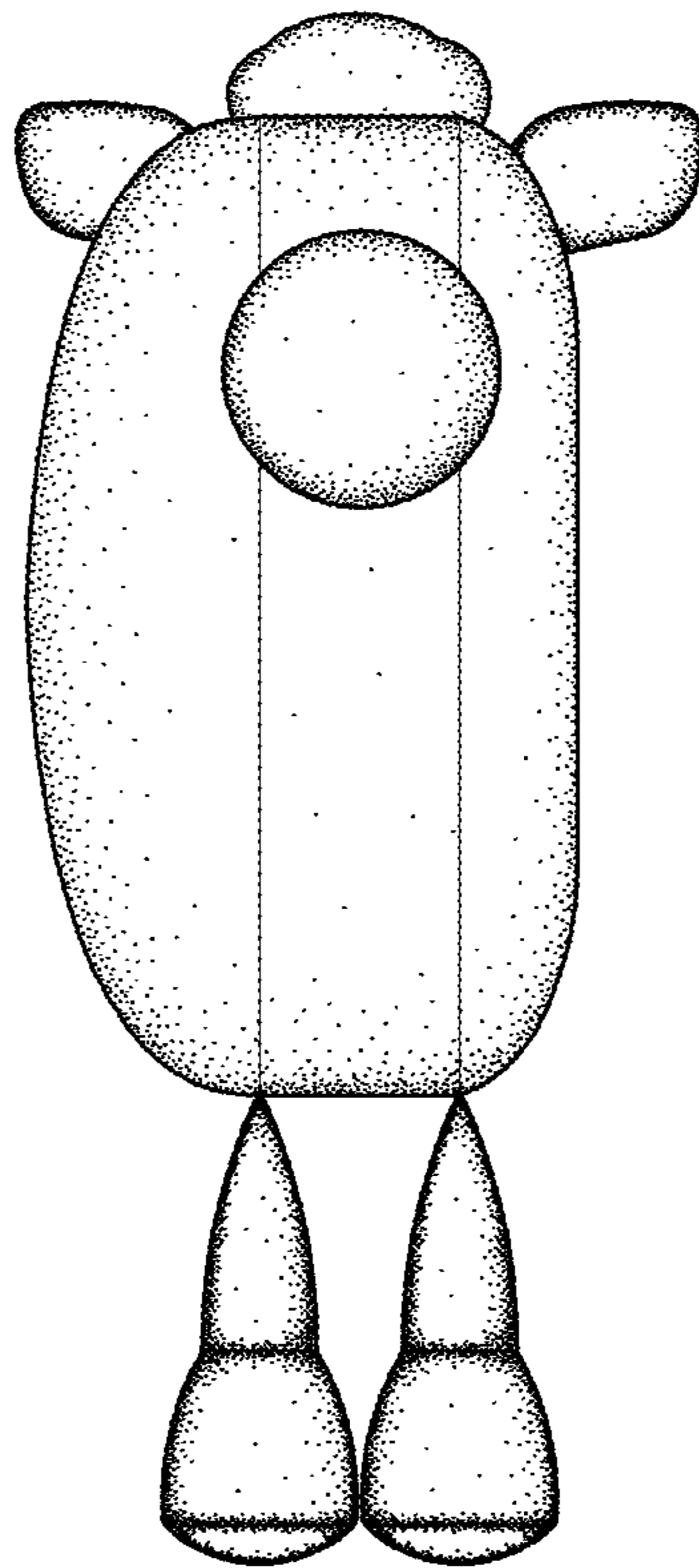

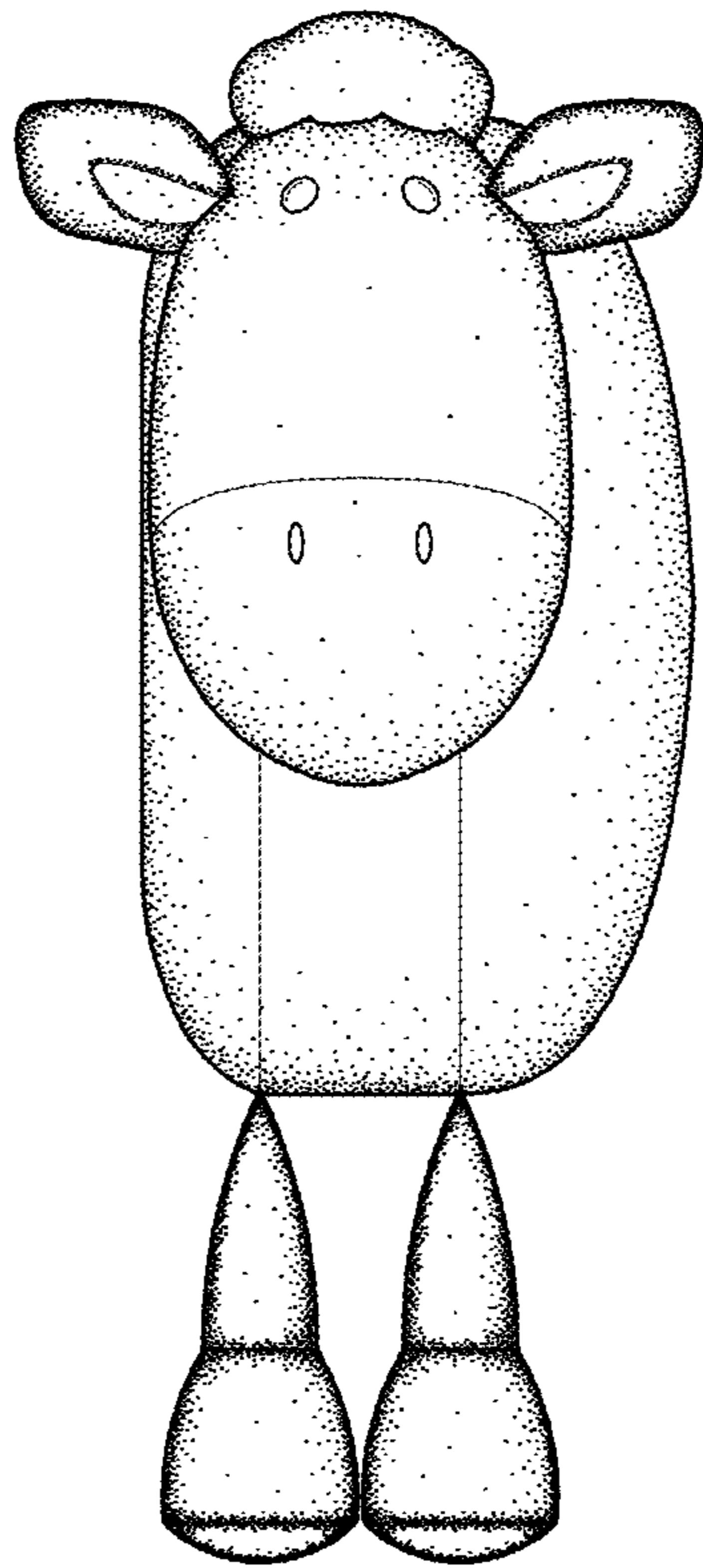

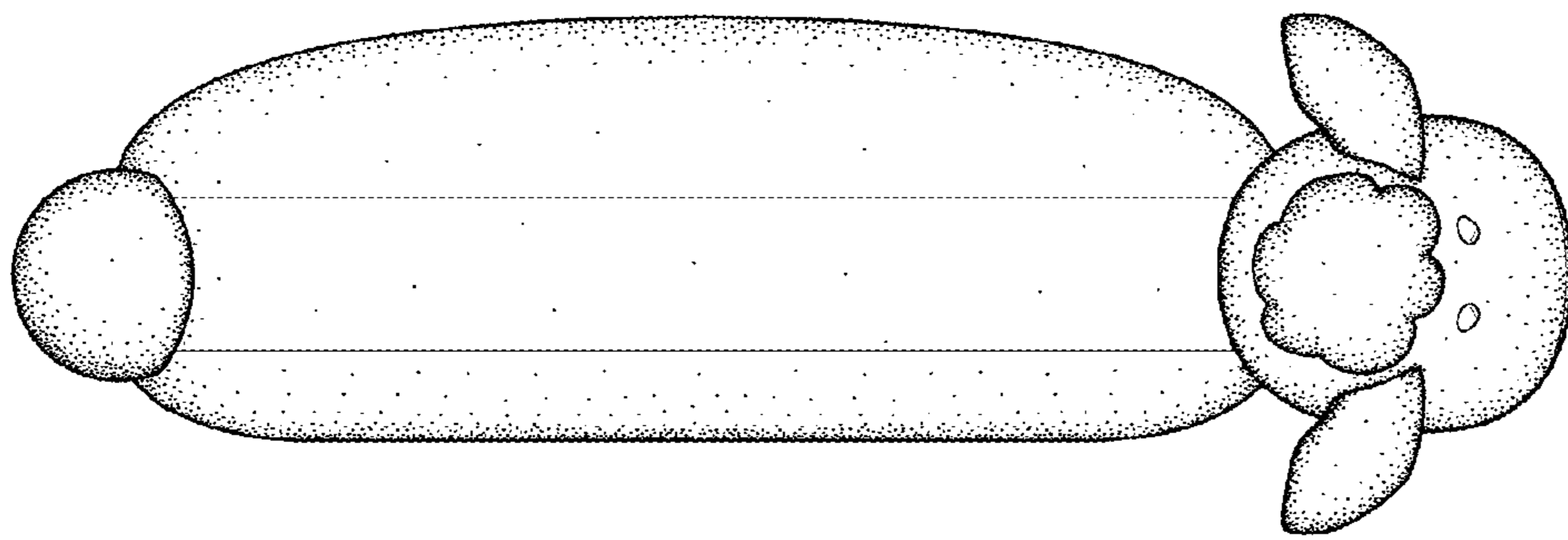

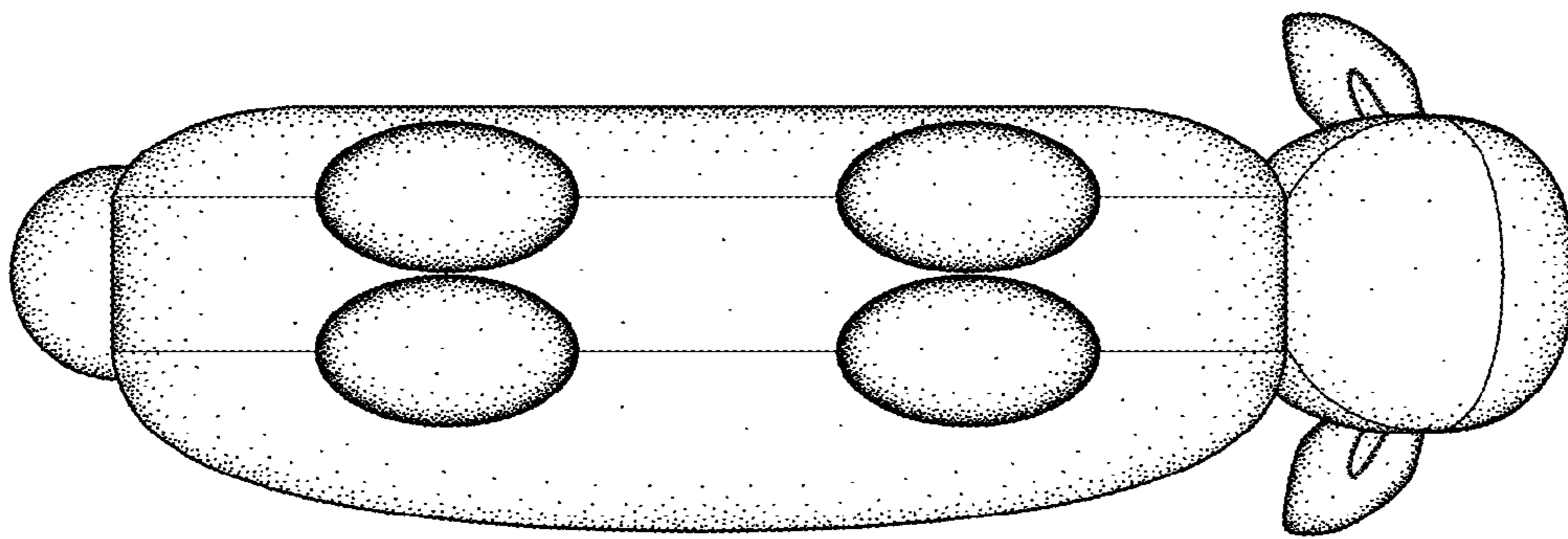

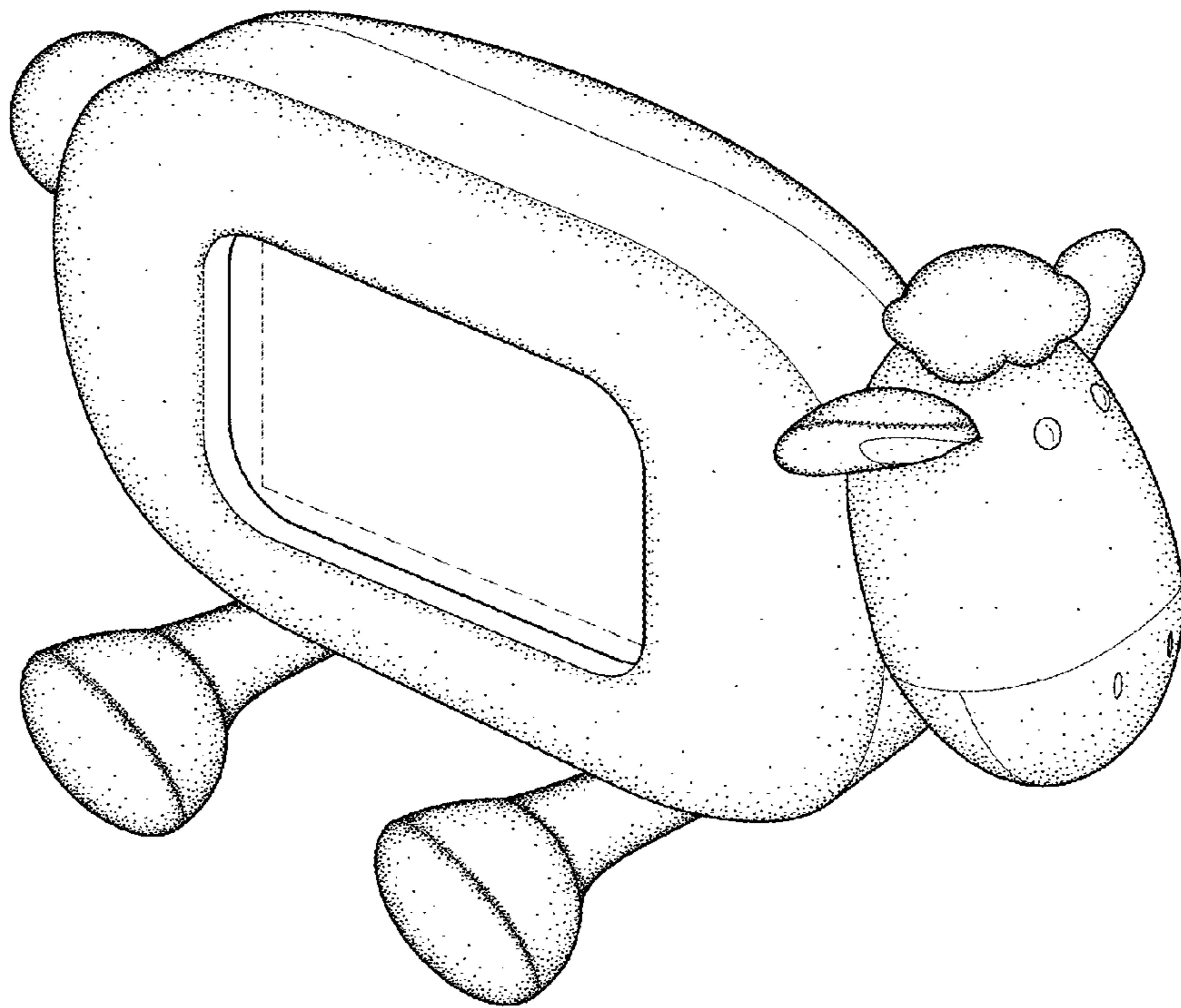
