The ornamental design for a tablet PC, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tablet PC showing our new design;

FIG. 12 is a left-side view of the tablet PC of FIG. 9;

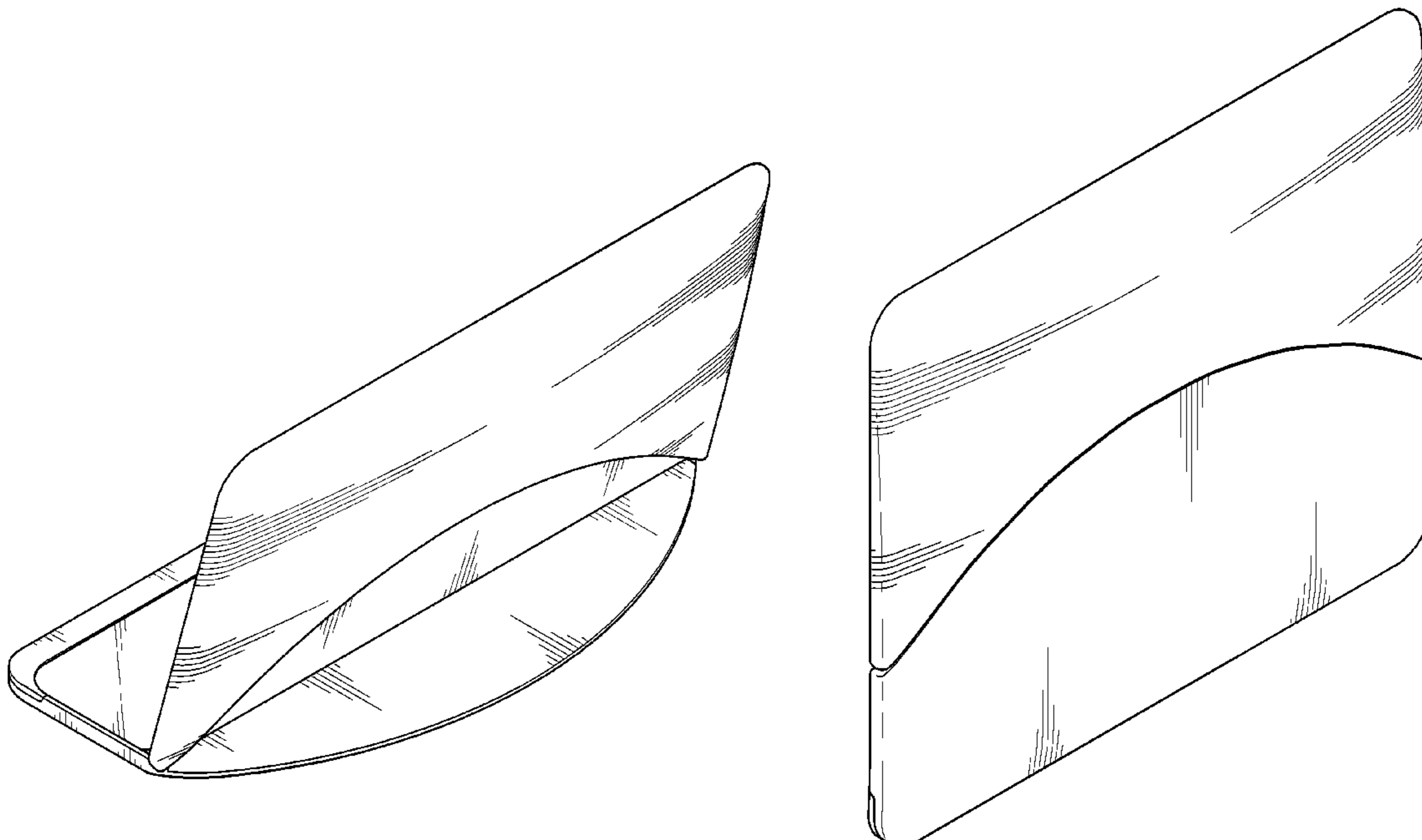
FIG. 13 is a right-side view of the tablet PC of FIG. 9;

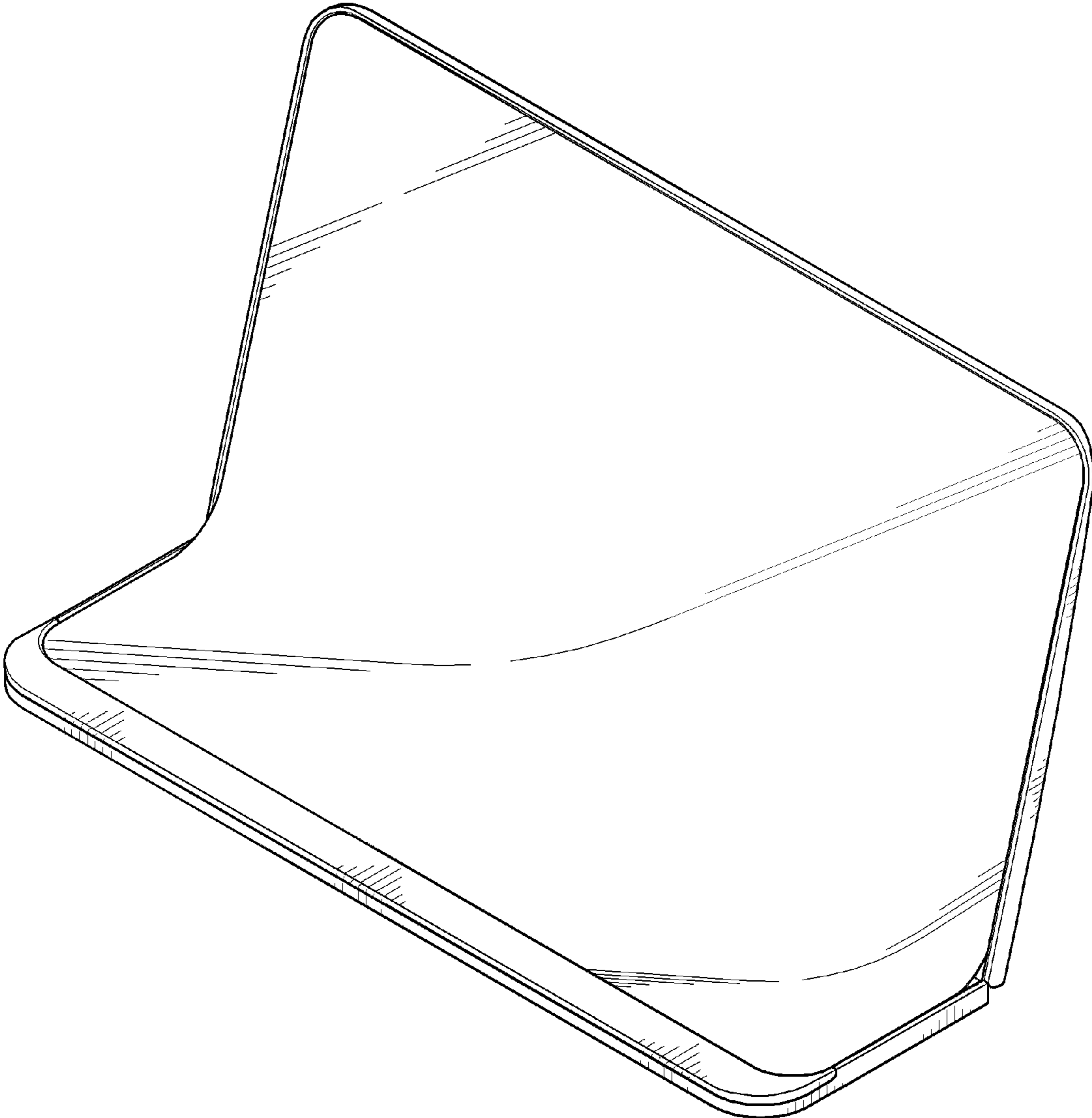

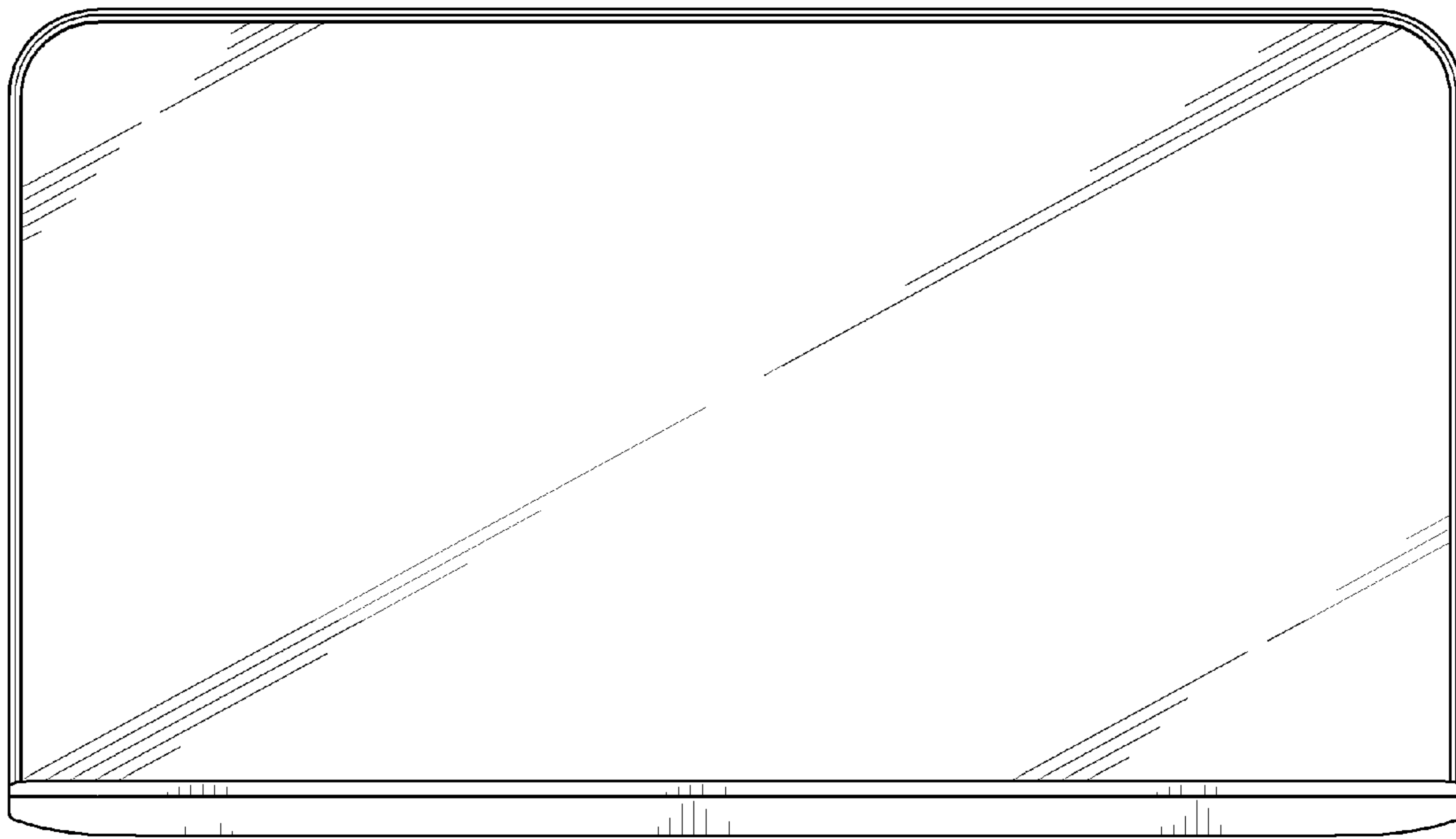

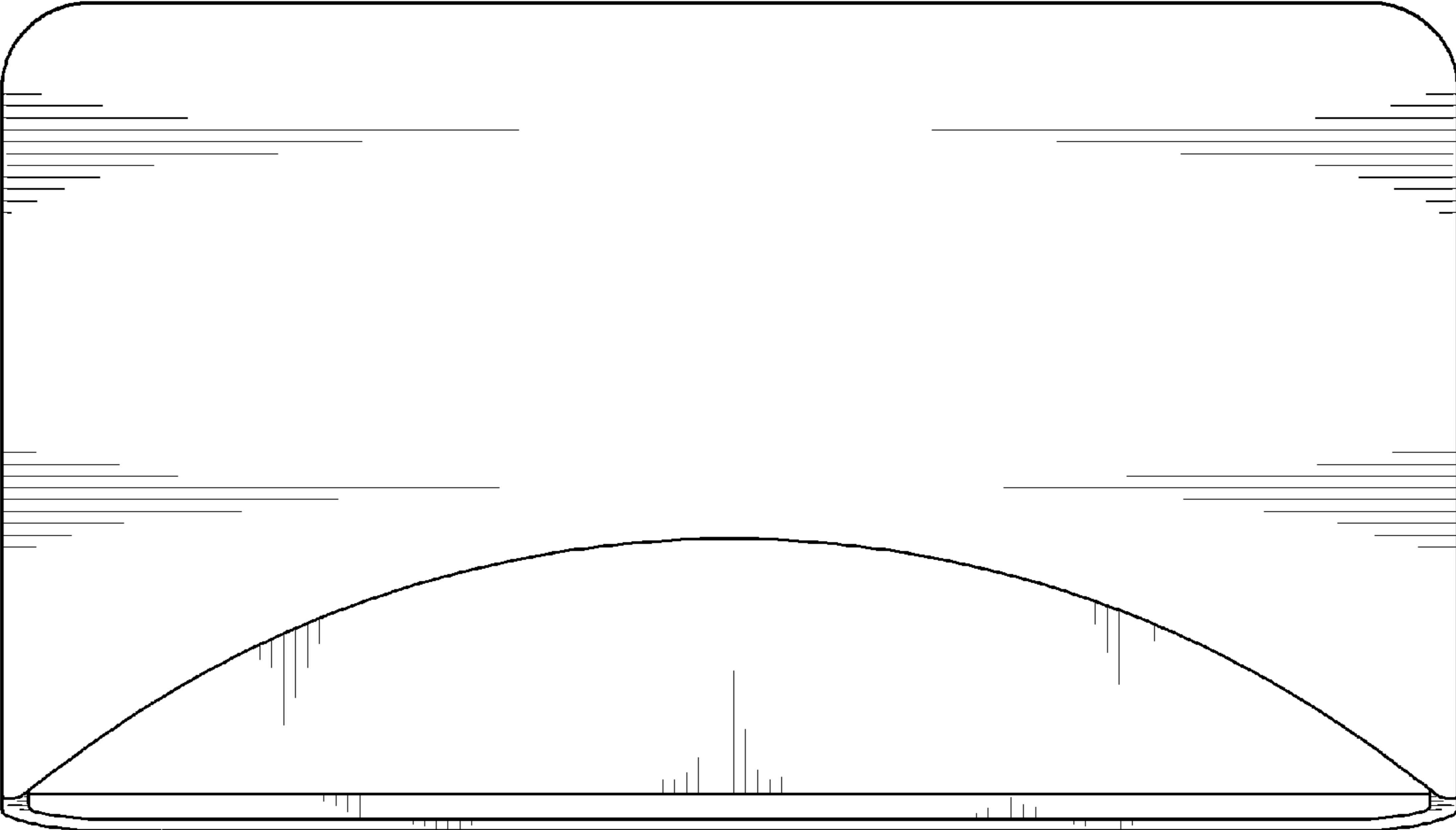

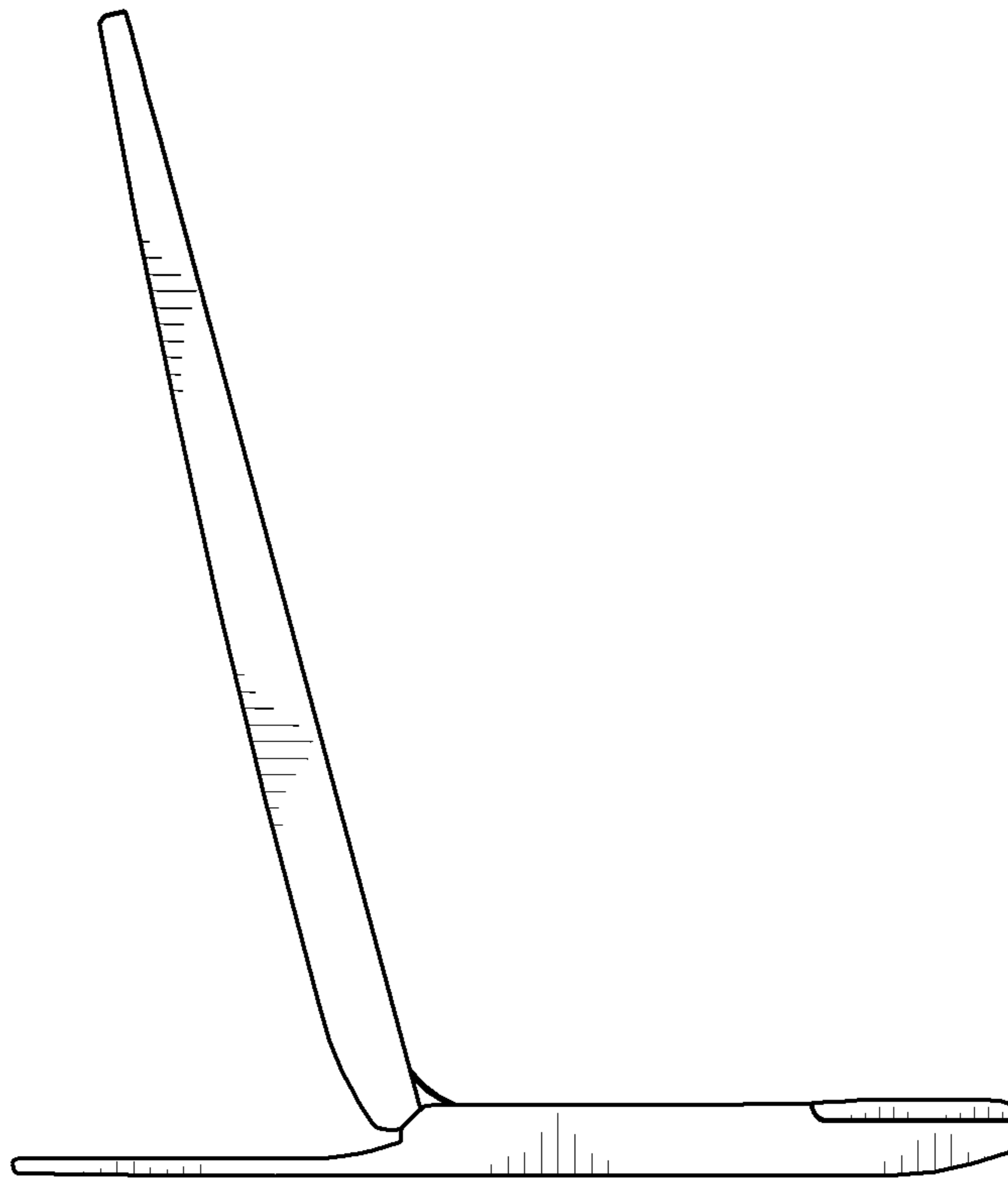

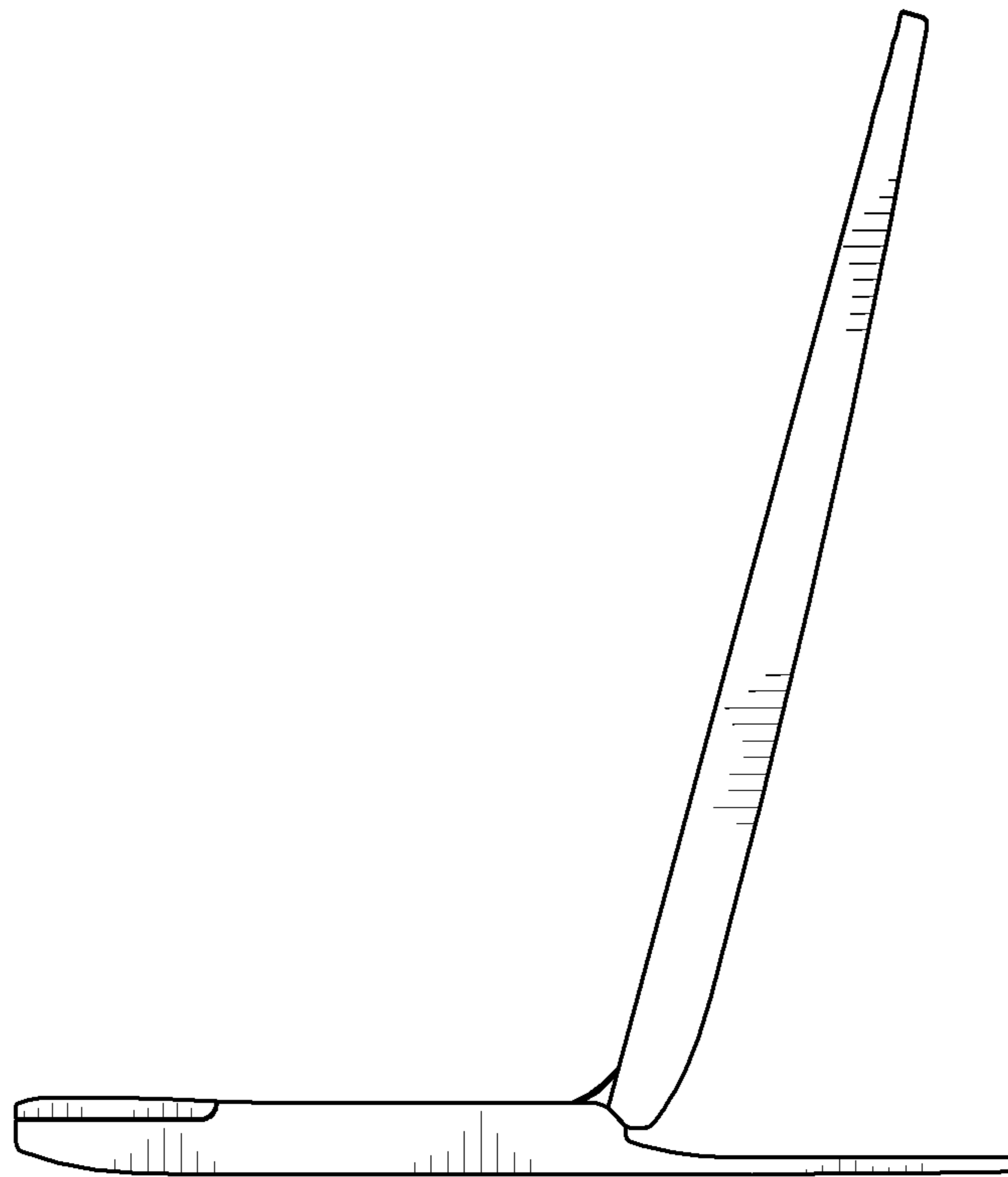

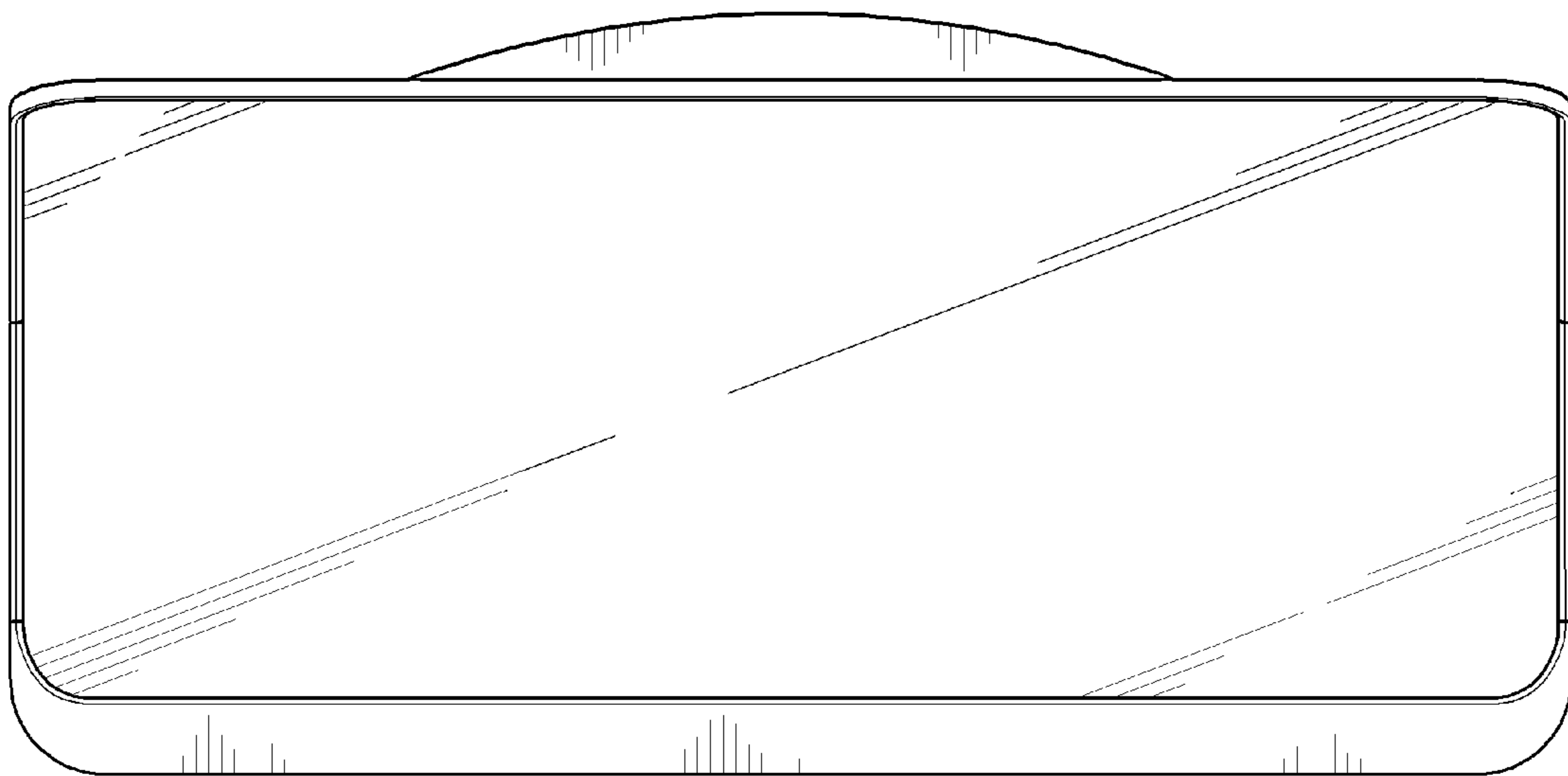

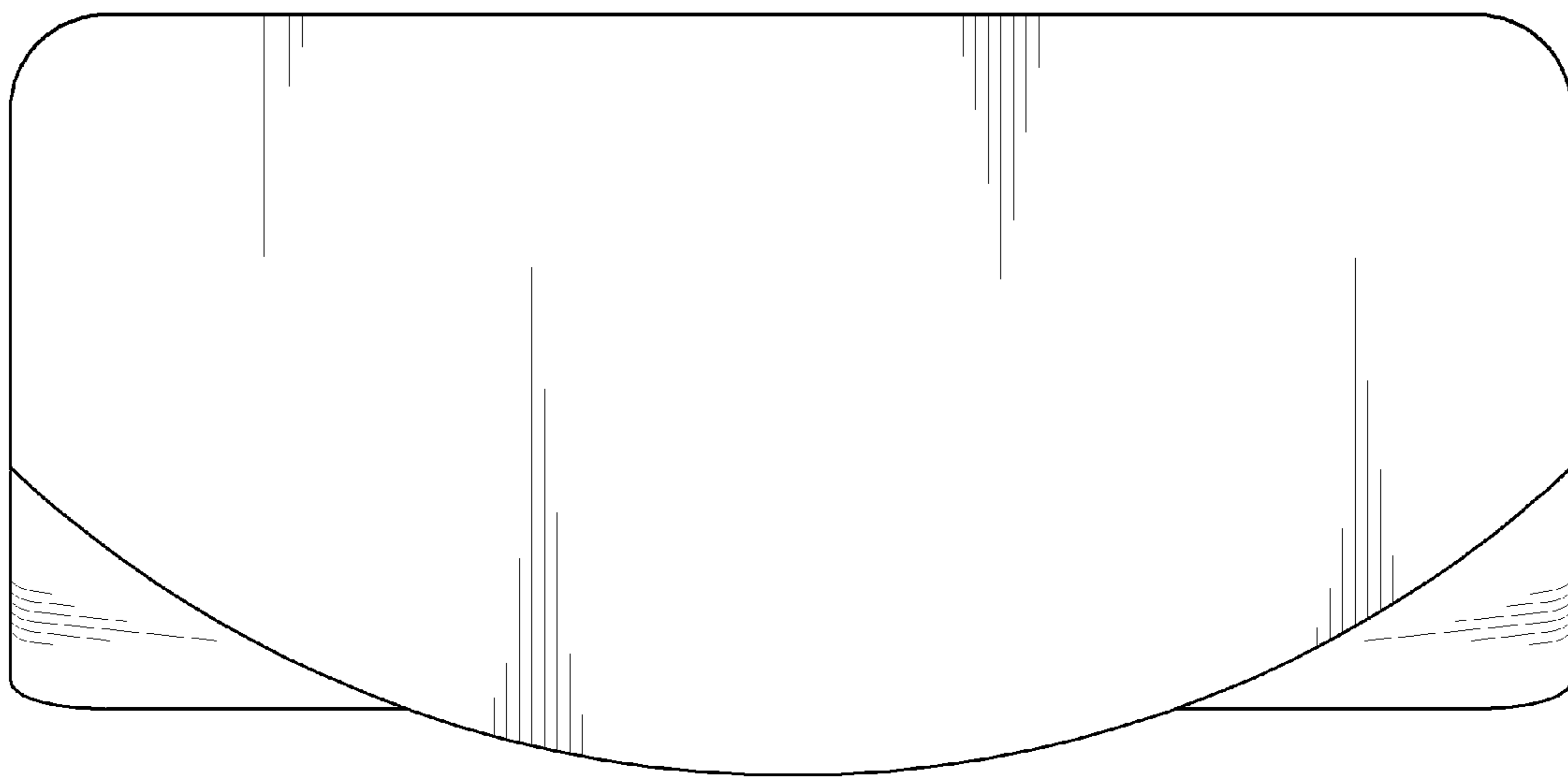

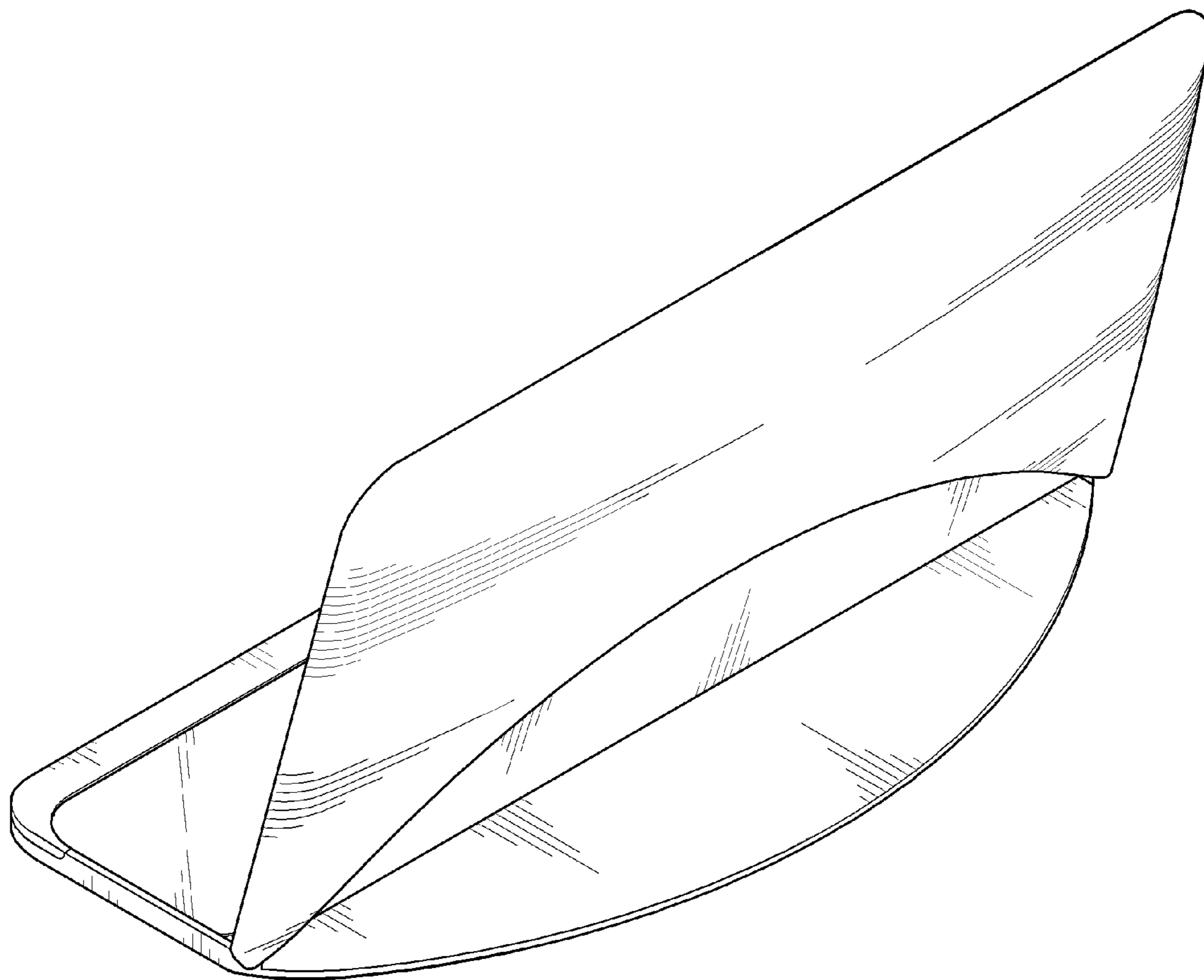

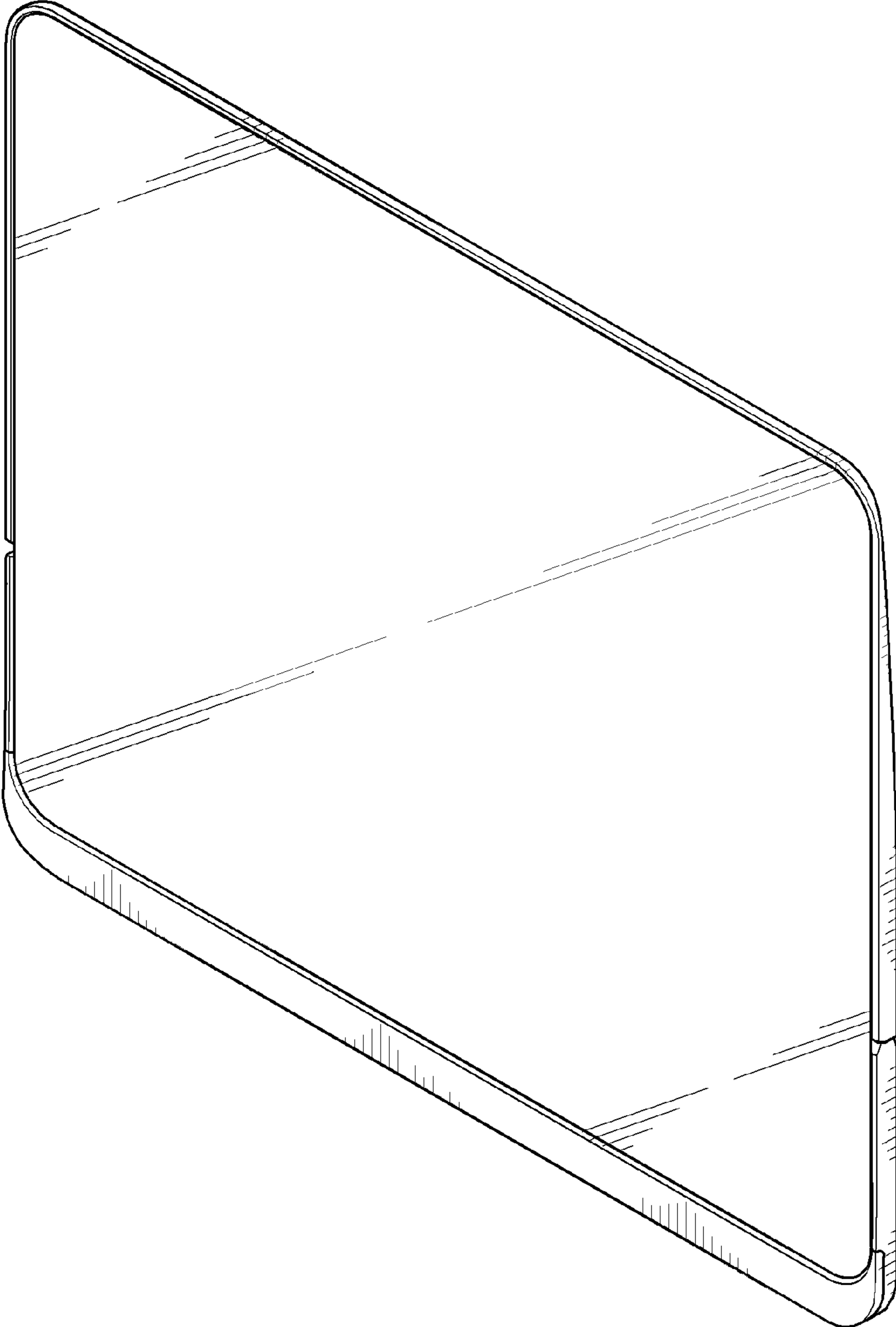

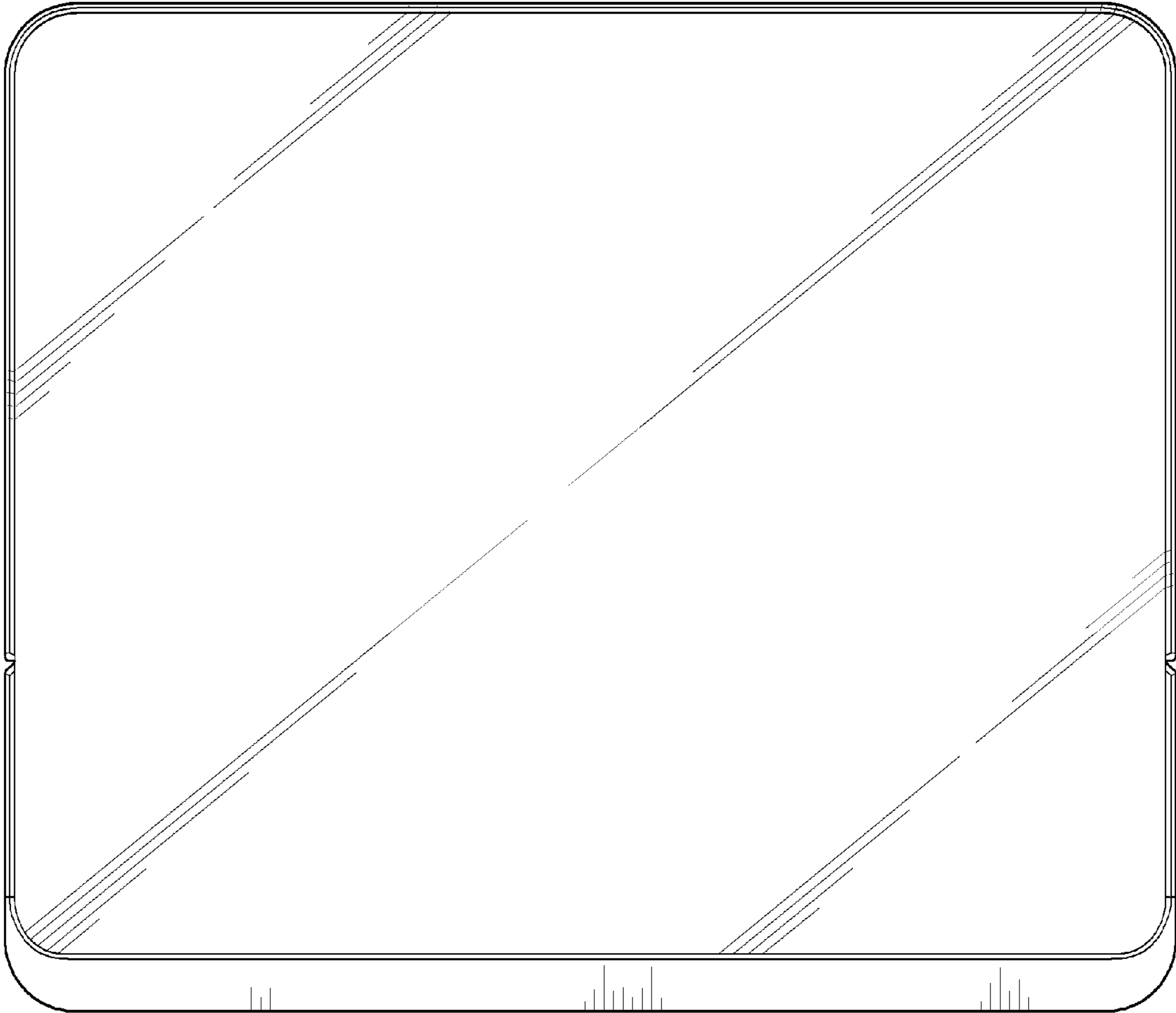

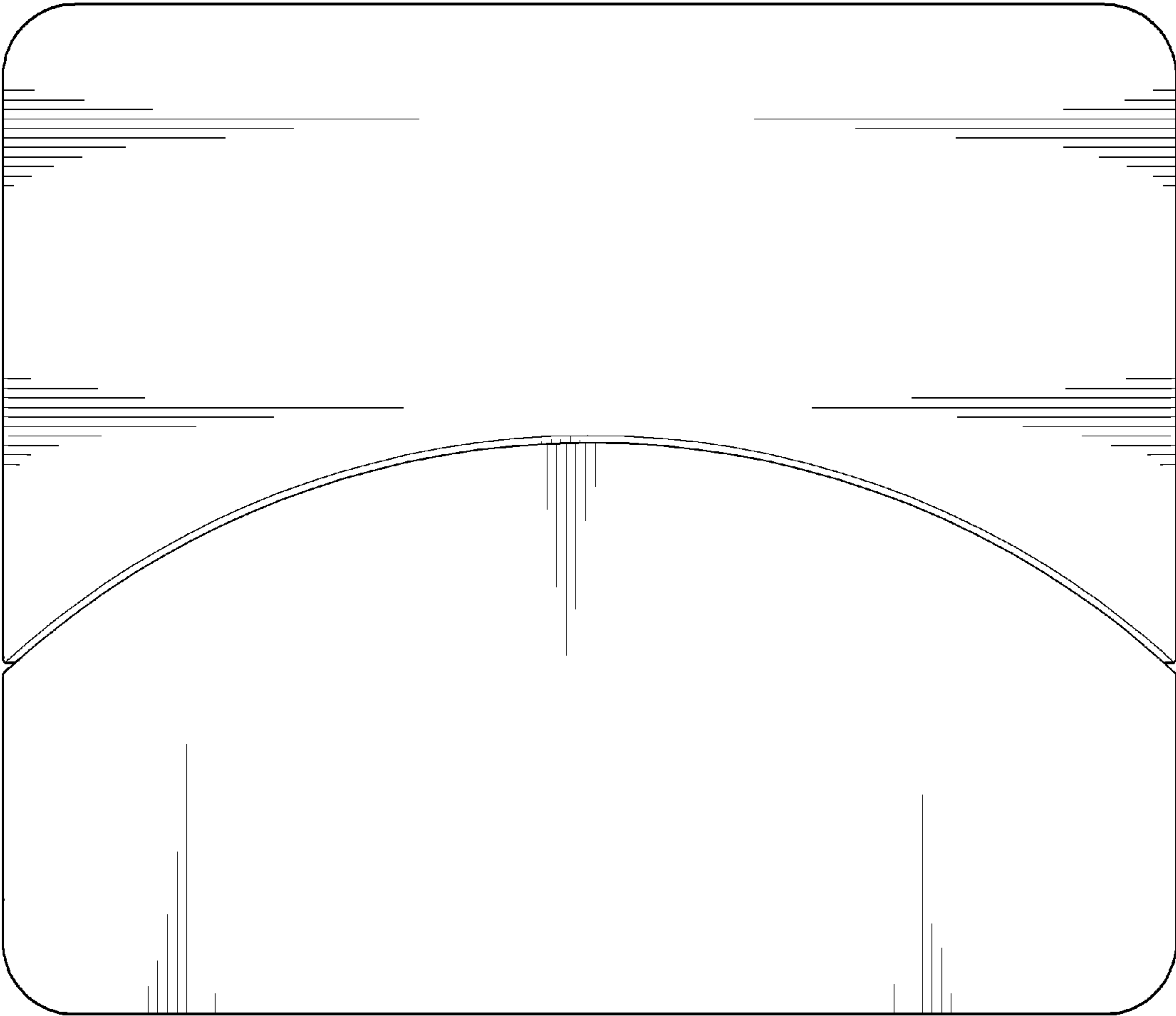

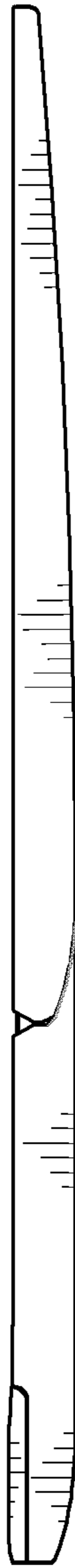

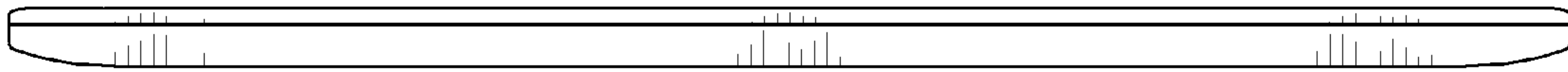
