(57) **CLAIM**

We claim the ornamental design for a crisper interior refrigerator drawer stack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a crisper interior refrigerator drawer stack showing our new design;
FIG. 2 is a front view of the crisper interior refrigerator drawer stack of FIG. 1;
FIG. 3 is a back view of the crisper interior refrigerator drawer stack of FIG. 1;
FIG. 4 is a left side view of the crisper interior refrigerator drawer stack of FIG. 1;
FIG. 5 is a right side view of the crisper interior refrigerator drawer stack of FIG. 1;
FIG. 6 is a top view of the crisper interior refrigerator drawer stack of FIG. 1; and,

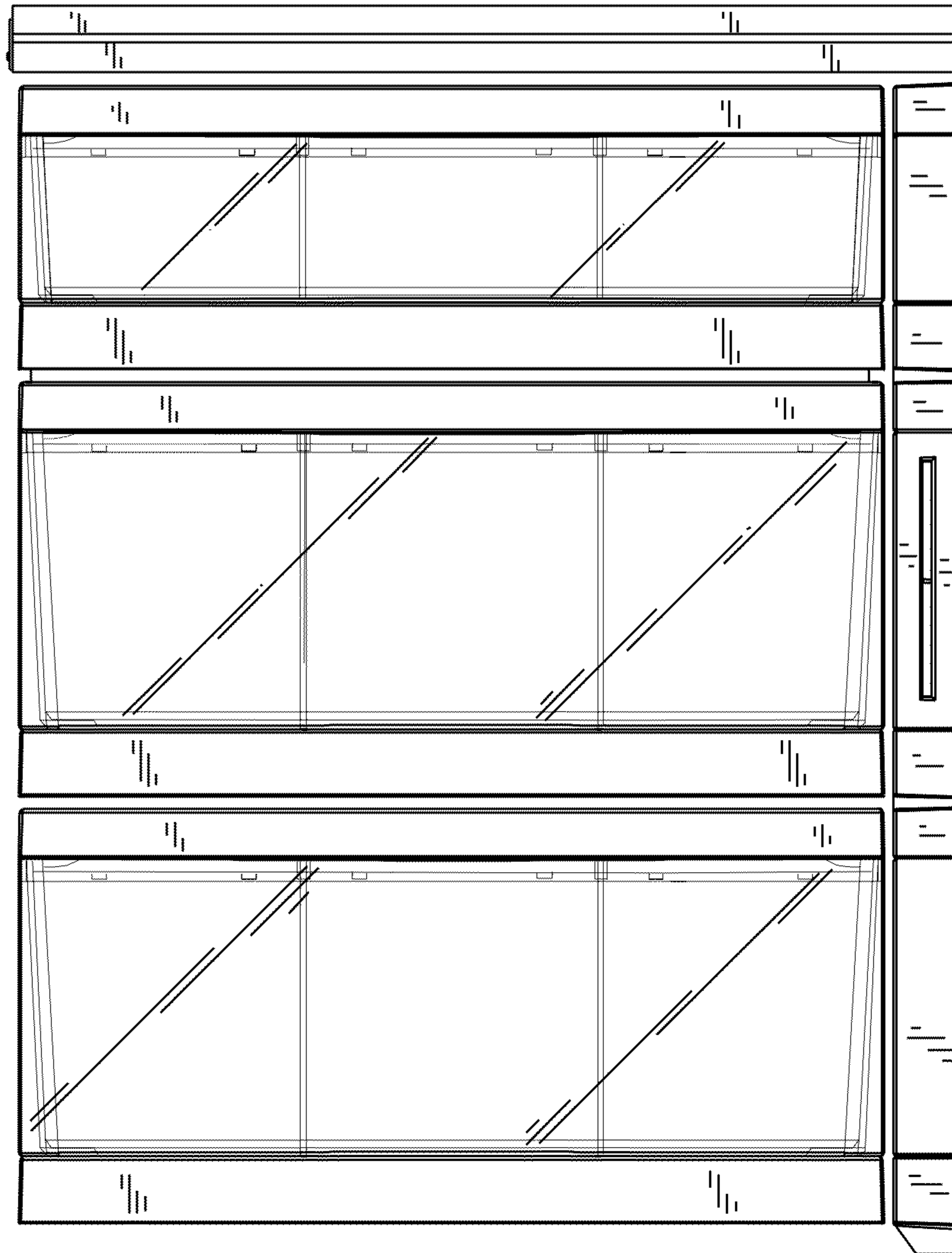

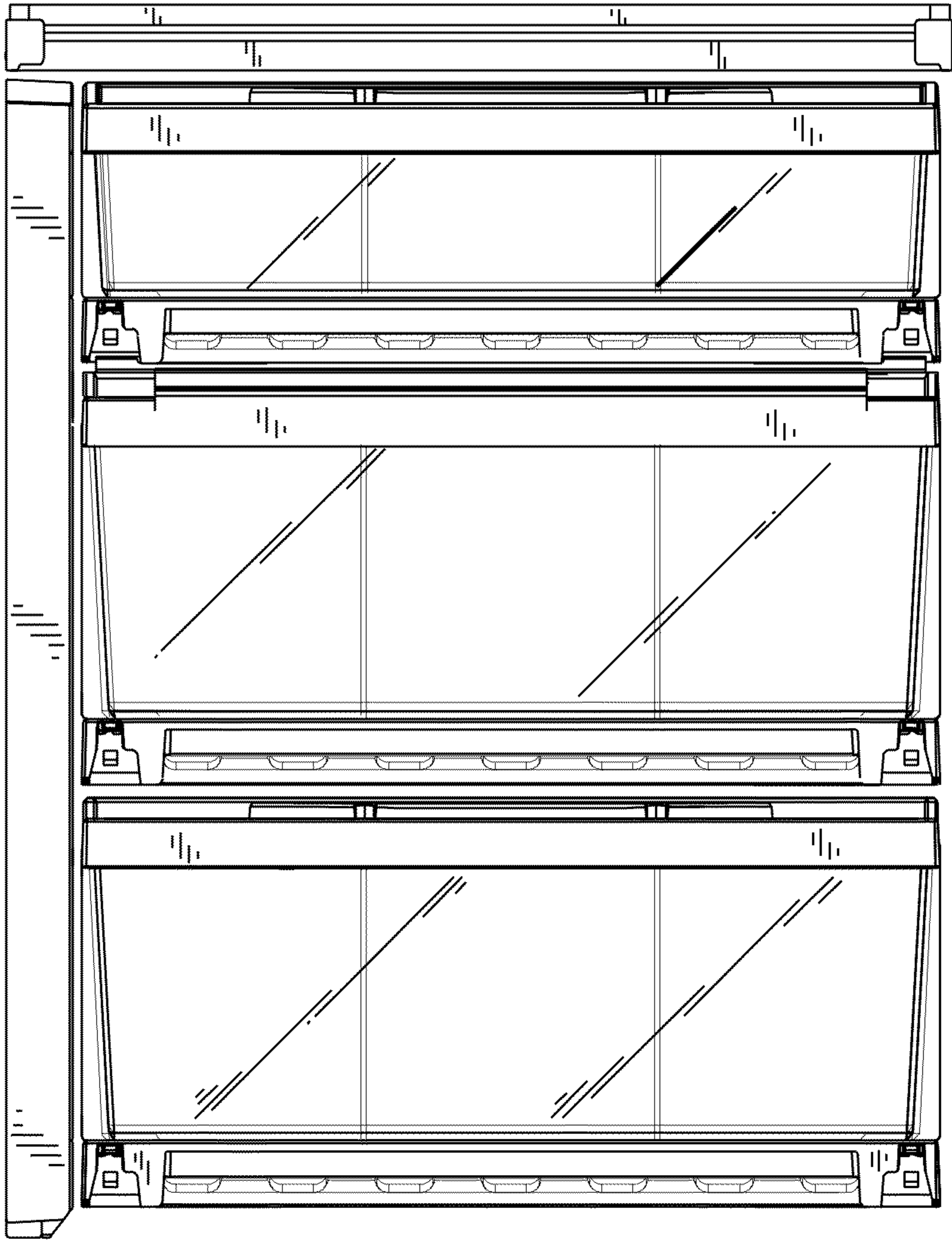

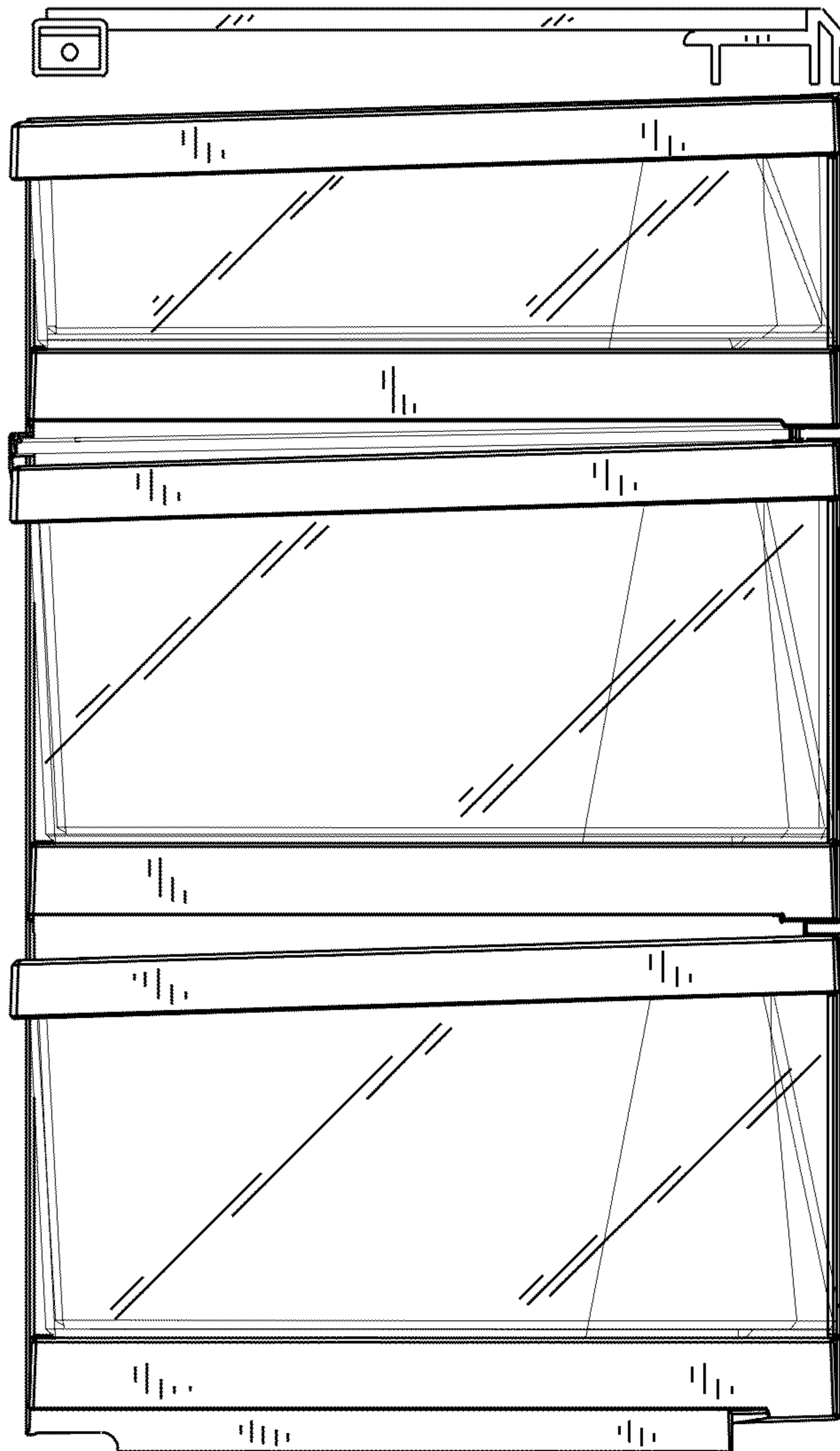

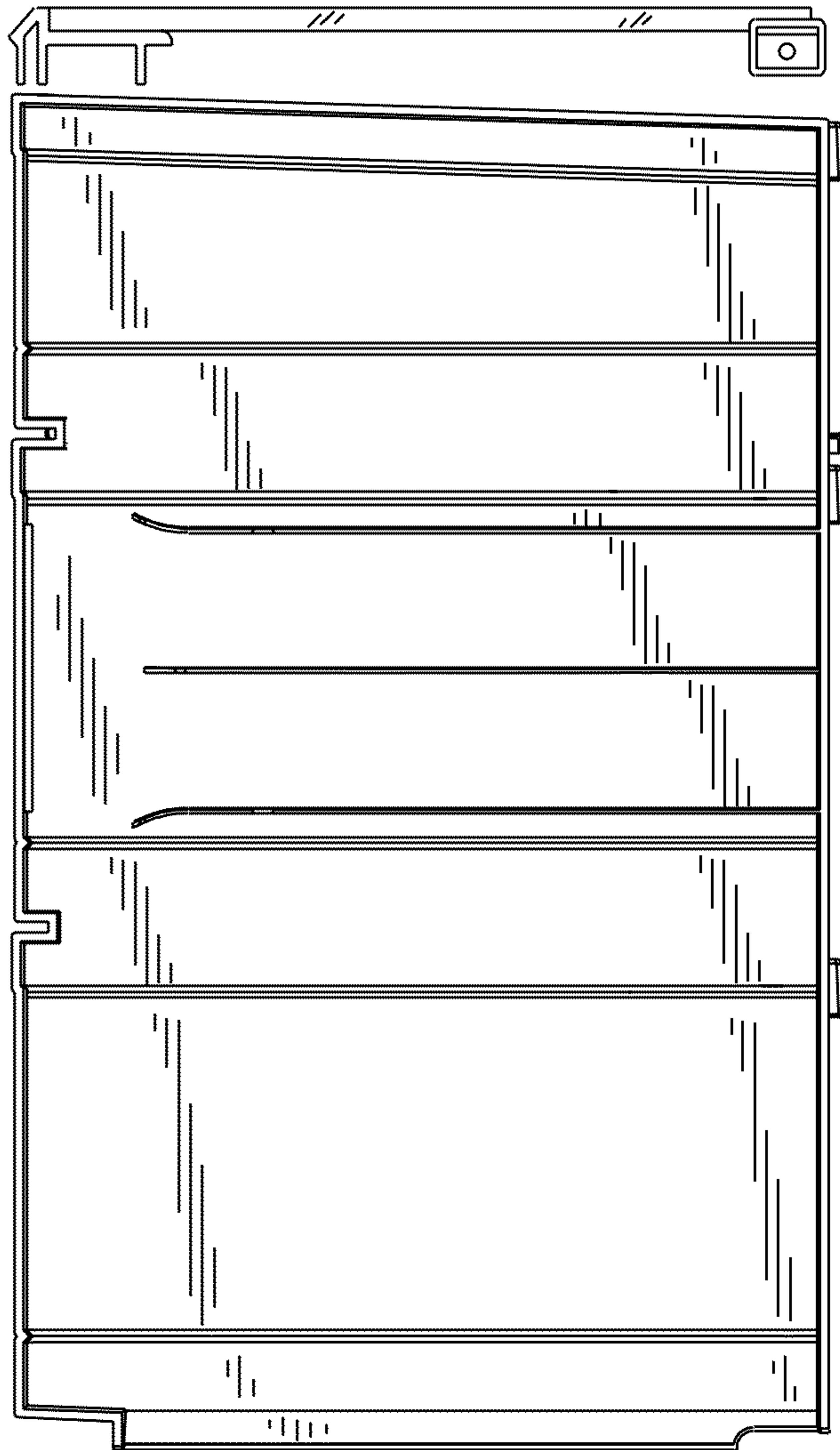

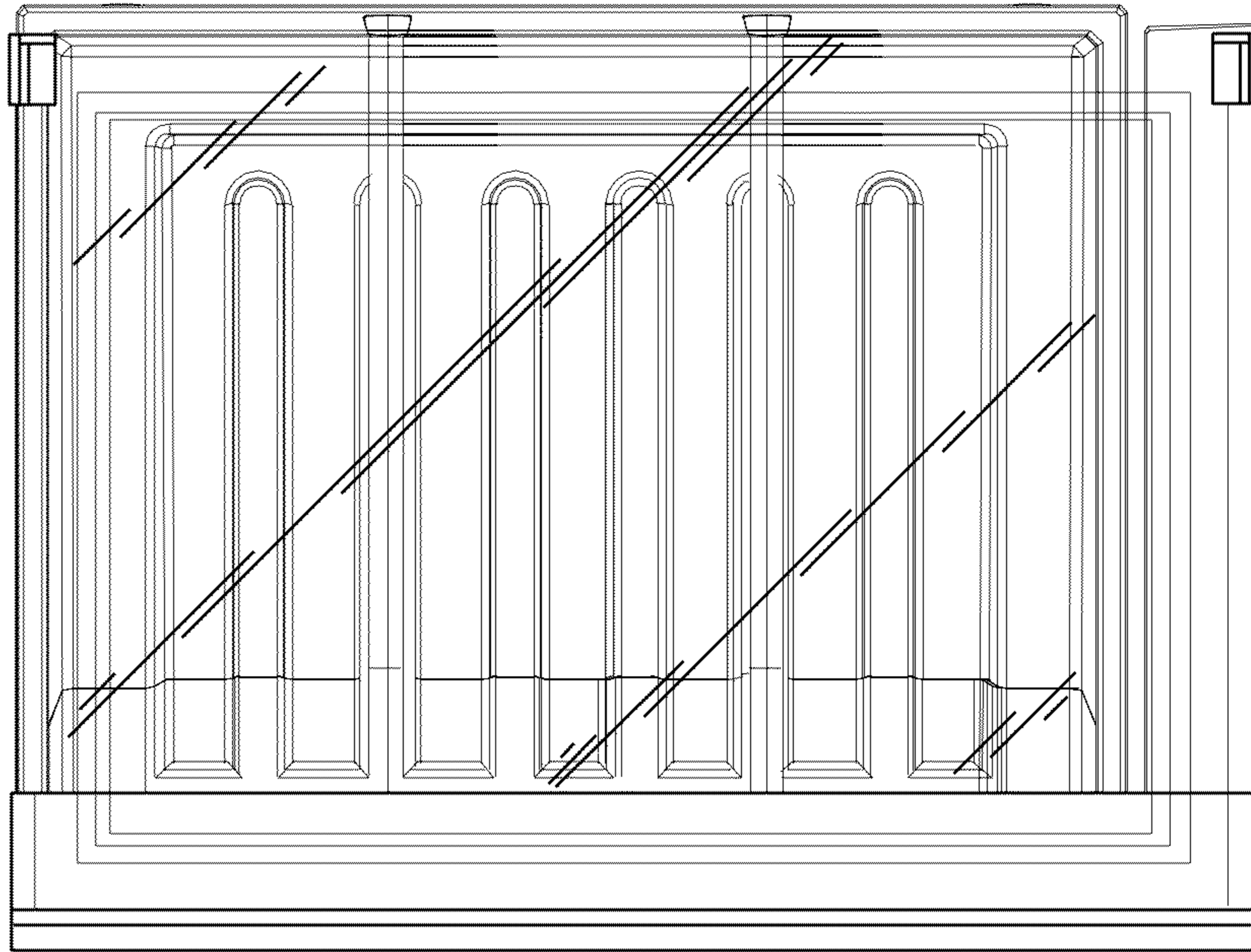

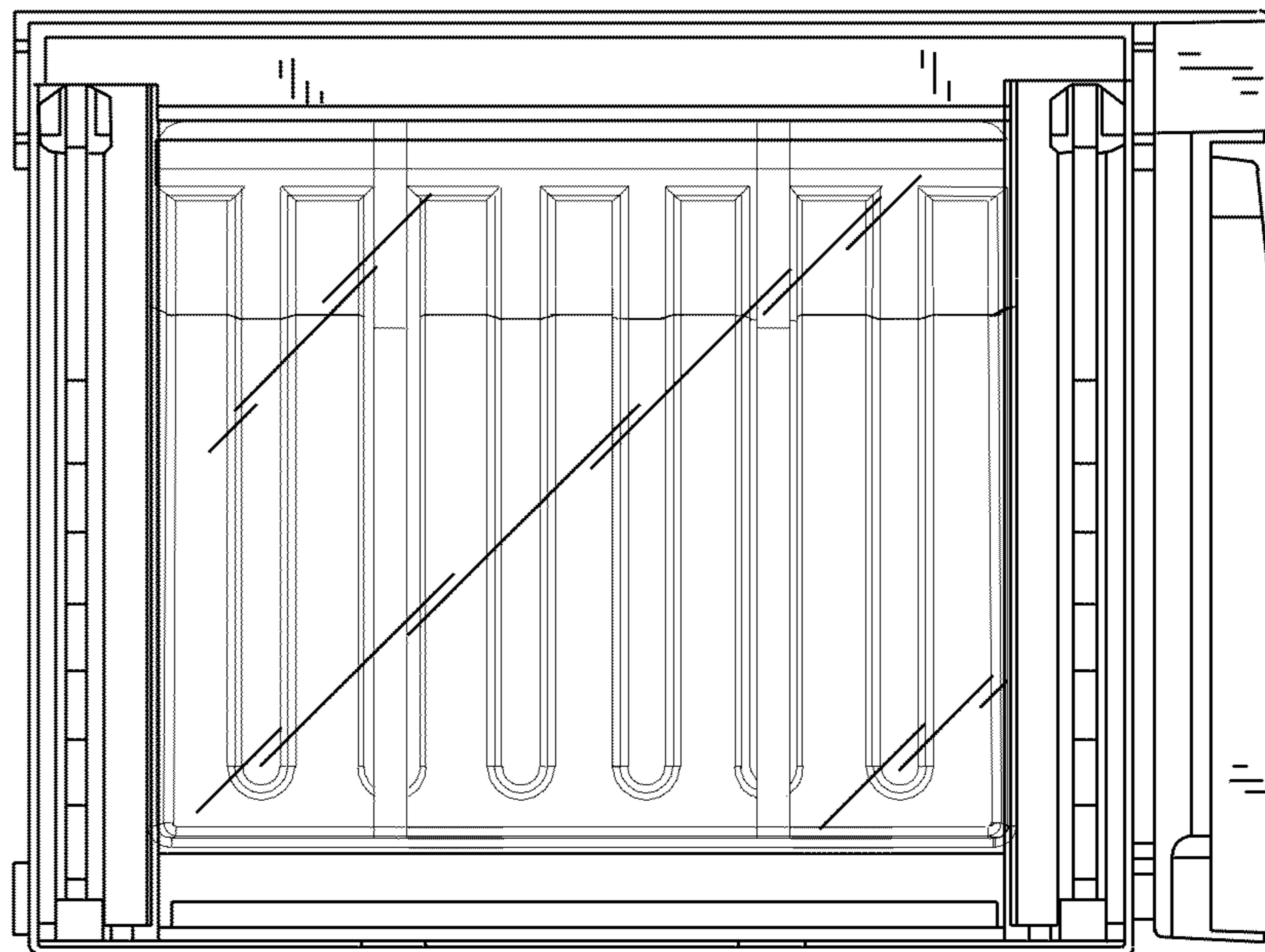
