DESCRIPTION

FIG. 1 is a front elevation of a scaler tip;

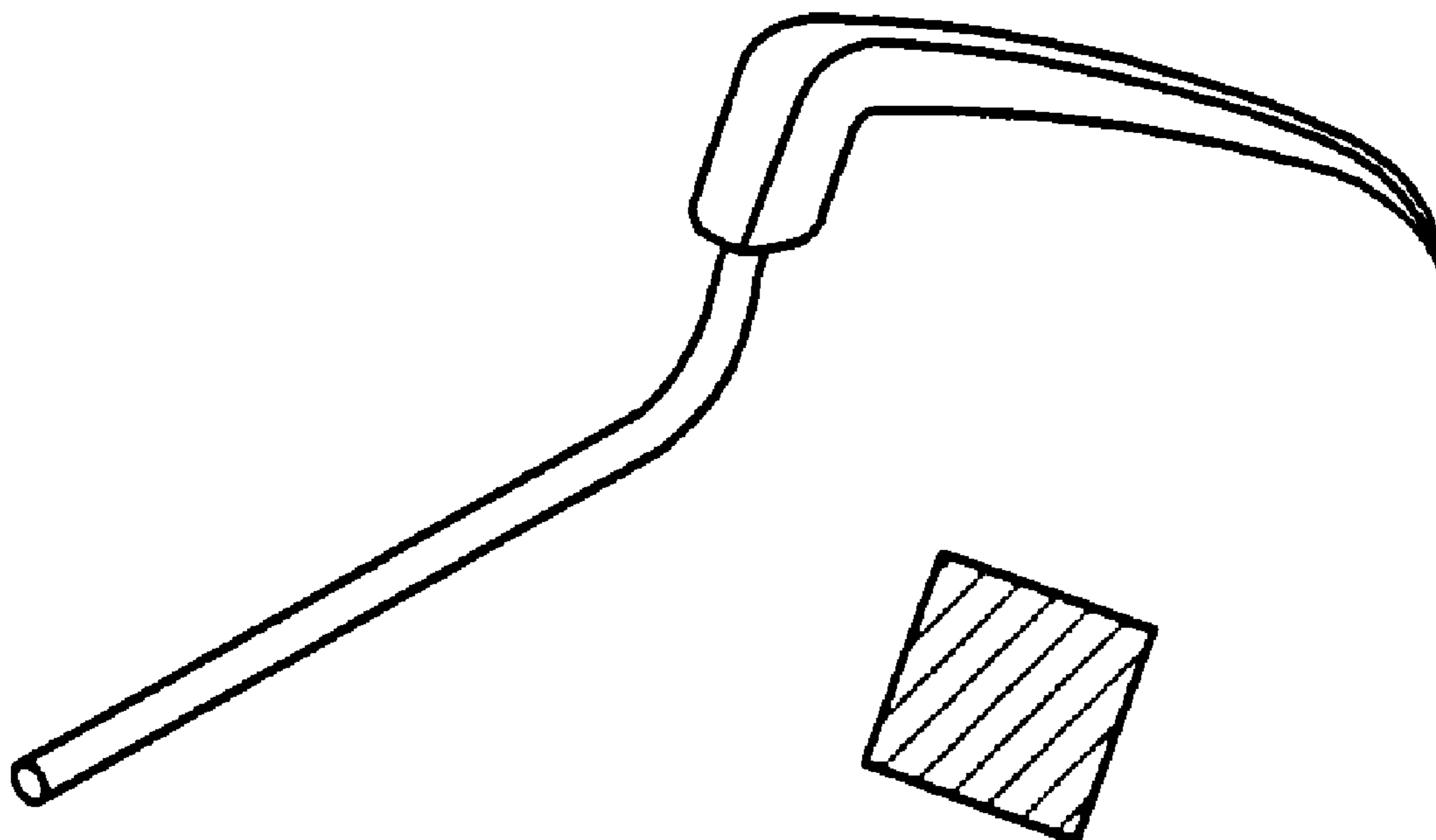

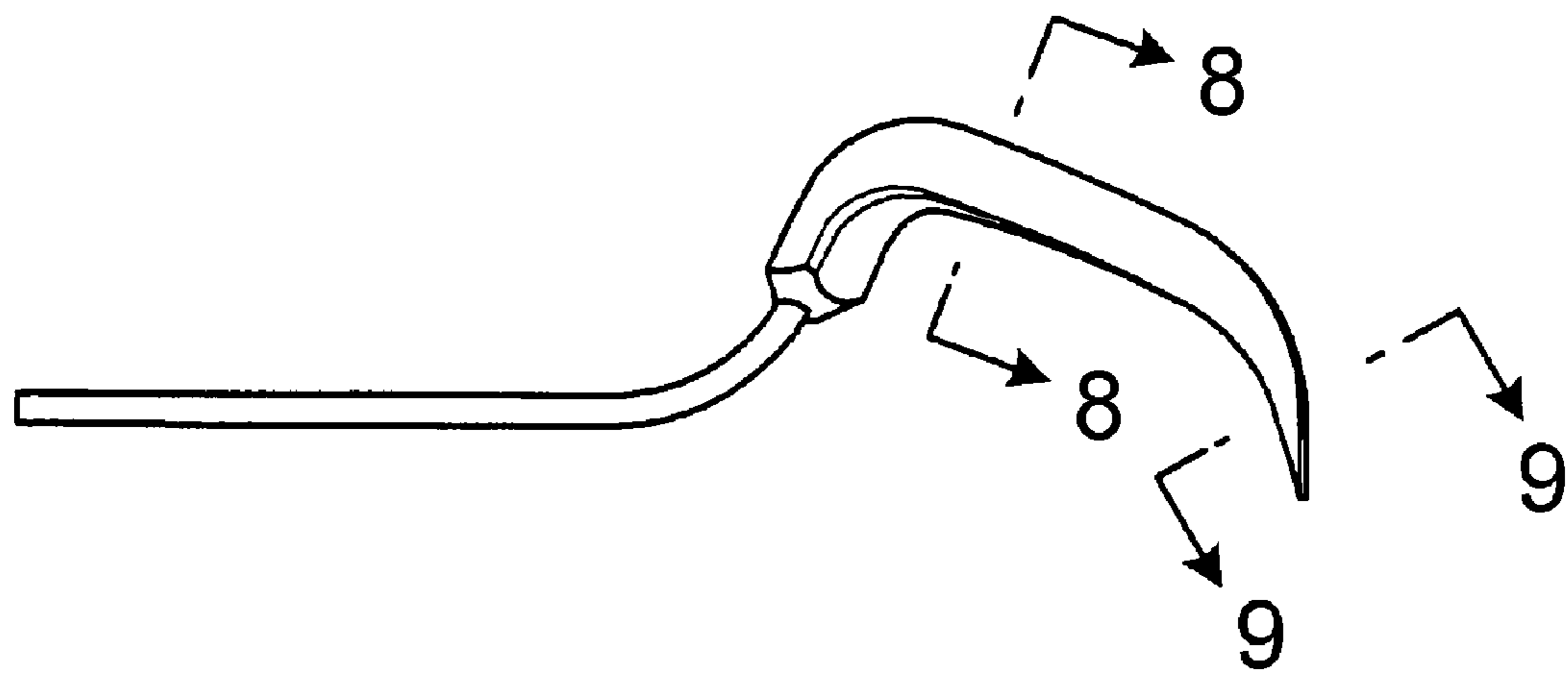

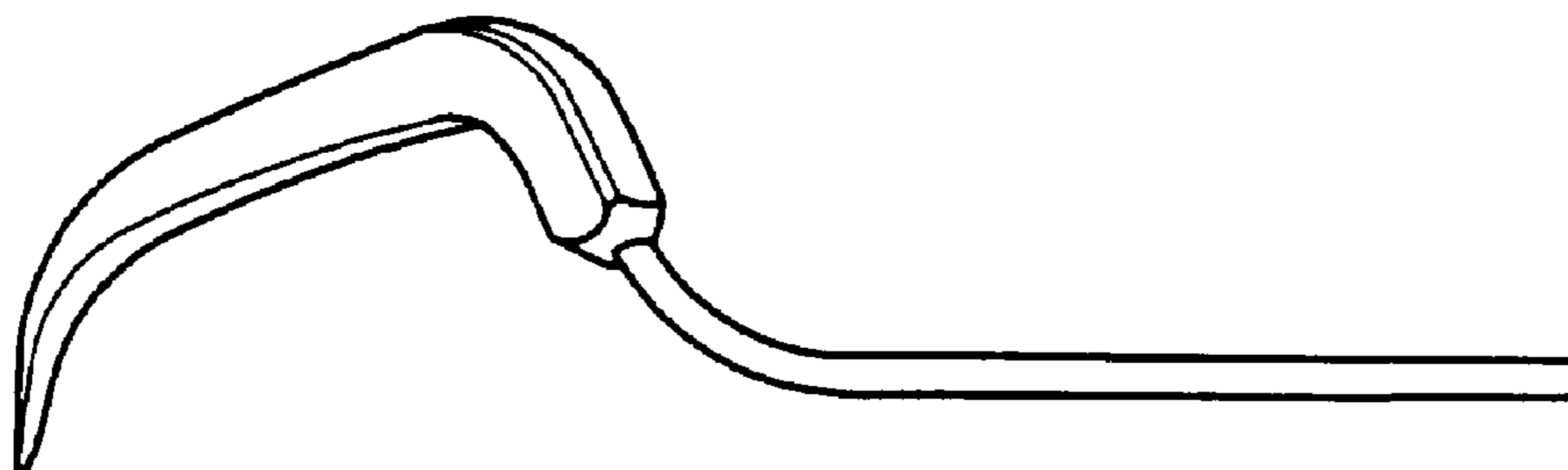

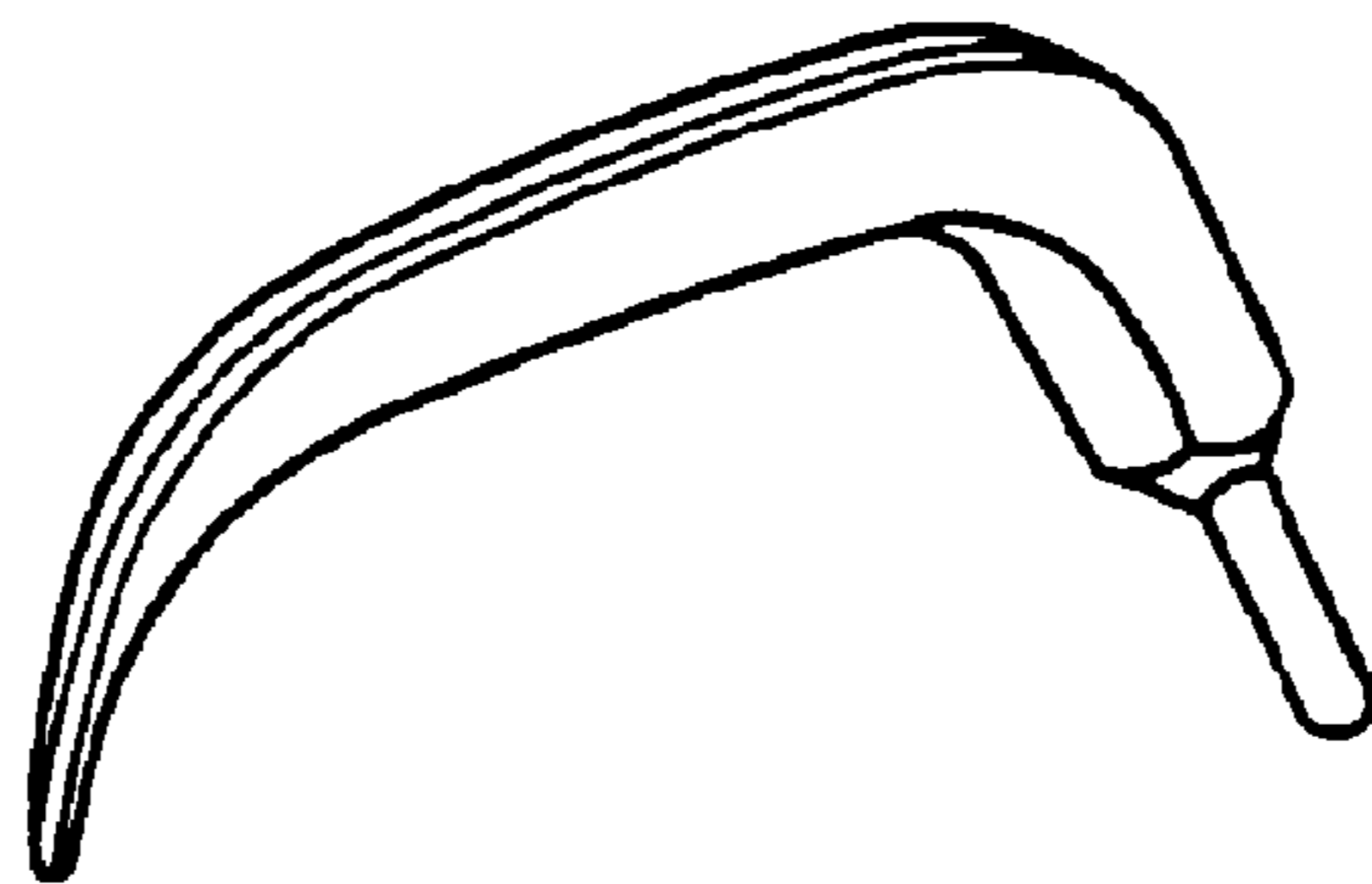

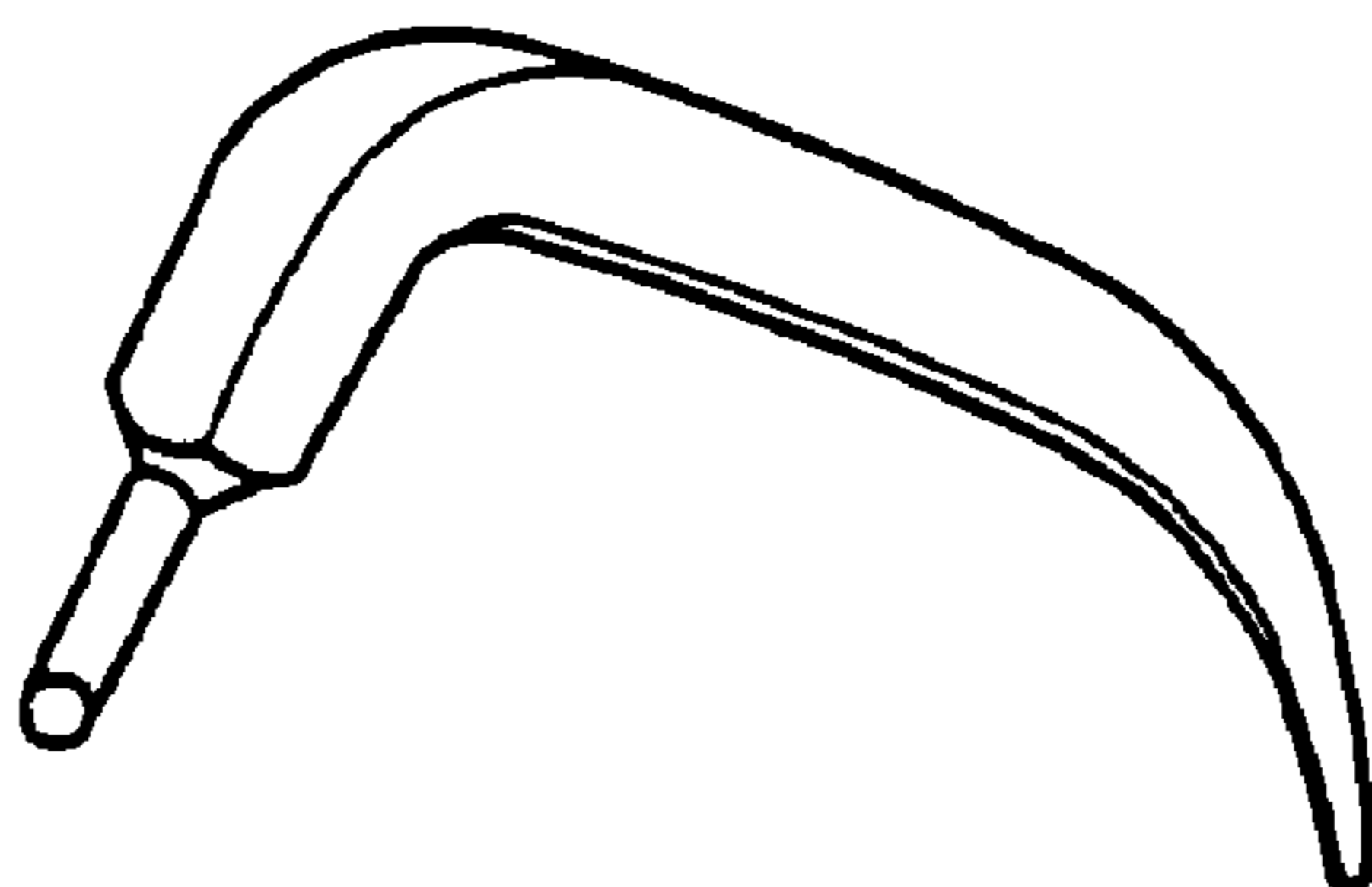

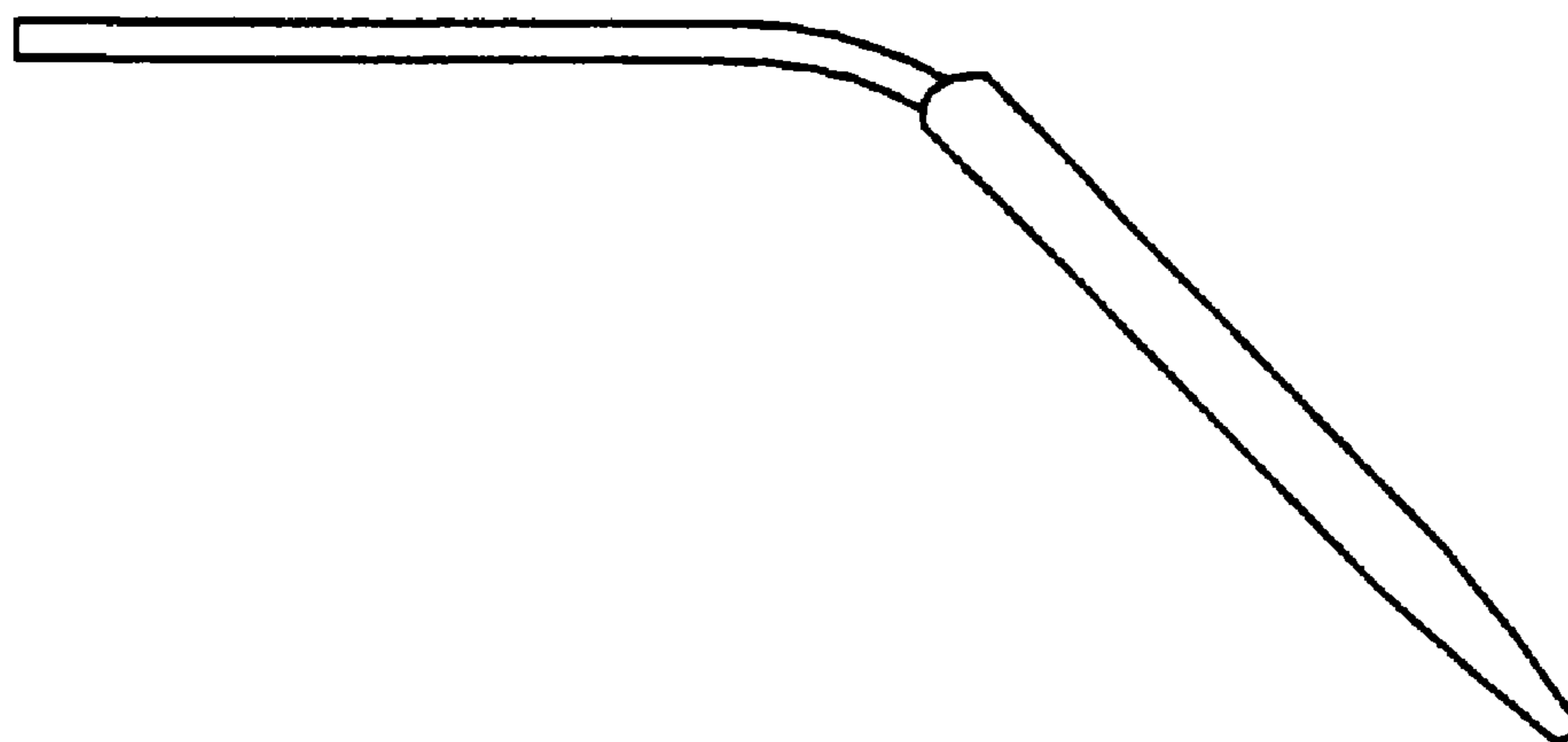

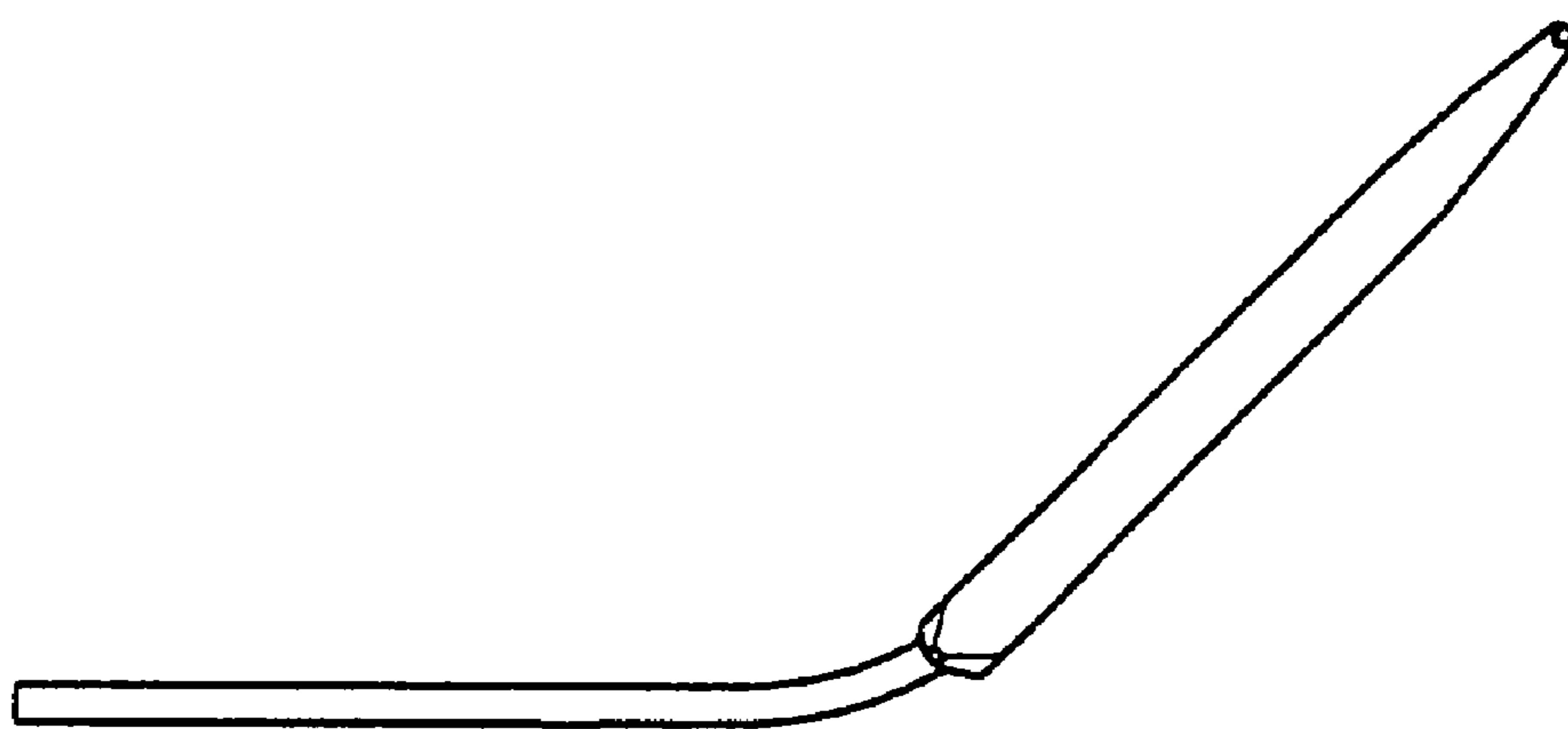

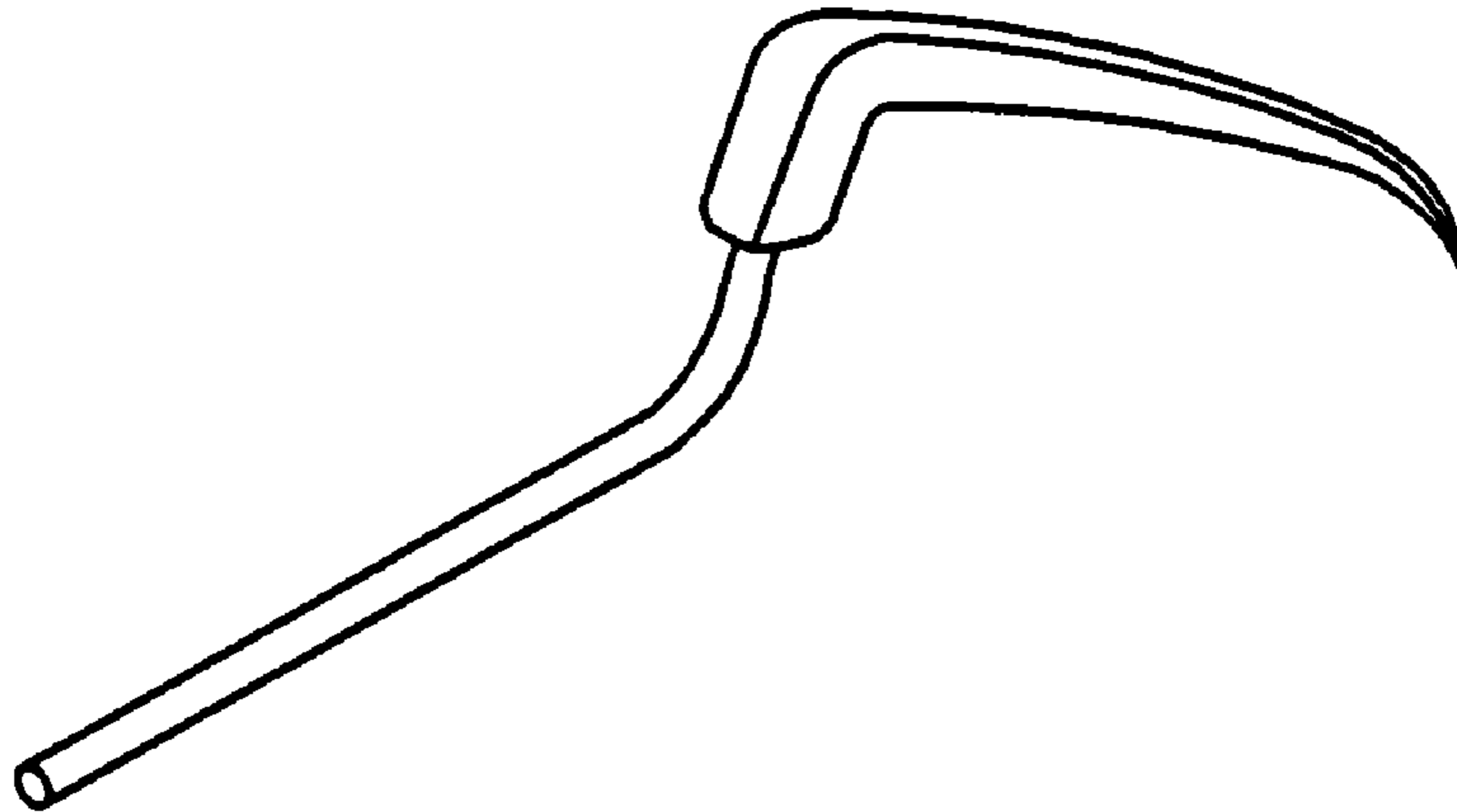

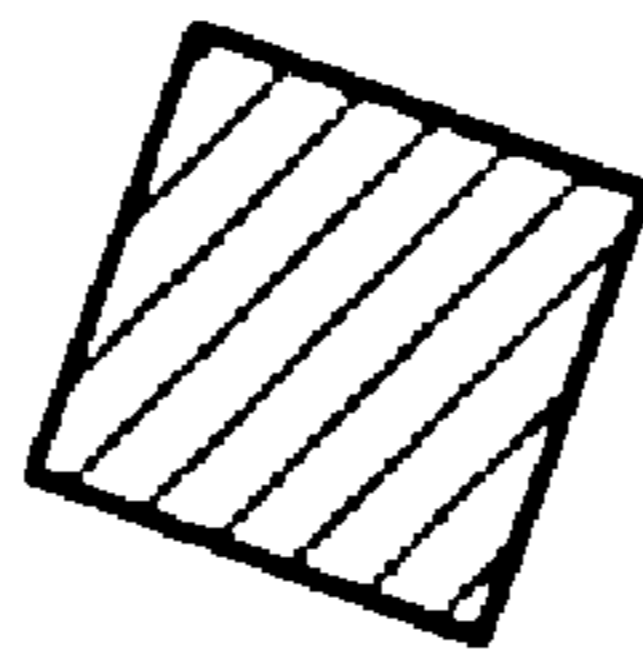
