FIG. 4 is a second, opposite side elevation view of the embodiment of the chair as shown in FIG. 1.

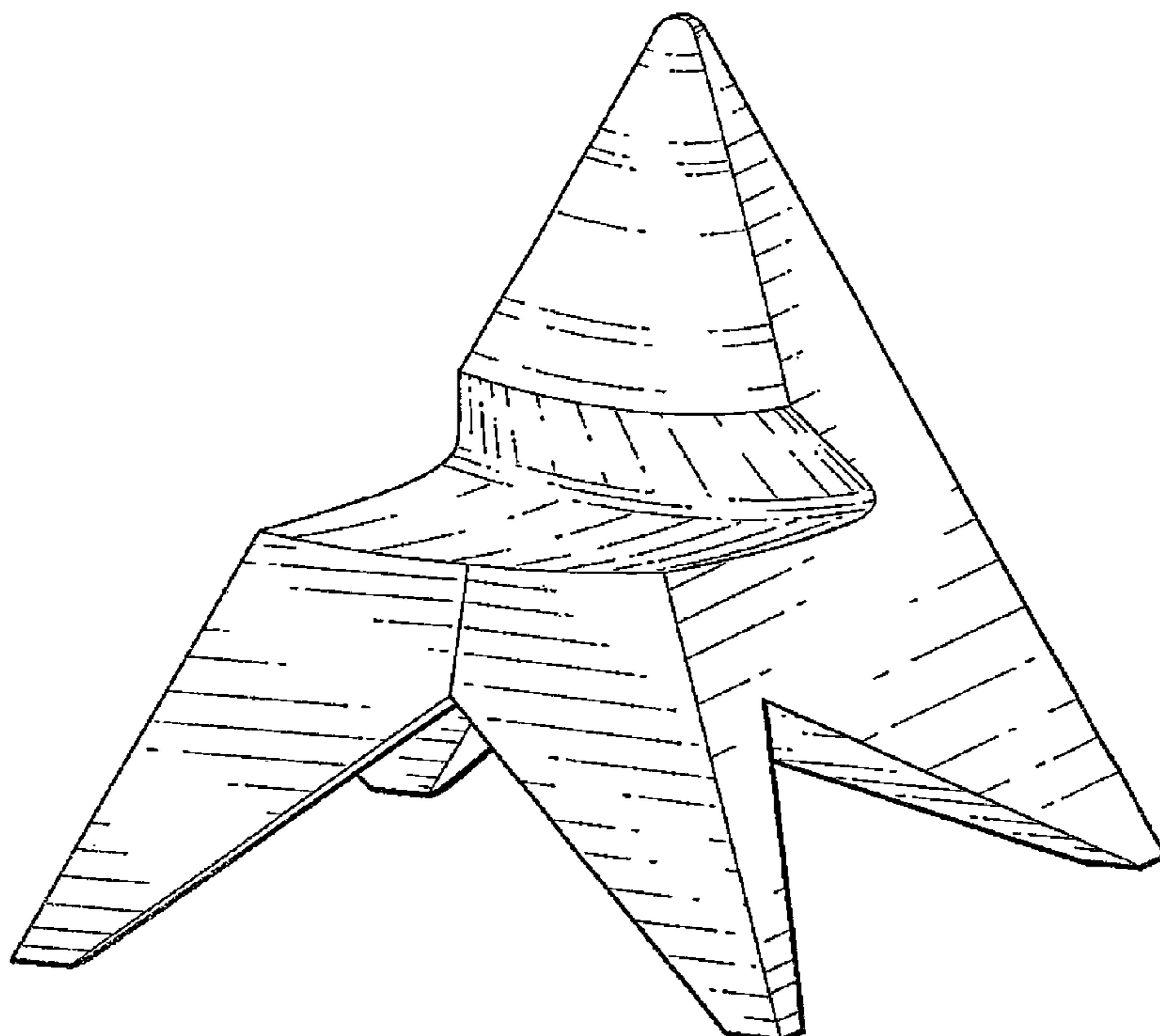
FIG. 5 is a front elevation view of the embodiment of the chair as shown in FIG. 1.

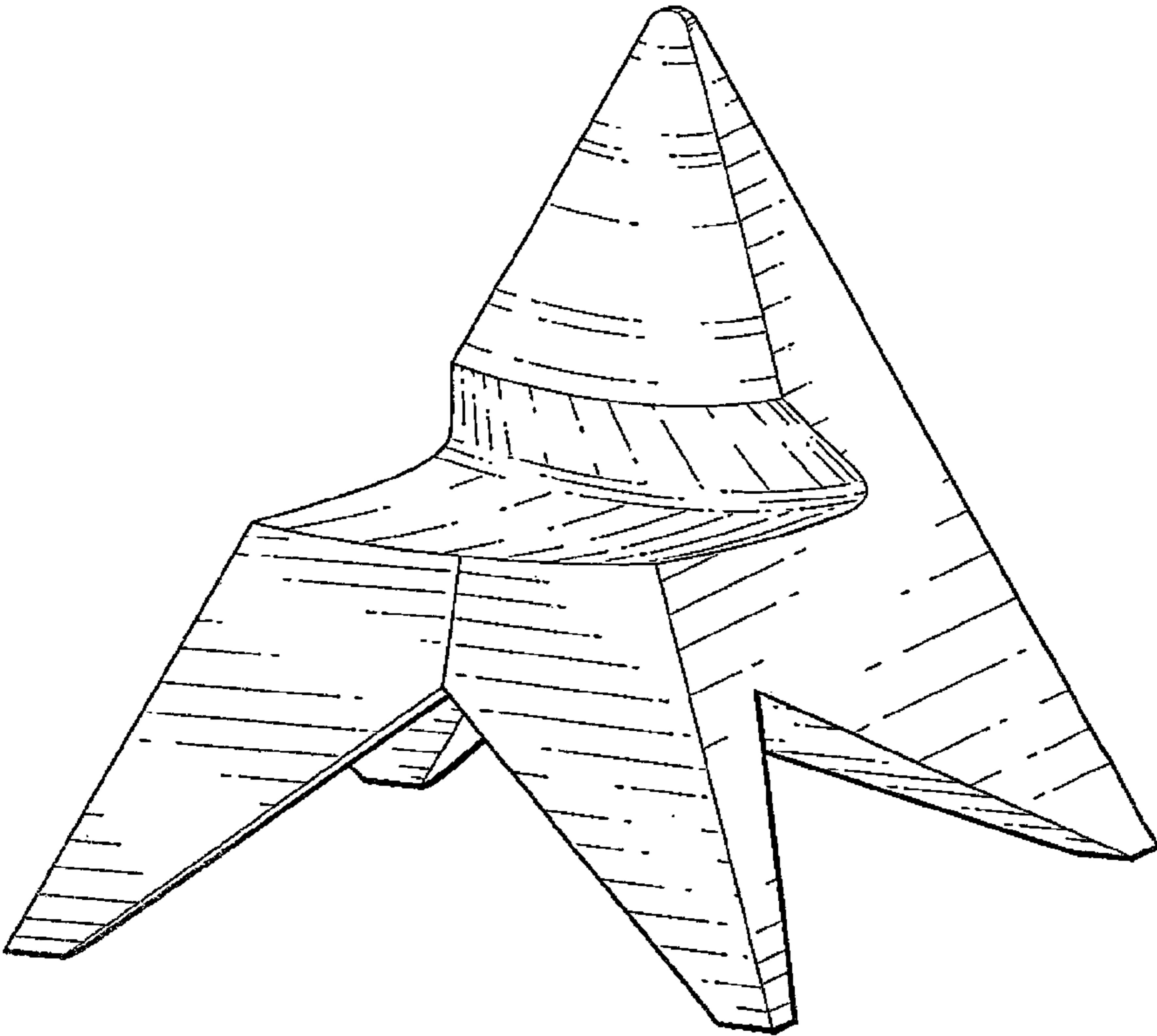
FIG. 6 is a top plain view of the embodiment of the chair as shown in FIG. 1.

FIG. 7 is a rear elevation view of the embodiment of the chair as shown in FIG. 1; and,

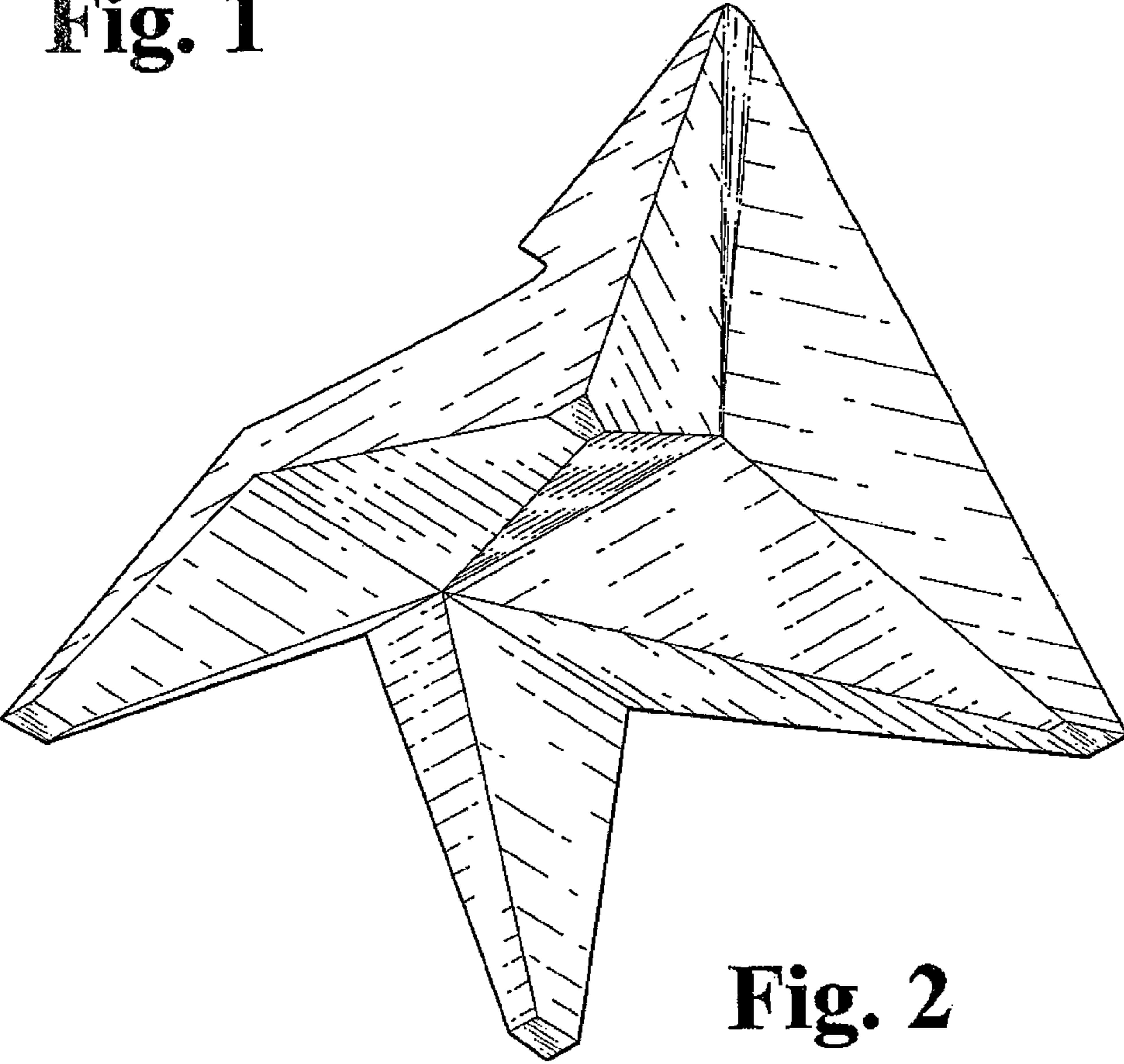
FIG. 8 is a bottom plan view of the embodiment of the chair as shown in FIG. 1.

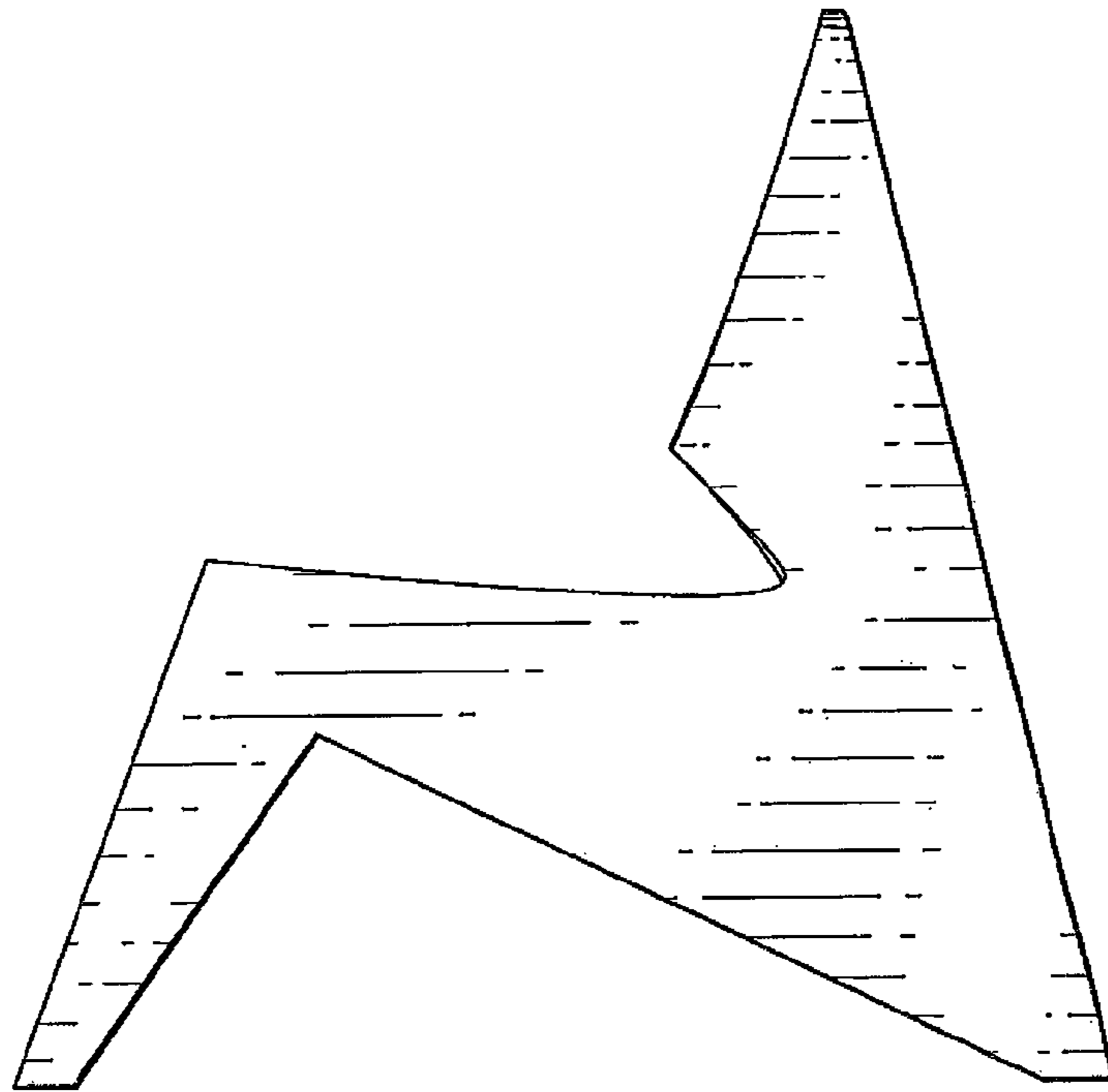




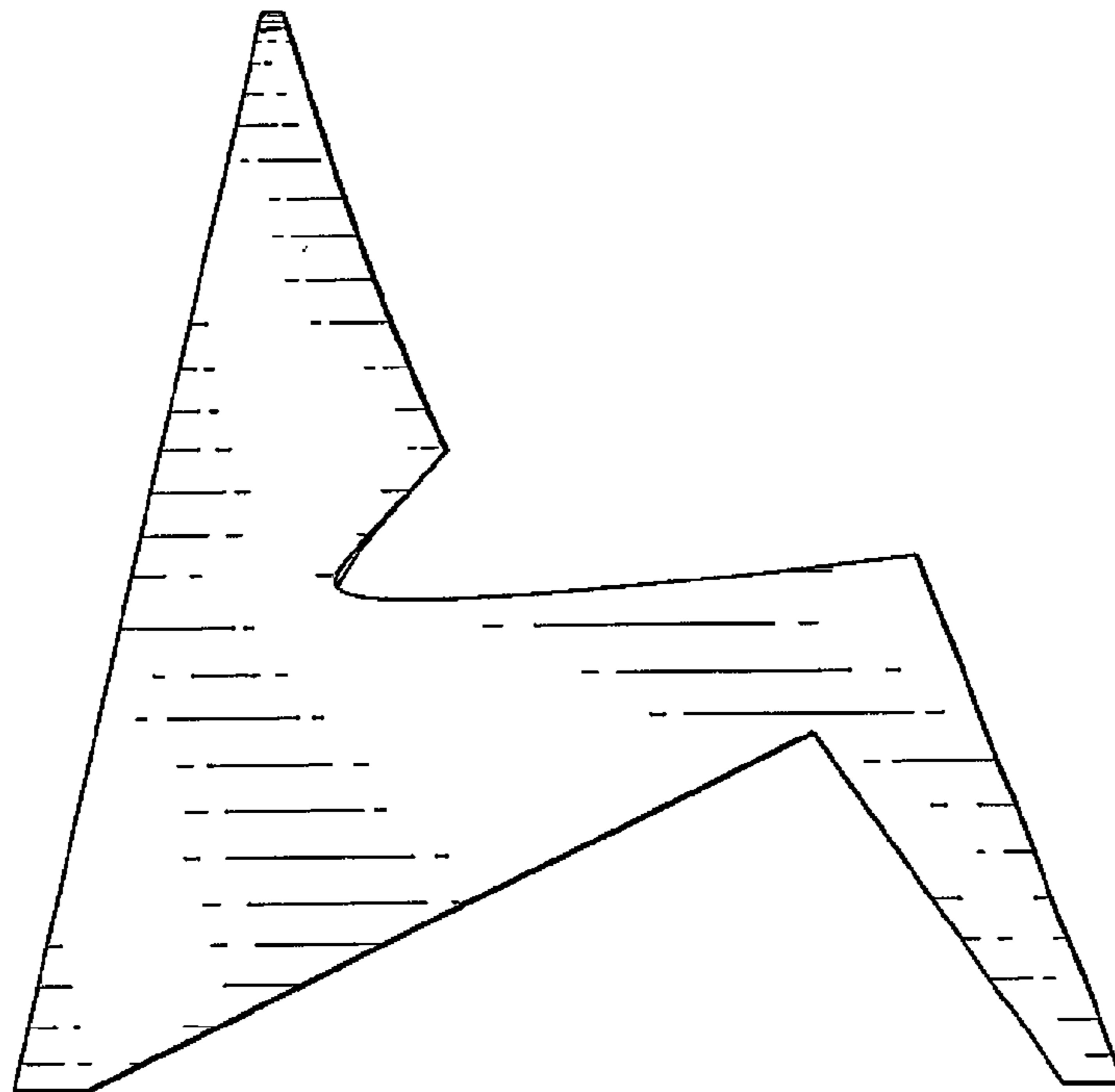

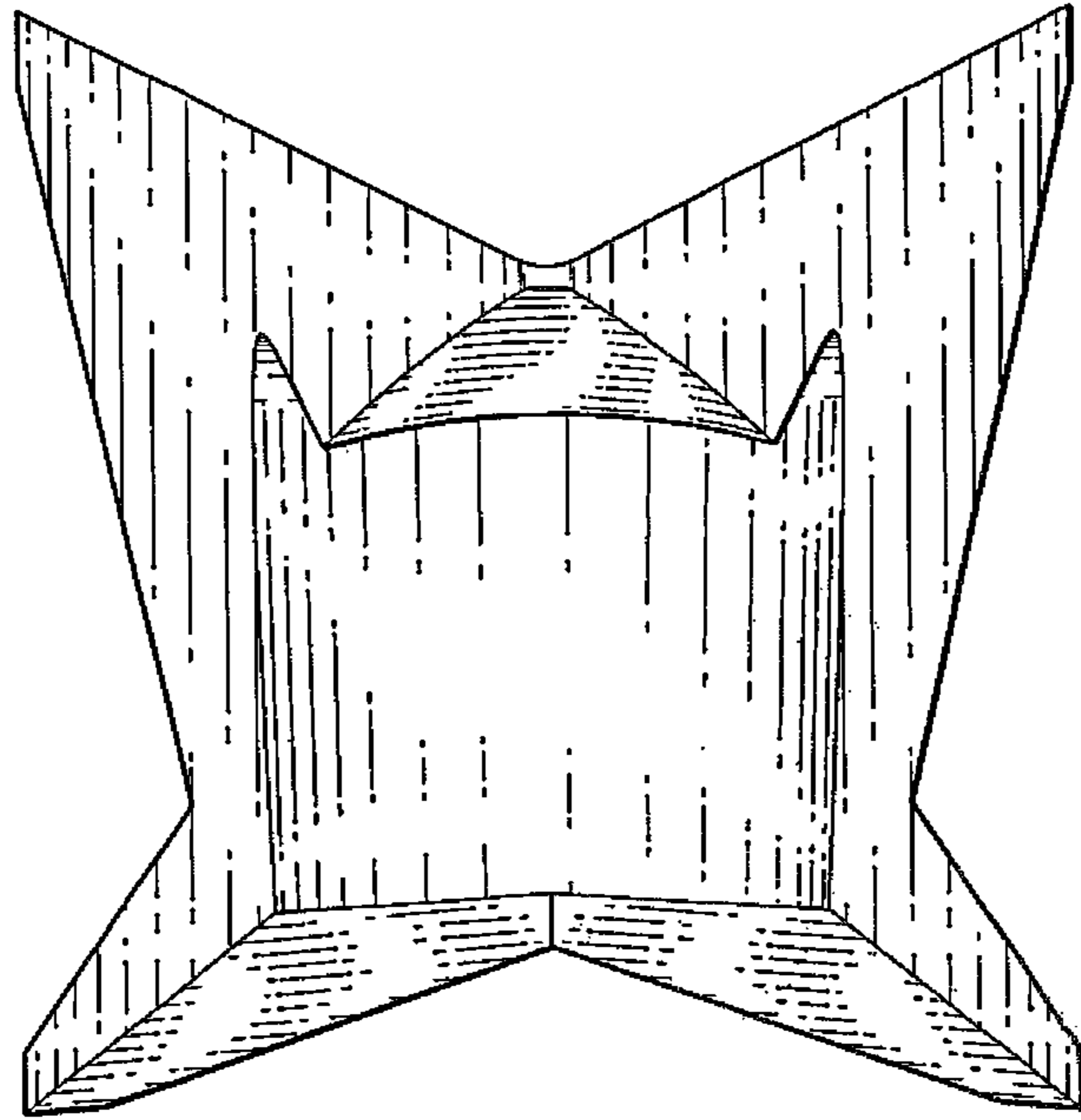

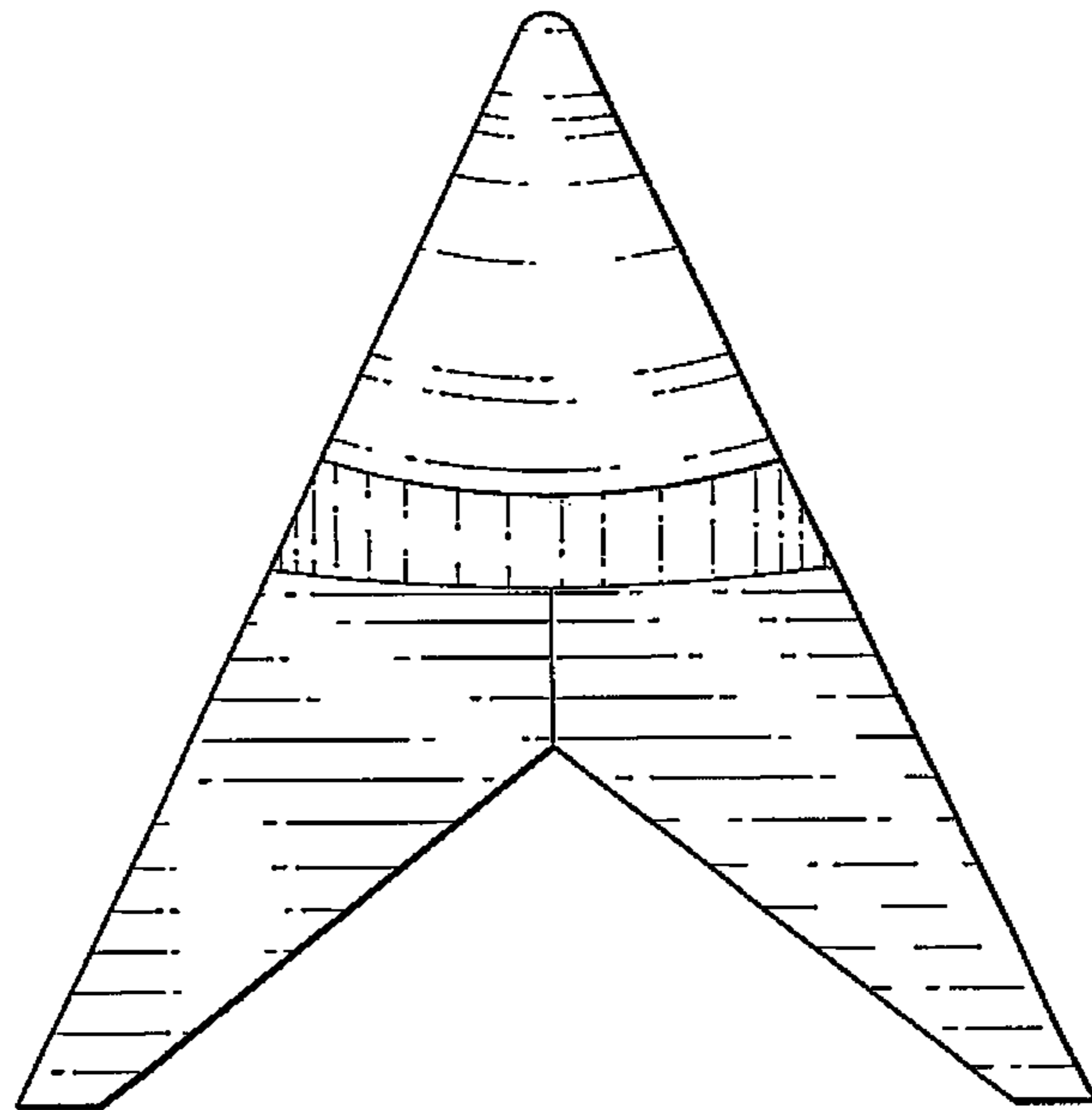

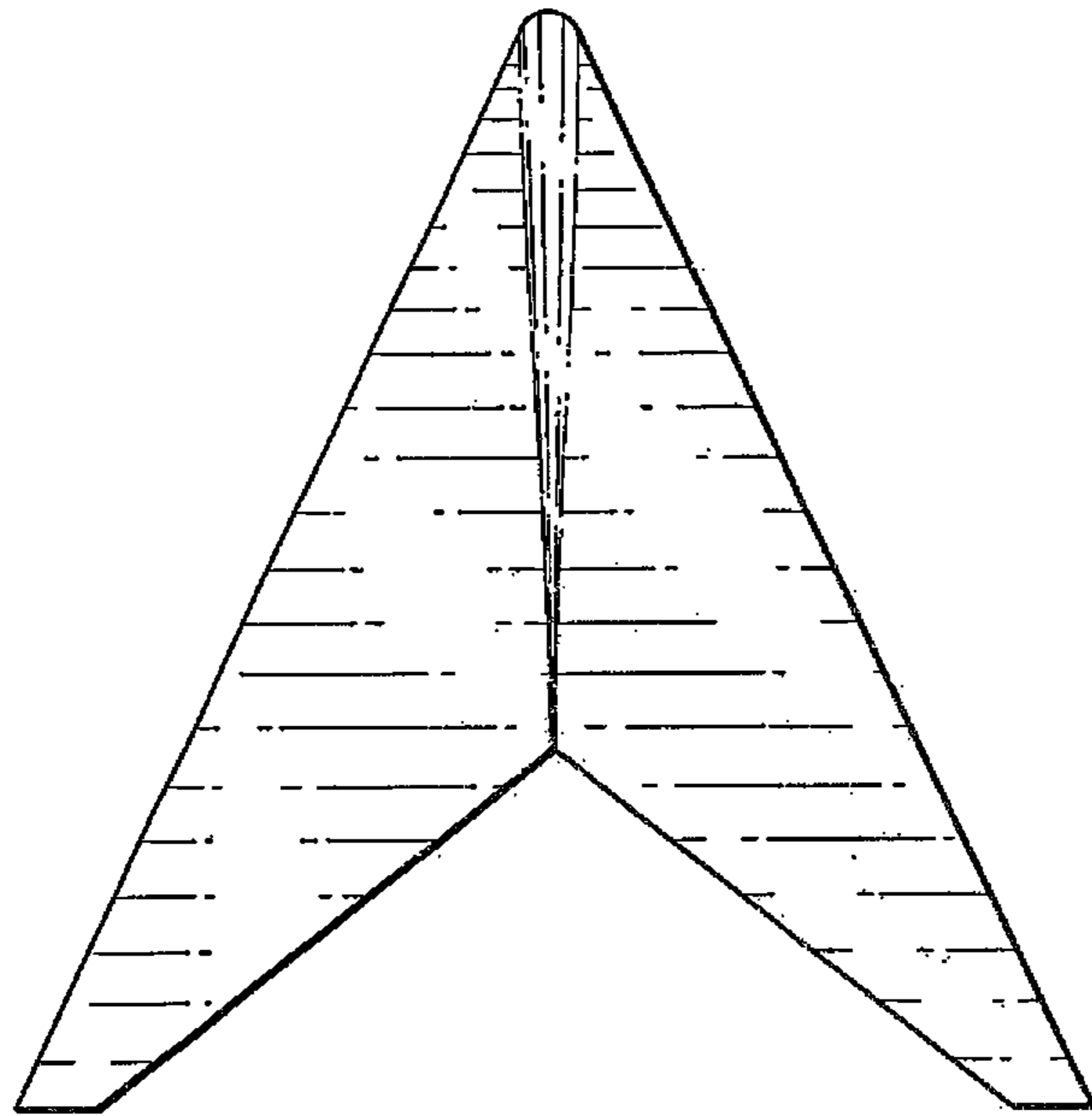

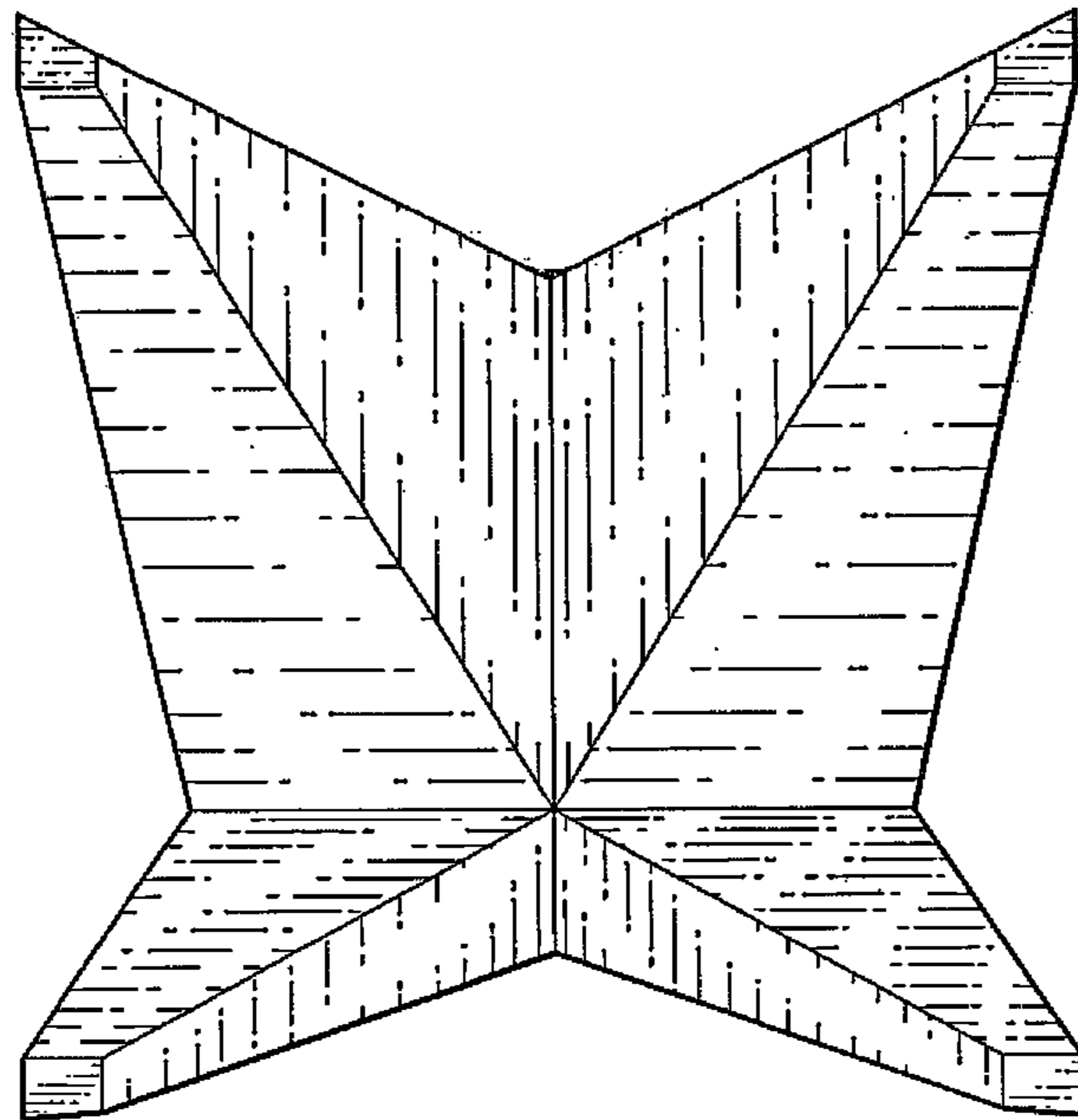
