DESCRIPTION

FIG. 1 is a perspective view of a coat rack showing our new design;

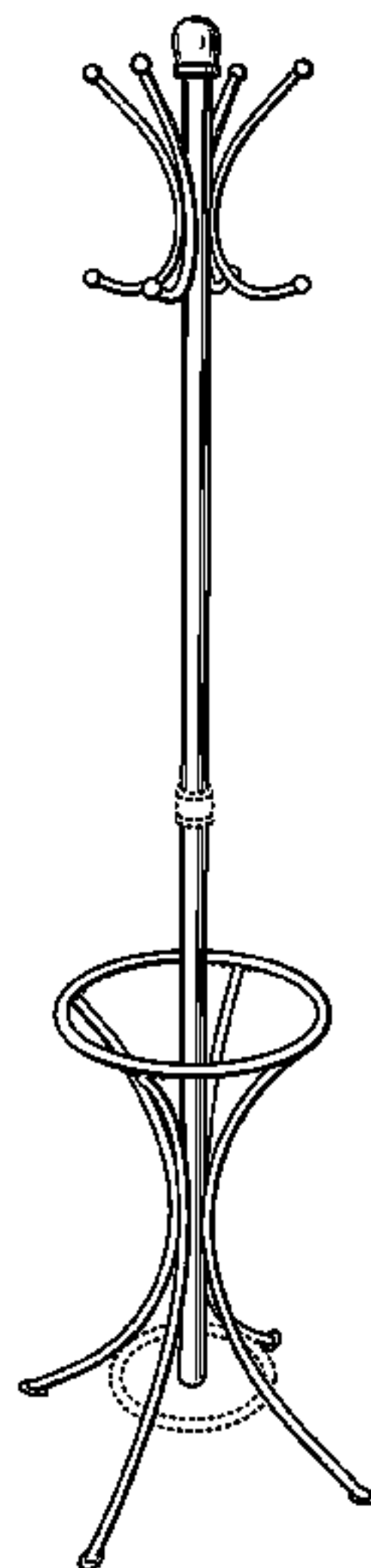
FIG. 2 is a front view thereof, the back, the right side and the left side being identical;

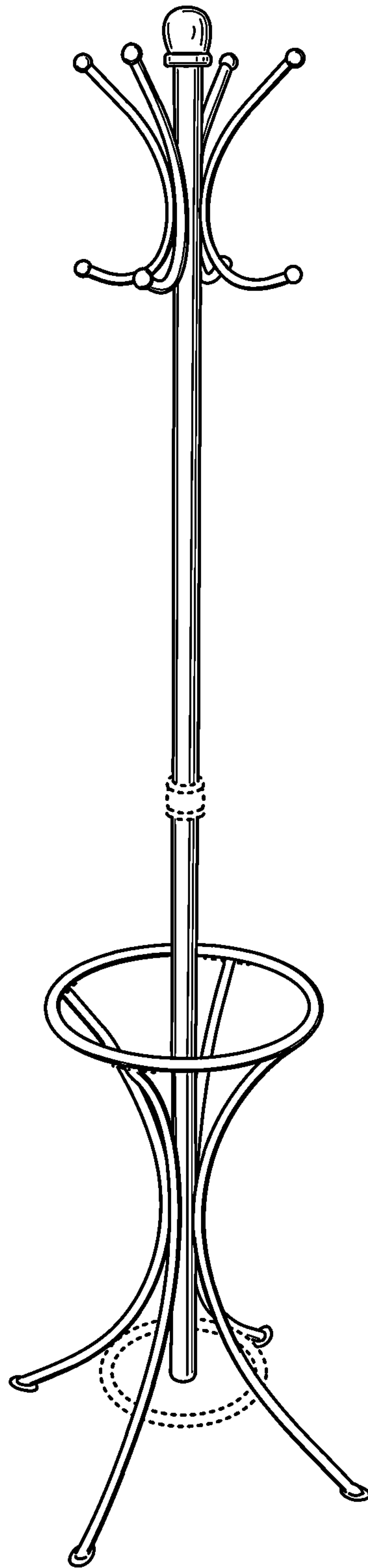

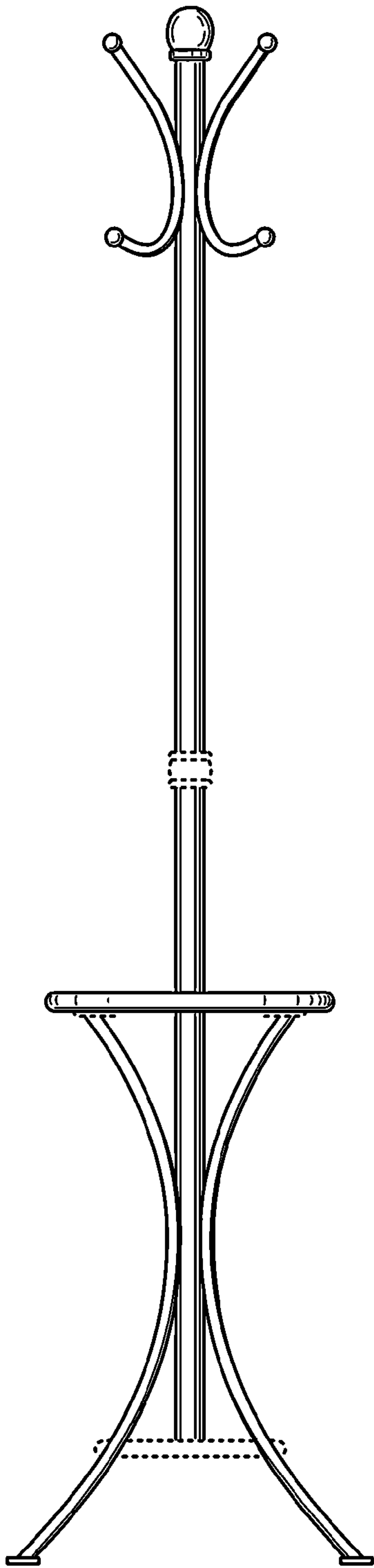

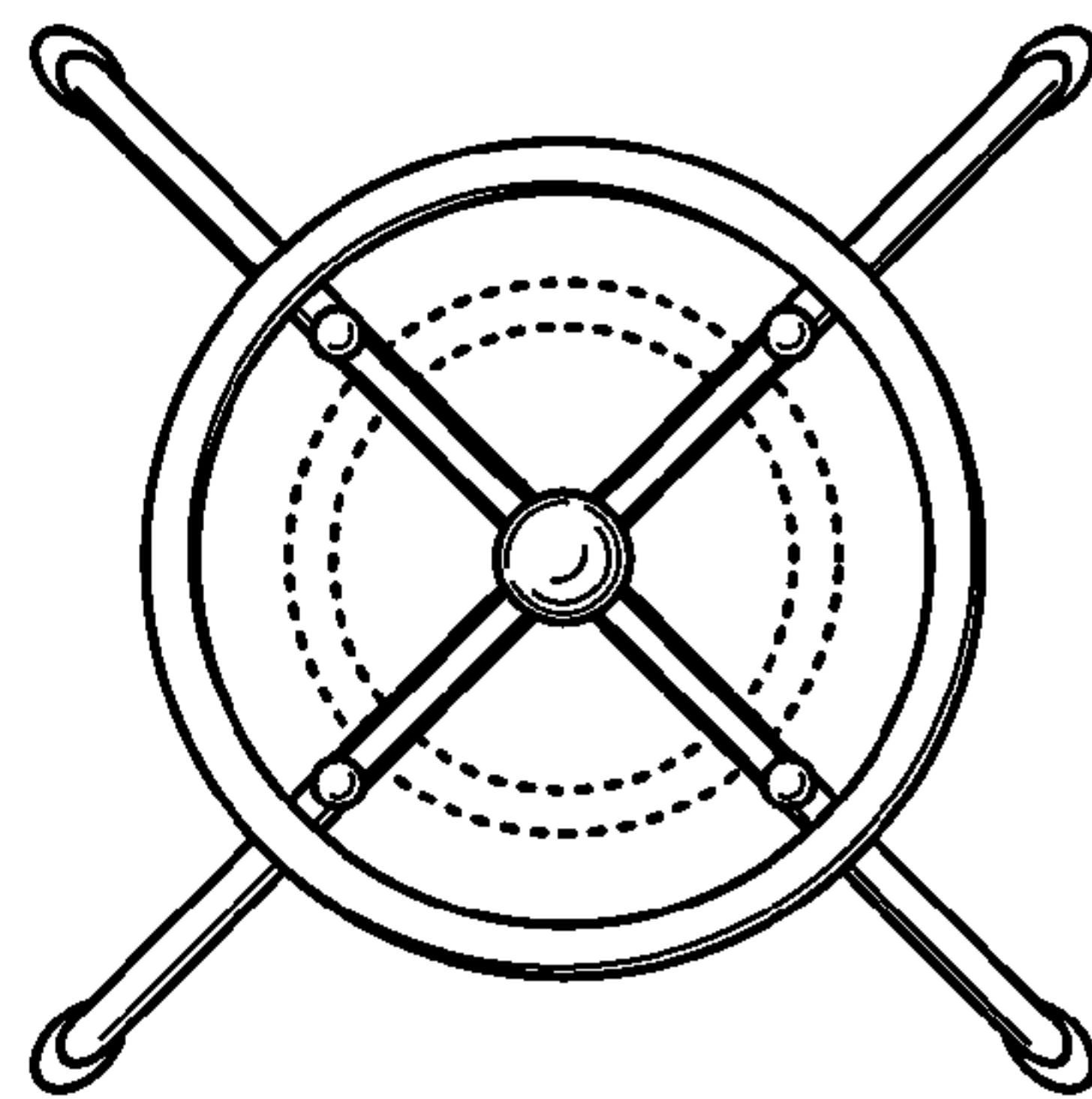

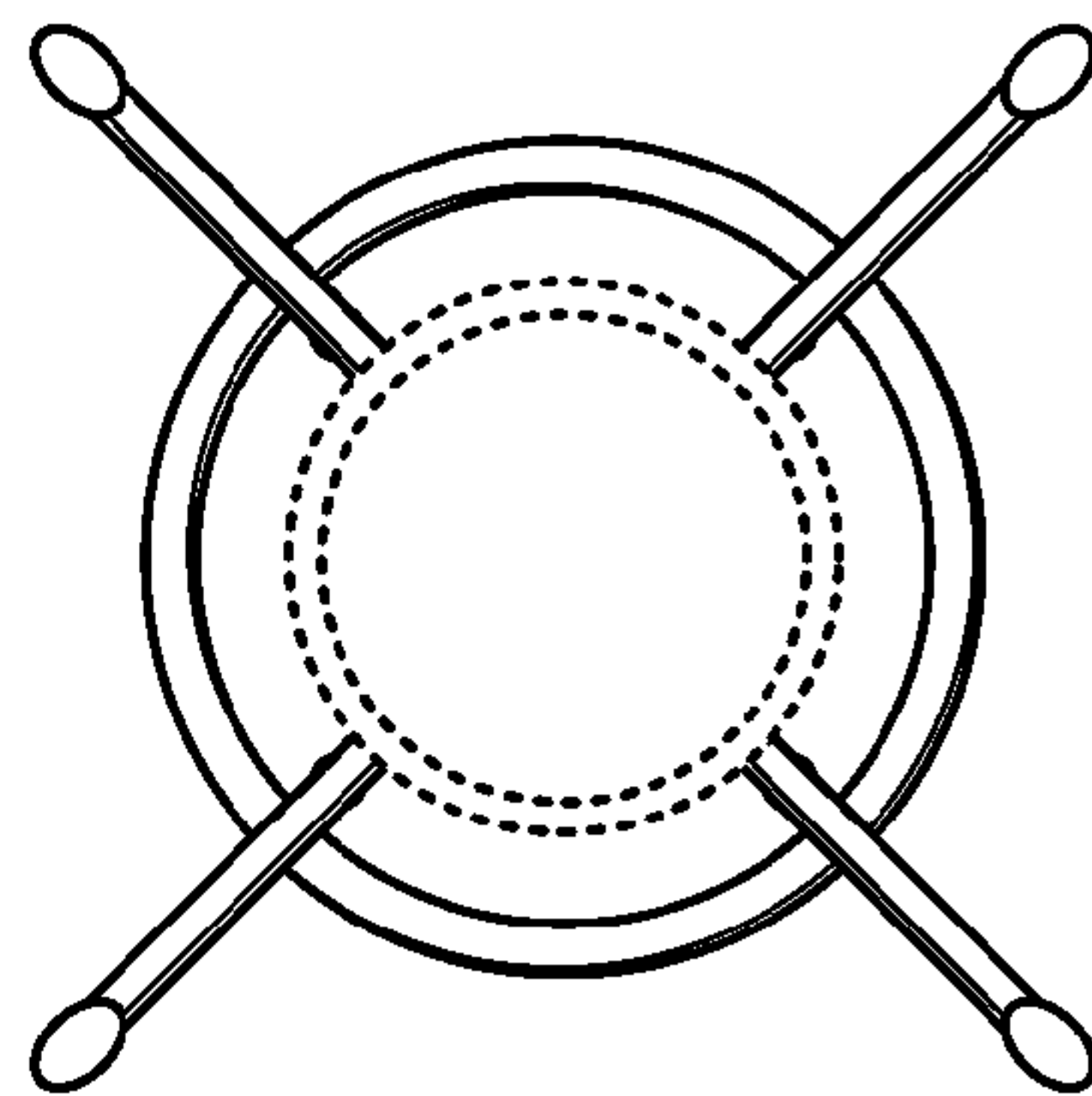
