(57) **CLAIM**

The ornamental design for a roller shade clutch cover, as shown and described.

DESCRIPTION

FIG. 1 is an upper front perspective view of the roller shade clutch cover of the present design.

FIG. 4 is a rear view of the roller shade clutch cover of FIG. 1.

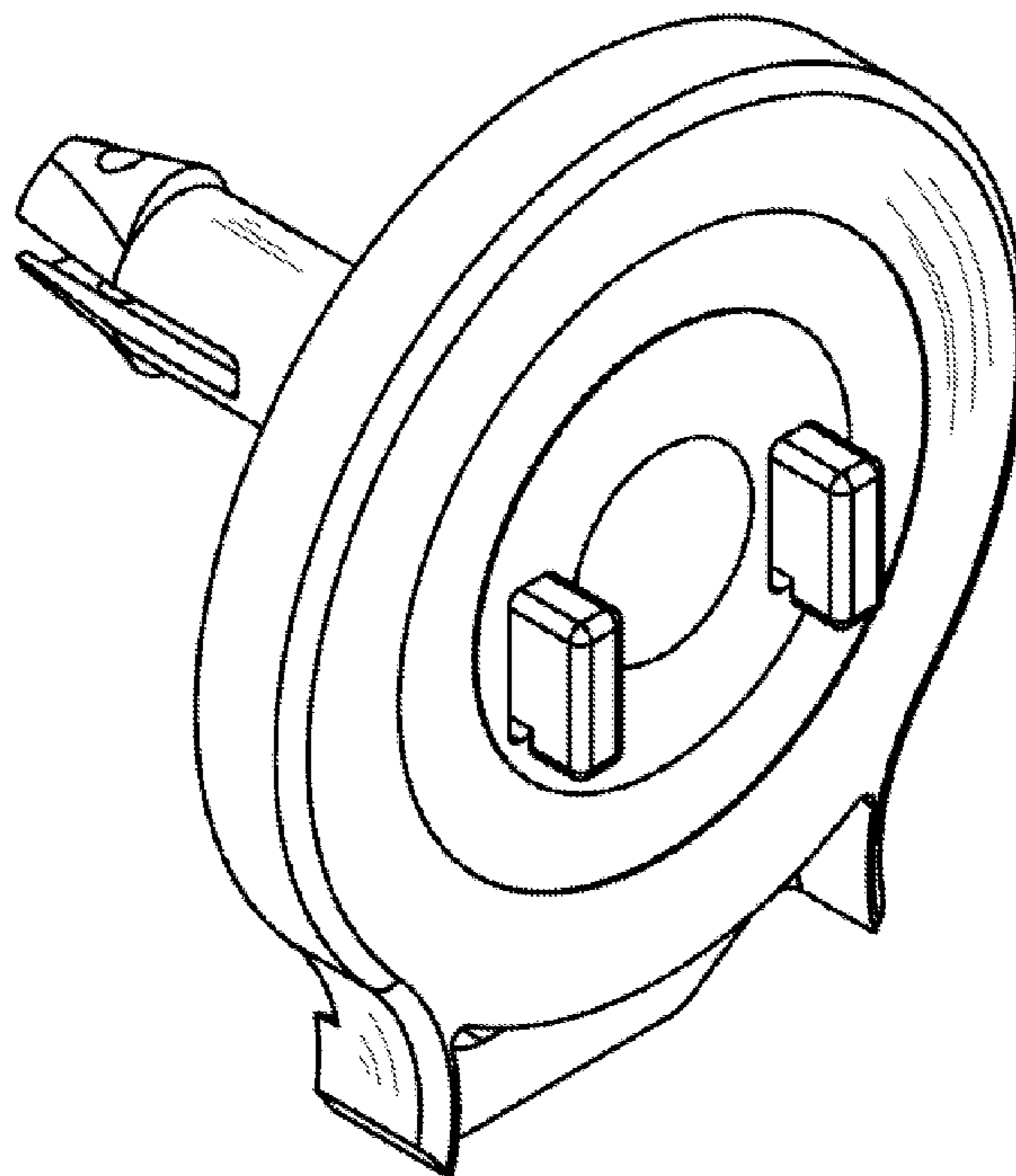
FIG. 5 is a top view of the roller shade clutch cover of FIG. 1.

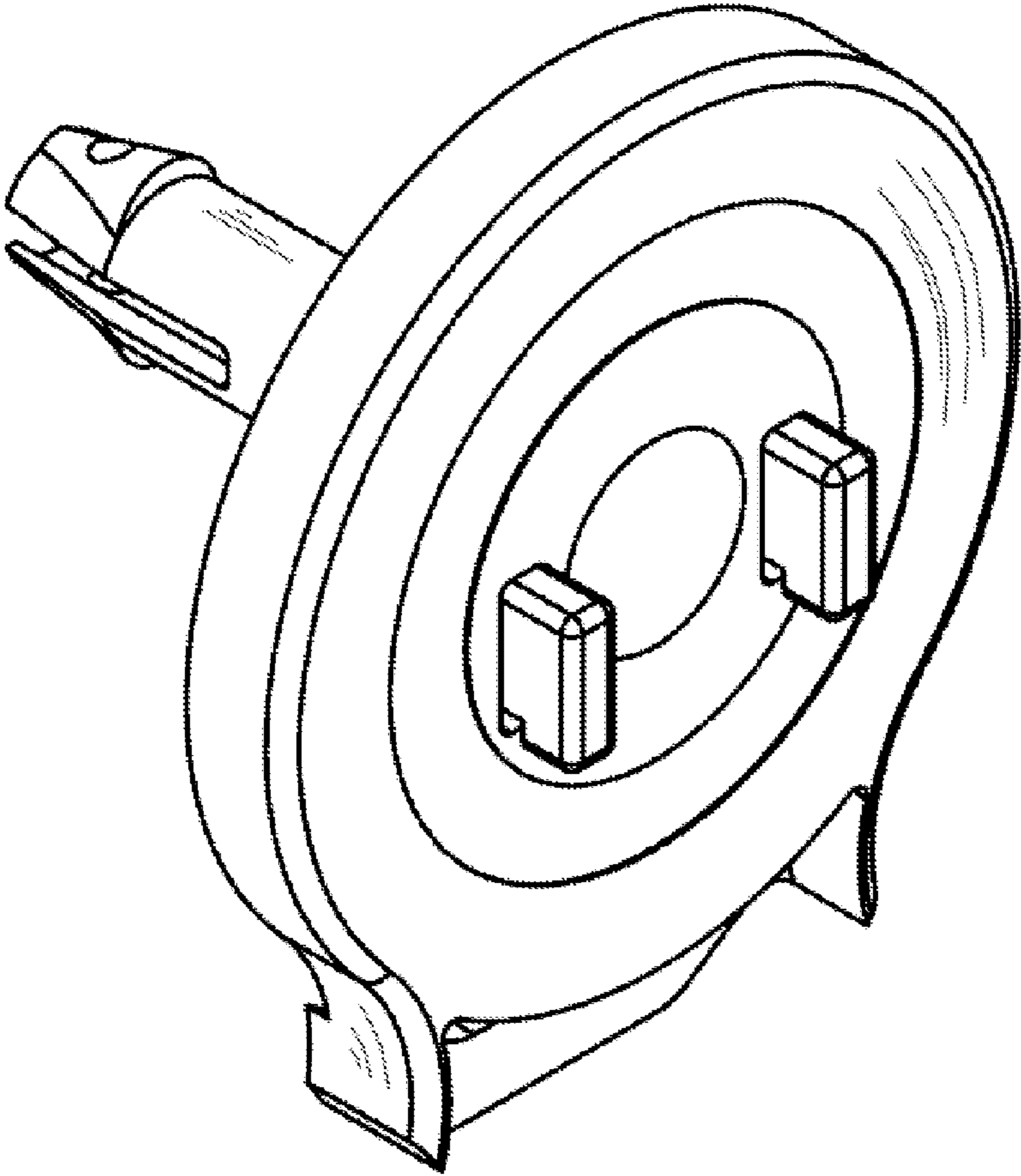

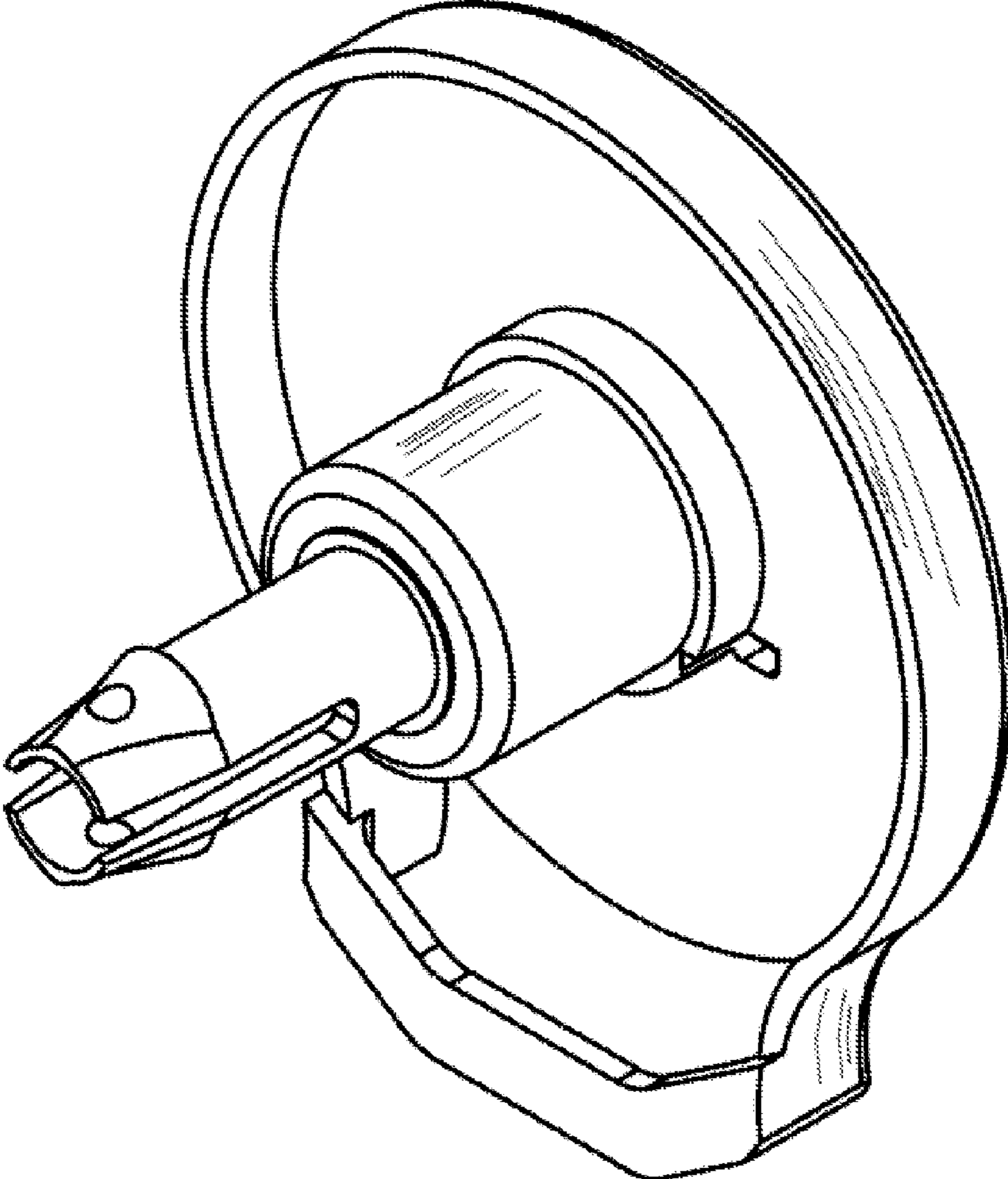

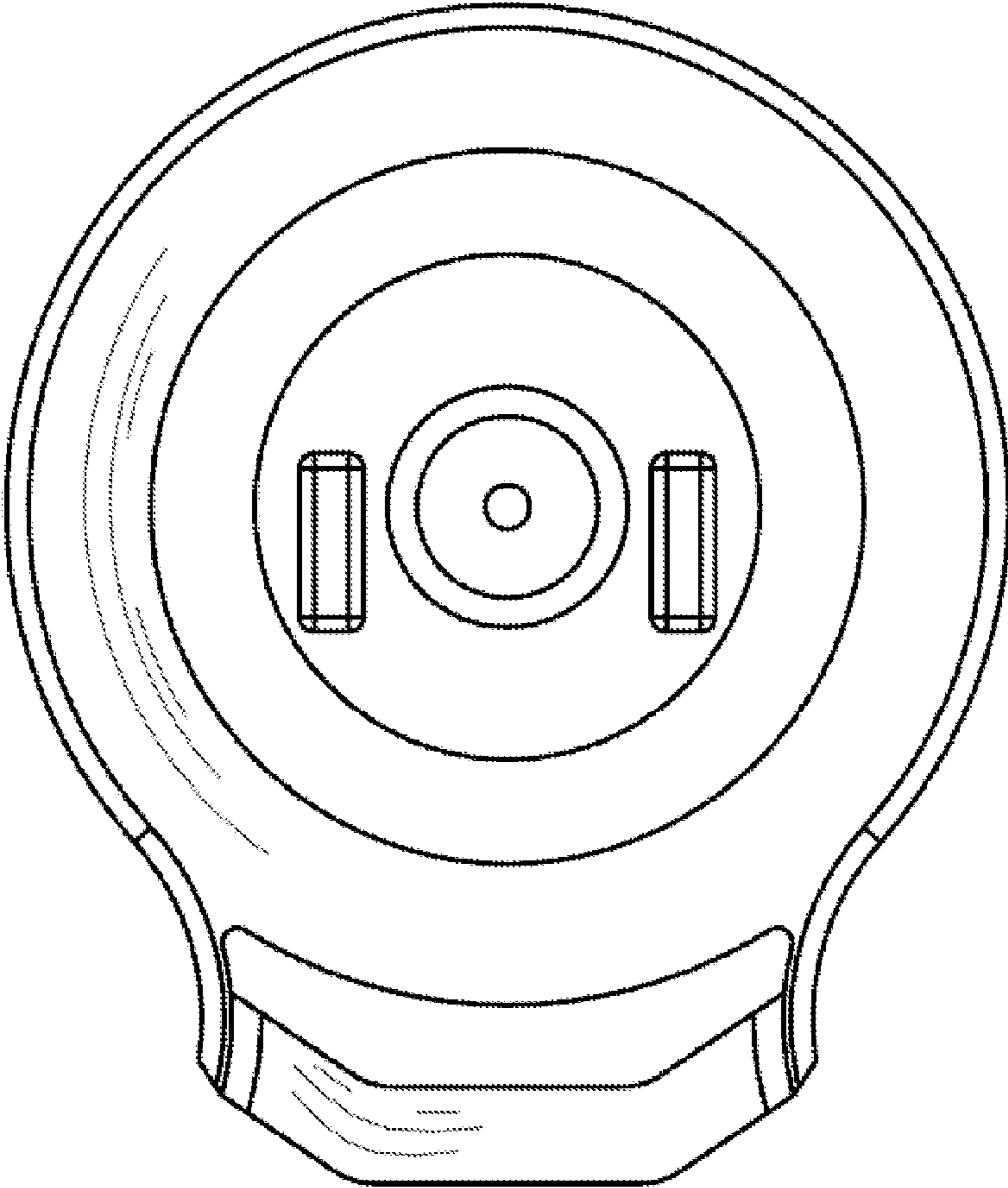

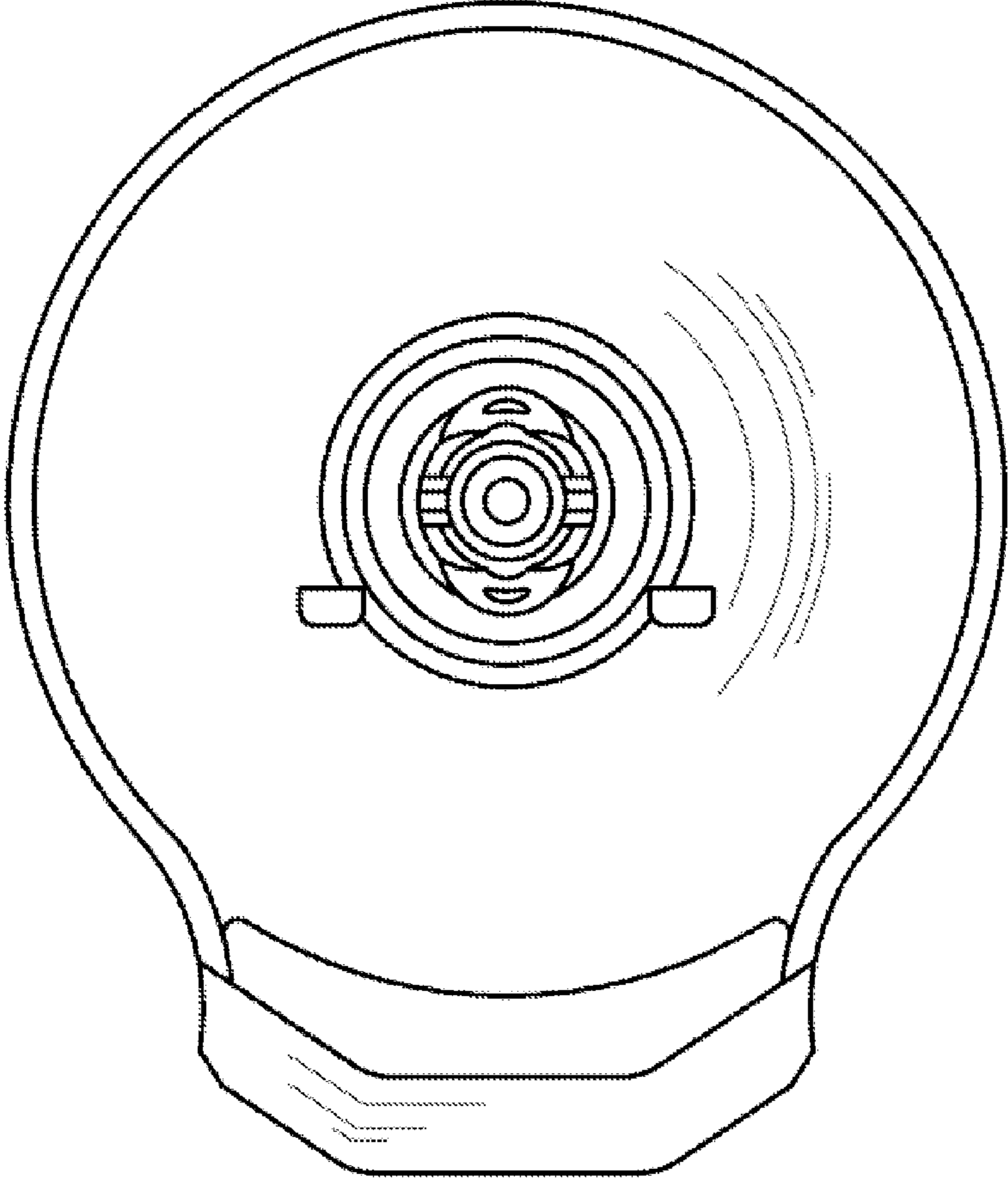

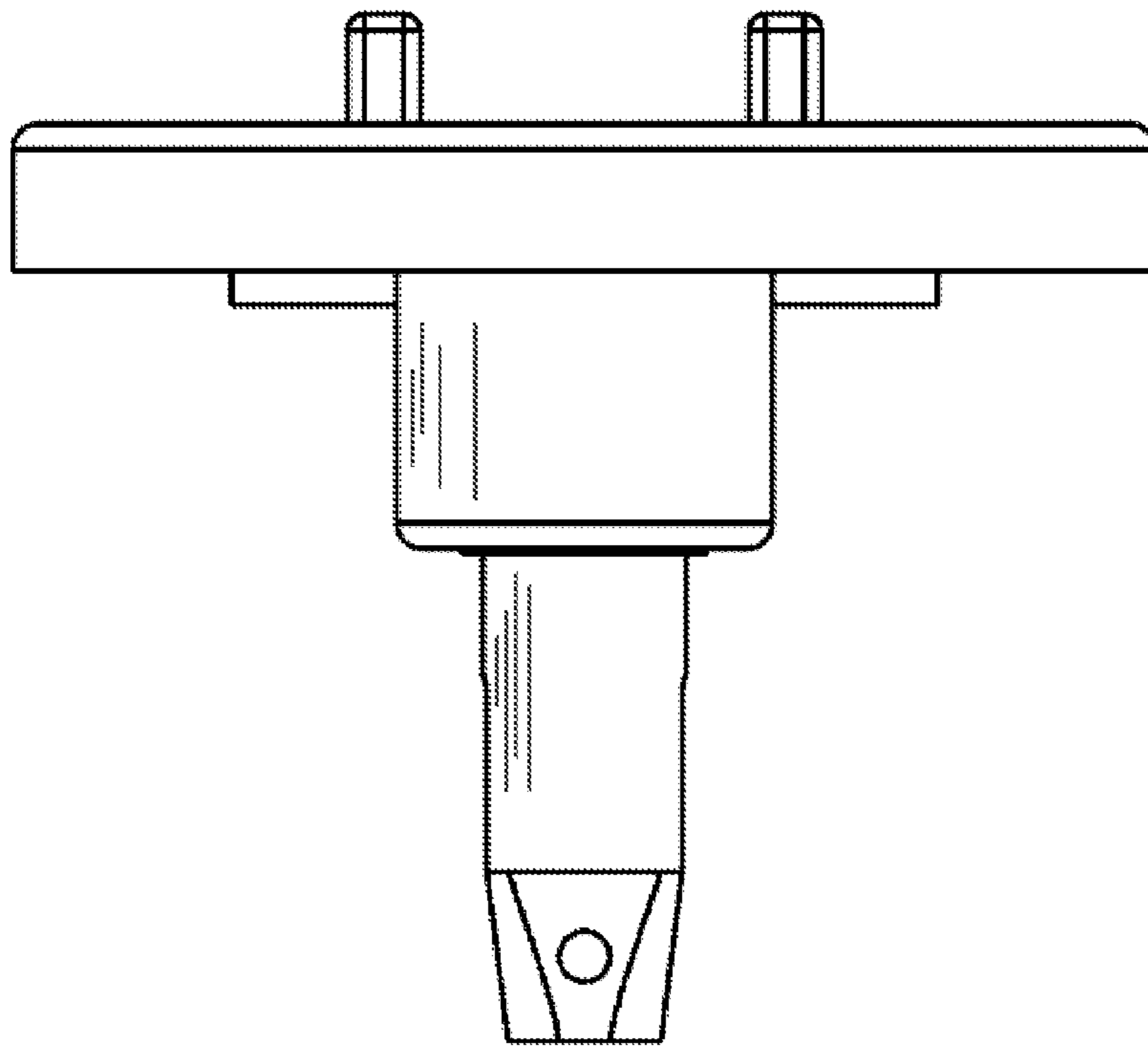

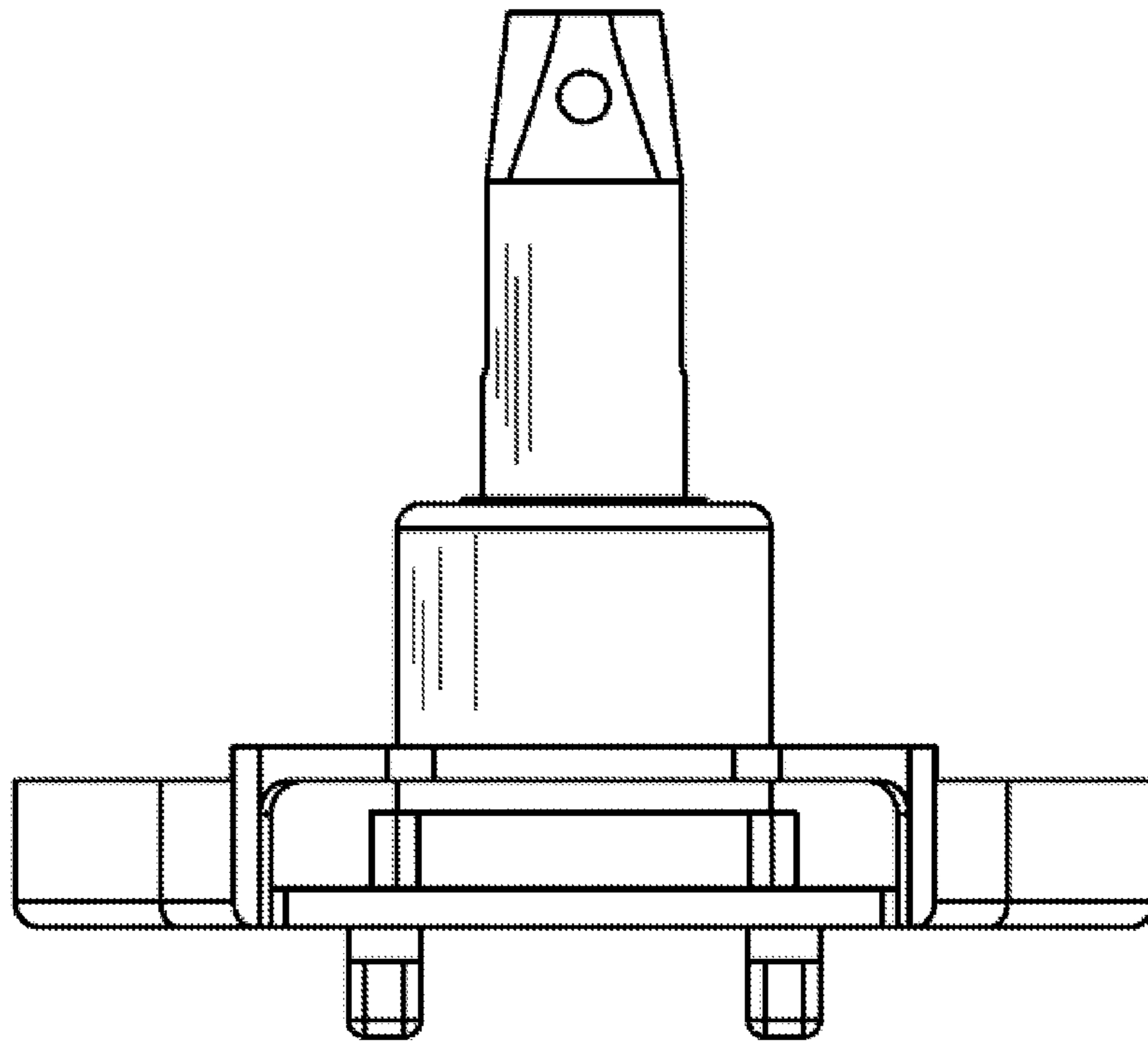

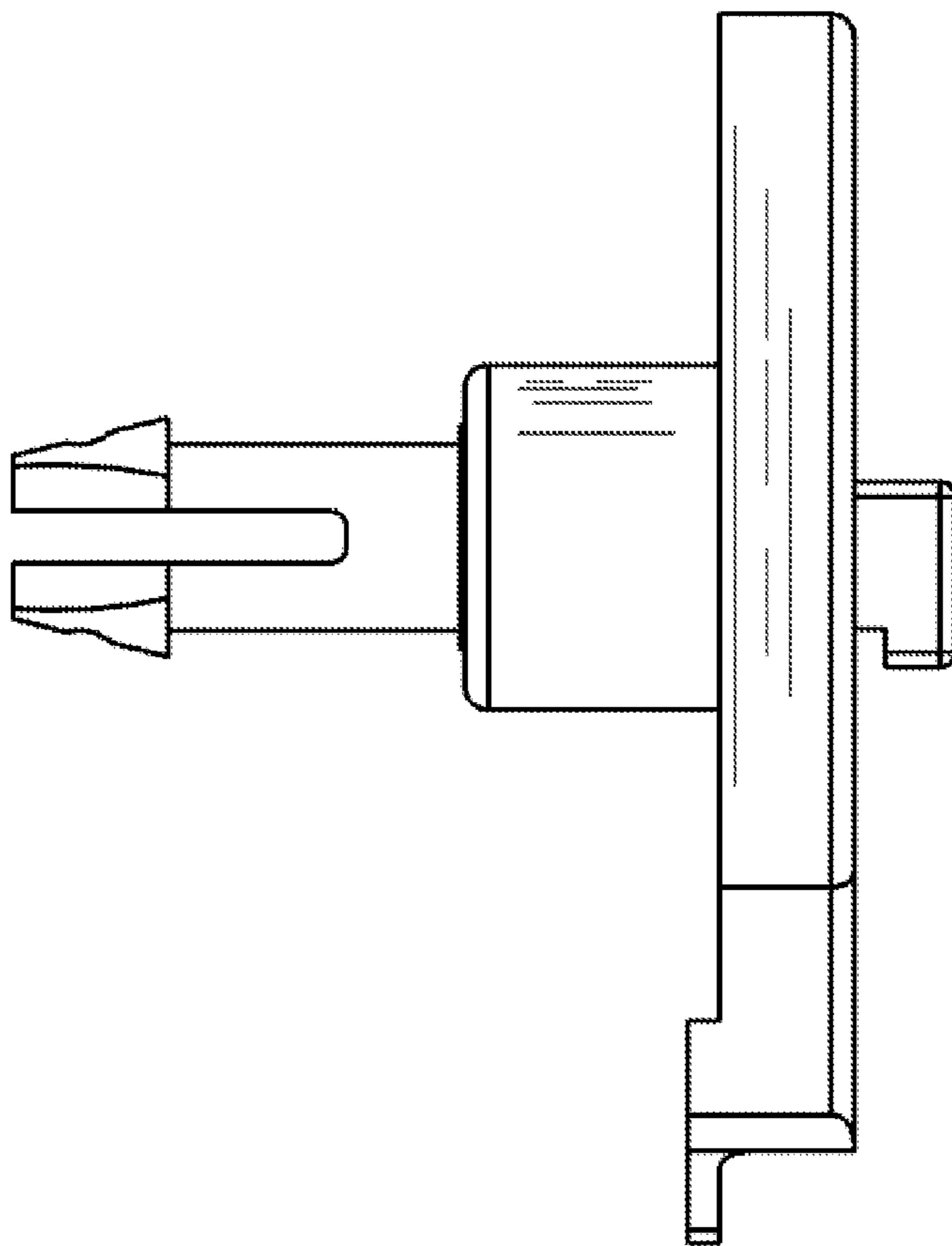

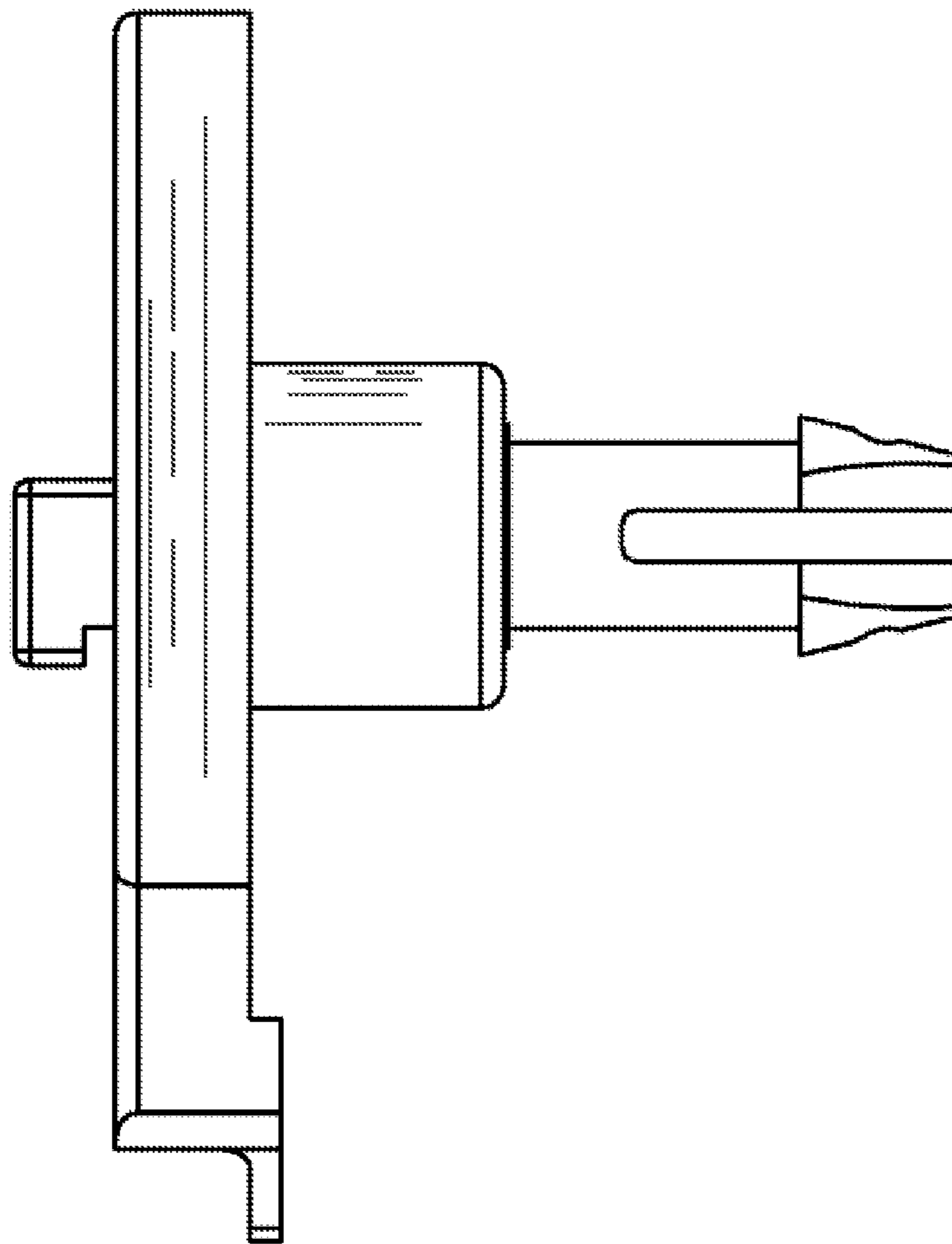
