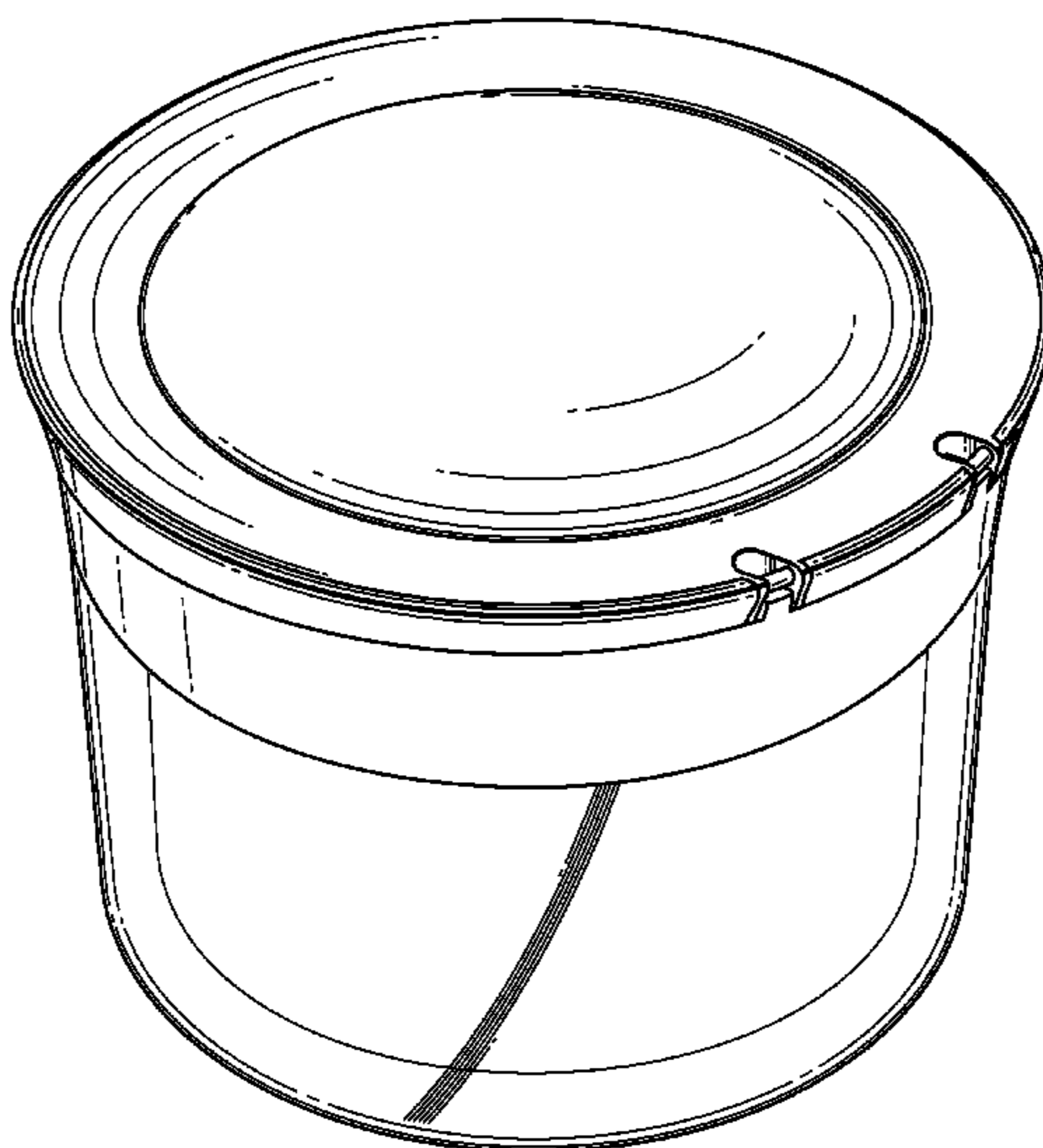

We claim the ornamental design for a wiping substrate dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wiping substrate dispenser showing our new design;  
FIG. 2 is a side elevation view thereof;  
FIG. 3 is an opposite side elevation view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a back elevation view thereof; and,  
FIG. 6 is a top plan view thereof.

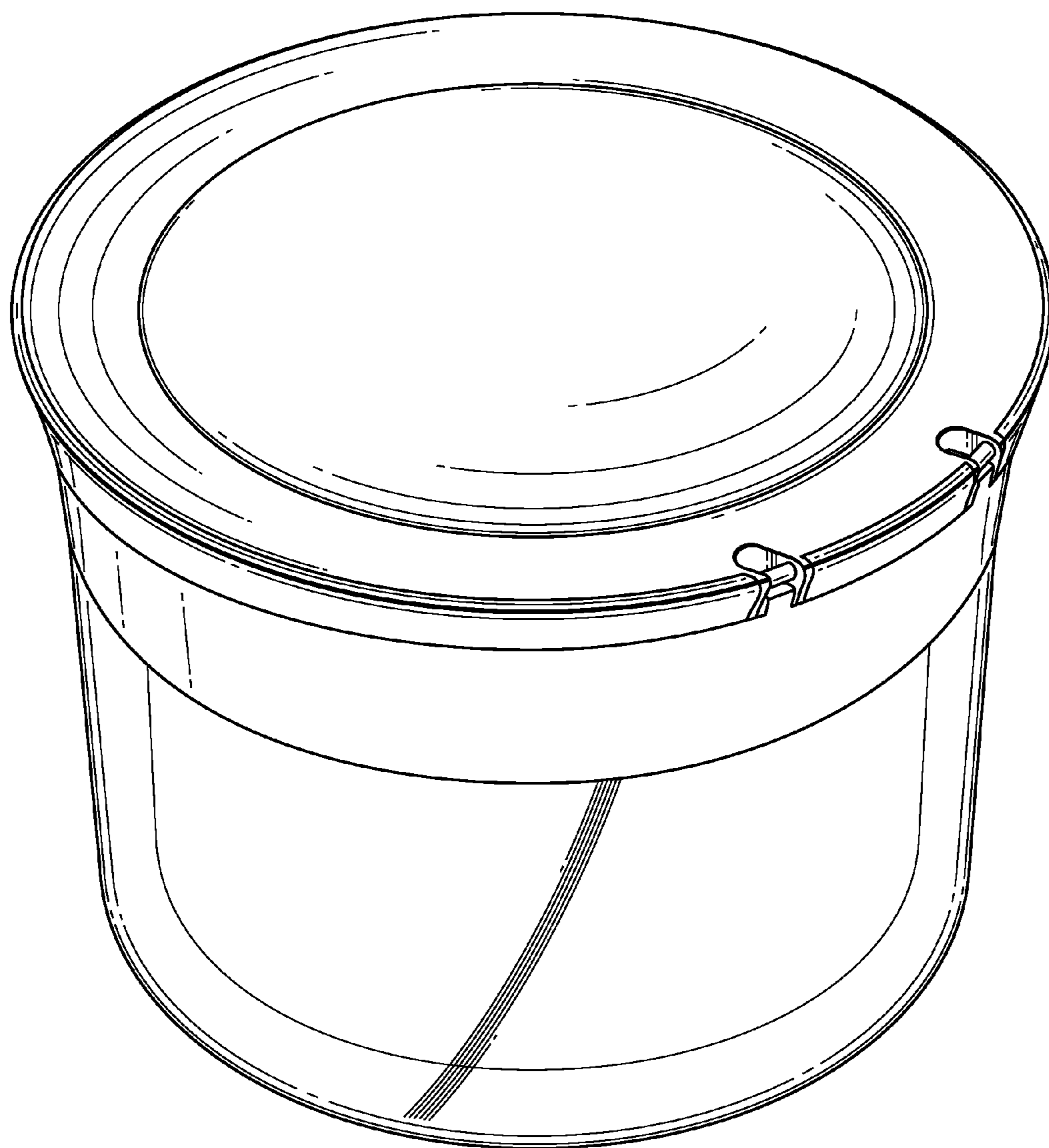

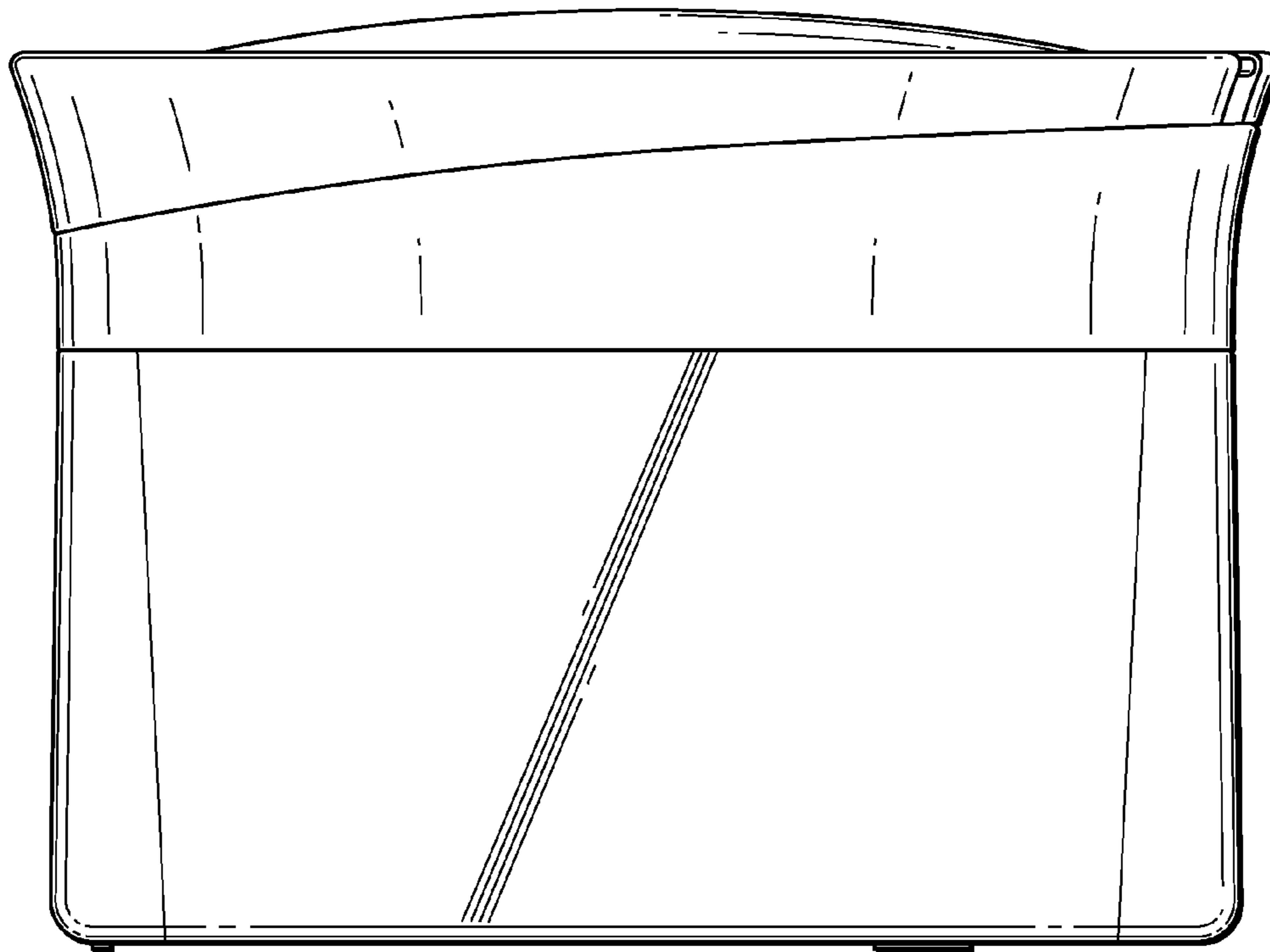

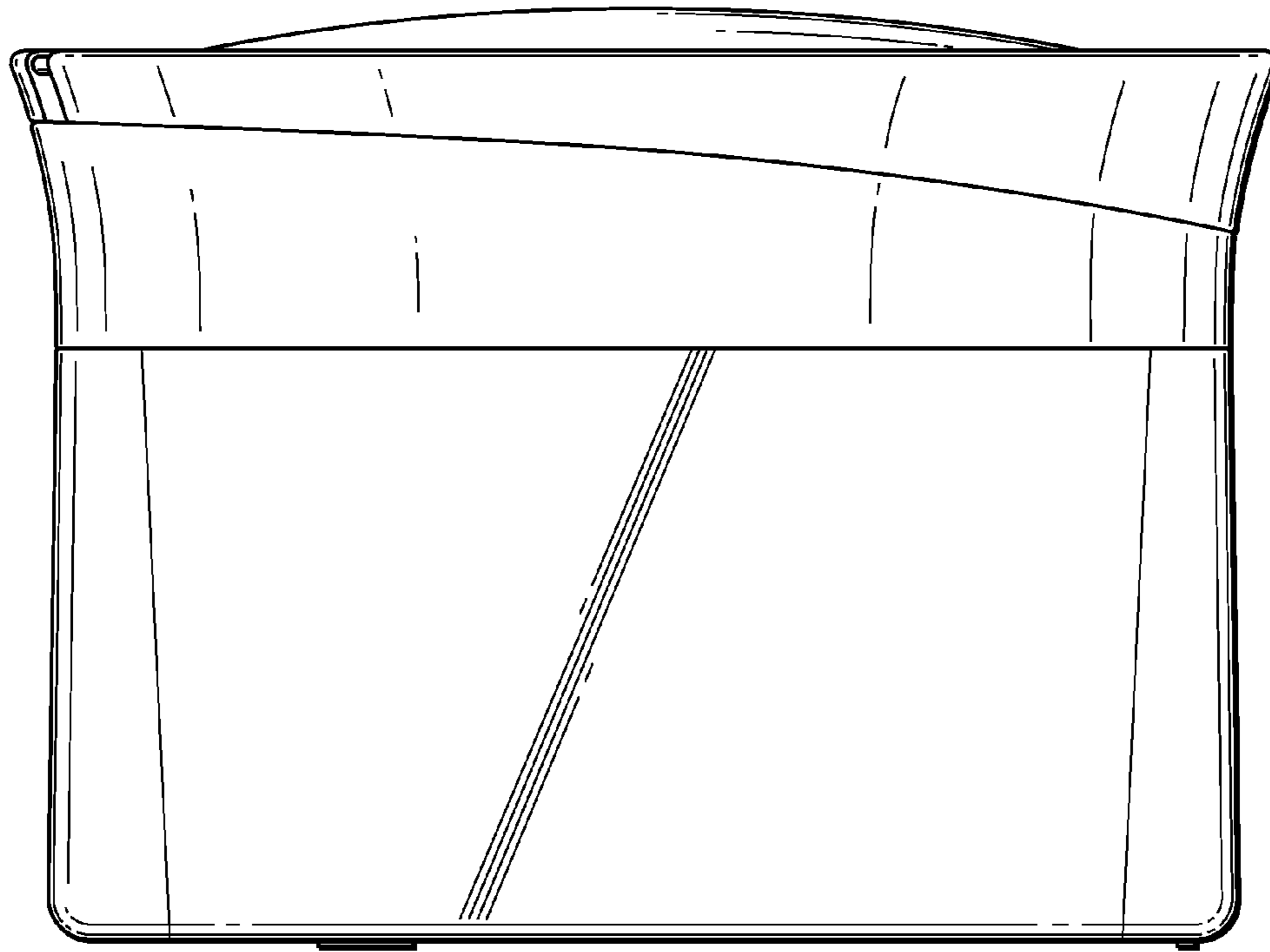

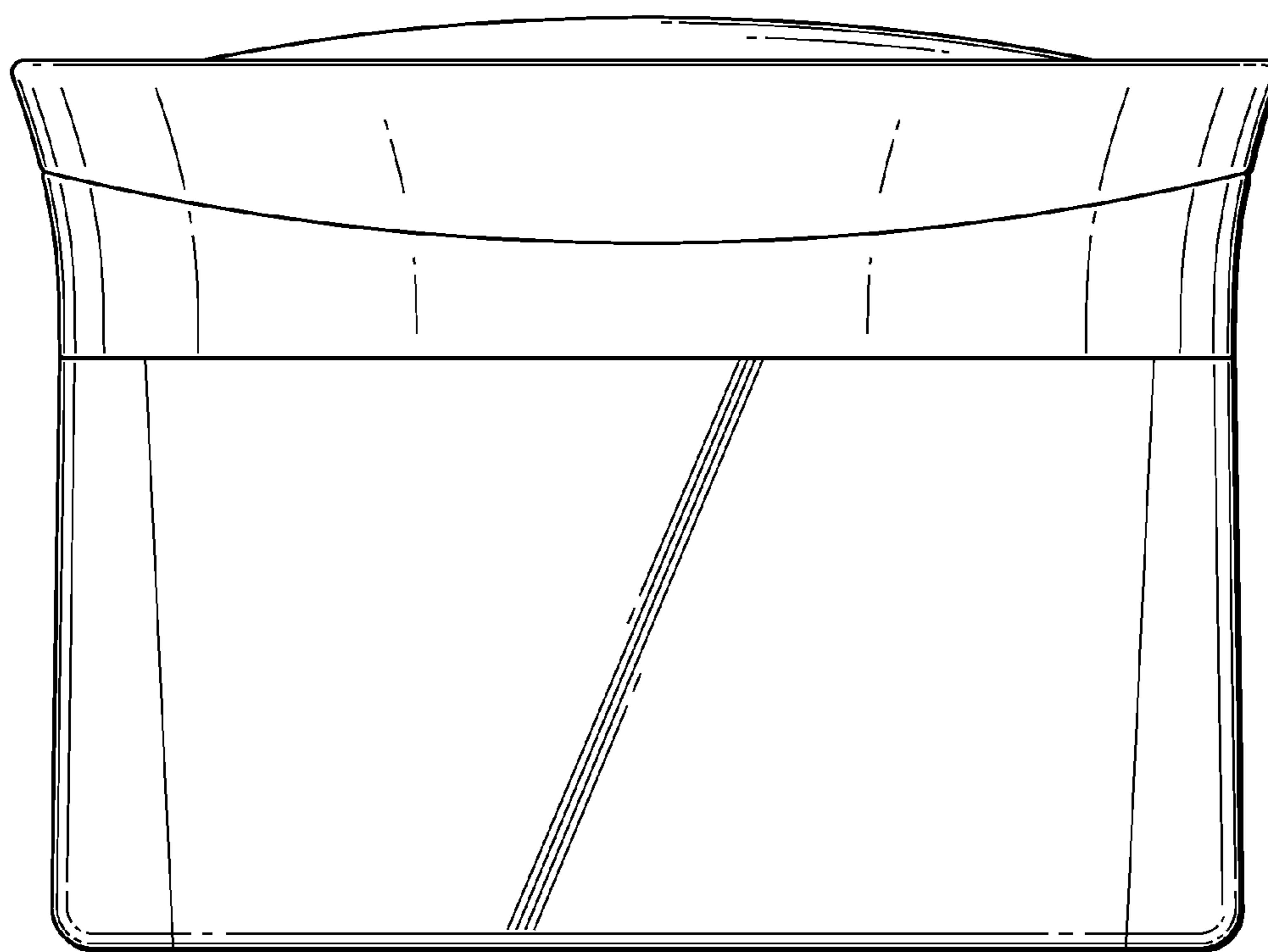

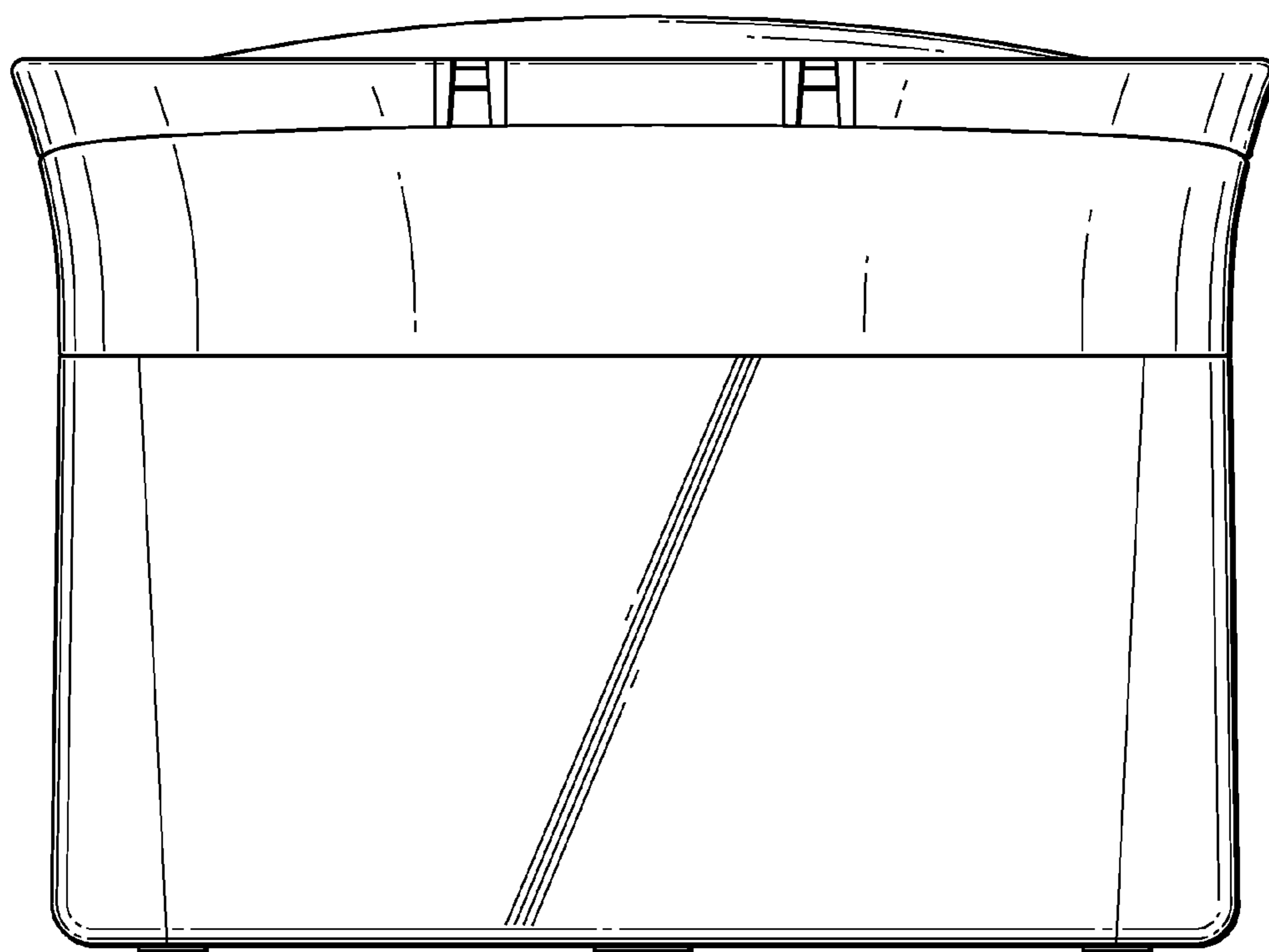

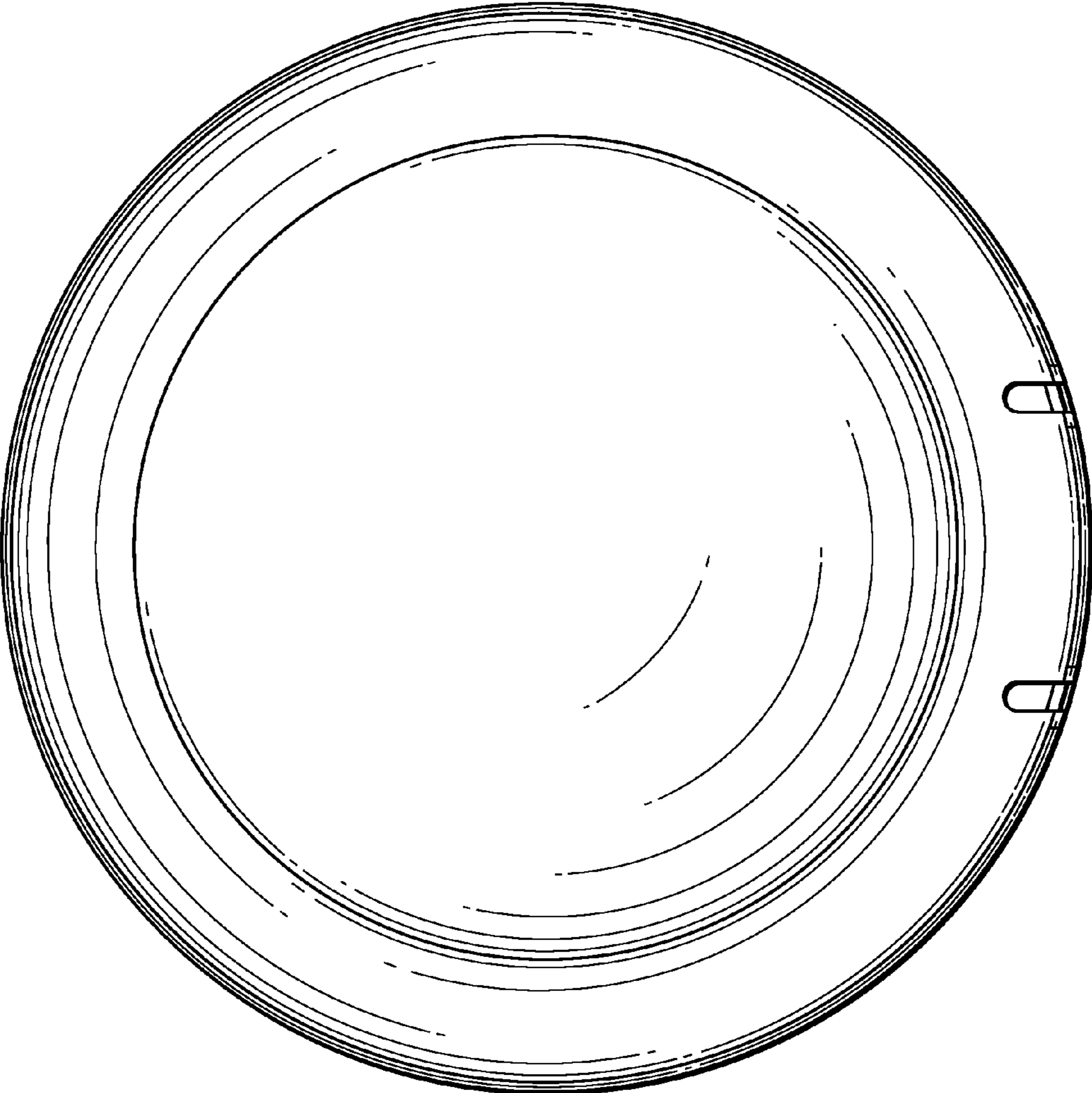
