The ornamental design for a joint for aircraft luggage compartments, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the right side of a joint for aircraft luggage compartments.

FIG. 2 is a perspective view from the left side thereof.

FIG. 3 is a front elevation view thereof.

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a right side elevation view thereof.

FIG. 6 is a left side elevation view thereof.

FIG. 7 is a top plan view thereof.

FIG. 8 is a bottom plan view thereof; and,

FIG. 9 is a referential view showing use thereof.

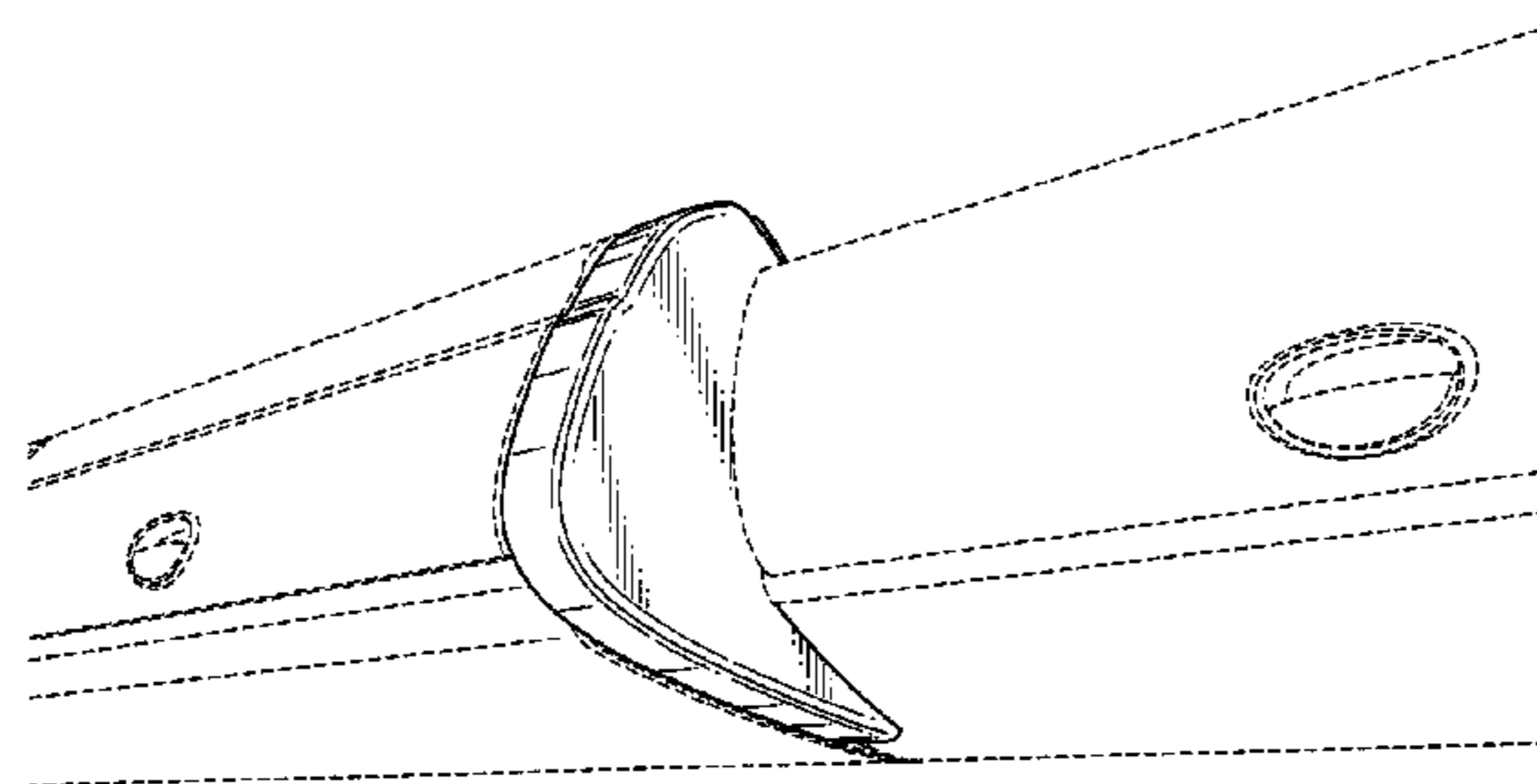
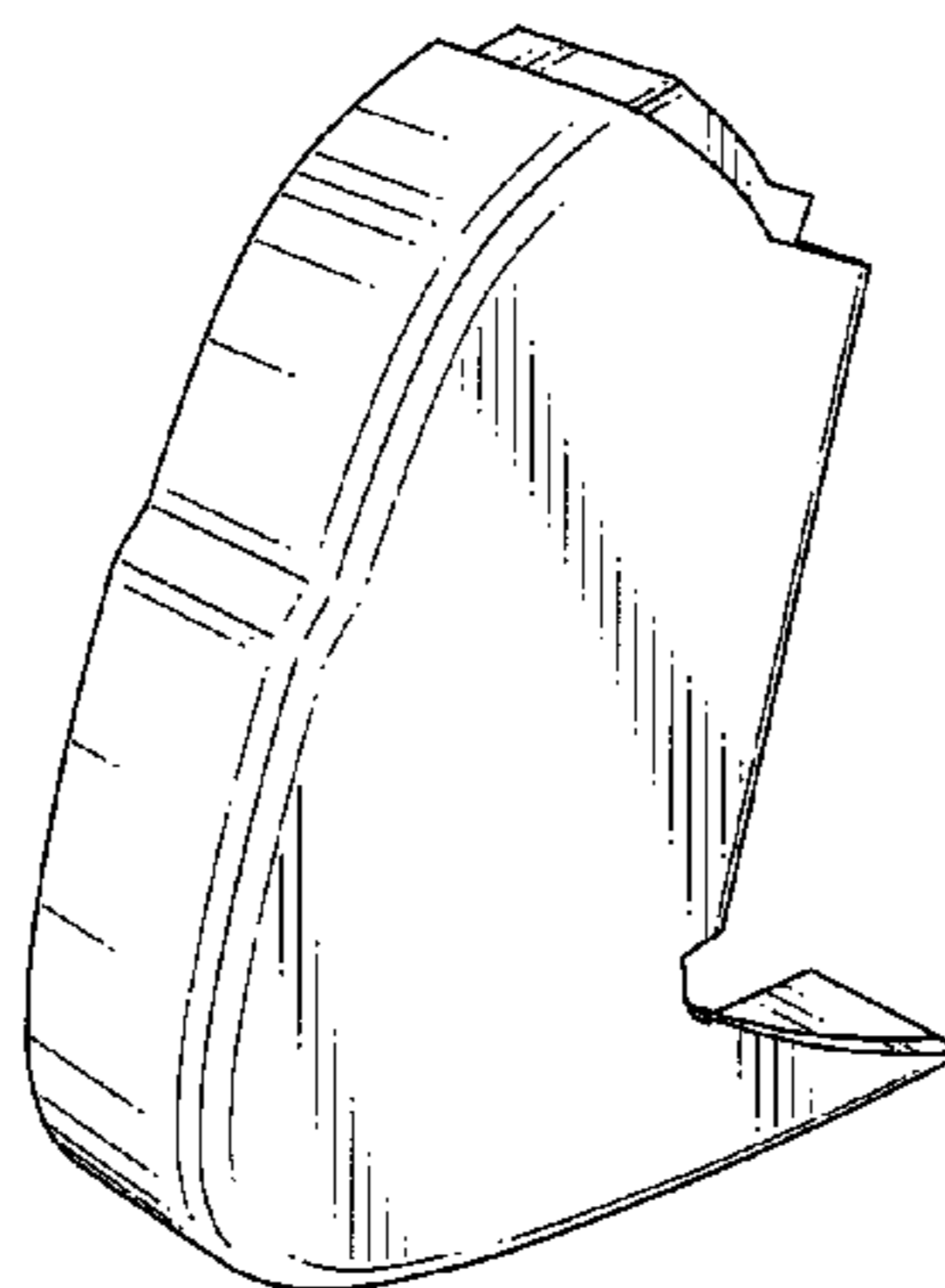

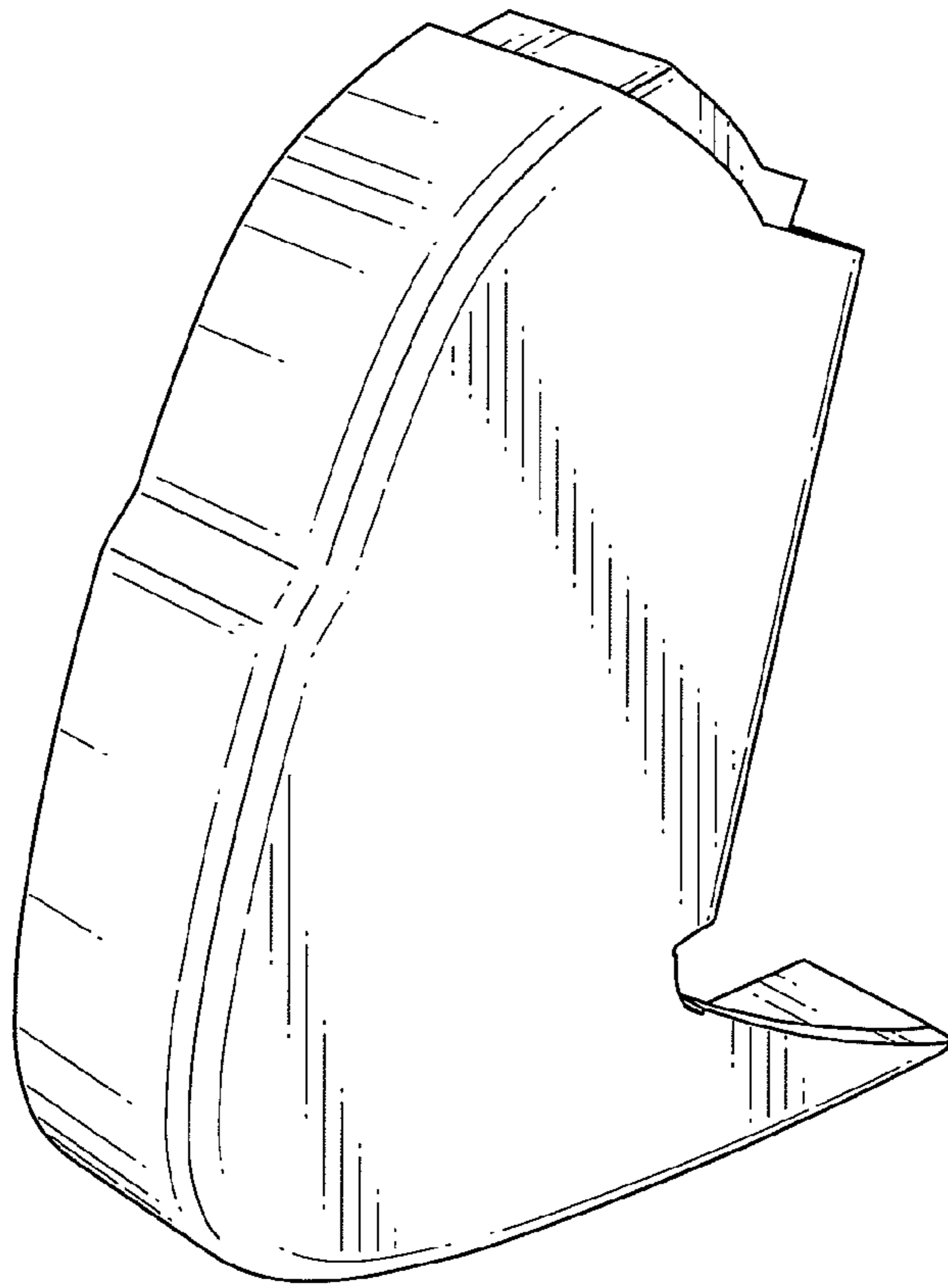

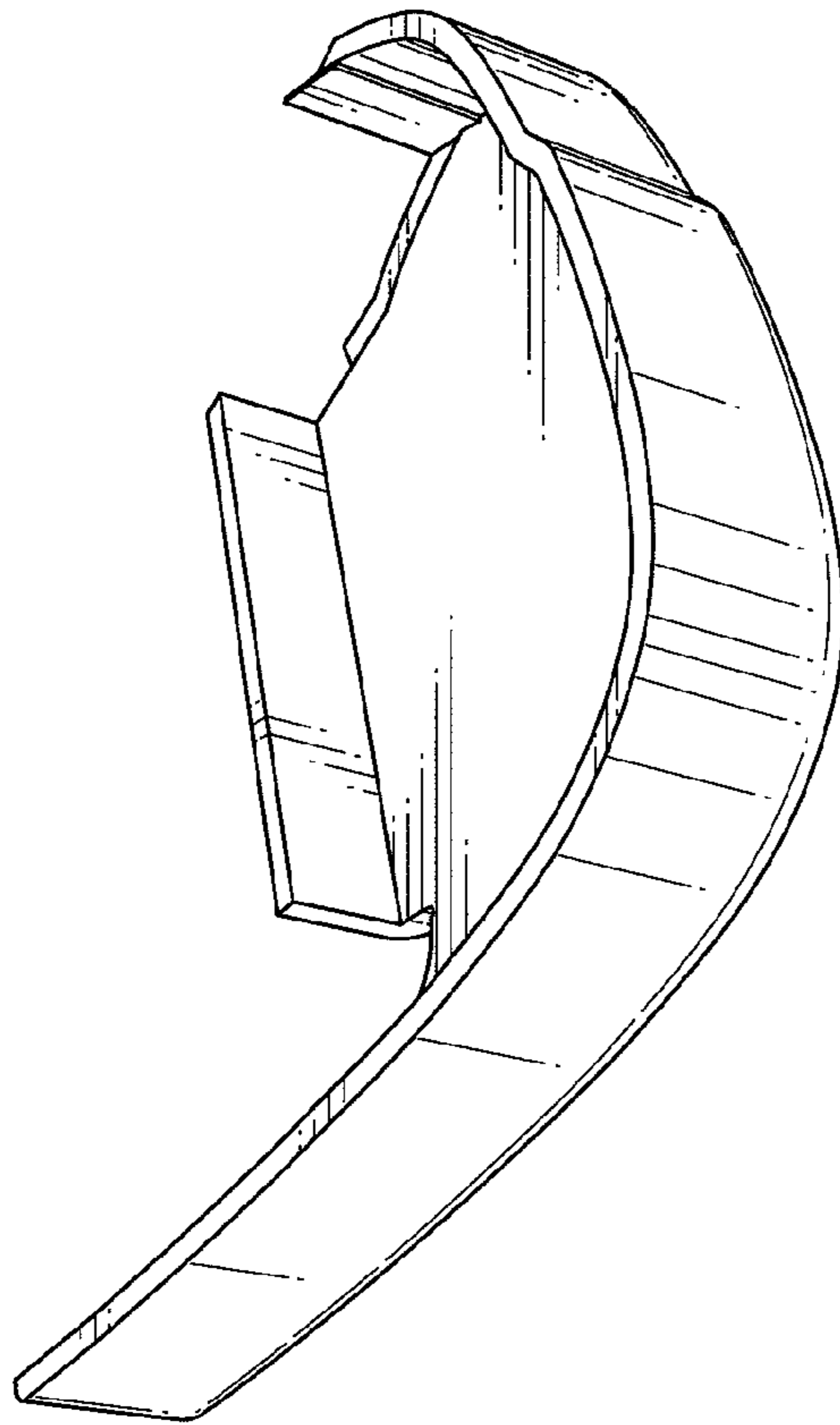

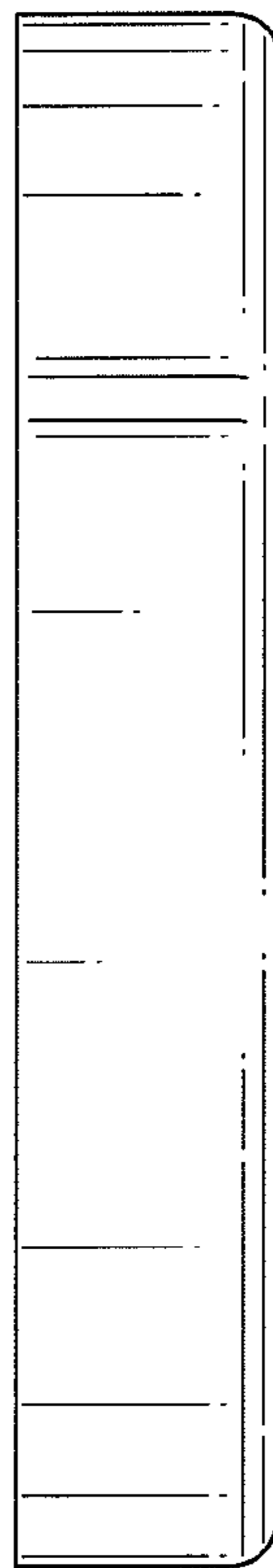

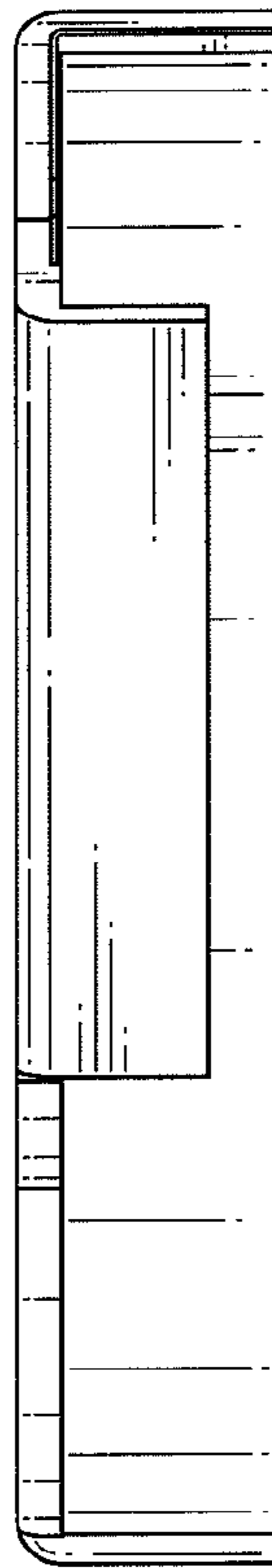

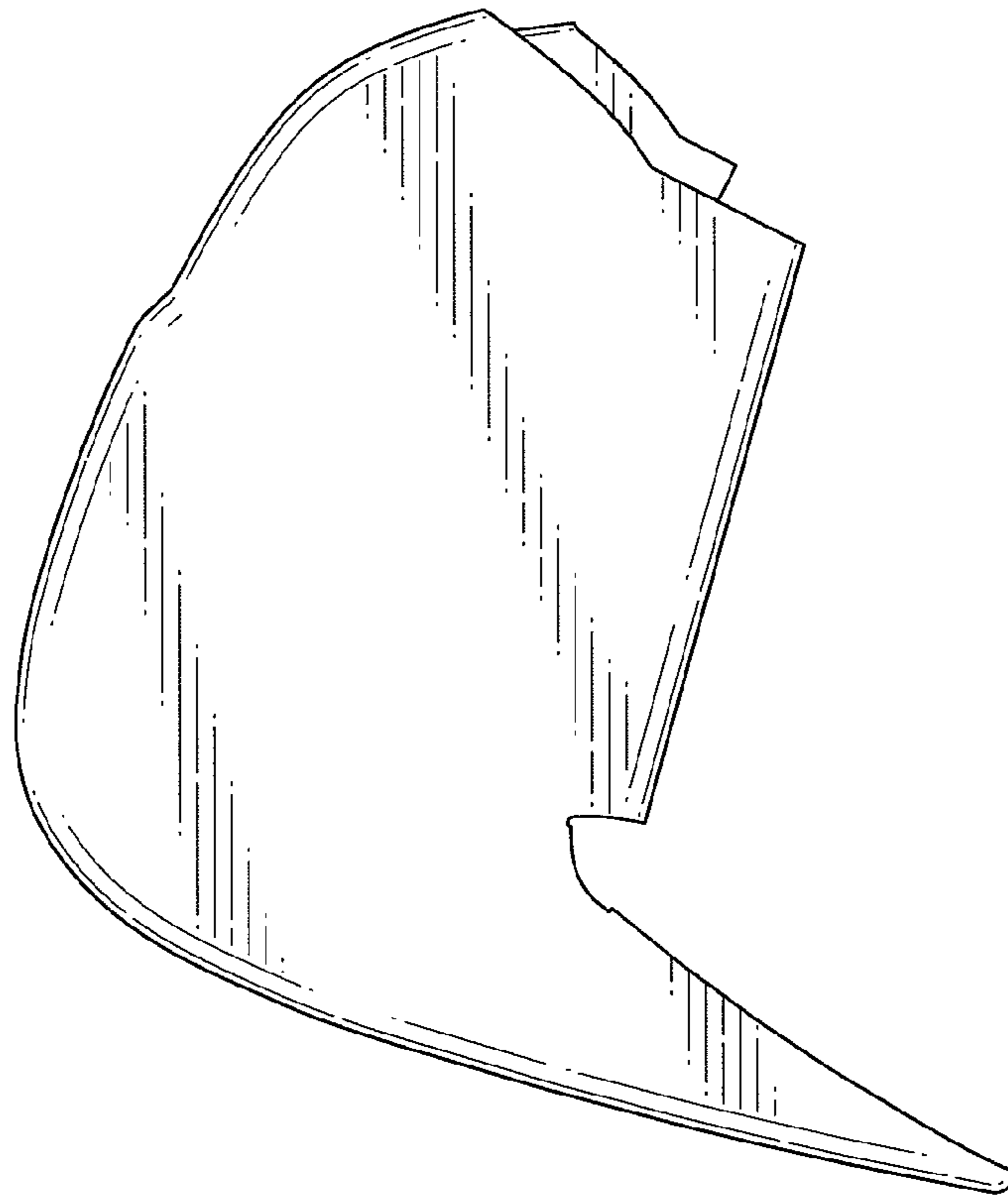

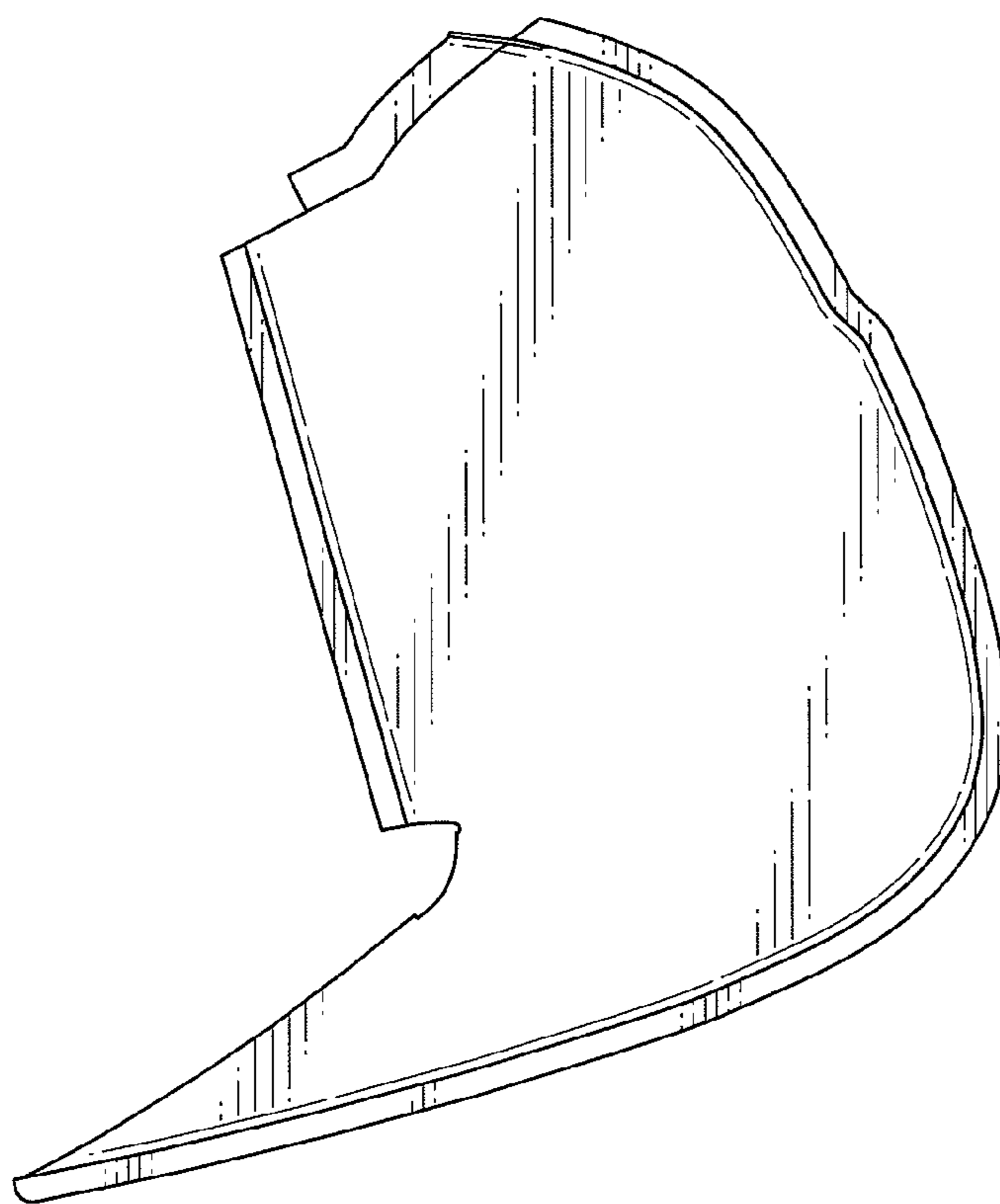

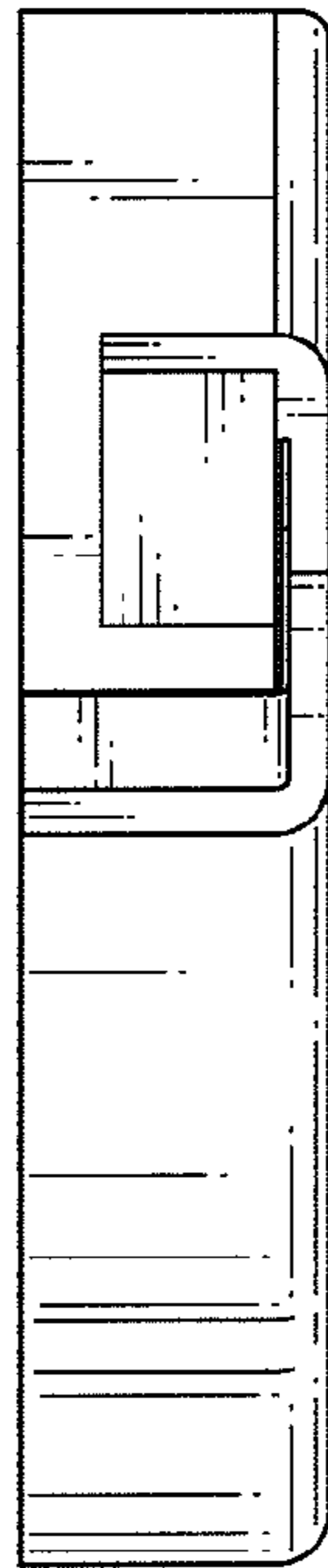

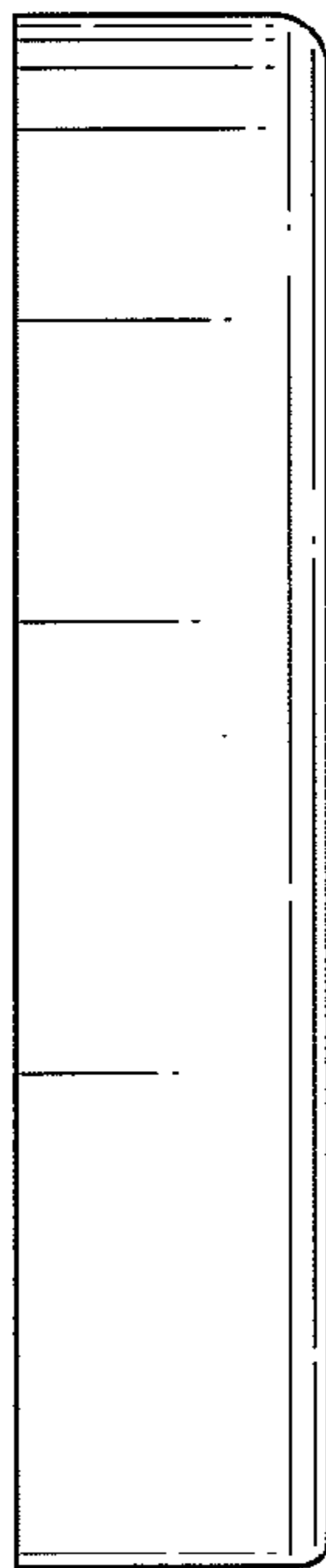
