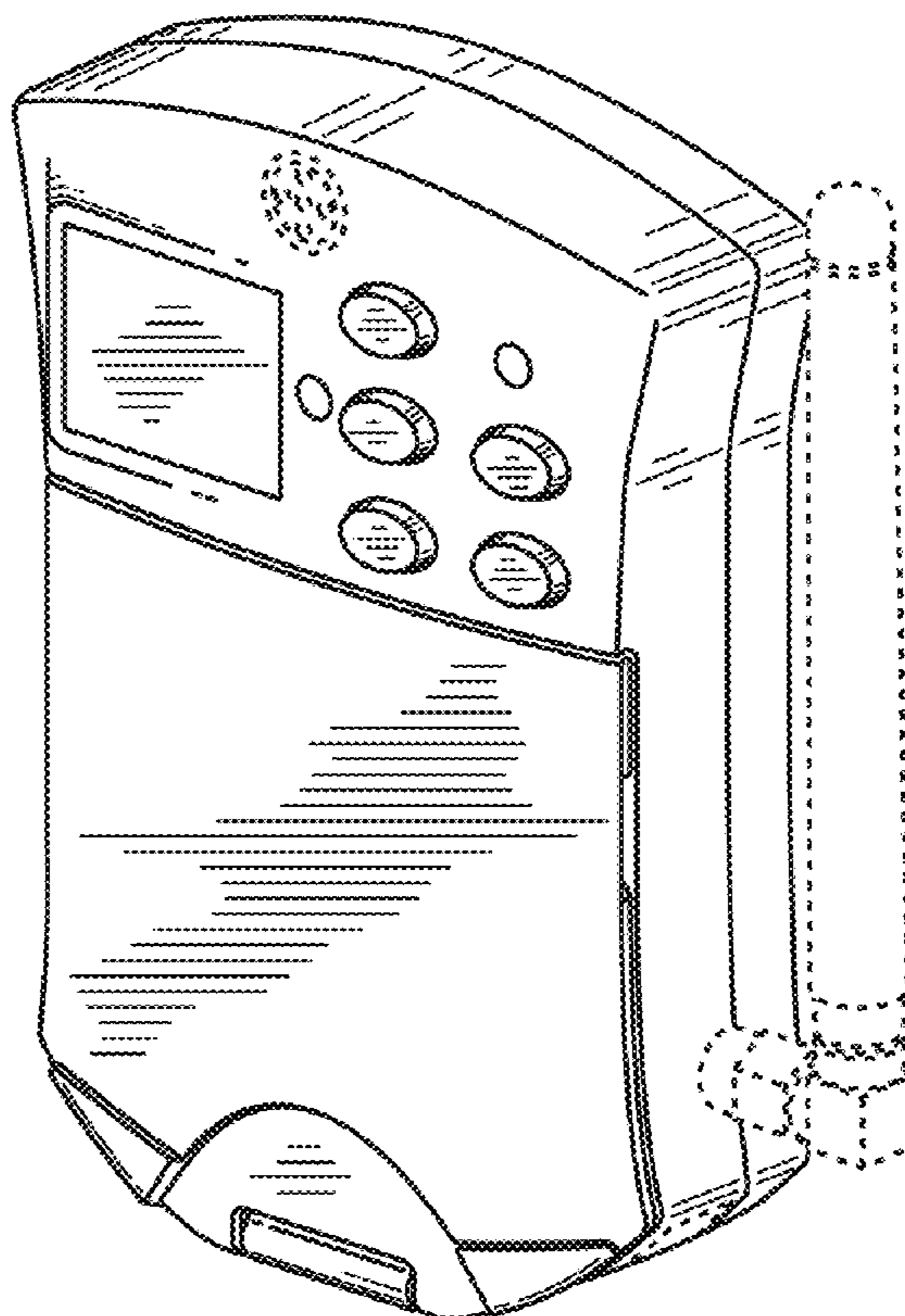
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a control panel in accordance with my new design;
FIG. 2 is a back perspective view of the design of FIG. 1;
FIG. 3 is a front elevation view of the design of FIG. 1;
FIG. 4 is a back elevation view of the design of FIG. 1;
FIG. 5 is a first side elevation view of the design of FIG. 1;

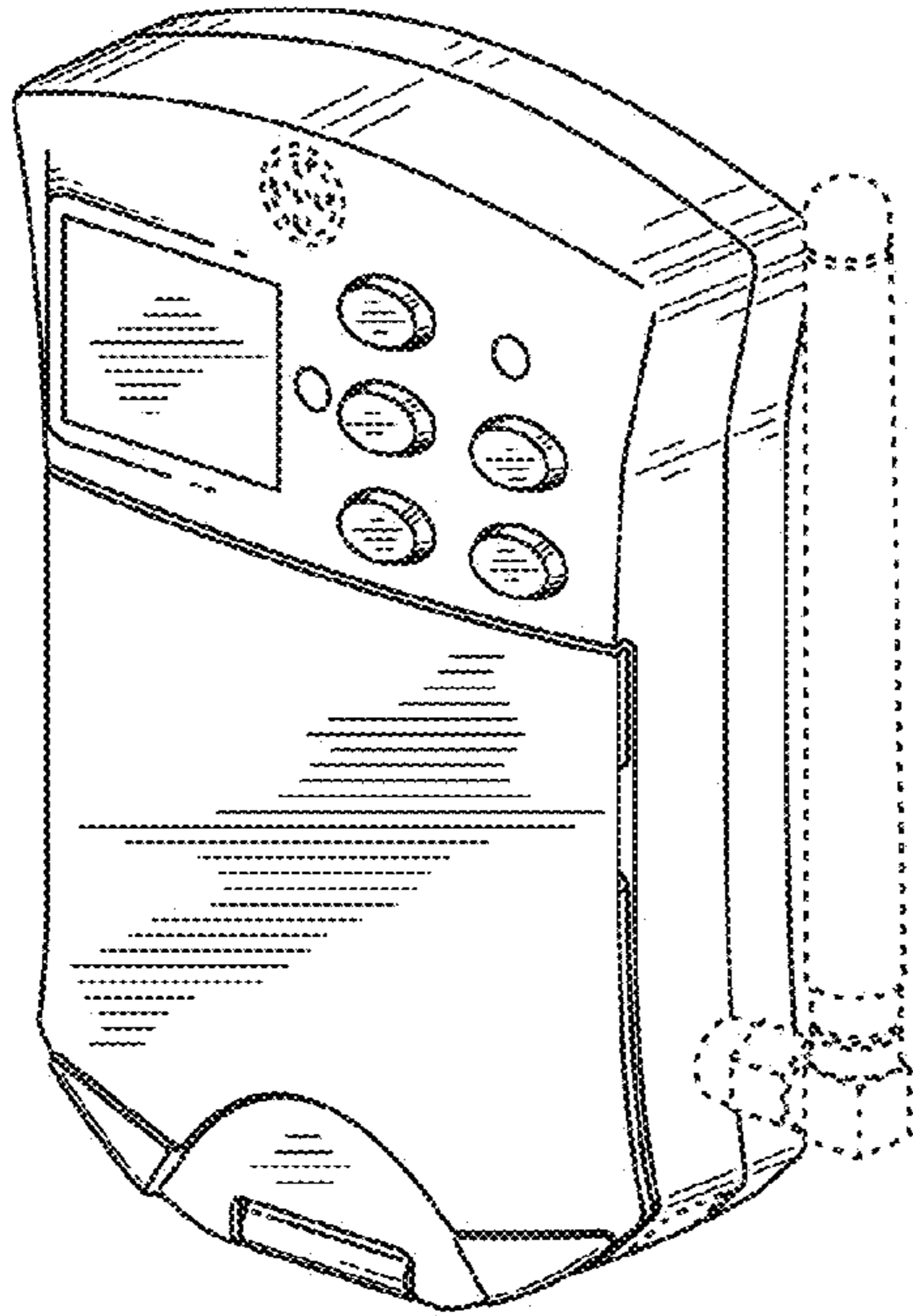

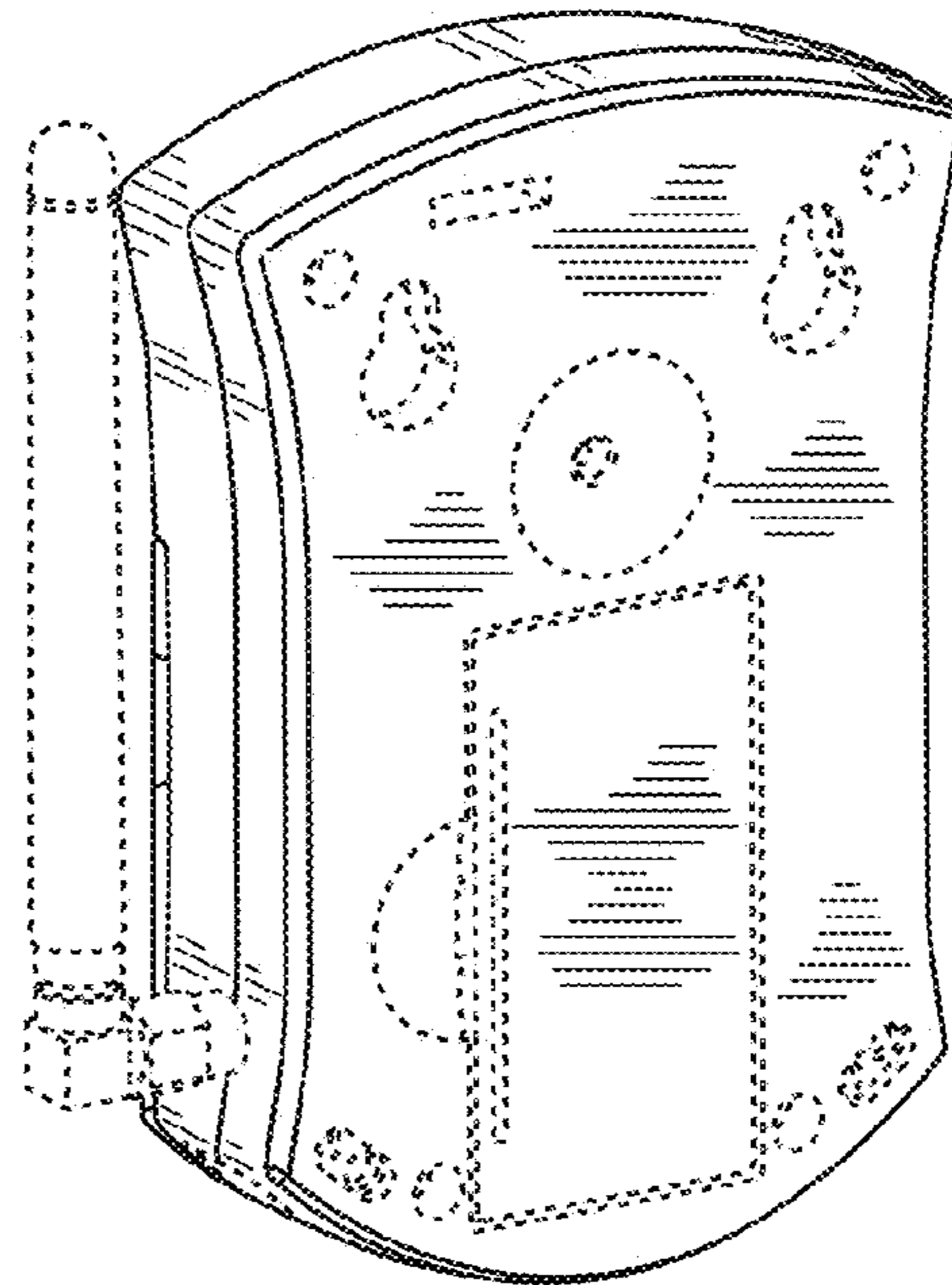

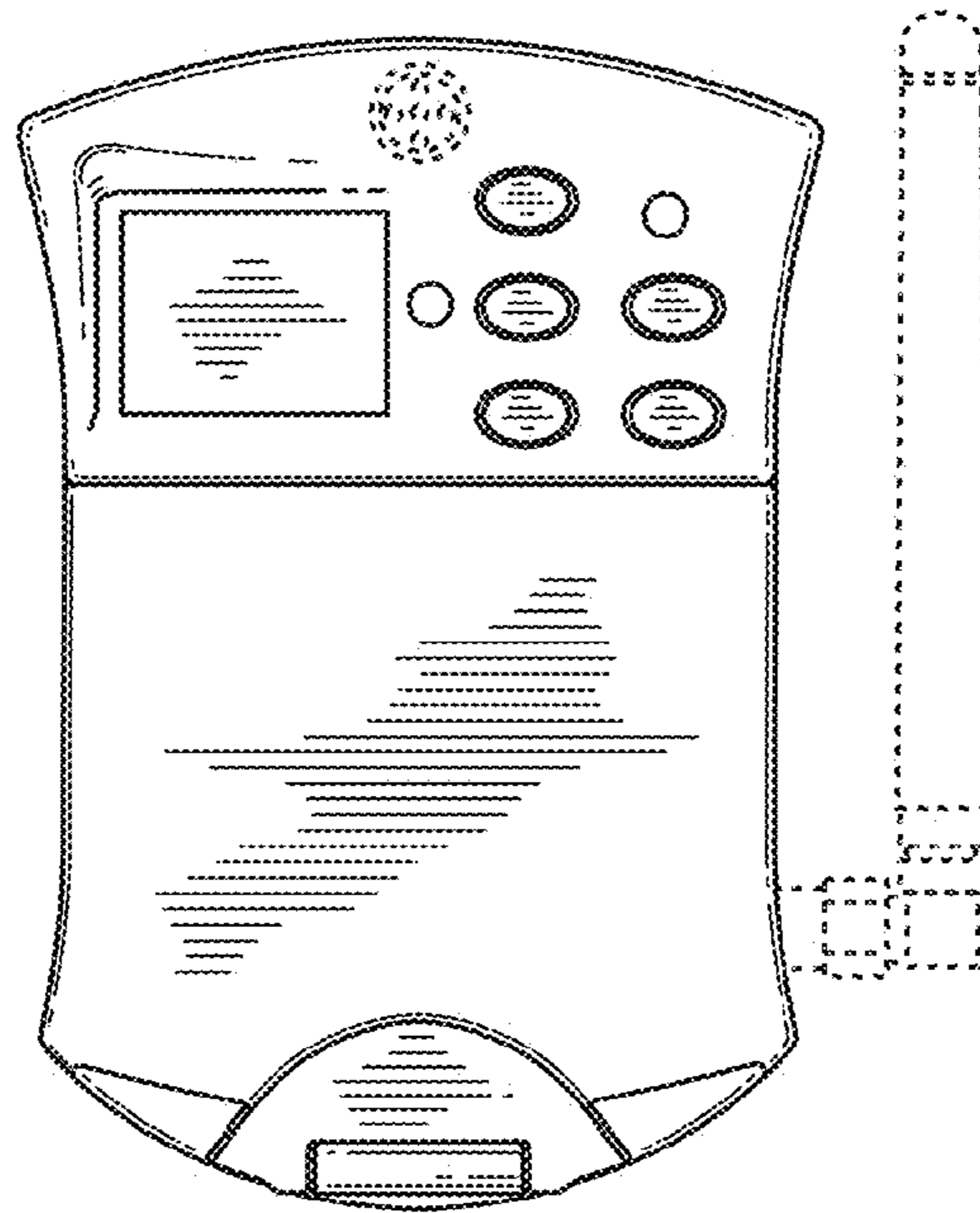

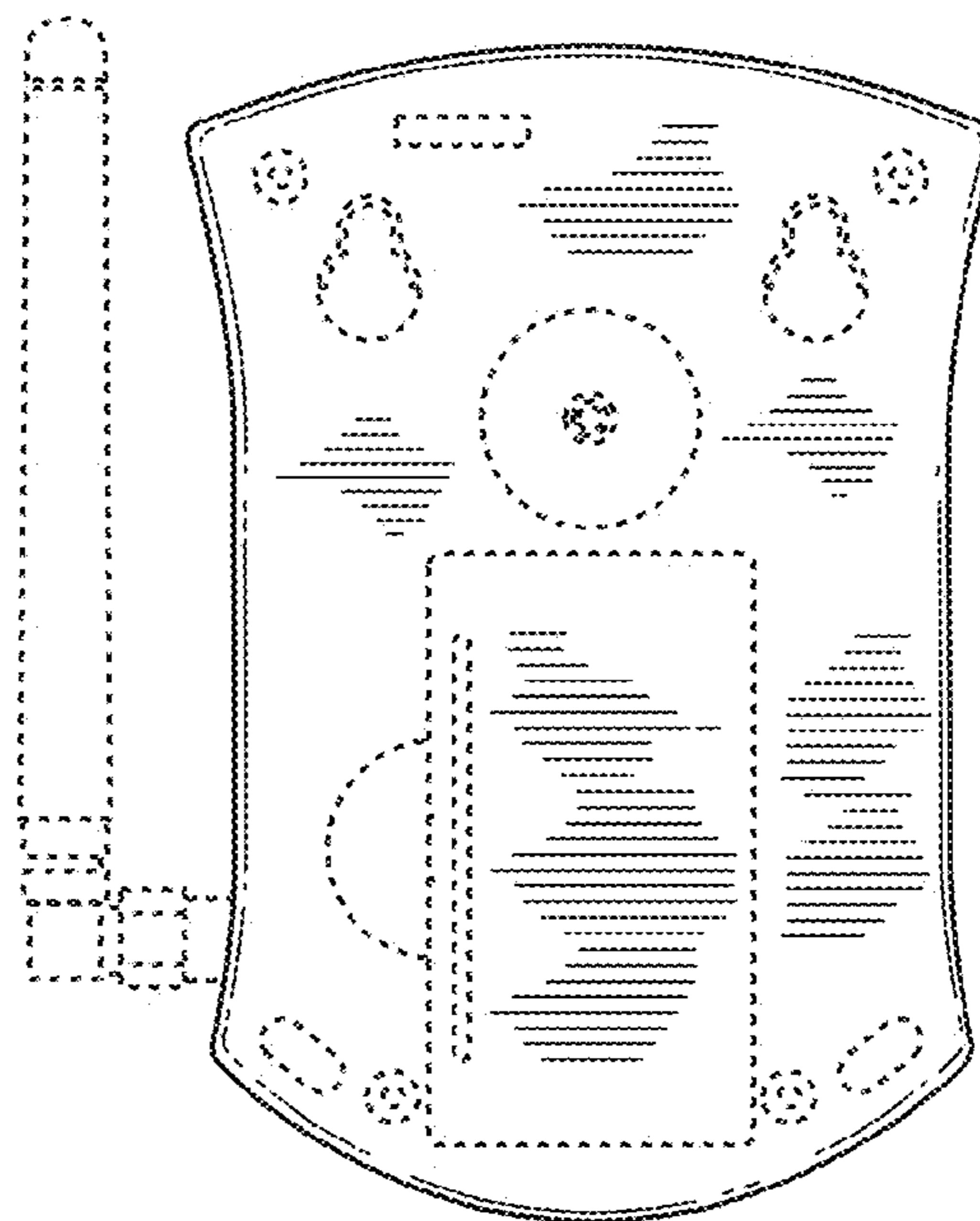

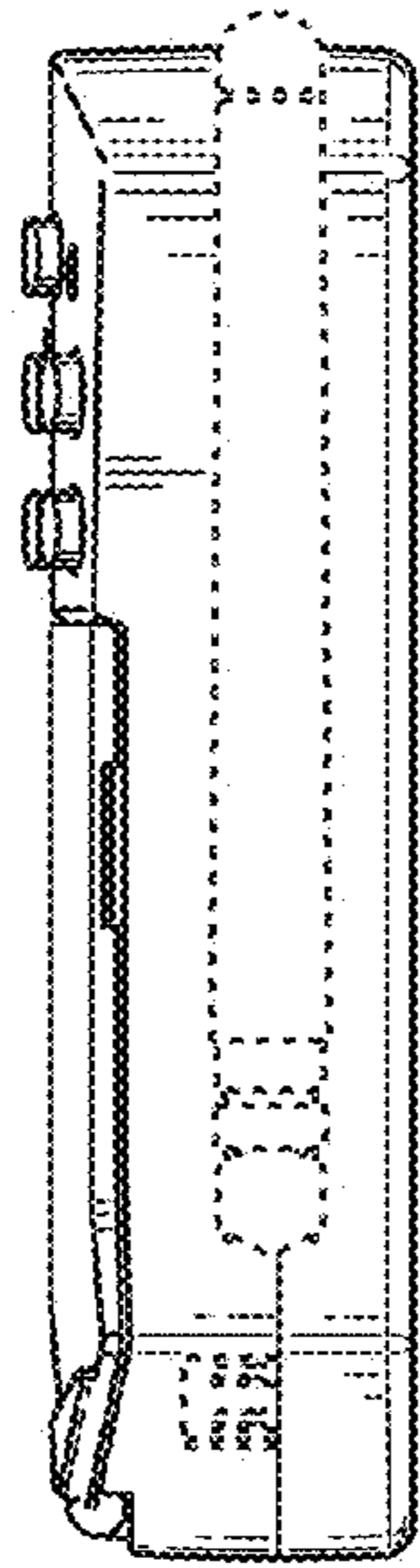

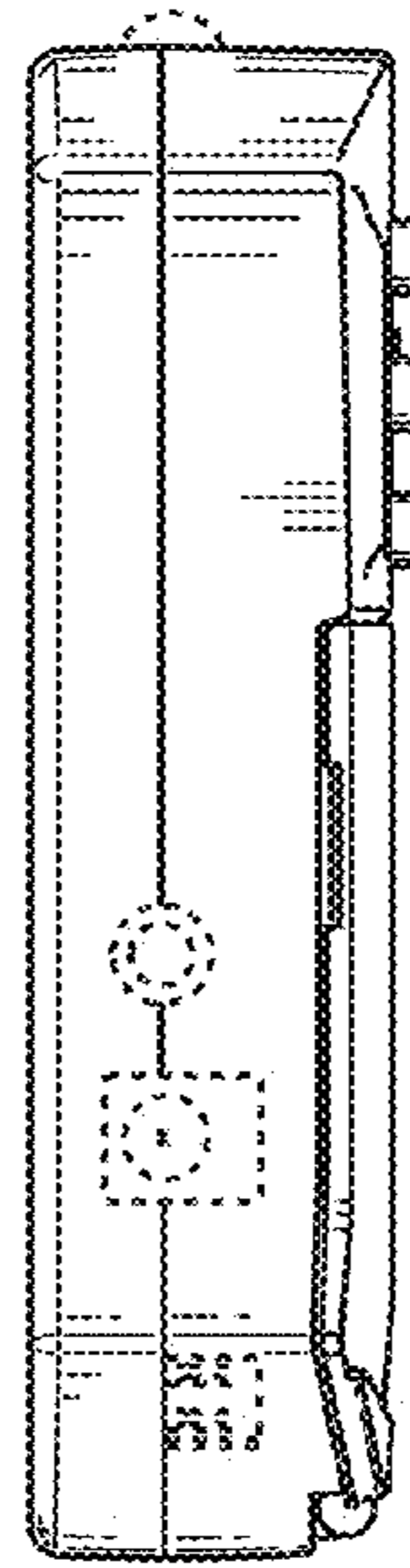

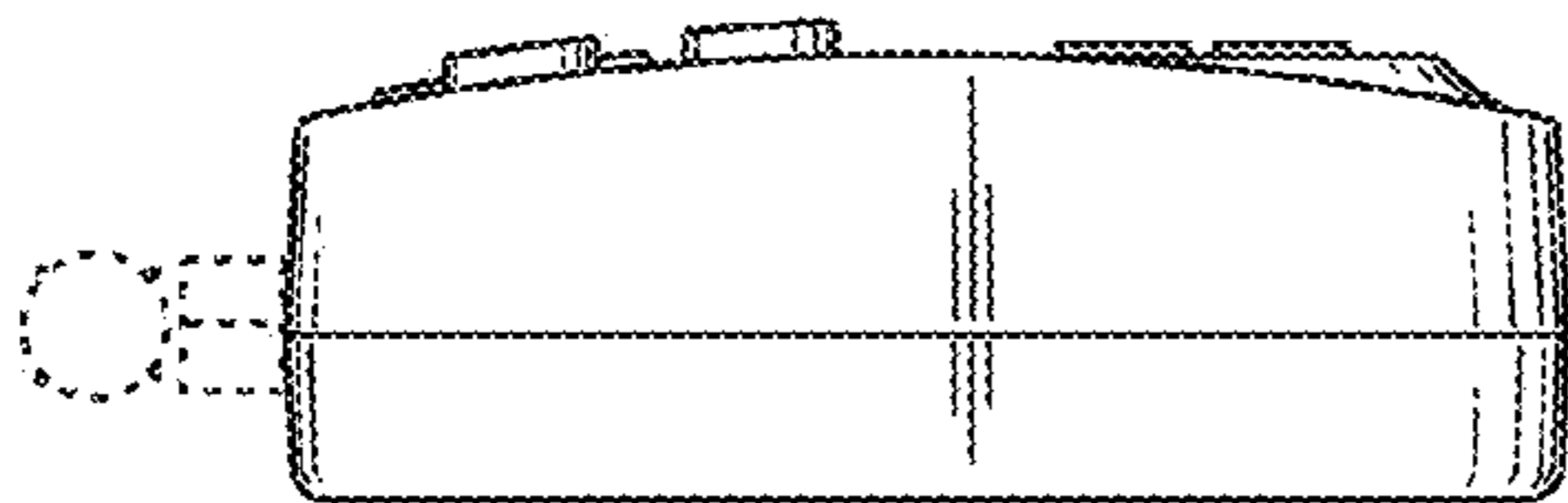

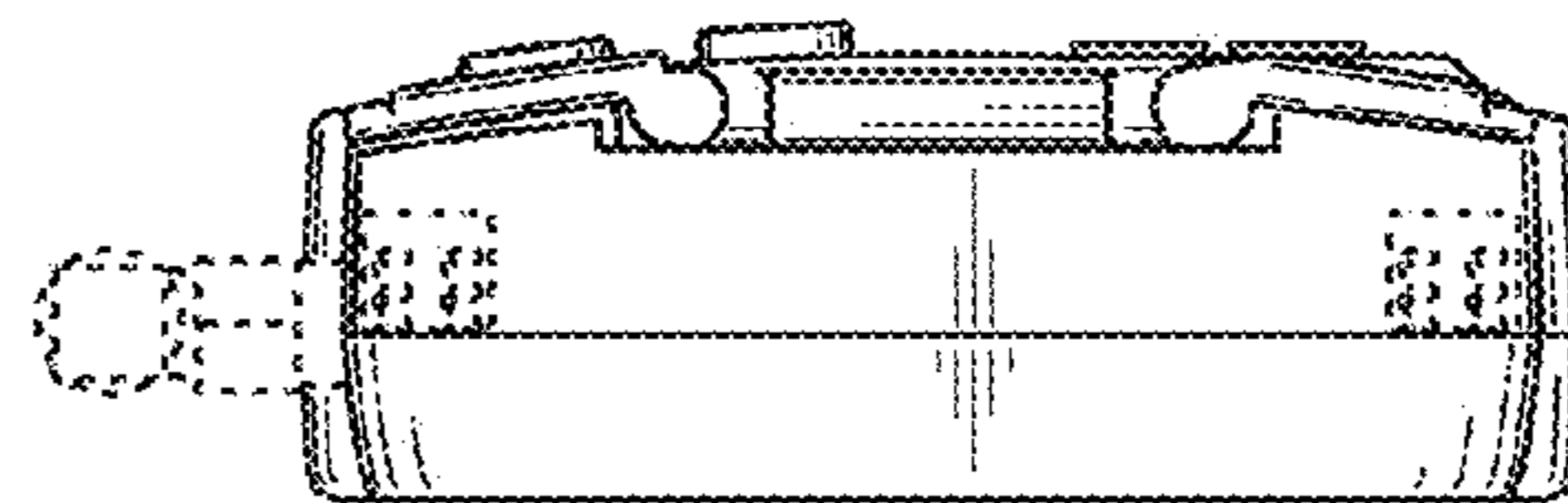
