(57) **CLAIM**

I claim the ornamental design for a case for mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the case for mobile phone showing my new design;

FIG. 2 is a rear view of the case for mobile phone;

FIG. 3 is a left side view of the case for mobile phone;

FIG. 4 is a right side view of the case for mobile phone;

FIG. 5 is a top view of the case for mobile phone;

FIG. 6 is a bottom view of the case for mobile phone;

FIG. 7 is a front, left side, top perspective view of the case for mobile phone;

FIG. 8 is a front, right side, top perspective view of the case for mobile phone;

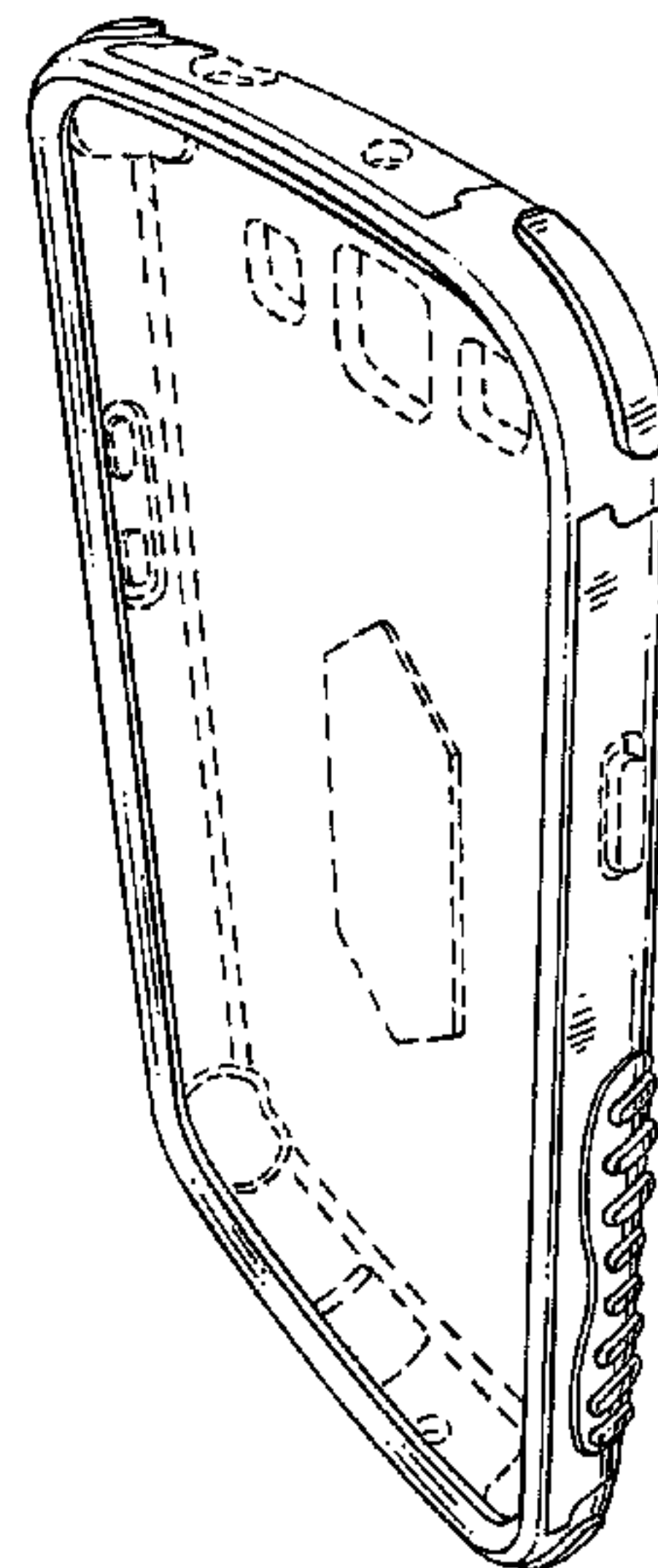
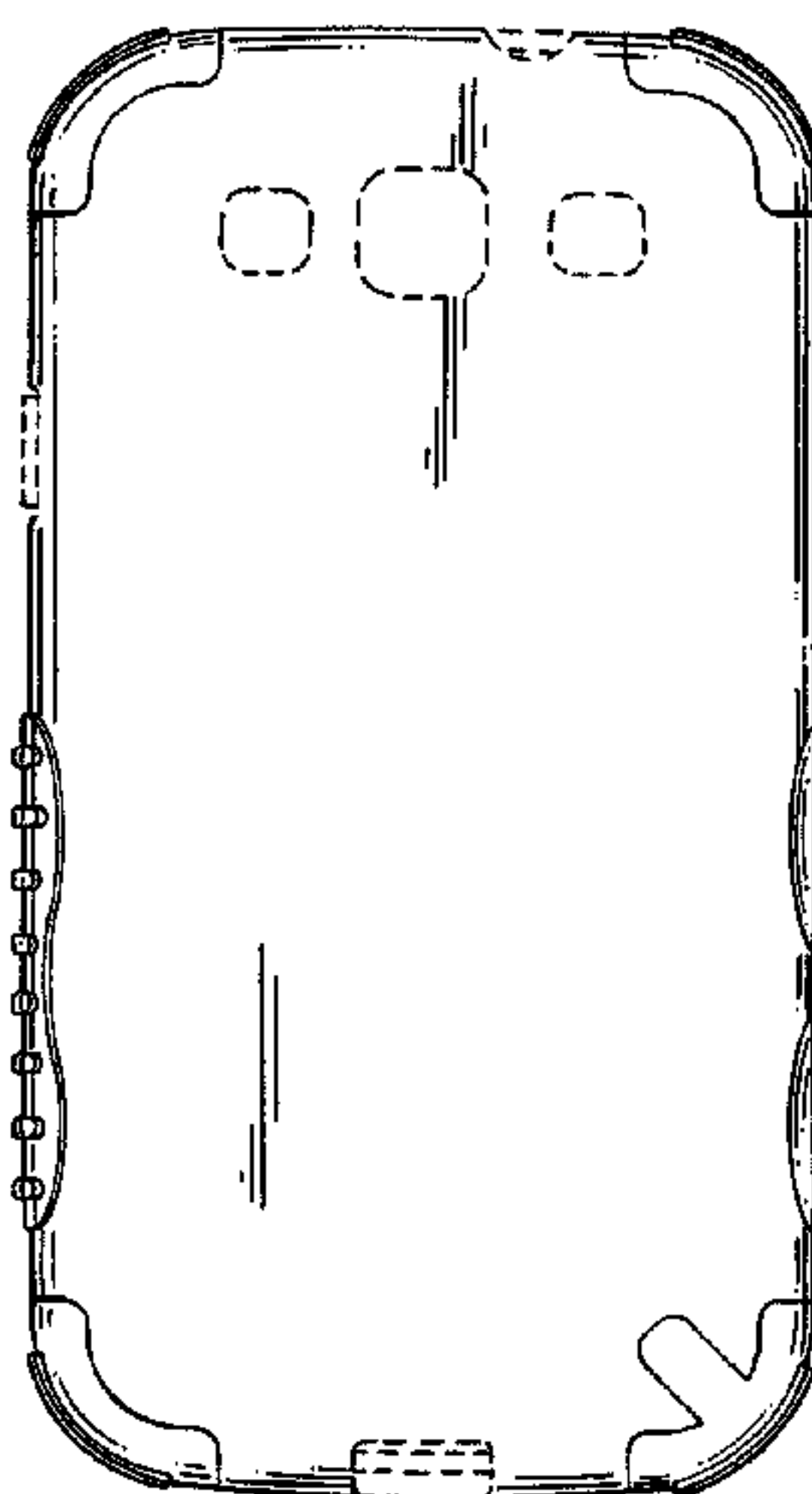
FIG. 9 is a front, right side, bottom perspective view of the case for mobile phone;

FIG. 10 is a front, left side, bottom perspective view of the case for mobile phone; and,

FIG. 11 is a rear, right side, top perspective view of the case for mobile phone.

The interior of the case for mobile phone, shown in FIGS. 1, and 7-10 as unshaded surfaces and broken lines on the unshaded surfaces, forms no part of the claimed design. The broken lines on the exterior of the case that are immediately adjacent the shaded surfaces represent boundaries of the claimed design. All other broken lines throughout the drawing figures depict unclaimed environment. The broken lines form no part of the claimed design.

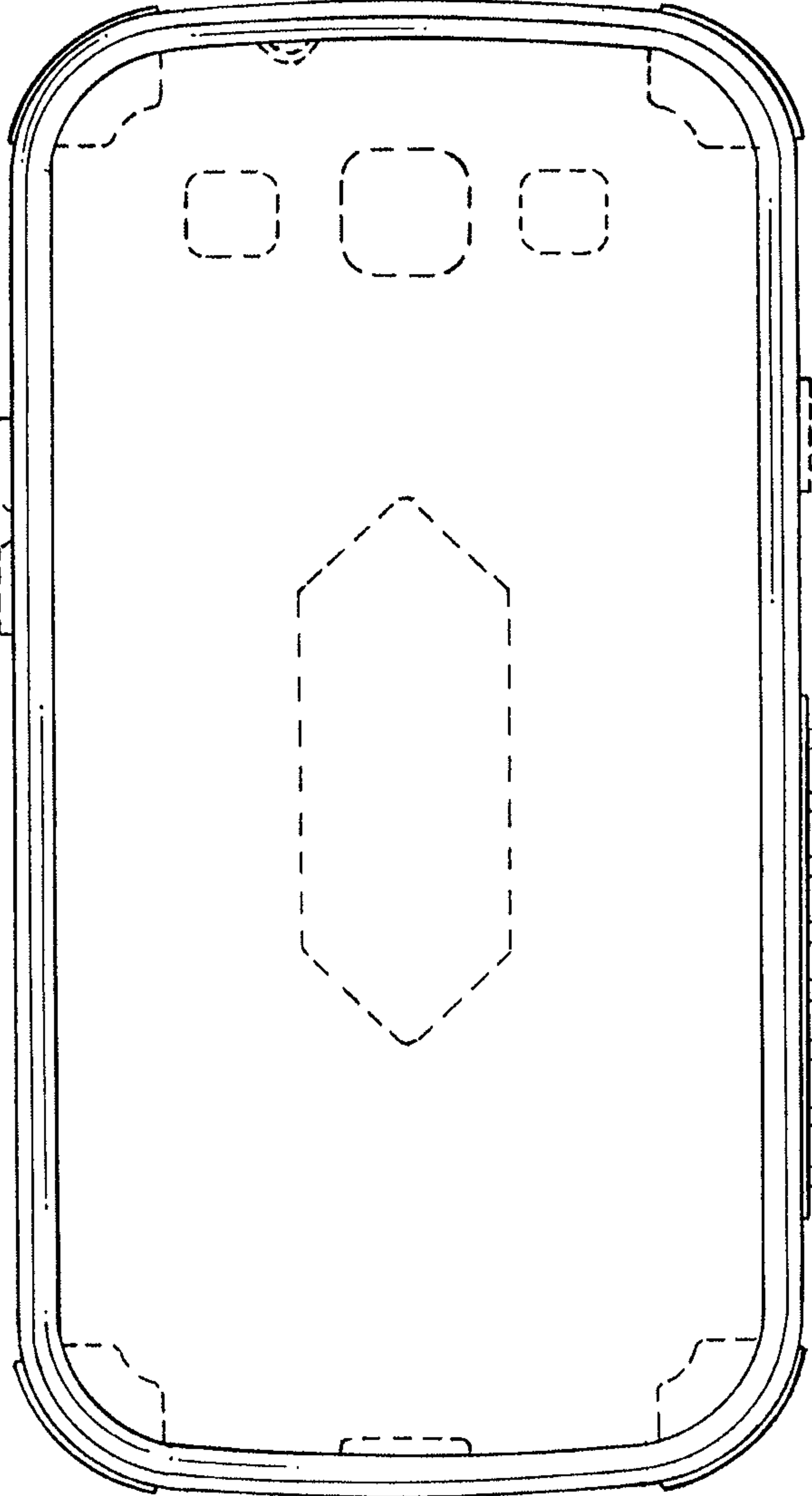

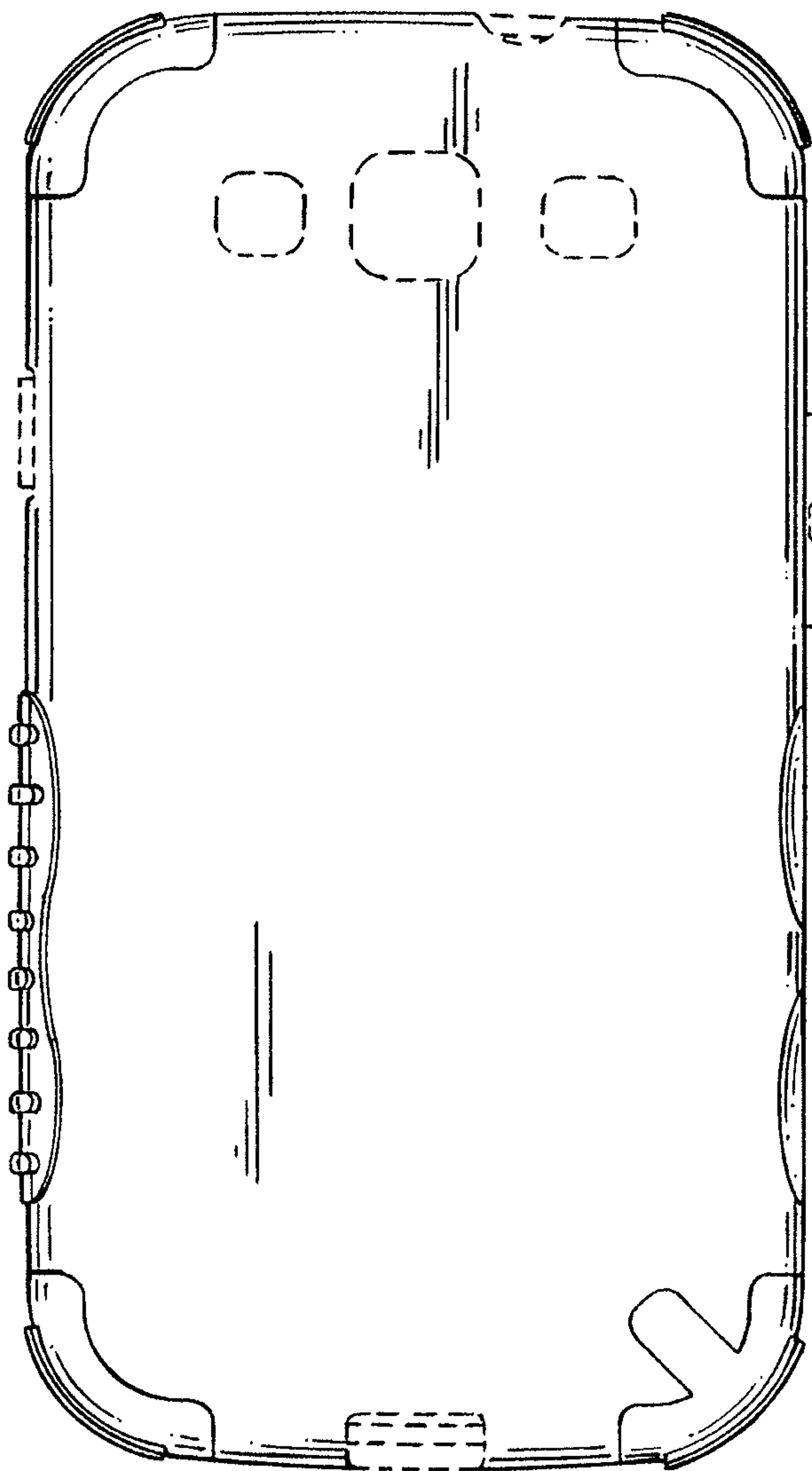

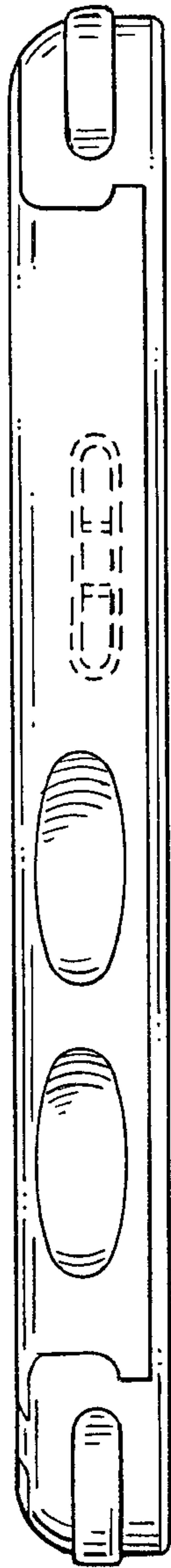

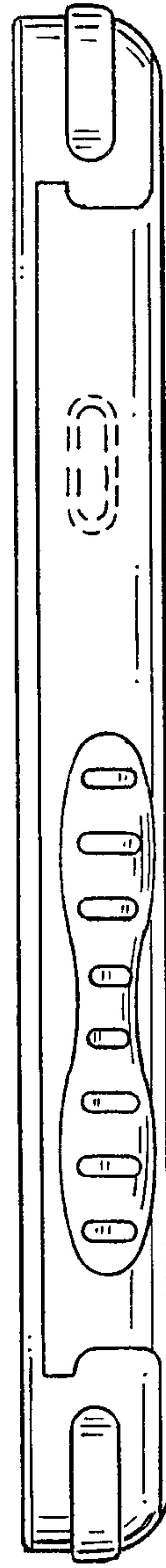

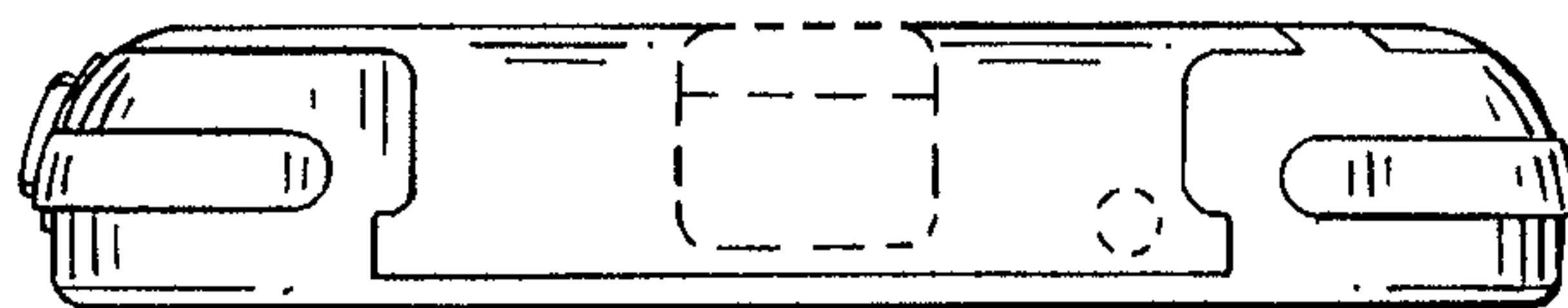

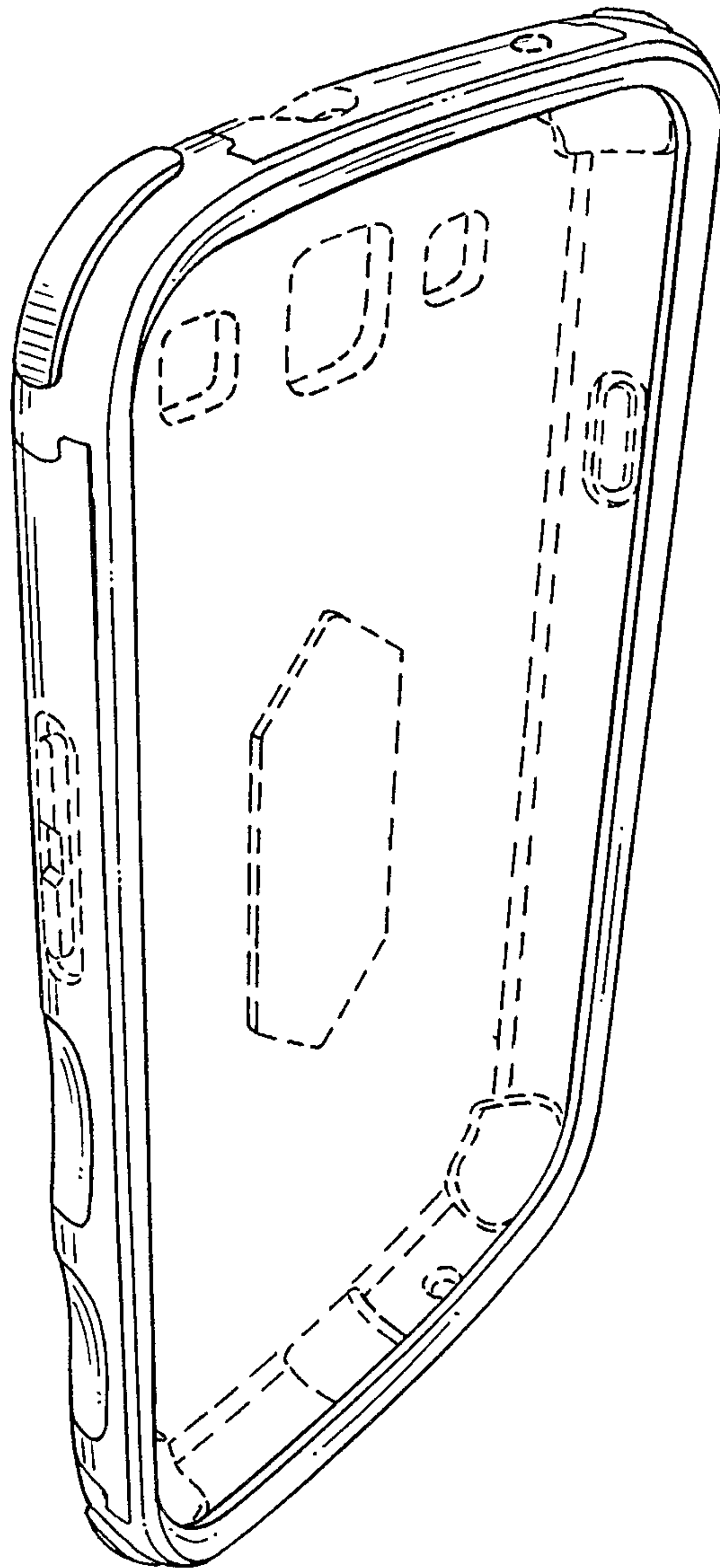

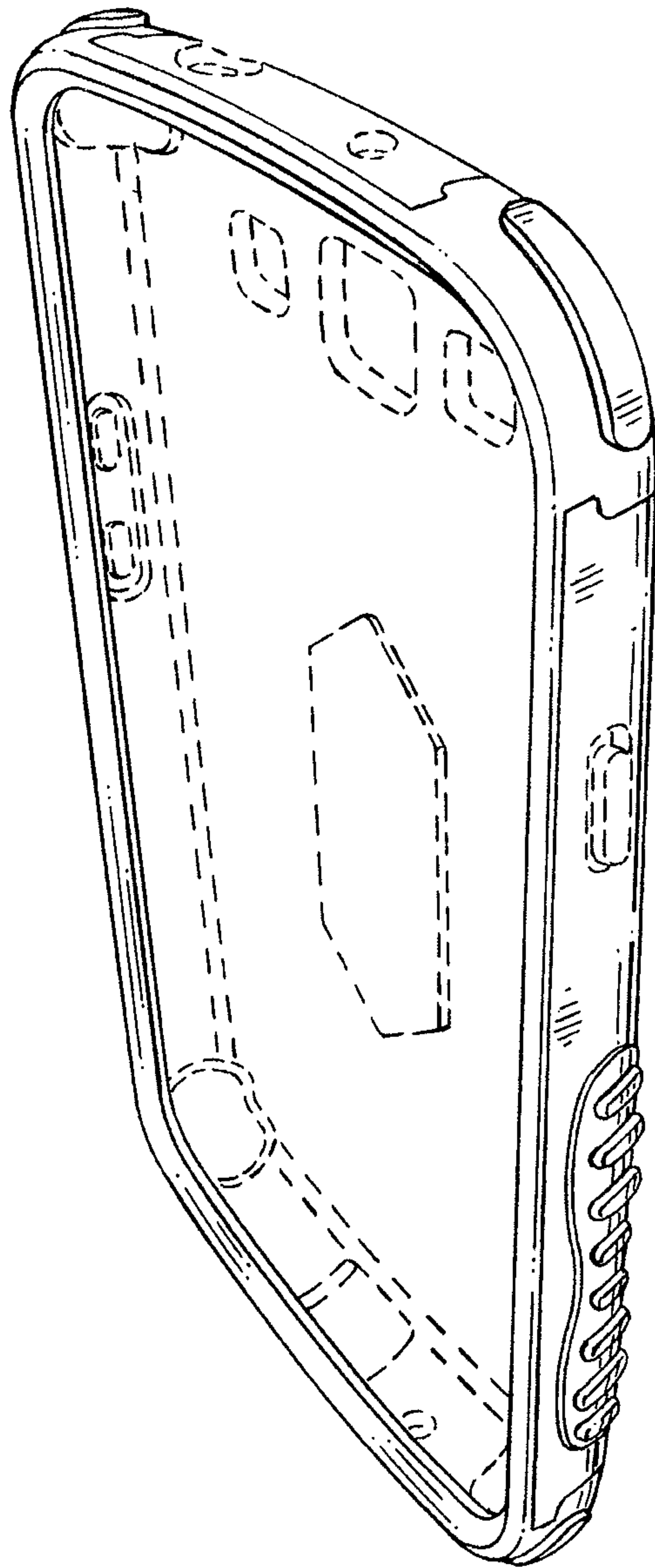

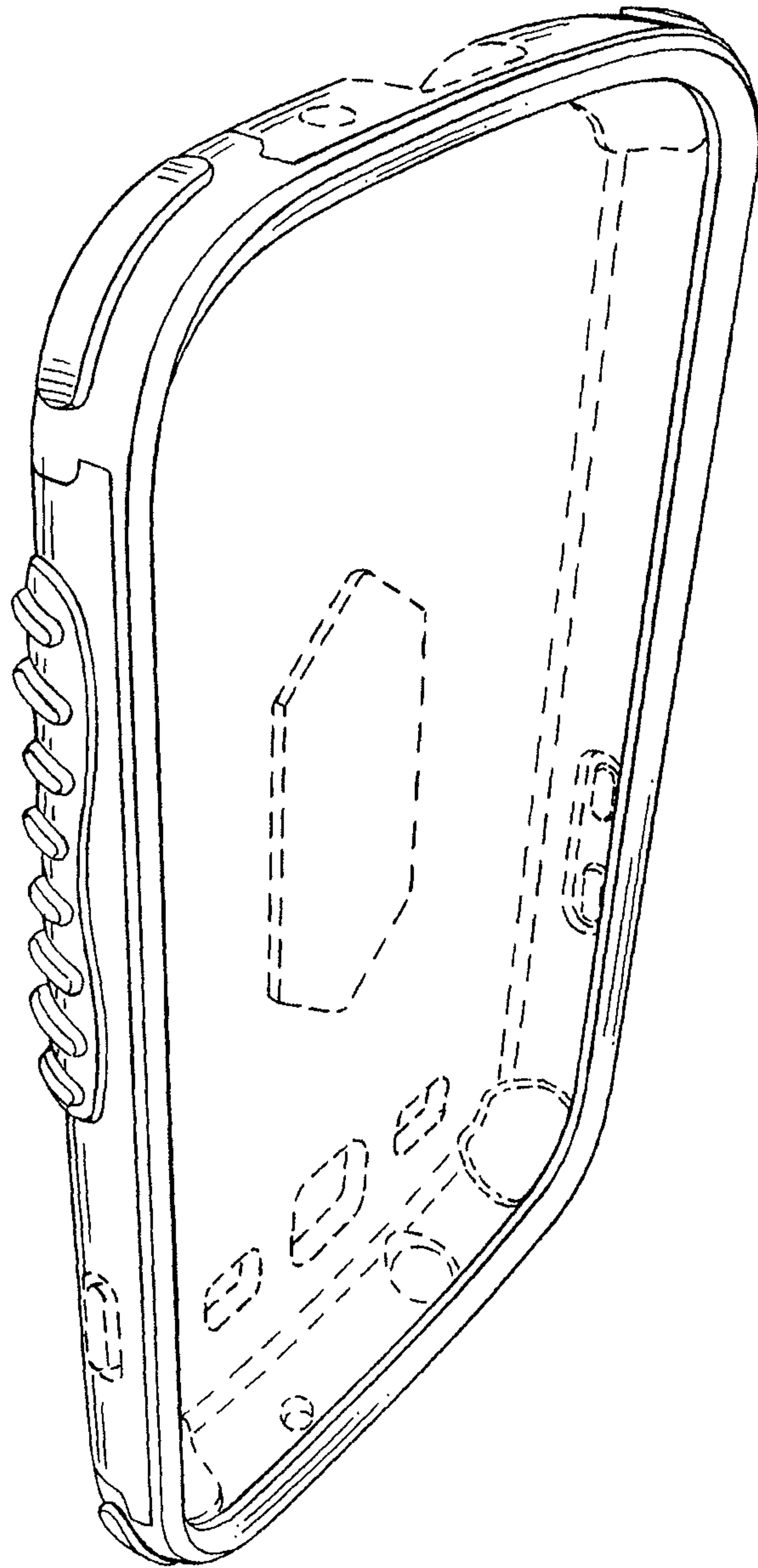

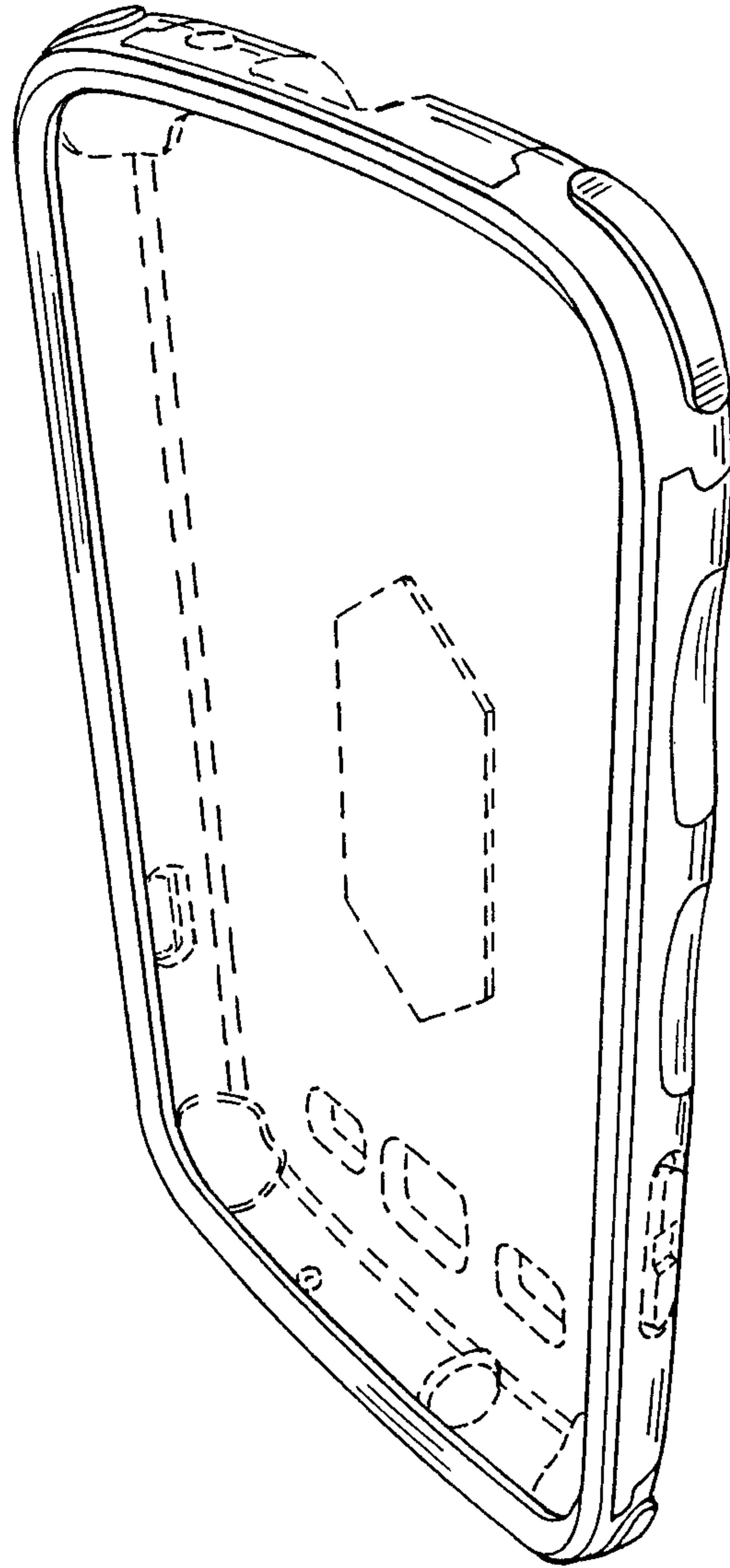

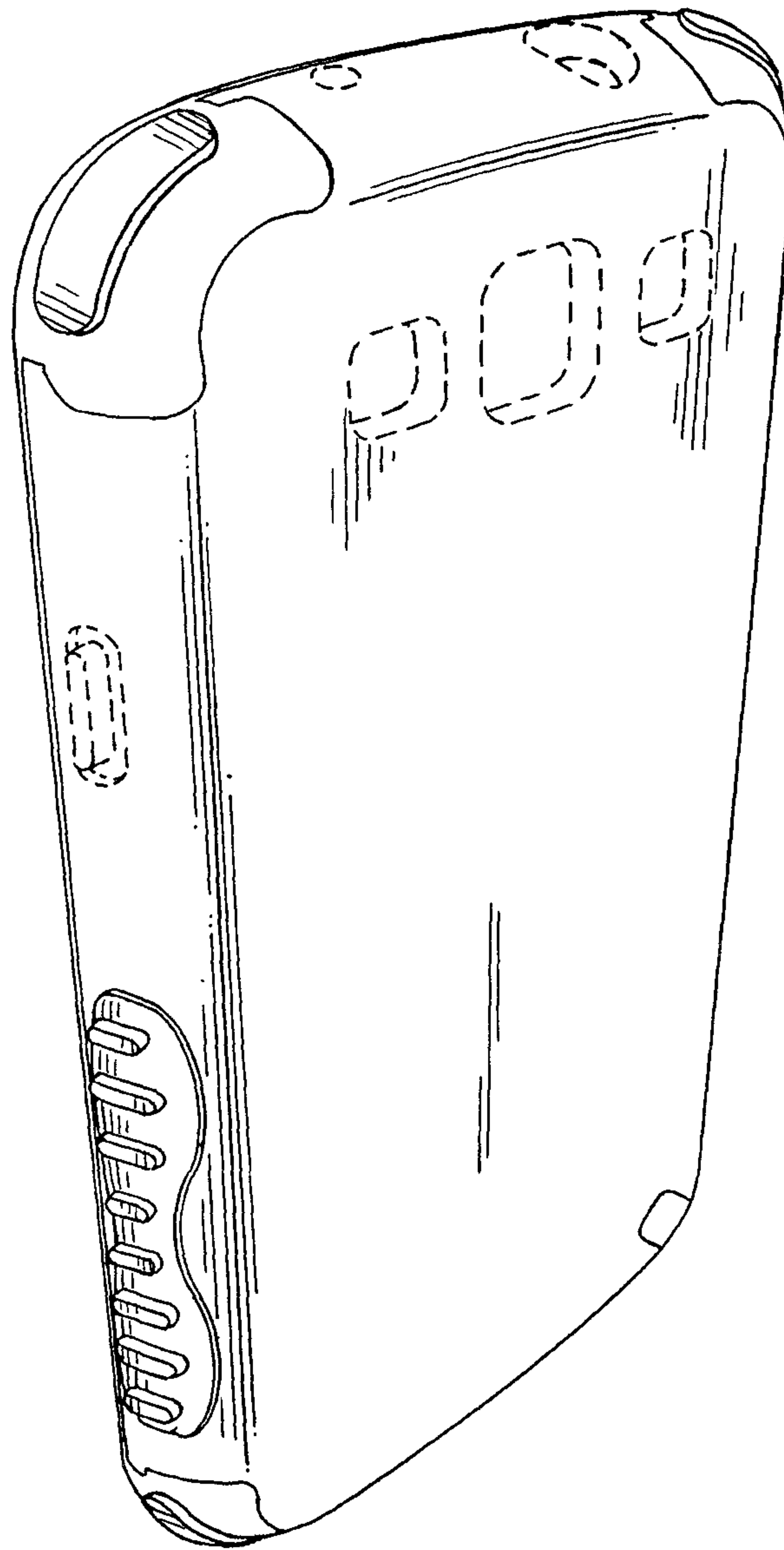
