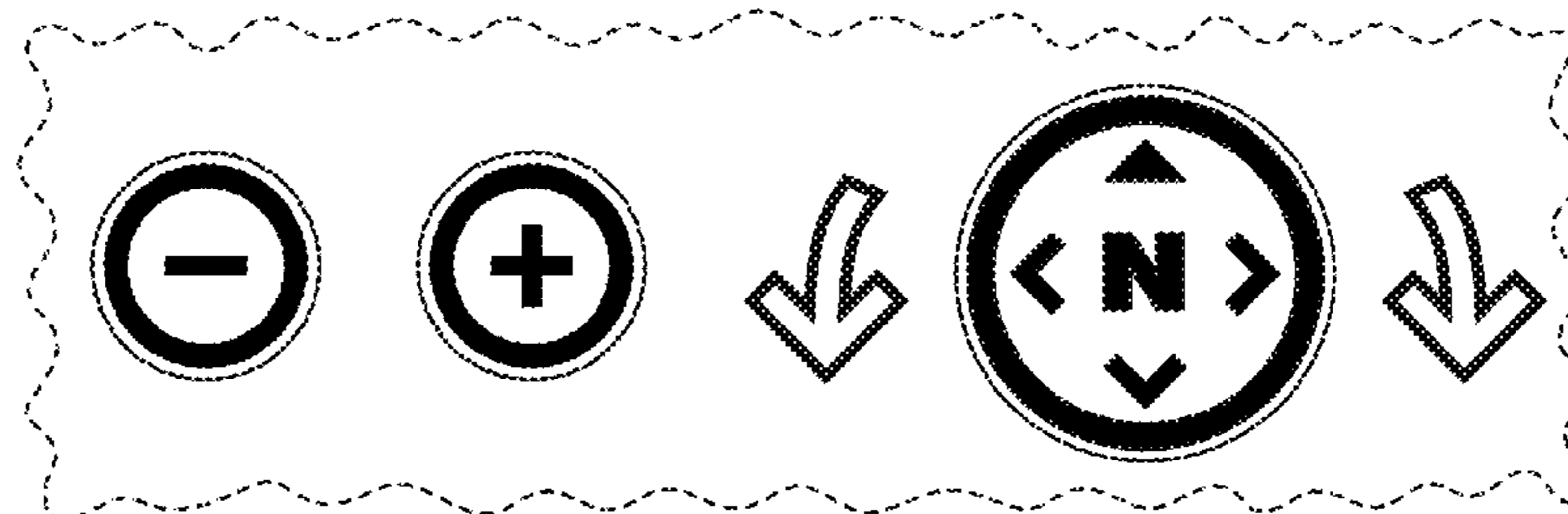
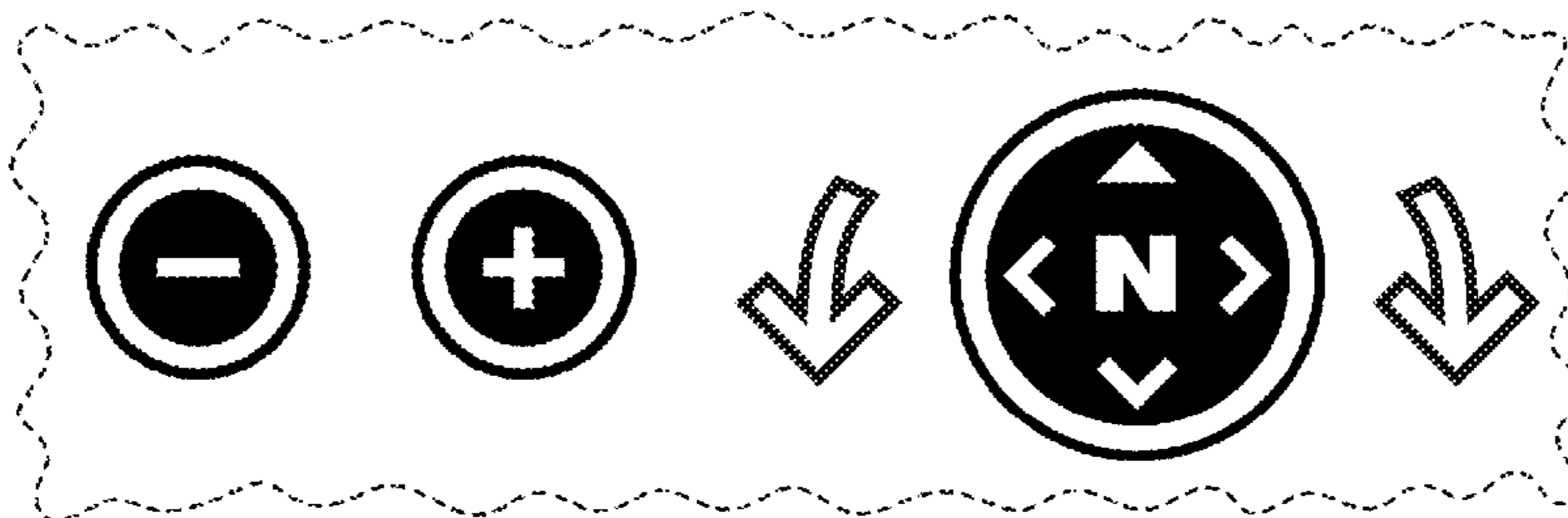
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing our new design;

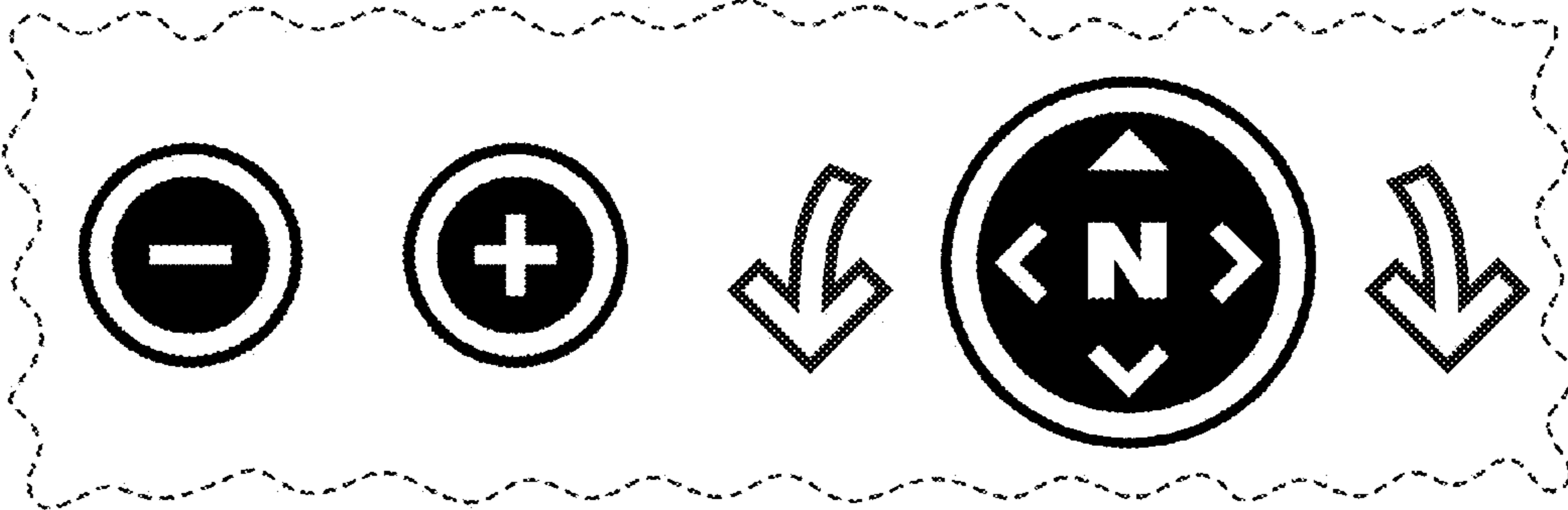

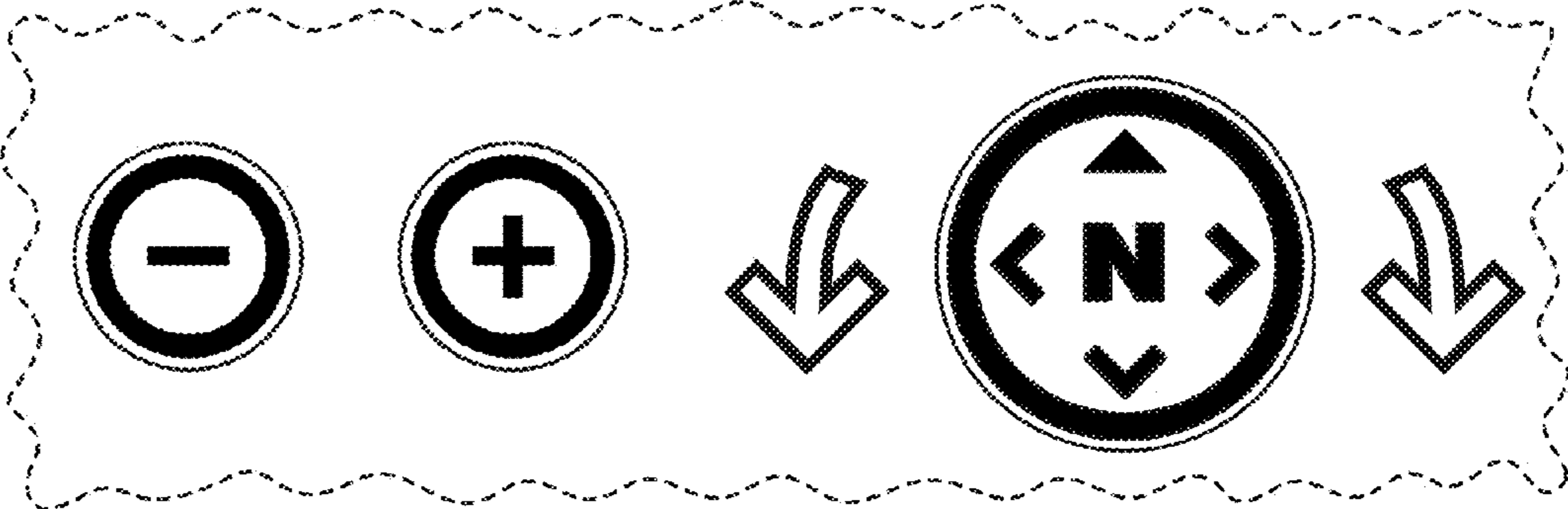

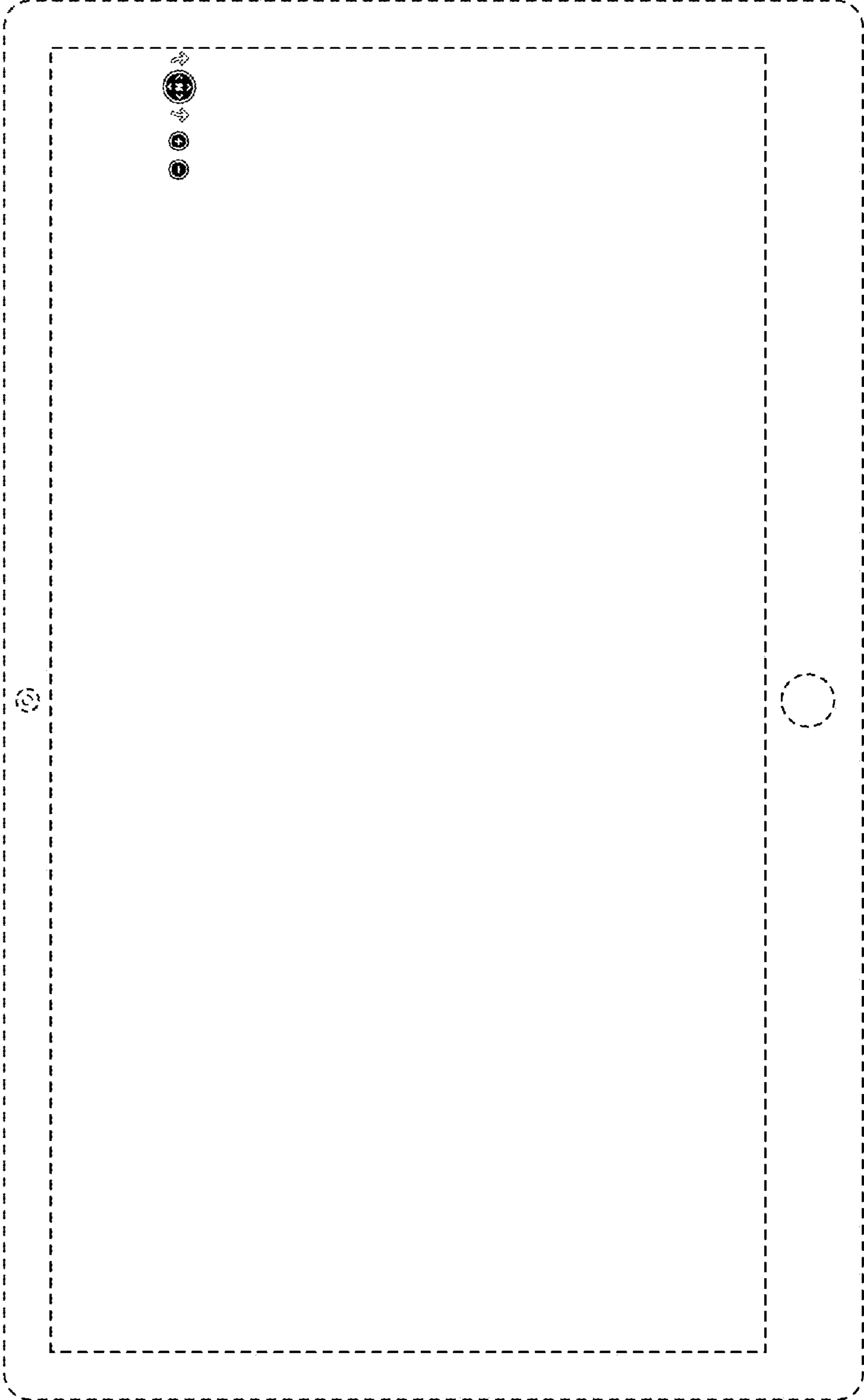

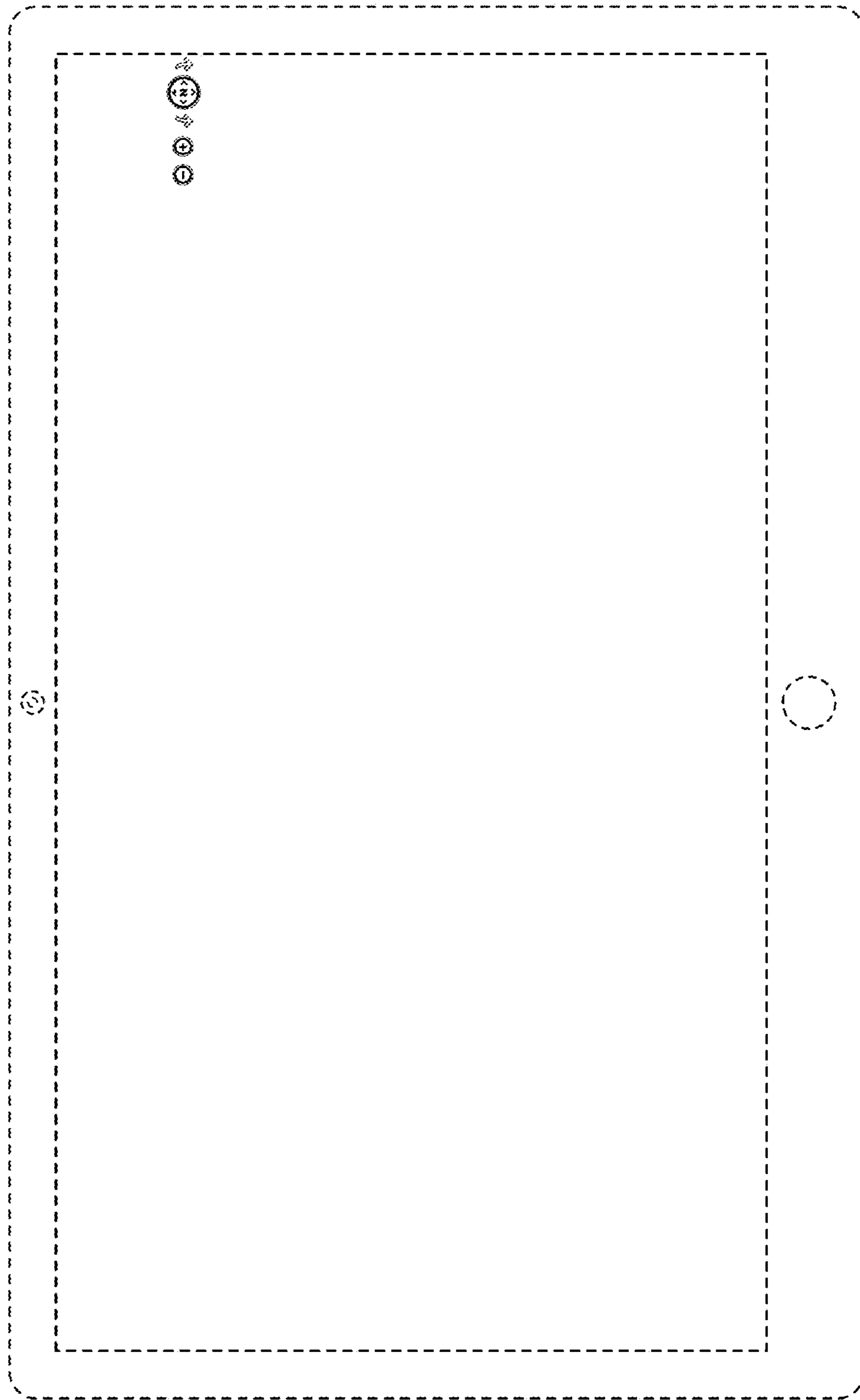
