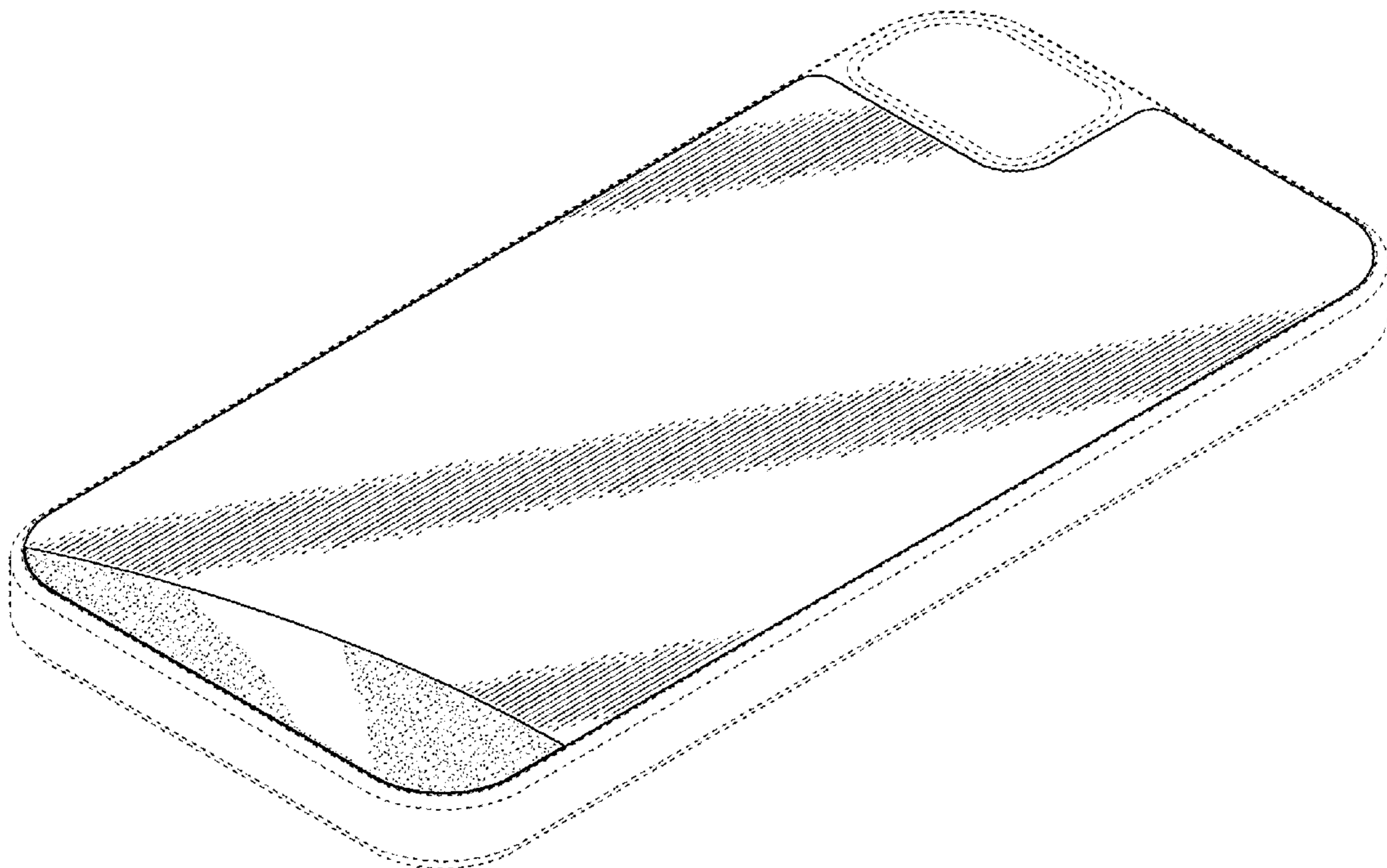
(57) **CLAIM**

The ornamental design for a back panel of a case for an electronic device, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a back panel of a case for an electronic device showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a top plan view thereof;

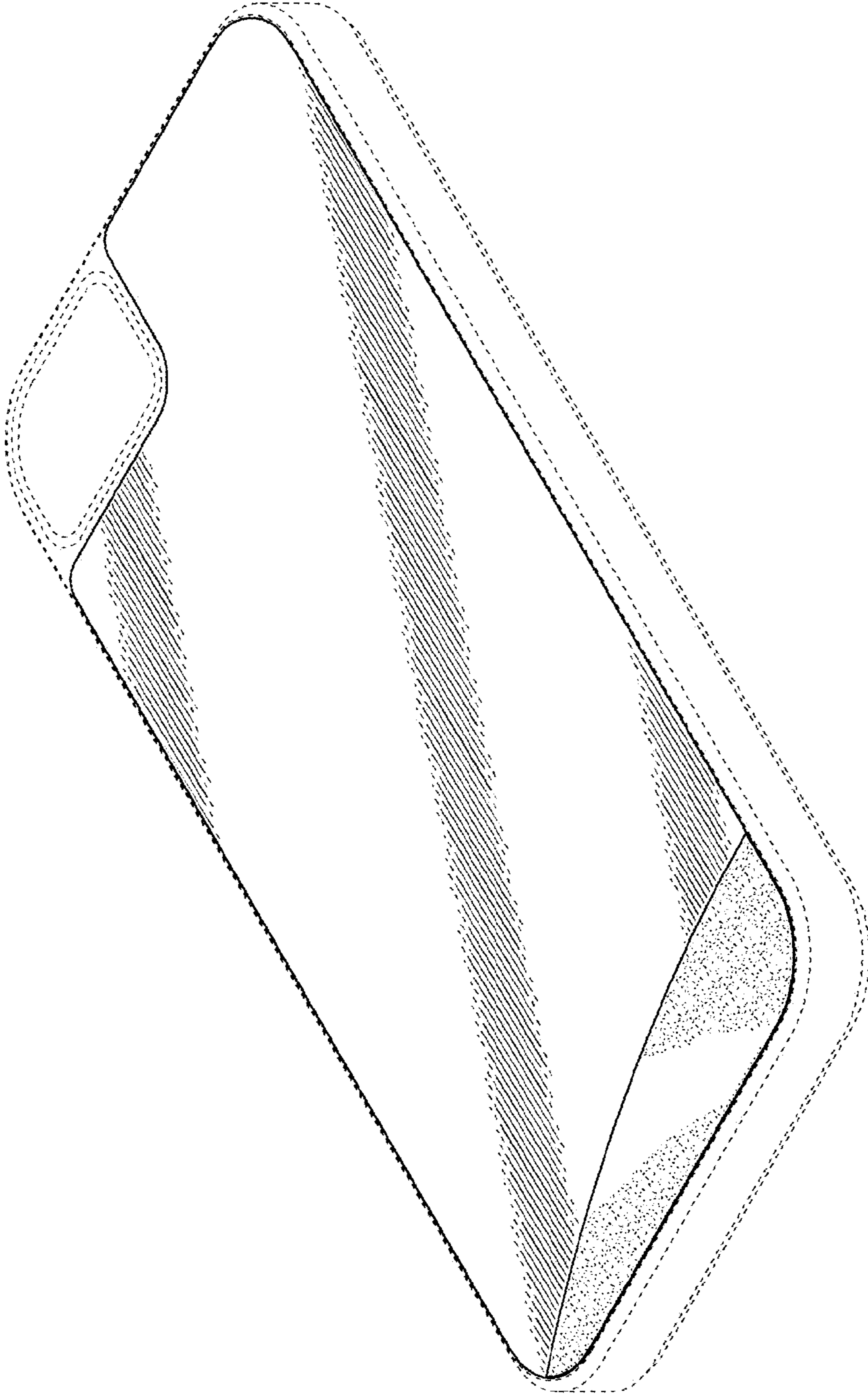

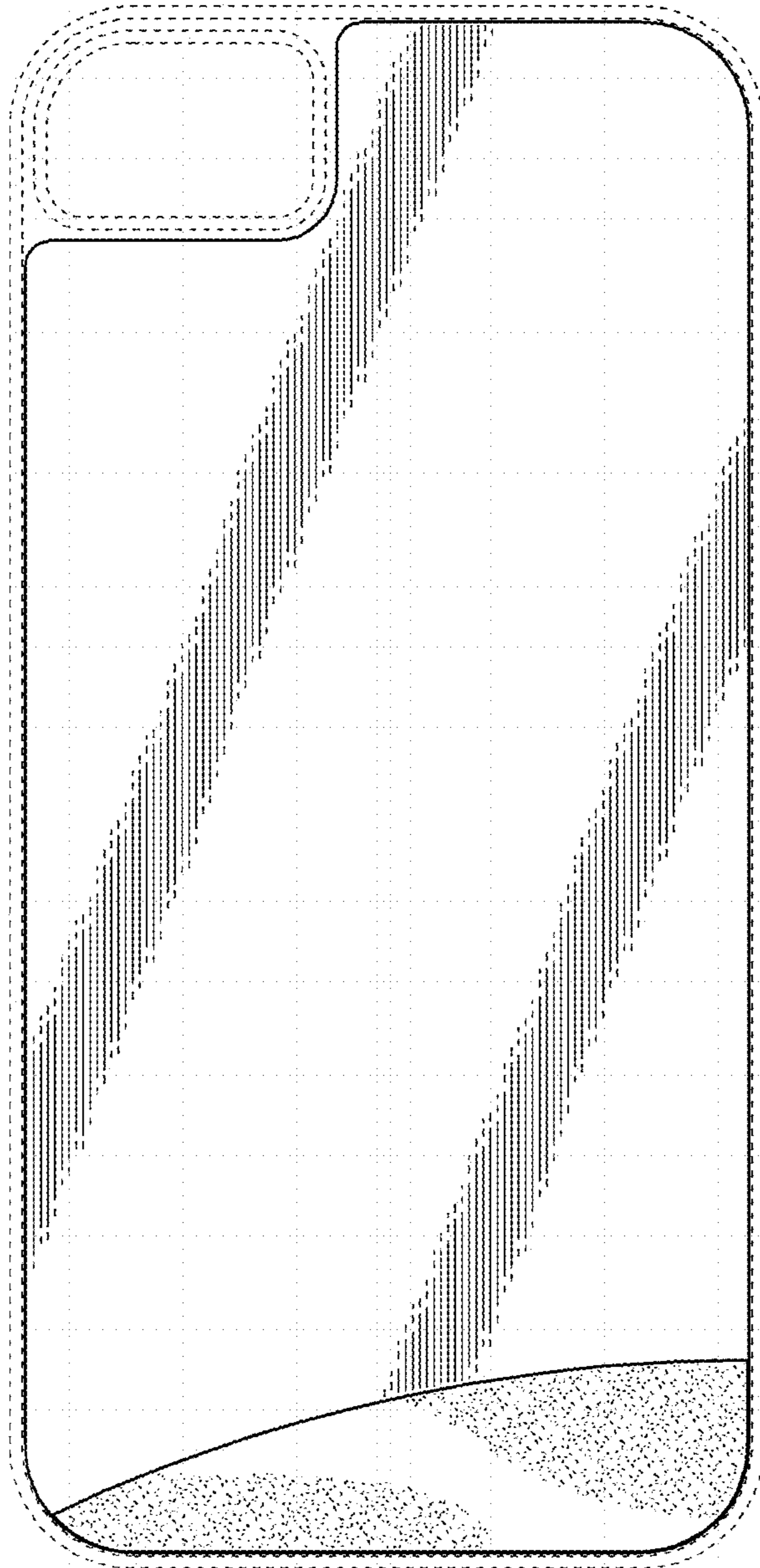

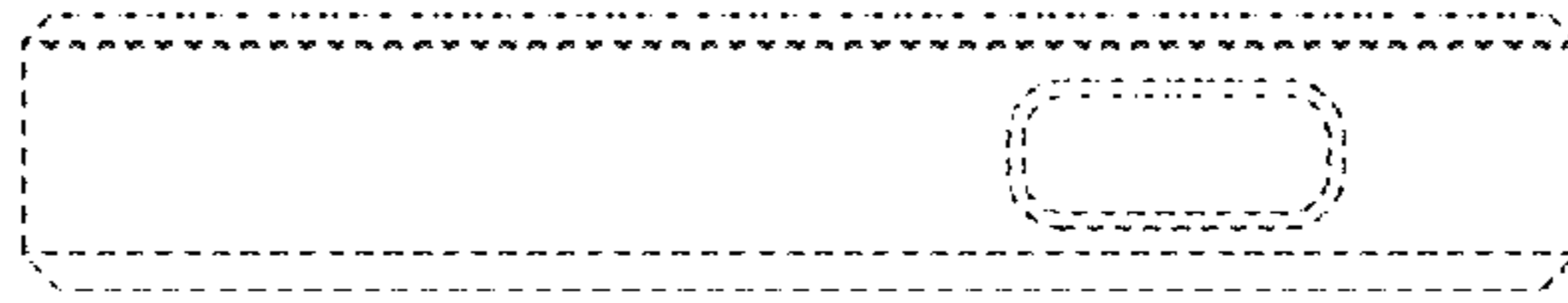

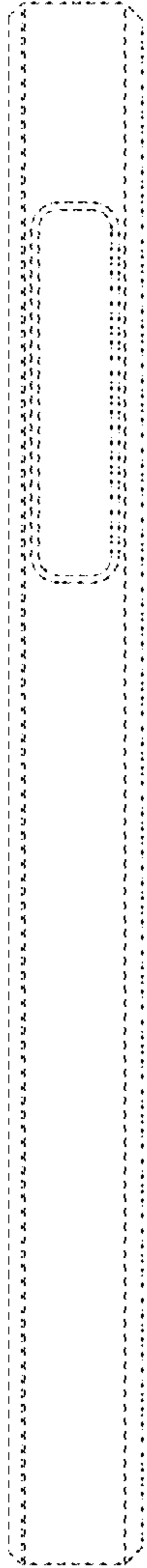

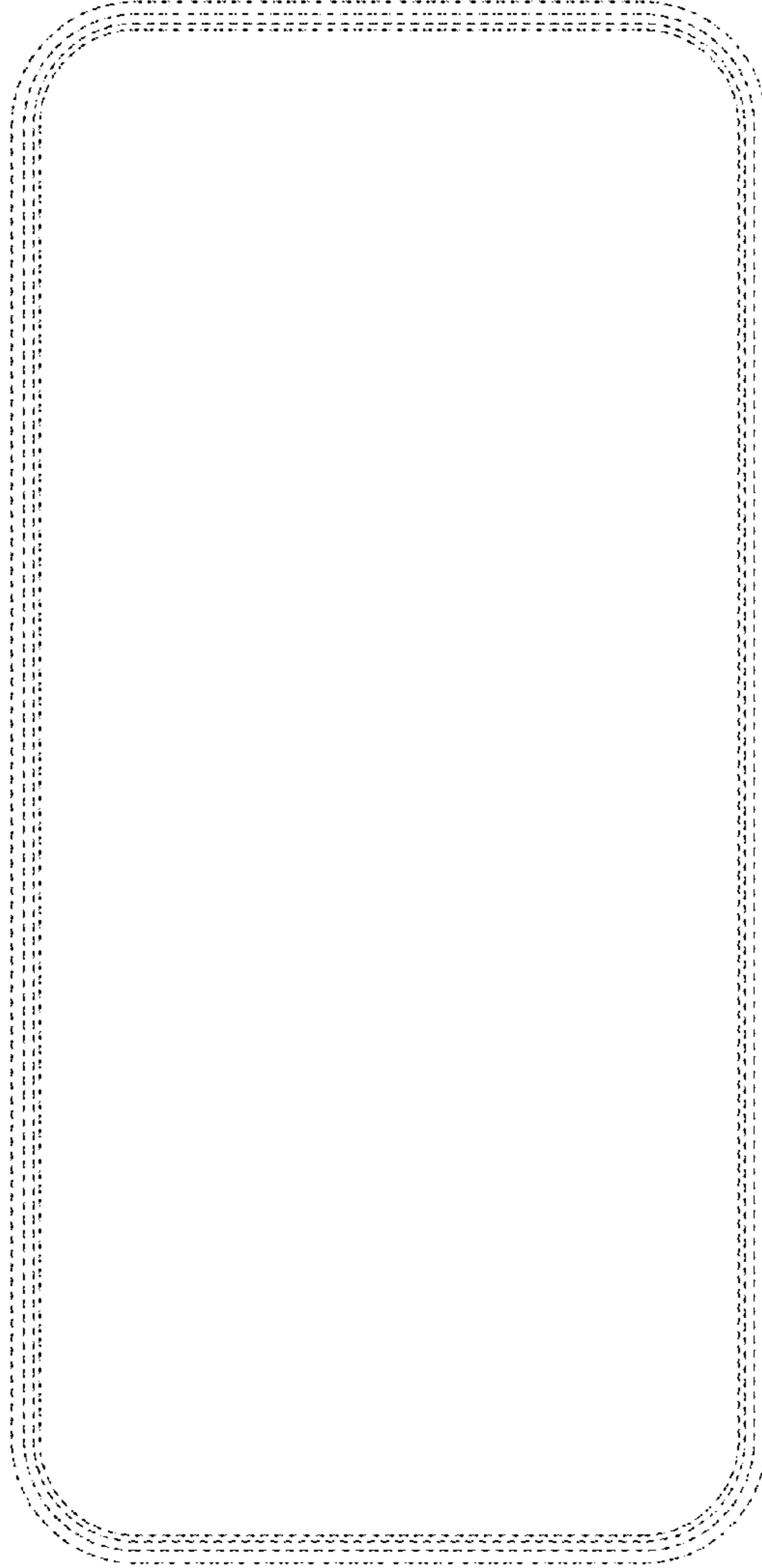

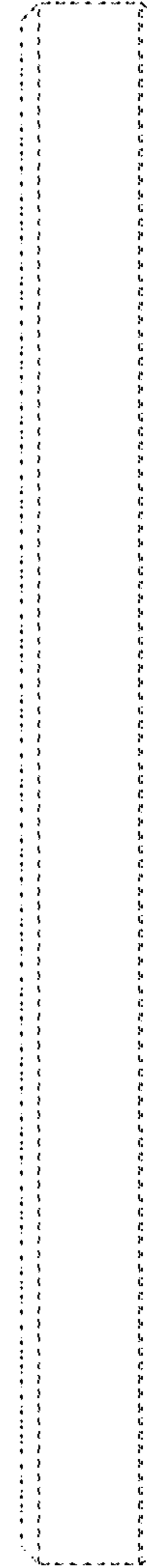

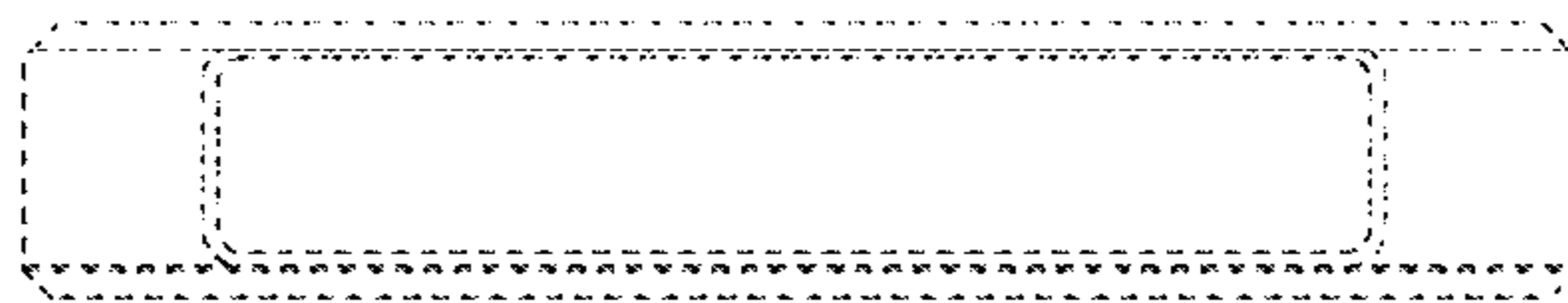
