(57) **CLAIM**

We claim the ornamental design for an electronic piano, as shown and described.

DESCRIPTION

FIG. 1 is a reference perspective view of the electronic piano showing a state in which the music desk is erected and the piano lid is opened according to the claimed design.

FIG. 2 is a reference perspective view of the electronic piano showing a state in which the music desk is brought down and the piano lid is closed according to the claimed design.

FIG. 3 is a front view of the electronic piano according to the claimed design.

FIG. 4 is a rear view of the electronic piano according to the claimed design.

FIG. 5 is a left-side view of the electronic piano according to the claimed design.

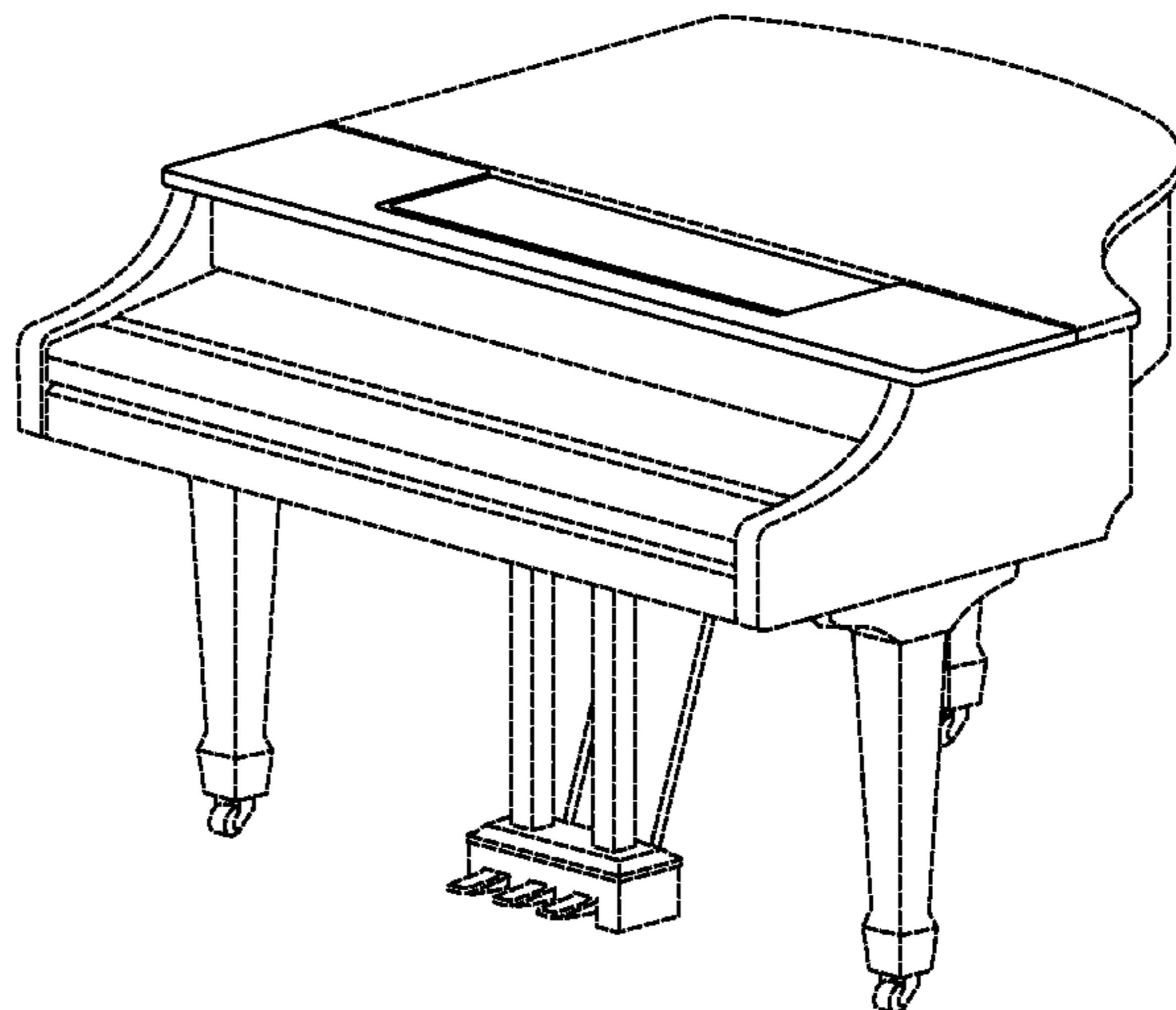
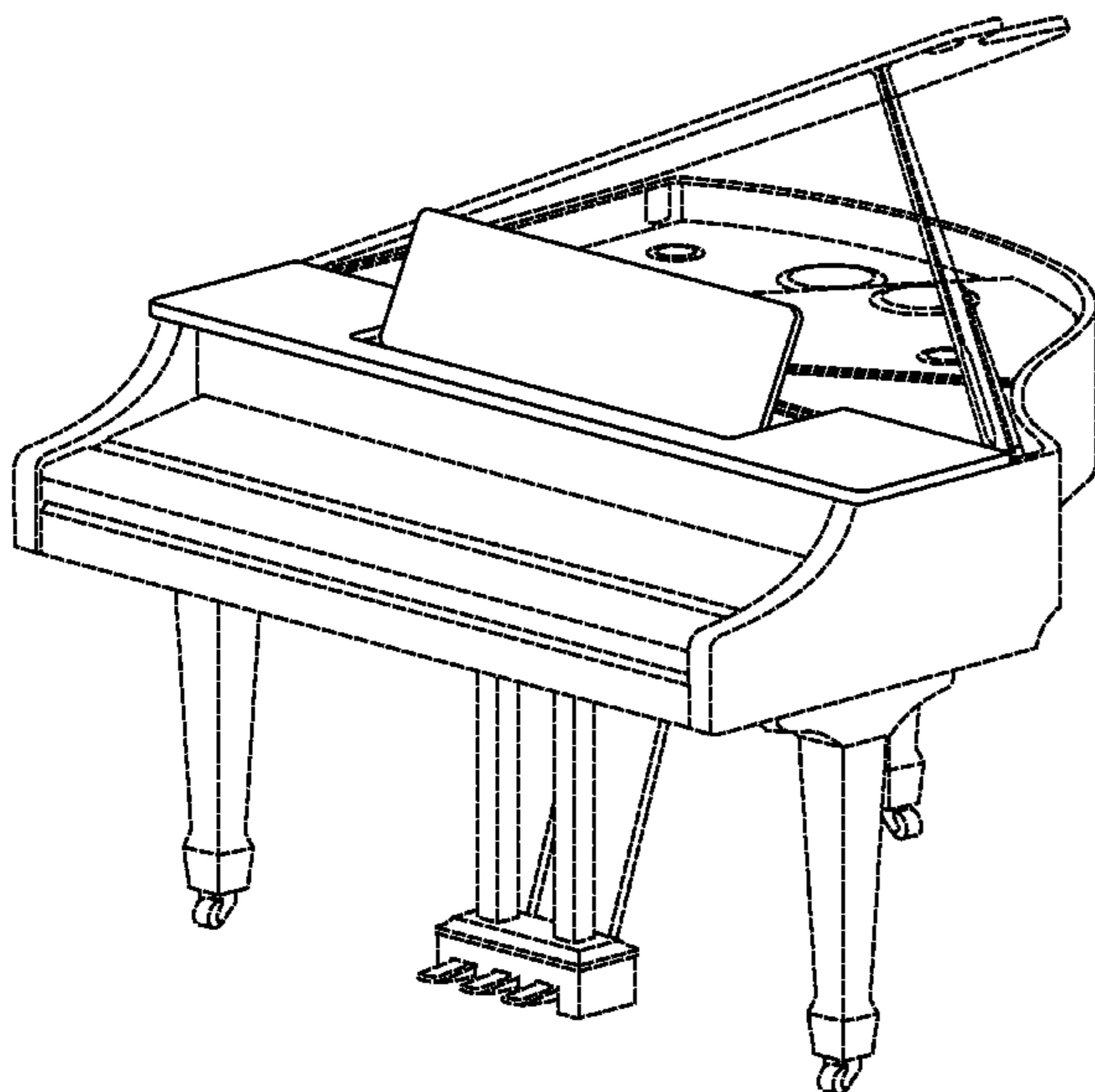
FIG. 6 is a right-side view of the electronic piano according to the claimed design.

FIG. 7 is a plan view of the electronic piano according to the claimed design; and,

FIG. 8 is a bottom view of the electronic piano according to the claimed design.

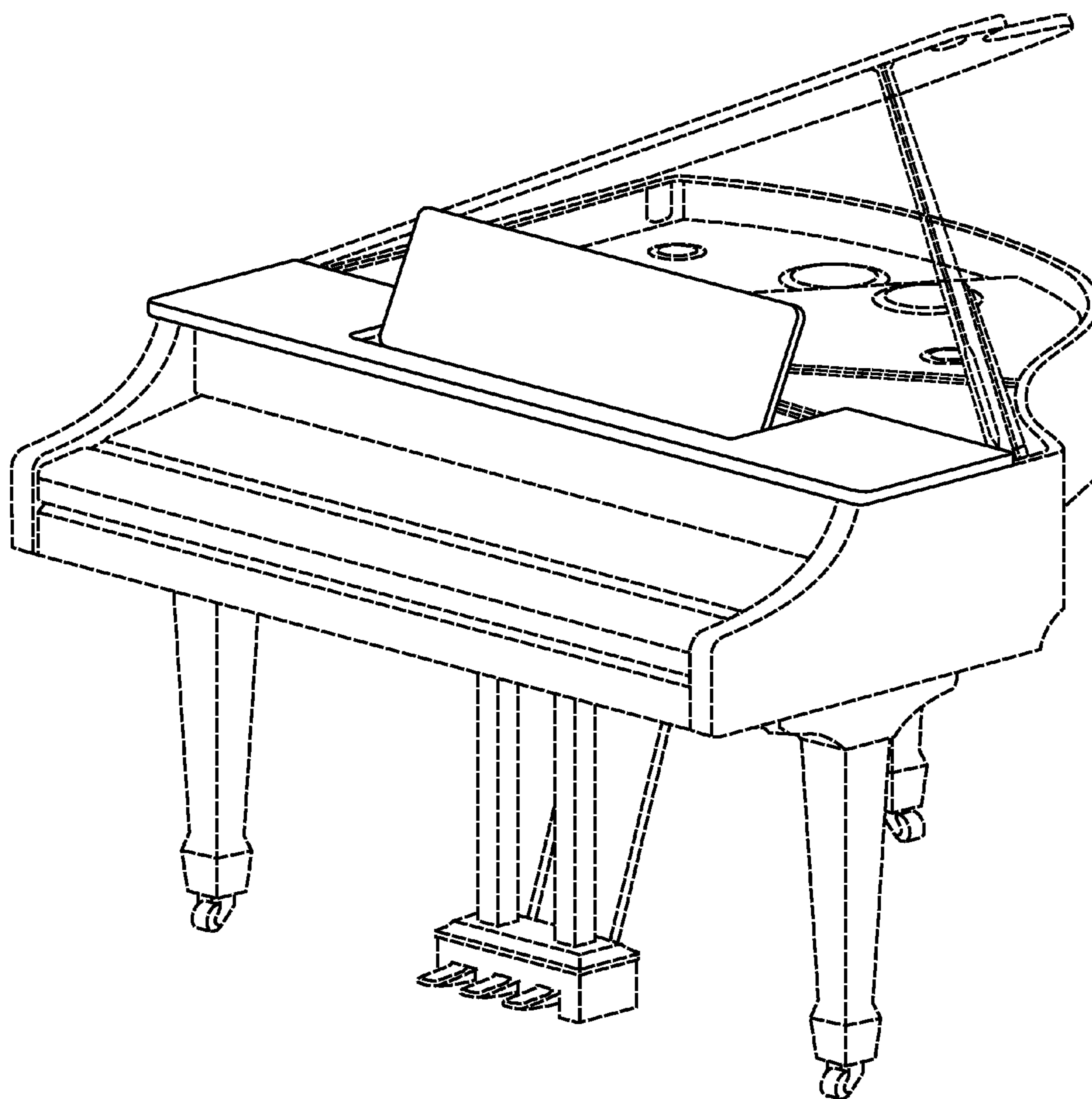

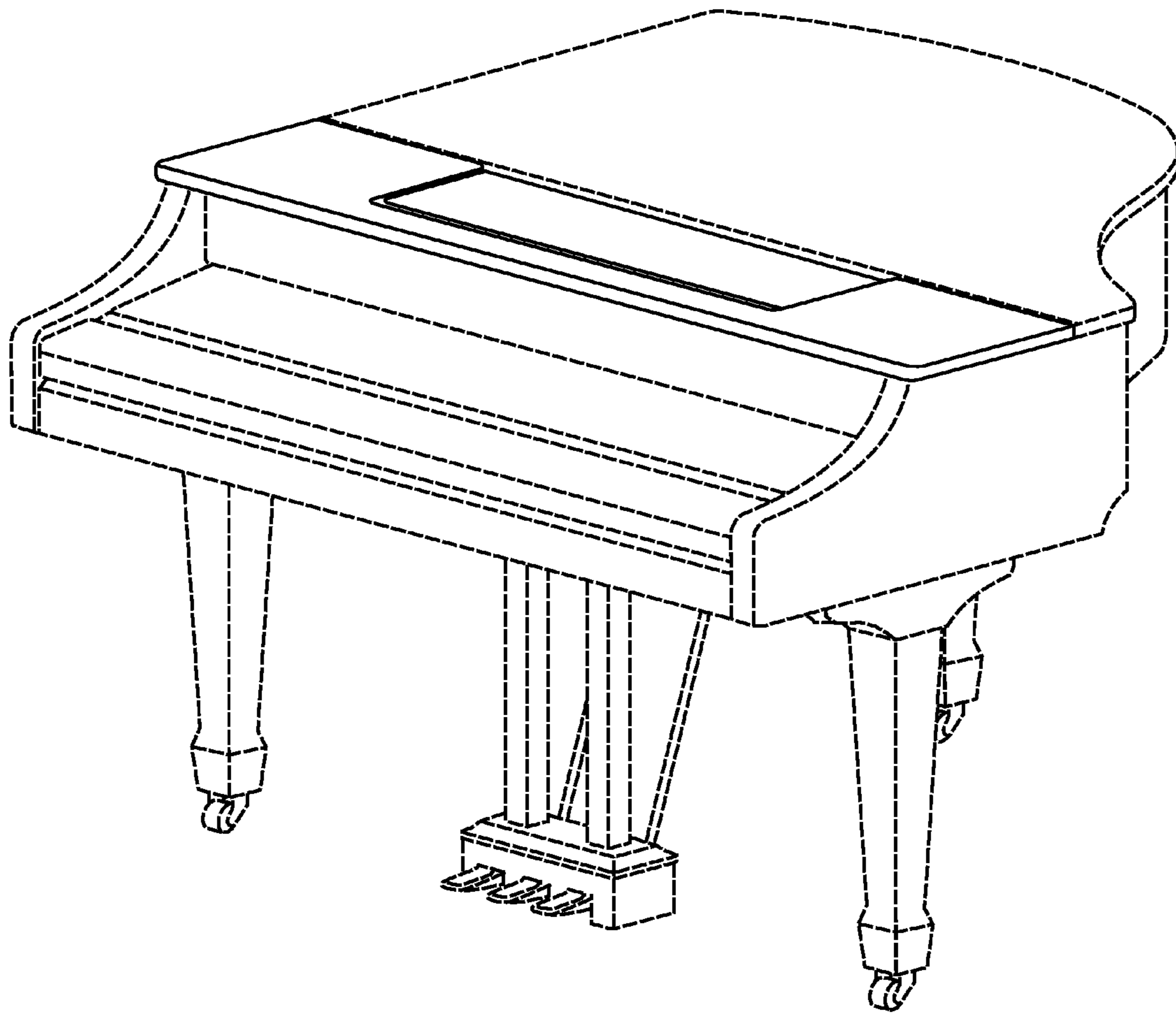

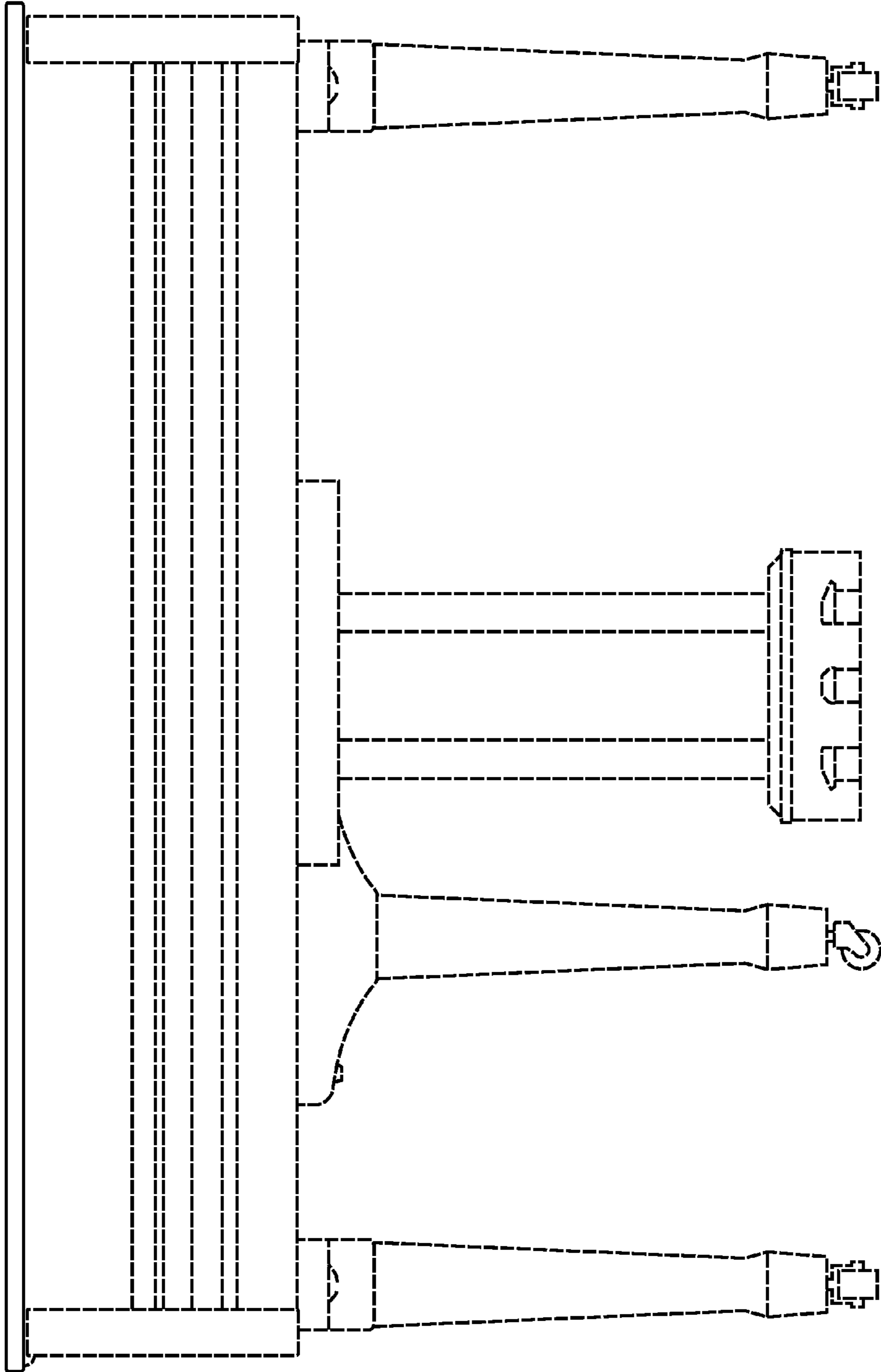

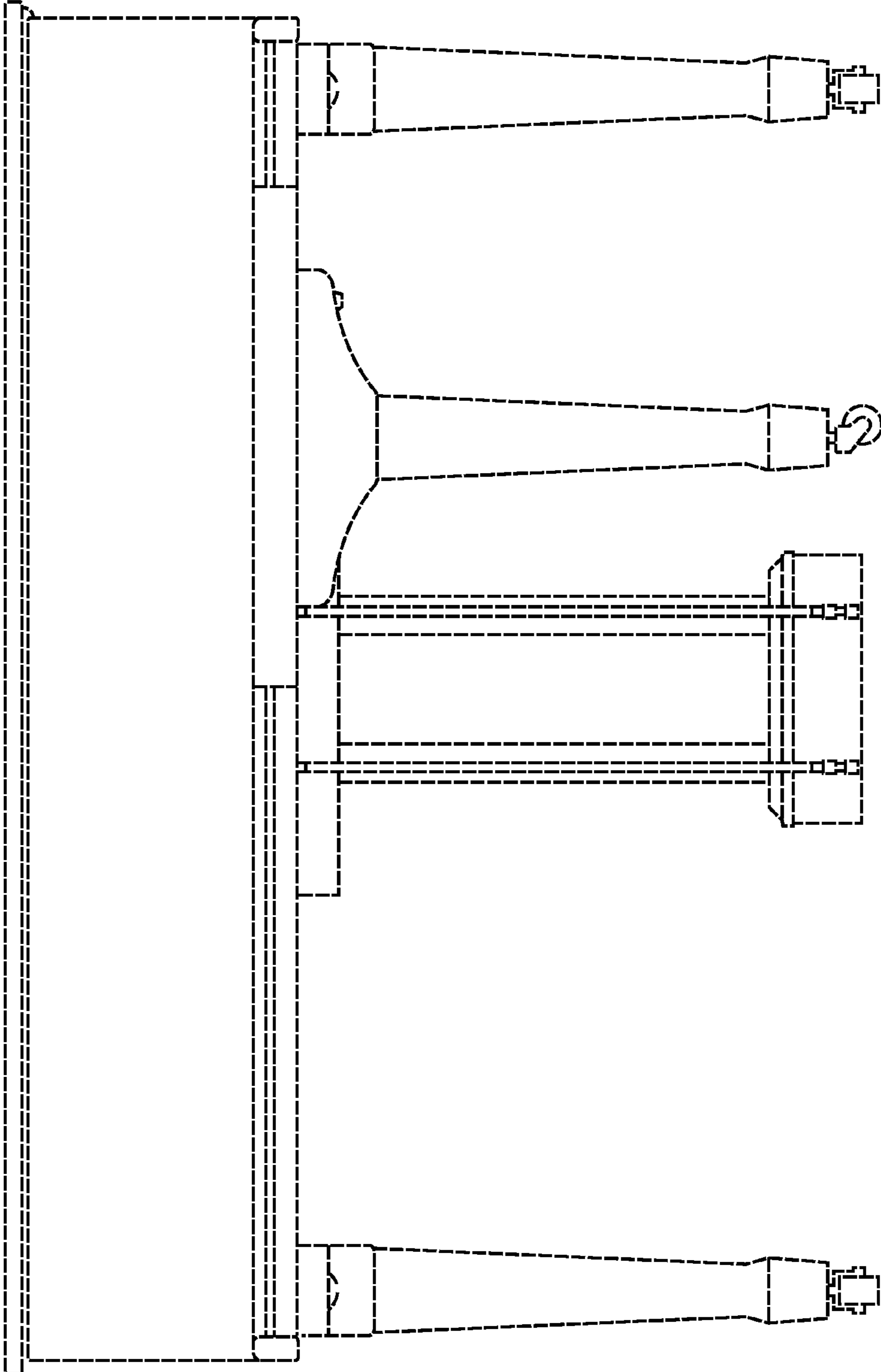

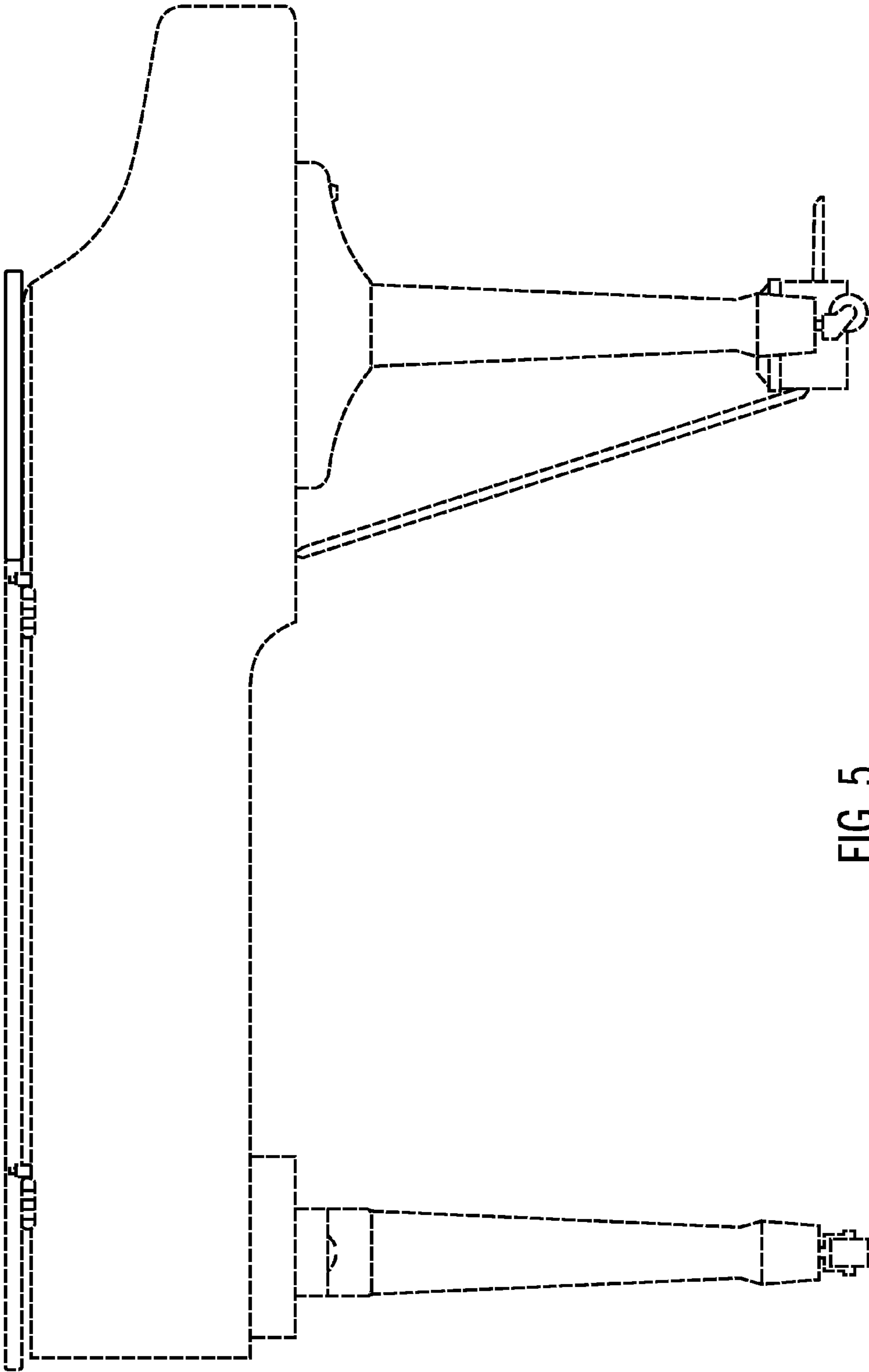

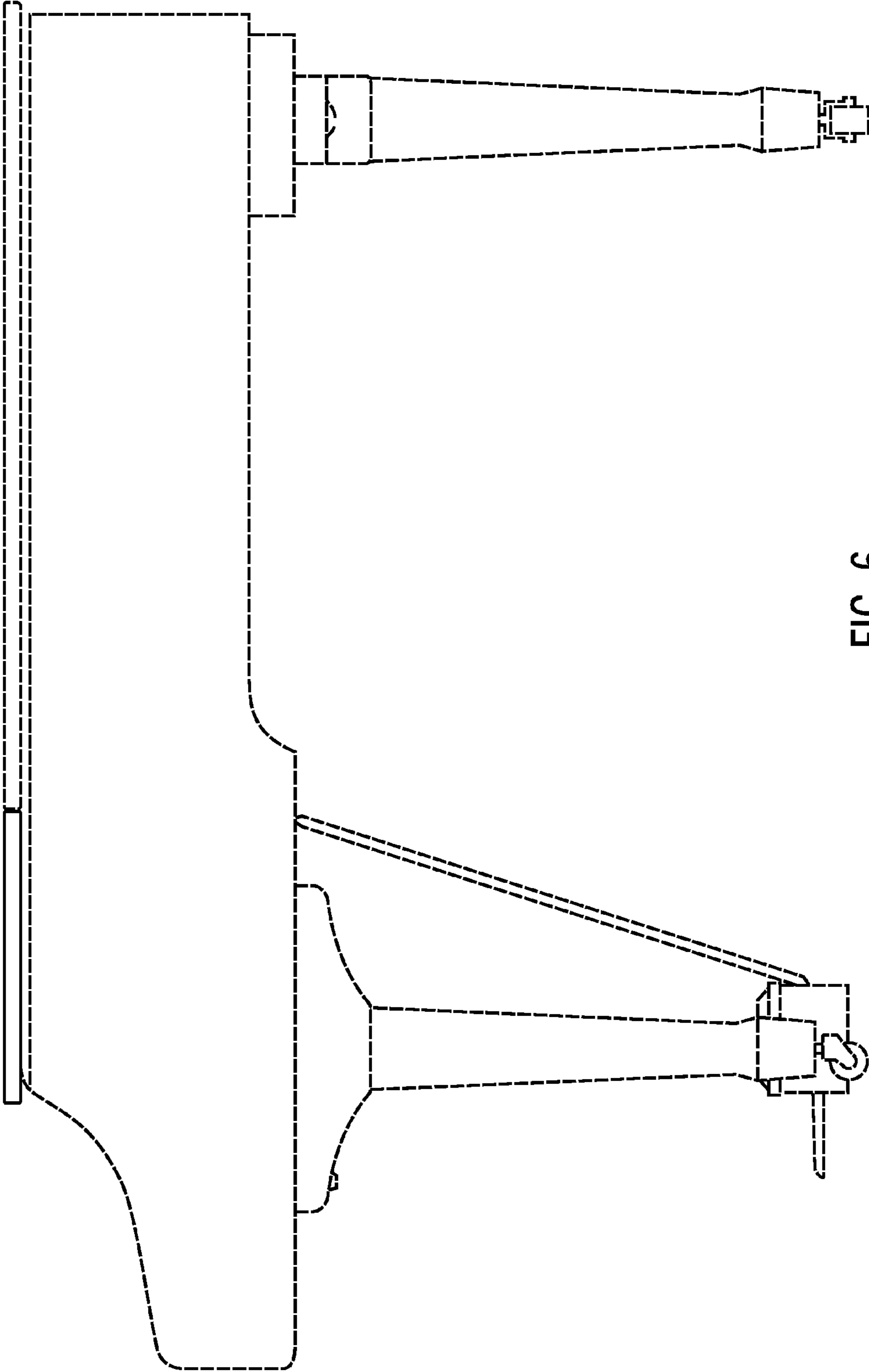

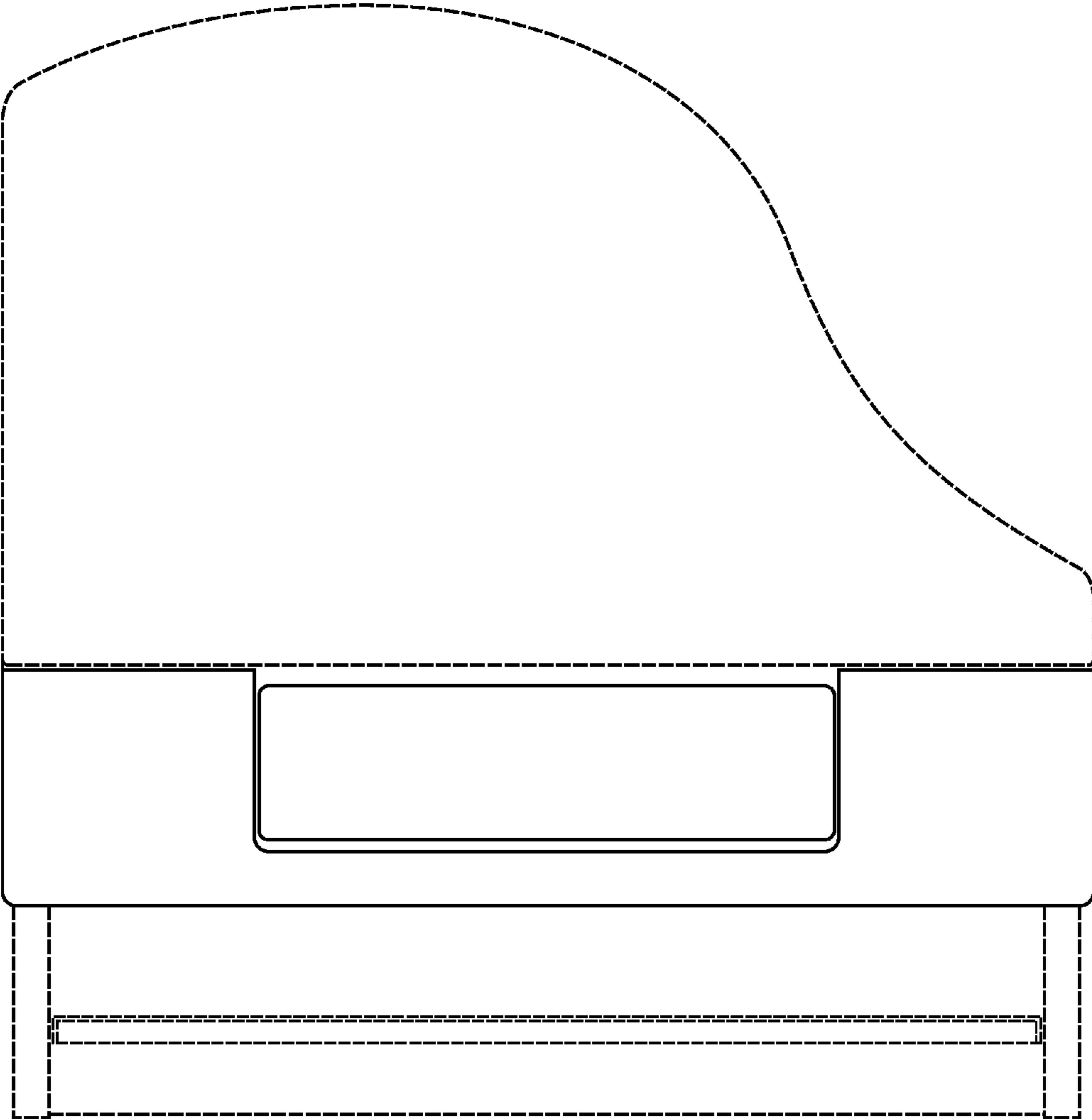

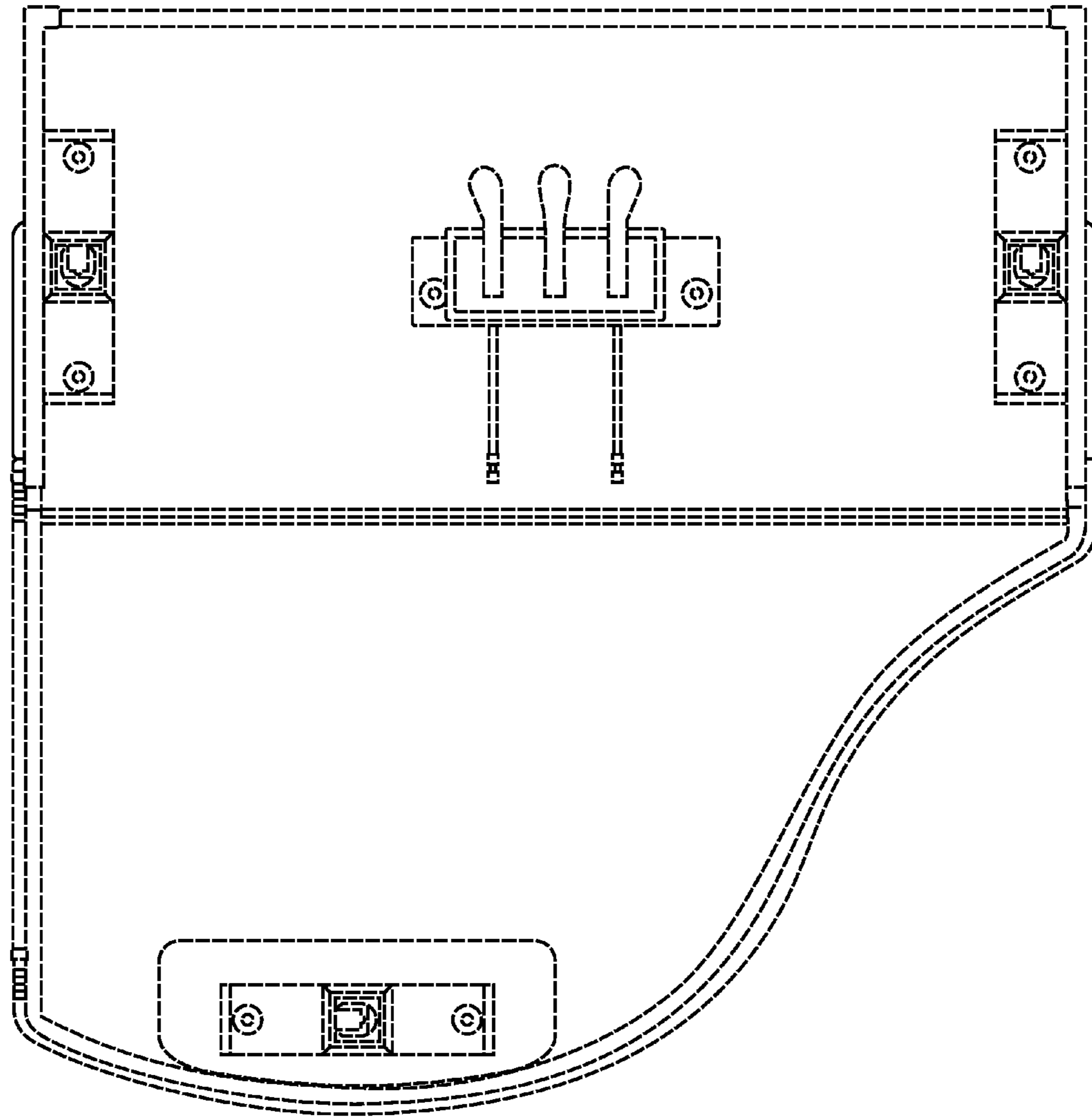
