DESCRIPTION

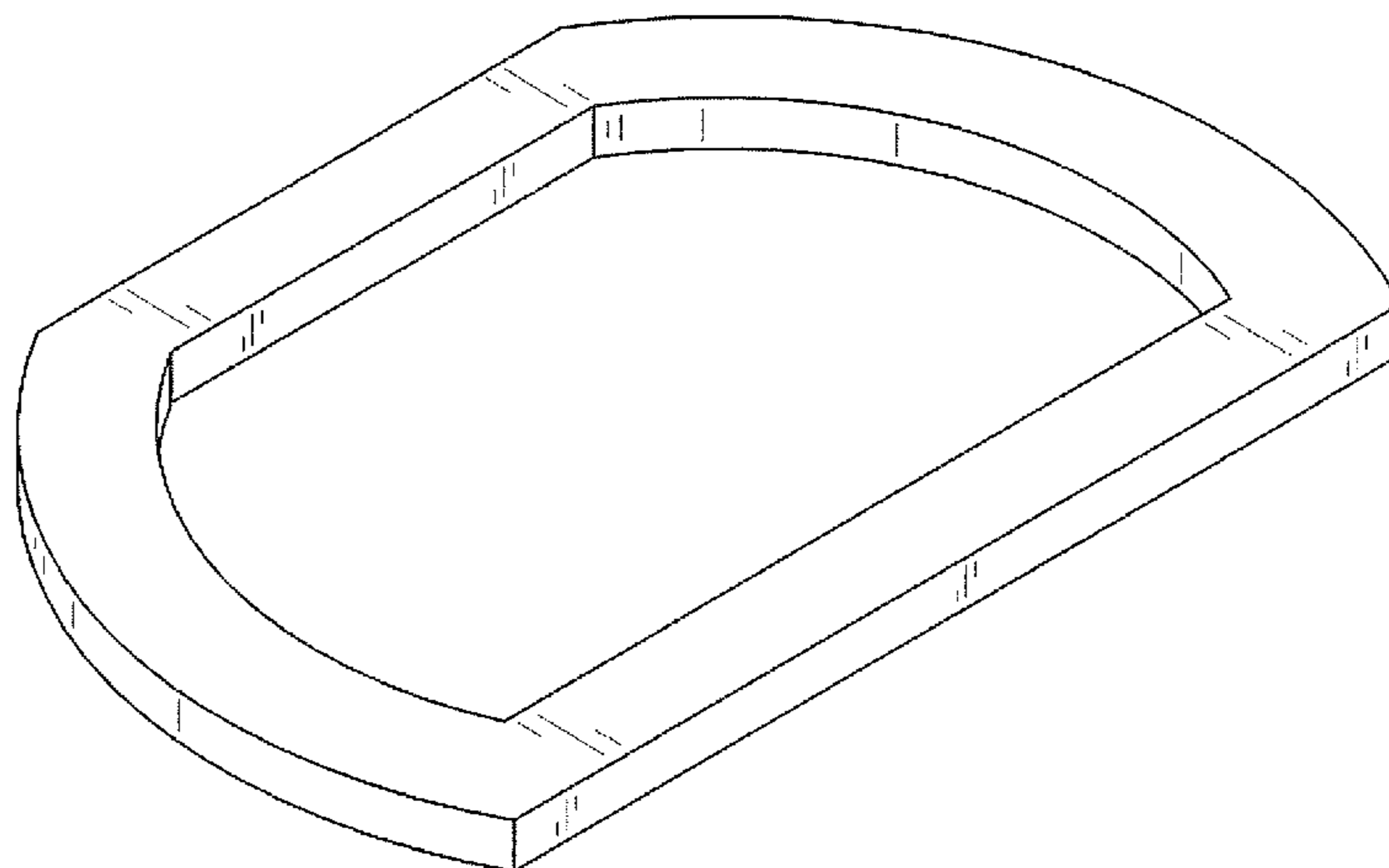

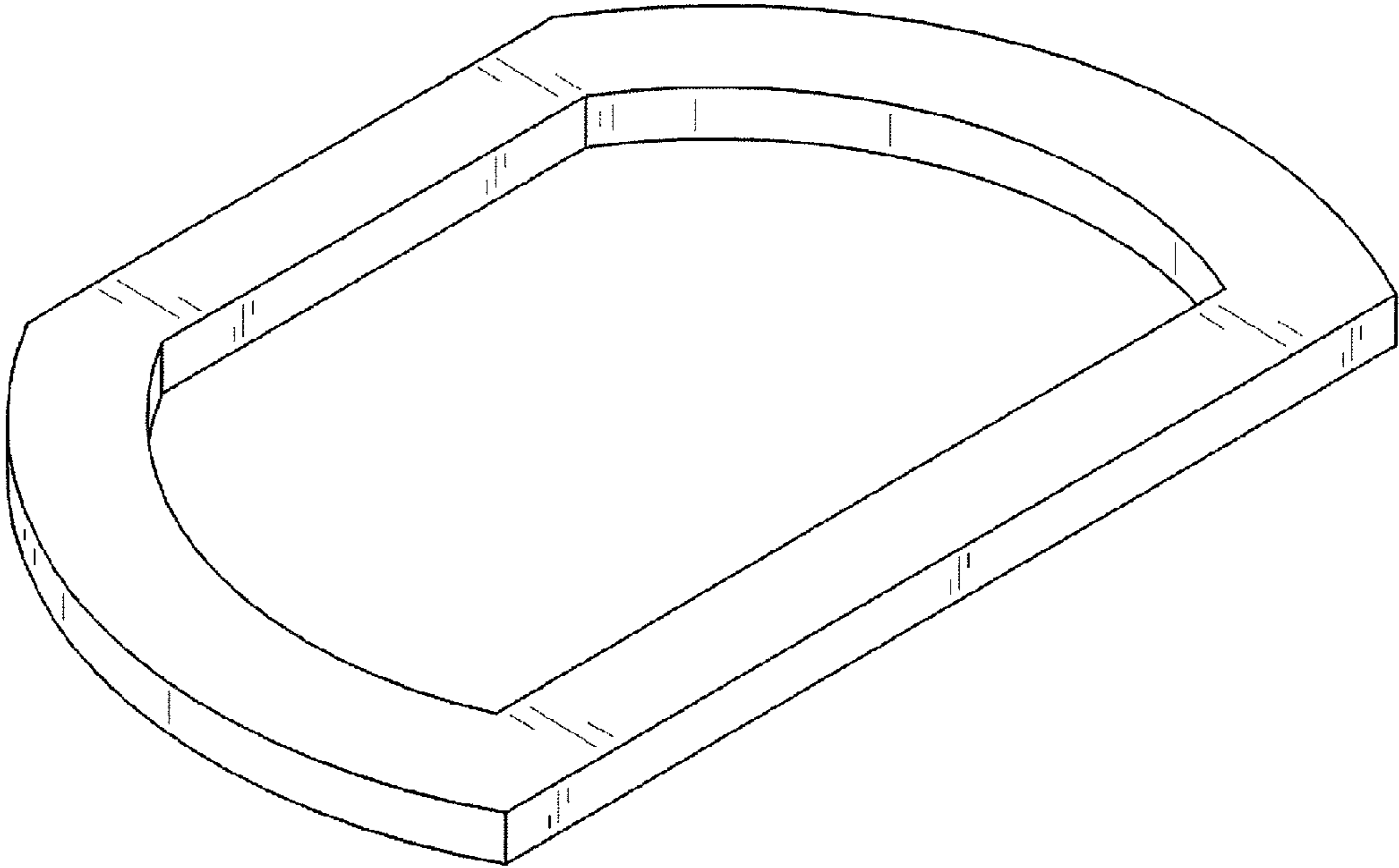

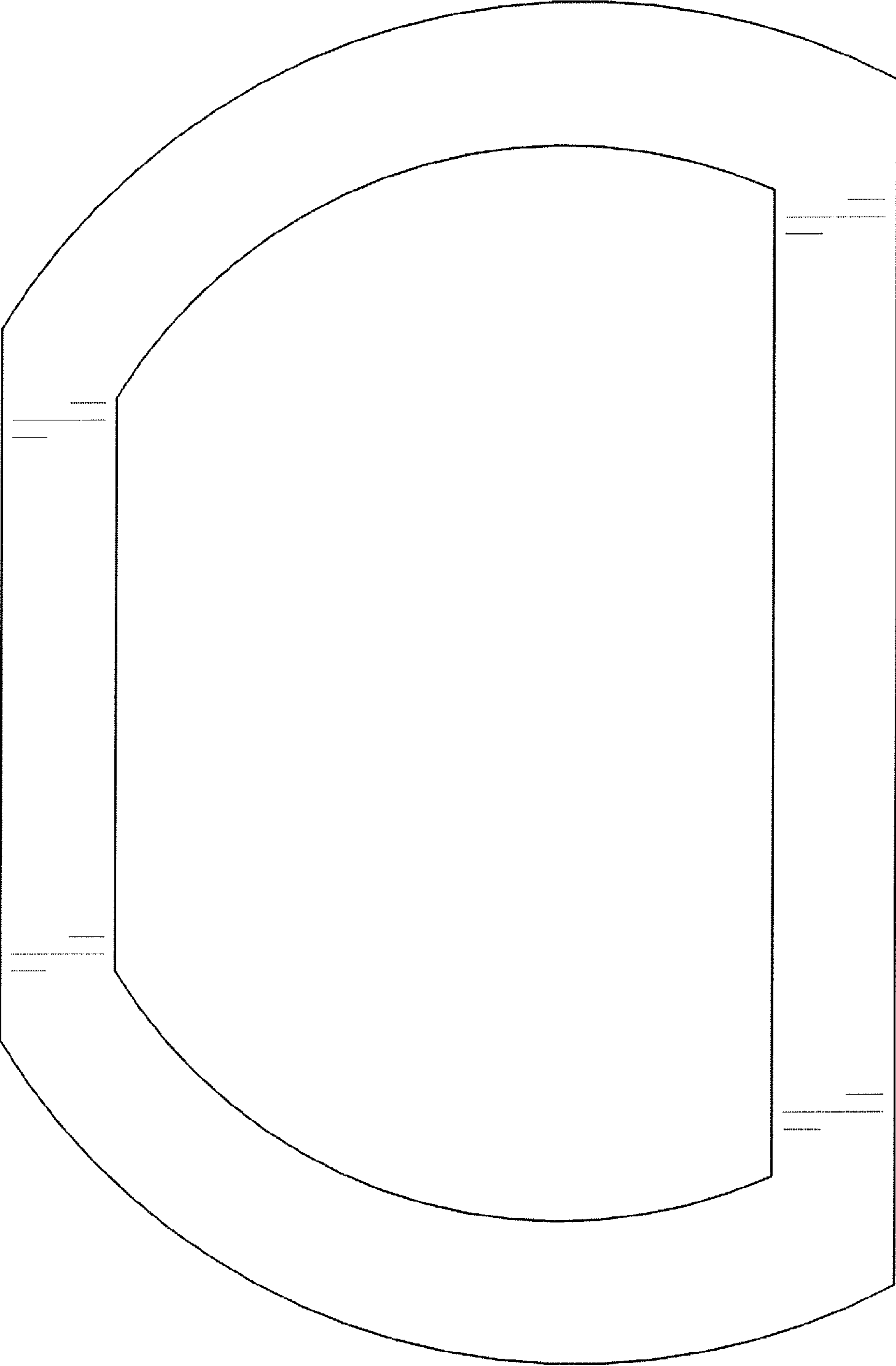

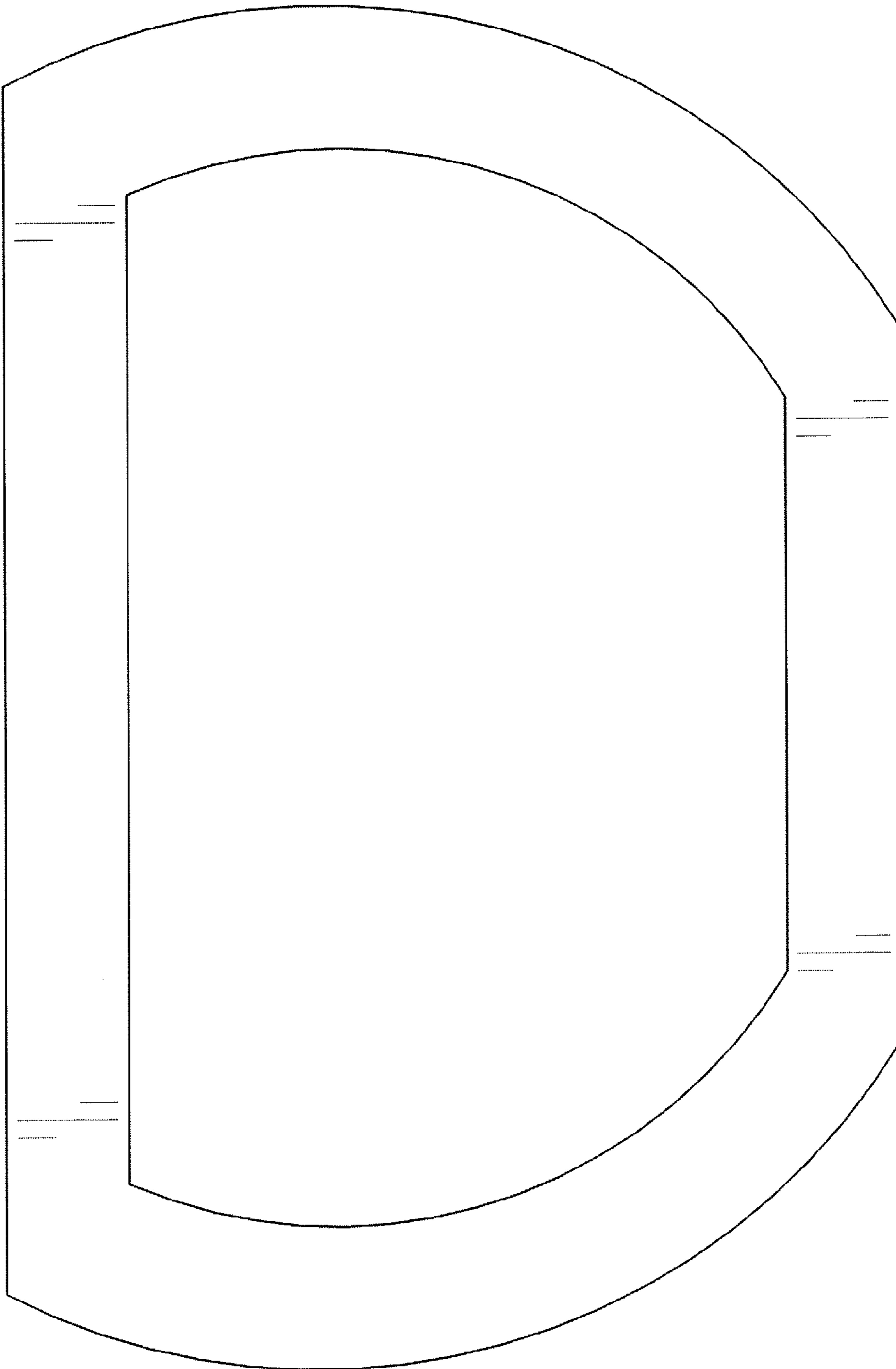

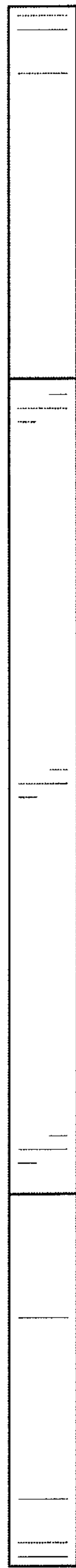

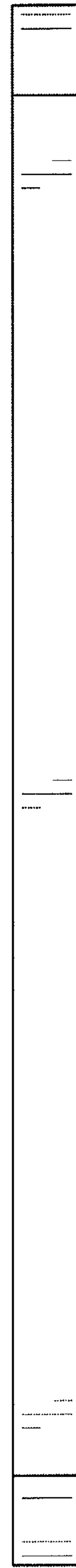

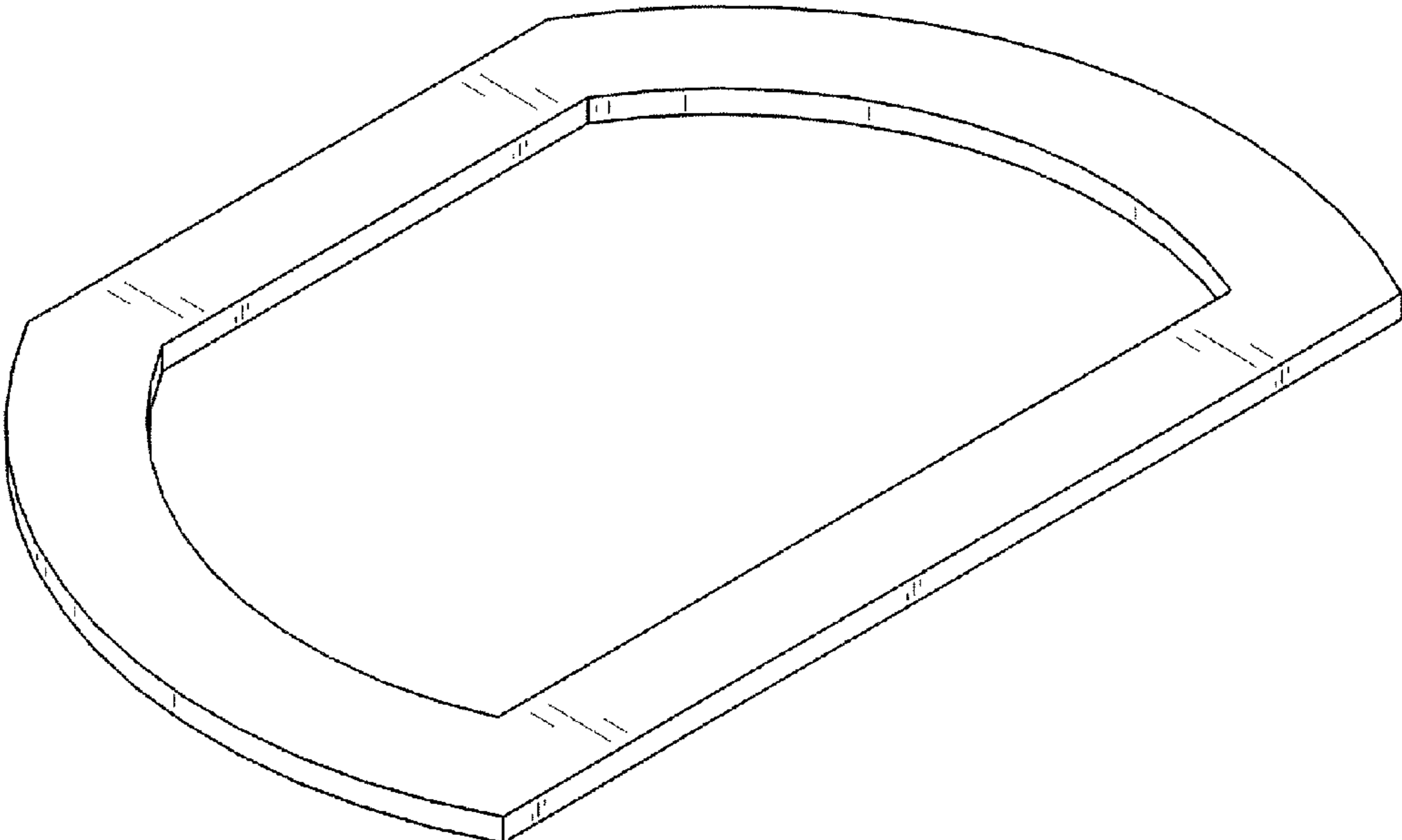

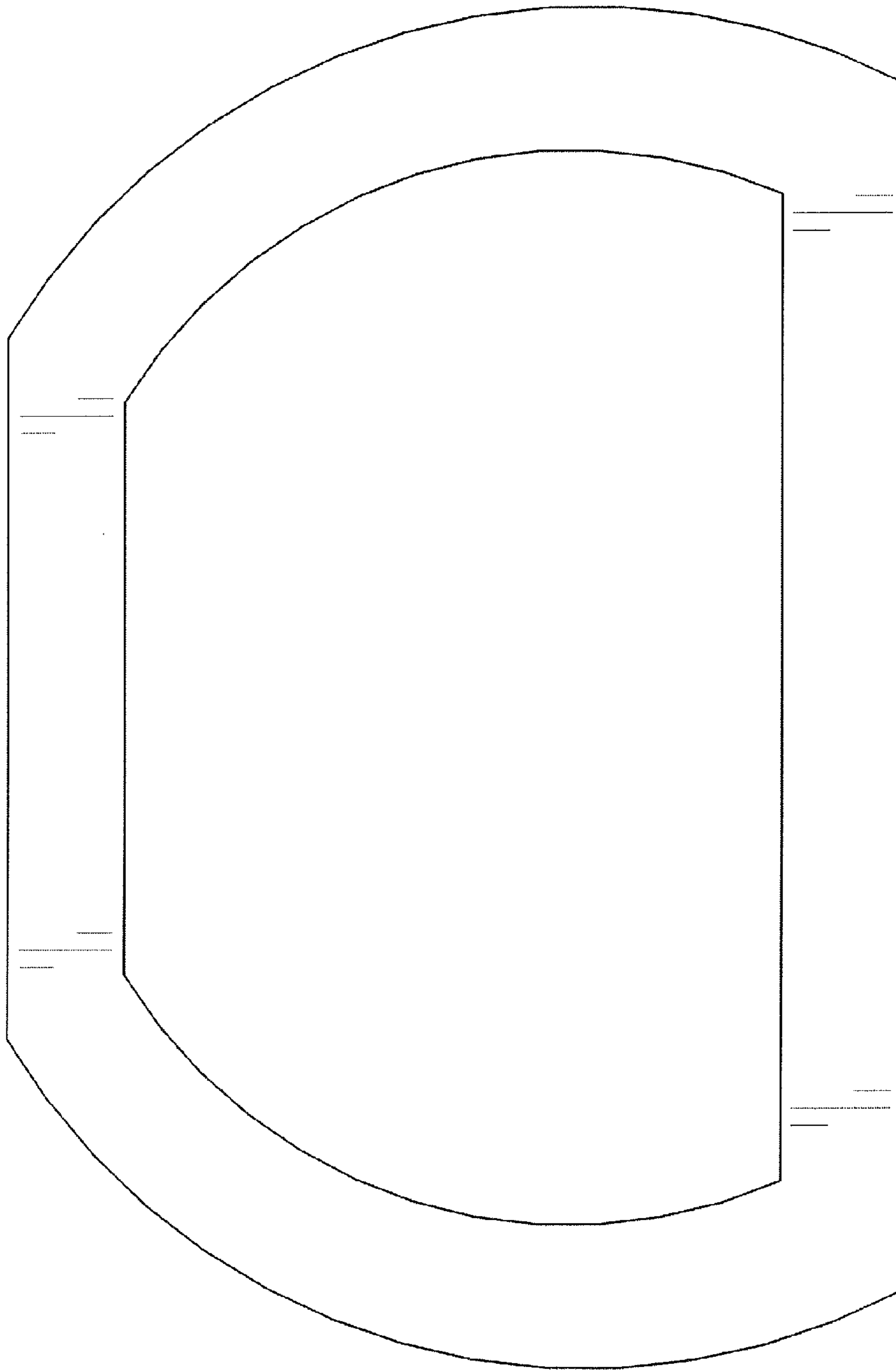

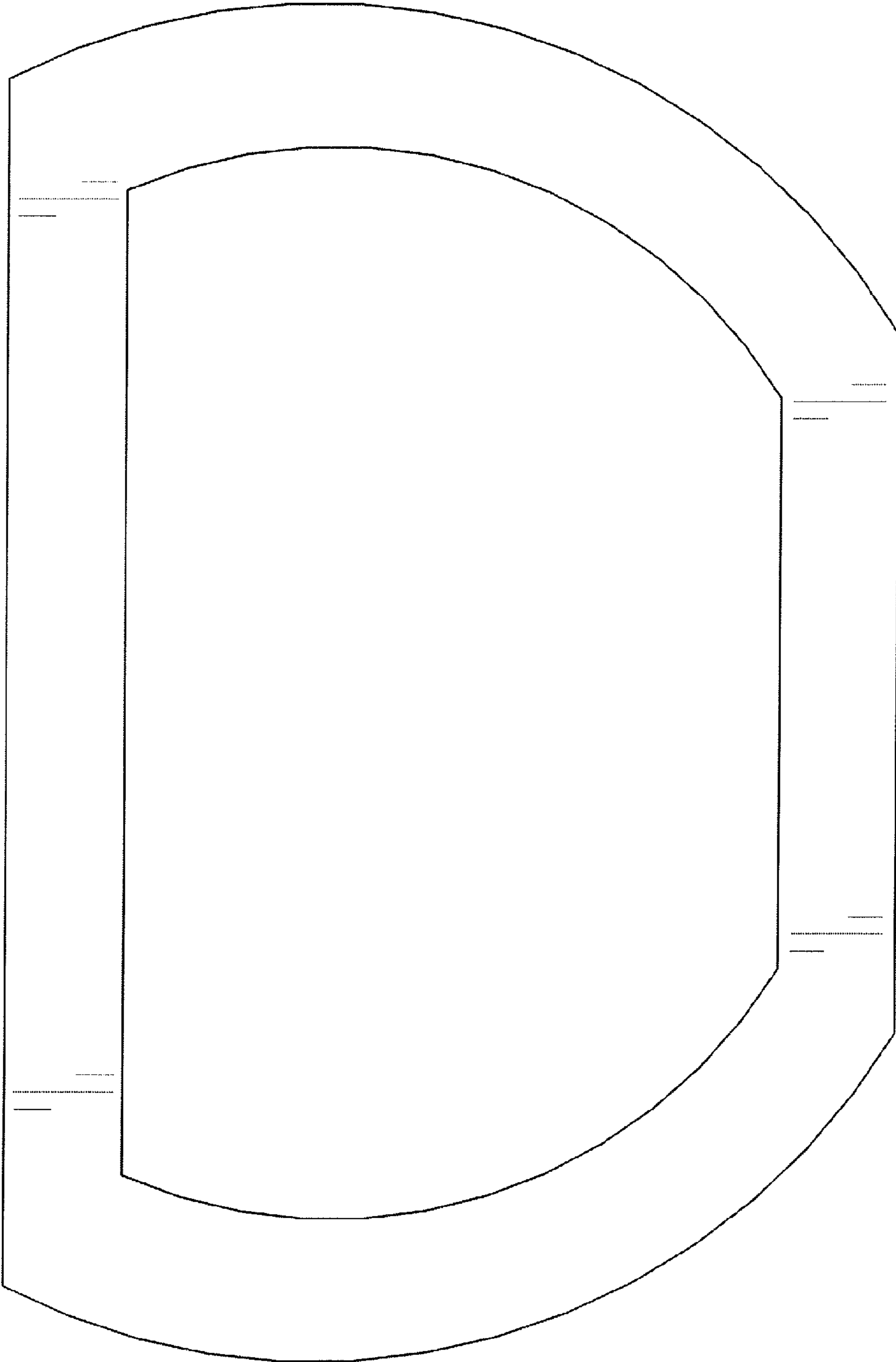
