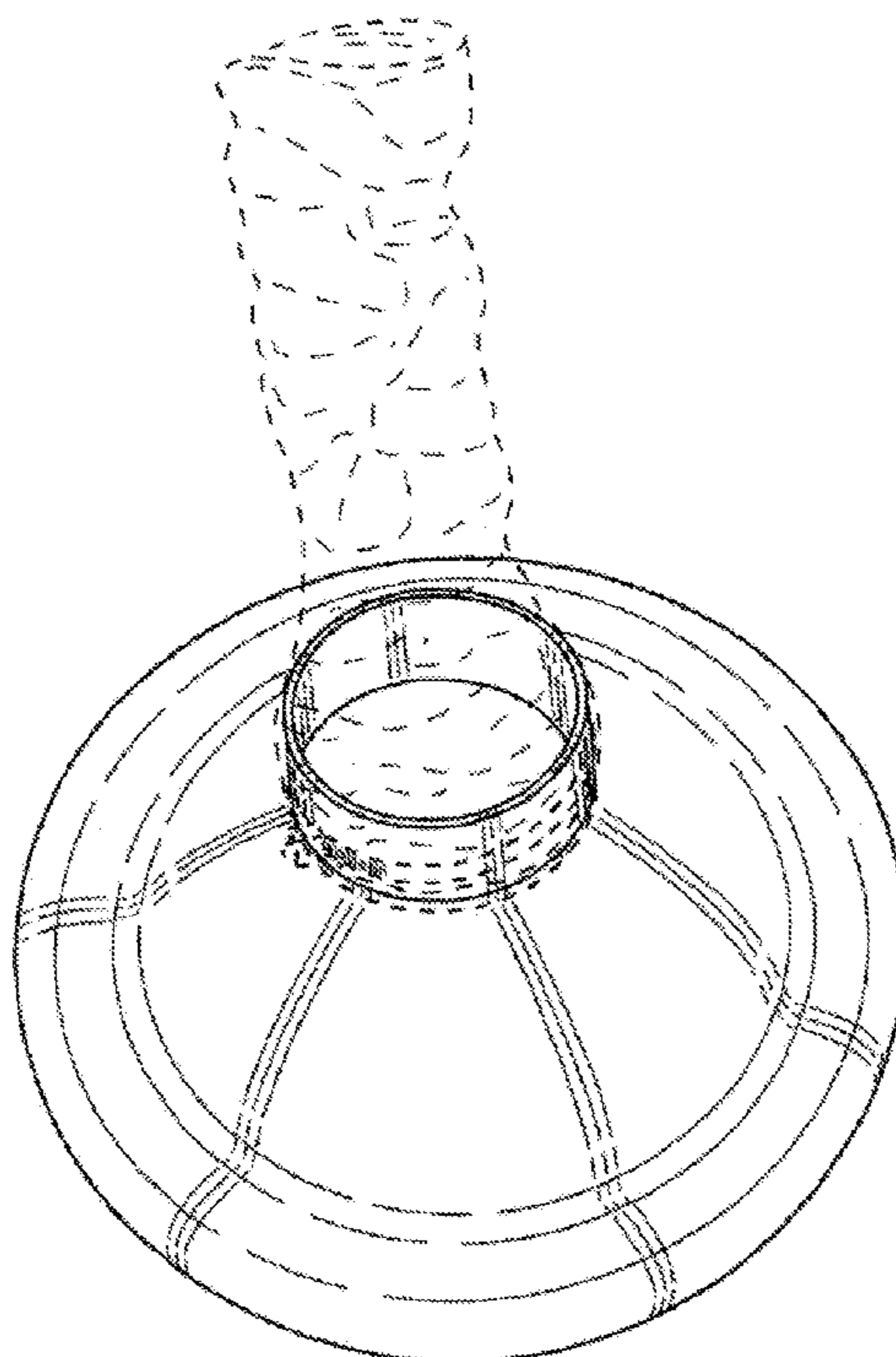
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a surgical shield, showing my new design;
FIG. 2 is a top plan view thereof;

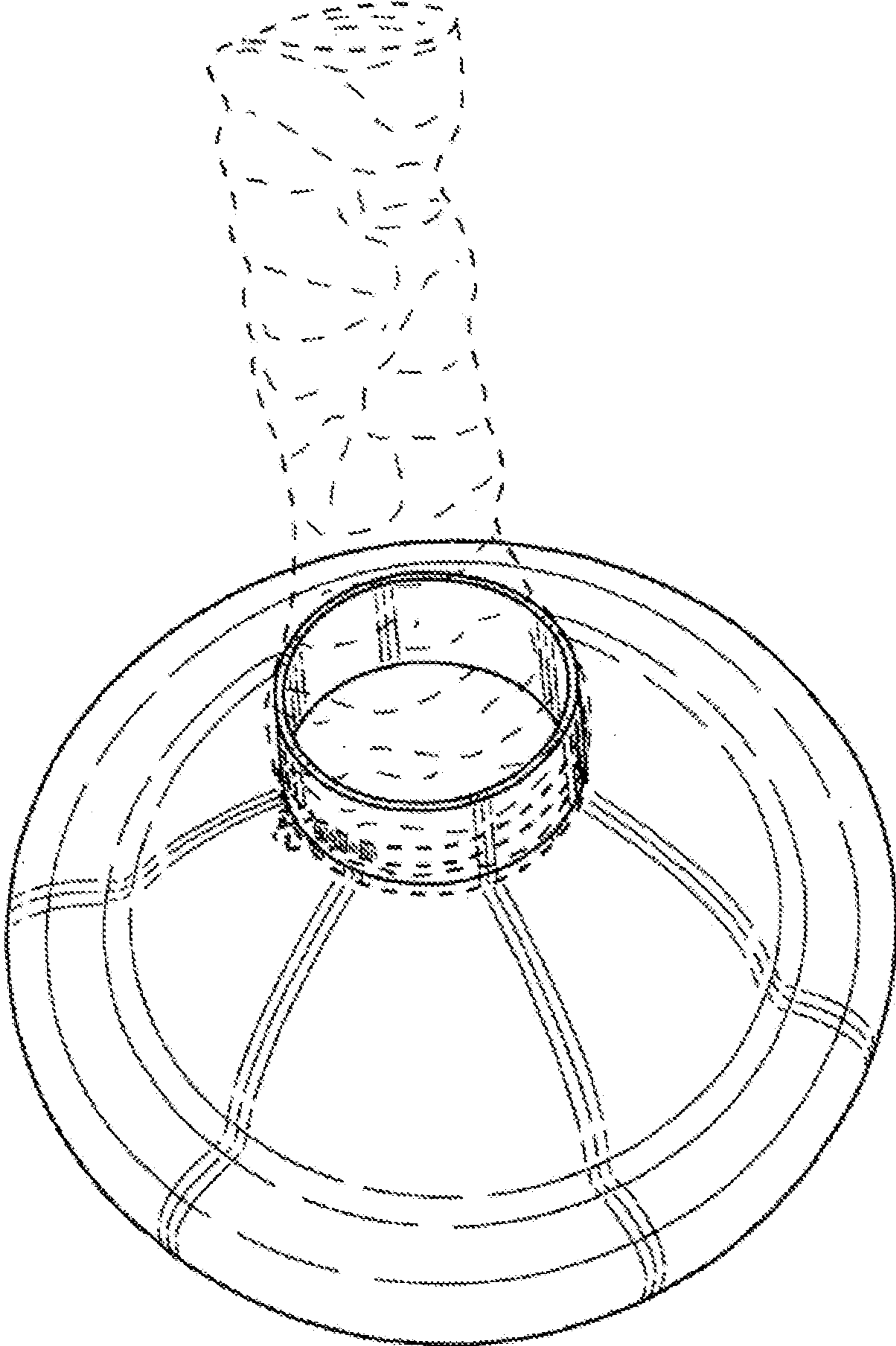

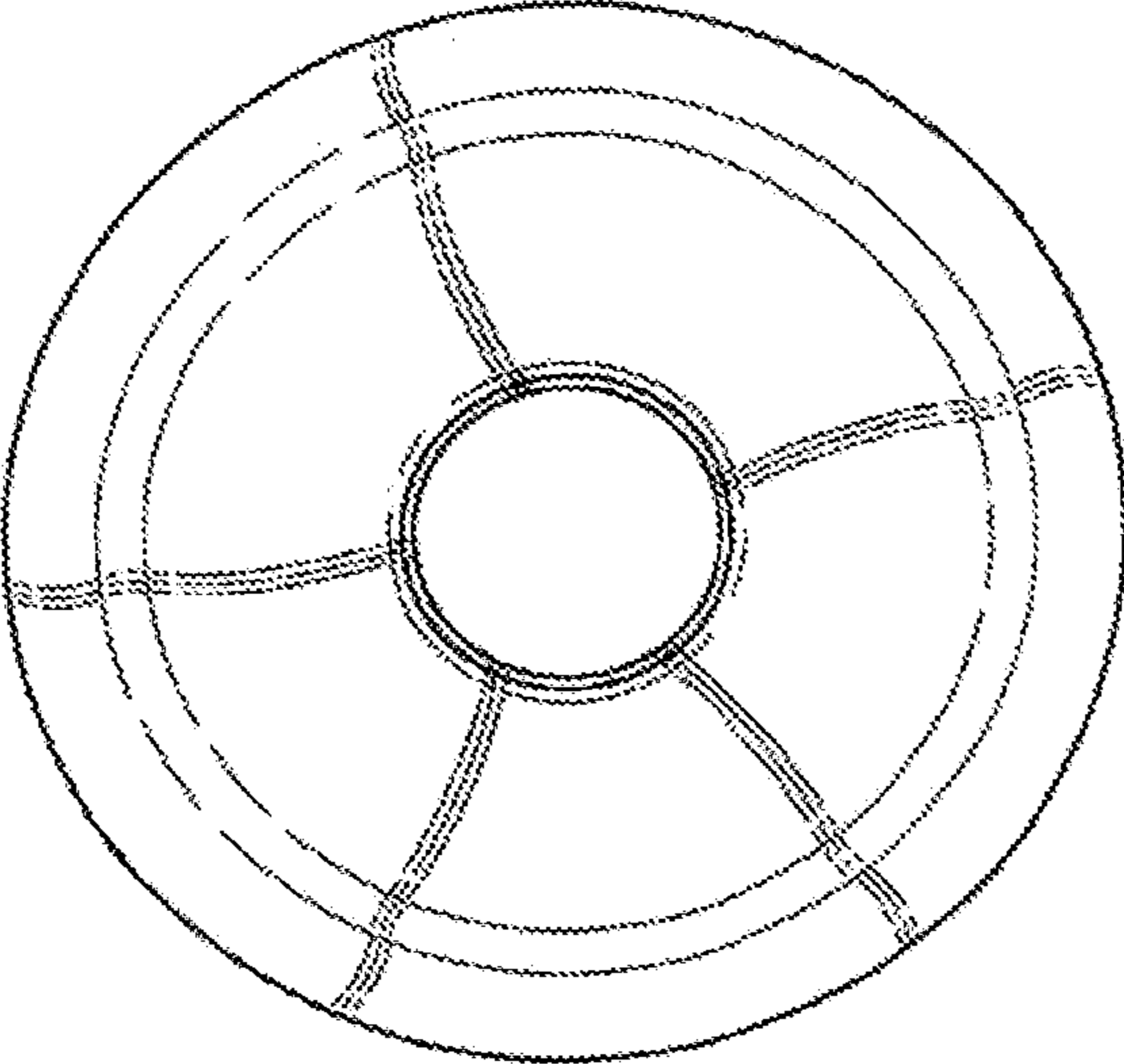

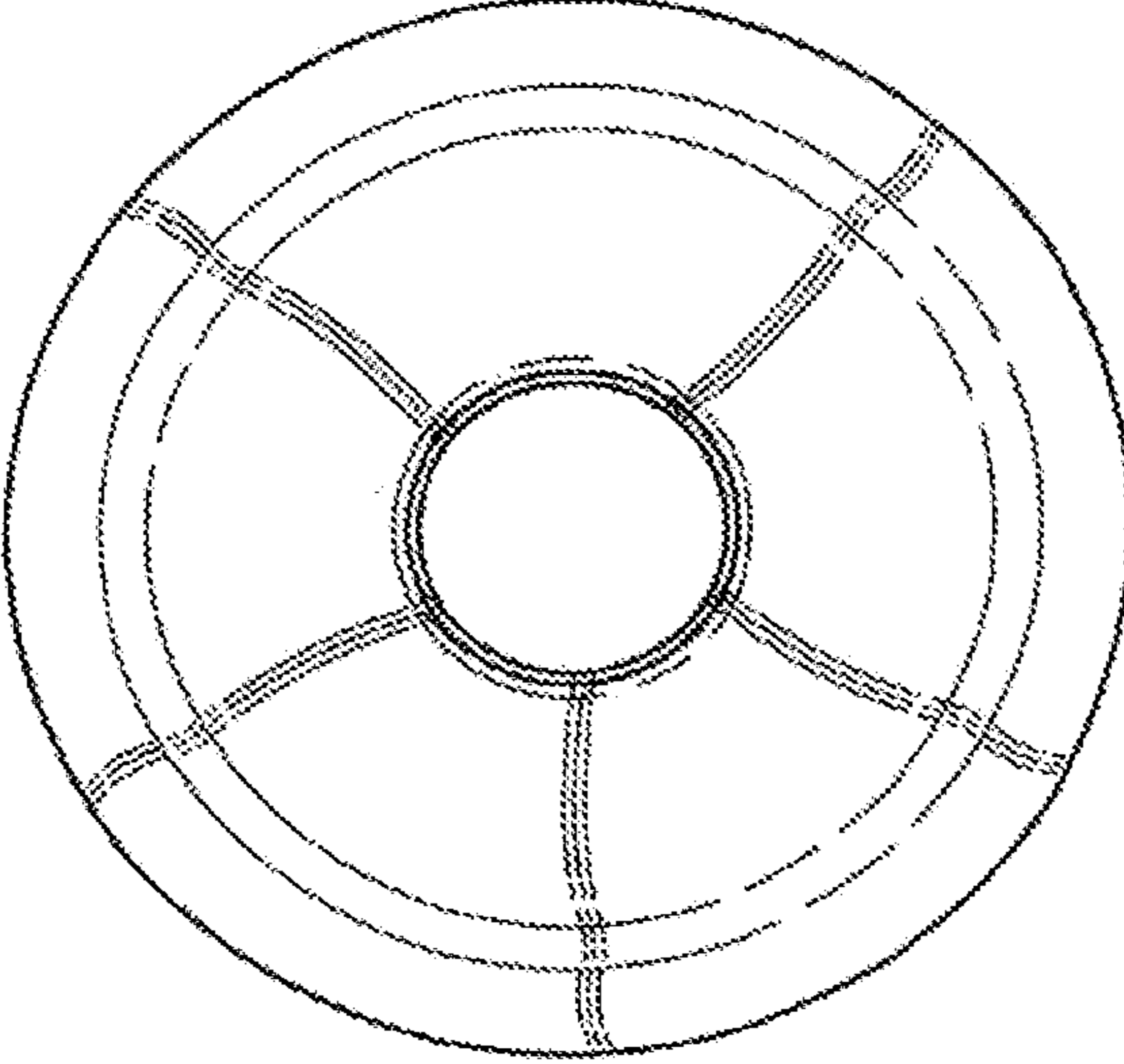

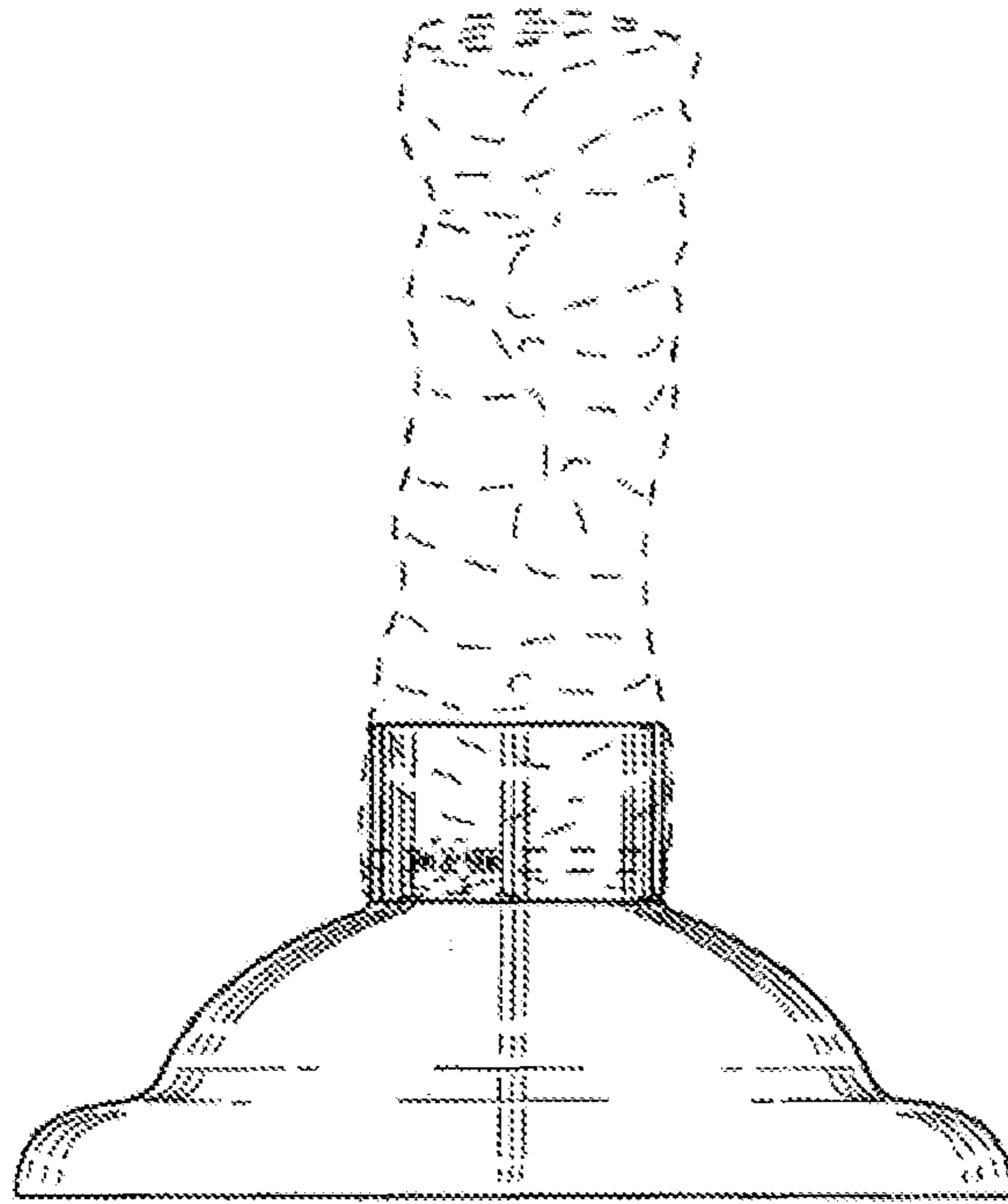

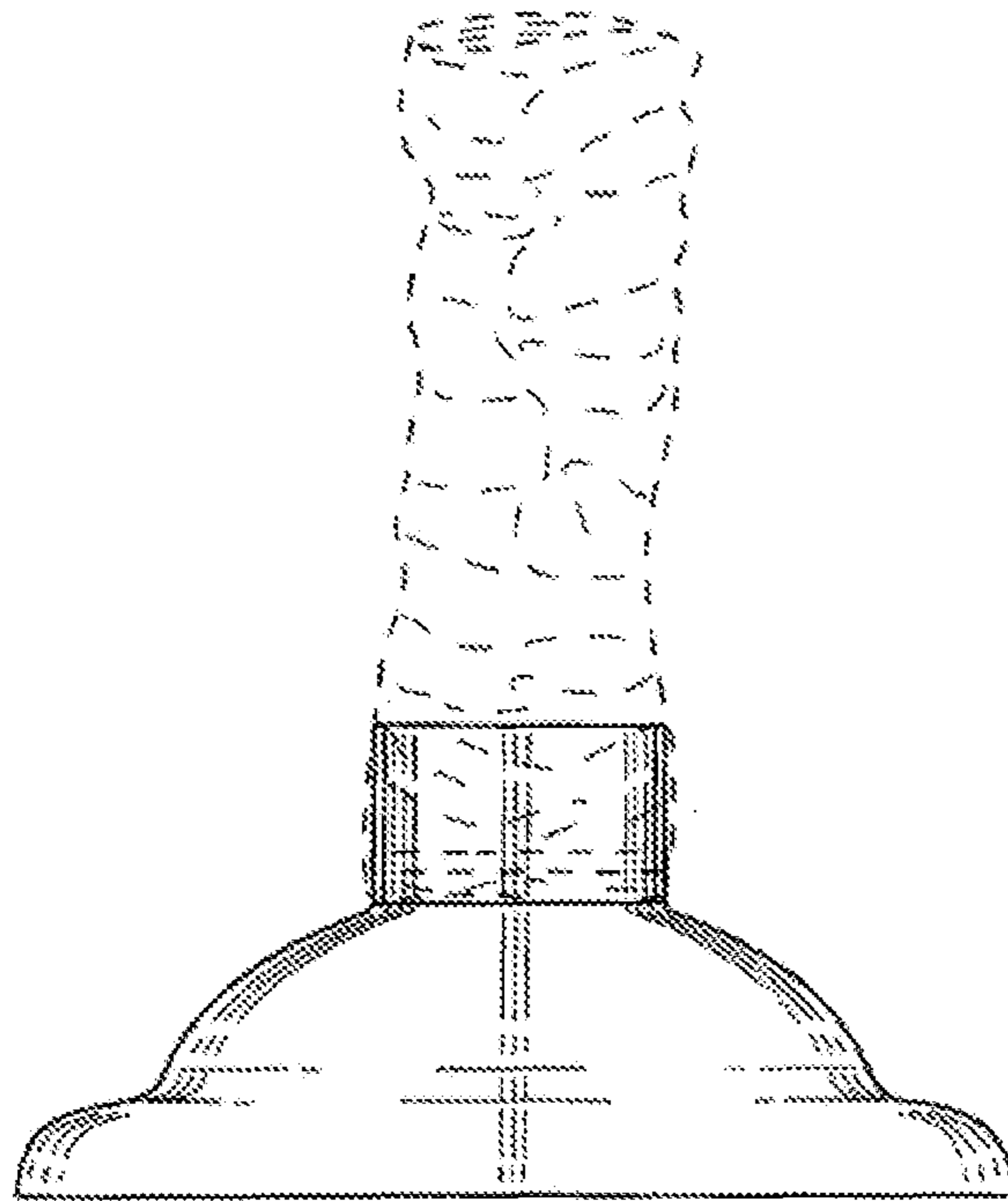

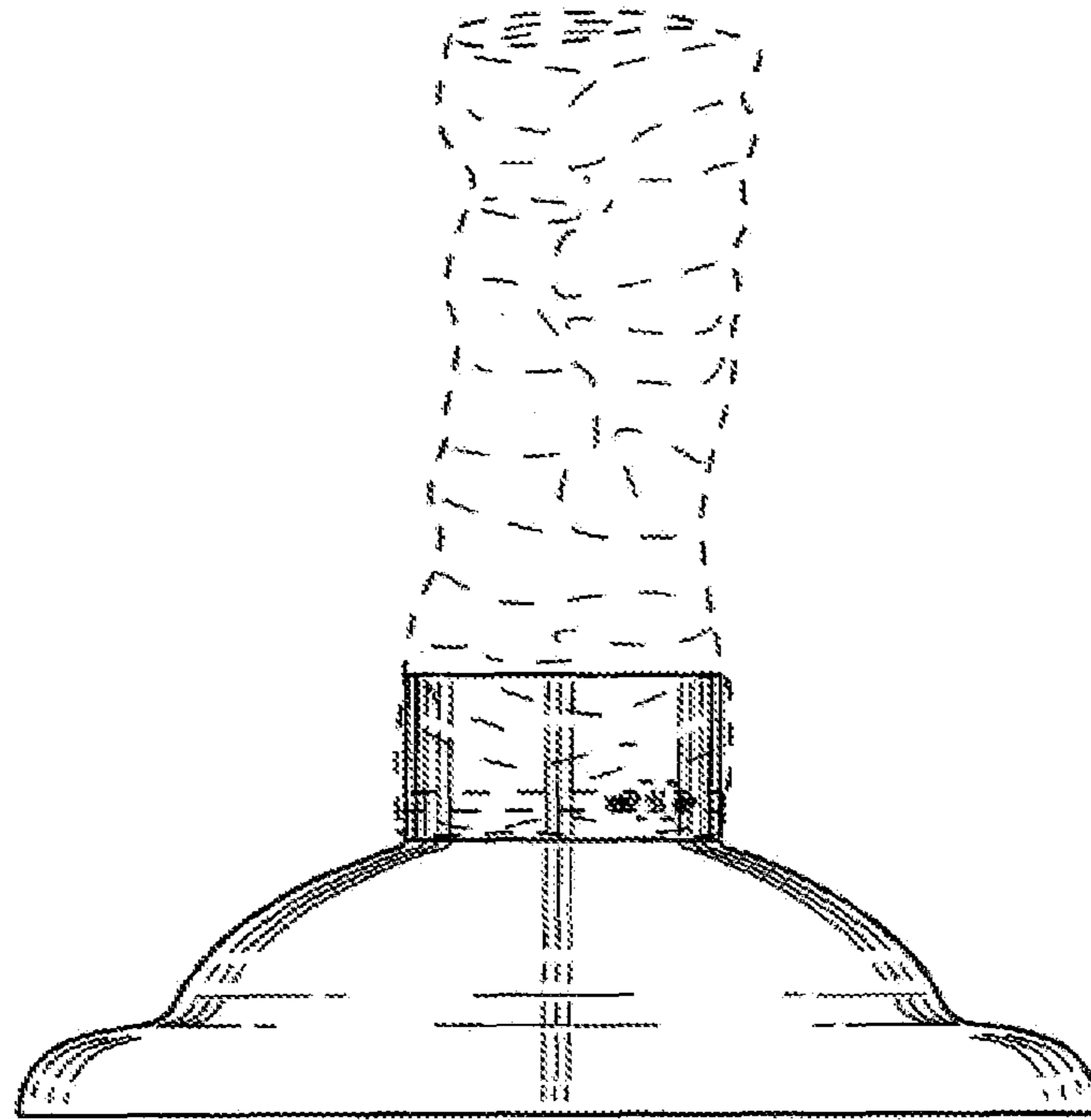

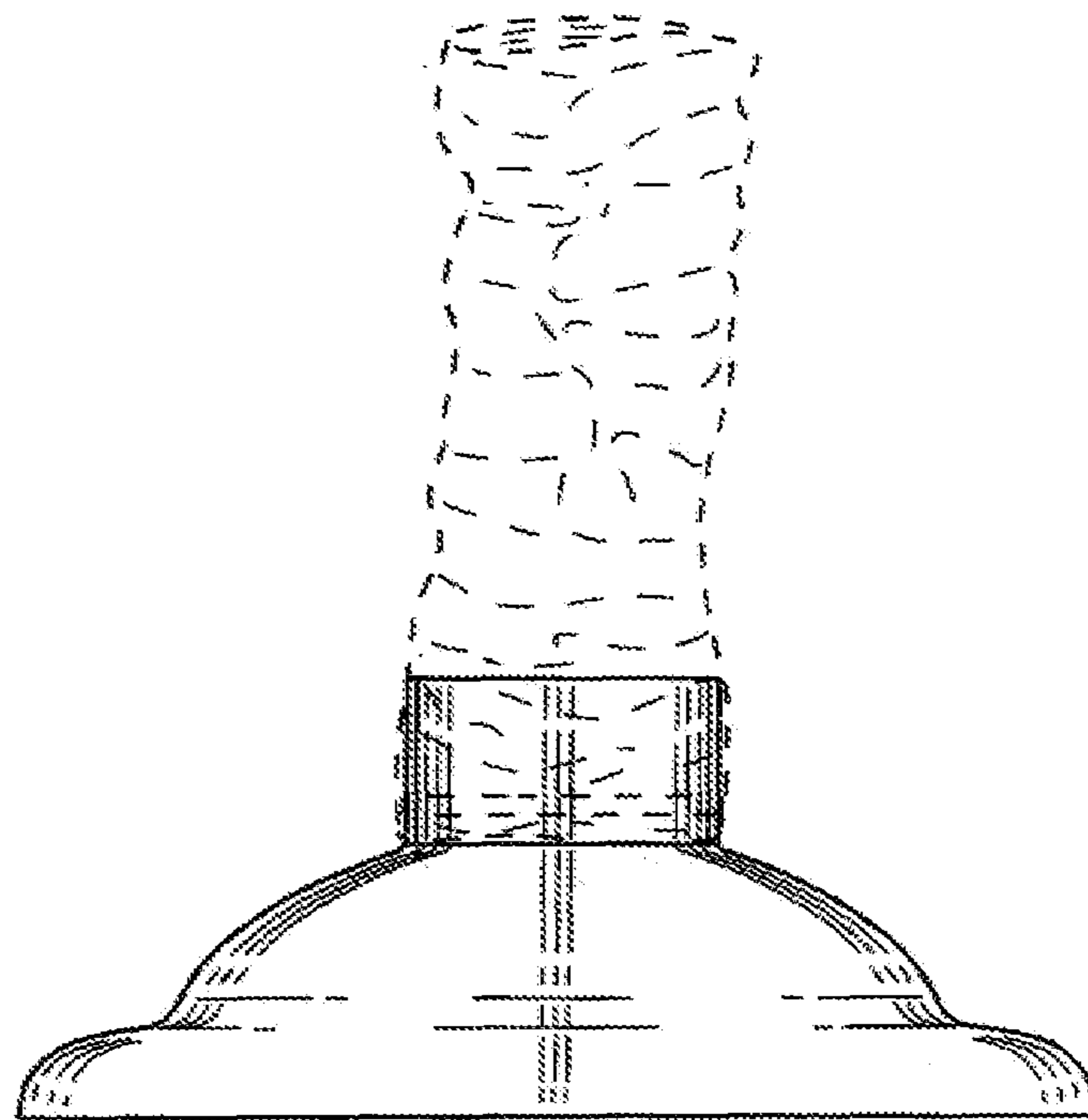
