(57) **CLAIM**

The ornamental design for a garment for children, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a garment for children showing my new design.

FIG. 2 is a rear elevational view shown in a closed configuration thereof;

FIG. 3 is a rear elevational view shown in an open configuration thereof;

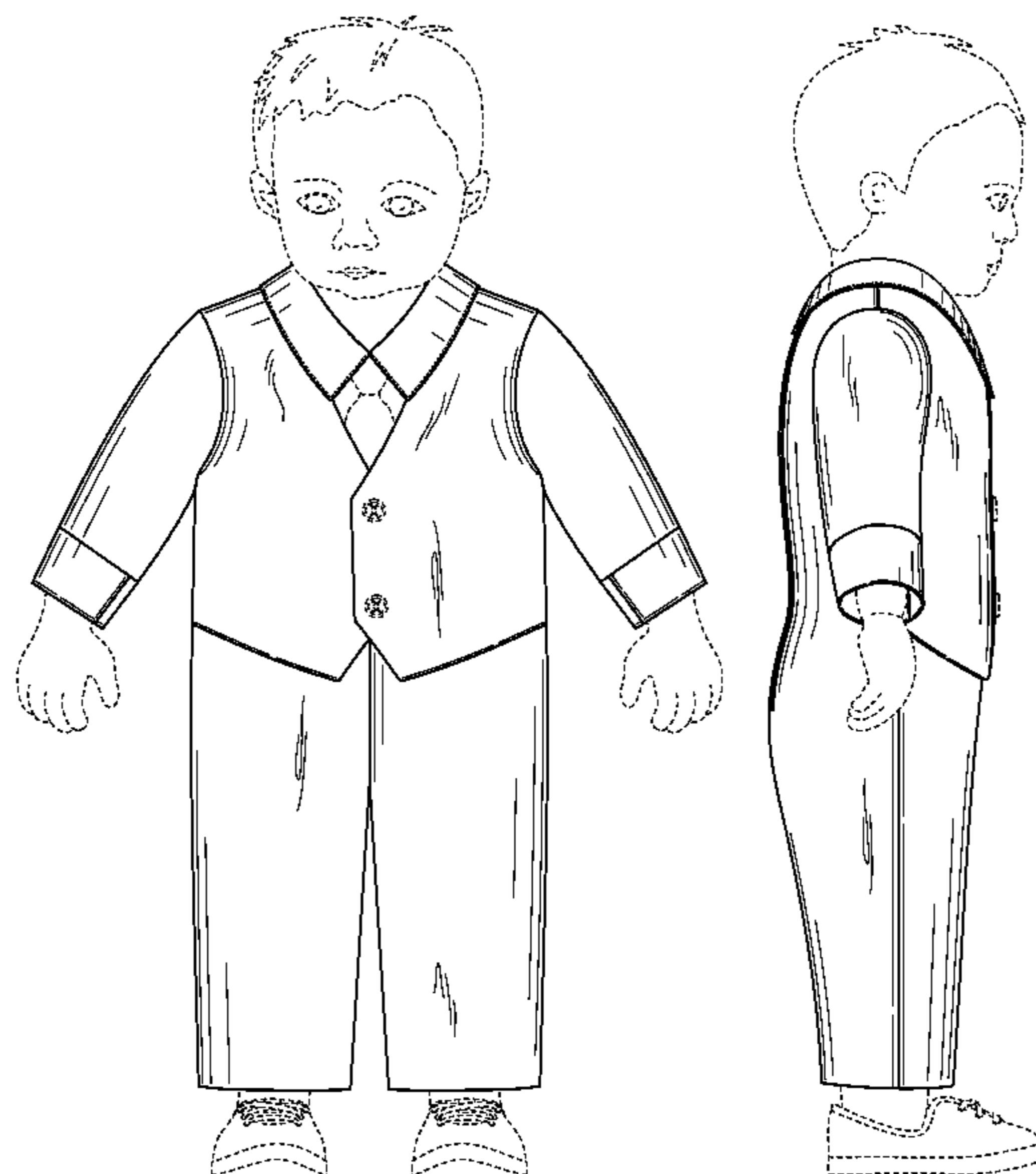
FIG. 4 is a left side elevational view thereof; and,

FIG. 5 is a right side elevational view thereof.

The small dash, small dash lines in FIGS. 1-5 of the garment for children represent stitching and are part of the claimed design.

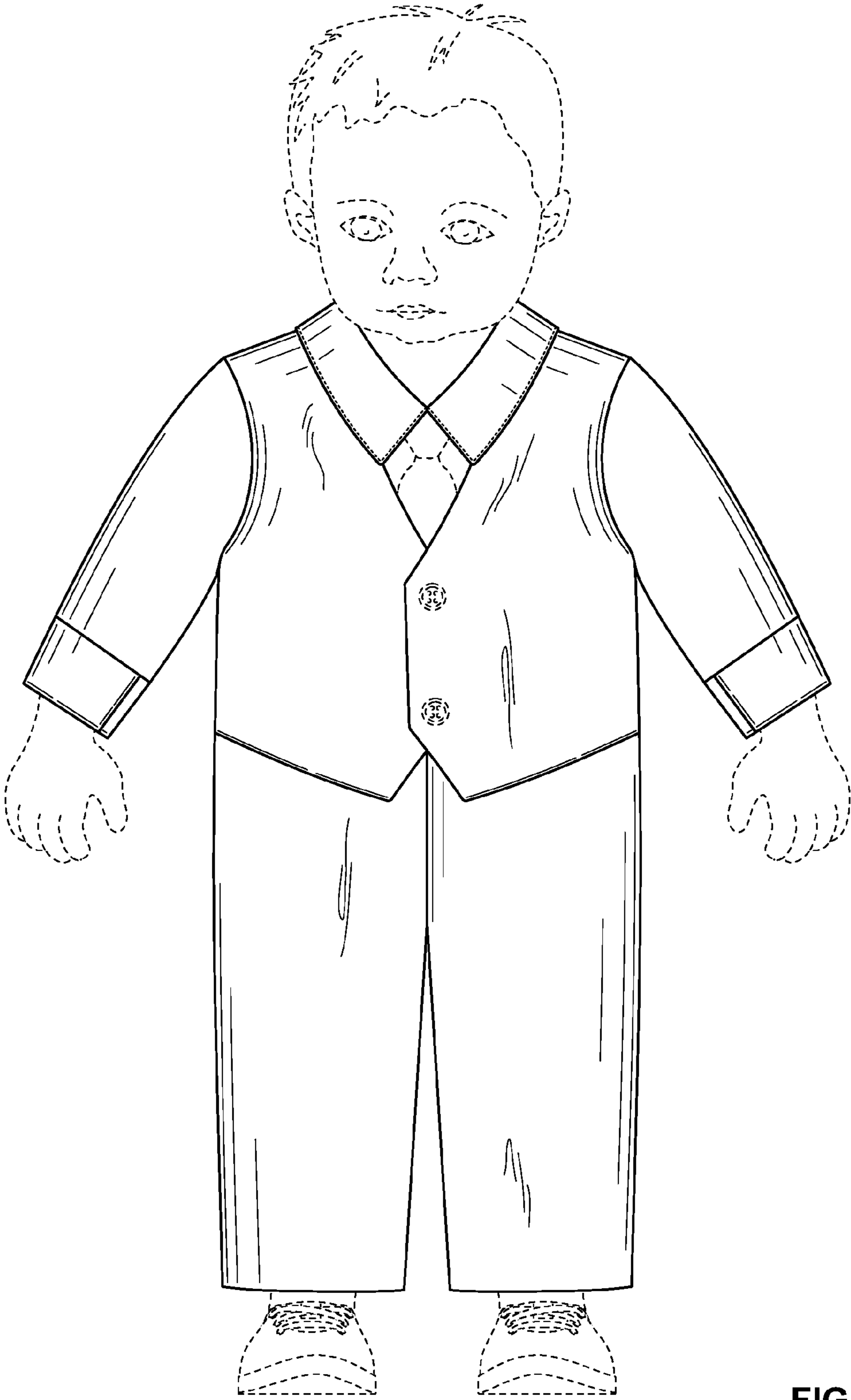

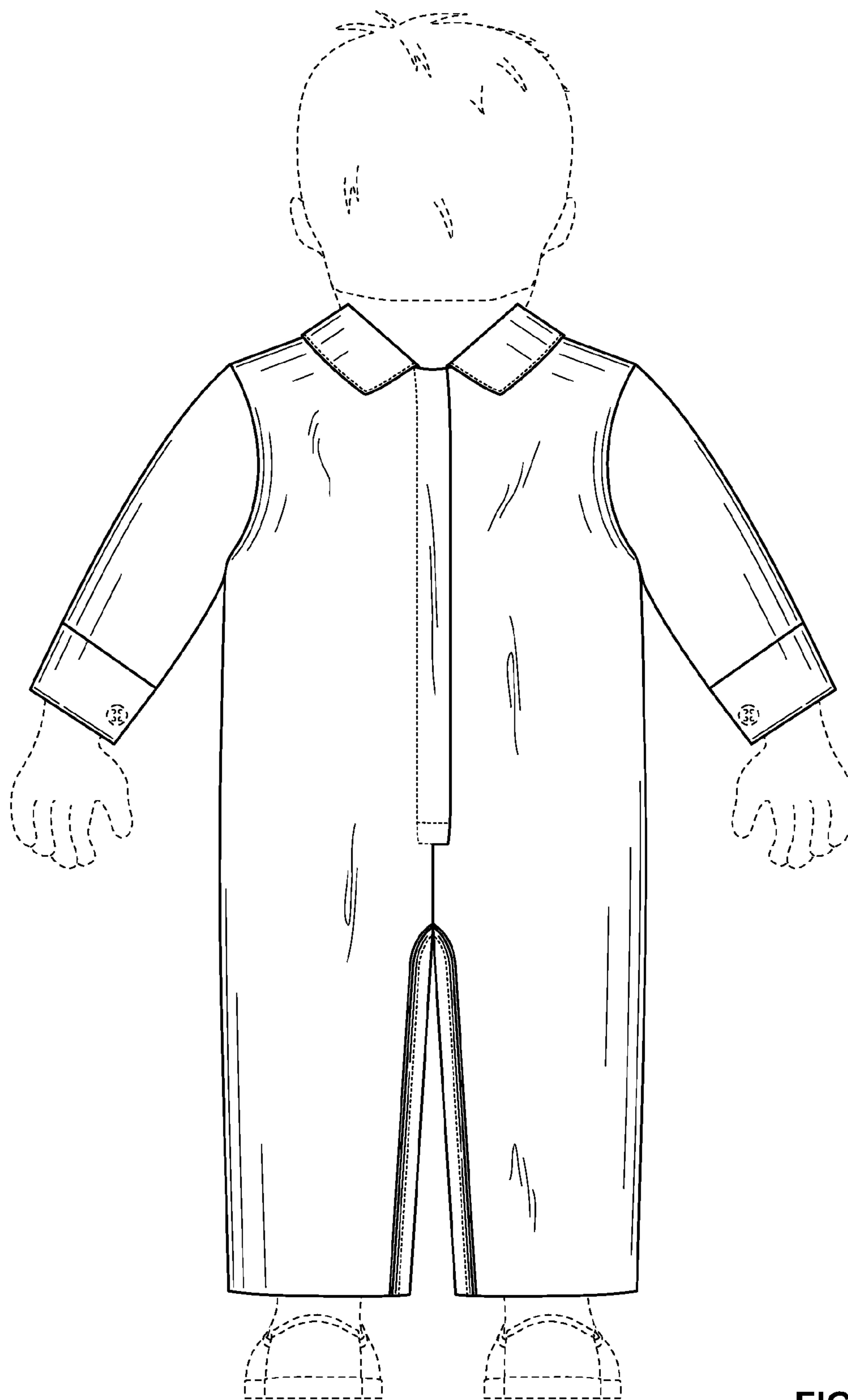

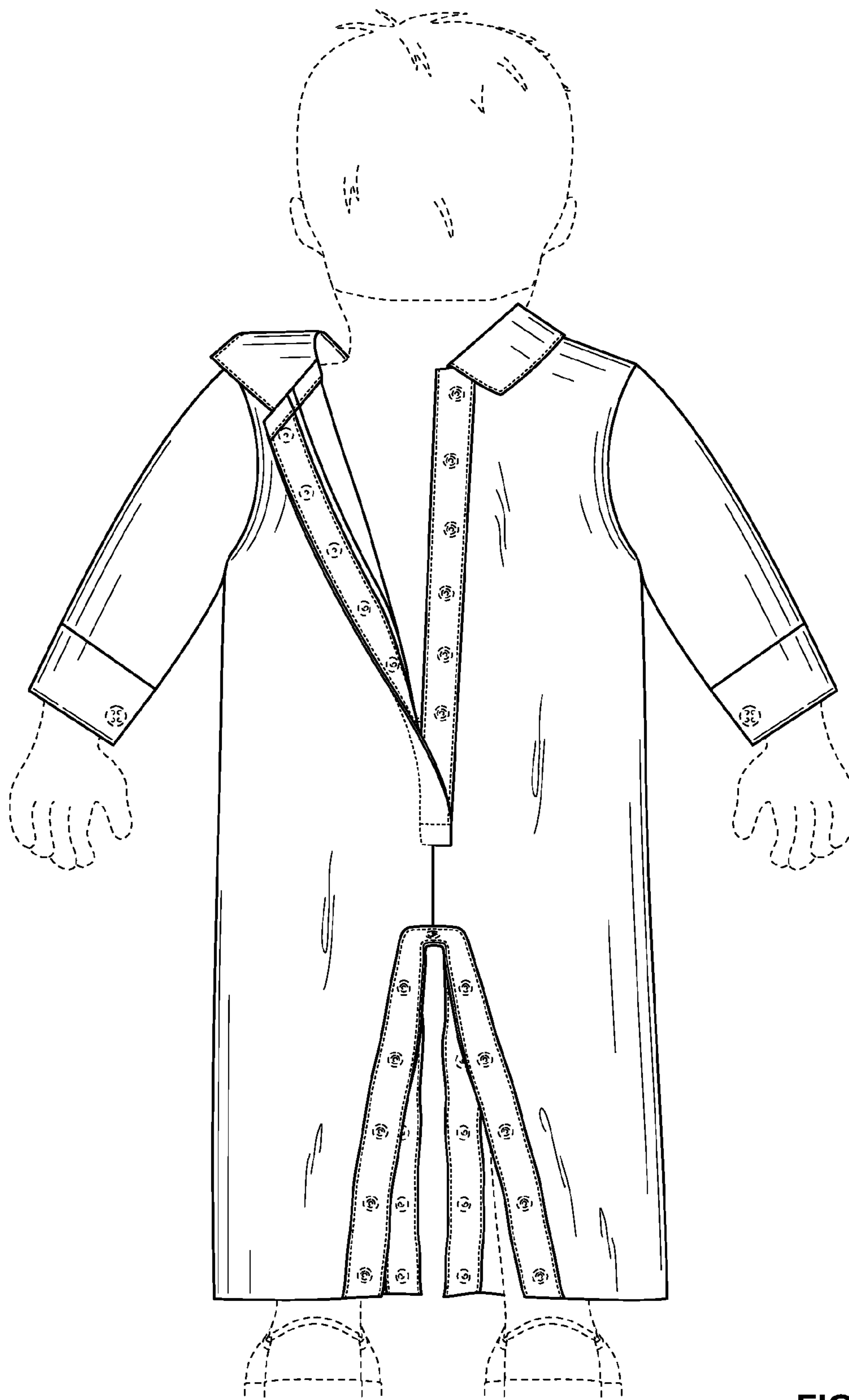

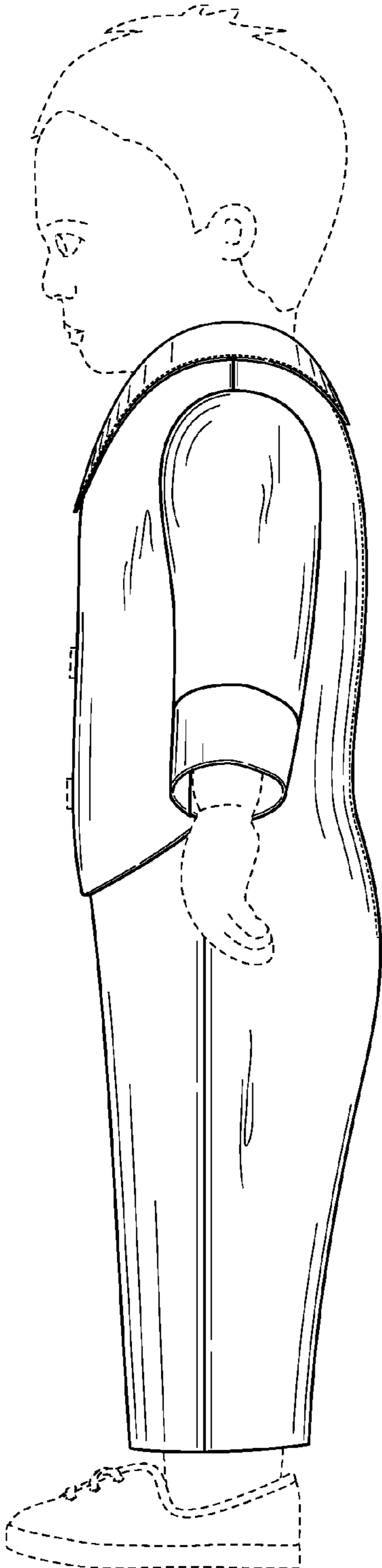

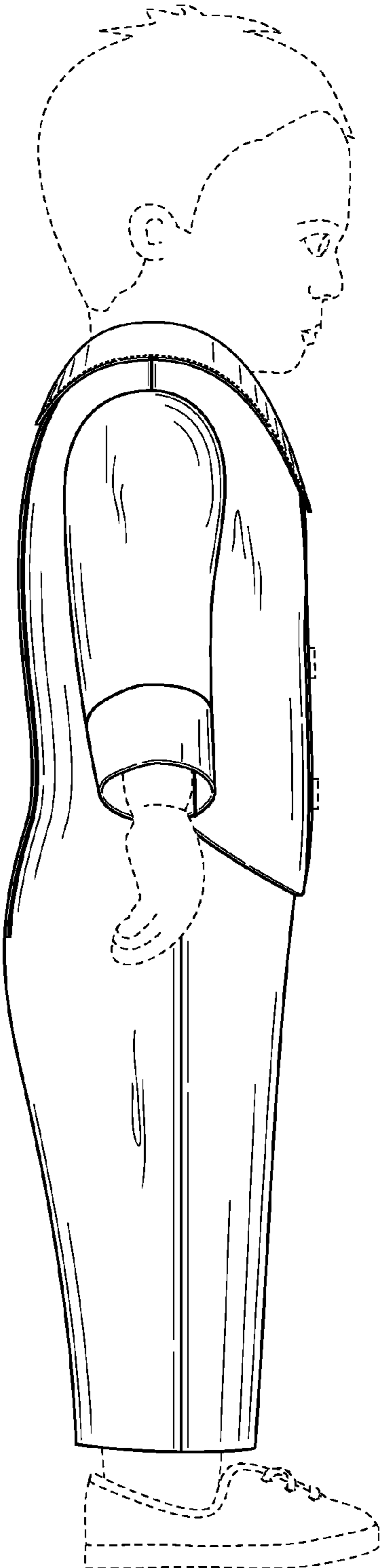
