DESCRIPTION

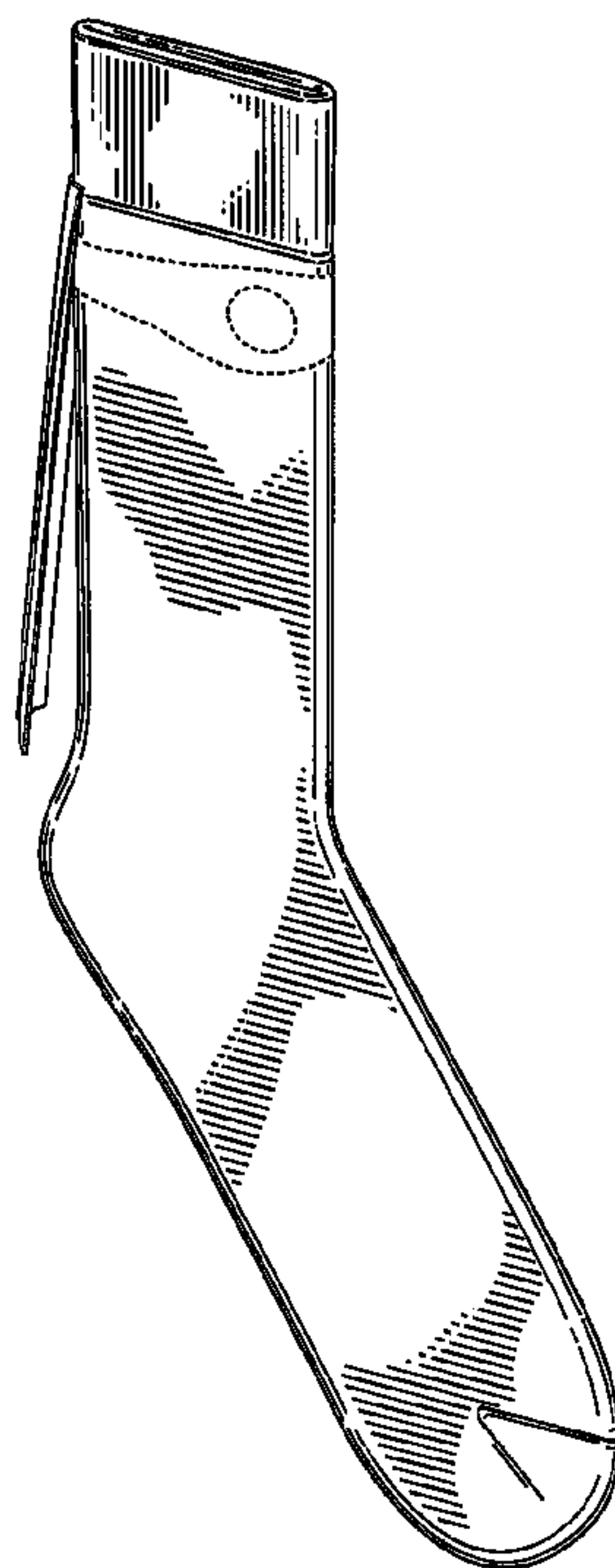
FIG. 1 is a top, right, front perspective view of the sock according to a first embodiment showing my new design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof. FIG. 8 is a top, right, front perspective view of the sock according to a second embodiment; FIG. 9 is a right side view thereof; FIG. 10 is a left side view thereof; FIG. 11 is a front view thereof; FIG. 12 is a rear view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof. The stipple shading on the rear strings in the second embodiment indicates a contrasted material.

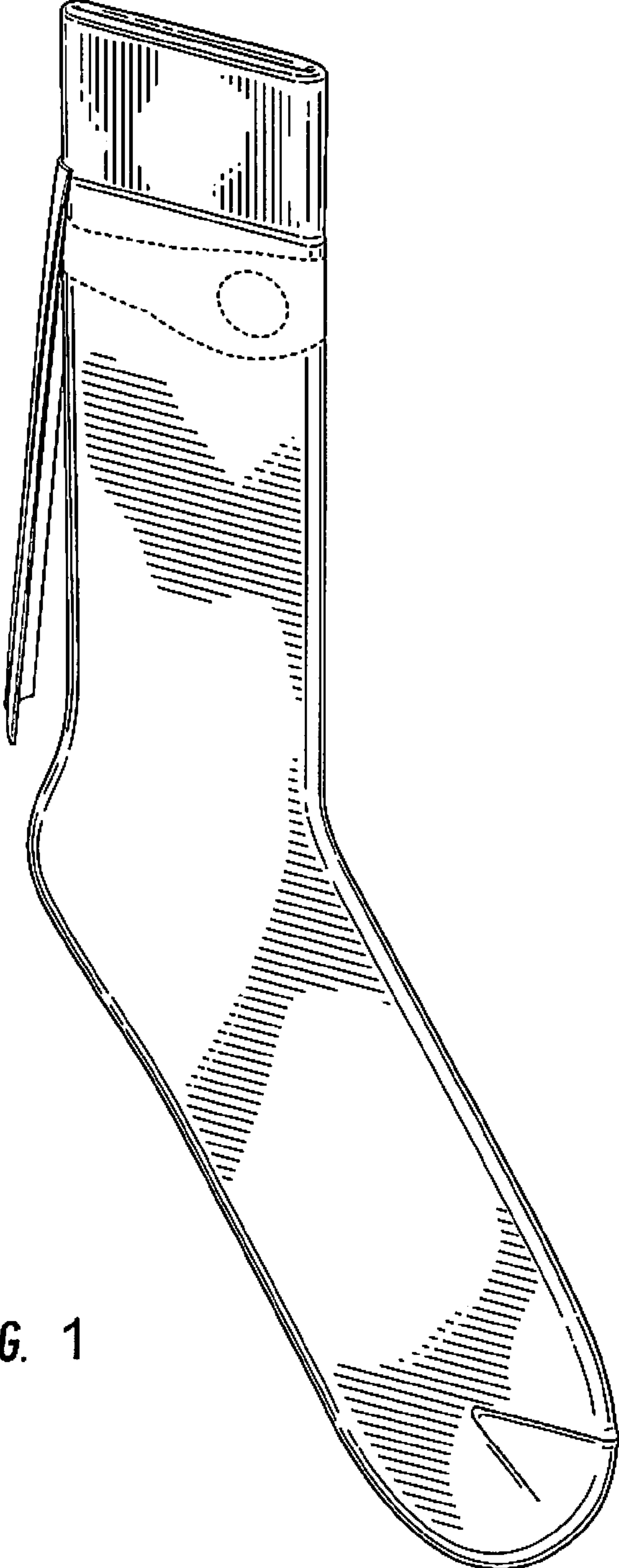

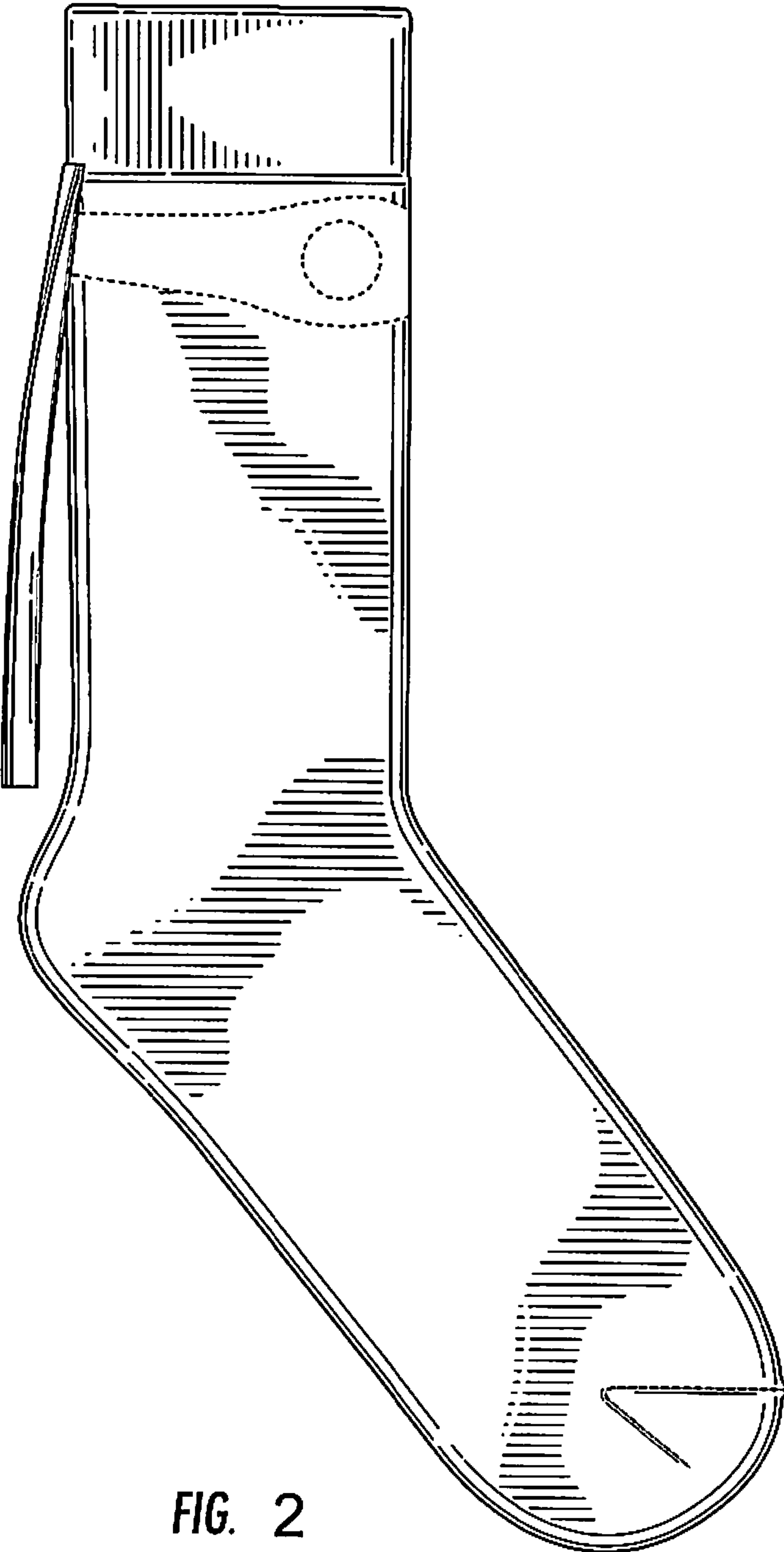

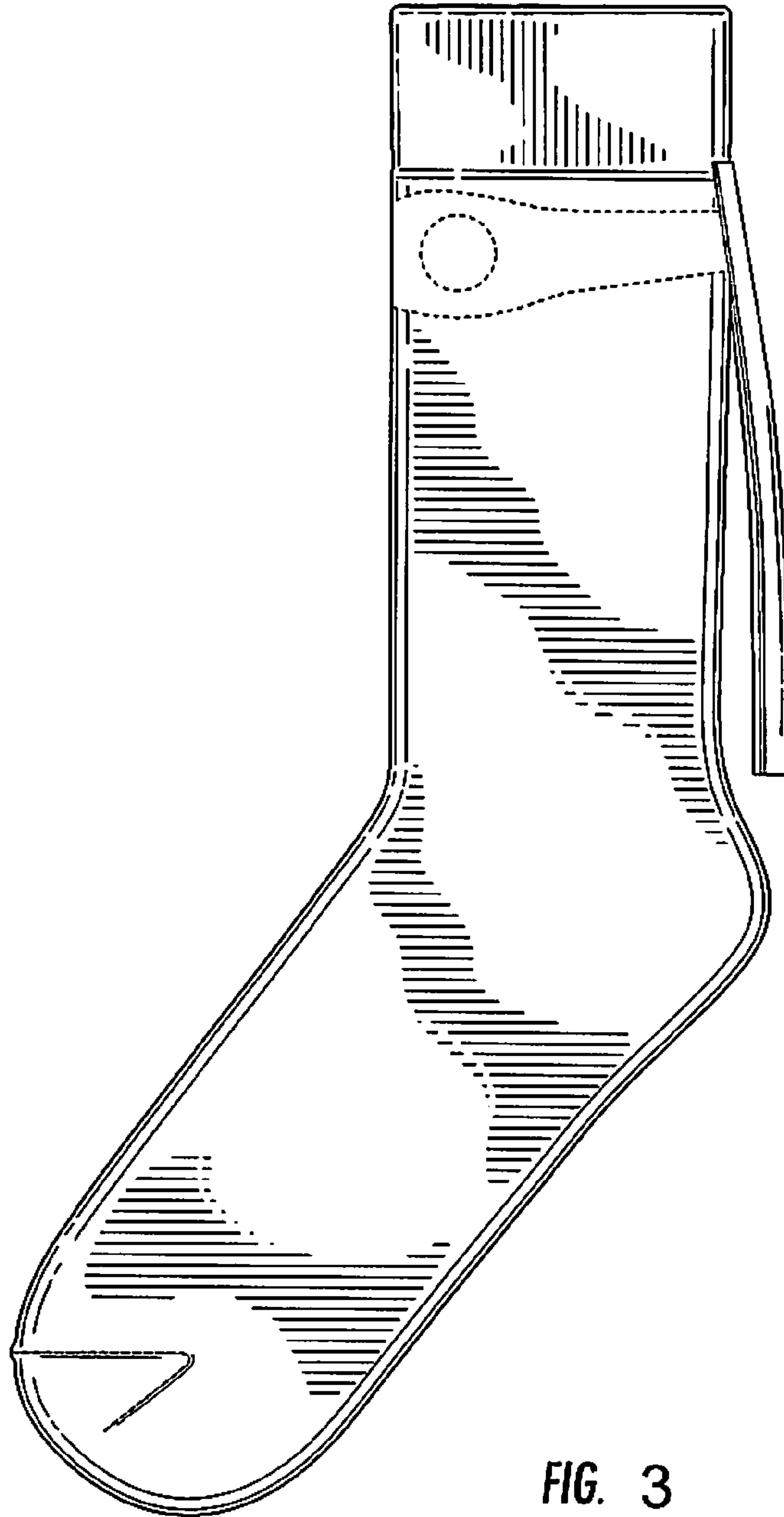

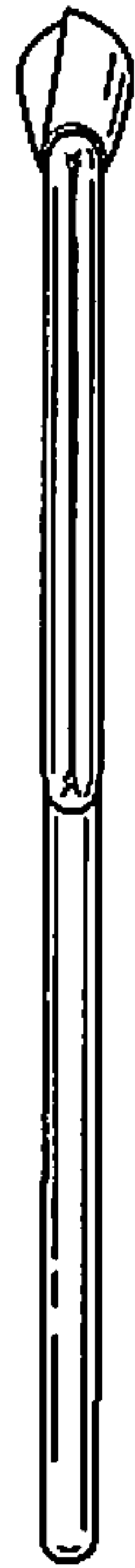

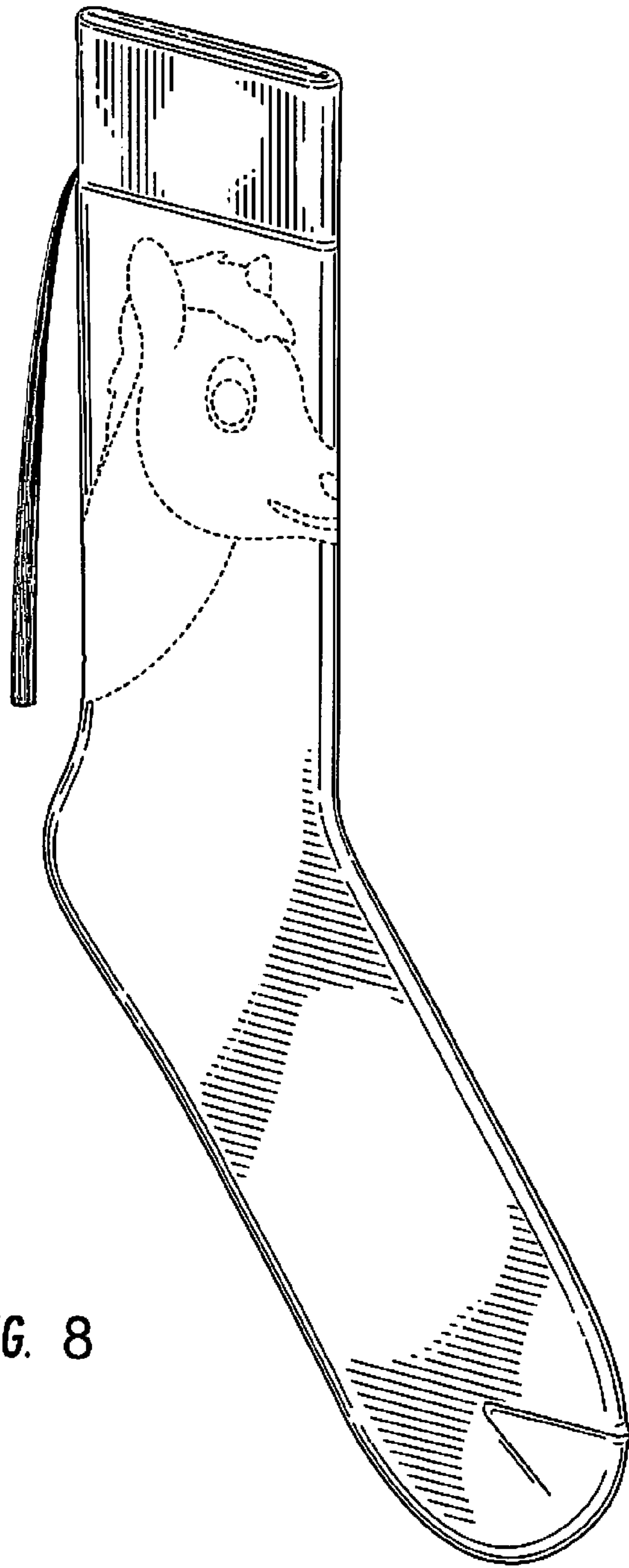

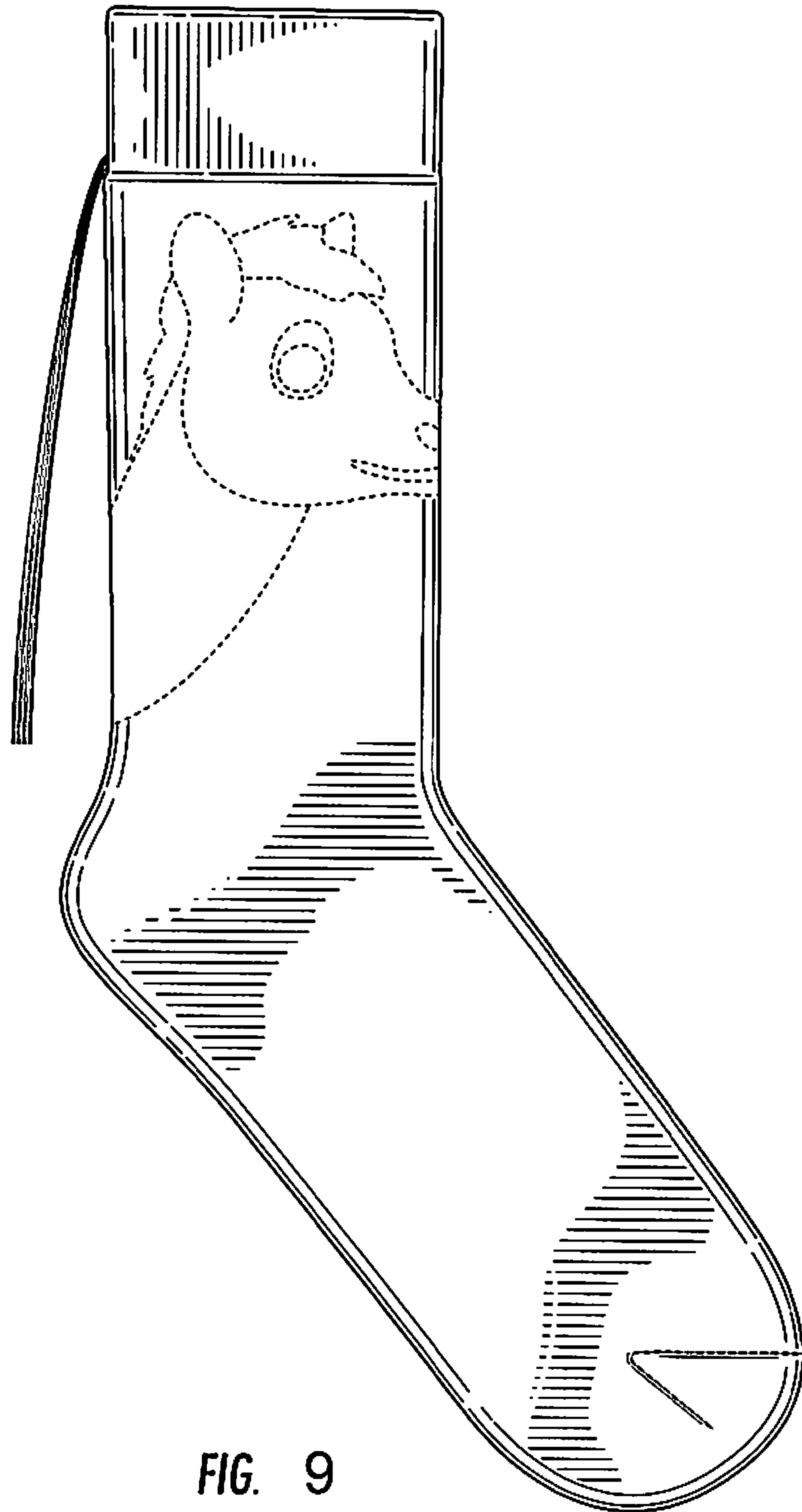

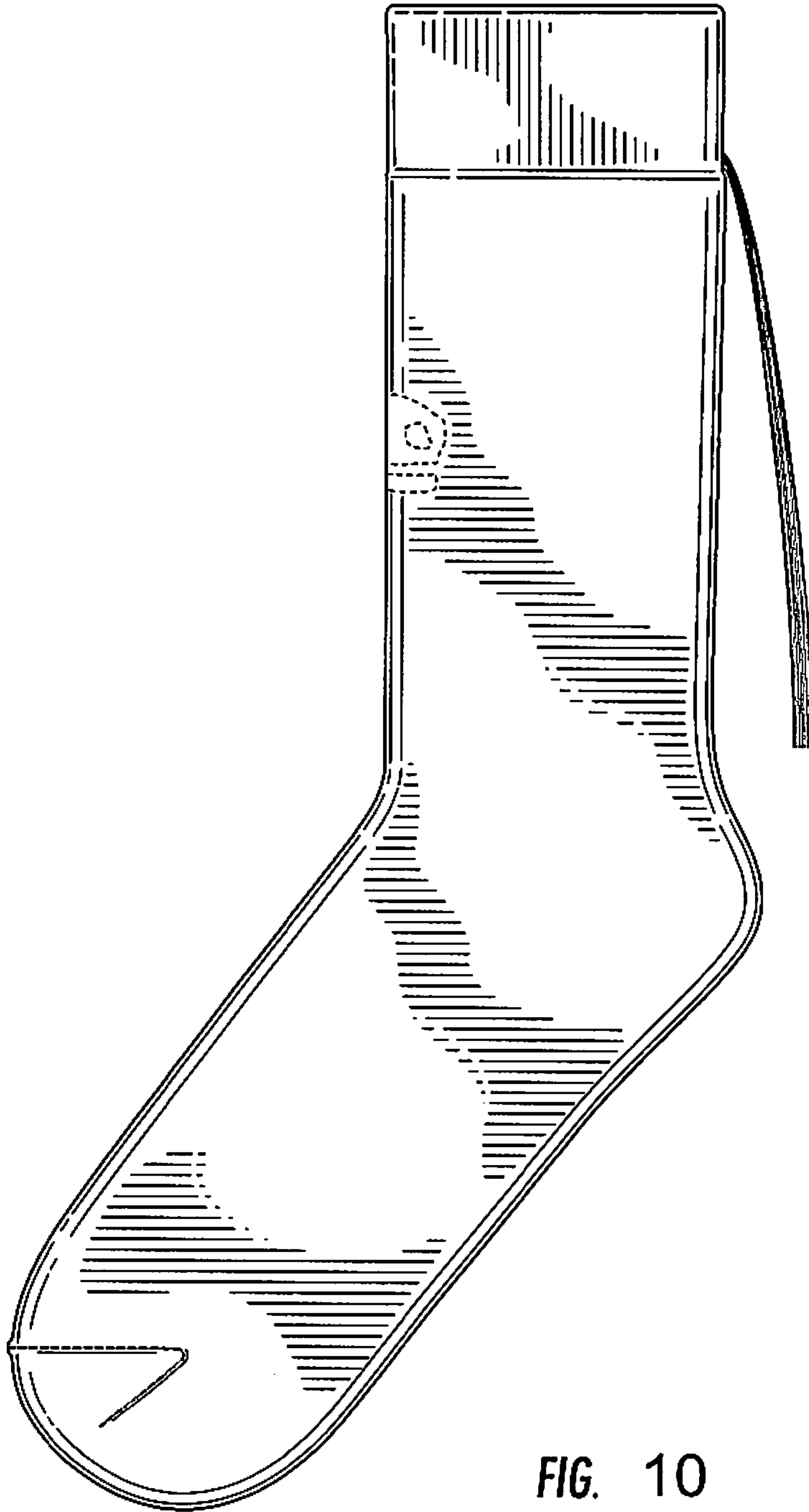
