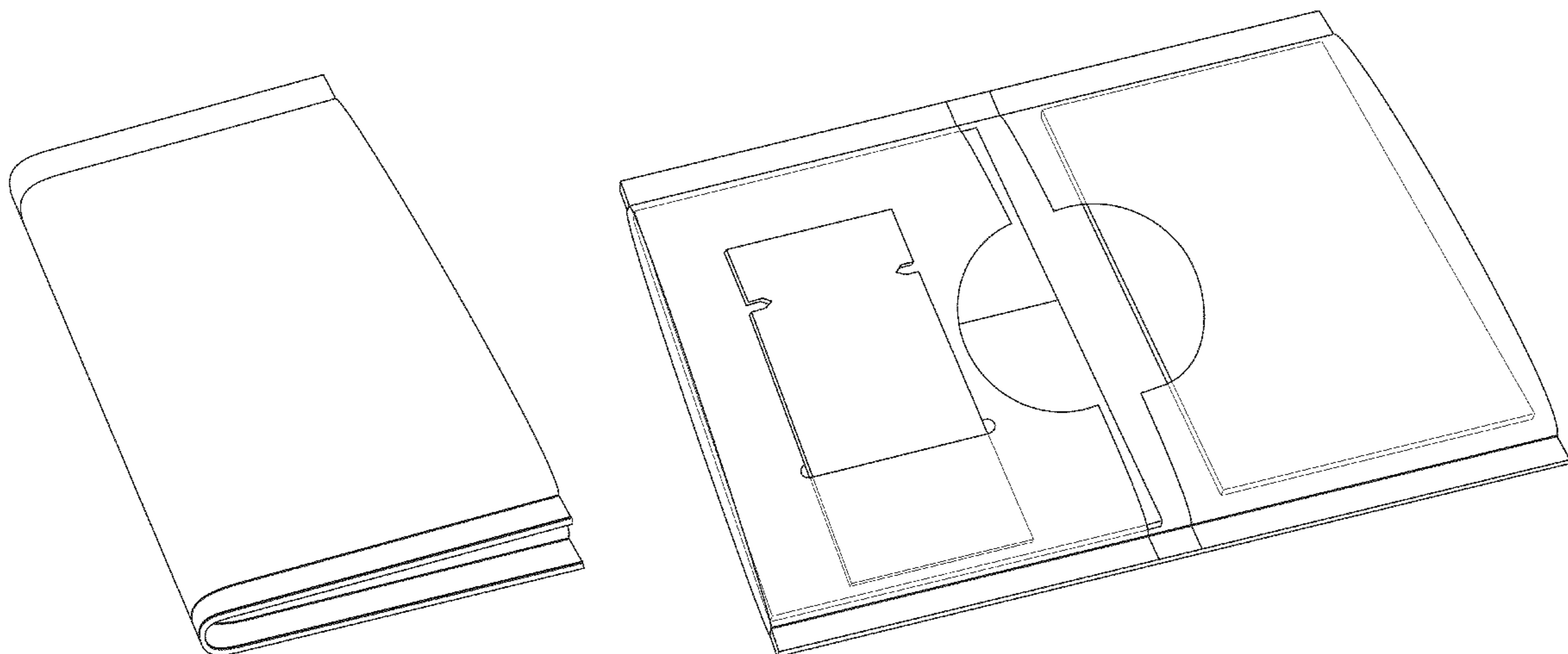
(57) **CLAIM**

The ornamental design for a package for different single-use articles, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a package for different single-use articles showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a front view of the article in its open position;  
FIG. 5 is a rear view thereof;  
FIG. 6 is a bottom view thereof, in its closed position;  
FIG. 7 is a top view thereof;

FIG. 9 is a left side view thereof; and,  
FIG. 10 is a perspective view thereof, in its open position.

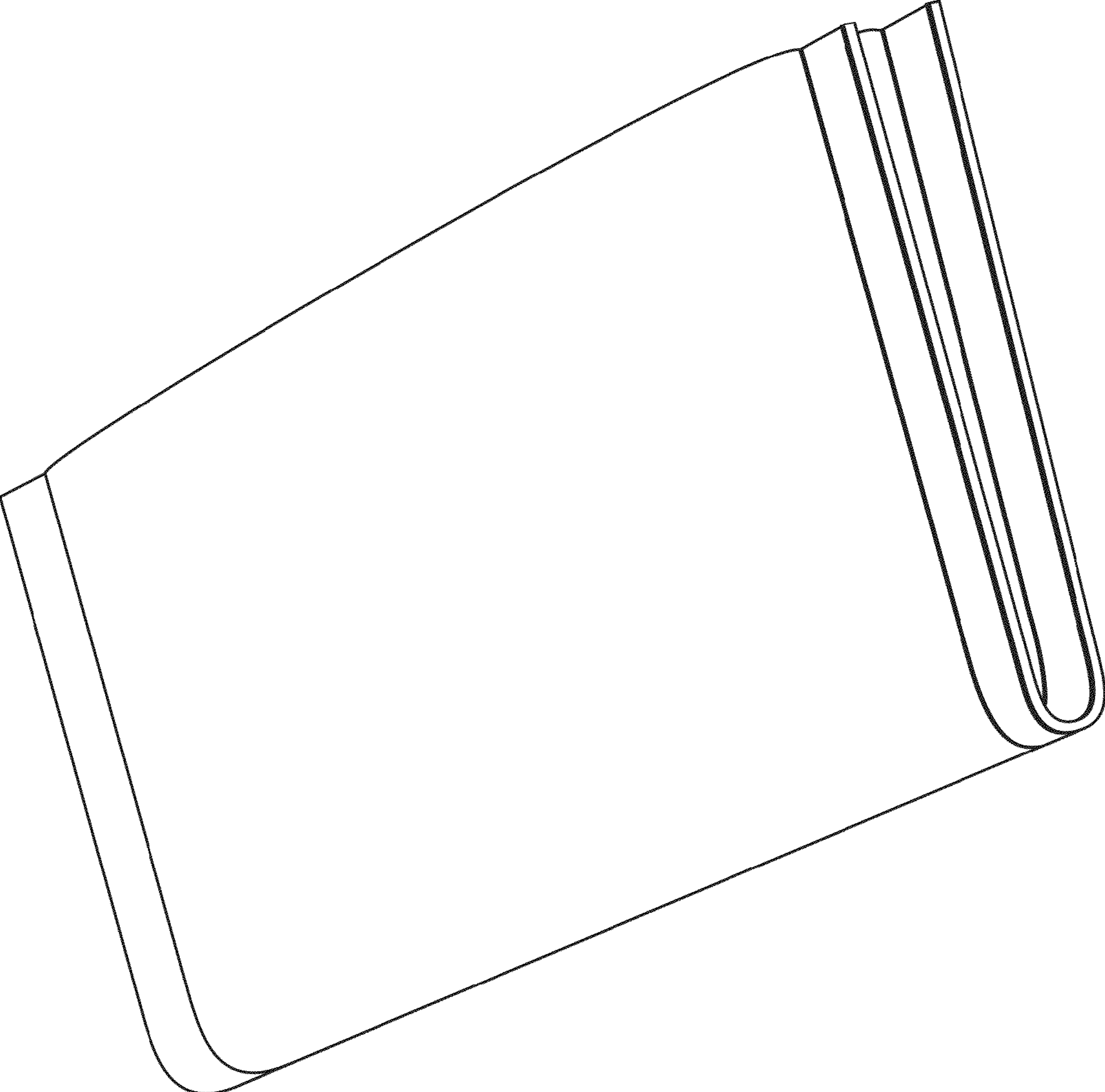

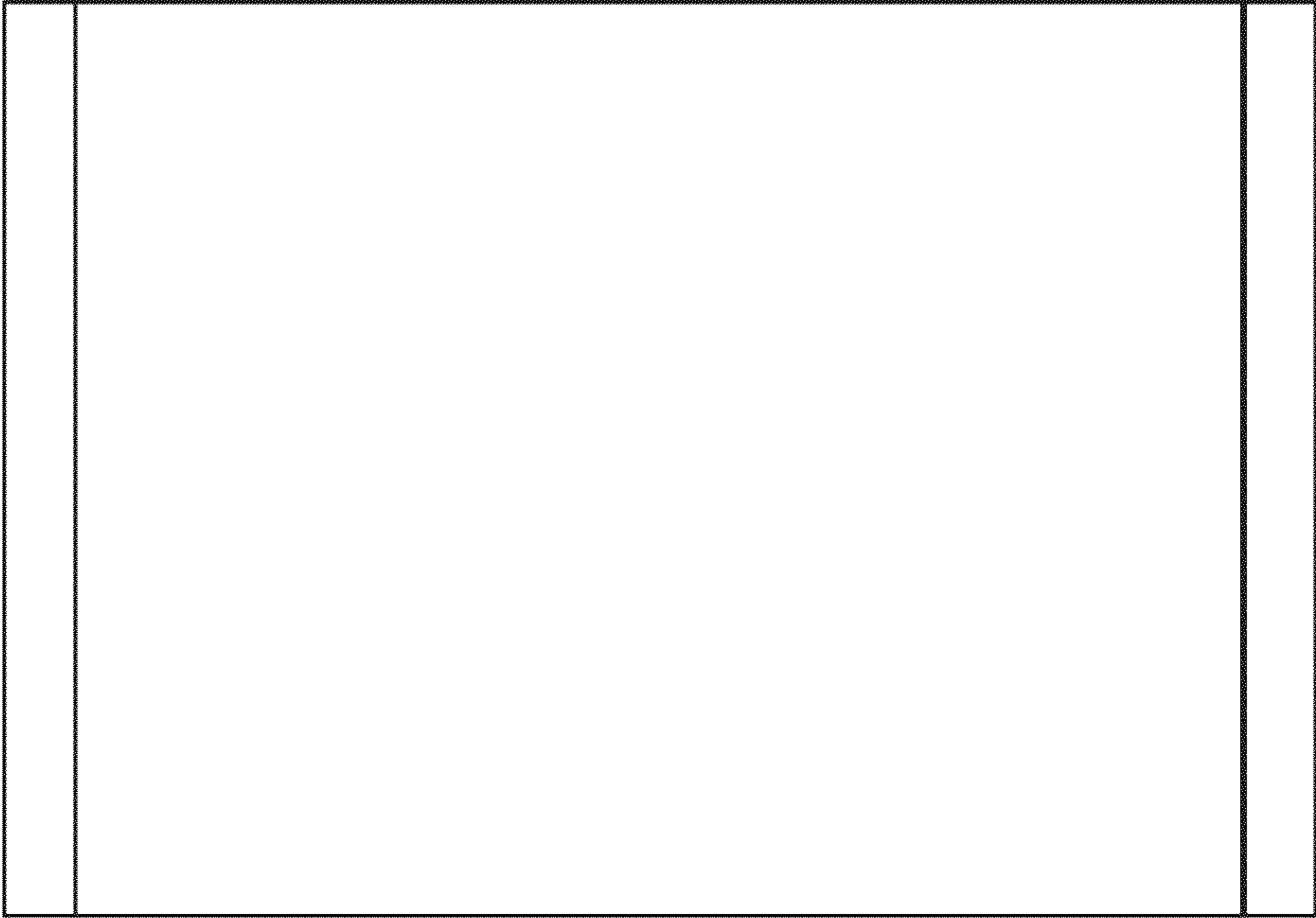

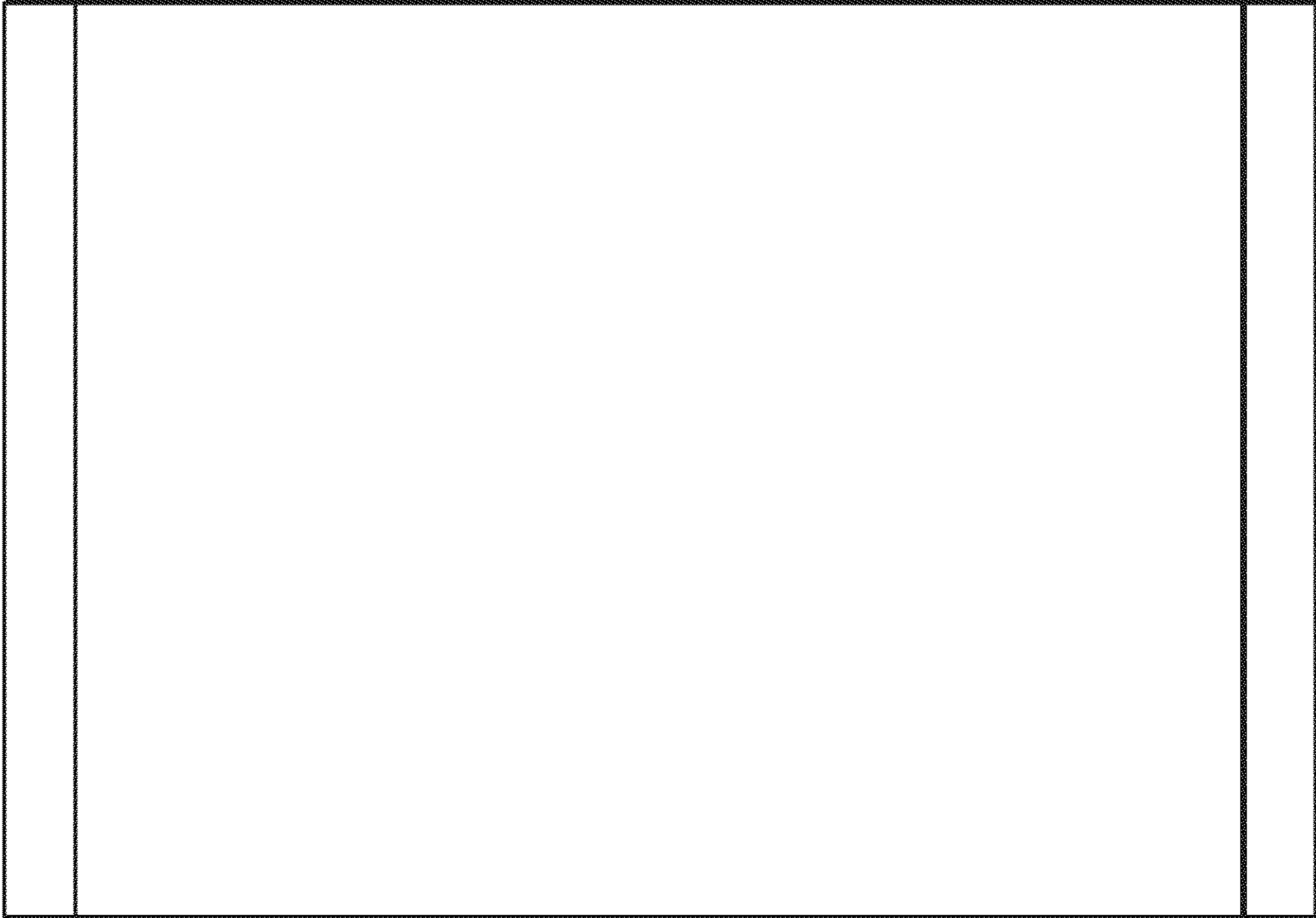

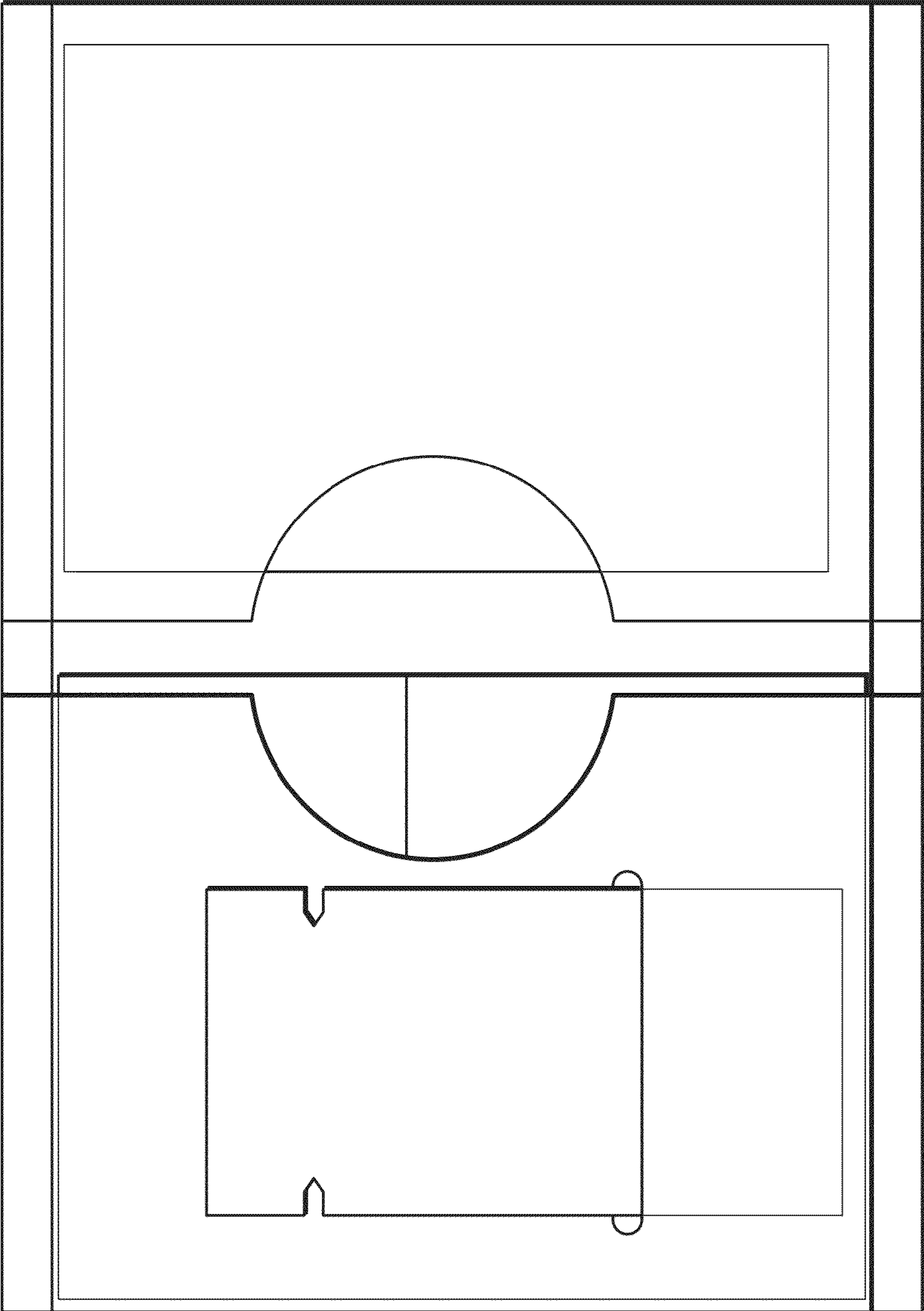

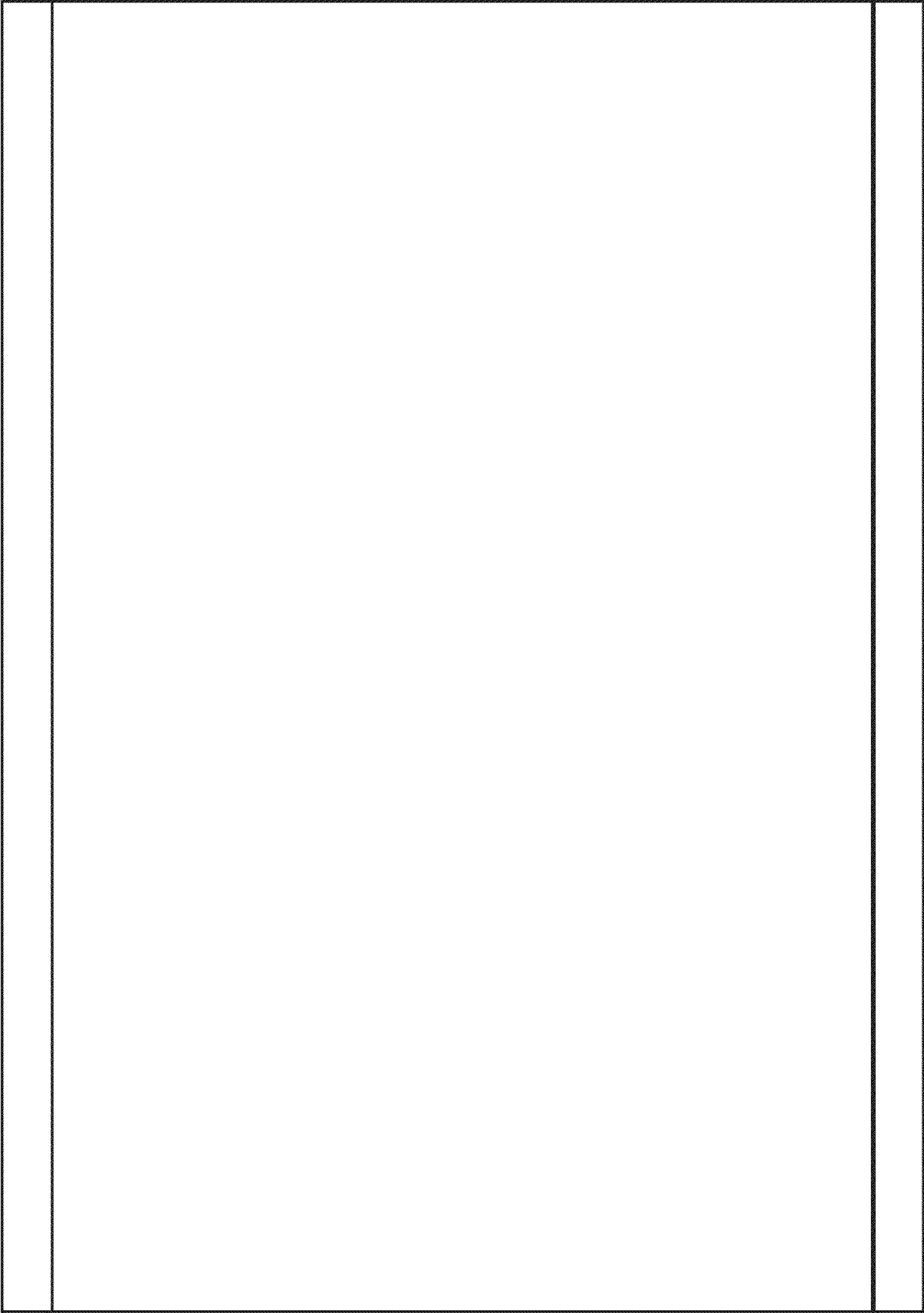

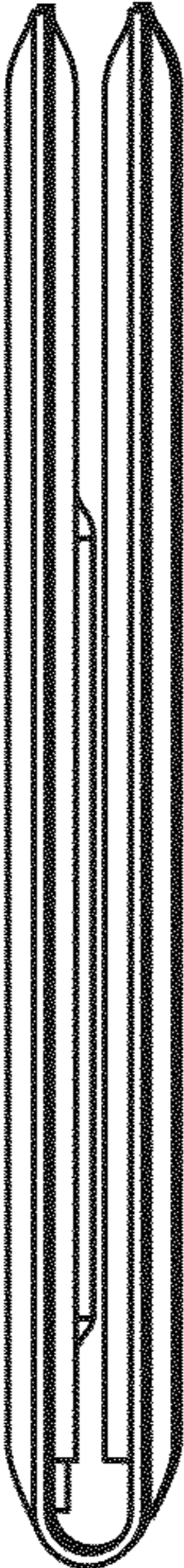

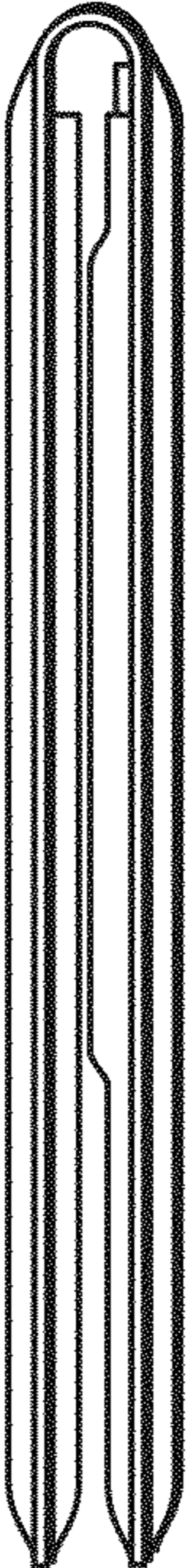

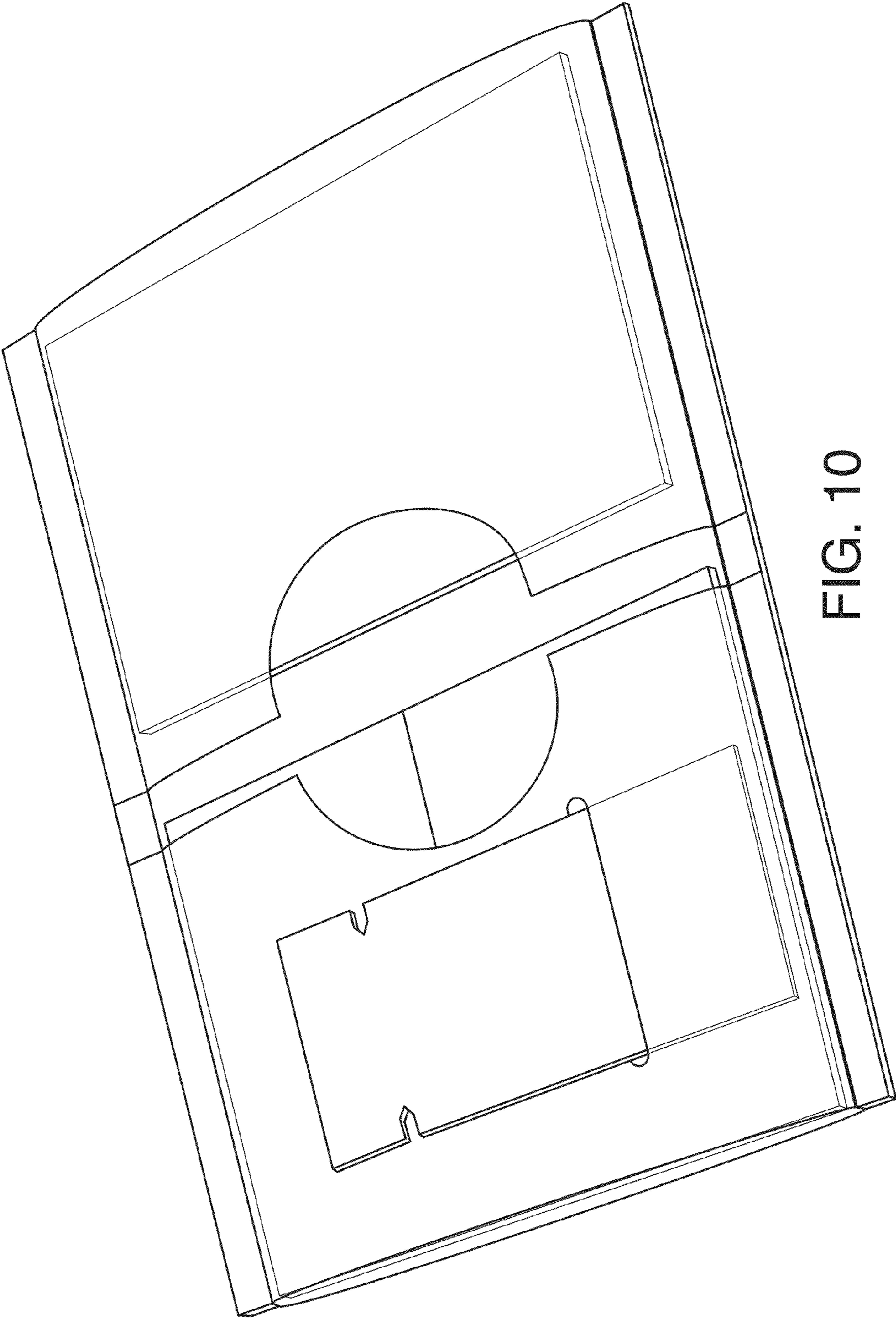
