FIG. 1 is a top perspective view of an epoxy roller cam showing my new design.

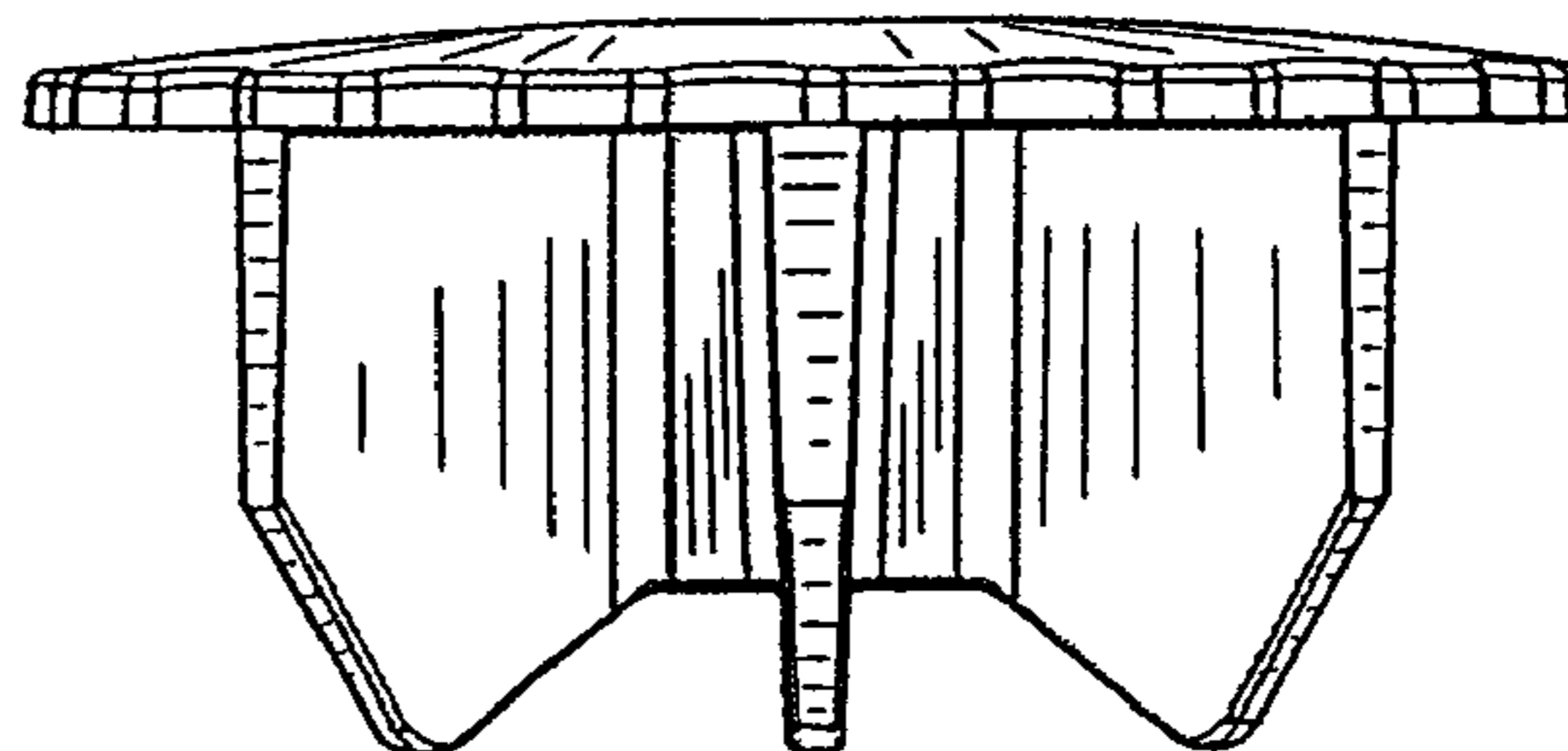
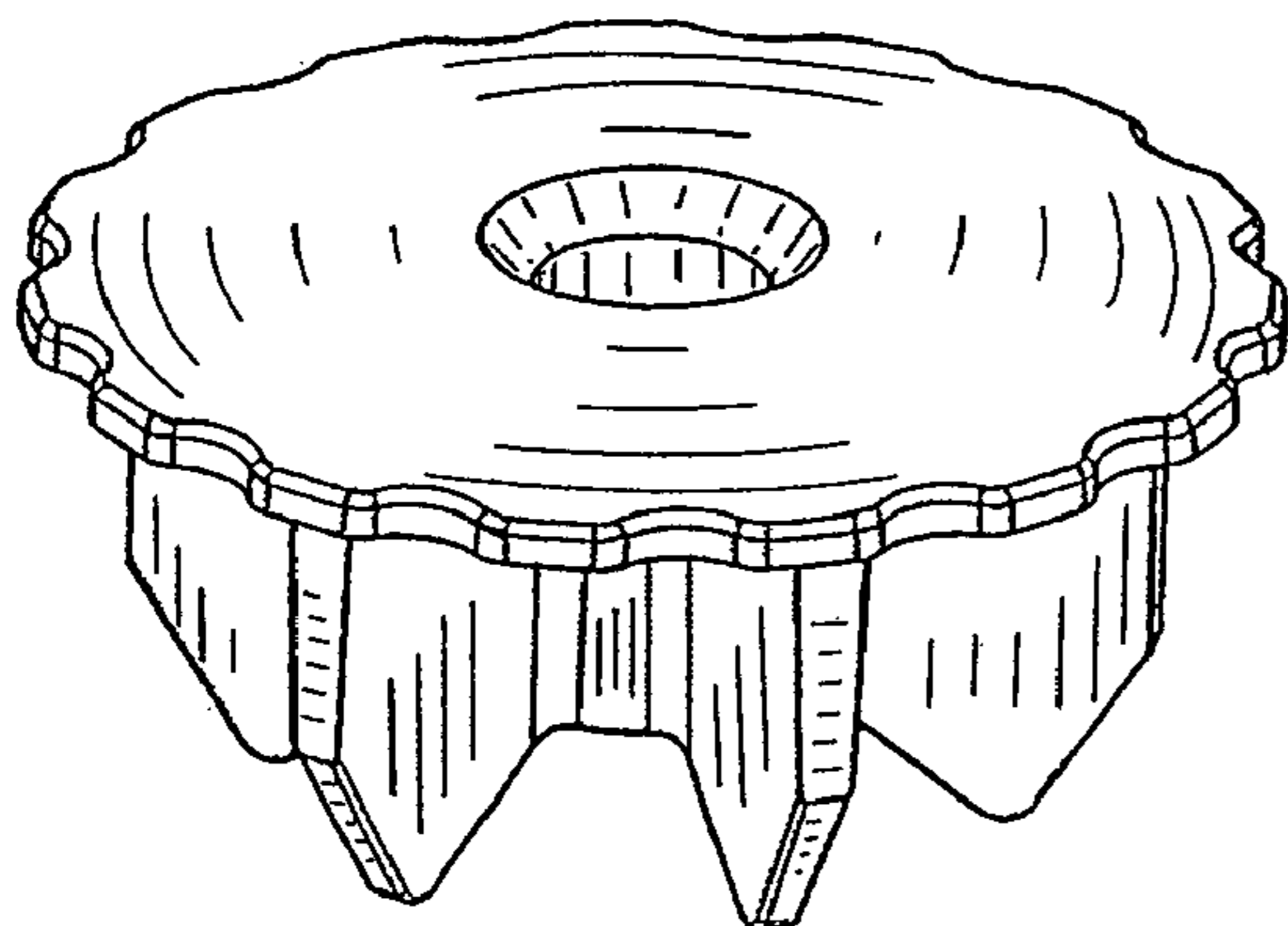
FIG. 2 is a top view thereof.

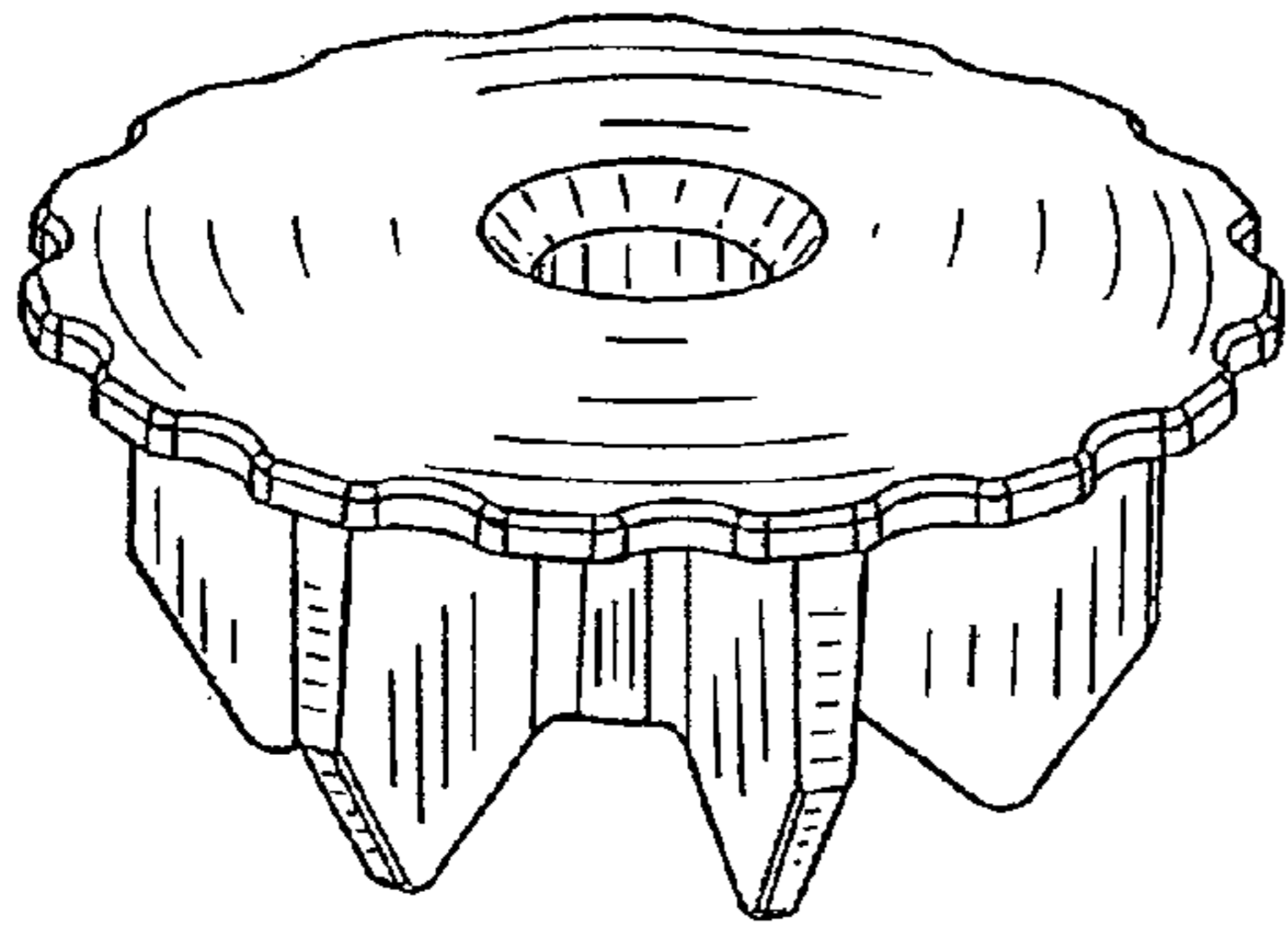

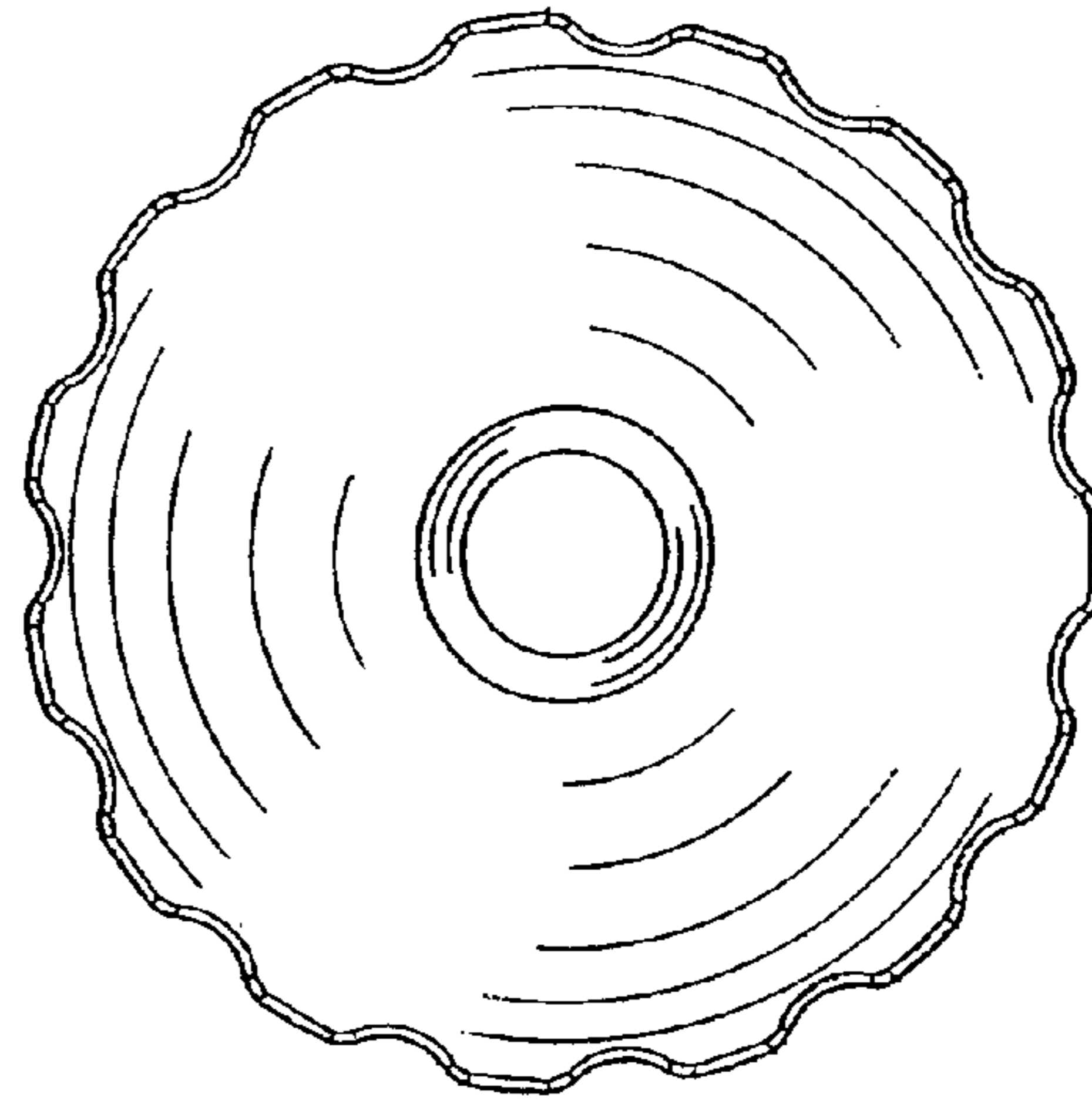

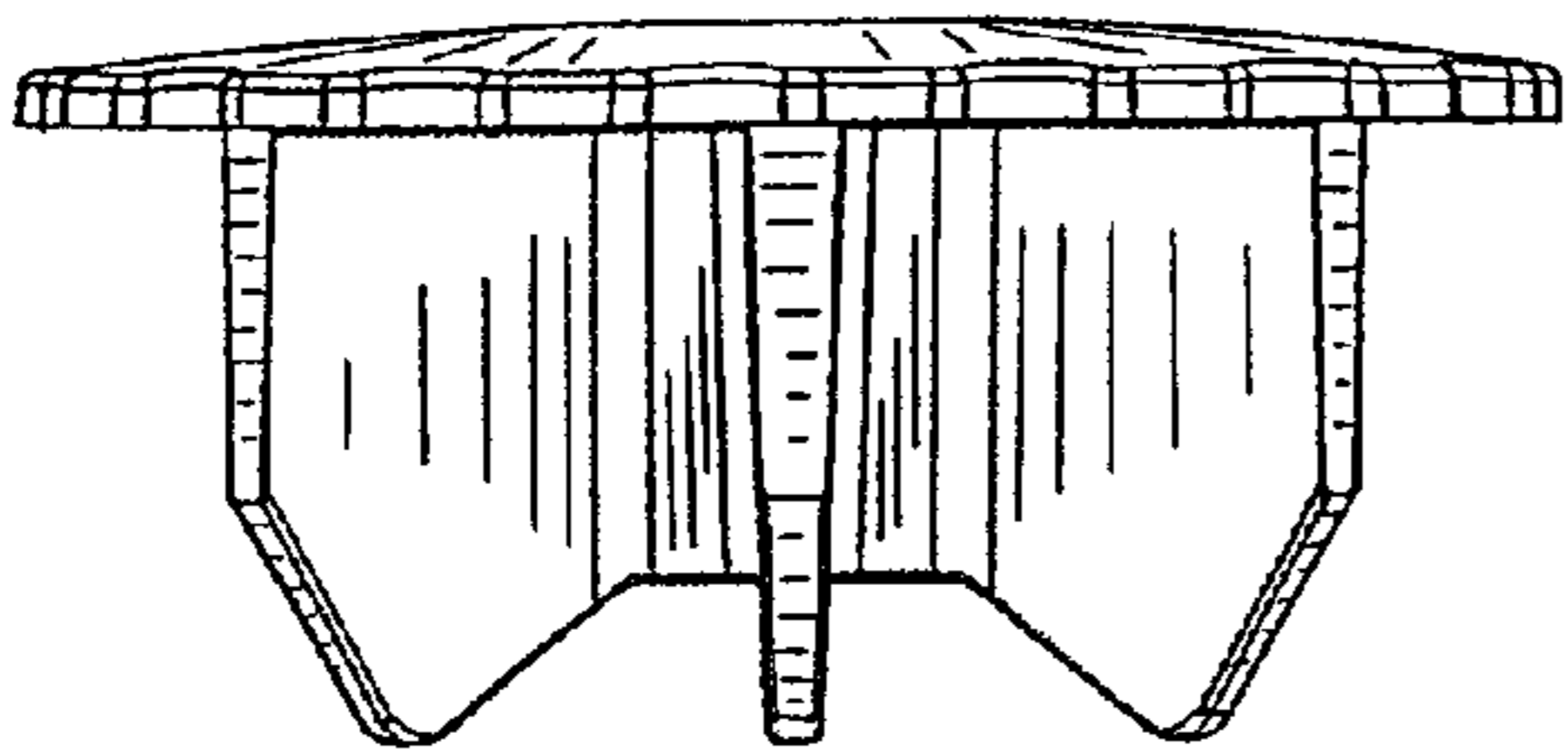

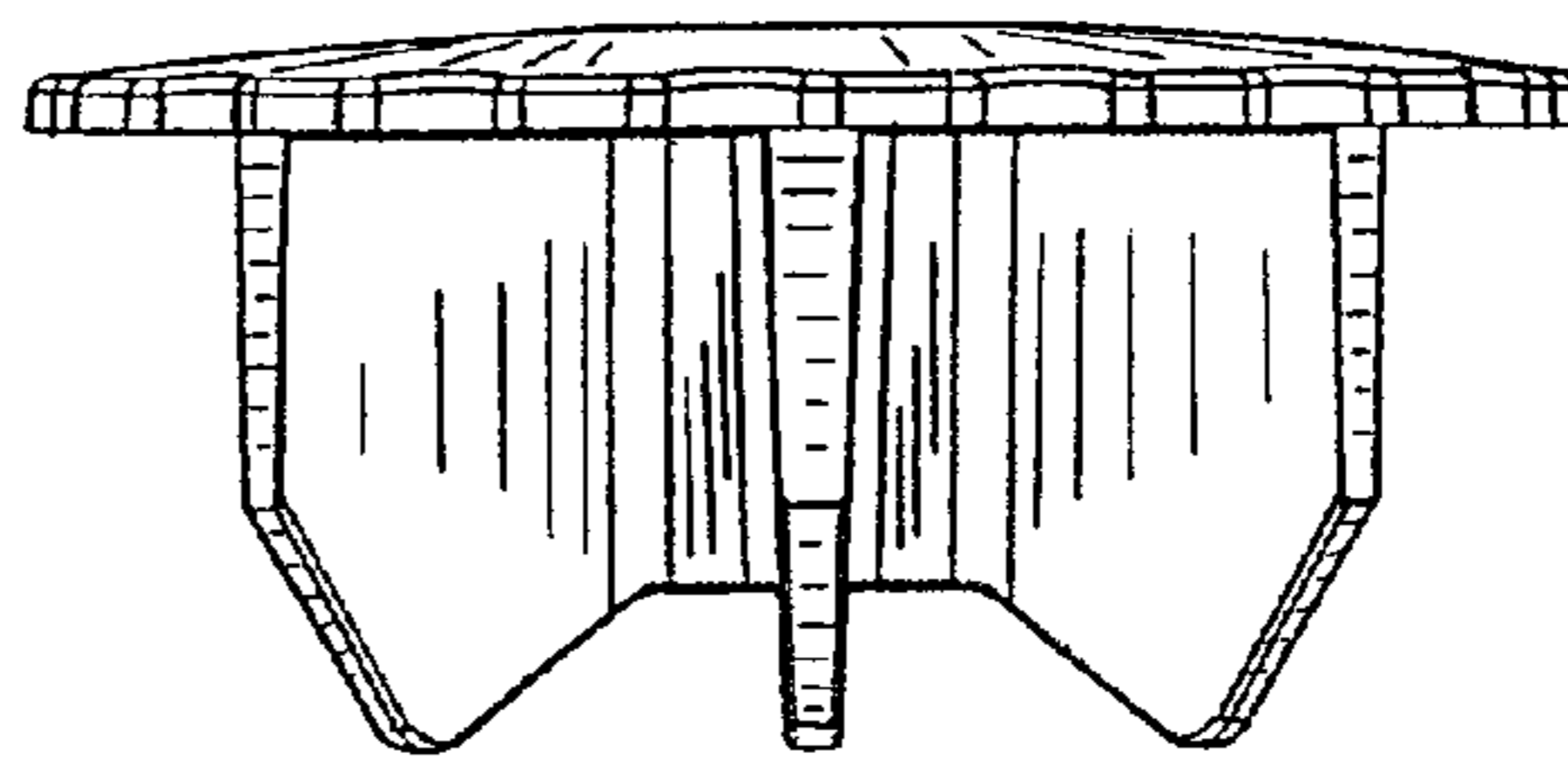

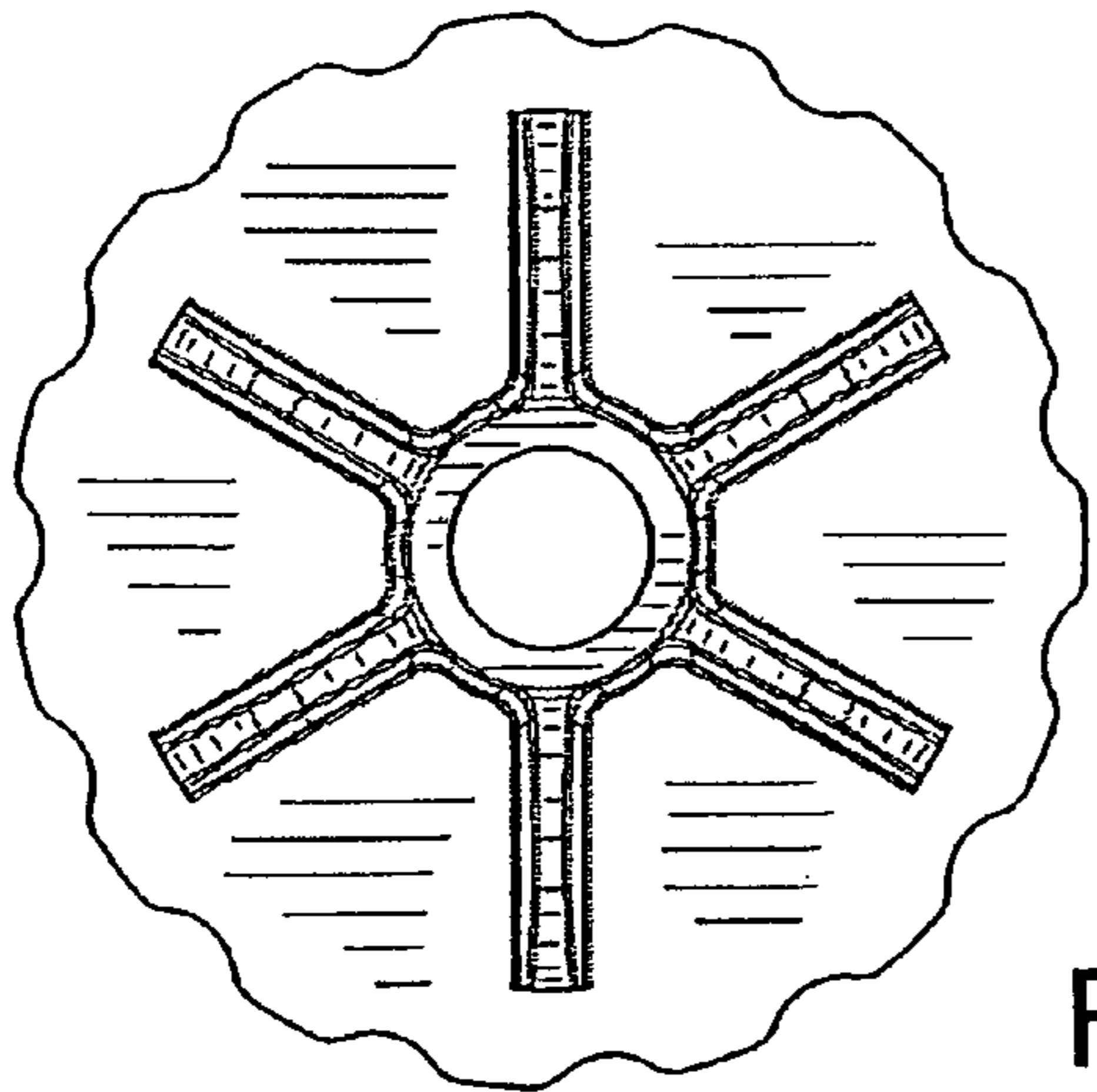
