FIG. 3 is a right side elevational view thereof;

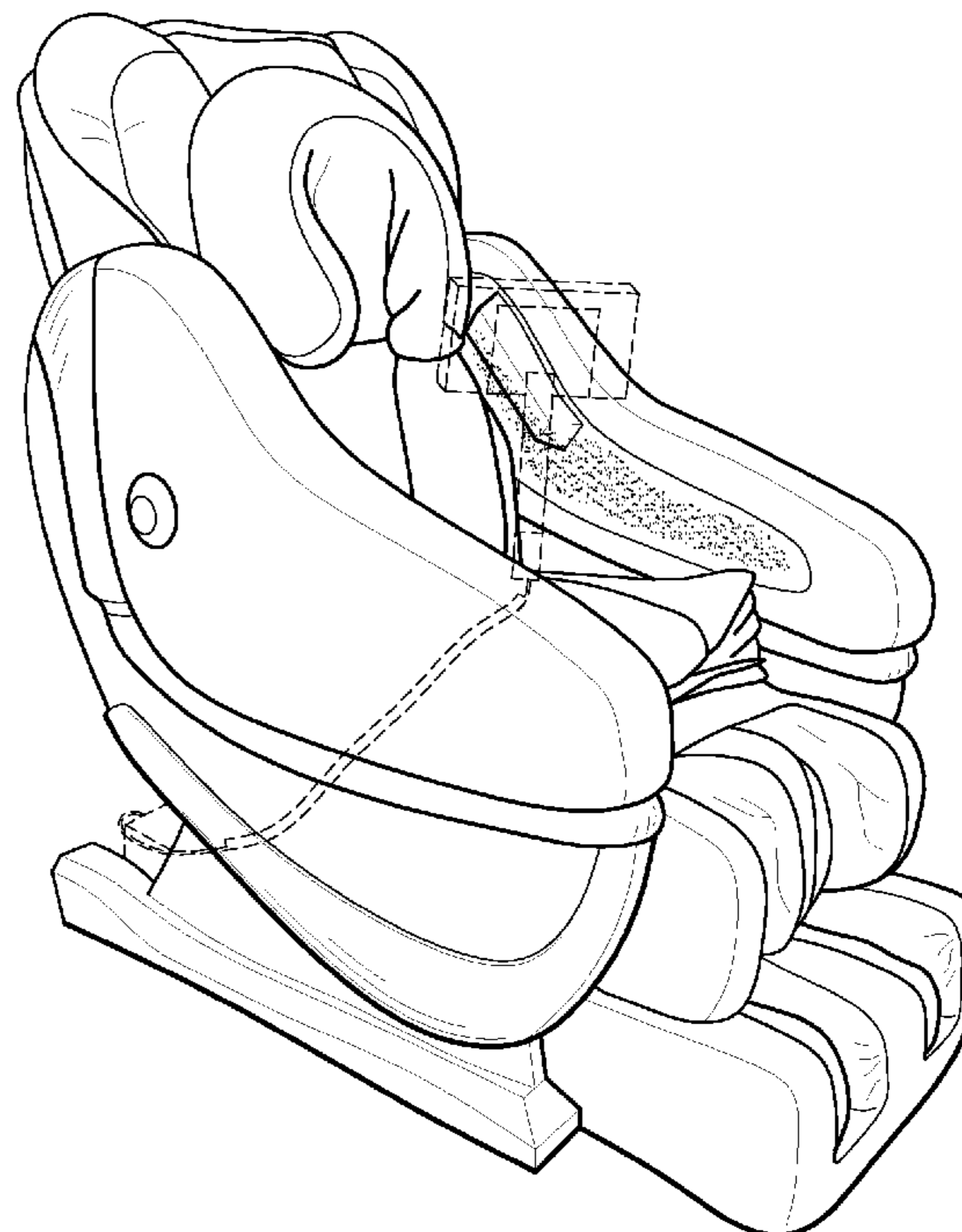
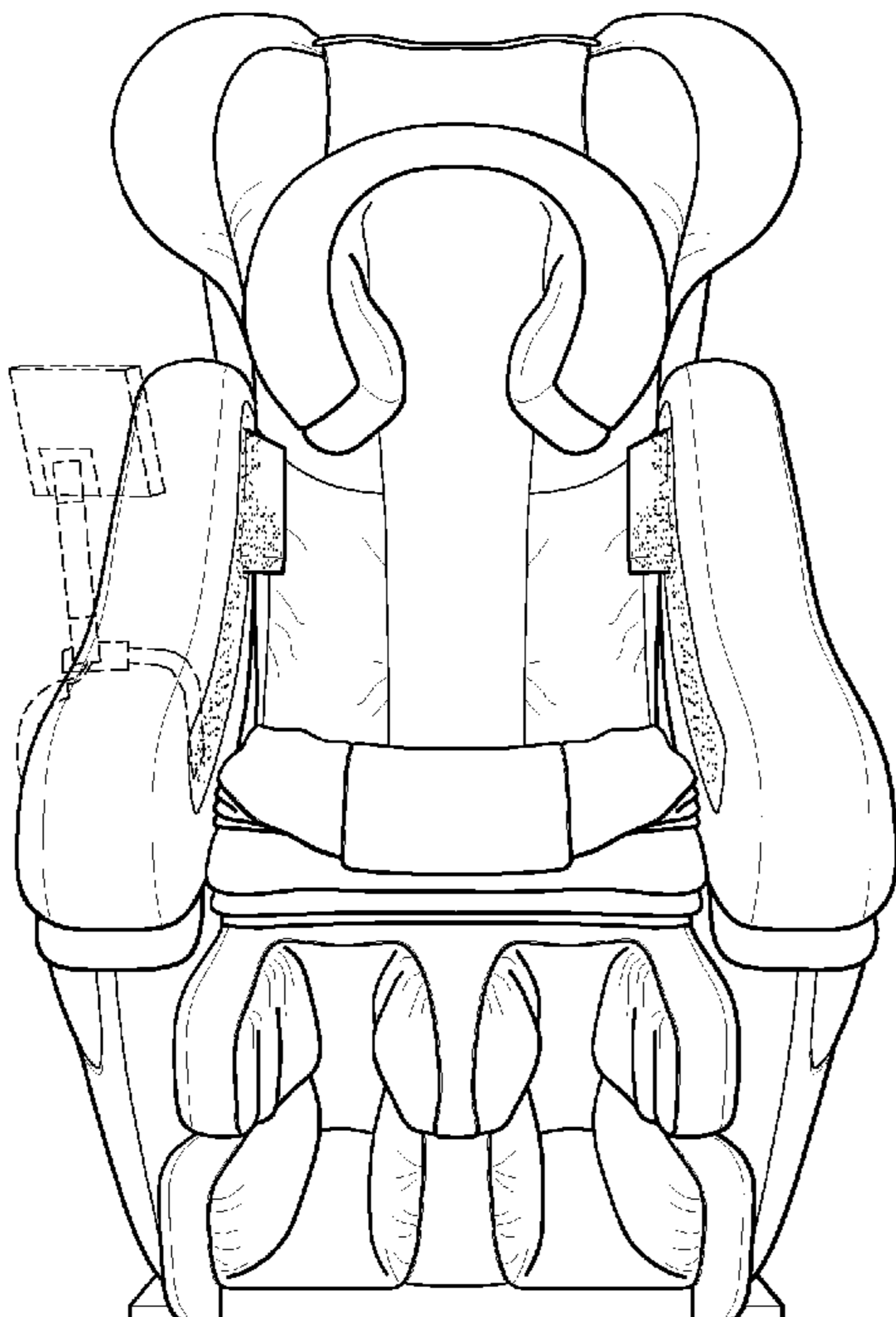
FIG. 4 is a left side elevational view thereof;

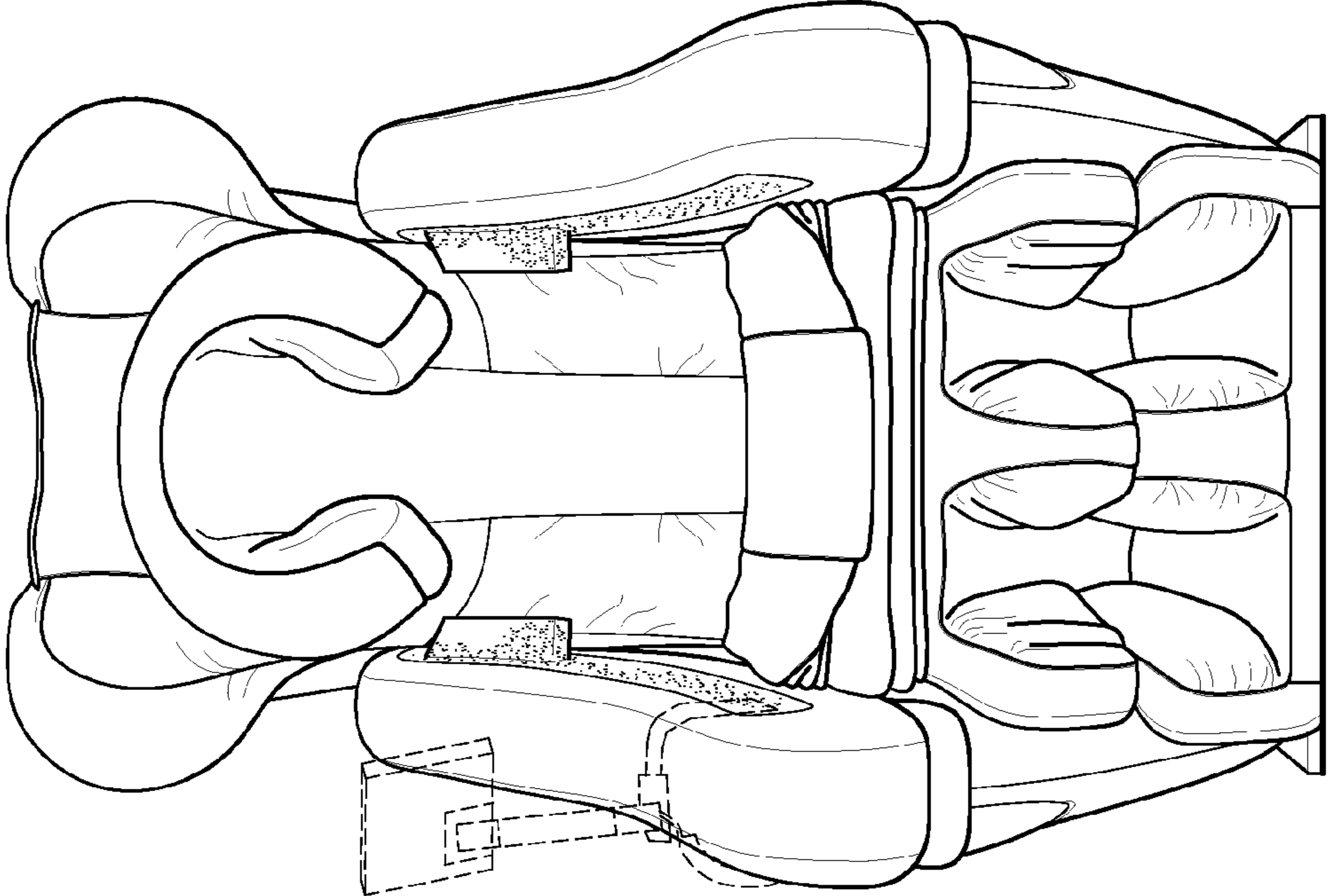
FIG. 5 is a front, right side perspective view thereof; and,

FIG. 6 is a front, left side perspective view thereof.

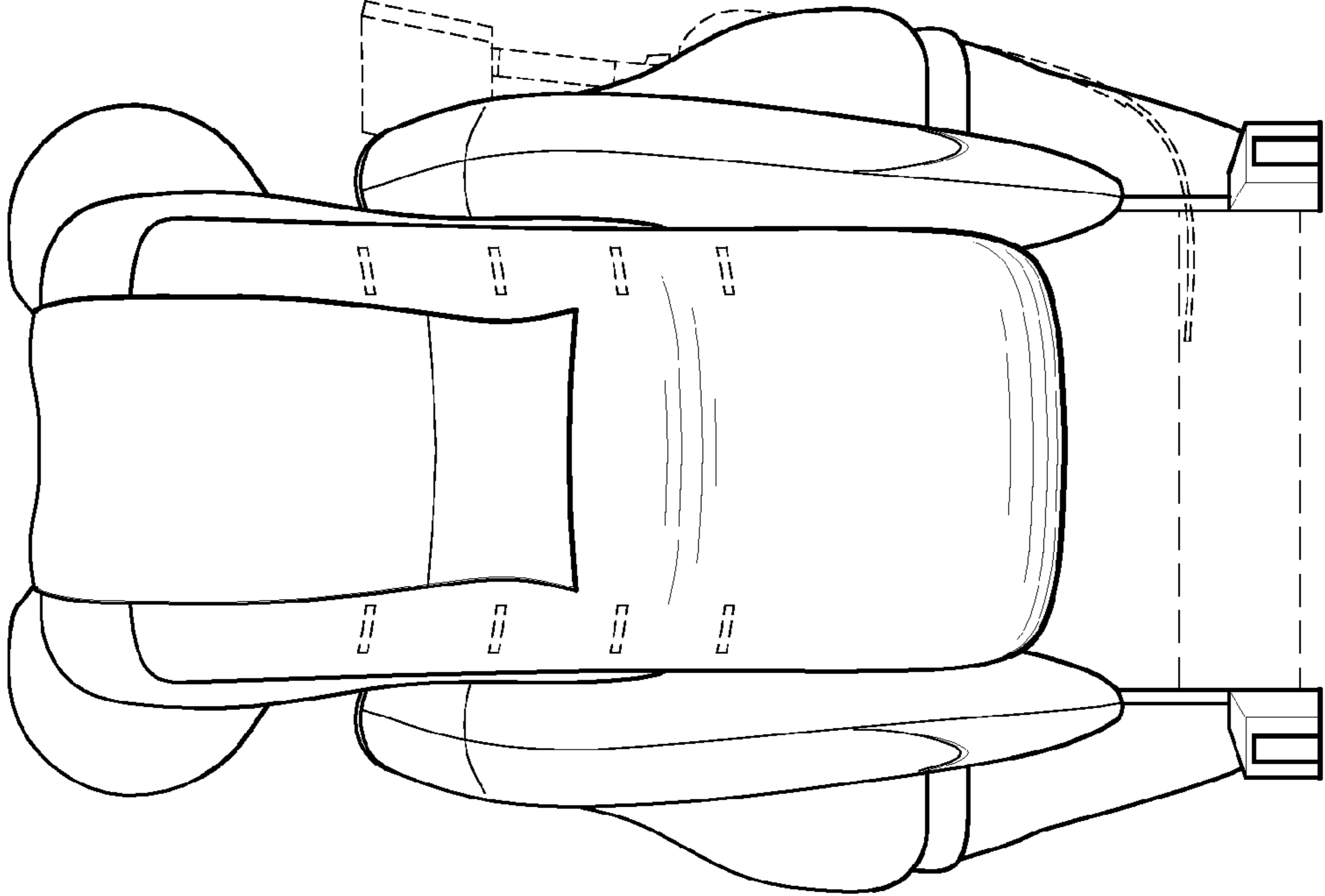

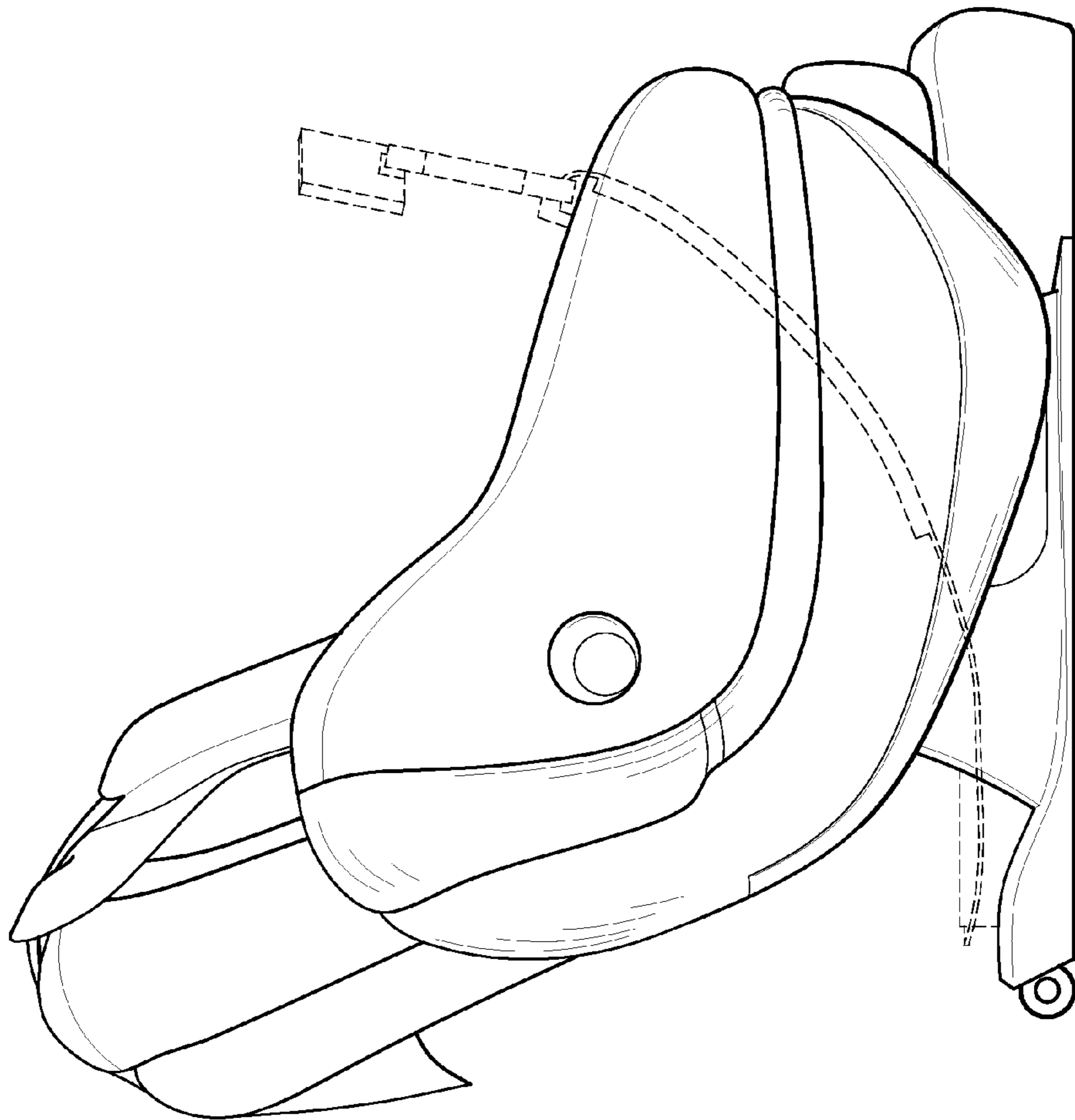




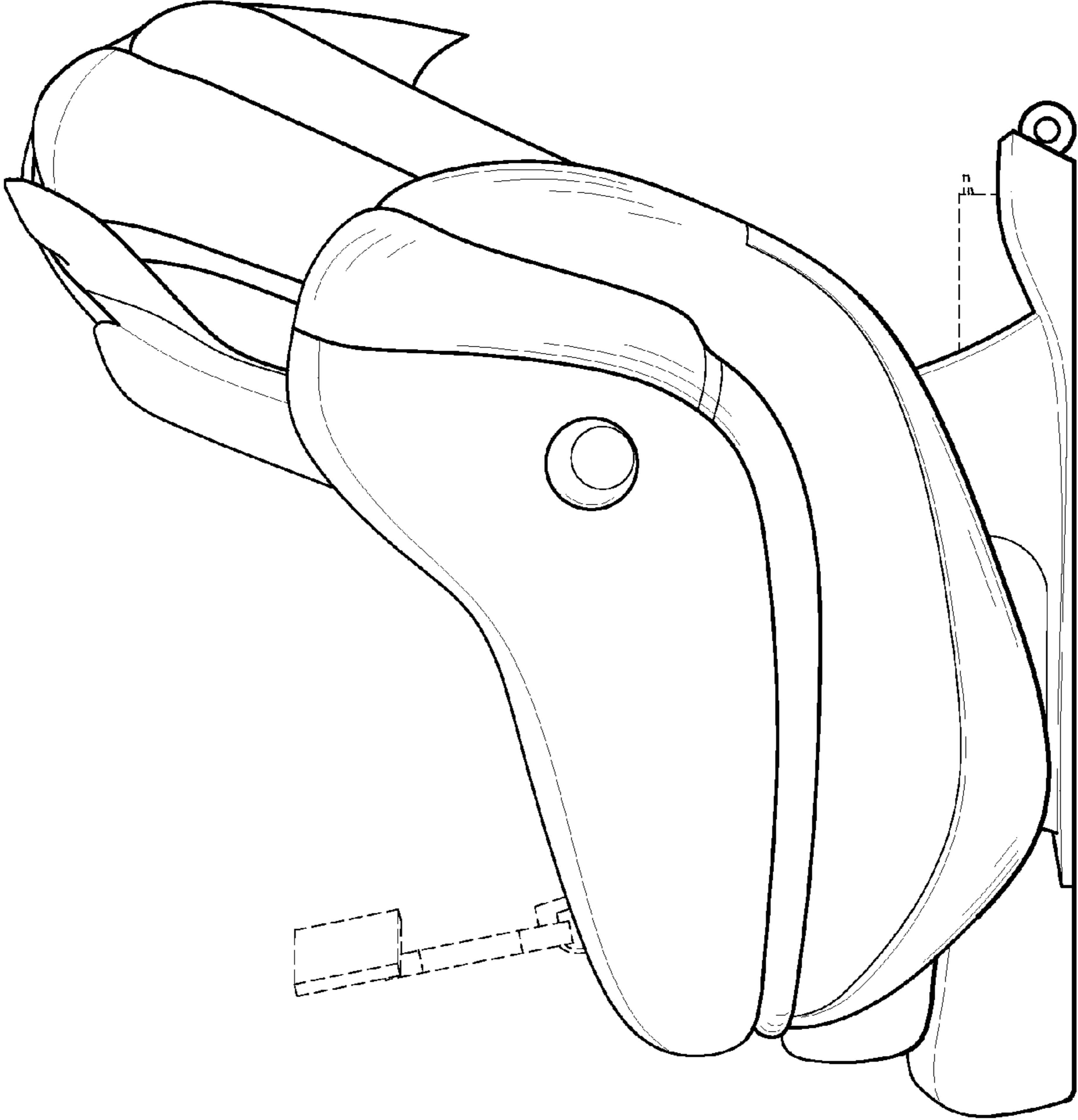

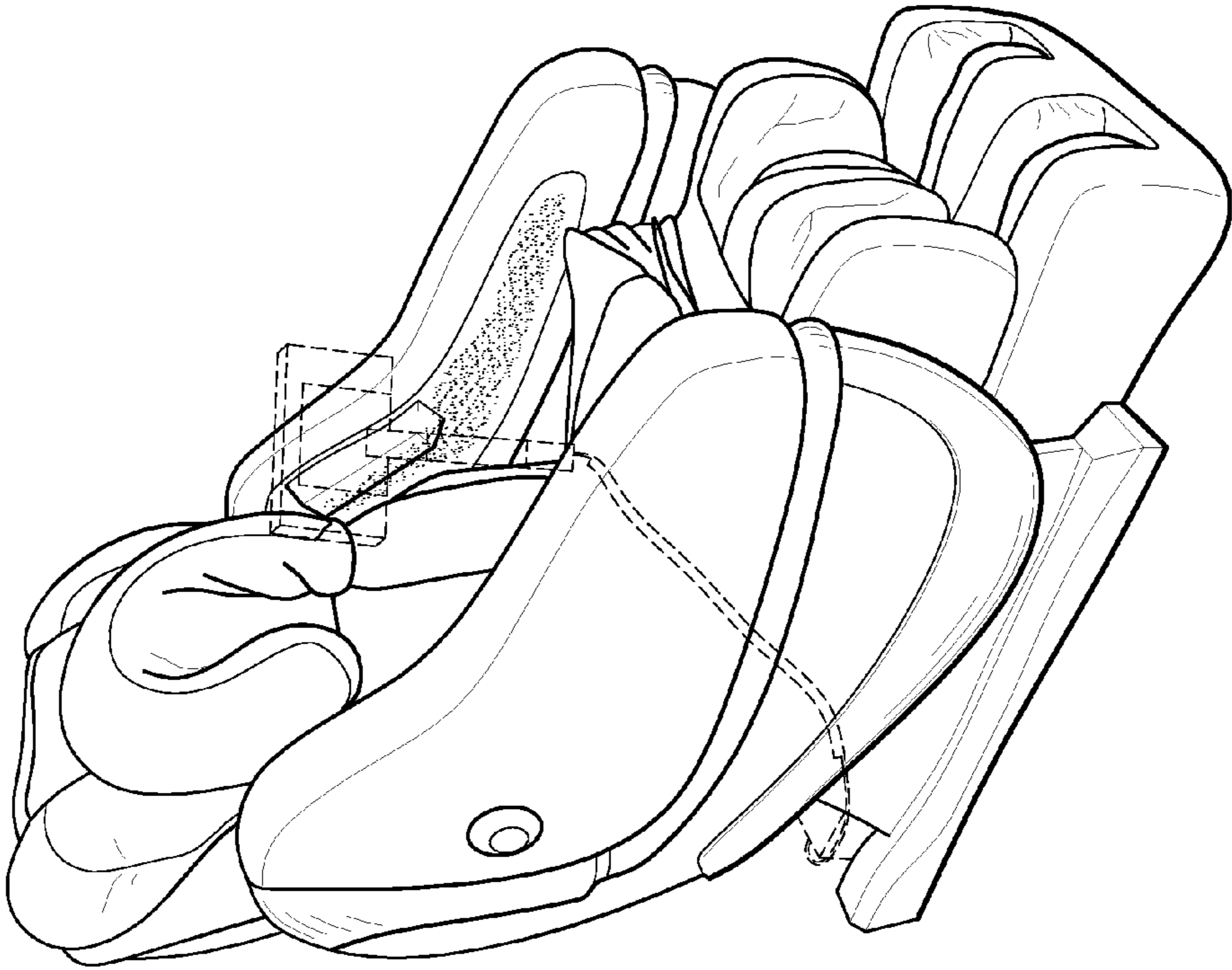

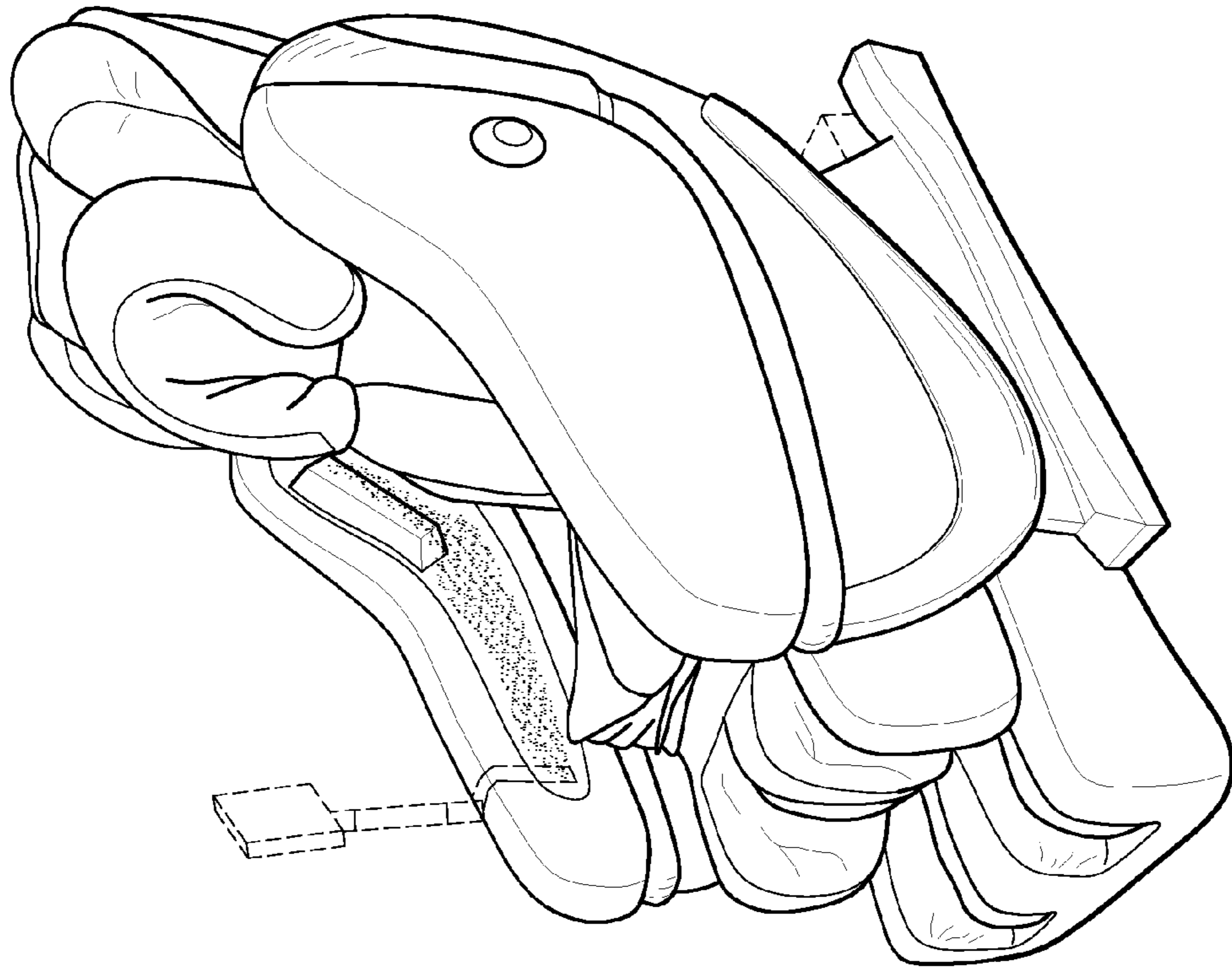
