**DESCRIPTION**

FIG. 4 is a front elevation view of FIG. 1.

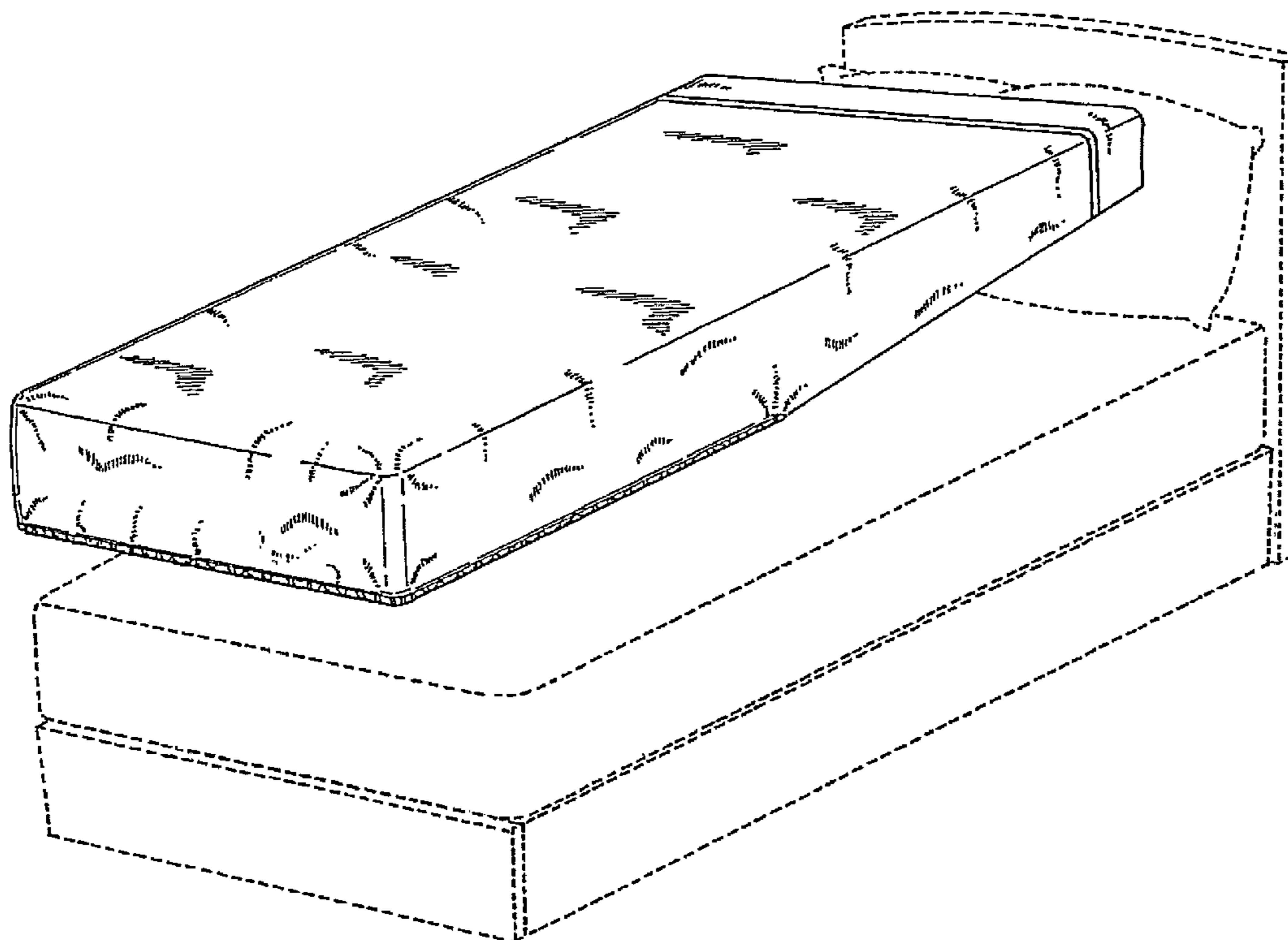
FIG. 5 is a rear elevation view of FIG. 1.

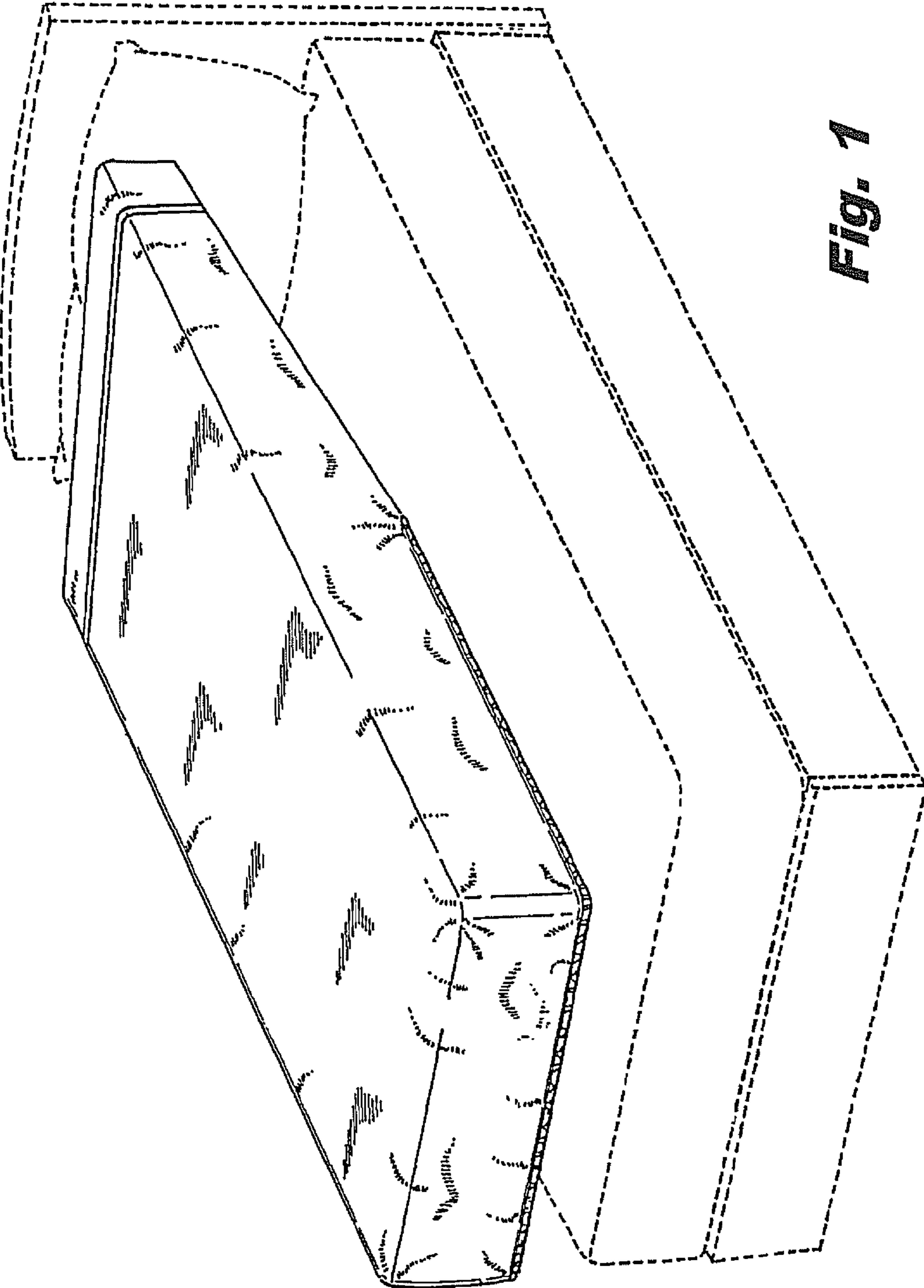
FIG. 6 is a left side elevation view of FIG. 1; and,

FIG. 7 is a right side elevation view of FIG. 1.

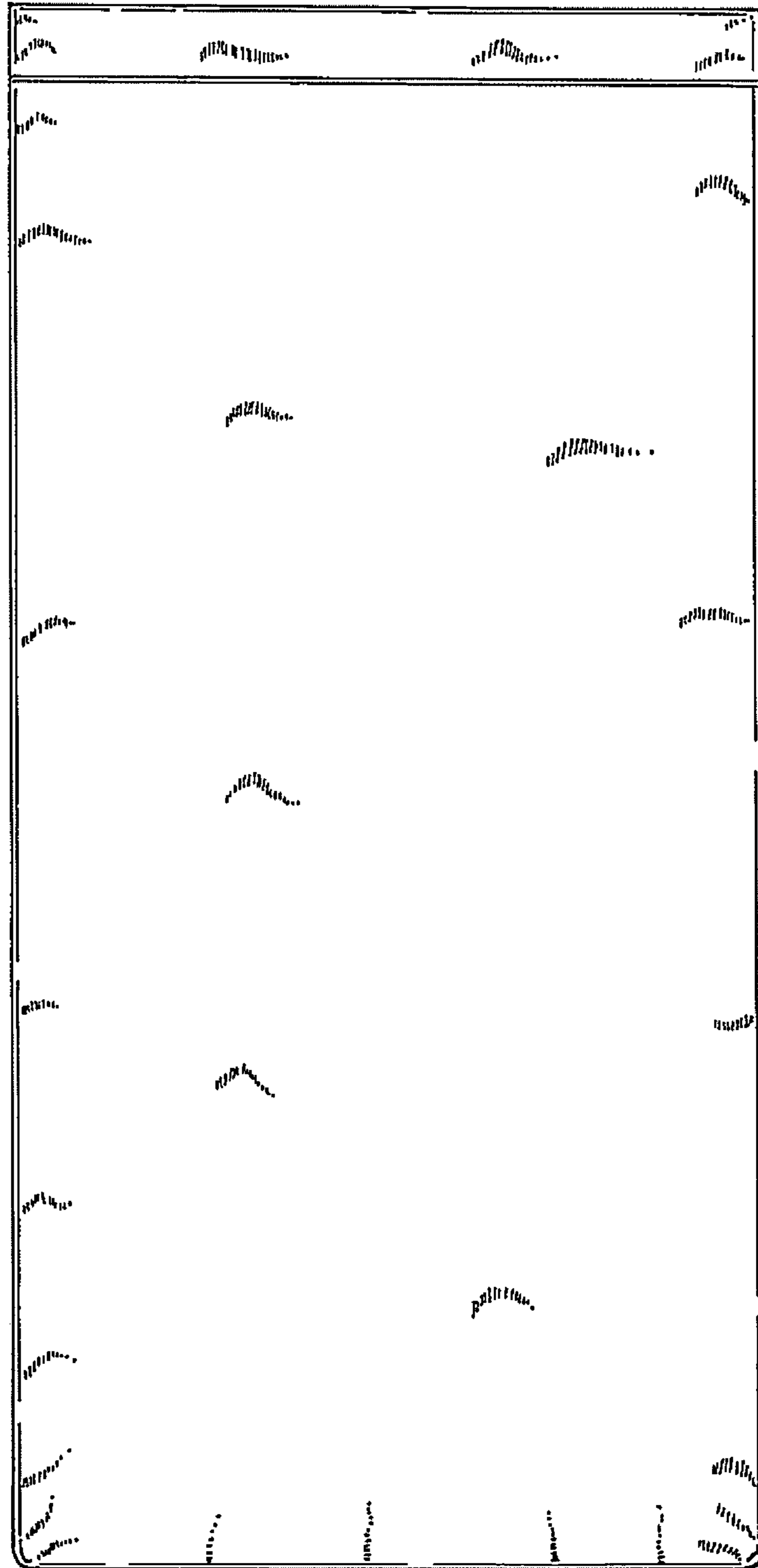
No claim is made to the dashed line regions on the drawings, including the bed and mattress arrangement which are shown only for display purposes and form no part of the claimed design.

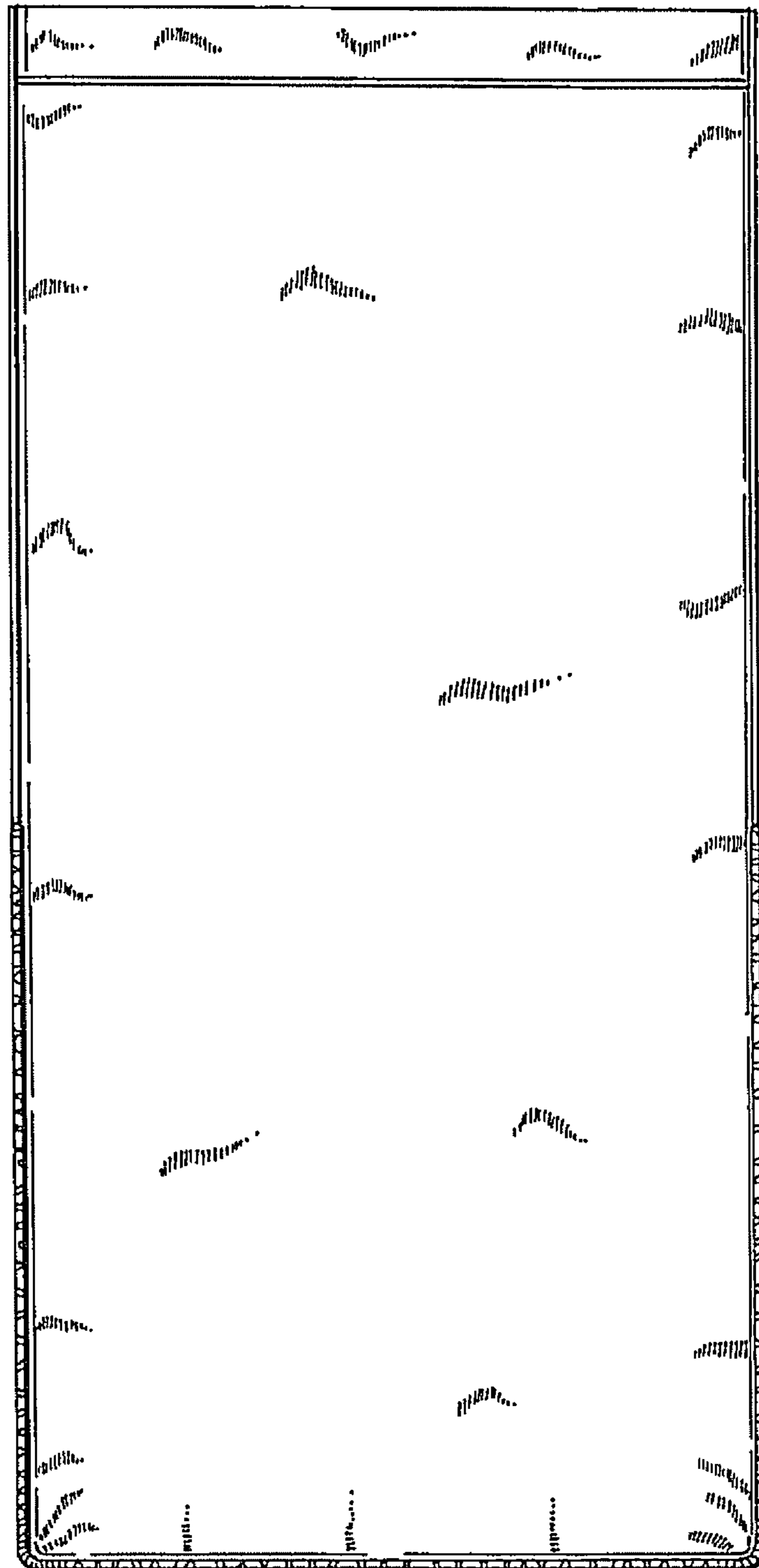




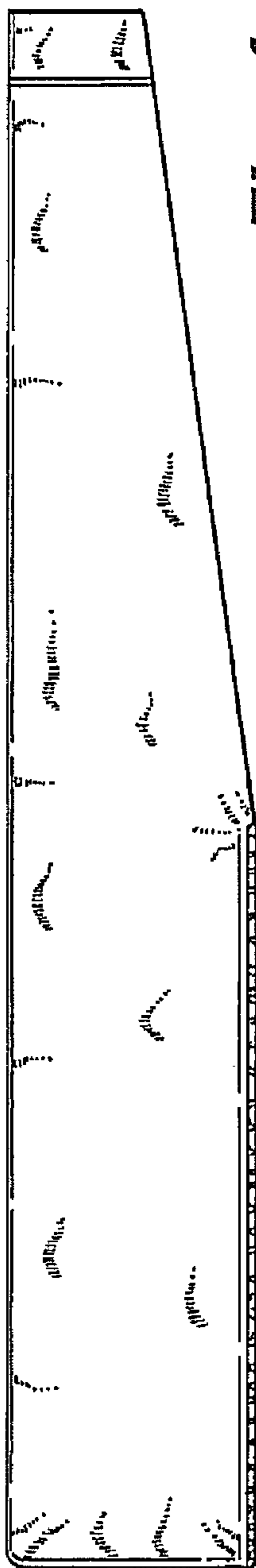

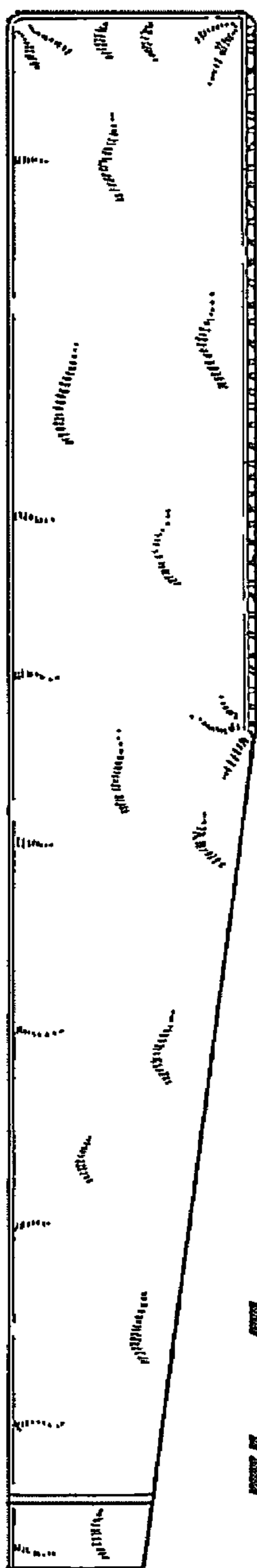

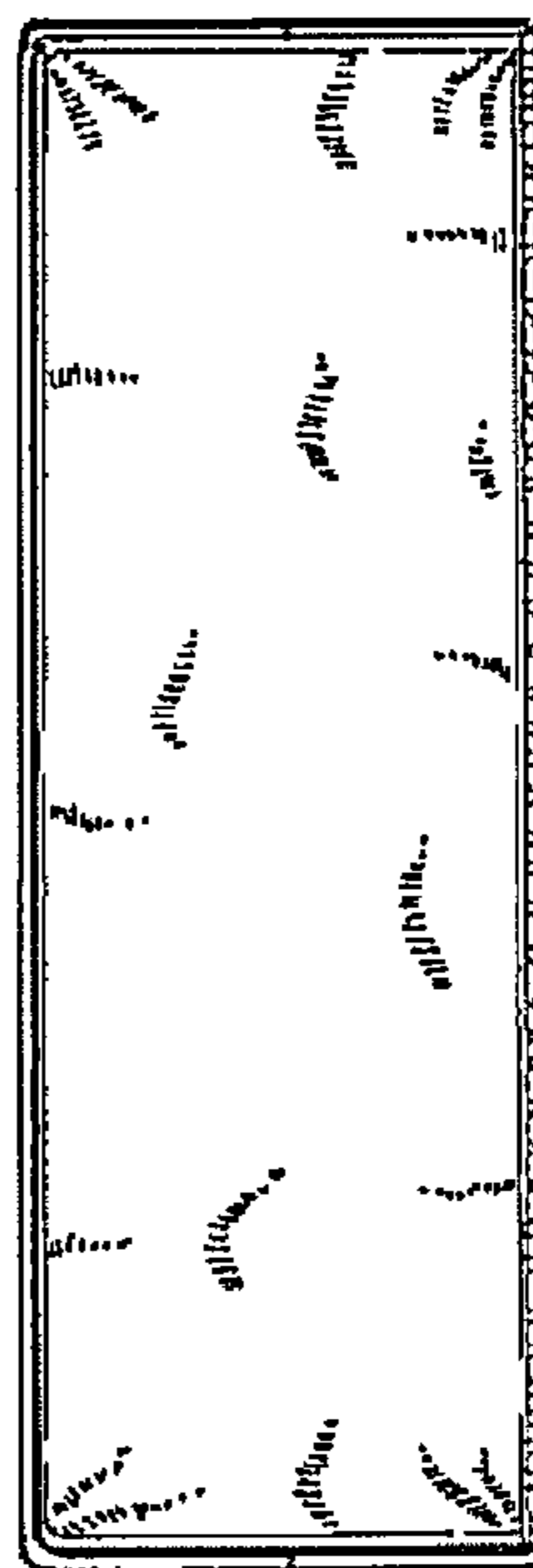

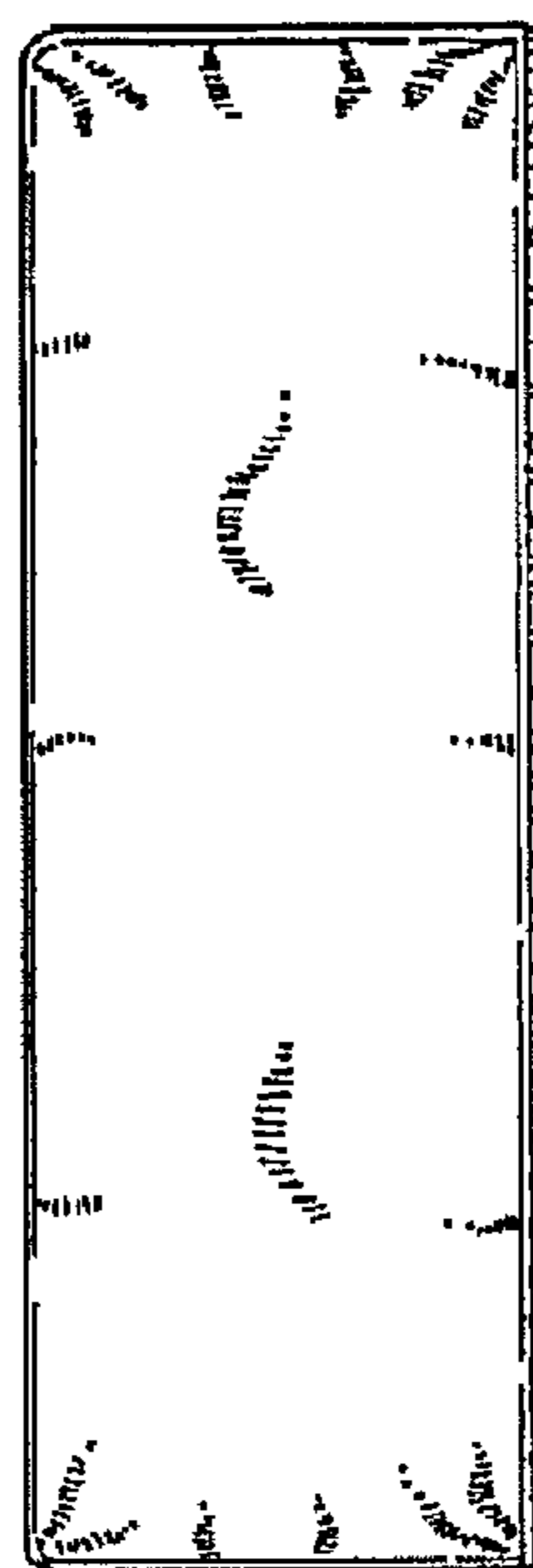
