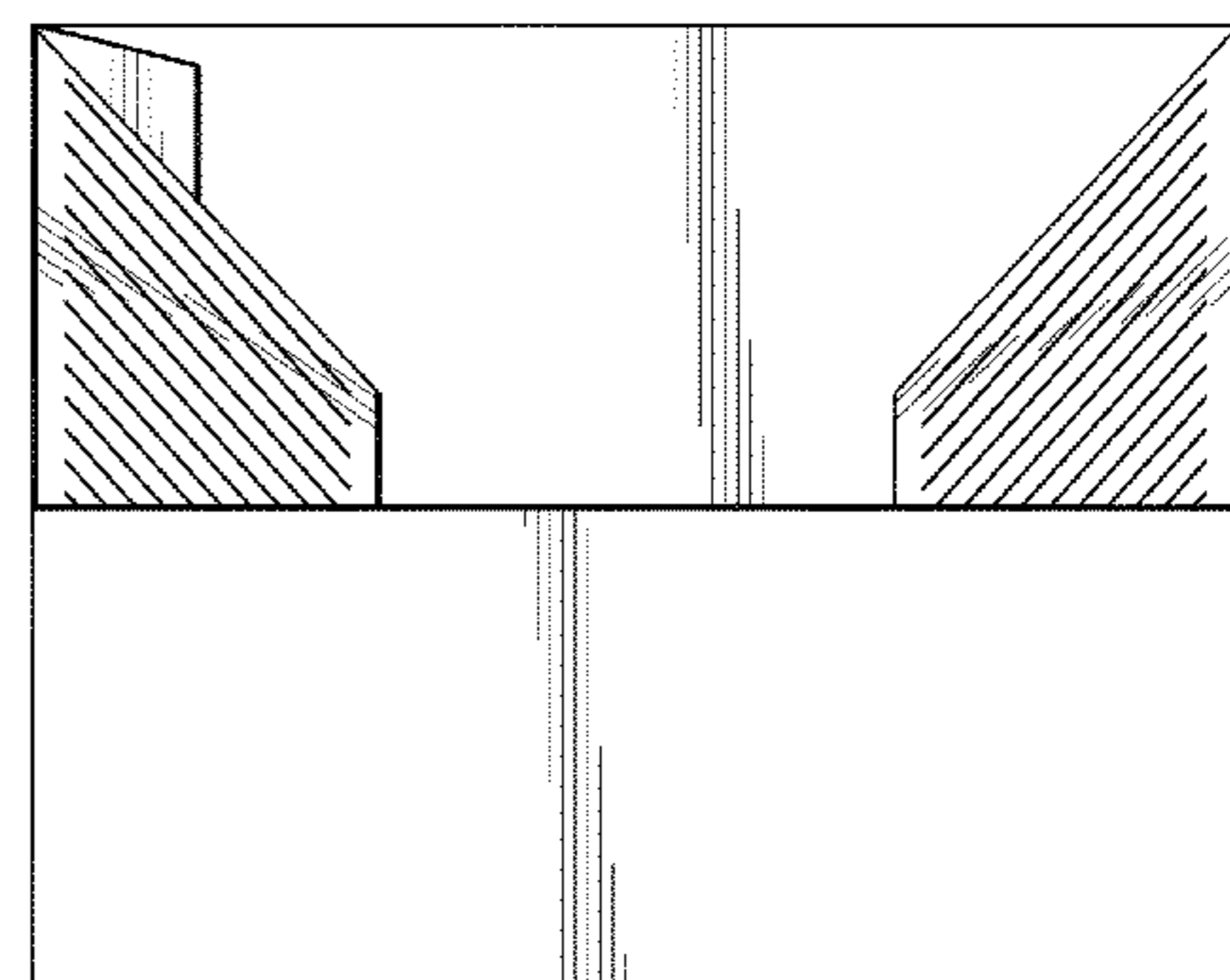
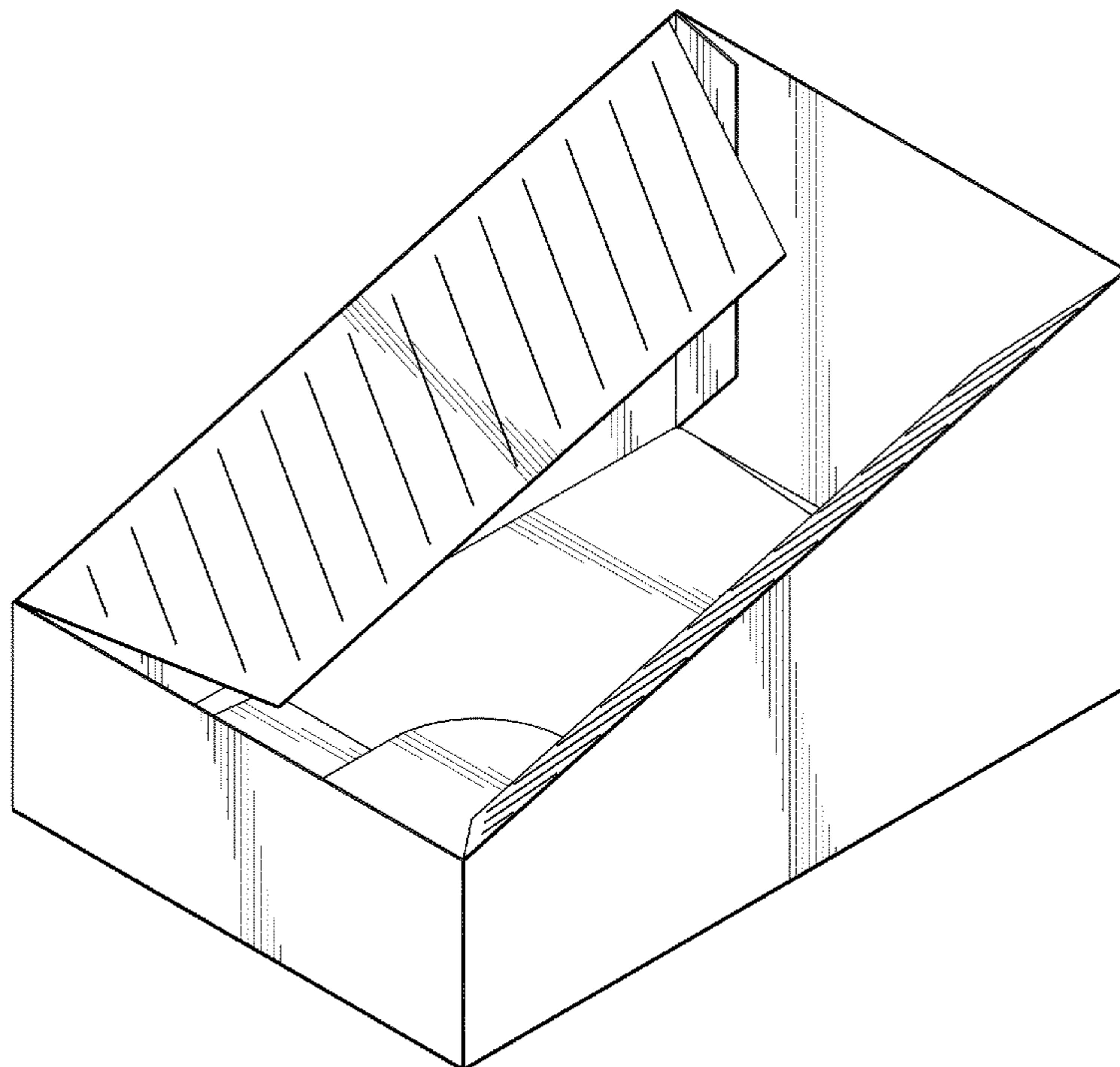
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the display carton for packaged product of the present invention.

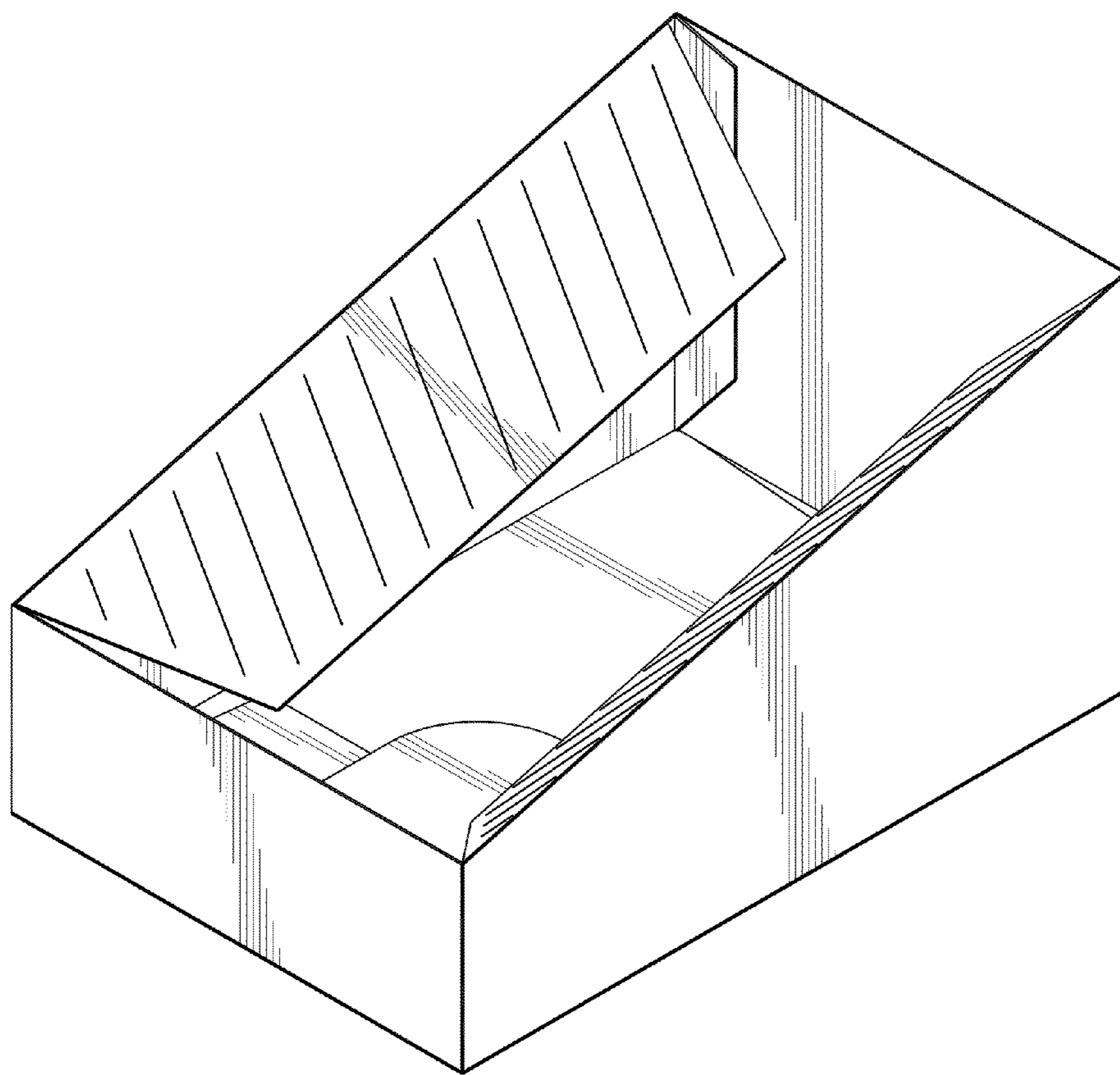

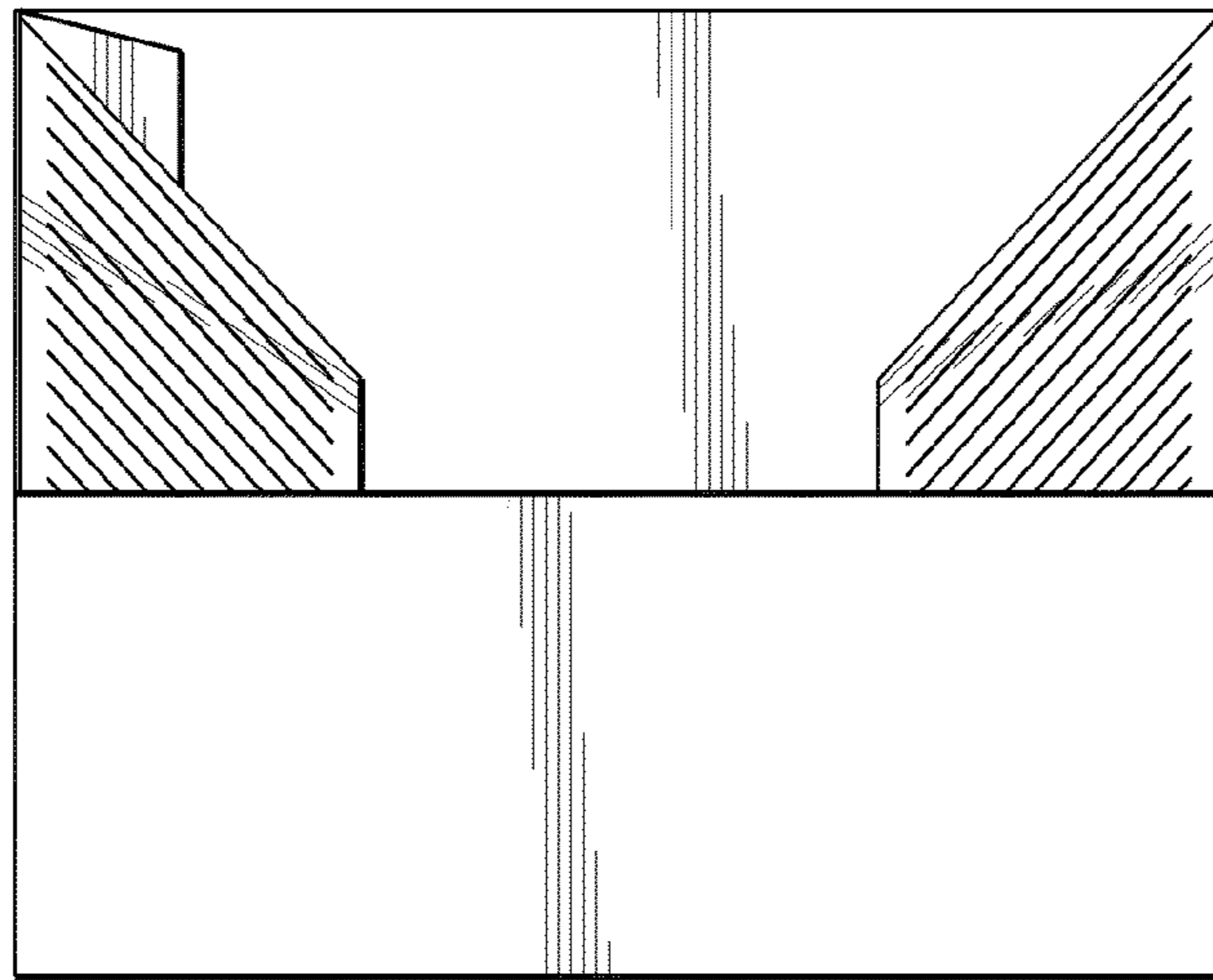

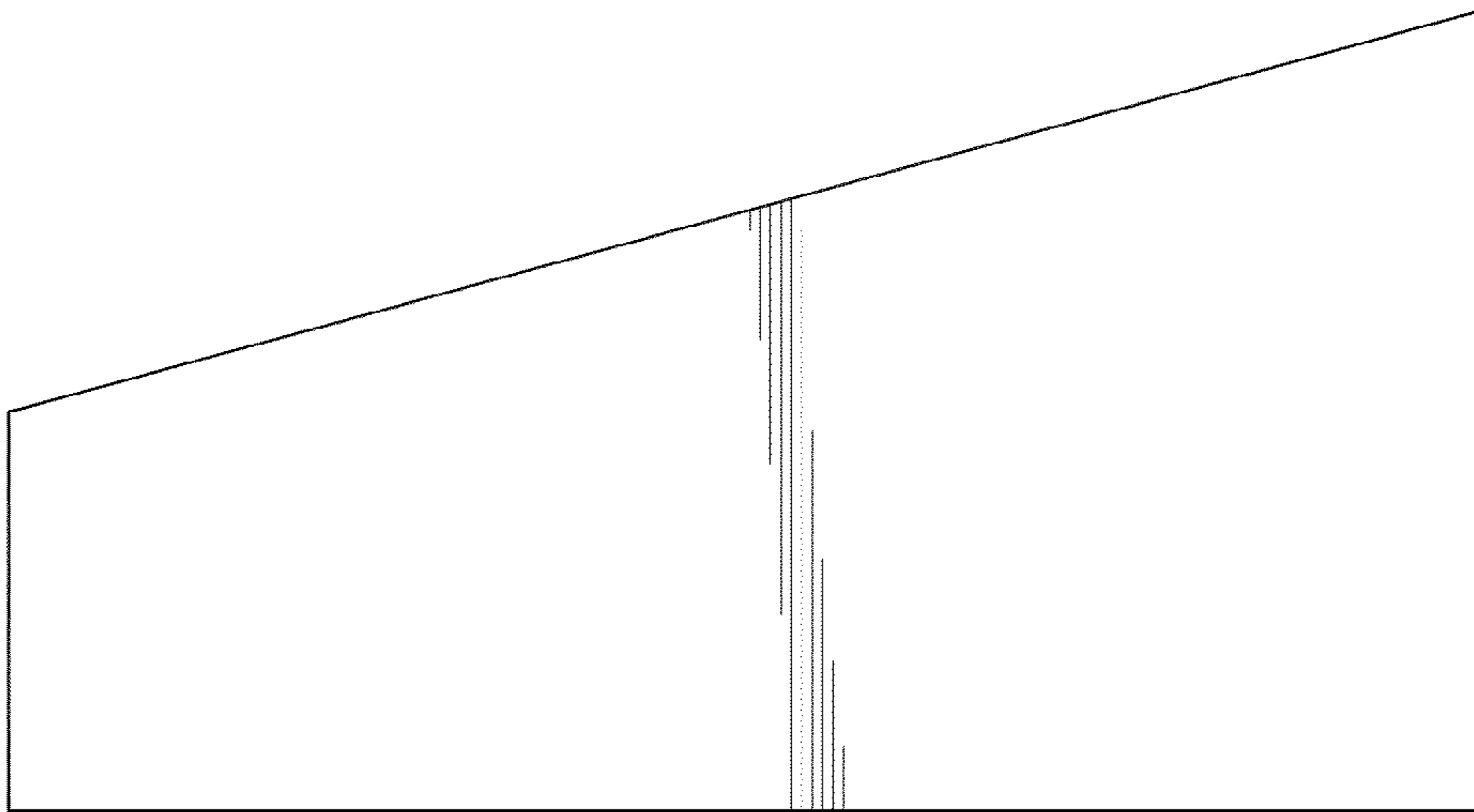

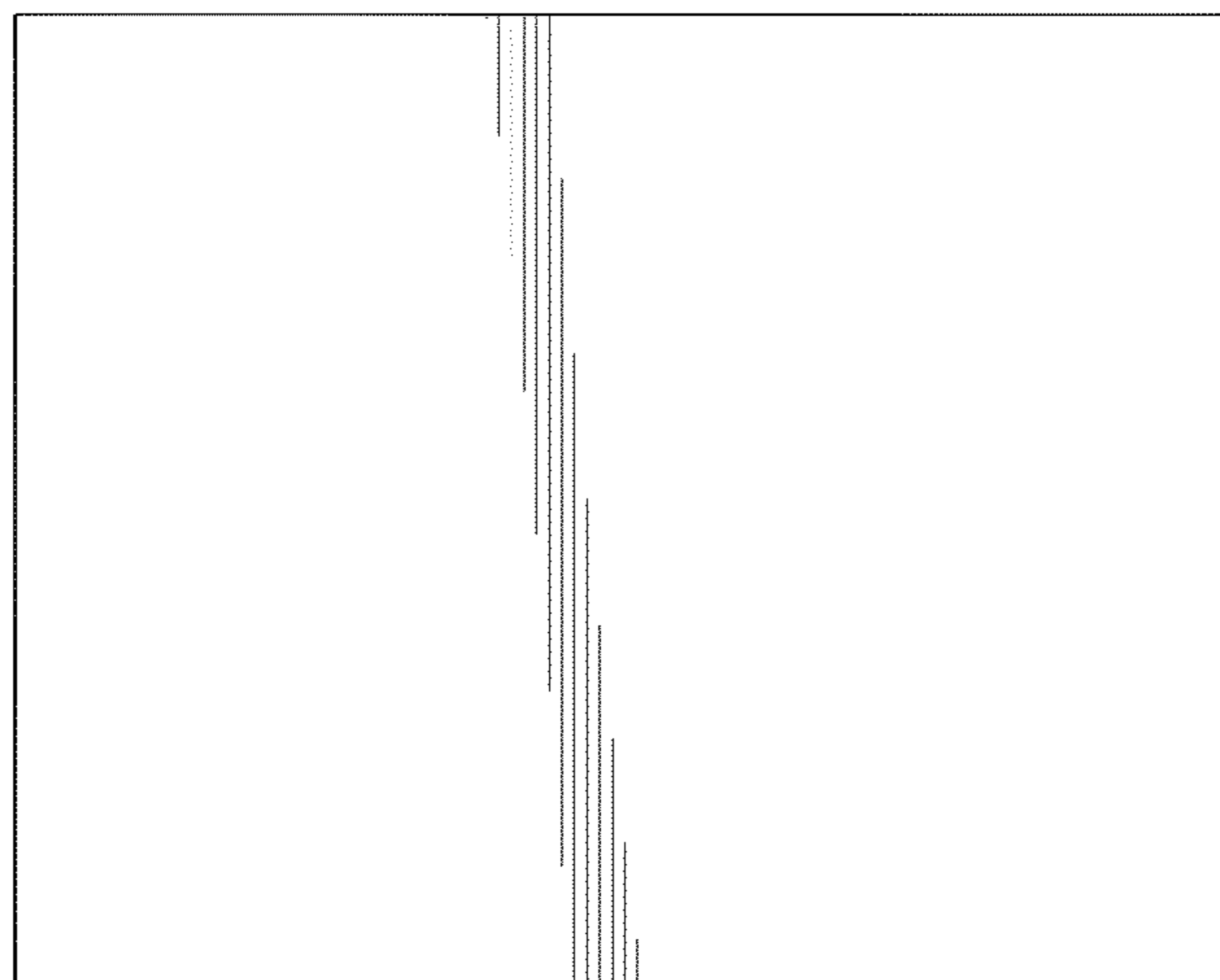

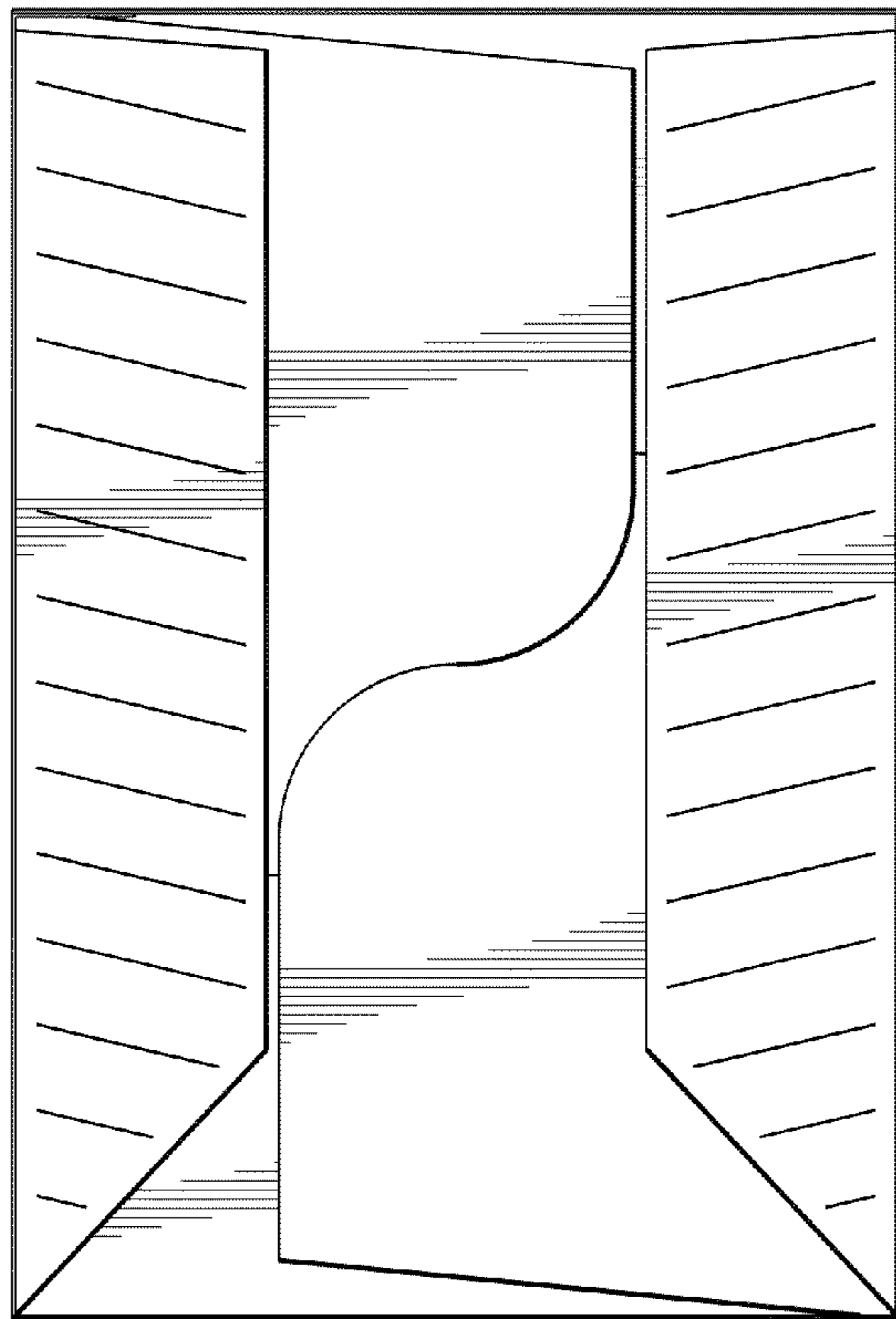

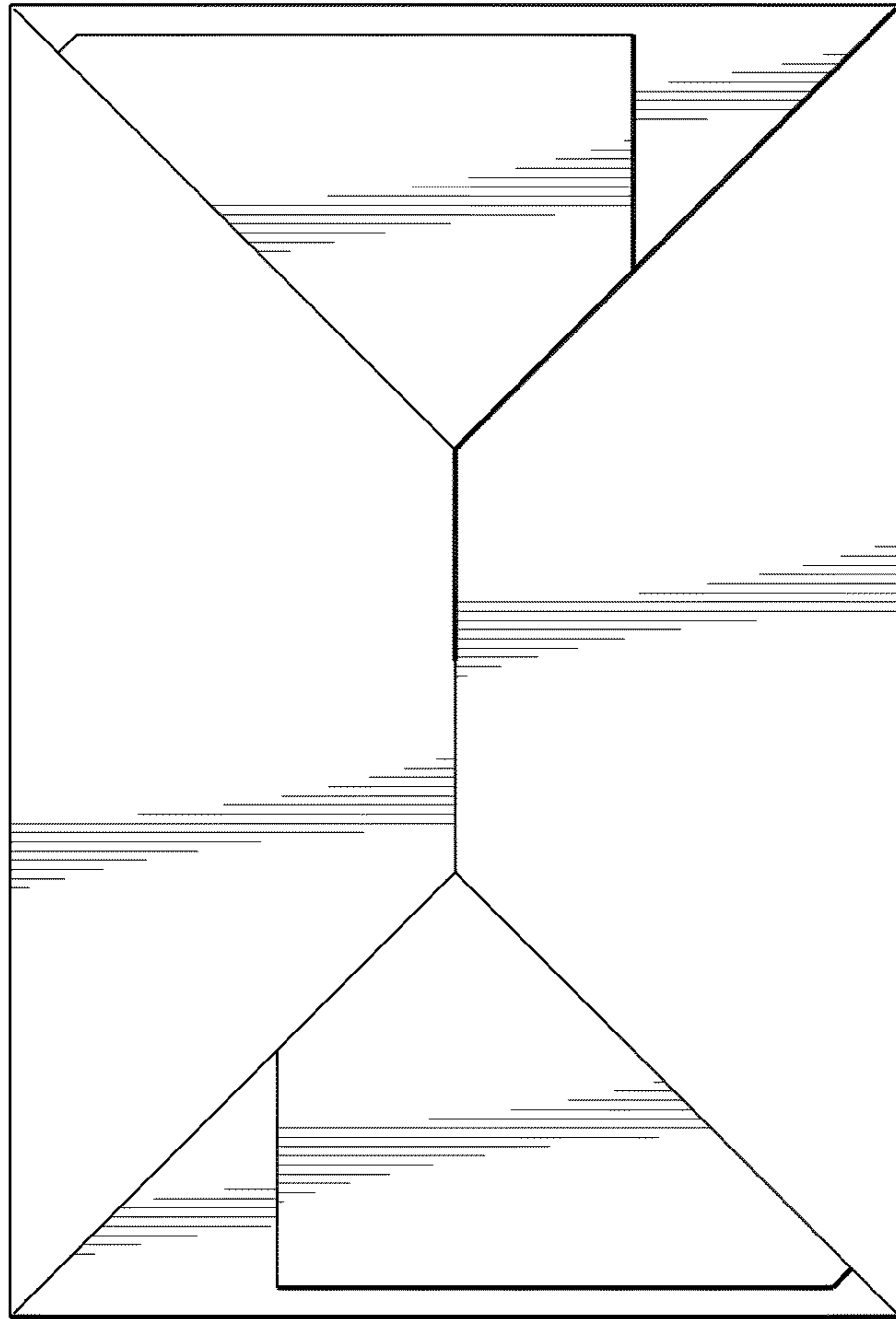

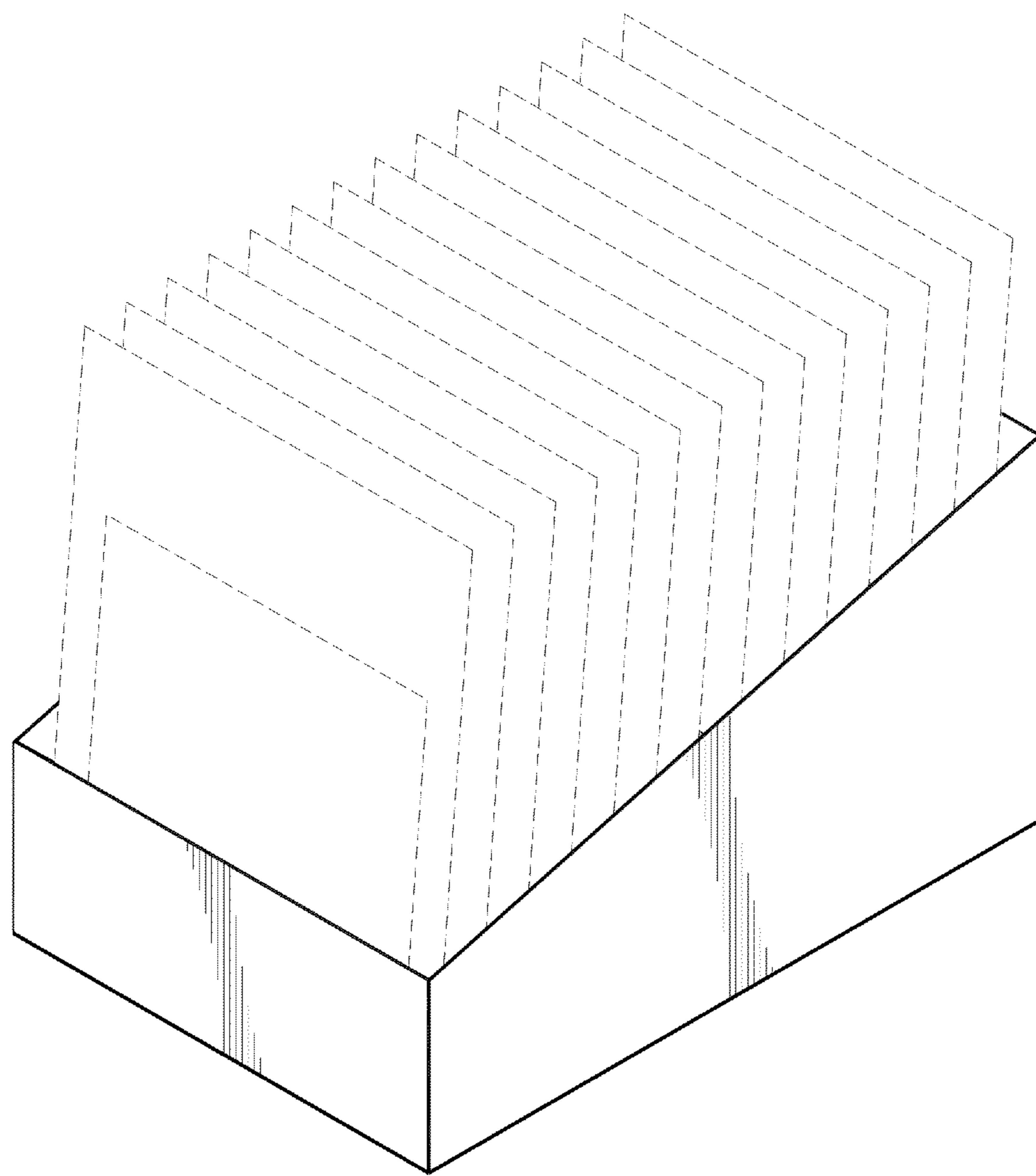
