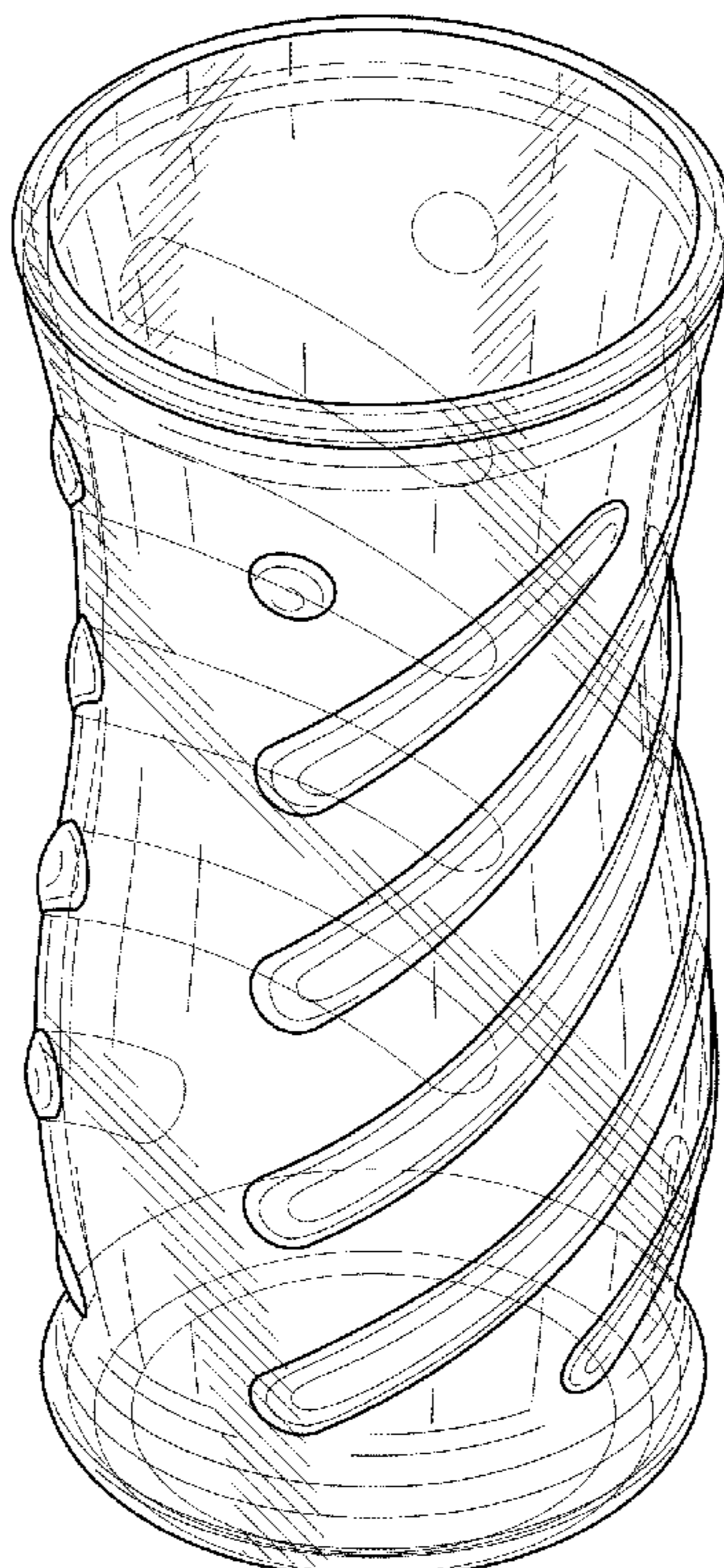
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a ribbed vase.
FIG. 2 is a front view of the ribbed vase of FIG. 1, the rear view being identical thereto.
FIG. 3 is a right side view of the ribbed vase of FIG. 1, the left side view being identical thereto.
FIG. 4 is a top view of the ribbed vase of FIG. 1; and,

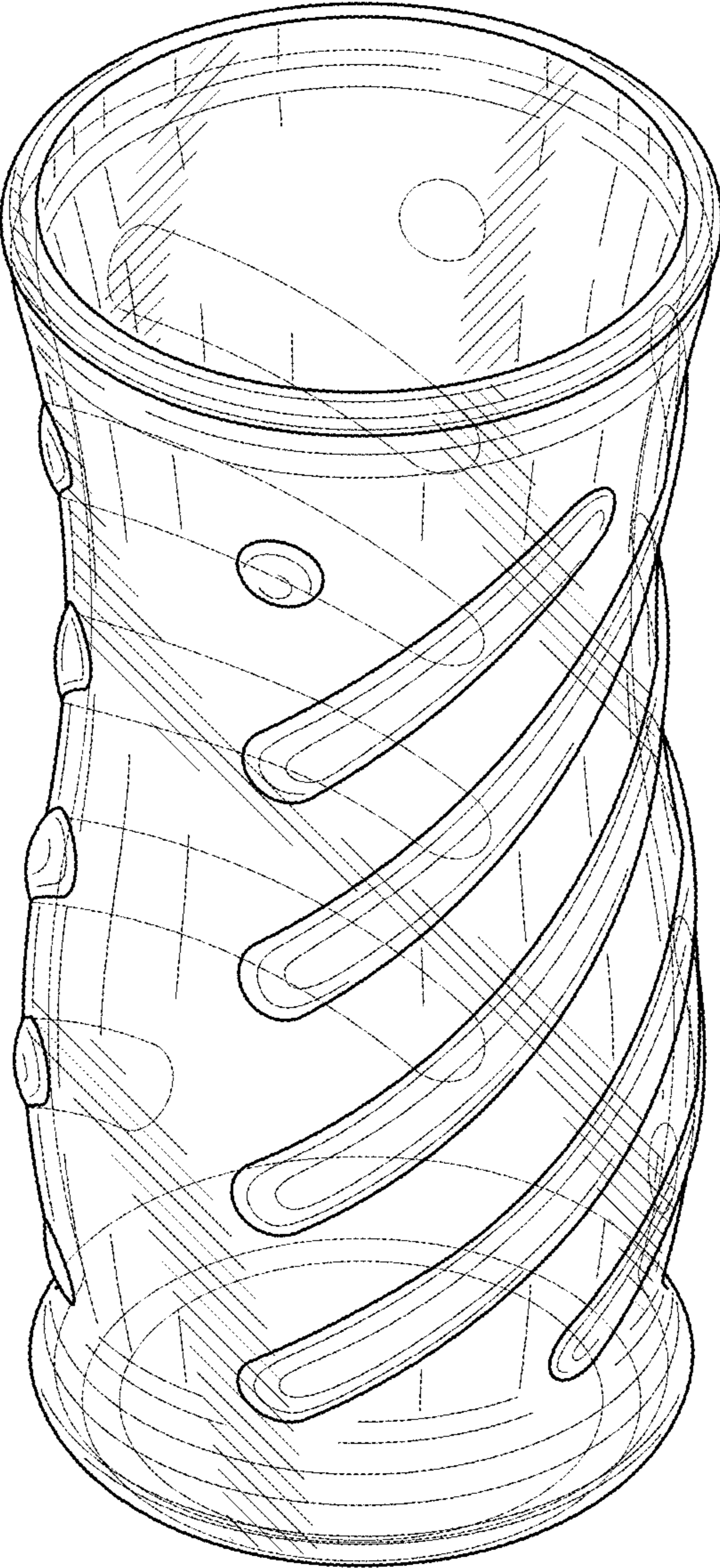

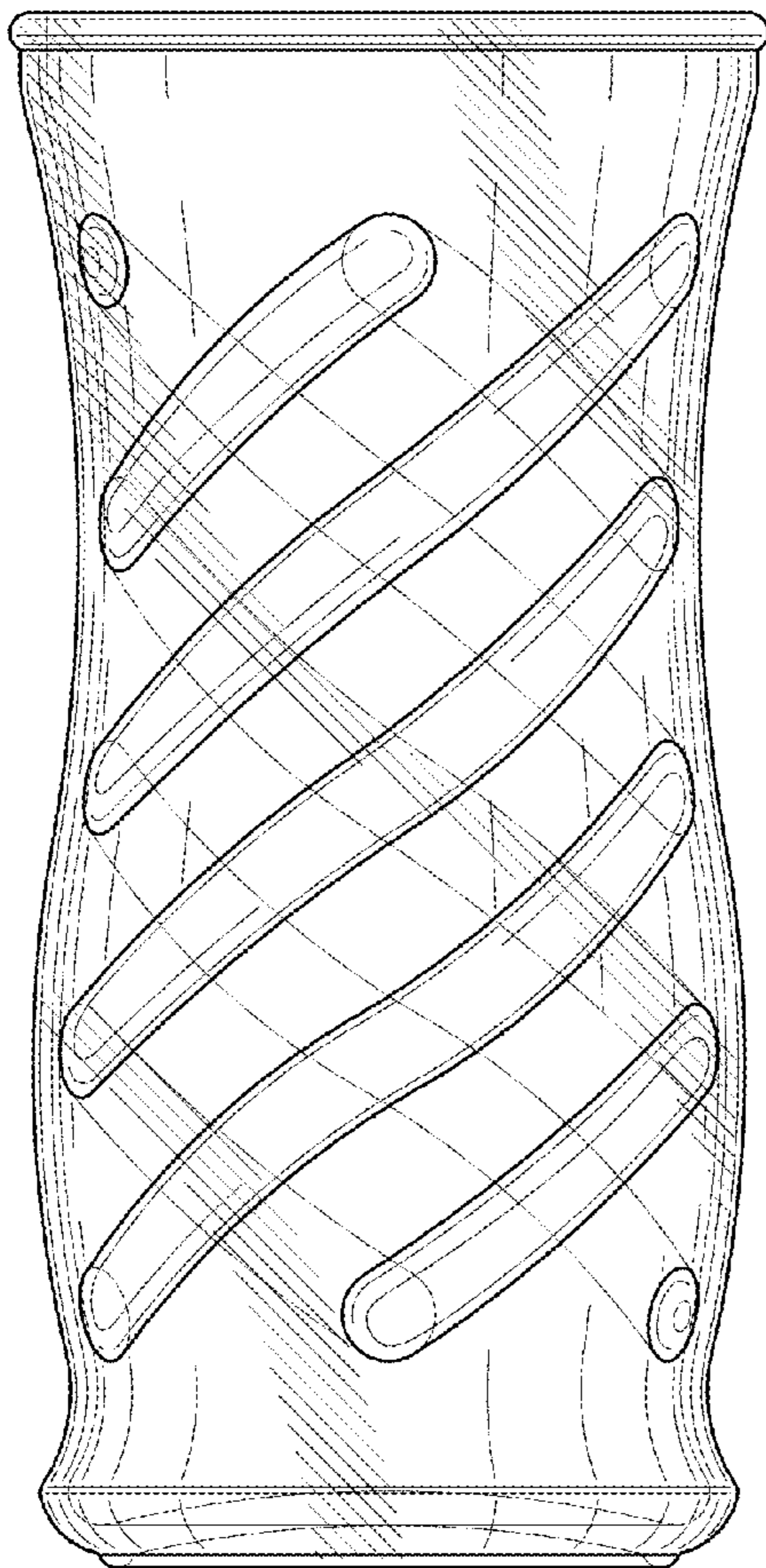

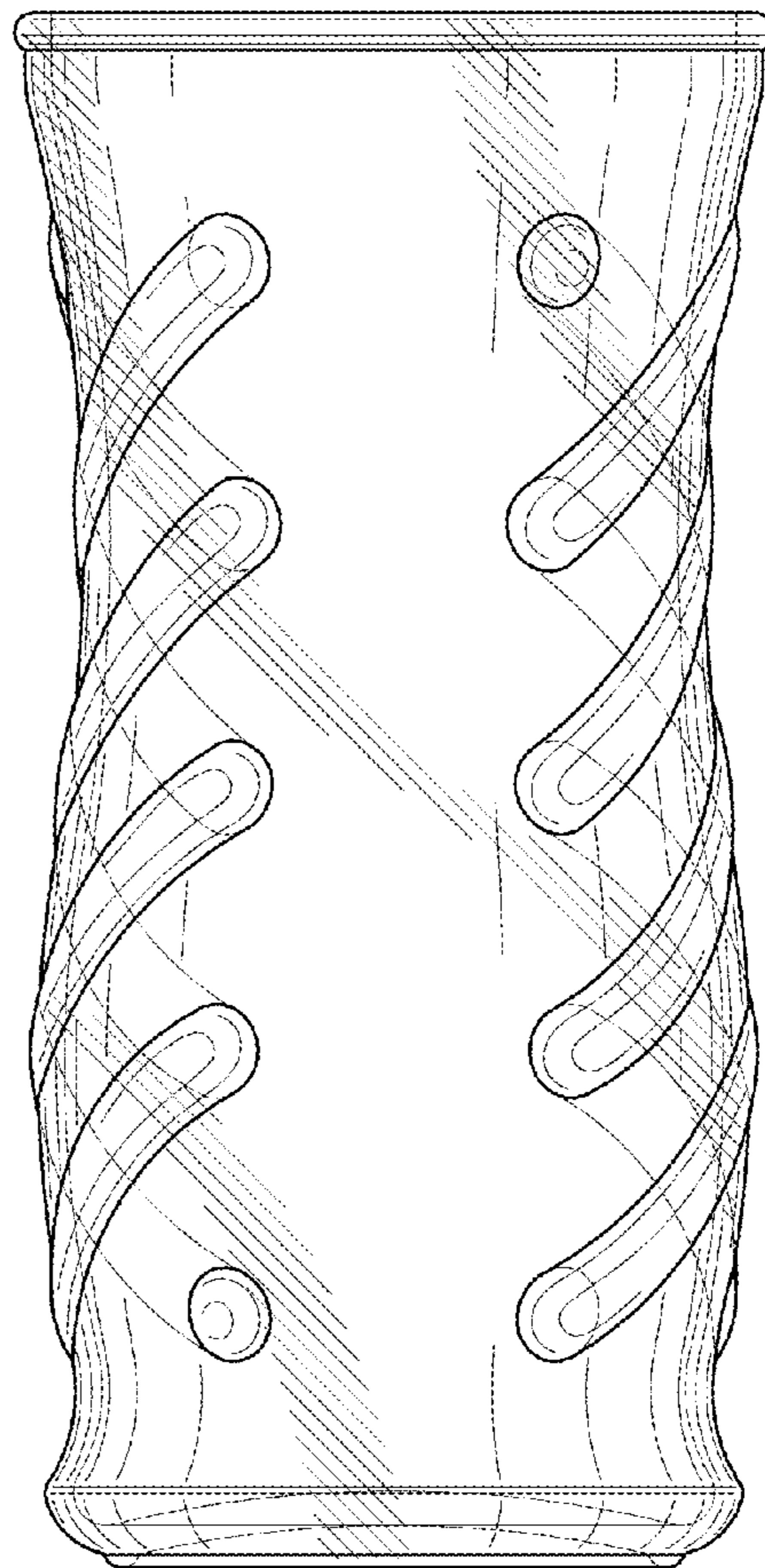

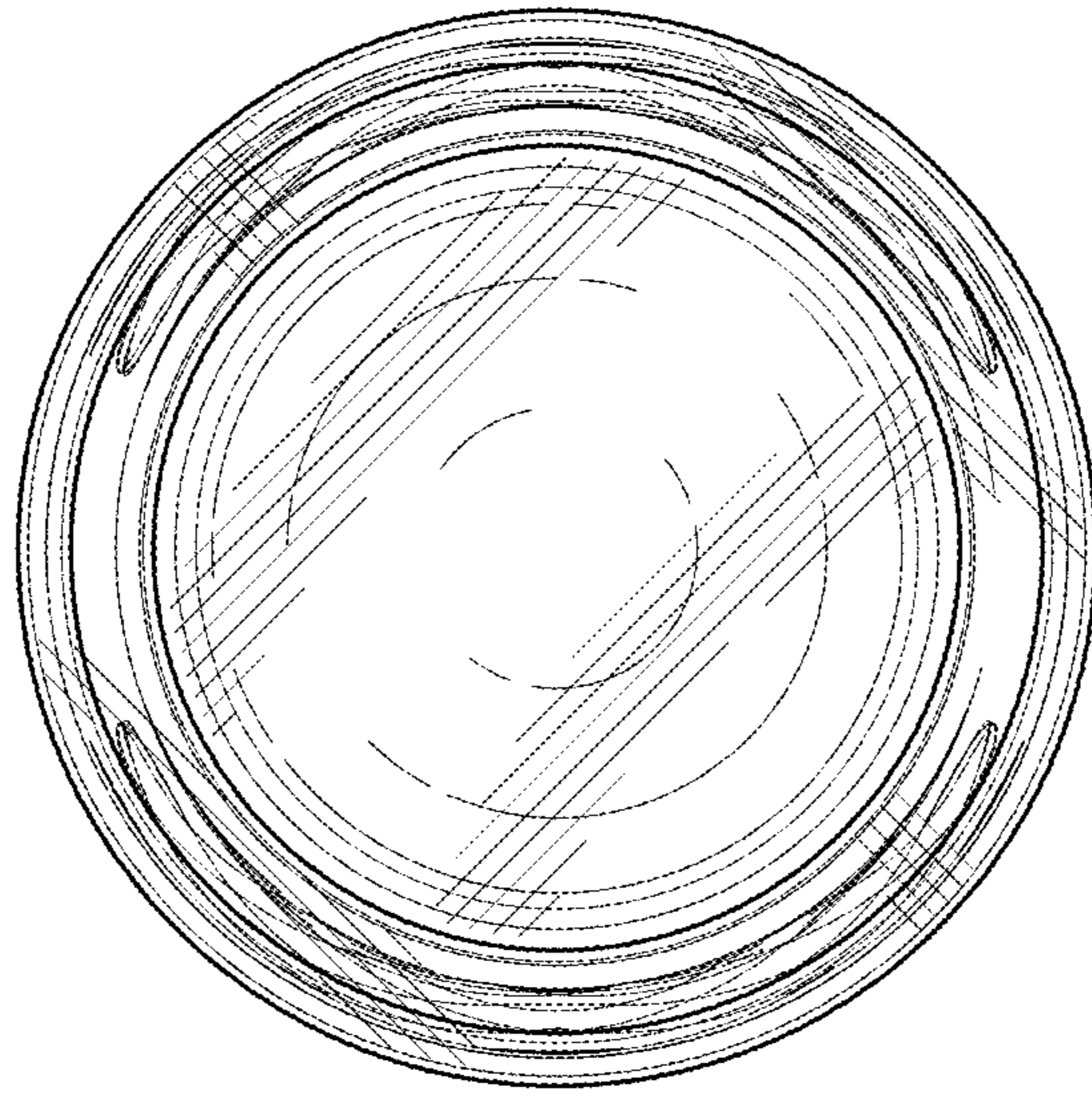

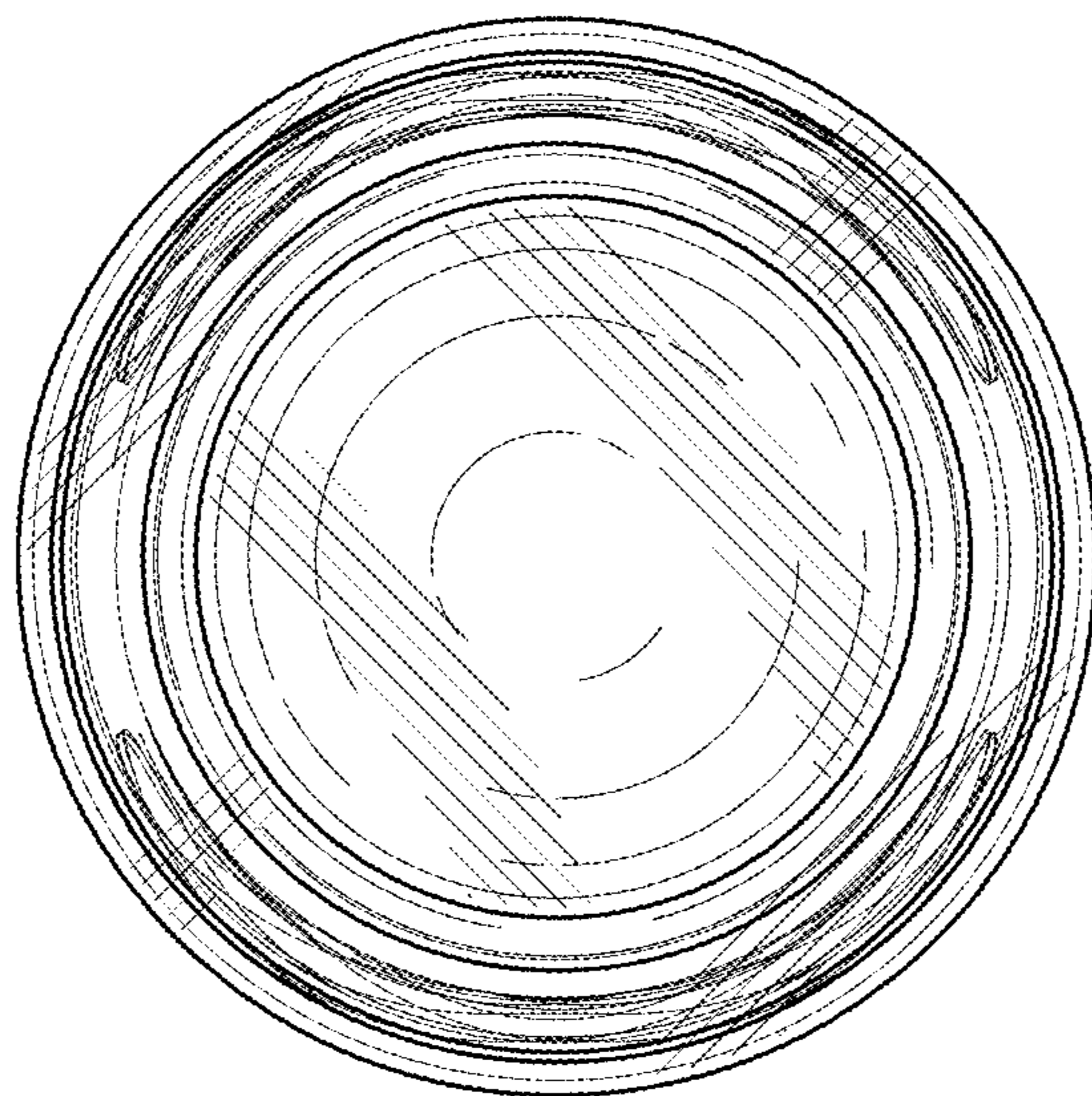
