The ornamental design for a hook for automobile, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a hook for automobile showing my new design;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a left side view thereof; a right side view being symmetrical to the left side view;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a perspective view thereof;  
FIG. 7 is a cross-sectional view thereof taken along the line 7-7 in FIG. 1;  
FIG. 8 is a cross-sectional view thereof taken along the line 8-8 in FIG. 1; and,

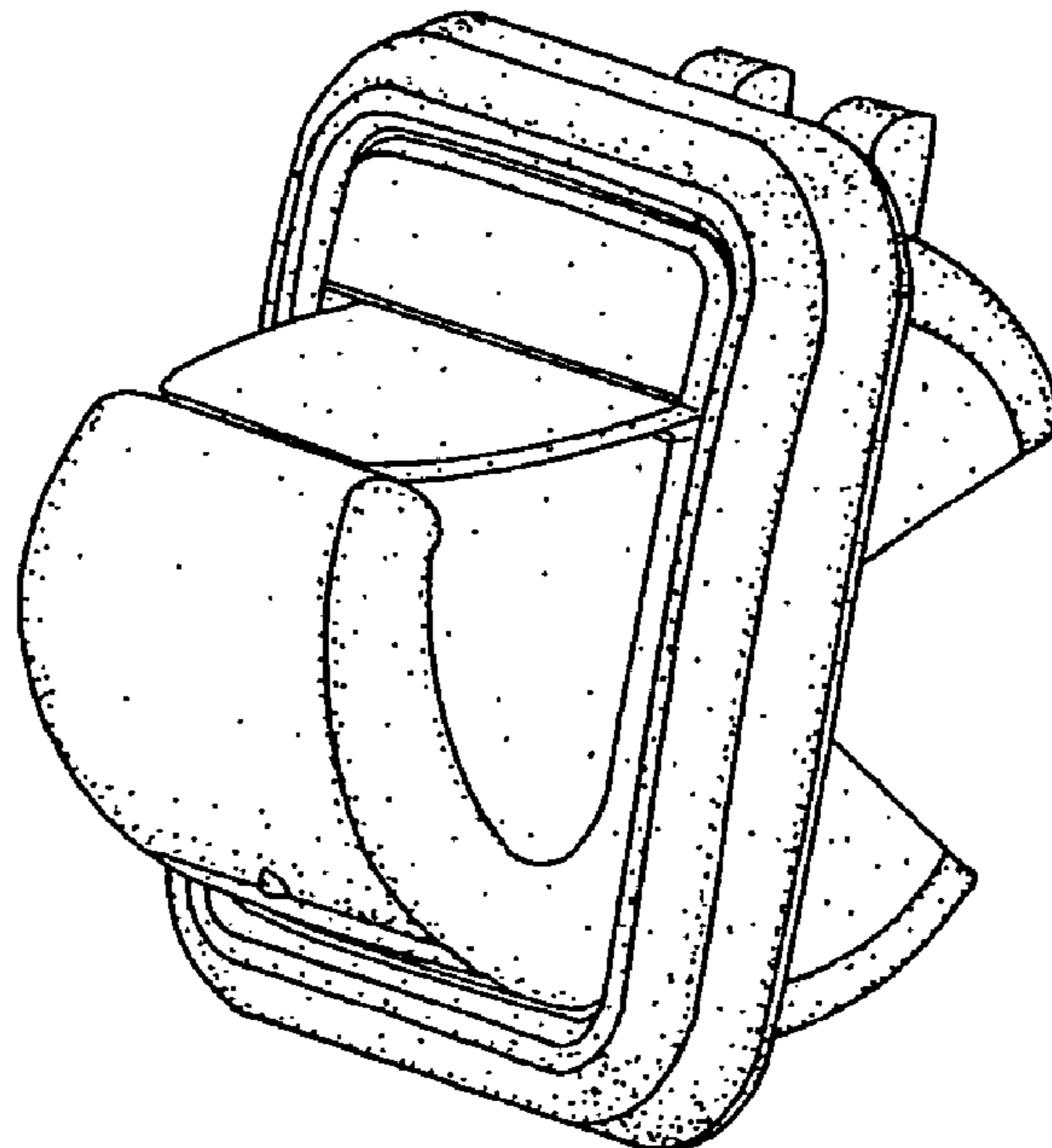

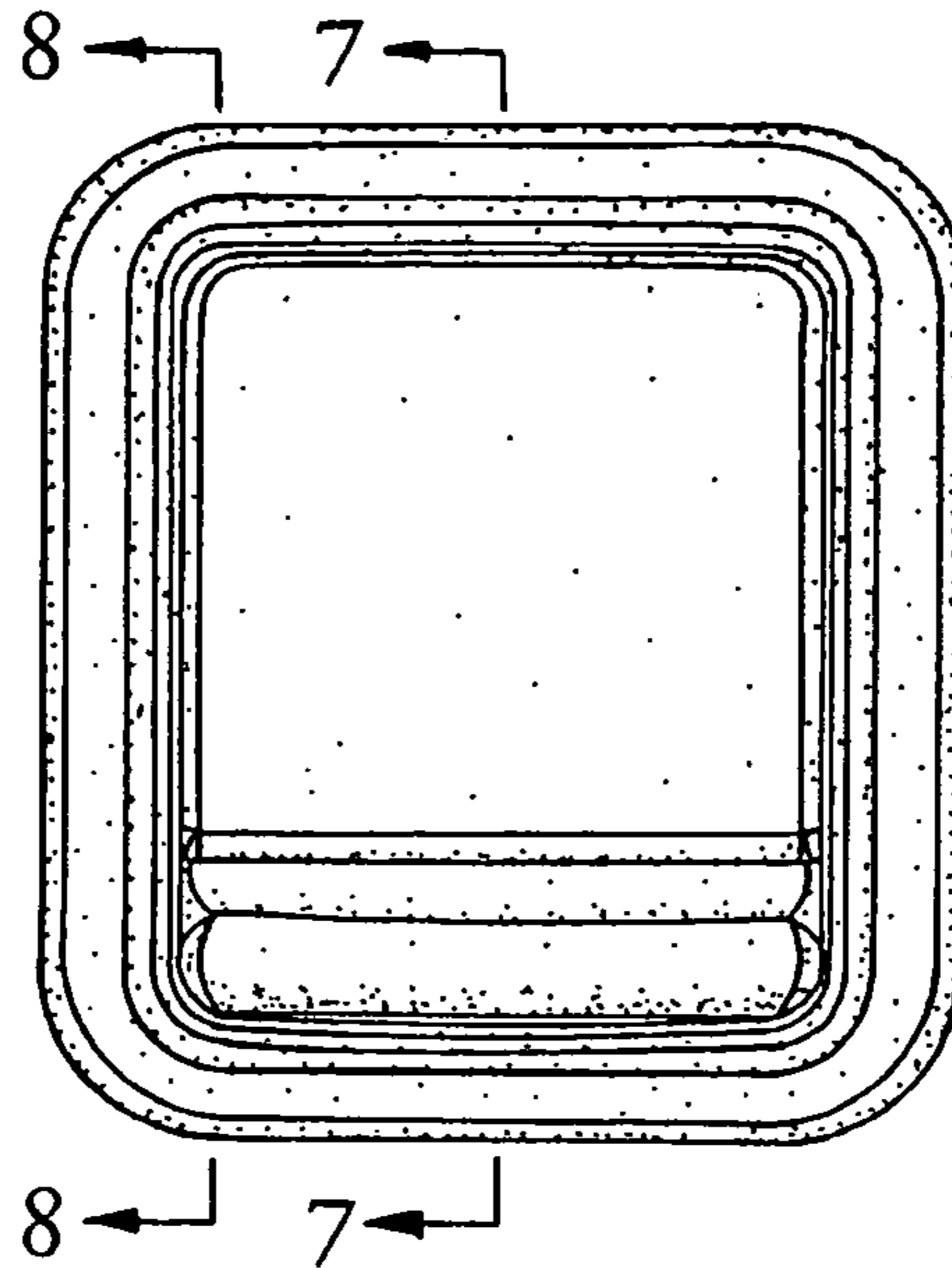

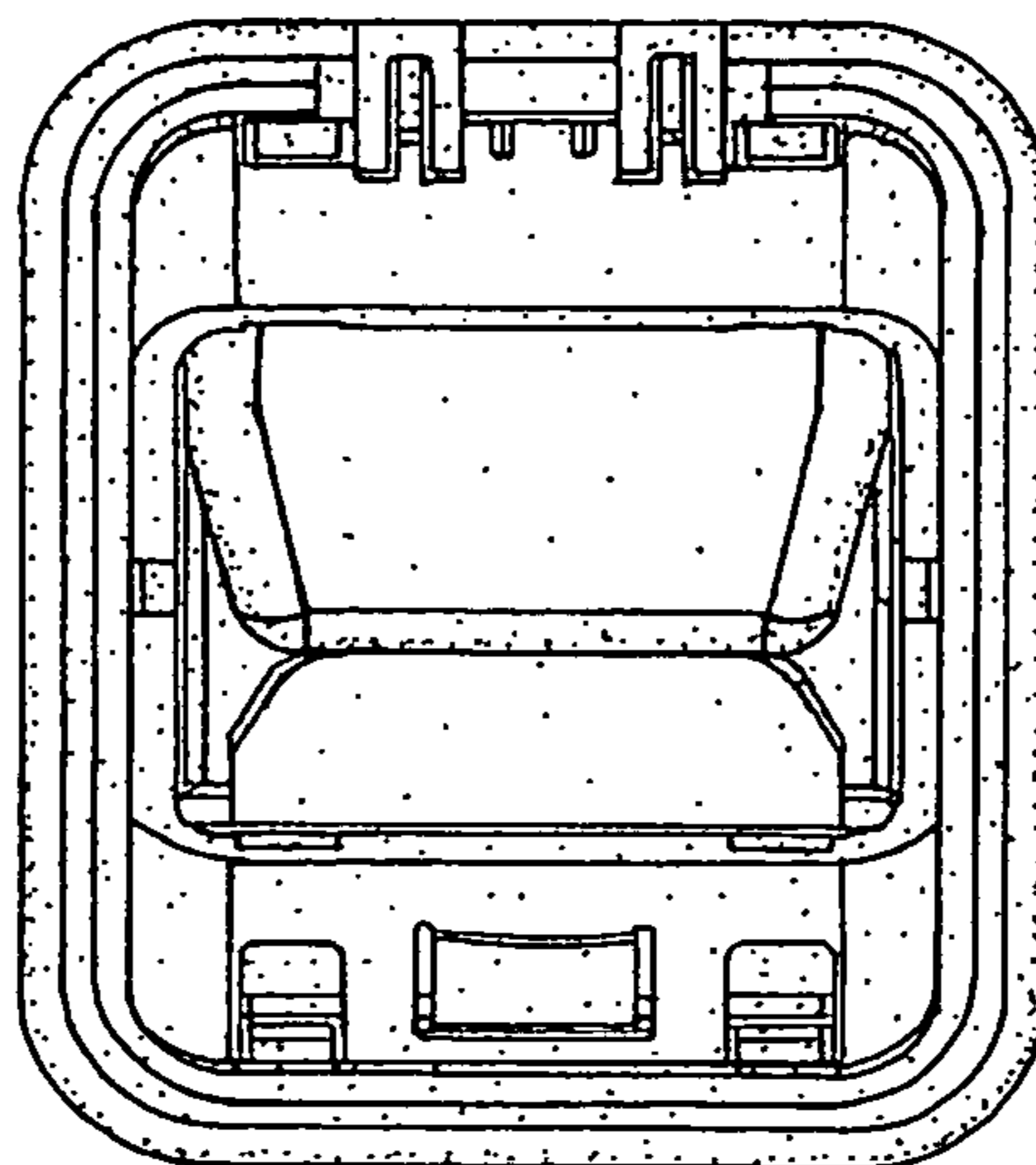

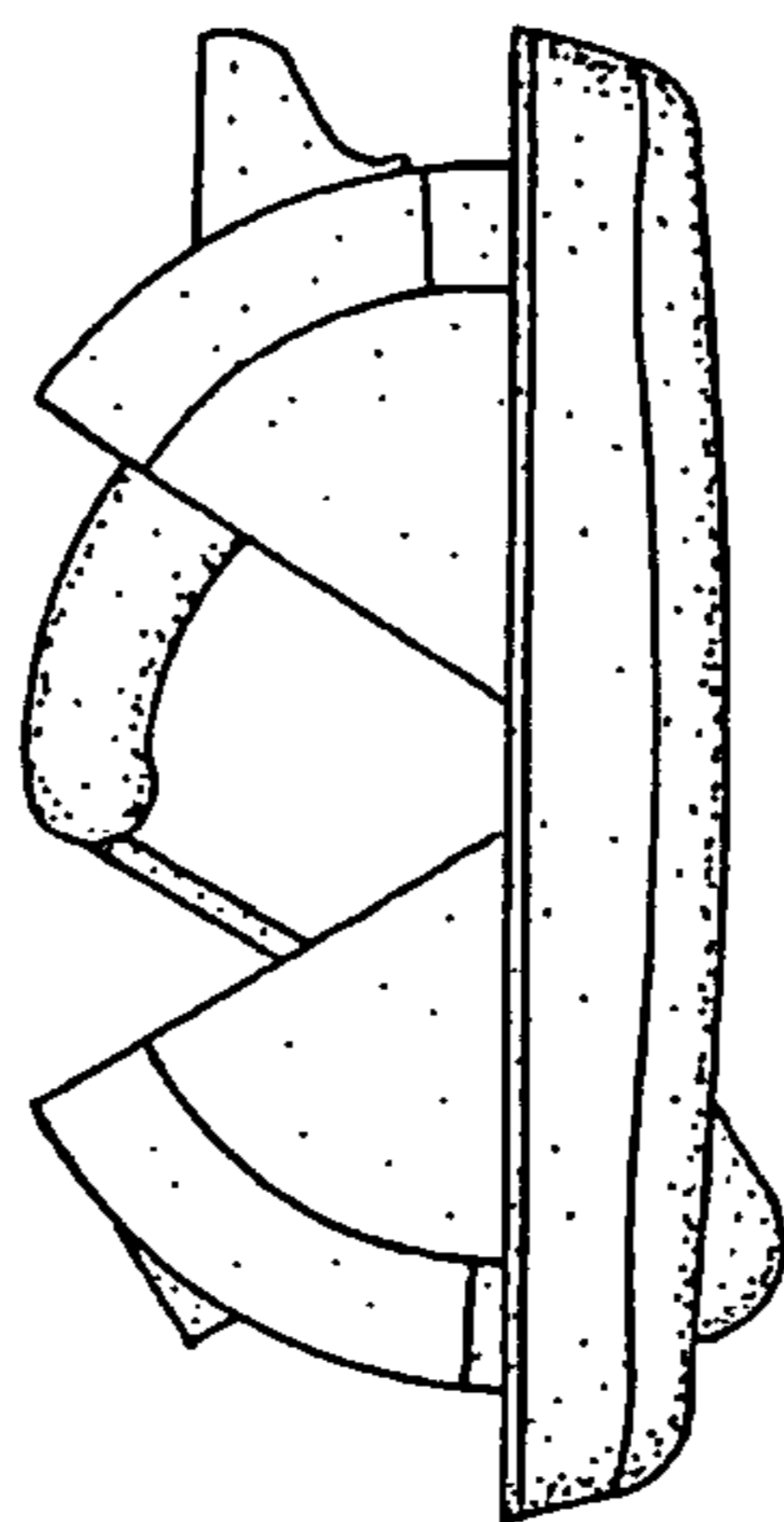

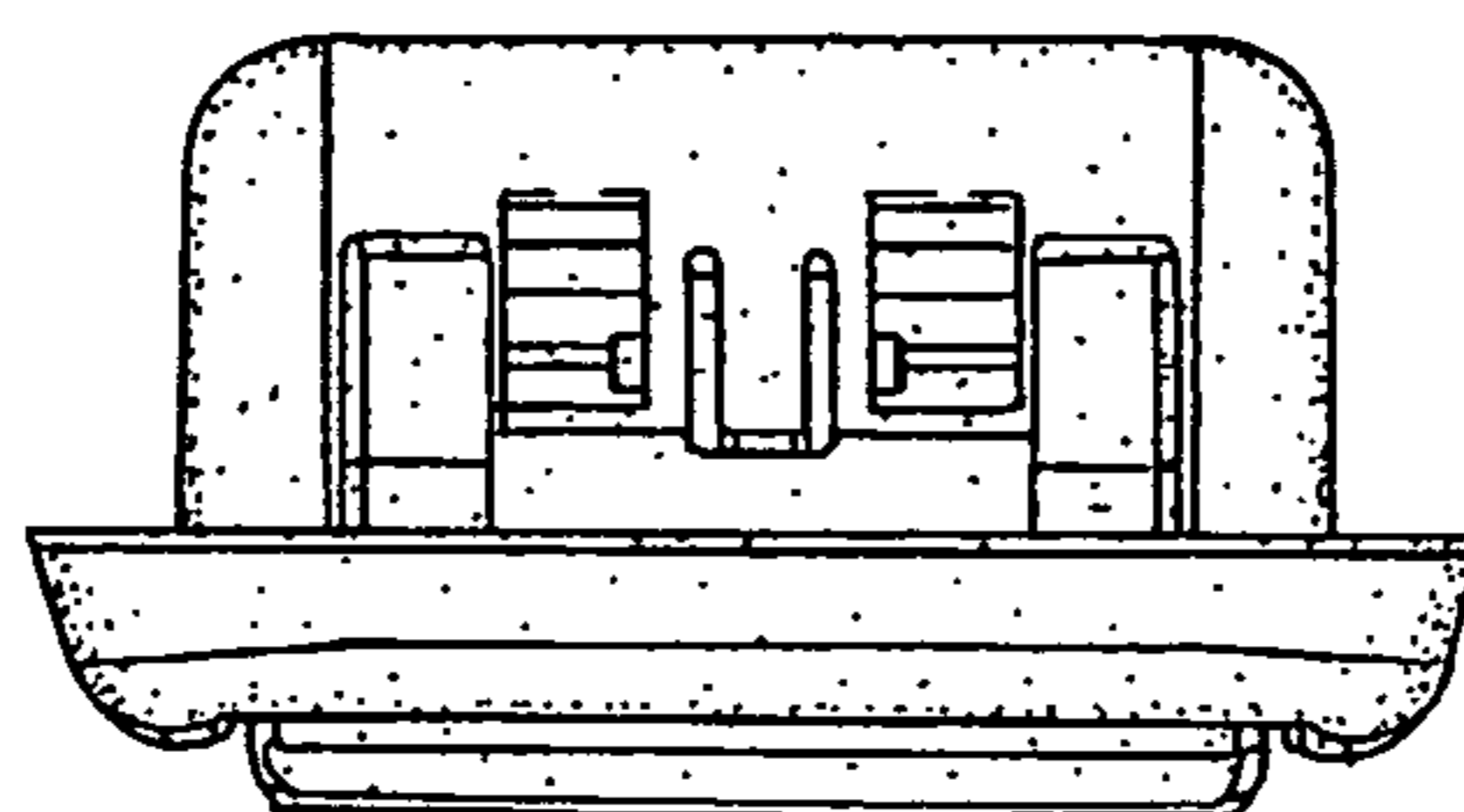

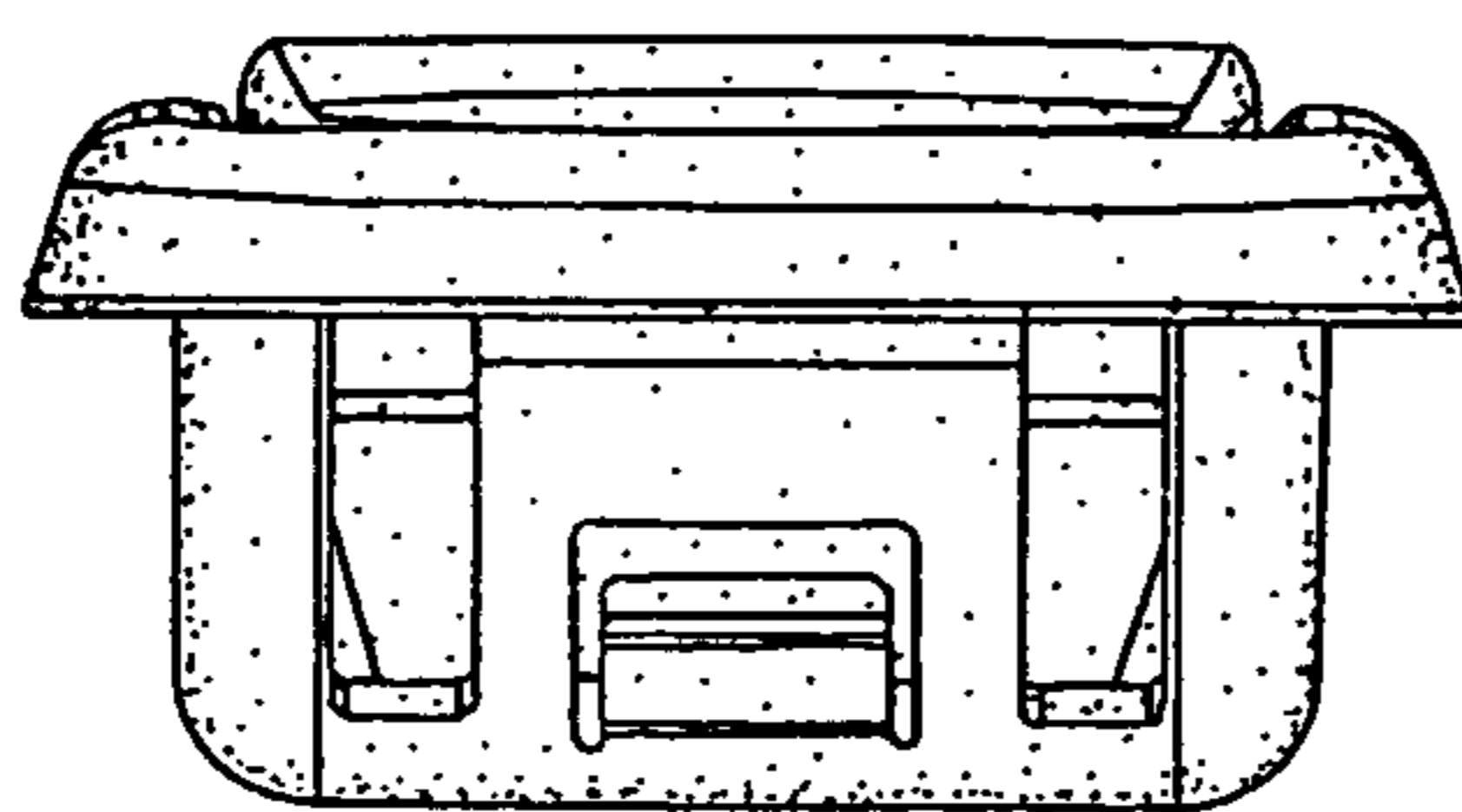

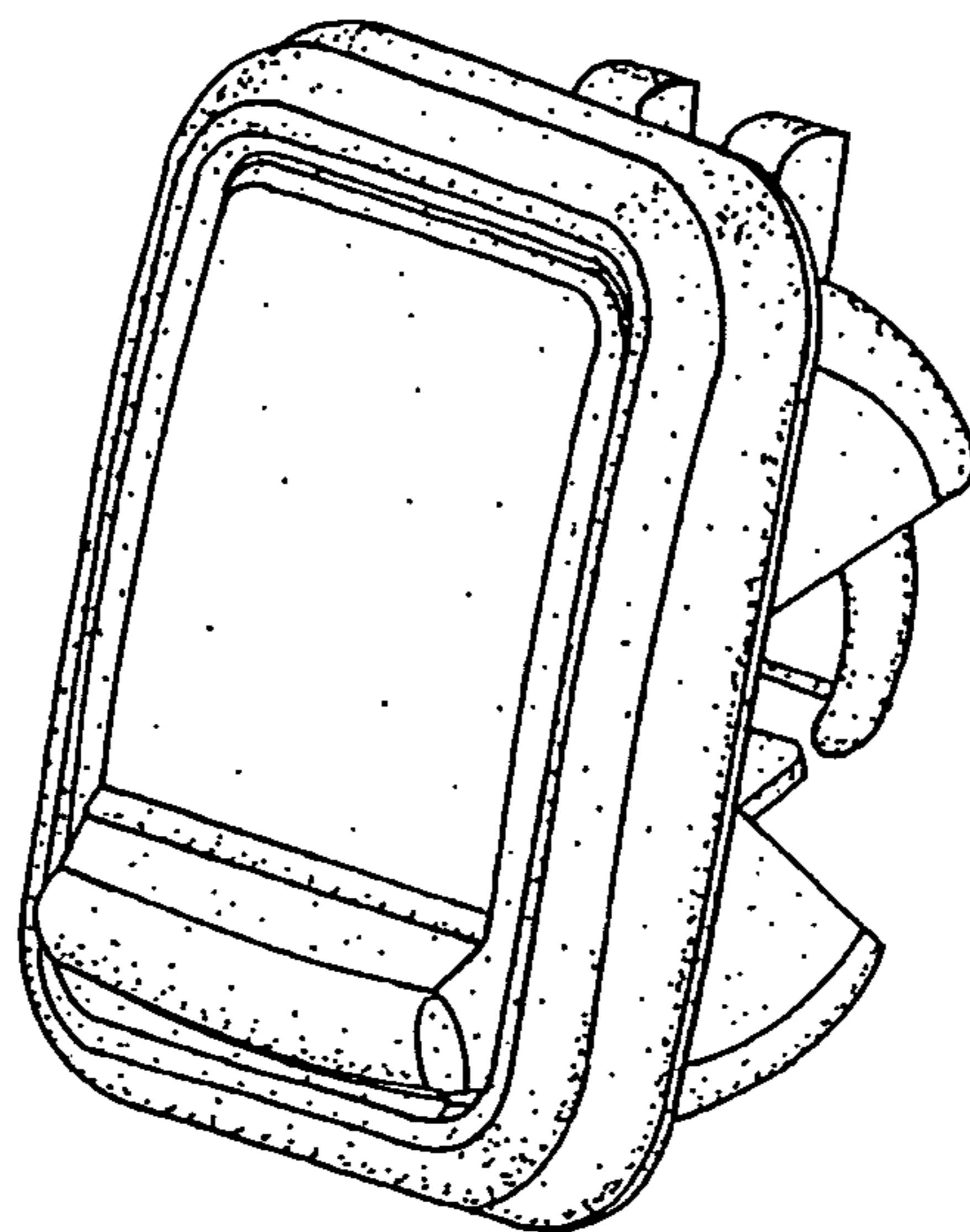

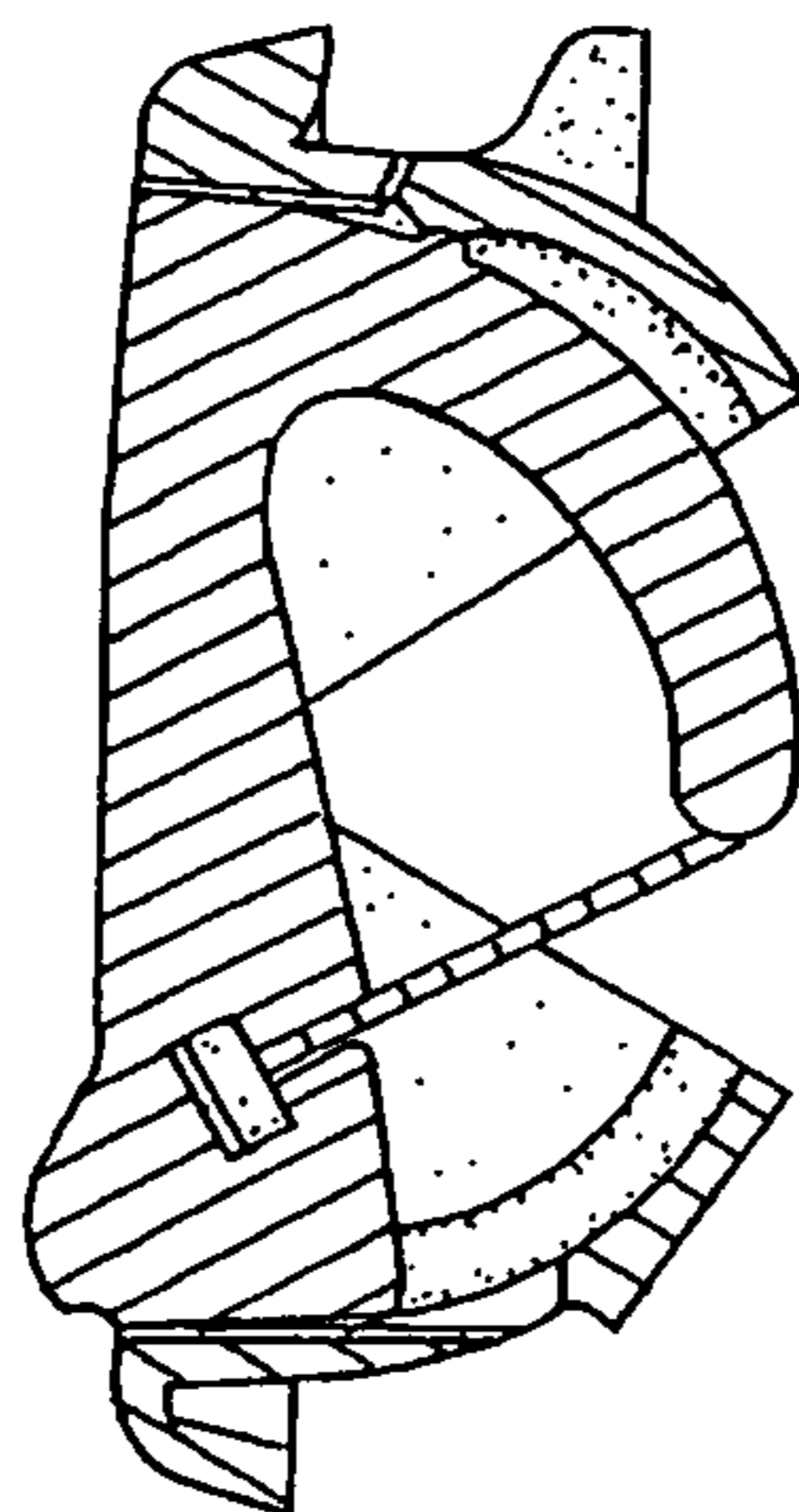

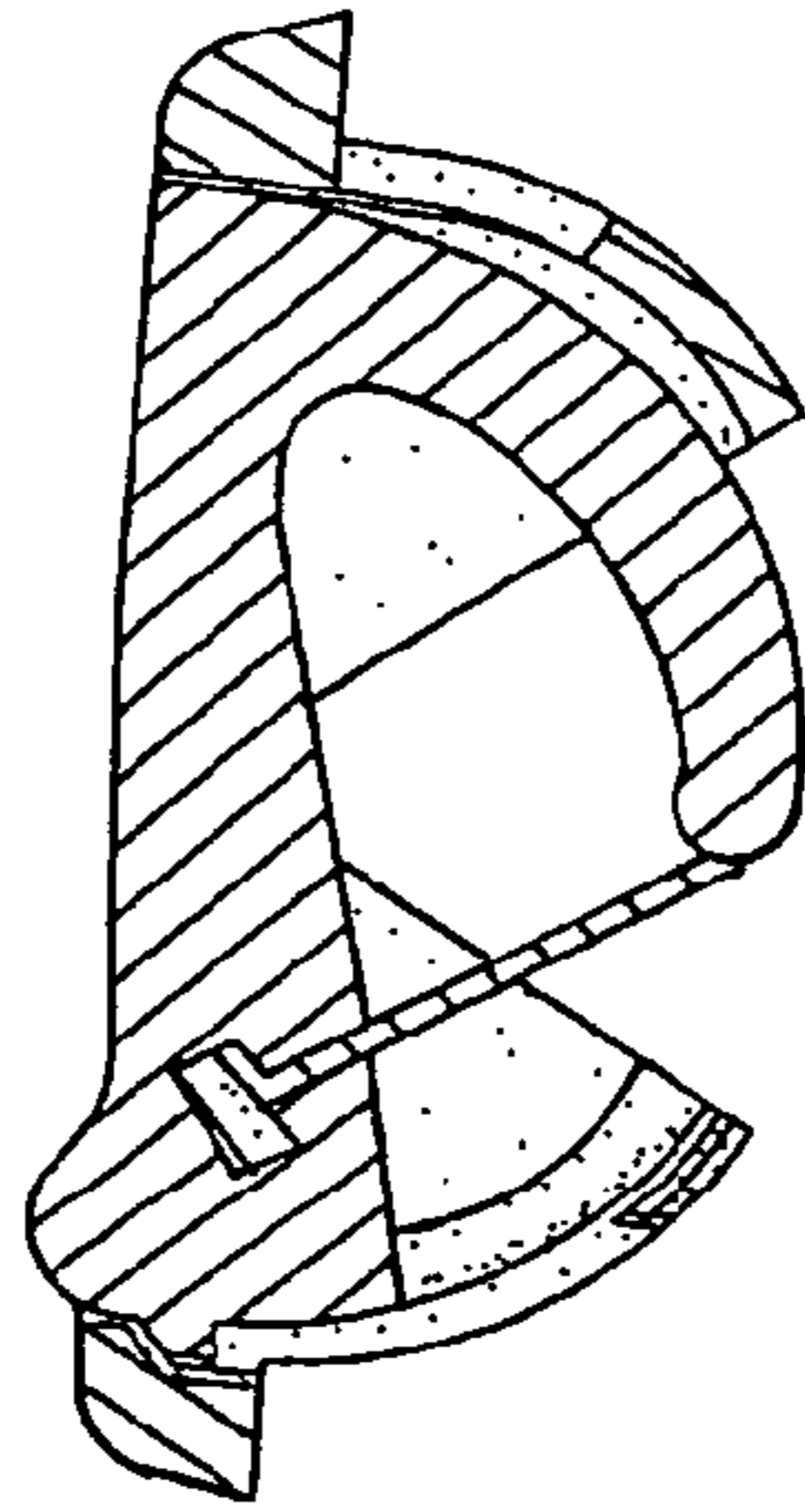
