DESCRIPTION

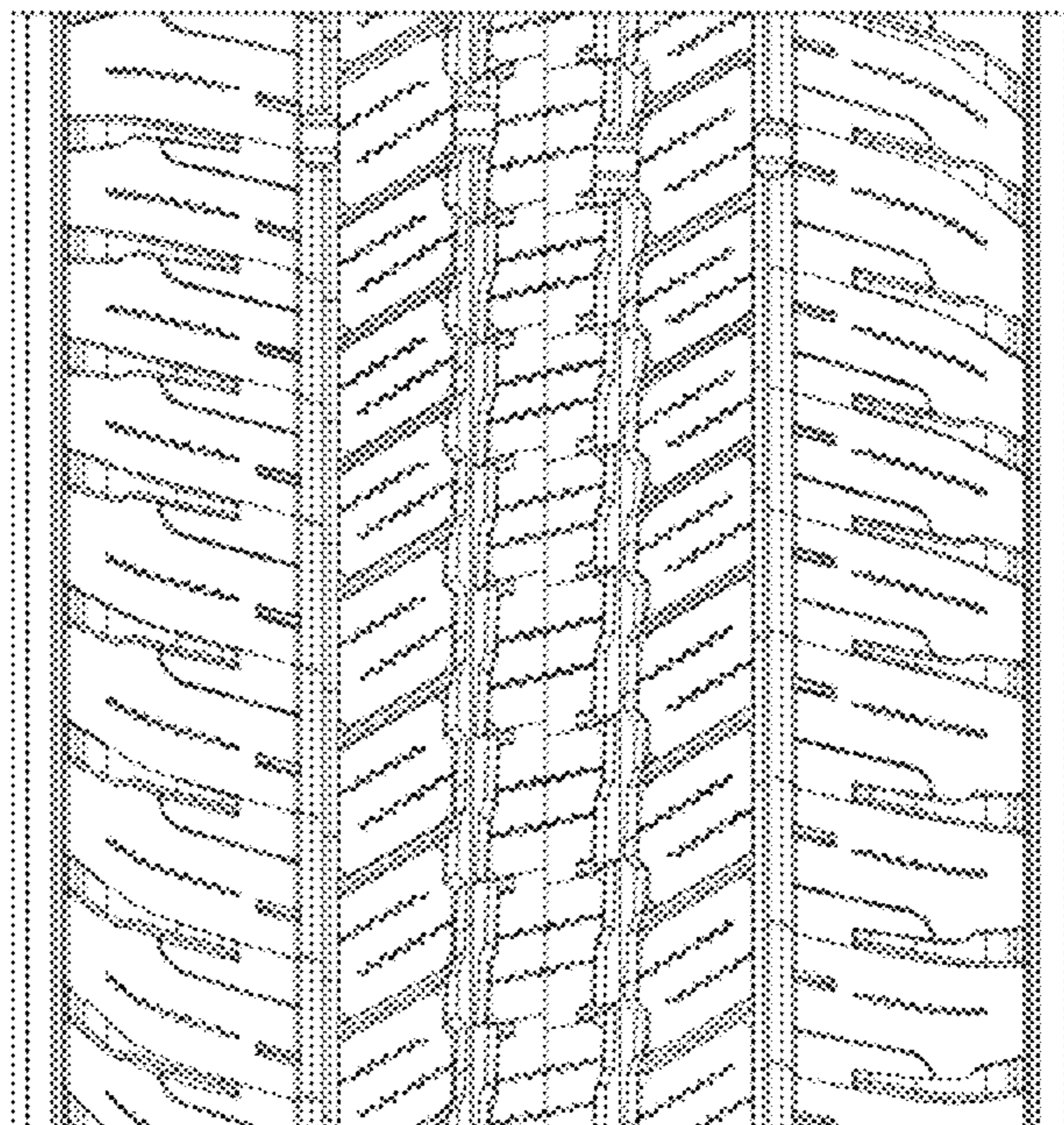
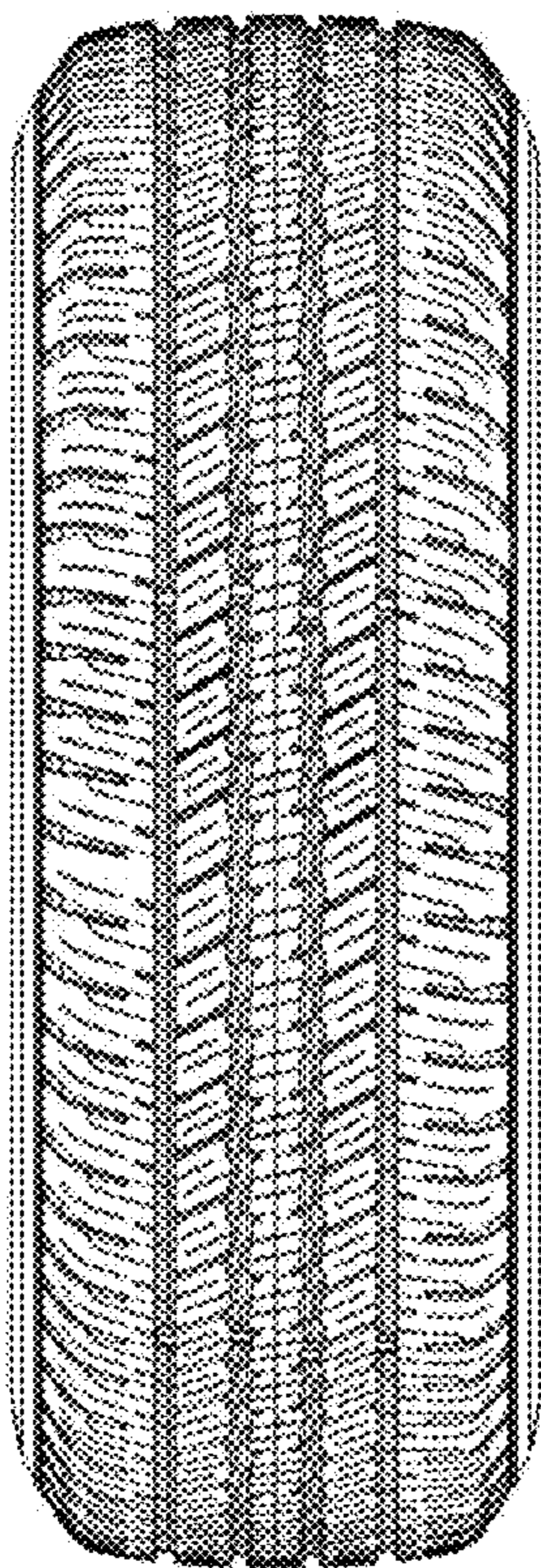
FIG. 1 is a front elevation view of the tire tread showing my design, a back elevation, top plan, and bottom plan views being identical.

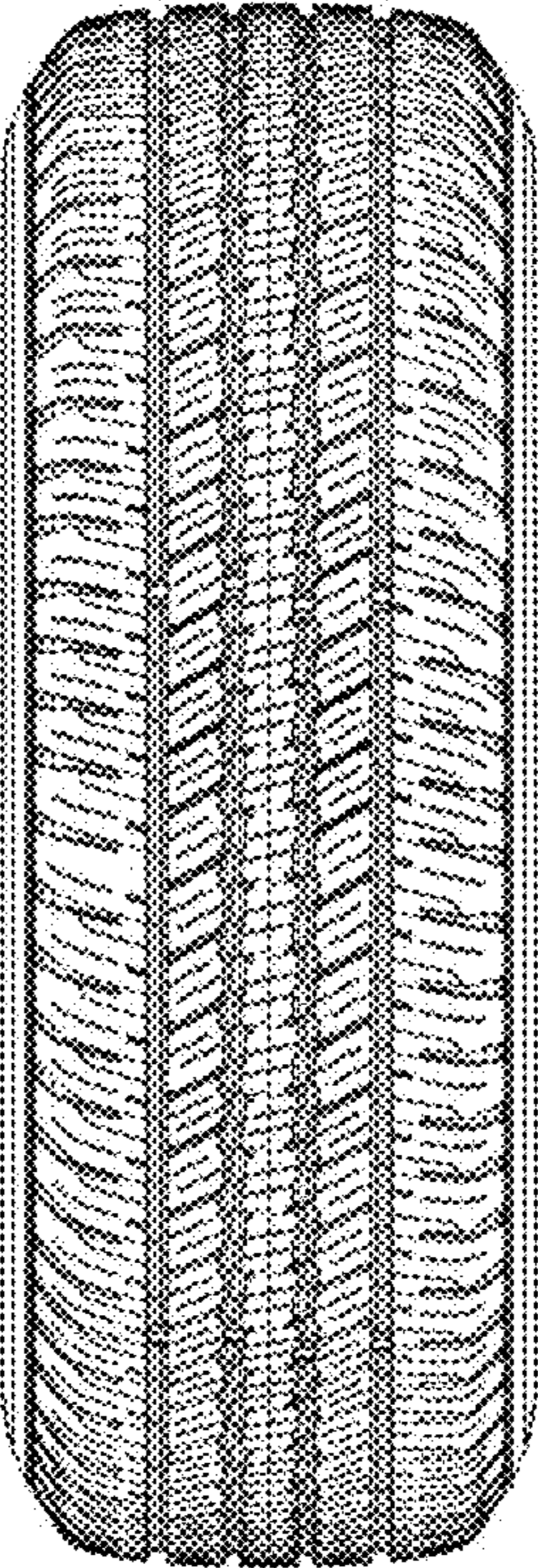

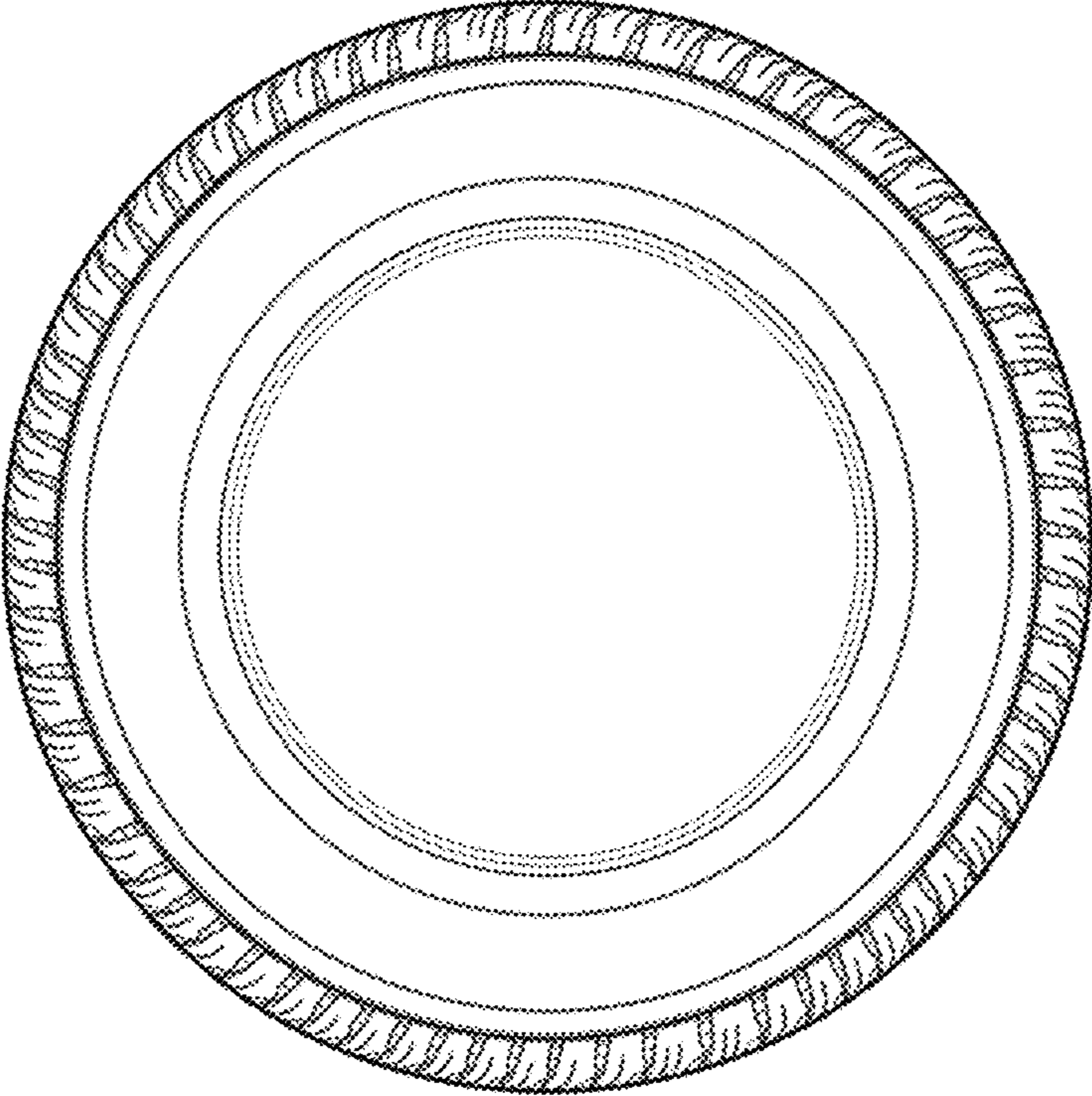

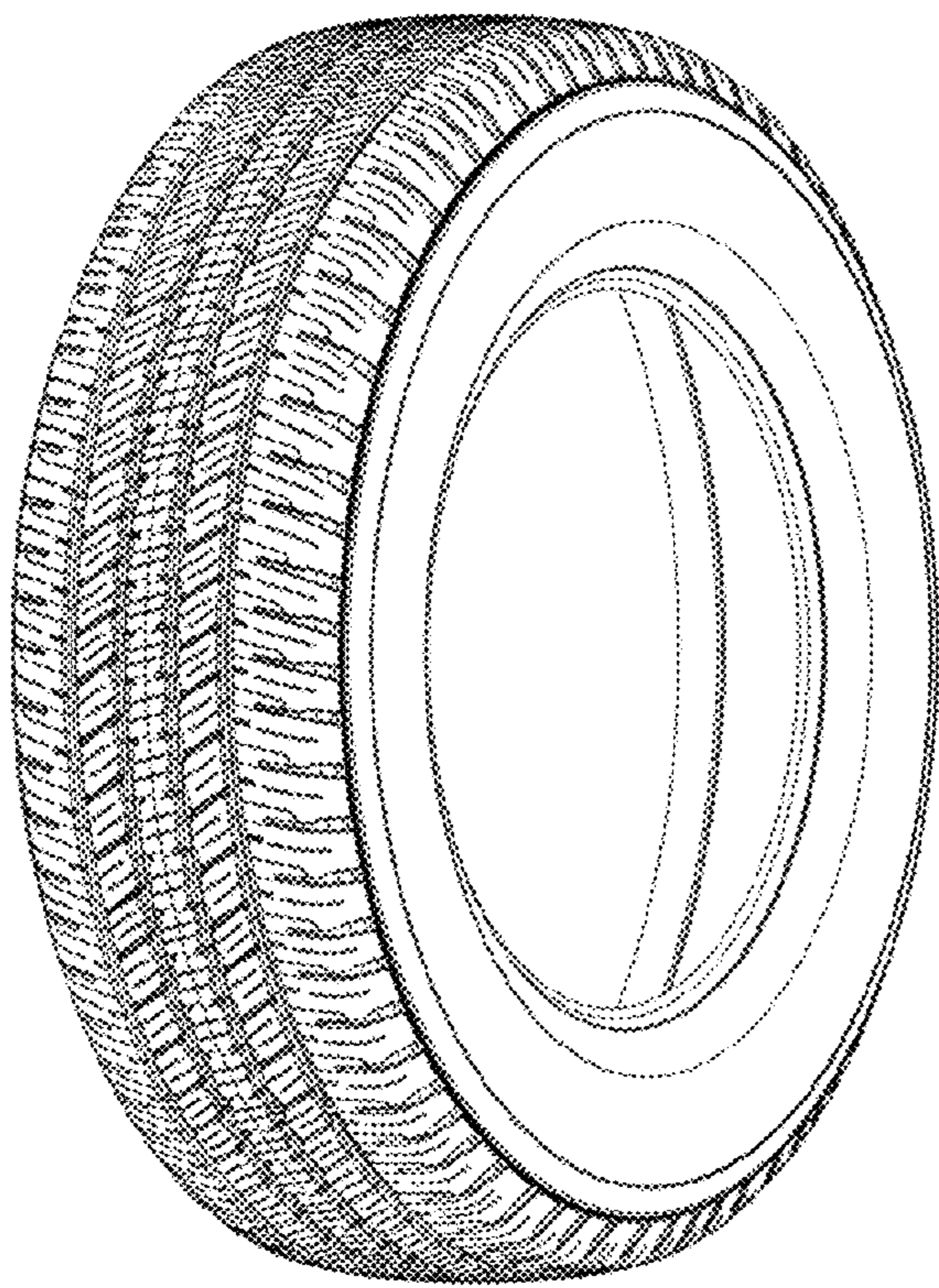

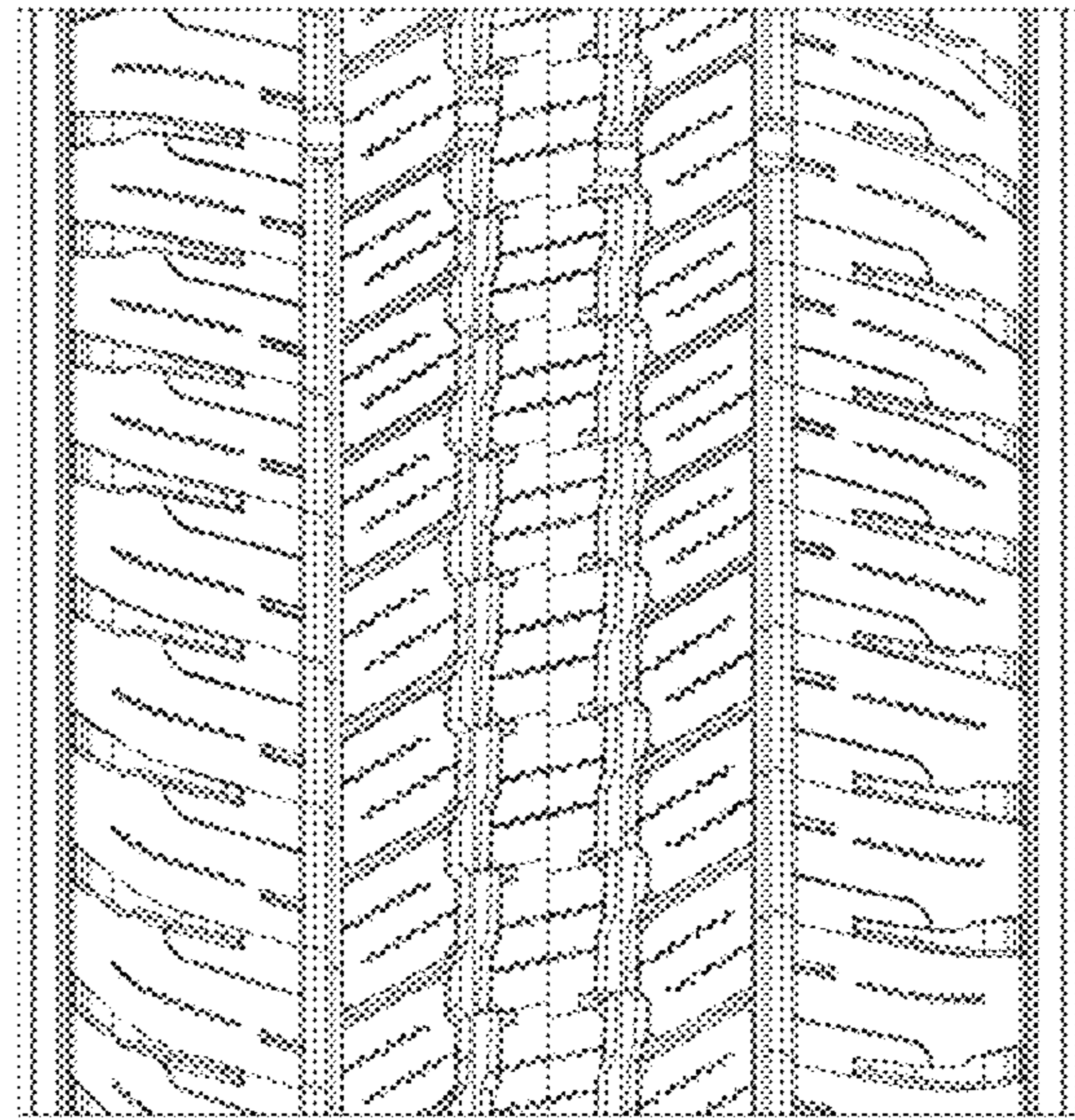
