FIG. 5 is a first side view thereof;

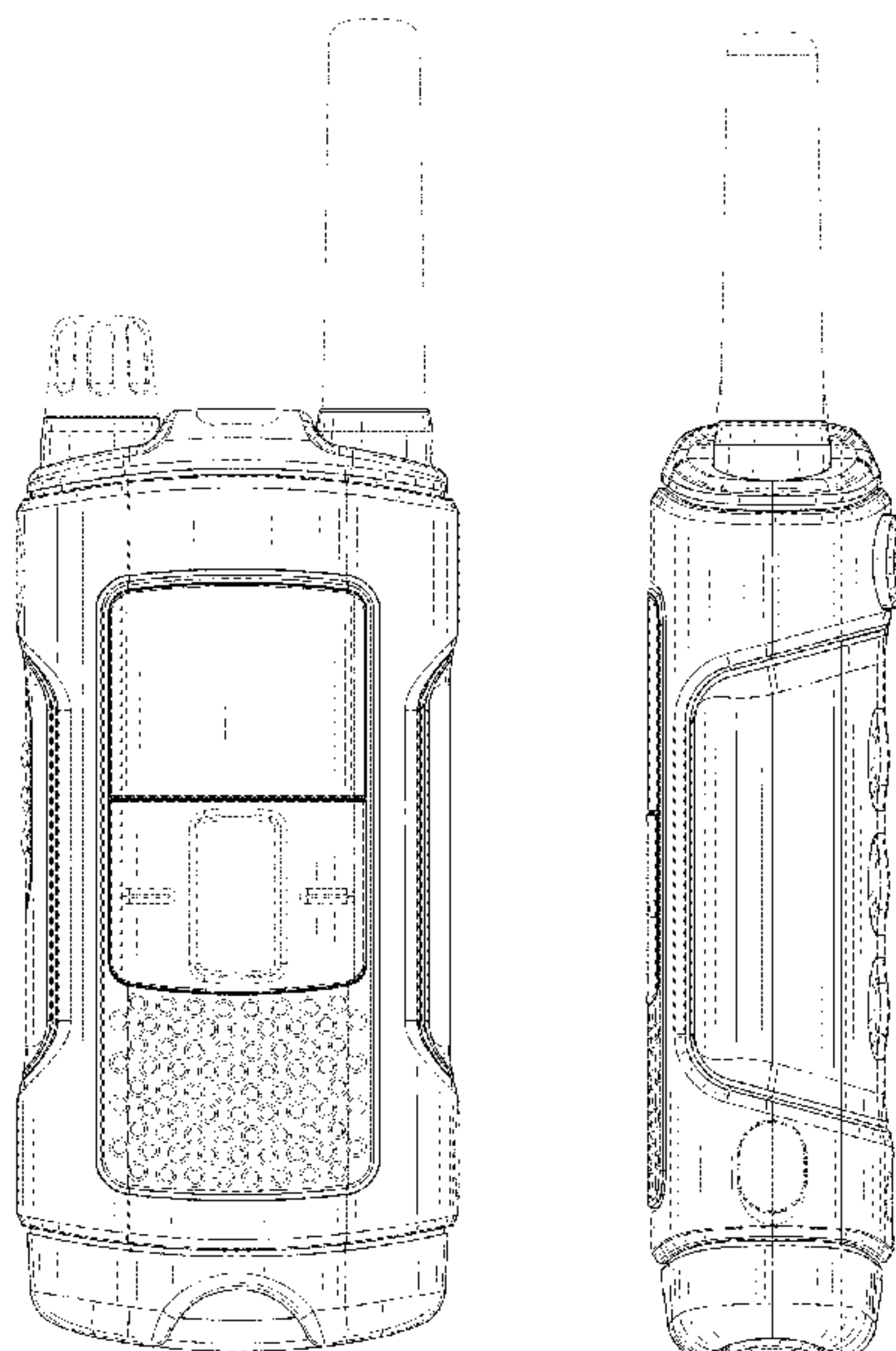
FIG. 6 is a second side view thereof;

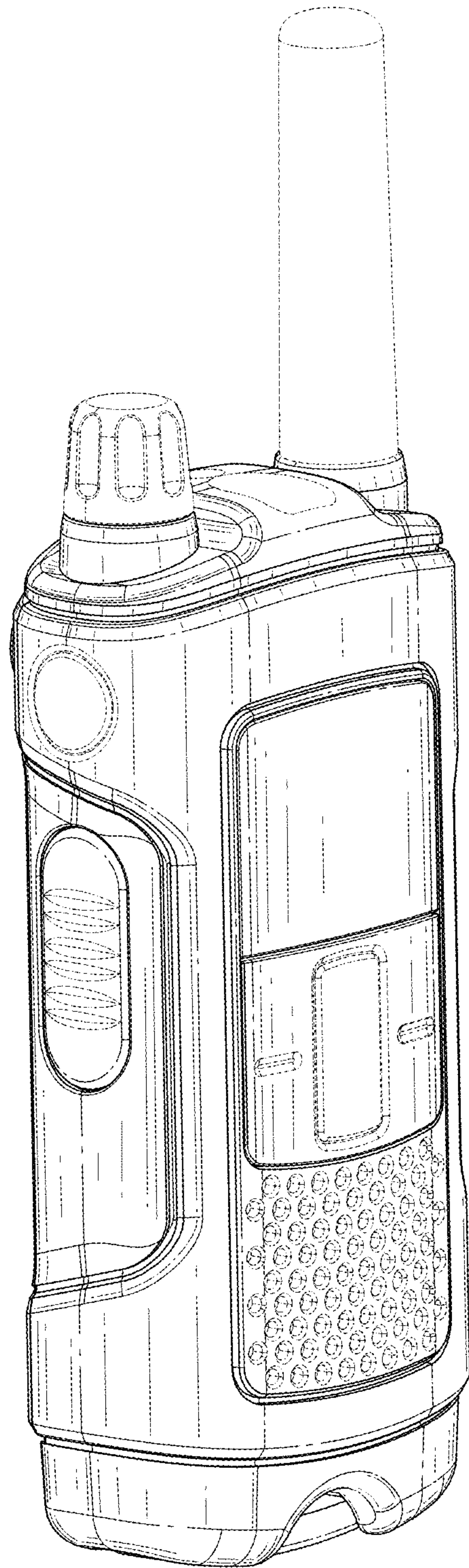

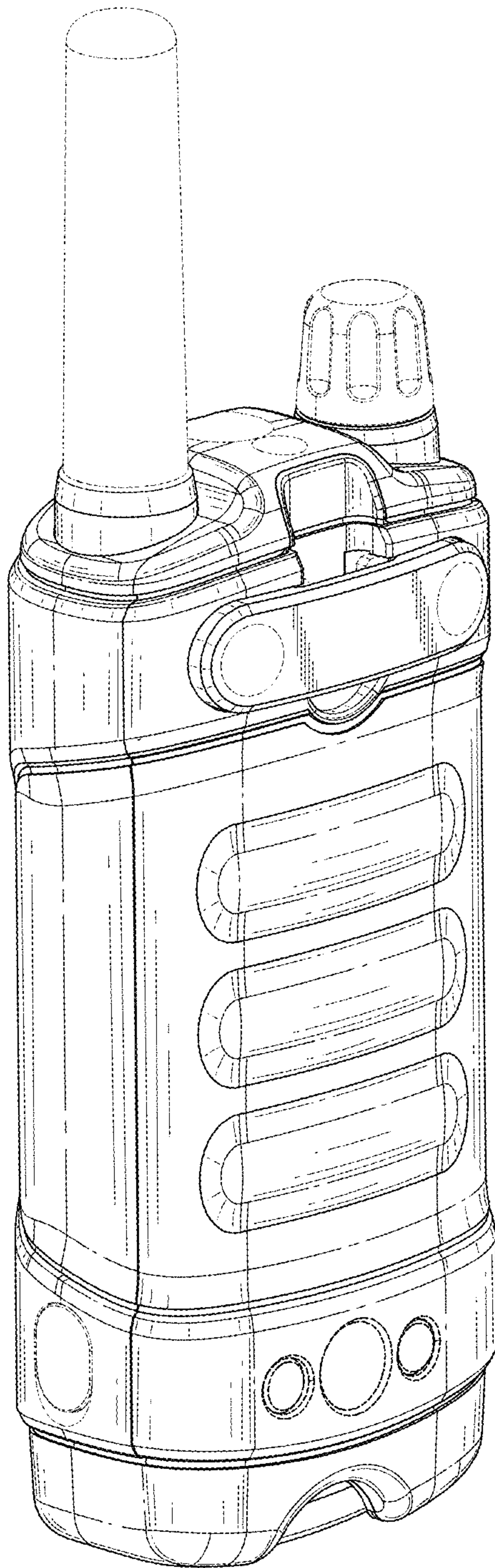

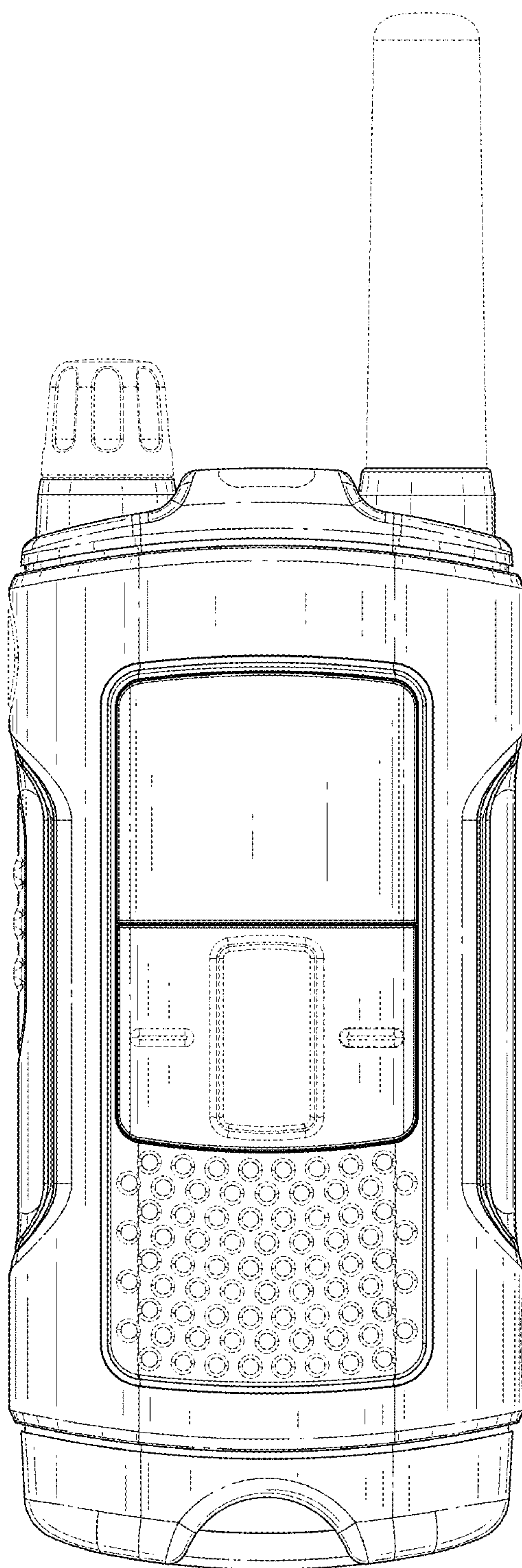

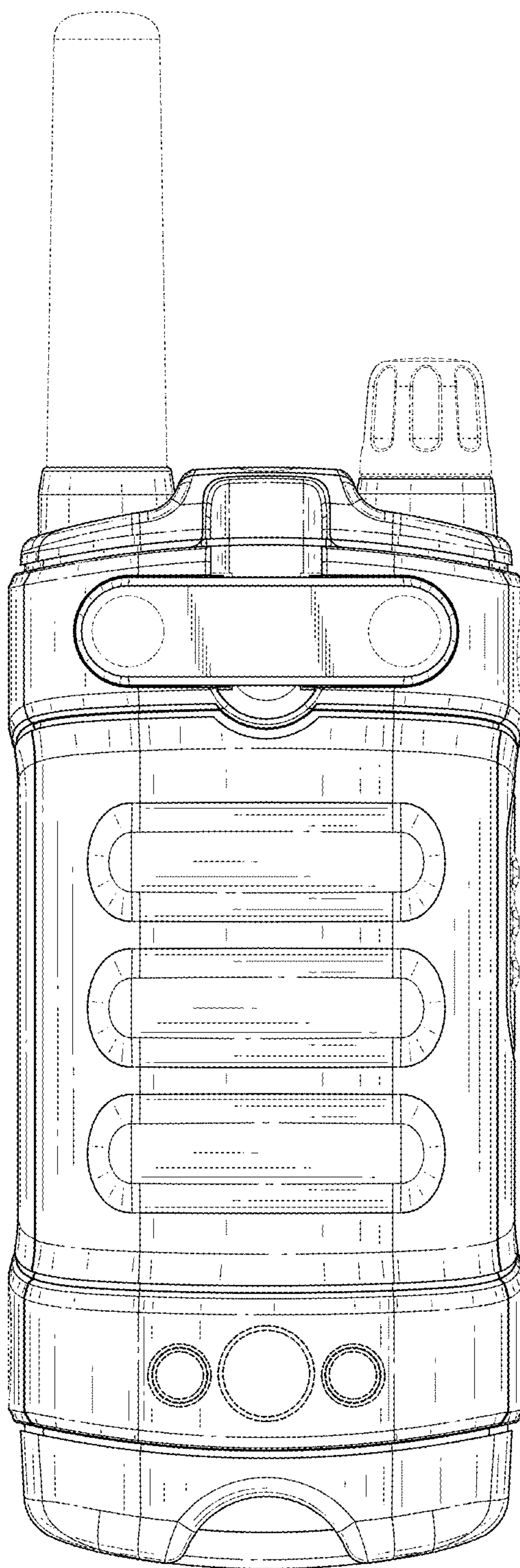

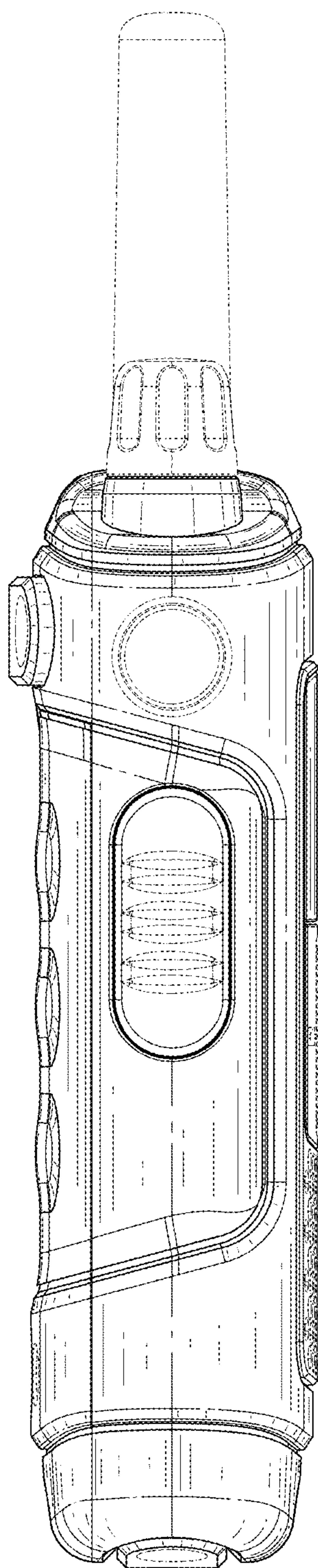

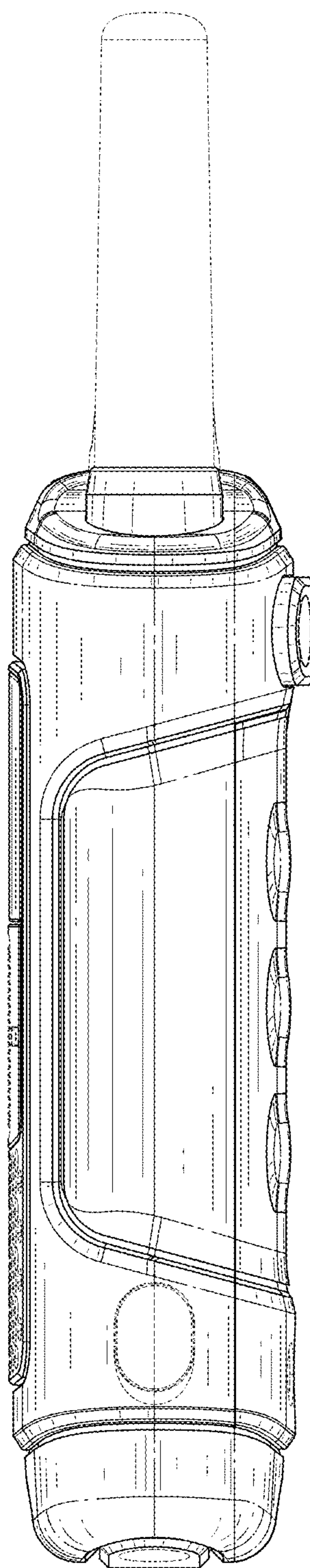

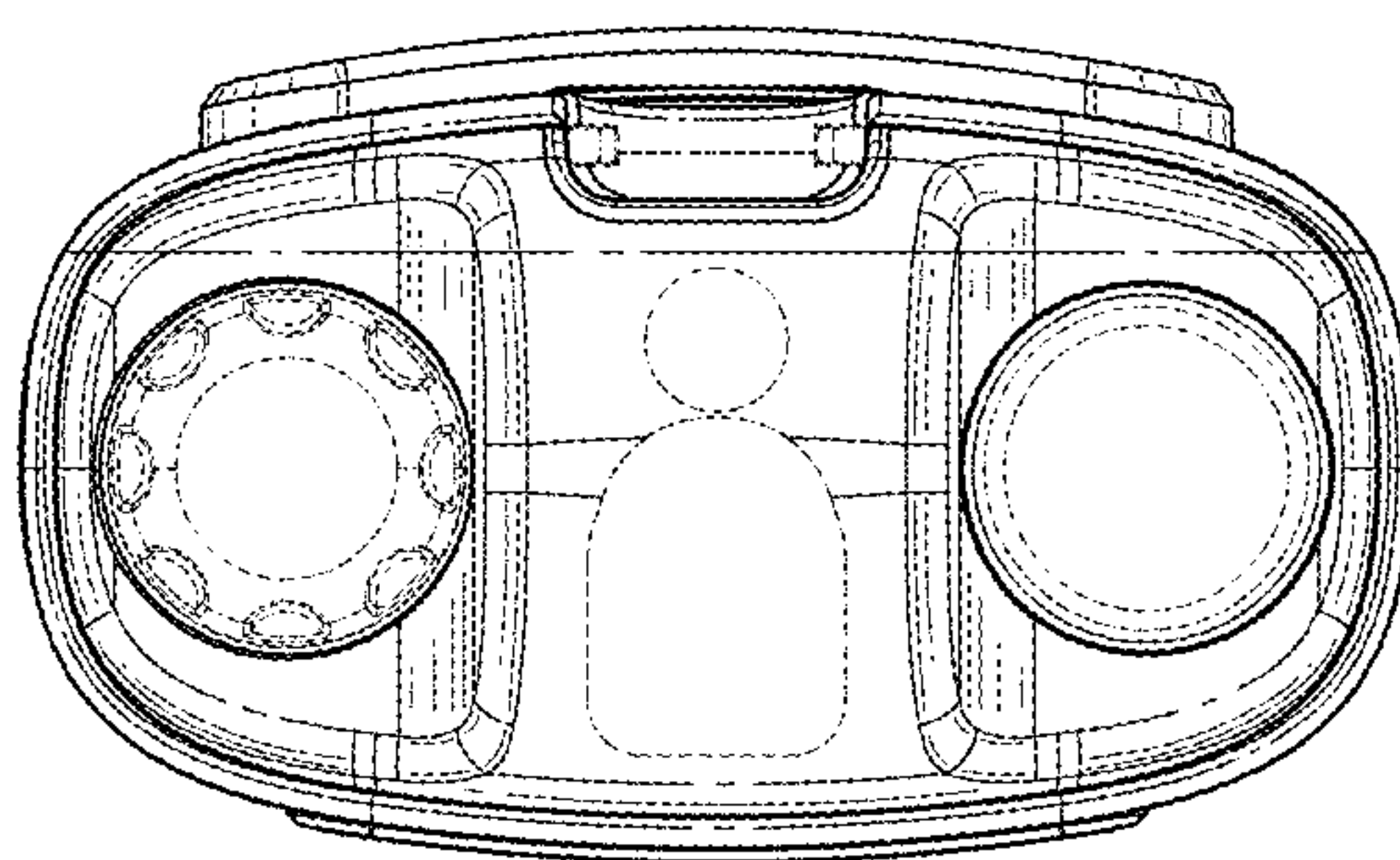

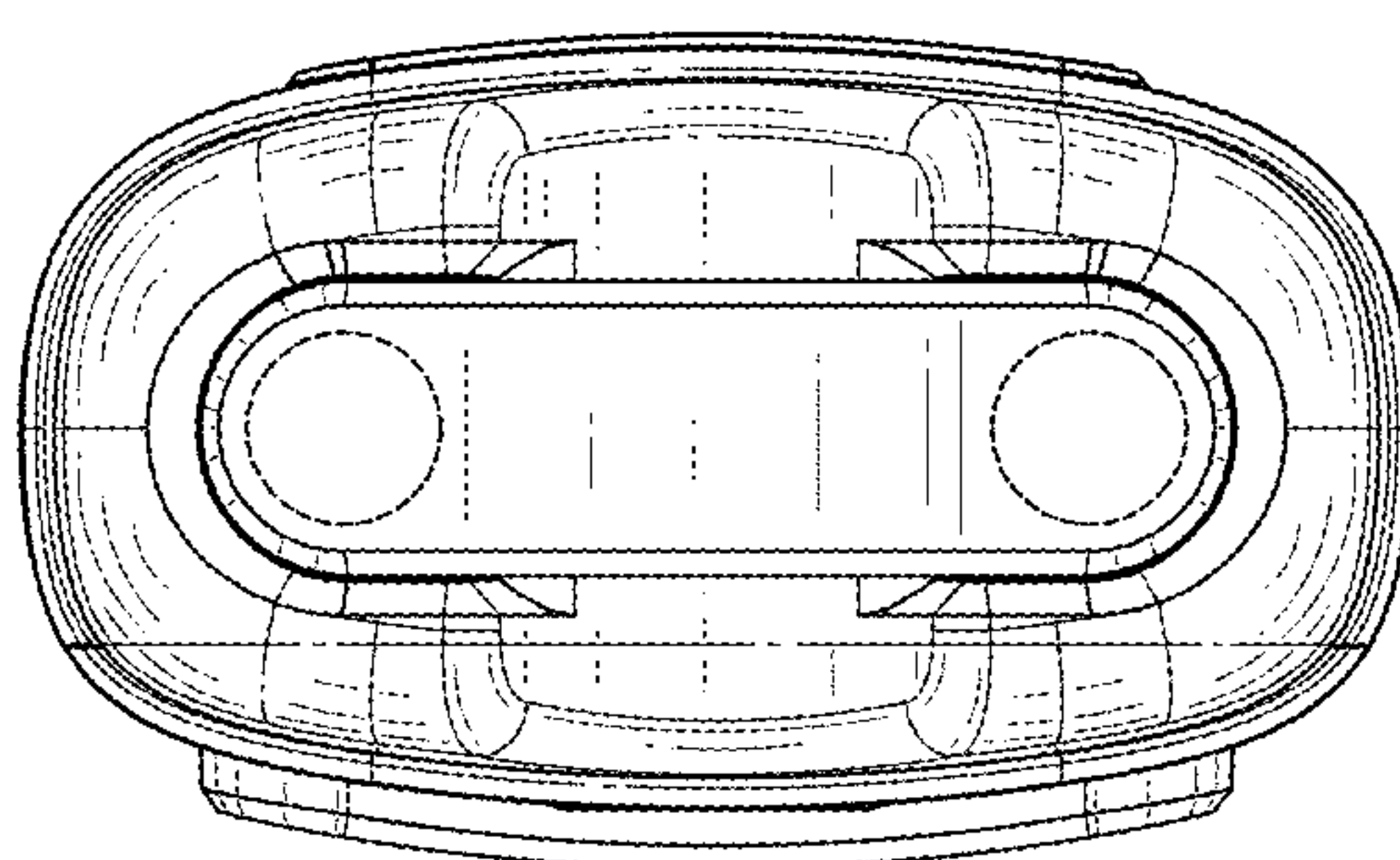
