(57) **CLAIM**

The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with a graphical user interface showing our new design; the graphical user interface shown separately for ease of illustration; and,

FIG. 2 is a front view thereof, shown with environment.

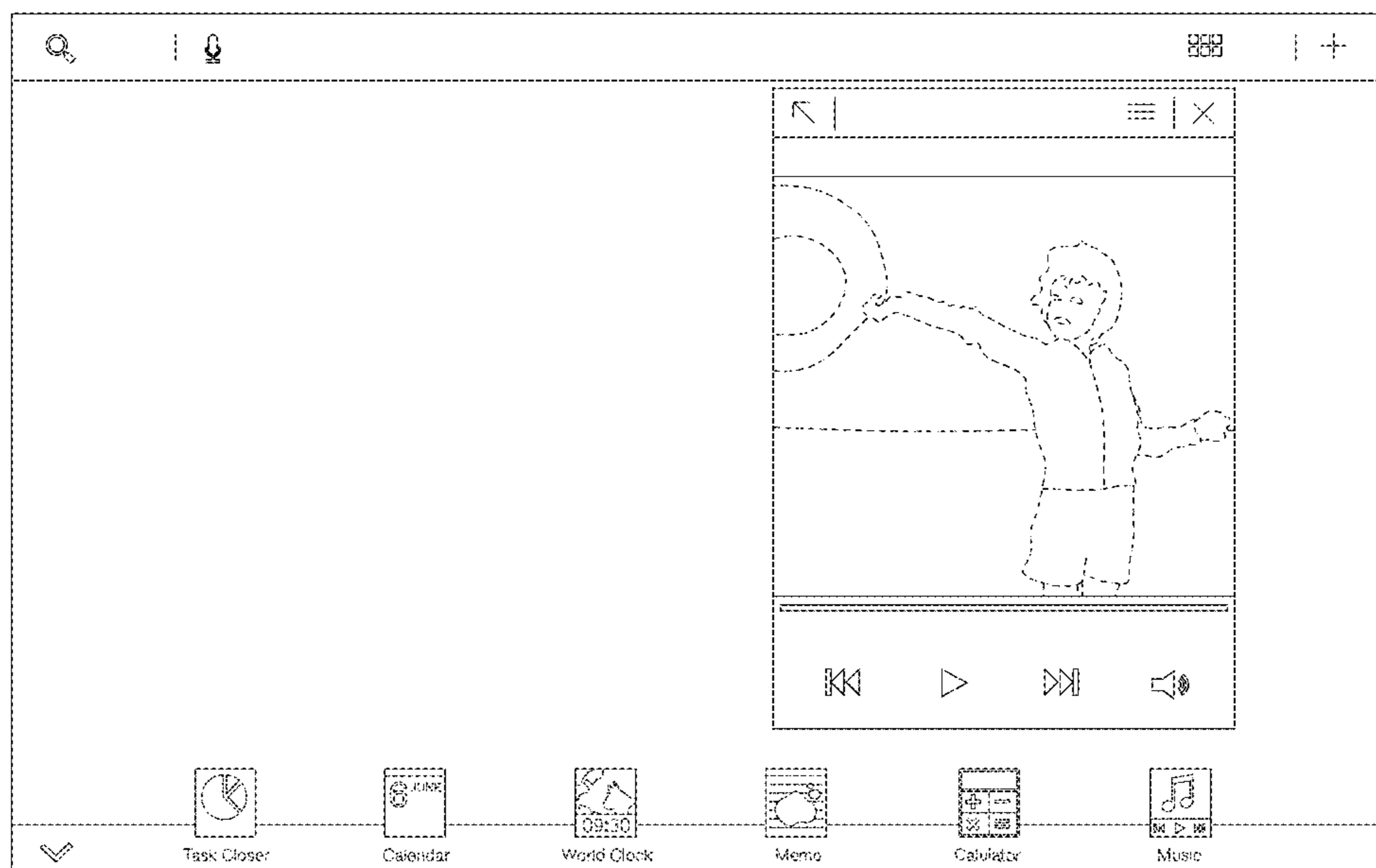

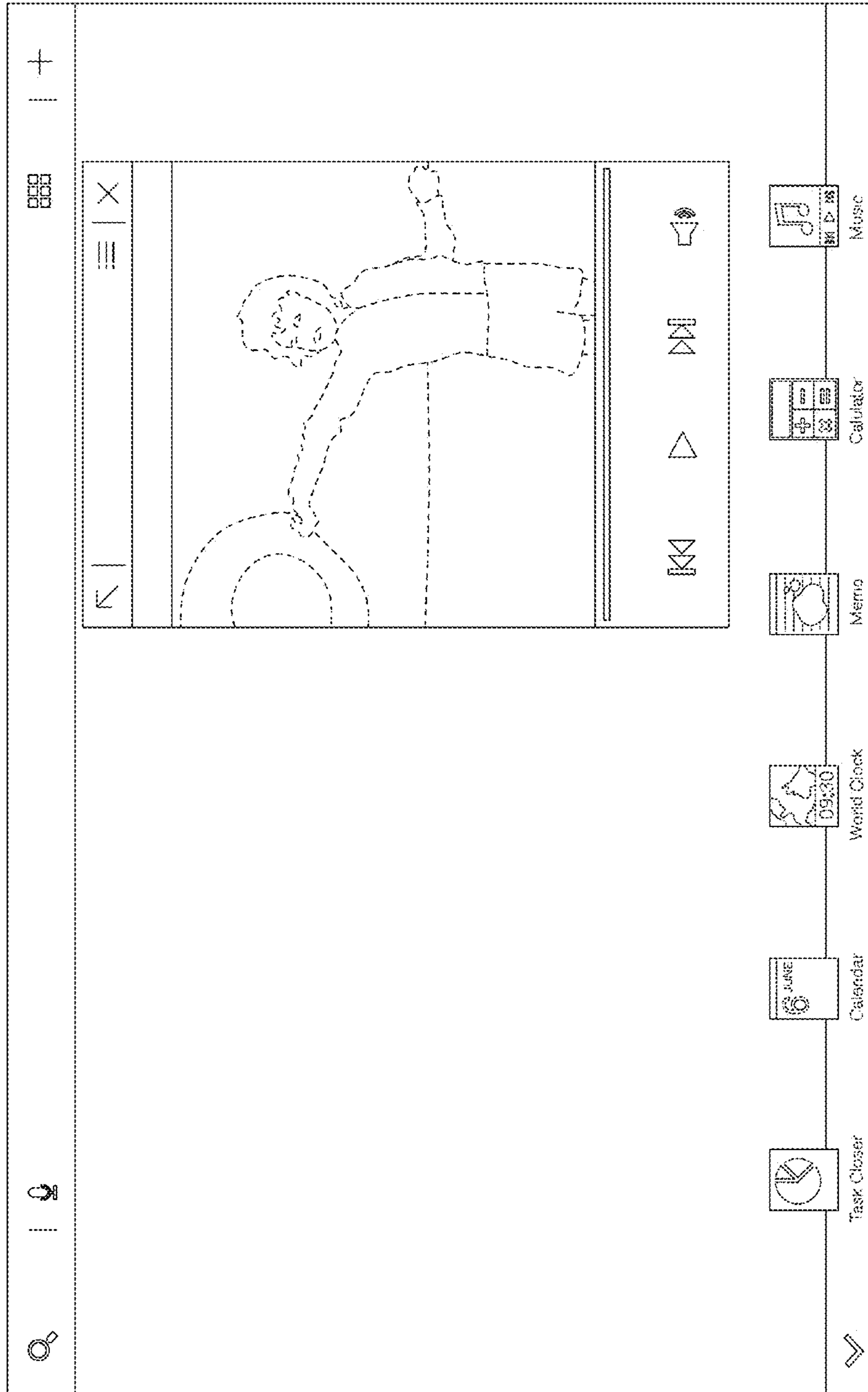
