We claim the ornamental design for a medical data recorder and player, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a medical data recorder and player of the present invention;

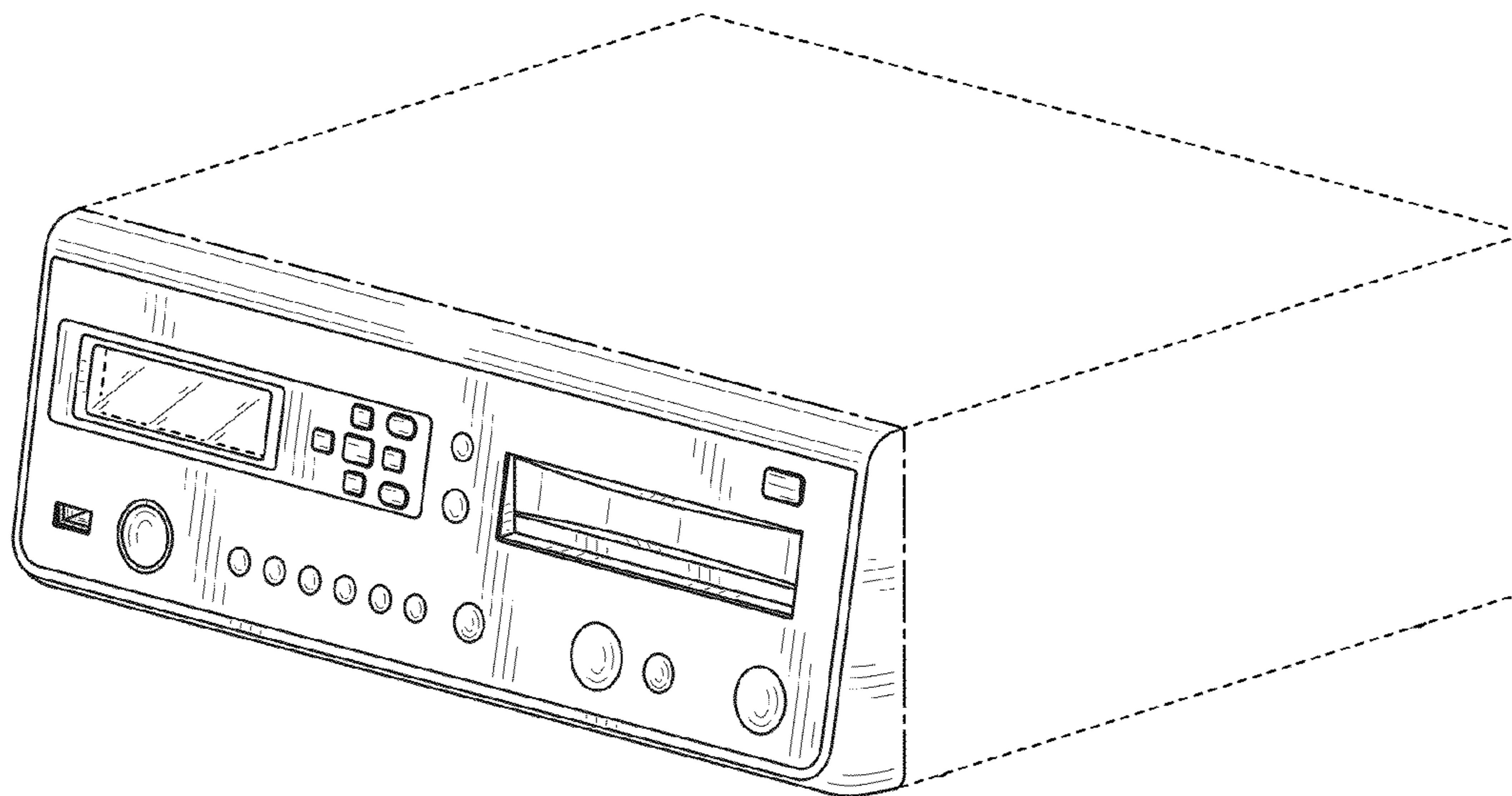

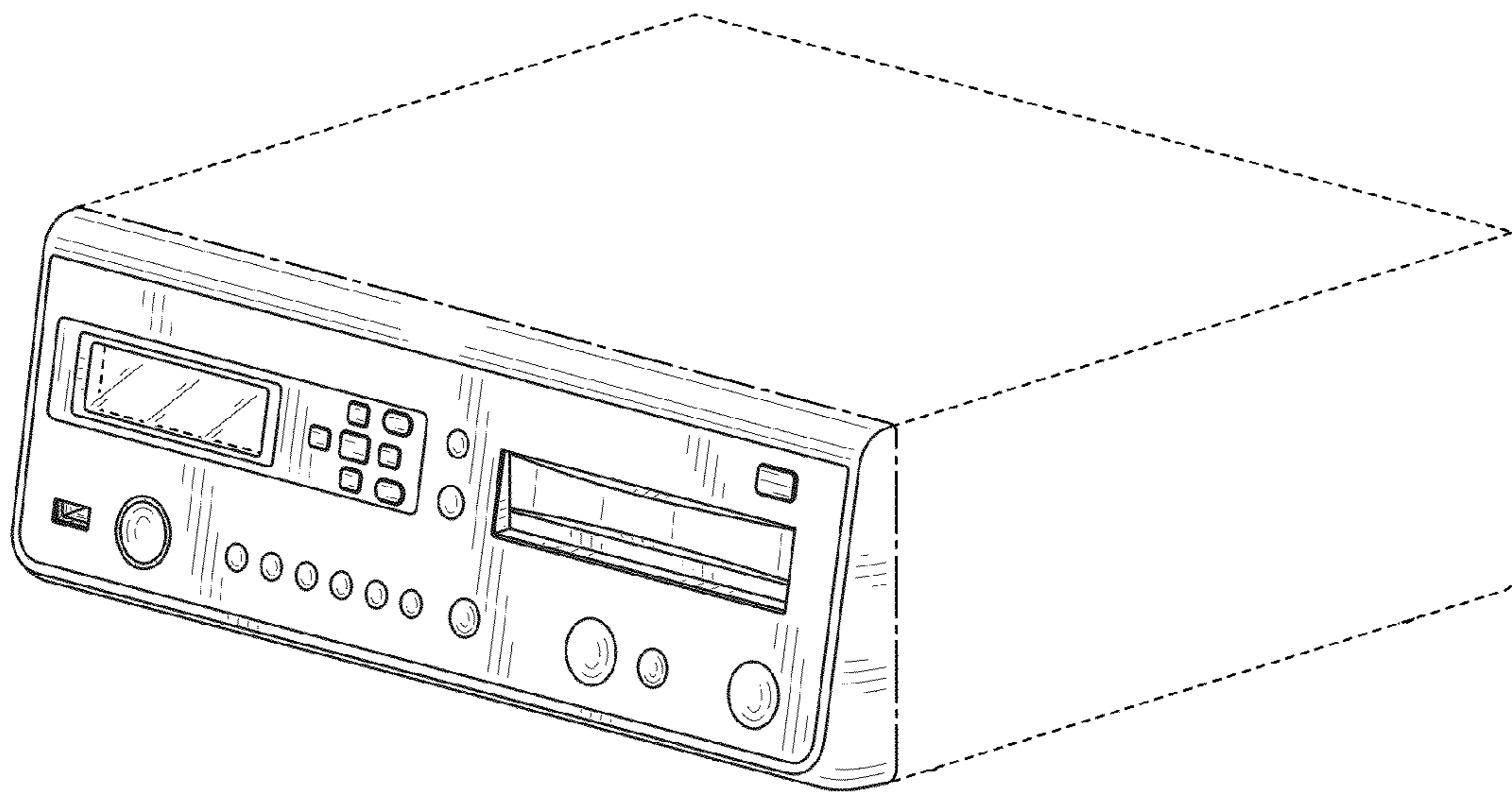

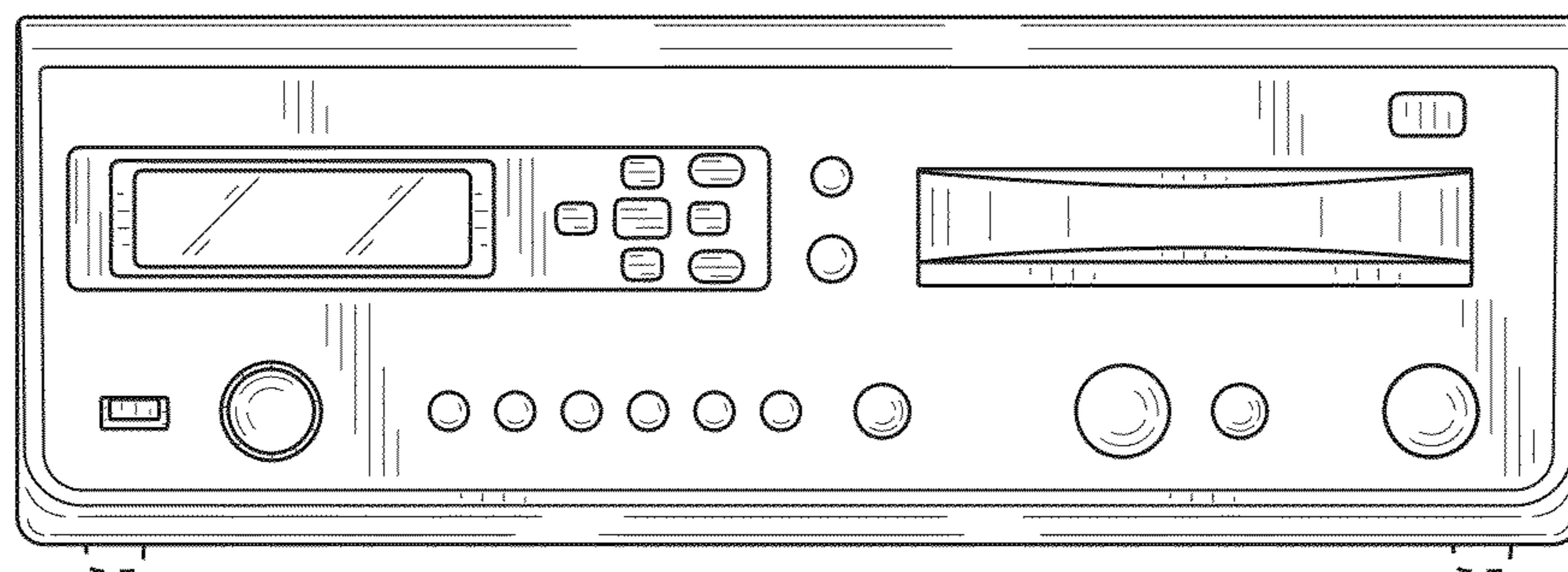
